DIMER STATISTICS ON A BETHE LATTICE

We discuss the exact solutions of various models of the statistics of dimer coverings of a Bethe lattice. We reproduce the well-known exact result for noninteracting hard-core dimers by both a very simple geometrical argument and a general algebraic form ulation for lattice statistical problems. The algebraic form ulation enables us to discuss loop corrections for nite dimensional lattices. For the Bethe lattice we also obtain the exact solution when either a) the dimers interact via a short-range interaction or b) the underlying lattice is an isotropic. We give the exact solution for a special limit of dimers on a Bethe lattice in a quenched random potential in which we consider the maxim alcovering of dimers on random clusters at site occupation probability p. Surprisingly the partition function for "maxim al coverage" on the Bethe lattice is identical to that for the statistics of branched polymers when the activity for a monom er unit is set equal to p. Finally we give an exact solution for the number of residual vacancies when hard-core dimers are random ly deposited on a one dimensional lattice.

I. IN TRODUCTION

The statistics of covering a lattice with monomers or dimers has a long and continuing history in condensed matter physics. Recently there has been a revival of interest in this topic in connection with a number of seem ingly unrelated problem s such as quantum uctuations in H eisenberg antiferrom agnets,¹ stability and dynamics in granular system s,² phase transitions in certain com plex uids³, dynamics of catalysis on surfaces,⁴ and the bio-

physics of m em branes.⁵ A coordingly, we have been led to revisit this problem with the goals of a) drastically sim – plifying the derivation of existing approximations and b) providing a fram ework within which the more modern techniques of statistical mechanics can be applied.




FIG.1: A Cayley tree with coordination number q = 3. The tree consists of three generations of bonds starting from the seed site, S.

The rst studies of the statistics of dimer coverings of a lattice were carried out more that 50 years ago,^{6,7,8} obtaining results analogous to those of the Bethe approximation^{9,10,11} for the Ising and Heisenberg models. At that time, the relation of this approximation scheme to the structure of the Cayley tree (a recursive \lattice," an example of which, with coordination num ber q, is shown in Fig. 1) was apparently not known. It was later recognized by Sykes,¹² who apparently rst coined the term \Bethe lattice," that the Bethe approxin ation was to be associated with local properties evaluated near the center of the tree, in order to avoid surface e ects which, for d-dim ensional hypercubic lattices, are unphysical. The pathological e ects of the anom alously large surface were later studied by several authors in the $1970's_{r}^{13,14,15,16}$ but, as was clear from the work of Fisher and Gaunt in 1964_{I}^{17} it was the results for local properties at the center of the in nite tree which could be connected to those of hypercubic lattices in the lim it d! 1. They obtained expansions in powers of 1=d for the coe cients of series expansions in the coupling constant. However, it was later shown by the renorm alization group¹⁸ that the critical exponents for typical lattice

models were those of mean-eld theory for d > 4.

M ost of the results of this paper will be obtained for the Bethe lattice. W e in plement the Bethe lattice condition either by explicitly considering sites far from the boundary or, alternatively, by using a form ulation appropriate to periodic lattices and then introducing approxim ations which become exact when the lattice does not support any loops.¹⁹ By initially treating a periodic lattice we eliminate anom alous surface e ects. W e are thus assured that our results are characteristic of the interior of the tree and should be associated with what is now commonly called a Bethe lattice.

Of course, an important aim is to treat real ddimensional lattices. To this end there have been a number of papers dealing with series expansions for the problem of dimer or monom er-dimer coverings of a lattice. Nagle²⁰ in 1966 developed a series expansion in powers of the dimer activity z for a number of two- and three-dimensional lattices. Longer series were later obtained obtained by G aunt²¹ who exploited the relation between the dimer problem and the Ising model in a

eld. A Itemative form ulations, based on the generalization of the M ayer cluster expansion²² by R ushbrooke and Scoins²³ have also been given.²⁴ M ore recently B razhnik and Fræed²⁵ have given a form ulation suitable not only for dimers but for m ore complicated entities. Here we treat the cases of both noninteracting and interacting dimers. We est address these problems using a simple intuitive geometrical approach. Then we adopt an algebraic approach based on a transform ation introduced by Shapir²⁶ which enables us to develop an expansion for a d-dimensional lattice in which the leading term is the exact result for the B ethe lattice of the same coordination num ber q. For noninteracting dimers corrections are obtained in powers of 1=q and the activity z, similar to the result of N agle.²⁰

Brie y this paper is organized as follows. In Sec. II we present a simple geometrical derivation of the Bethe

approximation for the statistics of distributing hard-core (but otherwise noninteracting) dim ers on a lattice. We also give an alternative algebraic derivation of this result which enables us to generate loop corrections for the case of a d-dimensional periodic lattice. We also brie y consider noninteracting dimers on an anisotropic lattice. In Sec. III we consider a model which includes dimerdim er interactions. W e derive the Bethe approxim ation for thism odel by both the geom etrical and algebraic approaches. The exact solution of a model in the special lim it of quenched random ness in which each cluster of random ly occupied sites is maximally covered by noninteracting dim ersisgiven in Sec. IV. In Sec. V we consider a model of random deposition of hard-core dimers in one dimension. We give an exact result for the fraction of sites which remain vacant after deposition is completed. Finally, our conclusions are summarized in Sec. VI. In a future paper we will generalize our approach to treat the statistics of entities m ore com plicated than dim ers.

II. NON INTERACTING DIMERSON A BETHE LATTICE

A. Geometrical Derivation of the Exact Result

Here we will develop a form ula for , the average number of dimers per edge on a lattice in terms of the dimer chemical potential , or preferably in terms of the dimer "activity" z = 0, where z = 1 = (kT). (Interactions between dimers and the underlying lattice as well as internal degrees of freedom of the dimer are easily included

by a rede nition of z.) We will give what we believe to be the simplest possible \geometric" derivation of the well-know $n^{6,7,8}$ \Bethe approximation," which has been show n^5 to be surprisingly accurate for some two dimensional lattices, and which is exact when applied to the Bethe lattice. We assume that only dimers can be adsorbed on the lattice, and that they can be adsorbed only as lying dimers (i.e., an adsorbed dimer covers two lattice sites). In the present section we will assume that there are no interactions between adsorbed dimers except for the hard-core restriction that two dimers cannot touch the same site. It is easy to generalize this treatment to deal with the two-component lattice and also to include the possibility of adsorption of standing dimers and m onom ers.²⁷

As stated in the introduction, we initially deal with a periodic d-dimensional lattice and will obtain the results for the Bethe lattice by introducing an approximation which is exact when the lattice is tree-like (i. e. it contains no bops). As a starting point of this discussion we introduce the (unnormalized) probability that there are N_D dimers on the lattice, W_N (N_D) z^{N_D} , where W_N (N_D) is the number of distinct congurations of N_D dimers on a lattice of N sites. The equation of state for this dimer system is the relation between z and $\overline{N_D} = N$, where $\overline{N_D}$ is the average value of N_D. In the Bethe approximation^{6,7,8}

where q is number of sites which are nearest neighbors of a given site. To emphasize that this result applies to a Bethe lattice we express it in terms of densities such as $2N_D = (qN)$, the fraction of bonds (a bond is an edge connecting two sites) covered by a dimerorq, the fraction of sites which are covered by a dimer. Stated alternatively, is the probability that a given bond is covered by a dimer and q is the probability that a given site is covered. In terms of these variables the equation of state is

or, equivalently,

where = q 1.




FIG.2: Classi cation of bonds in a lattice partially covered by dimers. As indicated in the text D labels a dimer, V a dimer vacancy, I an interacting bond, and H a halfbond.

For this discussion it is convenient to de ne som e term inology to describe con gurations of dimers on a lattice. In Fig. 2 we show a small section of a lattice where one sees occupied bonds (D) on which dimers are placed and unoccupied bonds, which can be of three types depending on whether or not the two sites of the bond are covered by dimers. If both sites of an unoccupied bond are uncovered, the bond is called a \dimervacancy," (V). If both sites of the unoccupied bond are covered, the bond is called (in anticipation of Sec. III where we allow dimerdimer interactions) an \interacting bond" (I),

and if only one site of the unoccupied bond is covered, the bond is called a \half bond" (H). We rst observe that in the therm odynam ic lim it the average and most probable values of N_D di er negligibly. Thus we may say that the average number of dimers N_D is the value of N_D for which the probability W_N (N_D)z^{N_D} is maximal. The condition that this quantity be stationary is

Consider the left-hand side of this equation. From any conguration of N_D dimers we can obtain a conguration of N_D + 1 dimers by placing an additional dimer on a dimer vacancy. The number of new congurations obtained by placing a dimer on one of the N_V dimer vacancies of each conguration of N_D dimers is thus $\overline{N}_V \, W_N \, (N_D)$, where \overline{N}_V is the average number of dimer vacancies for congurations having N_D dimers. However, we note that in this new set of congurations each con-

guration occurs N_D + 1 tim es because each dim er in the new con guration could have been the one new ly added. So^{28}

where we will replace N $_{\rm D}$ + 1 by N $_{\rm D}\,$ in the therm odynam ic lim it. Applying this for the most probable value of N $_{\rm D}\,$ gives the simple result 5

If we introduce the density of dimervacancies $_V$ by $_V$ = $\rm \overline{N}$ $_V$ =N $_B$, where N $_B$ is the total number of bonds, then this m ay be written as

Note that (or $_{\rm V}$) is de ned to be the total number of dim er (ordim ervacancies) divided by the total num ber of bonds. These quantities can also be de ned locally for a subsystem of bonds. It is not obvious that when and v are replaced by their local versions that Eq. (7) will still hold. Indeed, for the Ising model on a Cayley tree in an applied eld, the totalm agnetization divided by the total num ber of sites is not the sam e as the localm agnetization of a single site near the center of the tree. We now argue that v = does not depend on position within the tree. Consider two subsystem s^{29} S₁ and S₂ which consist of $N_{\,1}$ and $N_{\,2}$ bonds, respectively, where $N_{\,1}$ and $N_{\,2}$ are both large compared to 1 (so that we do not need to worry about discreteness e ects). Suppose v = assumesdi erent values within these two subsystem s. Then, if we move a dimer from subsystem S_1 to subsystem S_2 , the ratio of the number of con gurations W before moving the dimer to that, W 0 , after moving the dimer is

where the subscripts identify the subsystem in question. We may view the $_{Vn}$ for subsystem S_n as being order parameters. In order that W $_N$ (N $_D$) actually be maximal with respect to variation of these order parameters, it must be stationary with respect to moving a dimer. So W =W 0 = 1, which implies that $_V$ = is the same for all large subsystem s. Thus Eq. (7), which initially involved the ratio of global properties, is actually valid when interpreted as a relation between local quantities.

We now express $_V$ as an explicit function of in a region far from the boundary, so that Eq. (7) yields the equation of state we seek. If A and B are nearest neighboring sites, then

Here the sym bolP () denotes the probability of the event inside the parentheses. The basic probability space consists of all con gurations of dimers on the lattice. The (unnormalized) probability assigned to a con guration is $z^{N_{\rm D}}$, where $N_{\rm D}$ is the number of dimers in the conguration. Equivalently, we could limit our probability

space to the set of con gurations containing exactly N_D dimens, with all con gurations equiprobable. The conditional probability [the last factor in the last line of Eq.

(9)] is denoted P (B vacant jA vacant) and is, by de nition, equal to P (B vacant and A vacant)=P (A vacant). M ore generally, for any two events E_1 and E_2

We now invoke the approximation in which we replace the factor P (B vacant jA vacant) in Eq. (9) by P (B vacant jbond AB unoccupied). This replacement ignores the possibility that at most one of the other bonds touching site A might be occupied and thereby might indirectly a ect whether site B is occupied or not. Of course this possible inaccuracy can only arise if there is some indirect path from site A to site B not going through the bond AB. Since this approximation (which we will refer to as the tree decoupling) is exact for the B ethe lattice it leads to the B ethe approximation. Thus

The probability that a particular bond is unoccupied is $1 \$, so that

If B is vacant, the bond AB m ust be unoccupied; therefore the numerator of Eq. (12) is just P (B vacant) = 1 - q. Thus

which, in combination with Eq. (7), leads to Eq. (2). We have not succeeded in constructing a simple argument to estimate the magnitude of the di erence between P (B vacant j A vacant) and P (B vacant j bond AB unoccupied) for d-dimensional lattices. Qualitatively, the important point is that, within the family of con gurations in which bond AB is unoccupied, the probability that site B be vacant is not signi cantly in uenced by the presence of a dimer on (at most) one of the other bonds emanating from A.

In Appendix C we present a simple calculation of the m a jor correction to the tree approximation on a planar triangular lattice. However, the calculation is not the

rst term in a system atic series and is not easily extended to the square lattice. In the next section we will present a form alism which enables one to system atically generate corrections to the tree approxim ation.

B. Solution by Construction of an E ective H am iltonian

We now apply a technique introduced previously³⁰ in order to treat here the nontherm alstatistical problem of constructing a generating function for covering a lattice with 0,1,2,:::hard-core dimers. We wish to identify this generating function with a partition function, Z of the form Z = Trexp(H), where H can then be interpreted as the H am iltonian for the statistical problem.

The state in this program is obviously to construct the e ective H am iltonian. This can be done by writing 6

where hiji indicates that the sum is over pairs of nearest neighbors. For the expansion of the partition function in powers of z to count all possible dimer con gurations, where z is the dimer activity. the following trace rules are imposed on the operators s_i :

where Tr_i indicates a trace over states of site i and we set $C_0 = C_1 = 1$ and $C_n = 0$ for n > 1. It is not actually necessary to explicitly construct such an operator because the only property of these operators we need in order to construct the partition function is the trace rules of Eq. (15). We see that the fact that the trace of two or more operators at the same site vanishes, in plements exactly the hard-core constraint for dimers. Thus the partition function Z = Trexp(H) will indeed give the grand partition function for dimers as a function of their chemical potential :

where the sum is over all con gurations C of dimers and n(C) is the number of dimers present in the con guration C. From Z we can get the fraction of sites covered by dimers as a function of the dimer chemical potential via

Since the \spin operators" $s_i \mod m$ ute with one another, we have a mapping of the atherm alproblem of dimers on a lattice into a statistical mechanical problem involving classical spins with a given H am iltonian.

Now we use this mapping to a) construct the exact solution for the partition function for a Bethe lattice and b) generate series expansions for nite dimensional lattices. To do that we develop a perturbation theory for a periodic lattice in which the leading term contains the sum of all contributions from tree diagram s. For this purpose we write $Z = Tr_{hiji} f_{ij}$, where $f_{ij} = 1 + zs_is_j$ [the trace rules allow us to linearize the exponential in Eq. (14)] or equivalently

where g can be chosen arbitrarily. W e evaluate this perturbatively as

where $V_{ij} = f_{ij} = (g_i g_j)$ 1. We expand in powers of which we set equal to unity at the end. Each term in this expansion which involves at least one power of can be associated with a diagram in which the factor V_{ij} is associated with a line connecting sites i and j. We now choose g so that diagram shaving at least one line which is connected to only a single site (j) give zero contribution. Since all diagram son a B ethe lattice have at least one free end, this choice of g will lead to an exact evaluation of the partition function for a B ethe lattice and will enable us to generate loop corrections for d-dim ensional lattices. The condition we im plem ent is that

where = q 1. This is a nonlinear equation for the function g_j , but in view of the trace rules it is easily solved. From the form of f_{ij} one sees that g_i has to be of the form

(W e chose the positive sign before the square root to ensure that A ! 1 as z ! 0.) Then for the Bethe lattice we have the exact result

A first some algebra it can be shown that when this result is inserted into Eq. (17) we recover the result of Eq. (3).

Unfortunately, this formalism leads to an expansion of the partition function Z, whereas for d dimensional lattices, we would prefer to have an expansion for the free energy per site, $F = (1=N) \ln Z$. For that purpose we consider an expansion of the quantity Z^n , which in the limit n ! 0 is $1 + n \ln Z = 1 + nN F$. To obtain Z^n we introduce the n-replicated H am iltonian

where s_i and s_i are independent operators for for and for each replica index s_i obeys the same trace rules as in Eq. (15). U sually replicas are introduced to perform the quenched average (over $\ln Z$) for random problem s in which case the averaging leads to interactions between di erent replicas. Here we introduce replicas simply to facilitate construction of an expansion of $\ln Z$ and there are no interactions between di erent replicas. The partition function, $Z_{\rm rep}$ associated with the replicated H am illonian is

Thus we solve Eq. (21) with $f_{ij} = \begin{pmatrix} Q \\ 1 + zs_i s_j \end{pmatrix}$. Because di erent replicas are independent of one another, the solution to Eq. (21) is of the form

Because we need the partition function Z_{rep} to order n_{\star}^{31} we must evaluate C up to linear order in n but D can be evaluated for n = 0 because it always appears in connection with a sum over replica indices which give a factor of n. The term s in g_i in Eq. (21) independent of s_i give

C. Loop Corrections

Here we consider the expansion in powers of V_{ij} $f_{ij} \!=\! (\!g_i g_j) \! 1.0 \, \text{ur} \, \text{rst}$ objective is to show that contributions to Z_{rep} from disconnected diagrams are of order n^2 or higher and hence can be dropped. To see this we write

The contribution to Z $_{\rm rep}$ from a disconnected diagram is simply the product of the contributions from each connected component. We now argue that the contribution to Z $_{\rm rep}$ from a single connected diagram is of order n. Note that V_{ij} is a multinom ial in the s 's whose constant term is proportional to n. Thus the contribution to Z $_{\rm rep}$ will get at least one factor of n, either from the constant term in a V_{ij} , or from a sum over replica indices from terms in a V_{ij} involving an s operator. Thus using the n ! 0 lim it of the replica form alism we have elim inated unlinked diagram s.




FIG. 3: Leading loop corrections to Z^n for the hypercubic lattice (top) and for the plane triangular lattice (bottom).

Now we consider the leading loop corrections to Z^n . These come from the smallest loops that can be drawn on the lattice. In Fig. 3 we show these loops for both the d dimensional hypercubic lattice and the plane triangular lattice. Here we will explicitly evaluate only the corrections from the smallest possible loop diagram s.

W e will now show that this expansion involves evaluating a modi ed dimer partition function for diagrams

with no free ends. The contribution to the replica partition function from such a diagram is given by

It is a remarkable fact that for a diagram with no loops, G () vanishes and this form s a nice check of computer program sused to evaluate G () for an arbitrary diagram. (This is easy to check for small diagram s.) Furthermore, for a diagram with loops and which has a free end, G () does not vanish, but its cumulant G_c () does vanish. (This is also a nice check of computer program s.)

The present developm ent appears to be related to that of Ref. 20, but the detailed relationship of the two approaches is not clear to us. W e note that the disconnected diagram of Fig. 3d of Nagle²⁰ (which $\$ is required" for his dim er series) does not appear in our approach.

D. AN ISOTROPY

W e m ay generalize the above m odel to allow for different activities along di erent coordinate axes. For that purpose we relate the square lattice to a Bethe lattice in which each site is surrounded by four bonds, two of which we arbitrarily label as \horizontal" (or x) bonds and the others as \vertical" (or y) bonds. D in ers along the axis have activity z for = x; y. The fraction of

III. IN TERACT IN G D IM ERS

A. Geometrical Derivation of The Exact Result

Here we consider the case when two dimers separated by a single bond (an interacting bond as shown in Fig. 1) have an interaction energy . Thus the energy of a conguration of dimers on the lattice is $N_{\rm I}$, where $N_{\rm I}$ is the number of interacting bonds. We start by expressing $N_{\rm I}$ in terms of $N_{\rm V}$. For that purpose we record the following sum rules for periodic lattices. The rst sum rule expresses the fact that each bond is uniquely a member of one of the four sets shown in Fig. 1, so that the total number of bonds of the lattice $N_{\rm B}$ is given by

If m of these 2 vertices are vacant, then the num ber of dim er vacancies in the graph $G^{(0)}(G)$ is N_V(G) m 1. If we look at all the di erent graphs G^{0} (G) which can be generated by adding a dimer to a particular graph G, m assumes the values (1, ..., 2) with the respective probabilities p(m)which we shall calculate. Furtherm ore, since it is quite clear that the con gurations of two small subsections of a large graph G which are distant from each other are statistically independent, we assert that the probability distribution p(m) is the same for alm ost all graphs G (but p(m) does depend on $N_{D} = N$ which has the same value for all the graphs G). Thus for alm ost all graphs G we have




FIG. 4: Left: the bond AB and its environment in a Bethe lattice with q = 4. The subsystem sT_A and T_B are the regions outside the dotted lines. We show the sites neighboring to A and B, which are numbered 1 to 6 (1 to 2). There are no indirect paths connecting any pairs of numbered sites which do not pass through A and/orB. Middle: Environment of a bond AB on a square lattice where we show indirect paths which connect adjacent numbered sites, in which case the strong form of tree decoupling is not exact. Right: Environment of a bond AB on a triangular lattice. Here the decoupling is worse than for a square lattice because a) there are nearest neighbor bonds connecting numbered sites and b) some neighbors of A are sin ultaneously neighbors of B.

We do this using an approximation, which for reasons explained below we call the \strong form of tree decoupling," in which we replace the d-dimensional lattice by a Bethe lattice. To obtain p(m) we rst relate p(m) to the quantity p_on which we de-

ne to be the conditional probability that site i is vacant when site j is known to be vacant, where sites i and j are nearest neighboring sites. Recall that A and B are vacant neighboring sites. We label the vertices adjacent to A (excluding B) by the index i (i = 1;:;) and the vertices adjacent to B (excluding A) by the values i = +1;:::2, as shown in Fig. 4. We de ne a random variable X_i which has the value 1 if the vertex i is vacant and the value 0 if a dimer is touching vertex i. On the Bethe lattice the X_i (i = 1;2;:::2) are independent random variables. Note that P (X_i = 1) is the conditional probability that a neighbor of B is vacant given that not only B but also A is vacant. On a Bethe lattice the condition that A is also vacant is irrelevant in this context, in which case P (X_i = 1) is just p_{con}, so that

W e focus our attention on a bond AB and we continue to consider the Bethe lattice. For this discussion we divide the lattice into two parts by cutting the bond AB, so that one part, T_A , contains site A and all sites accessible to site A without going through site B and the other part, T_B , is de ned similarly, as shown in Fig. 4. On the Bethe lattice, when the bond AB is unoccupied, these two parts T_A and T_B are independent subsystem s. In that case we see, from Eq. (86), that the "weight" of a con guration of either T_A or T_B is obtained as the product of (a) a factor = $z \exp[-(2q - 1)]$ for every bond covered by a dim er³² (the actual value of will not appear in the nal results) and (b) a factor e for every bond which is a dim er vacancy. 


FIG.5: Schem atic graphs of G () for < $_{\rm c}$ (left) and for > $_{\rm c}$ (right). In the right panel we show the line at ln [z_0 ()] at which the net area between the line and the curve of G () is zero. This is the \equal area" construction which gives z_0 (). We also show lines for a value of z (z_c) which is less than z_0 () and a value of z (z_c) which is larger than z_0 (). The values of $_j$ are the values of at which the line for z_0 () intersects G ().

W e close this section by discussing the accuracy of the \strong form of tree decoupling\ in which we approximate a d-dimensional lattice by a Bethe lattice of the same coordination number. Recall that in the tree decoupling introduced above Eq. (11) it was only assumed that we could neglect indirect paths which connect nearest neighboring sites A and B.A com parable approxim ation here is to assume that the conditional probability that a neighbor of site A is vacant given that both sites A and B are vacant is the same as the conditional probability when only site A is vacant. If this were the only approximation, then the present treatment of the interacting dim er system would be expected to be quite accurate -as is the tree decoupling for noninteracting dim ers.⁵ However, here we also started from the much stronger assum ption that the random variables X i introduced above Eq. (92) are independent of one another. On the Bethe lattice this is obviously true, as can be seen from Fig. 4. However, on a real lattice, this assumption neglects the m any next-nearest neighbor connections between the X i sites. This same neglect reappears if one tries to apply the subsequent calculation of p⁰ to a d dim ensional lattice. A coordingly it would not be surprising if the Bethe approximation for interacting dimers had an accuracy similar to that of mean eld theory for the Ising model in the same spatial dimensionality. In two dimensions, this would imply that the Bethe lattice value of $_{\rm c}$ may di er from the exact value for a d dim ensional lattice by about 30% .

B. Solution by Construction of an E ective H am iltonian $% \left({{{\mathbf{F}}_{\mathbf{F}}}^{T}} \right)$

In this section we generalize the e cetive H am iltonian for noninteracting dimers to include dimer-dimer interactions. We continue to mark sites with operators s_i which obey the trace rules of Eq. (15). But in addition we need to have operators which keep track of interactions. So at each site i we introduce operators t_i which have zero trace unless accompanied by an s_i operator. These operators commute with one another and obey

IV. QUENCHED RANDOMNESS

A. D im ers on Percolation C lusters at In nite Fugacity

Here we consider the statistics of dimers on a quenched random lattice in which sites can be either X "sites with probability p or Y " sites with probability 1 p. For a given con guration C (i. e. for a given distribution of X and Y sites), the grand canonical partition function, Z (C;fzg) for dimer coverings is calculated as

A n exact result for the dim er density on a B ethe lattice does not seem easy to obtain. However we now give an exact solution for the dim er density on a B ethe lattice in the lim it $z_{X | X}$! 1 and $z_{X | Y} = z_{Y | Y}$! 0. Thus we consider M_D (p), the average of the maximal number of dim ers which can be placed on percolation clusters of X sites. Even in this lim it the result is not trivial because the constraint that dim ers do not overlap plays a variable role depending on the com pactness of the cluster.

To obtain the exact solution we will explicitly evaluate the expansion of M $_{\rm D}$ (p) in powers of p. For this purpose we tem porarily consider M $_{\rm D}$ as a function of the set of pi's, where pi is the probability that site i is present (i. e. is an X site). Then we write




FIG . 6: Sm all clusters for which we give the cum ulant value of M .




FIG.7: Cluster of N sites in which site N is a free end.

V. RANDOM DEPOSITION

A. Introduction

Here we consider a special case of a model of catalysis⁴ in which hard-core dimers are random ly deposited on bonds and the hard-core constraint does not allow two dimers to intersect the same site. Deposition on all allowable bonds is equiprobable. A quantity of interest is the nal concentration when no further dimers can be deposited. We have not been able to construct such a solution on a Bethe lattice. However, here we give an exact solution of this model in one dimension.

To characterize this process it is essential to consider deposition on a line of bonds of nite length in one dimension. In order to consider deposition recursively, we therefore introduce the function F (i; j), (with i < j) which is de ned to be the average number of dimers which willultim ately be deposited in the interval between two preexisting dimers, one on bond i and the other on bond j. O byiously F (i; j) = F (i n; j n) and as shorthand we set F (1; j) F (j).

Let us see what this function is for sm all argument. It is clear that F (1;3) = F(1;4) = 0 because a new dimer can not be deposited on a bond neighboring an occupied bond, since neighboring bonds share a site which can not be occupied by two hard-core dimers. Next consider F (1;5) F (5). If we start with dimers on bonds # 1 and # 5, then an additional dimer can only be deposited on bond # 3, so

is the average number of dimers which will be deposited between dimers at sites # 1 and # 5. Similar considerations indicate that F (6) = 1 and F (7) = 5=3.

Next consider F (1;8). In the rst step an additional dim er will be placed on bonds # 3, # 4, # 5, or # 6, each with probability 1/4. If it is placed on bond #3 (or equivalently on bond # 6), then we have added one dim er and will be able to add (on average) F (1;3) + F (3;8) =0+1=1 further dimer in later step (s). Therefore in each case these two processes lead to the deposition of two dimers. So the combined contribution to F (1;8) from these two cases, each occurring with probability (1/4) is F(1;8) = 1. Similarly, if the rst new dimer is placed on bond #4 (or equivalently on bond #5), then we have added one dimer and will be able to add (on average) F(1;4) + F(4;8) = 0 + 1 = 1 further dim er. As before, the contribution to F (1;8) from these two cases, each occurring with probability (1/4) is F (1;8) = 1. Therefore we see that F(8) = 2.

B. Recursion Relation

Now imagine starting with dimers on bonds # 1 and N , with N > 4. The stadded dimer can go on bond # 3,

4, N 3, N 2, each with probability 1=(N 4). So, if we include this added dimerwe have

is the fraction of sites which remain vacant in the jam - ming limit (after deposition is completed).

VI. SUMMARY

In this paper we have presented two approaches, which we call geom etric and algebraic, for the analysis of dimer statistics. B oth approaches yield exact results when the lattice does not have bops, as for a Bethe lattice. The charm of the geom etricalm ethod is that it starts from the m ost basic statem ent, namely that in a grand canonical ensem ble, the activity z is precisely the ratio of the statisticalw eights of the N-particle system to that of the N + 1particle system. The virtue of the algebraic approach is that once the H am iltonian is constructed using operators whose trace rules incorporate kinem atic restrictions, the standard procedures of statistical mechanics can be applied, for instance to obtain series expansions for nite dimensional lattices. (This approach was used²⁶ to give a

eld theoretic analysis of the m onom er-dim er problem .) H ere we also show that the use of replicas (which norm ally are invoked to im plem ent quenched averages of a random H am iltonian) can be useful in converting a series for the partition function into one for its logarithm, the free energy. Exact solutions for generalizations in which a) the lattice is an isotropic orb) dim er-dim er interactions are included were also developed using both approaches. W e give an exact solution for dim er statistics on a B ethe lattice in a sim ple quenched random potential in which dim ers are placed on percolation clusters. F inally, we developed an exact solution for the fraction of sites which rem ain vacant after random disposition is com pleted in a one dim ensional system .

APPENDIX A: ANALYSIS OF THE PHASE TRANSITION

The phase transition in the presence of dim er-dim er interactions is entirely similar to that in the van der W aals gas.

The right-hand side of Eq. (105) gives an explicit formula for zP (N_D + 1)=P (N_D) when Eq. (103) is used.³² Thus we have

Figure 5 shows schem atic graphs of G () versus for slightly less than and slightly greater than $_{\rm c}$. For = 2 we nd $_{\rm c}$ 4:95 and the value of at the critical point is $_{\rm c}$ 0:159, G ($_{\rm c}$) = 3:226, and $z_{\rm c}$ 0:0199.

If > $_{\rm c}$ and z is close to $z_{\rm c}$, a horizontal line (dashed in Fig. 5) at height ln(l= z) will intersect the graph of G () three times, each of the intersections corresponding to a value of N_D for which P (N_D + 1)=P (N_D) = 1. If we denote the intersections $y_1 < y_2 < y_3$ and the corre-

sponding density of dimers $_1$, $_2$, and $_3$, then we have

If z_0 () is the value of z such that the area of the loop below the dashed line at height ln (1= z) is equal to the area of the loop above that line, then P (3)=P (1) = 1. If z is slightly less than z_0 , then the negative area exceeds the positive area and P (3)=P (1) < 1, in which case is the stable phase has = 1. Note that 2 is always less probable than 1. Sim ilarly, if z is slightly greater than $z_0 z = z_<$, then the stable (most probable) phase corresponds to = 3. Note that because of the prefactor N q=2 before the integral, \m ost probably" m eans \overwhelm ingly m ost probable."

If we place a density of dimers on the lattice which is intermediate between $_1(z_0)$ and $_3(z_0)$, the lattice will separate into regions with coverage at densities $_1(z_0)$ and $_3(z_0)$, the size of the two regions being determined by the requirement that the total number of dimers is that specied.

If is slightly greater than $_{\rm c}$, then the tem perature T is slightly less than $T_{\rm c}$ and the denition of implies that (T_c T) / ($_{\rm c}$). In this case the distance between the two roots of Eq. (109) is proportional to ($_{\rm c}$)^{1=2}, and thus the distance between the corresponding value of is also proportional to ($_{\rm c}$)^{1=2}, which is proportional to $T_{\rm c}$ T)^{1=2}. Exam ination of F ig. 5, without additional analysis, makes it clear that the dimension of the distance in density between the two coexisting phases, $y_3(z_0) = y_1(z_0)$ is also proportional to ($T_{\rm c}$ T)^{1=2}.

APPENDIX B:MEAN FIELD THEORY

In this appendix we obtain mean eld theory for interacting dimers from the Ham iltonian using the standard decoupling even though this Ham iltonian involves operators which obey unusual trace rules.

In view of the trace rules (extended to in nite q) we may write

The last equation gives t_c , the value of hti at the critical point, to be $t_c = \frac{1}{2}$. Putting this into the preceding equation gives $q_{c} = \frac{1}{2} + (3=2)$.

W e m ay compare this with the solution for the Bethe lattice. For simple models (such as the Ising model) it is known that the Bethe lattice solution only coincides with mean eld theory for large q. For large q the Bethe lattice solution for T_c given by Eq. (112) agrees with the present result.

APPENDIX C:GEOMETRICAL CALCULATION OF FIRST LOOP CORRECTION FOR THE TRIANGULAR LATTICE

For the triangular lattice, a simple geometrical argument permits us to calculate most of the dierence between the "exact" value of $\overline{N}_D = N$ (notation as in Table I) and the value given by the Bethe approximation. The argument depends on the "tight" structure of the triangular lattice, and we have not been able to extend the argument to the square lattice. Furthermore, unlike the "loop corrections" calculated in Sec. IIC, our geometrical calculation is not the rst term in a systematic series of corrections. Nevertheless, the calculation is simple and remarkably accurate. From Eq. (7) we have




FIG.8: A portion of the triangular lattice.

The computer readily calculates for each value of z in Table II. The corresponding value of $\overline{N}_{D} = N$, which we call _G, is 3 and is exhibited in Table II.

Thus, a simple geom etrical argument yields a good estimate of the "rst loop correction" for the triangular lattice. However, we have been unable to make a corresponding argument for the square lattice, nor can we extend this argument in an orderly way to make higher order corrections.
