Subdi usive axial transport of granular materials in a long drum mixer

G ranular m ixtures rapidly segregate radially by size when tum bled in a partially lled horizontal drum. The sm aller component m oves tow and the axis of rotation and forms a buried core, which then splits into axial bands. M odels have generally assumed that the axial segregation is opposed by di usion. U sing narrow pulses of the sm aller component as initial conditions, we have characterized axial transport in the core. We nd that the axial advance of the segregated core is well described by a self-sim ilar concentration pro lewhose width scales as t, with 0:3 < 1=2. Thus, the process is subdi usive rather than di usive as previously assumed. We nd that is nearly independent of the grain type and drum rotation rate within the sm oothly stream ing regime. We compare our results to two one-dimensional PDE m odels which contain self-sim ilarity and subdi usion; a linear fractional di usion m odel and the nonlinear porous medium equation.

An interesting property of dry granular materials is their tendency to separate by size under a wide variety of ow conditions [1, 2]. Granular segregation is widely found in nature, and plagues industrial processes as well. P robably the best controlled and m ost widely studied example is segregation along the axis of a partially lled, horizontal \drum m ixer" [3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15]. A fter hundreds of drum rotations, an initially m ixed binary distribution of di erent-sized grains sorts itself into almost periodic bands along the axis of the drum. These bands are threaded by a radial core of the smaller grains which develops prior to axial band form ation [5, 6, 10, 13, 14, 15]. The radial core typically form s after just a few drum rotations. Accounting for this rich dynam ical behaviour has been the goal of cellular autom ata m odels [16], m olecular-dynam ics sim ulations [18] and several continuum theories [19, 20, 21, 22, 23, 24, 25]. The axial bands must som ehow be sustained against being mixed away by the random motion of the grains. Continuum models have generally assumed that the random motions min ic normaldi usion, and therefore that norm al Laplacian gradient terms determ ine the shortwavelength cuto of the axial band pattern. In this Letter, we experimentally challenge this common assum ption.We nd, surprisingly, that the axial transport of the radially segregated core along the drum is much slower than di usion, i.e. that it is subdi usive. It is nevertheless described by a self-similar pro le which scales approximately as $t^{1=3}$. We also nd that the self-di usion of the larger particles is subdi usive. These results have strong implications for models of axial segregation, and possibly for other theories of granular mixing.

Early theoretical models regarded axial band form ation as the result of a di usion process with a negative di usion coe cient [19, 20, 22]. These models ignore the radially segregated core, and they cannot account for the oscillatory transient that precedes axial band form ation in som e m ixtures [8, 9, 11]. This oscillatory travelling

wave state apparently dem ands that the basic dynam ics be at least second order in time. A later model due to A ranson et. al [23, 24] reproduced both axial segregation as well as the oscillatory transient, while still ignoring the core. We have recently shown experimentally that this model is also inadequate [10], and that the core dynam ics are them selves oscillatory. A nother m odel due to Elperin et. al [25] regards axial segregation as resulting from a radial core instability leading to a spatially periodic thickening of the core. This model, unfortunately, also cannot account for the travelling wave state. In all cases, these models explain the short wavelength cuto of the axial band pattern as the result of the supposed axial di usion of the smaller grains. We show experimentally below that axial transport is not well-described by normaldi usion. This is true of either the smaller grains in a binary m ixture or of the larger grains in a self-m ixing process. This falsi es a common, basic assumption of segregation m odels.

A few studies have investigated the axial transport of grains experim entally [13, 14, 15, 17], but none have system atically investigated the e ects of varying grain type and drum rotation rate. Here we report experiments which characterize the axial transport of radially segregated grains using several di erent grain types and drum rotation rates, starting with a narrow pulse initial condition.

The drum mixer used in all experiments consisted of a horizontal P yrex tube, 600 mm long with an inner diameter of 28.5 mm, rotated about its long axis at a constant rotation rate of 0.31 rev=s or 0.62 rev=s. The larger grains were either cubic white table salt or transparent glass spheres and had a size range of 300-420 m. The smaller grains were either irregularly shaped black hobby sand or bronze spheres, with a size range of 177-212 m. The lled volume fraction of the drum was 28 %. In order to reproducably llthe drum, the grains were loaded into a long U-shaped channel, which was inserted lengthwise into the drum and rotated to deposit its contents. This procedure ensures a uniform lling fraction of the




FIG. 1: (Color online) a) An image of the shadow of the radial core form ed by 177-212 m sand grains within 300-420 m salt grains. b) The detected edge used to determ ine the vertical extent h (x;t) of the core. c) The x integral of h is not constant in time, and is thus not proportional to the volume of sm all grains contained within the radial core. d) The integral of h^2 is constant in time and is proportional to the desired concentration.

drum. To obtain reproducible, quantitative dynamical information, we used a pulse initial condition. The pulse was made by placing thin spacers in the U-shaped channel1.5 mm apart. The 1.5 mm space was lled with the smaller grains, and the remaining space was lled with the larger grains.

After a few drum revolutions, the pulse of sm all grains form s a subsurface radial core and cannot be observed using standard surface lighting and video in aging techniques. Instead, we used a bulk visualisation technique developed by Khan et al [10]. The large grains are transluscent and the sm all grains are opaque. W hen a bright light source is placed behind the rotating drum, one can observe a shadow of the radial core on the front face of the granular sample. This shadow is a twodim ensional projection of the radial core. A computer controlled high speed cam era was used to observe the radial core shadow. Five in ages per drum revolution were obtained and averaged to determ ine the evolution of the radial core. Figure 1a shows a typical in age of the radial core shadow. U sing edge detection, the radial core height h(x;t) was measured as shown in qure 1b, and

expressed as a fraction of the full height of the material




FIG.2: (Coloronline) a) Concentration pro less fa spreading radial core pulse of sand grains within salt grains at various times. b) Power-law scaling of the FW HM of the radial core pulse. From the linear t (yellow line) we nd that the width / $t^{0:38}$.c) Collapsed concentration pro less of the radial core pulse corresponding to (a). The collapse parameter is = 0:37.

in the drum . If we assume that any cross section of the three dimensional structure of the radial core is an ellipsoid, the square of the diameter of the radial core h^2 is proportional to the volume of small grains contained in the radial core at each axial position x. Figure 1c shows

the tim e evolution of the x integral of h, which increases with time. Figure 1d shows that the x integral of h^2 is constant in time, as it should be for a conserved quantity. This validates our assumption about the core shape, and demonstrates that h^2 can be used as a local concentration

m easure. The error in m easurem ent of h^2 corresponding to an error in h of 2 pixels.

For a normal di usive process, the width of a narrow pulse initial condition grows as t^{1-2} . In our experim ent, the pulse of sm all grains do not m ix into the larger ones, but instead the pulse sinks below the surface of the larger grains forming a radial core, which then spreads axially. We can nevertheless ask if this axial spreading is analogous to norm aldi usion, as is assumed in m odels[19, 20, 22, 23, 24, 25]. Figure 2a shows the radial core concentration pro le at di erent tim es, for a mixture of sm all sand grains and large salt grains. P lotting the full-width at half-maximum of the concentration pro le against time, we determ ined the power-law dependence of the radial core width with time, as shown in aure 2b. From this, we determ ined that the width scales as t, where < 1=2. This analysis, how ever, only determines the power-law time dependence of one arbitrarily chosen dimension of a pulse (here, the half-m axim um width) and not the whole pulse shape. For a symmetric initial condition, data collapse can test the scaling of the entire pulse. Figure 2c shows collapsed data corresponding to the concentration pro les in 2a, where the axial length scale was transformed as x ! xt and the axial concentration of sm all grains C (x;t) was transform ed as C ! Ct. The pulse width increases at the same rate as the pulse am plitude decreases, thus the spreading process is self-sim ilar. This implies that the integrated concentration is constant and that no grains are lost from the core. The average collapse parameter for large salt grains and sm all sand grains with a drum rotation rate of 0.62 rev=s is = 0.37 0.03, averaged over 10 runs. Similar experiments were repeated for dierent combinations of grains at two drum rotation rates. The results are shown in table 1 I. We conclude that cores of sm all grains spread axially ast where 1=3 < 1=2, independent of grain type and drum rotation rate within the sm oothly stream ing regime.




FIG.3: (Color online) a) Concentration proles of a mixing pulse of dyed black salt grains surrounded by white salt grains. b) Collapsed concentration proles corresponding to a). The collapse parameter is = 0.3.

It is interesting to compare the spreading of radially segregated cores of sm all grains with the non-segregating self-di usion of the large grains alone. To observe this experim entally, som e of the large grains were dyed black. These dyed grains were loaded into a drum full of otherwise identical white grains with a 1.5 mm wide pulse as the initial condition. The space-time evolution was observed using standard surface-lighting and im aging techniques [8, 9]. Figure 3a shows the concentration pro le of dyed salt particles at various times. This data was collapsed in a similar way as discussed previously, as shown in gure 3b. Again, we nd a collapse parameter < 1=2. For runs using salt grains, $= 29 \quad 0.01$ and for runs using glass spheres, = 34 0:04, each averaged over 5 runs. Thus, we conclude that the self-di usion of grains in the rotating drum is also subdi usive, even when no segregation is involved. W e discuss som e di erences between these two cases below.

In addition to exam ining the tem poral scaling of the pulse, we can also measure in detail the functional shape of the scaling solution. Here is it possible to distinguish between di erent subdi usive processes. We have investigated two candidate models for radial core spreading; the fractional di usion equation (FDE) and the porous medium equation (PME). The fractional di usion equation is

$$\frac{\theta}{\theta t} C (x;t) = D \frac{\theta^2}{\theta x^2} C (x;t); \qquad (1)$$

where = 2 denotes the order of a fractional time derivative [26, 27]. Solutions of this linear equation have the property that the width of a narrow pulse initial condition grows as t, where 1=2. If = 1=2, the solution reduces to normal Fick di usion. This FDE model is often used to describe processes which occur in spaces where there are temporal or spatial constraints, such as the ow of tracers through porous media [28]. The FDE has an analytic series solution in term s of Fox's H-Functions [26, 27], which form s the self-sim ilar scaling solution. We also exam need the porous media media (PME),

$$\frac{\theta}{\theta t}C(\mathbf{x};t) = D'\frac{\theta^2}{\theta \mathbf{x}^2}(C(\mathbf{x};t)^2):$$

This nonlinear model describes the spreading of a compact mound, and has the property that for a narrow pulse initial condition, the width grows as $t^{1=3}$, and the scaling solution has a parabolic pro le[29].

We tradial core concentration data collapsed with as a free parameter to the series solution of the FDE, and data collapsed with = 1=3 to a num erical solution of the PME, as shown in gure 4a and b respectively. We nd that while both solutions model the collapsed concentration pro les reasonably well within experim entalerror, the PME has a smaller system atic discrepancy, since the pro les are better described as parabolic. The FDE solution has exponential wings and in ection points that are not obvious in the data. We note, how ever, that our projection visualization technique may simply be too insensitive to detect these tails.

We also t the non-segregating self-di usion of the large grains to both models and nd that the FDE gives a qualitatively better t because in this case, the concentration pro les have tails within experimental resolution, while the parabolic PME solution does not. Examples of these ts to collapsed concentration pro les of mixing salt grains are shown in gures 4c-d. In all cases, how - ever, ts to ordinary Fick di usion with = 1=2 are very poor.

In conclusion, our results show that the axial transport of grains in a rotating tube is a subdi usive process. This is true of both sm all particles comprising a segregated radial core as well as for surface m ixing of larger grains. In all cases, we not tem porally self-sim lar concentration profiles that scale approximately as $t^{=3}$. These conclusions suggest that spontaneous axial segregation patterns in such tubes are more weakly damped, in the sense that they are sustained against slower mixing processes, than has been previously supposed. The goal of our future work is to elucidate the connection between axial band form ation and the axial transport of grains, which is still unclear.




FIG. 4: (Color online) Collapsed concentration pro les of a black sand radial core in salt grains tto: a) the fractional diffusion equation (yellow line), b) the porous medium equation (yellow line). Collapsed concentration pro les of mixing dyed black salt grains tto: c) the fractional di usion equation (yellow line), d) the porous medium equation (yellow line).
