B reakdown of Hydrodynam ics in the Radial B reathing Mode of a Strongly-Interacting Ferm i Gas

We measure the magnetic eld dependence of the frequency and damping time for the radial breathing mode of an optically trapped, Fermigas of 6 Liatoms near a Feshbach resonance. The measurements address the apparent discrepancy between the results of K inast et al., [Phys. Rev. Lett. 92, 150402 (2004)] and those of Bartenstein et al., [Phys. Rev. Lett. 92, 203201 (2004)]. Over the range of magnetic eld from 770 G to 910 G, the measurements con rm the results of K inast et al. C lose to resonance, the measured frequencies are in excellent agreement with predictions for a unitary hydrodynamic gas. At a eld of 925 G, the measured frequency begins to decrease below predictions. For elds near 1080 G, we observe a breakdown of hydrodynamic behavior, which is manifested by a sharp increase in frequency and damping rate. The observed breakdown is in qualitative agreement with the sharp transition observed by Bartenstein et al., at 910 G.

Optically trapped, strongly-interacting Ferm i gases of atom s [1, 2] are possibly the most convenient and exible systems for exploring the rich physics of the BEC-BCS crossover [3], i.e., the transitional regime between Bose and Ferm i statistics. A tom ic system s are unique in that the state of the gas can be tuned throughout the whole crossover region, simply by varying a magnetic eld. The last two years have seen explosive progress in experim ents on degenerate, strongly-interacting Ferm i gases which include anisotropic expansion [2], studies of universal interactions [2, 4, 5], and molecular condensates on the BEC side of the crossover [4, 6, 7, 8]. Recently, m icroscopic evidence for super uidity has been obtained by observing preform ed pairs on the BCS side [9, 10] and by measurement of the gap [11, 12]. The focus of this Rapid Communication is on extension and veri cation of experim ents which probe the macroscopic properties of the trapped gas by studying the breathing mode [13, 14]. M apping the frequency of the mode throughout the BEC-BCS crossover, as a function of the magnetic eld, tests the predictions for the equation of state and can be used to verify current m any-body calculational m ethods.

K inast et al. [13], have m easured the frequencies and dam ping times of the radial breathing mode in an optically trapped gas of ⁶Linear a Feshbach resonance [13]. They not that for magnetic elds in the range of 770–910 G, the frequencies are close to the hydrodynamic predictions [15, 16, 17, 18, 19, 20] and that the damping rate drops rapidly as the temperature is lowered. The temperature dependence of the damping rate is consistent with a transition to a super uid state at low temperature and inconsistent with a picture of a collisional normal uid [21, 22, 23]. Bartenstein et al., also have measured the magnetic eld dependence of the frequencies for both the axial and radial breathing modes of an optically trapped gas of ⁶Li [14]. For the axial mode, the agreement with predictions for a hydrodynamic gas

is quite good [17, 20, 24] and the minimum damping rate is very low. In contrast, the measured frequencies for the radial mode are 9% below the predictions of hydrodynamics, and both the frequency of the radial breathing mode and the damping rate exhibit an abrupt increase at a magnetic eld near 910 G. Further, the damping rate measured near 910 G by Bartenstein et al., exceeds the maximum damping rate allowed in a collisional gas by more than a factor of 5, signaling a possible transition between a super uid state and a normal gas.

The discrepancies between the two groups in the measured frequencies and damping rates of the radial breathing mode motivated an additional study of the magnetic eld dependence. In this paper, we describe new measurements of the magnetic eld dependence of the radial breathing mode in an optically trapped, resonantly interacting gas of $^6\mathrm{Li}$, over a magnetic eld range from 750–1114 G (the widest range accessible to us at present). For elds below 950 G, we not that the measurements conmm the results obtained by K inast et al., [13]. For elds near 1080 G, we observe a breakdown of hydrodynamic behavior, which is manifested in a sharp increase in frequency and damping rate. The observed breakdown is in qualitative agreement with the sharp transition observed by Bartenstein et al., [14], which occurred at 910 G.

In the measurements, we prepare a highly degenerate $50-50 \, \mathrm{m}$ ixture of the two lowest spin states of $^6\mathrm{Liatom}$ s in an ultrastable CO2 laser trap [25], using forced evaporation near a Feshbach resonance [2]. The trap depth is lowered by a factor of ' 580 over 4 s, then recompressed to 4.6% of the full trap depth in 1 s and held for 0.5 s to assure equilibrium. The number of atoms is determined from the column density obtained by absorption imaging on a two-level state-selective cycling transition [2, 13]. In the measurements of the cloud column density, we take optical saturation into account exactly and arrange to have very sm all optical pum ping out of the two-level system . The column density is integrated in the axial direction and divided by the total atom number to obtain the one dim ensional density n (x), which is normalized to 1. Fitting the measured distributions of the expanded cloud

w ith a Thom as Ferm idistribution yields the cloud radius and the reduced tem perature (T=T $_F$) $_{fit}$ ′ 0:1, where T $_F$ is the Ferm i tem perature.

To excite the transverse breathing mode, the trap is turned o abruptly (1 s) and turned back on after a delay of $t_0=25\,$ s. Then the sample is held for a variable time $t_{\rm hold}$. Finally, the trap is extinguished suddenly, releasing the gas which is in aged after 1 m s. The temperature increase from the excitation is estimated as $T=T_{\rm F}=0.015\,$ when the gas therm alizes [13].

To determ ine the breathing mode frequency and dam ping time, the transverse spatial distribution of the cloud is twith a one dimensional zero-tem perature Thomas-Fermi (T-F) prole to extract the radius, $_{\rm TF}$ as a function of $t_{\rm hold}$. To acquire each curve, 60-90 equally spaced values of $t_{\rm hold}$ are chosen in the time range of interest. The chosen values of $t_{\rm hold}$ are randomly ordered during data acquisition to avoid systematic error. Three full sequences are obtained and averaged. The averaged data is twith a damped sinusoid x_0 + A exp($t_{\rm hold}$) sin(! $t_{\rm hold}$ + '). For a t_0 = 25 s excitation time, we observe damping times up to = 7 ms for both the interacting and noninteracting gas at 4.6% of full trap depth.

We normalize the breathing mode frequencies to the transverse oscillation frequency !? for the noninteracting gas at 526 G, where the scattering length is nearly zero [26, 27]. Param etric resonance measurements yield the trap oscillation frequencies (uncorrected for anharmonicity) $!_x = 2$ 1600 (10) H z, $!_y = 2$ 1500 (10) Hz and $!_z = 2$ 70(5) Hz at 4.6% of full trap depth. As in our previous study, the frequency !x is also calibrated by exciting the breathing mode in a noninteracting sample, which yields agreement to 1%. In addition, the measured breathing mode frequency $2!_x$ is used to scale the value of!? for m easurem ents m ade on di erent days, since small changes in the laser power alter the trap oscillation frequencies. Typically, we obtain a total atom number N = 2.0(0.2) 10^5 at temperatures $(T=T_F)_{fit}$ ' 0:1. From the measured trap frequencies, we nd (after correction for anham onicity using Eq. 1 below) ! $_{?} = ^{p} \frac{1}{1 \times 1} = 2$ 1596(7) Hz, and $! = (!_{x}!_{y}!_{z})^{1=3} = 2$ 560 (13) Hz. For these parameters, the typical Ferm item perature for a noninteracting gas is $T_F = (3N)^{1-3}h! = k_B ' 22 K, small compared to$ the naltrap depth of 35 K.

A nharm onicity arising from the gaussian trapping potential reduces the measured frequencies! $^{\rm m}$ eas from their zero-energy harm onic oscillator values! . The transverse oscillation frequency! $_{\rm ?}$ for the noninteracting gas at 526 G is corrected using the formula [28],

Where U is the trap depth, M is the 6 Lim ass, and $b_B = 1 + (!_x t)^2 = 10.3$ is the ballistic expansion factor for the release time t = 1 ms. Note that the rms width for the ballistically expanding gas is $x_{B \text{ rm s}} = \frac{B}{T_F} = 8$,

where $^{B}_{\text{TF}}$ is the transverse T-F radius of the ballistically expanded cloud at 526 G .

The m easured hydrodynam ic frequencies $!_{\rm H}$ are corrected for anharm onicity using [28]

Here, b_{ti} is the hydrodynam ic expansion factor [2, 29], 11.3 after 1 m s, and $x_{tm \, s} = \frac{1}{T \, F} = \frac{1}{8}$ is the m s width for the interacting gas after expansion. Note that b_{ti} rather than b_{ti} is used to estimate the trapped cloud m s radius because we observe anisotropic expansion of the gas [2] which is in good agreement with the predictions of hydrodynamics [2, 29].




FIG. 1: M agnetic eld dependence of the frequency ! of the radial breathing m ode. Solid line is the theory based on super uid hydrodynamics from Hu et al. [17]. Dashed line is the hydrodynamic frequency for a unitarity gas, 10=3, as predicted at resonance. Note that the top (m agnetic eld) axis is not linear.

The extracted ratios of the corrected frequencies, $!_{\rm H}$ =! $_2$, and the m easured damping ratios 1=(! $_2$) are given in Table 1 as a function of magnetic eld. The frequencies are plotted in Fig. 1 as a function of magnetic eld. The lower horizontal scale gives 1=(k_F a), where k_F is the Ferm i wavevector at the trap center hk_F = $\frac{k_F}{2M}$ k_B T_F and a = a (B) is the scattering length. Note that we assume that the Feshbach resonance is located at 834 G , consistent with the best recent estimates [30, 31]. The solid curves in Fig. 1 show the predic-

tions for the frequency by H u et al. based on assum ptions of super uid hydrodynam ics [17, 32].




FIG. 2: M agnetic eld dependence of the dam ping rate 1= of the radial breathing m ode. D am ping rate (solid circles, axis labelled on the right); frequency (data{open circles, theory{ solid curve, axis labelled on the left). Solid curve (predicted frequency). The maximum damping ratio occurs at 1080G and exceeds the maximum 0.09 perm itted for collisional dynam ics by a factor of two. Note that the top (magnetic eld) axis is not linear.

The data exhibit several interesting features. For elds near resonance, the measured radial breathing mode frequencies are in very good agreement with hydrodynamic theory [15, 16, 17, 18, 19], con ming our previous measurements [13]. Further, the measured breathing mode frequency at 840 G , $!_{\rm H}$ =! $_2$ = 1.829 (.006), is very close to that predicted for a unitary—limited, hydrodynamic Ferm i gas, where $!_{\rm H}$ =! $_2$ = 10-3 = 1.826. Fig. 2 shows that the damping rates are small near resonance. The maximum damping time of 7 ms, obtained near resonance, corresponds to a minimum damping ratio

 $1=(!_{?})=0.014$, or about 20 periods of hydrodynam ic oscillation.

Away from resonance, the data in Fig. 1 exhibit qualitative agreem ent with the hydrodynam ic theory of Hu et al. [17]. However, the frequencies measured well below resonance, at 750 G and 770 G, are lower than predicted by approximately two standard deviations. Further, above resonance, the measured magnetic eld dependence of the frequency is compressed. In addition, there is a region where the data are consistently below the theory and this is followed by a region where the data are consistently above. The frequency reaches its lowest value at 925 G, dropping below the theory by three standard deviations, and then it rises rapidly at 1080 G.At the highest eld achievable with our magnets, 1114 G, the frequency is well above the theoretical prediction, but does not reach the asymptote, 2!x, for a noninteracting gas. In this region above resonance, we observe a clear breakdown of hydrodynam ics, both in the rapid change in frequency at 1080 G and in the damping rate. A transition is obvious in Fig. 2, which shows the dam ping rate as a function of B. Near 1080 G, the dam ping rate increases to 0:17!?, well above the maximum 0:09!? attainable by collisional hydrodynam ics [21, 22]. The observed behavior is therefore in qualitative agreement with the abrupt frequency change and increased dam ping observed by the Innsbruck group [14]. However, our results di er from those of Bartenstein et al., in two im portant respects: i) Near resonance, our observations for the radial breathing mode agree with hydrodynamic theory; ii) the eld of 1080 G, at which we observe the com plete breakdown of hydrodynam ics and rapid dam ping, is substantially higher than the 910 G value observed by the Innsbruck group [14].

The Innsbruck group has suggested that the break-

down may arise when the zero temperature BCS energy gap is smaller than the collective mode energy h! [14]. Zubarev [18, 19] has determ ined the trap averaged value of and shows that if the abrupt transition occurs at 910 G for the Innsbruck group, then for the conditions of our trap, we should observe the transition near 1000 G, assum ing $3 10^5$ atom s. U sing sim ilar estim ates, we nd that at 910 G, '2h! for the conditions of the Innsbruck group and 'h! for our trap conditions at 1080 G . Since single particle excitations have a m in im um energy of 2, perhaps the condition = h! underestim ates the required collective m ode energy for complete pair breaking. However, it has been noted by Heiselberg [33] that in-gap surface modes have a smaller energy than , but scale sim ilarly, possibly accounting for the observed breakdown at > h!.

For the conditions of the Innsbruck group, the breakpoint occurs at the same magnetic eld of 910 G at a shallow trap depth and for a trap depth increased by a factor of 9 [14]. This magnetic eld independence was rst explained by the Innsbruck group and arises as follows. In their case (but not in ours) the axial con nement is provided primarily by the bias eld magnets, and the ratio of the Ferm i energy to h! $_{?}$ and hence to h! decreases with increasing trap depth. Then, using the most recent values of the scattering length [31], we not the increase in $k_{\rm F}$ in the exponent of the pairing gap compensates for this reduction at 930 G , consistent with their argument.

W e can obtain an alternative estim ate of the m agnetic eld at which an abrupt change occurs using an idea due to Falco and Stoof [34]. They suggest that when the Feshbach (v=38) m olecular state in the singlet potential has a higher energy than the two-particle Ferm i energy (relative to the zero of the triplet potential), the system becomes BCS-like. In this case, the system may not be interacting strongly enough to remain super uid at the temperatures we achieve. A simple estimate of the breakdown magnetic eld is then obtained from

W e assum e that near resonance, interactions make the sam e contribution to the chem ical potential of free triplet atoms and to very weakly bound atoms in large singlet m olecules. We also assume the energy of the molecular state is $b = h^2 = M a^2$ relative to the zero of energy in the triplet potential, which is valid in the two-body case near the Feshbach resonance. Using the trap averaged local Fermi energy, we obtain $2h_F$ (x) i_D = (5=4) k_B T_F = $(5=8) h^2 k_F^2 = M$, so that $1=(k_F a) =$ 5=8 = 0:79.From Table I, we see that at B = 1080 G, $1=(k_F \text{ a}) =$ 0:74, in reasonable agreem ent. Unfortunately, our sim ple hypothesis cannot explain the insensitivity of the B eld value with respect to trap depth observed by Bartenstein et al.: Scaling our Fermi energy down from 22 K to 12 K for the conditions of the Innsbruck group, we predict a transition near B = 970 G, higher than observed.

In sum m ary, we have measured the magnetic eld dependence of the frequencies and damping rates of the radial breathing mode for a strongly interacting Ferm i gas of $^6\mathrm{Li}$. The measurements are in very good agreement with the predictions of hydrodynamics near the Feshbach resonance at 834 G, but we observe a breakdown of hydrodynamics away from resonance. Beginning at higher elds near 925 G we observe rst a frequency decrease, well-below predictions, and then an abrupt frequency increase at a eld of 1080 G, accompanied by rapid damping, which exceeds the maximum damping for a collisional norm al uid.
