Point scatterers in low number of dimensions

It is well known that in 1D the cross section of a point scatterer increases along with the scatterer's strength (potential). In this paper we show that this is an exceptional case, and in all the other cases, where a point defect has a physical meaning, i.e., 0 < d < 1 and 1 < d = 2 (d is the dimensions number), the cross section does not increase monotonically with the scatterer's strength. In fact, the cross section exhibits a resonance dependence on the scatterer's strength, and in the singular 2D case it gets its maximum value for an in nitely weak strength. We use this fact to show that two totally dimensions can describe exactly the same physical entity (the same scatterer).

It is well known that in general the cross section of a scattering process does not have a monotonic dependence on scatterers strength (potential). On the contrary, the spectral vicinity of resonances causes the main impact on the scattering process. However, when sm all scatterers (com pared to the incident scattered particle's wavelength) are under consideration, no such resonances can occur, and the scatterer's strength has a direct in uence on the scattering cross section. In 3D this process is known as Rayleigh scattering in Optics, and Born approximation in Quantum Mechanics (QM), and unlike M is scattering (in Optics term inology) has a very simple dependence on the scatterer's strength: the cross section is proportional to the square of the scatterer's strength (scatterer's potential in the QM picture), i.e., $/ V^{2}$. Sim ilarly, in 1D the re ection coe cient monotonically increases along with the scatterer's strength:

(L is the scatterer's width, ! is the incoming particles' energy and V is the scatterer's potential hereinafter we adopt the units h = 2m = 1).

In this paper we show that these cases are the exceptions: in general, the cross section does not have a m onotonic dependence on the scatterer's strength, even when the scatterer is m erely a point defect. In particular we investigate without approximations the dimensionality regime $0 < d_2$ for a point scatterer, and we show that the d = 1 is the only case in this regime, in which the cross section increases m onotonically with the scatterer strength (potential). In all the other cases (other dimensions), we prove that beyond a certain potential ("strength") value, the scattering cross section starts to decrease.

The stationary-state Schrodinger equation in ddimensions reads:

where we adopt again the units h = 2m = 1 (m is the particle's mass), p^2 is the particle's energy, is the parameter which characterizes the point scatterer's strength, r^2 is the d-dimensions Laplacian, and ^d (r) is the D irac delta function in d-dimensions (r is the vector in d-dimensional space).

Let us denote by G $_{\rm d}$ (r) the d-dimensions G reen function, i.e.,

and by $_{\rm inc}$ (r) the incident wave function. It is then straightforward that the scattered wave function is sim – ply and exactly

where the scattering coe cient is equal (exactly) to (for $d < \ 2)$

Thus, the problem is reduced to an evaluation of the G reen function.

The Green function is required in two regimes: for jrj! 1

where (d) $2^{d} (d^{2})=2 \tan \frac{d}{2} \cdot W \in \text{im m edi-}$ ately recognize a resonance pattern in eq.(8).

In general, the physics encapsulated in Eq.(8) can be divided into four categories:

For 0 < d < 1, a resonance occurs only for positive , i.e., only barriers (in contrast to wells) demonstrate a non-monotonic dependence on the scatterer's strength ()

For d = 1, the scattering coe cient (in this case equivalent to the re ection coe cient) is reduced to the well-known equation

and the dependence (on $\)$ is monotonic (and is independent of the sign of $\).$

For 1 < d < 2, the non-m onotonic behavior appears again but this time only for negative (that is, only for wells).

d = 2 is a more complicated case, and will be discussed seperately in this paper, but the same general nonmonotonic dependence still holds in the 2D case.

To investigate the resonant nature of Eq.(8) and the way it depends on dimensionality, it is more convenient to use, instead of the enrgy p^2 , the dimensionless energy

where $_{\rm d}$ is a universal function, which depends m erely on the dimensions number, i.e.,

Therefore, the maximum corss section is obtained for

for any d, and the scattering coe cient m axim um value is

For the 2D case, Eq.(12) may be a bit m isleading, for it suggests an in nitely strong scattering coe cient, i.e., jf_{max}^2 (2 d)² for d ! 2. However, this value is obtained, as Eqs.(10) and (11) im ply, only at "! 1. For any nite energy (i.e., " < 1) jfj^2 is in nitely small (like (2 d)²).

Before investigating the d = 2 any further, it is instructive to investigate the non-monotonic dependence of the scattering coe cient $jf j^2$ on the scatterer's strength . For convenience, let us use the following dimensionless physical parameters: the scattering coe cient (which is proportional to the scattering cross section)




FIG.1. A plot of the norm alized scattering ∞ cient F as a function of the norm alized "strength" for d = 0.4;1 and 1.8. Only in the d = 1 case there is no local maximum.

This function is plotted in Fig.1 for the d = 0.4;1 and 1.8 cases. It is clear that in general this function is not monotonic. It gets its maximum value for

and therefore,




FIG.2. A plot of F $_{\rm m\,\,ax}$ and F $_{\rm in\,f}$ as a function of d.

Two universal dimensions appear: F_{max} receives its minimum value for d' 0.81 and F_{min} receives its maximum value for d = 1:19, however they get the same value with the same derivative only at d = 1 (see Fig.2).

It is then clear why monotonic dependence is restored only for d = 1. In all the other cases (both d < 1 and d > 1), $F_{inf} < F_{max}$ (see Fig.1); moreover, the larger the dimensionality (beyond d > 1), the lower m_{ax} . Therefore, to achieve maximum cross section, the scatterer's strength should be decreased.

These last two conclusions run contrary to comm on intuition. One would norm ally expect to increase the scattering cross section by increasing the scatterer strength, not decrease it.

W ith this in m ind, it should not be surprising that in order to get a m aximum scattering cross section in 2D the point scatterer's strength should be in nitely low, and for any other nite value of , the cross section w ill vanish.

The applicability of a point scatterer in 2D is well known in the literature, and due to the singularity of the 2D case, there where m any indirect approaches to m odel a 2D point scatterer (see, for example, β {10]). In what follows we present two generalized function, which can replace directly the potential of a 2D point scatterer without any approximations. The rst function was already presented by A zbel β], but the second one is a new function. D espite the di erent appearance they both describe the sam e defects.

To create a scatterer (with a nite cross section) in 2D one can choose, instead of a delta function, a nite width () scatterer (but a very narrow one, i.e., p = 1) [3]. For example, let us choose the potential [3]

Surely, in the lim it ! 0, eq.14 is simply the Dirac's

delta function.

Since this potential has a nite width, one cannot use eq.7 for the G reen function. Instead, the G reen function near jrj=0 should be taken, and in 2D it can be written as

where is the Euler constant [2].

M oreover, due to the singularity one cannot use eq.(5) to calculate the scattering coe cient, instead the follow - ing general expression should be taken [11]

Substituting eqs. 15 and 14 in eq.16, the scattering $\cos i \sin w$ ill be

This expression again illustrates the non-monotonic behavior of jfjon the scatterer's strength : for a very weak scatterer, jfjincreases with the strength, but when exceeds the value (2) ln p e $^{=2} = 2$ ¹; jfjbegins to decrease. In particular, choosing (ref. [3])

one obtains (in the lim it ! 0)

where

is the point potential resonance energy.

We therefore see again that in 2D, the point in purity potential must be in nitely shallower than the 2D delta function, that is, the strength is in nitely (logarithm i-cally with the in purity's width) narrow (eq.18).

In the last few paragraphs we confronted the problem – atic (due to the singularity) 2D case by starting with a nite () width potential, xing the right potential strength (eq.18) and only then taking the limit ! 0. M ore form ally, the desired potential can be written

Such a generalized point potential m in ics a physical 2D point scatterer with eigen energy expressed by eq. 20.

This procedure was taken in [3] by Azbel and was named Impurity D Function (DF), however, this is not the only way to attack the singular 2D potential. Our derivation also suggests that it is possible to confront the singularity of the 2D case via the dimensions' number (i.e., d). That is, it is clear that d = 2 and = 0 is a singular point, but instead of approaching it via the ! 0lim it (while xing d = 2), one can approach it via the d! 2 (from below) lim it (while keeping = 0).




FIG.3. In the d plane, each arrow illustrates a di erent way of approaching the singular point d = 2 and = 0. The 1st and 2nd regions (including the d = 2 line) correspond to impurities whose cross section does not depend m onotonically on their potential strength. The d = 1 line is the only case in which the m onotone dependence occurs. In the 3rd region, a point impurity cannot exist. Notice that the < 0 region has no physical m eaning.

In particular, again choosing the potential

with the potential "strength"

substituting it in Eq.(13) and then taking the limit $d \mid 2$ (from below), the simple expression (19) of F is retrieved.

W e therefore nd another way to construct a 2D point in purity, which describes a physical in purity characterized by the eigen energy E_0 . This generalized potential can be written as the following limit

$$V(\mathbf{r}) = 2 \lim_{d \ge 2} (2 \quad d) E_0^{(2 \ d) = 2 \ d} (\mathbf{r}) : \qquad (22)$$

The potentials described by eqs. 21 and 22 describe exactly the same physical entity. Despite their di erent appearance, they both present a point impurity in 2D, with the same eigen energy E_0 (see eq.20).

In both cases, these are generalized functions, where their limit is presented in Fig.3: the limit ! 0 of eq. 21 is presented by the "A" arrow in the gure, while the limit d! 2 of eq.22 is the "B" arrow.

To sum m arize, in this paper we show ed that our everyday experience that the cross section of a point scatterer increases with the scatterer's strength fails in low num ber of dim ensions. It was shown that the 1D is the only case in which there is a m onotonic dependence of the scattering coe cients on the scatterer's strength, in all the other cases (other dim ensions) the scattering coe cient show s a resonance dependence on the scatterer's strength. W e use our derivation to construct a new generalized function, which can describe the potential of a point defect in 2D.
