Boson-ferm ion dem ixing in a cloud of lithium atom s

in a pancake trap

Abstract. We evaluate the equilibrium state of a mixture of Liand Liatom s with

repulsive interactions, con ned inside a pancake-shaped trap under conditions such

that the thickness of the bosonic and ferm ionic clouds is approaching the values of the

s-wave scattering lengths. In this regime the e ective couplings depend on the axial

con nem ent and full dem ixing can become observable by merely squeezing the trap,

without enhancing the scattering lengths through recourse to a Feshbach resonance.

1. Introduction

Dilute boson-ferm ion mixtures have recently been studied in several experiments by trapping and cooling gases of mixed alkali-atom isotopes [1, 2, 3, 4, 5, 6]. The boson-ferm ion coupling strongly a ects the equilibrium properties of the mixture and can lead to quantum phase transitions. In particular, it has been shown that boson-ferm ion repulsions in three-dimensional (3D) clouds can induce spatial demixing of the two components when the interaction energy overcomes the kinetic and connement energies [7]. Several congurations with dierent topology are possible for a demixed cloud inside a harmonic trap [8]. Although spatial demixing has not yet been experimentally observed, the experiments of Schreck et al. [1] on a ⁶Li-⁷Limixtures inside an elongated 3D trap appear to be not far from the onset of a demixed state: an increase in the boson-ferm ion scattering length by a factor vewould be needed to enter the phase-separated regime [9].

In this Letter we exam ine the possibility of attaining phase separation by merely varying the trap geometry for the $^6\text{Li}^-\text{Li}$ mixture at the "natural" values of the scattering lengths. We focus on the case of quasi-two-dimensional (Q 2D) con nement inside a pancake-shaped trap. We not that this geometry favours the demixed state through the appearance of the axial size of the atom ic clouds in their elective coupling in the azimuthal plane. We also show that several congurations are possible in the plane of the trap at zero temperature, but the conguration consisting of a core of bosons surrounded by a ring of fermions is the most energetically favourable for a wide range of values of system parameters.

2. The model

The atom ic clouds are trapped in pancake-shaped potentials given by

where m $_{b;f}$ are the atom ic m asses and $!_{z\,(b;f)}$ $!_{x\,(b;f)}$ the trap frequencies. We focus on the case where the trap is at enough that the dimensions of the clouds in the axial direction, which are of the order of the axial harm onic-oscillator lengths $a_{z\,(b;f)} = (\sim = m_{b;f} !_{z\,(b;f)})^{1=2}$, are comparable to the 3D boson-boson and boson-ferm ion scattering lengths a_{bb} and a_{bf} . In this regime we can study the equilibrium properties of the mixture at essentially zero temperature (T ' $0.02\,T_F$) in terms of the particle density proles in the fx;yg plane, which are $n_{c}(x;y)$ for the Bose-Einstein condensate and $n_{f}(x;y)$ for the fermions. The proles are evaluated using the Thomas-Ferm i approximation for the condensate and the Hartree-Fock approximation for the fermions. We shall take $a_{zb} = a_{zf}$ (= a_{z} , say) and only near the end we shall discuss the case $a_{bif} \in 1$.

The Thom as-Ferm i approximation assumes that the number of condensed bosons is large enough that the kinetic energy term in the Gross-Pitaevskii equation may be

neglected [10]. It yields

for positive values of the function in the square brackets and zero otherwise. Here, $_{\rm b}$ is the chem ical potential of the bosons. This mean—eld model is valid when the high-diluteness condition $n_{\rm c}a_{\rm bb}^2$ 1 holds and the temperature is outside the critical region. If the conditions $a_{\rm z} > a_{\rm bb}$; $a_{\rm bf}$ are fulled, the atoms experience collisions in three dimensions and the coupling constants in Eq. (2) can be written in terms of the 3D ones as [11]

with g_{bb}^{3D} = 4 $\sim^2 a_{bb}$ =m $_b$, g_{bf}^{3D} = 2 $\sim^2 a_{bf}$ =m $_r$ and m $_r$ = m $_b$ m $_f$ = (m $_b$ + m $_f$).

The Hartree-Fock approximation [12, 13, 14] treats the ferm ion cloud as an ideal gas subject to an elective external potential, that is

where $_{\rm f}$ is the chemical potential of the fermions and

The ferm ionic component has been taken as a dilute spin-polarized gas, for which the ferm ion-ferm ion s-wave scattering processes are inhibited by the Pauli principle and p-wave scattering is negligibly small [15]. In the mixed regime the Ferm i wave number in the azimuthal plane should be smaller than $1=a_{\rm bf}$, but this is not a constraint in the regime of demixing where the boson-ferm ion overlap is rapidly dropping.

The chemical potentials $_{\rm b;f}$ characterize the system in the grand-canonical ensemble and are determined by requiring that the integrals of the densities over the fx;yg plane should be equal to the average numbers N $_{\rm b}$ and N $_{\rm f}$ of particles. The presence of a bosonic thermal cloud can be treated by a similar Hartree-Fock approximation [9], but it has quite negligible elects at the temperatures of present interest.

3. General conditions for phase separation

The e ective strength of the atom -atom collisions in the azim uthal plane depends in our Q 2D model on the axial harm onic-oscillator length according to Eq. (3). We derive and illustrate in this section the consequences for demixing at very low temperatures.

We prelim inarly recall that in the macroscopic limit the phase transition is sharp and the overlap between the two species after demixing is restricted to the interfacial region, where it is governed by the surface kinetic energy (see Ref. [16] for an example in a 3D model). In the case of mesoscopic clouds under con nement the transition is instead spread out and several alternative de nitions of the location of demixing can

therefore be given. We discuss below three alternative locations, that we denote as partial, dynamical, and full demixing. Their de nition and the derivation of simple analytical expressions in the Q 2D model are given in the following.

3.1. Partial dem ixing

The interaction energy $E_{\rm int}$ between the boson and ferm ion clouds initially grows as the boson-ferm ion coupling is increased, but reaches a maximum and then falls o as the overlap between the two clouds dim inishes. We locate partial demixing at the maximum of $E_{\rm int}$, that we calculate from the density proles according to the expression

In the calculations that we report in this section we have used values of system parameters as appropriate to the experiments in Paris on the $^6\text{Li-}^7\text{Lim}$ ixture [1], that is N_b = N_f ' 10^4 and $!_{xb}$ =2 = 4000 Hz, $!_{xf}$ =2 = 3520 Hz.

We set x the two scattering lengths at their "natural" values $Q_0 = 5:1 \, a_0$ and $a_{\rm bf} = 38 \, a_0$, with a_0 the Bohr radius) and vary the thickness a_z of the trap from $100 \, a_{\rm bf}$ down to $a_{\rm bf}$. By this choice we are increasing both the boson-boson and the boson-ferm ion elective coupling in the azimuthal plane. The behaviour of the interaction energy as a function of the ratio $a_{\rm bf} = a_z$ at $x = a_{\rm bf} = a_z$ and $a_{\rm bf} = a_z = a_z$ and $a_{\rm bf} = a_z = a_z$ and $a_{\rm bf} = a_z = a_z = a_z$. 


Figure 1. Boson-ferm ion interaction energy $E_{\rm int}$ in a circular disc (in units of N ~! $_{\rm xb}$, with N = N $_{\rm b}$ + N $_{\rm f}$), as a function of $a_{\rm bf}$ = $a_{\rm z}$ for xed values of $a_{\rm bb}$ and $a_{\rm bf}$. The arrows indicate the locations of demixing estimate from Eqs. (7), (12) and (14).




Figure 2. Boson-ferm ion interaction energy $E_{\rm int}$ in a circular disc (in units of N ~! $_{\rm xb}$), as a function of $a_{\rm bf} = a_{\rm bb}$ for $a_{\rm bb} = 5:1 \, a_0$. The arrows indicate the locations of demixing estimate from Eqs. (7), (12) and (14).

As an alternative and with the aim of a later comparison with the results previously obtained in the 3D case [8, 9], we show in Fig. 2 the interaction energy as a function of the ratio $a_{bf} = a_{bb}$ at $xed a_{bb}$. The axial thickness a_z has been set equal to the largest of the two scattering lengths. This condition xes the limit of validity of our model [17]. The maximum of E_{int} lies at $a_{bf} = a_{bb}$ of 0.8, much below the value $a_{bf} = a_{bb}$ of the ratio of the "natural" scattering lengths. In fact, at $a_{bf} = a_{bb}$ of 7 the two clouds would undergo demixing as the axial trap stiffness is increased towards a Q2D model.

An approximate analytic formula for the location of partial demixing as a function of the system parameters in the Q2D model can be obtained from the condition $@E_{int}=@g_{bf}=0$ by using the estimate $n_{c;f}$ $N_{b;f}=(2\ R_{b;f}^2)$ with the values of the cloud radii in the absence of boson-fermion interactions, $R_f=(8N_f=_f)^{1=4}a_{xf}$ and $R_b=(16N_ba_{bb}=(2\ a_{zb}))^{1=4}a_{xb}$ where $a_{x(b;f)}=(\sim m_b;f!_{x(b;f)})^{1=2}$. The location of the maximum in the boson-fermion interaction energy as a function of $a_{bf}=a_{bb}$ lies at

We recognise in Eq. (8) a geometric combination of two scaling parameters: $c_1N_f^{1=2}=N_b^{1=2}$ is dominant in the case N_b N_f while $c_2N_b^{1=2}=N_f^{1=2}$ is dominant in the opposit limit. The prediction obtained from Eq. (7) is shown in Figs. 1 and 2 by a solid arrow. There clearly is good agreement between the analytical estimate and the numerical results.

3.2. Dynam ical dem ixing

On further increasing the boson-ferm ion coupling one reaches the point where the ferm ion density vanishes at the centre of the trap. This occurs when

We denote this point as the dynam ical location of the dem ixing in a mesoscopic cloud, since we expect a sharp upturn of the low-lying ferm ion-like collective mode frequencies to occur here as it is the case for both collisional and collision less excitations in a mixture under 3D con nement [18, 19].

If we insert the chem ical potentials for ideal-gas clouds in Eq. (11), we obtain an approximate expression for the location of dynamical demixing,

The condition for dynam ical dem ixing coincides with that for partial dem ixing in the lim it N $_{\rm b}$ N $_{\rm f}$. The prediction obtained from Eq. (12) is indicated in Figs. 1 and 2 by a dot-dashed arrow .

3.3. Full dem ixing

The point of full dem ixing is reached when the boson-ferm ion overlap becomes negligible as in a macroscopic cloud. Using the instability criterion outlined in Ref. [20] for the 3D case, the condition for full phase separation at T=0 is

At variance for the condition for full phase separation in 3D, for the Q2D con nement this criterion does not depend on the number of ferm ions, while $1=a_z$ plays the role of the Ferm imom entum.

The prediction obtained from Eq. (7) is indicated in Figs. 1 and 2 by a short-dashed arrow.

3.4. Density pro les at full dem ixing

In sum m ary, it can be seen from Eqs. (7), (12) and (14) that the two control parameters for the transition in a mesoscopic cloud under Q 2D con nement are $a_{\rm sf}=a_{\rm bb}$ and $a_{\rm z}=a_{\rm bb}$. Our main conclusion is that in a Q 2D geometry a relatively small value of the boson-ferm ion scattering length su ces to reach the regime of full phase separation. In the case of the $^6\text{Li}^{-7}\text{Lim}$ ixture the bare values of the boson-boson and boson-ferm ion scattering lengths full the condition for full phase separation for values of $a_{\rm bf}$.

In view of the above result, it is useful to illustrate in Fig. 3 the density proles to be expected in the fully demixed regime for a mixture under isotropic connement in the azimuthal plane (notice that a circular disc appears in Fig. 3 as an oval, because of the dierent scales used on the horizontal and vertical axes). In fact we have found various metastable congurations for the demixed mesoscopic cloud in addition to the thermodynamically stable one consisting of a core of bosons surrounded by a ring of fermions.




Figure 3. Density pro less at full demixing for fermions (left) and bosons (right) in the fx;yg plane, for a Q 2D m ixture with $a_{bb} = 5:1a_0$, $a_{bf} = 38a_0$, and b = f = 1:

In Fig. 3 we show topviews of the density proles in the fx;yg plane for the choice of parameters $a_{bb} = 5:1\,a_0$, $a_{bf} = 38\,a_0$ and $a_z = a_{bf}$. The most energetically stable conguration is shown in Fig. 3(a) and lies at energy E = 74:90 N ~!xb. Figure 3(b) shows a conguration with fermions at the centre surrounded by a ring of bosons inside a fermion cloud (E = $78:94\,\text{N} \sim !x_b$). In Fig. 3(c) a fermion slice lies between two boson slices surrounded by a fermion cloud (E = $79:04\,\text{N} \sim !x_b$). Finally, Fig. 3(d) shows an asymmetric conguration in which a core of bosons is displaced away from the centre of the trap (E = $80:20\,\text{N} \sim !x_b$). The latter two congurations break the symmetry of the trap and this is an elect due to the linite size of the system.

Con gurations (b)-(d) are structurally but not energetically stable, i.e. they represent metastable structures in local energy minima. They have been obtained by using density proles with various topologies as the initial guess for the self-consistent solution of Eqs. (2) and (4). In experiments bulk modes with the appropriate symmetry may be exploited to attain these \exotic" con gurations [21].

We have also studied the behaviour of the con gurations shown in Fig. 3 as a function of the scattering lengths (5:1a₀ < a_{bb} < 3 10^6 a₀ and 38a₀ < a_{bf} < 5 10^7 a₀) and the planar-anisotropy parameters (10 3 < $_{b,f}$ < 400). In contrast to the case of an elongated 3D con nement studied in our previous work [8], where the lowest-energy con guration can have dierent topologies depending on the system parameters, we have found that the conguration shown in Fig. 3(a) remains the most energetically stable for the Q2D geometry. A conguration consisting of a central core of fermions surrounded by a cloud of bosons may, however, be the stable one for succeptly strong boson-boson repulsions [8].

4. Sum m ary and concluding rem arks

In sum mary, we have focused on a boson-ferm ion mixture con ned inside pancake—shaped traps, such that the scattering events can still be considered three-dimensional but nevertheless a ected by the vertical con nement. By using a mean—eld description for the equilibrium densities in the azim uthal plane, we have studied the boson-ferm ion interaction energy as a function of the thickness of the atom ic clouds and of the boson-boson and boson-ferm ion scattering lengths. We have given approximate analytical expressions identifying three critical regimes in terms of the scaling parameters $a_{bf} = a_{bb}$ and $a_z = a_{bb}$: (i) partial demixing where the boson-ferm ion interaction energy attains maximum value from a balance between increasing interactions and diminishing overlap; (ii) dynamical demixing where the fermionic density drops to zero at the centre of the trap and a sharp dynamical signature of demixing may be expected; and (iii) full demixing where the boson-fermion overlap is negligible as in the macroscopic limit. These different criteria for the location of the phase transition in a mesoscopic cloud yield quite close predictions in a pancake-shaped trap under strong axial con nement.

We have found several metastable congurations for the demixed cloud, having various topologies but lying at higher energy above the stable conguration which is composed by a core of condensed bosons surrounded by fermions. We have veried that this is the minimum energy conguration over extensive ranges of values for the coupling constants, the anisotropy in the plane of the trap, and the thickness of the trap.

A main result of our work is that full dem ixing can be reached in the $^6\text{Li}^-\text{Li}$ m ixture by merely tuning the thickness of the trap, without necessarily tuning the scattering lengths. The full-dem ixing critical value of about $10\,a_{bf}$ for the thickness is not attainable in the actual experiments with the bare value of the $^6\text{Li}^-\text{Li}$ is cattering length, and a combination of squeezing of the pancake-shaped trap and exploiting Feshbach resonances should be used. On the contrary, the dynamical location of dem ixing may be observed by only varying the number of particles, without enhancing the scattering length. In fact for a mixture of 10^6 atom s of ^7Li and 10^4 atom s of ^6Li trapped in the radial connement discussed in Sec. 3.1, it may be possible to observe a sharp upturn of the low-lying fermionic modes for a pancake thickness of the order of $600\,a_{bf}$ of $1\,\text{m}$.
