Landau dynam ics of a grey soliton in a trapped condensate

It is shown that grey soliton dynamics in an one-dimensional trap can be treated as Landau dynamics of a quasi-particle. A soliton of arbitrary amplitude moves in the trapping potential without deformation of its density prole as a particle of mass 2m. The dynamics in the local density approximation is shown to be consistent with the perturbation theory for dark solitons. D ynamics of a vortex ring in a trap is discussed qualitatively.

Following the experim ental observation of grey solitons (or more precisely, entities associated with quasi-onedim ensional grey solitons) in Bose-Einstein condensates (BEC's) [1], a great deal of attention has been paid to the theory of the phenom enon (see e.g. [2, 3] and references therein). It was found that a grey soliton in a parabolic trap displays a num ber of peculiarities. A m ong them, we mention the frequency of oscillations, which is 2 times less than the frequency of oscillations of the condensate as a whole [2], and the consequent beatings, which can be observed in the long-time dynamics of a soliton, an internal mode accompanying soliton dynamics, nontrivial phase changes in soliton evolution [3], etc. It turns out, however, that the mathematical treatment of the problem, based on the application of perturbation theory to dark solitons [4] and covering all the main e ects, is rather involved, and m ore im portant, requires a sm all soliton velocity. The major problem is that a grey soliton even in the sim plest one-dim ensional (1D) parabolic trap is dram atically di erent from the standard grey soliton known from soliton theory. Distinctions emerge from different boundary conditions, which are zero in the case of a trap potential and nonzero in the case of a m athem atical grey soliton (see e.g. [5]).

The present paper aims to describe the motion of a grey soliton over a wide range of velocities in a trapped condensate, whose longitudinal size is su ciantly large. The phenomenon is described by the mean-eld 1D G ross-Pitaevskii (GP) equation

We consider a cigar-shaped condensate with the following relations among the transverse $a_{?}$, the longitudinal 2L dimensions of the condensate and a healing length $= \frac{p - \tilde{c}}{2m c}$ (c hereafter being the sound velocity): $a_{?}$ 2L. The 1D coupling constant q, comes from the \averaging" over the transverse cross section of the condensate [3, 6].

W e developed a full description of the dynam ics of the soliton, considering it as a quasiparticle and using the

Landau theory of super uidity. Subsequently we show that this approach is consistent with the GP equation and derive the main result by use of the proper perturbation procedure. In conclusion, on the basis of the results obtained we discuss qualitatively the dynam ics of a vortex ring.

Soliton in a hom ogeneous condensate. We start with a gray soliton in a uniform 1D condensate, i.e. when U(x) 0. A coording to T suzuki [7] the respective condensate wave function can be presented in the form (see also [8], x5.5):

where X (t) = vt, v is the velocity of the soliton, n is the unperturbed linear density, = $g_1 n = m c^2$ is the chem i-calpotential, $u = \frac{1}{c^2} - \frac{1}{v^2}$, and ' = ~=m u is the width of the soliton. The energy of the soliton is computed to be

Landau dynamics of a soliton in an inhomogeneous condensate. Let us now suppose that the condensate length, 2L, is large compared to the width of the soliton:

Then, for such large condensates one can use sem iclassical Landau dynam ics of the soliton, where the quantity (3) plays role of the H am iltonian of quasiparticle. We notice that condition (4) is stronger than the condition of applicability of the Thom as Ferm i (TF) approximation to the condensate L [8, 9]. Requirement (4) ensures, also, that the velocity of motion of the condensate as a whole due to the soliton oscillations is small and one can regard the condensate as being in the rest.

Subject to condition (4), one can use a local density approximation, assuming that equation (3) for the soliton energy is valid in the inhomogeneous condensate, i. e., that c can be changed to its local value c (X), where X is the position of the center of the soliton. In the rst approximation the soliton wave function has the same form (2), where X and v are functions of time related by dX = dt = v(t). The soliton motion is then de ned by the energy conservation equation

which obviously implies that u is also a constant. Expressing E in term sofu, we nally nd the equation

which can be solved by a simple integration.

In order to distribution of the sound speed, we approximate the density by the TF law

where $c_0 = \frac{p}{m}$ is the sound speed at x = 0. Substitution into (6) gives

This equation describes classicalm otion of a particle having mass 2m and energy m (c_0^2 u²) in the potential U (X) [11]. It is remarkable that the soliton propagates through the condensate without change of its density pro-

Indeed, simple calculation gives for the density perturbation in the vicinity of the soliton:

This quantity does not depend of time (at a given x = X), because u is an integral of motion.

Let us apply these results to a harm onic trap U (x) = m $!_x^2 x^2 = 2$. Notice that $!_x$ is the frequency of oscillations of the center of m ass of the condensate. Now the distribution of the sound velocity is $c^2(X) = c_0^2 + 1 = X^2 = L^2$ where 2L is the condensate length de ned by $I_r^2 = 2 = m !_x^2$ and (9) takes the form $\frac{dX}{dt}^2 = \frac{1}{m} + u^2 + \frac{1}{2} X^2$: This equation describes pure harm onic oscillations with frequency $!_s = !_x = 2$. This frequency coincides with the one obtained in Refs. [2, 3] in a different way for a slow soliton with v = c_0. The amplitude of oscillations is equal to the coordinate X₁ of the turning point:

The soliton oscillates between points X_1 , where the soliton velocity and central density become zero. Our approach requires, in addition to the general condition (4), that the distance between a turning point and the condensate boundary is larger than the soliton width: L X_1 `. This condition can be transformed to $u=c_0$ (=L)¹⁼³; which indicates that velocity of the soliton m ust not be too close to speed of sound.

To conclude this section, we must make an important remark. Equation (3) was derived for a uniform background in the absence of an external potential. It is not obvious that the energy has the same form in the presence of trapping potential. The point is that a soliton is a region of decreased density and, thus contains a negative "number of atom s"

O nem ay think that to the energy E onem ust add the potential energy N $_{\rm s}$ U (X) that corresponds to these atom s. Such conclusion would be wrong. A ctually, this decrease of energy is compensated by increasing the energy of atom s outside of the soliton. We will prove this in the next paragraph by direct calculation of the energy.

It is worthwhile to notice that the depletion (12) of the number of atoms in the soliton depends only on its energy E. This implies that N_s is also an integral of m otion. A soliton is a quasiparticle of constant (negative) m ass m N_s. However, this "physical" m ass of the soliton depends on energy and is not equivalent to the "e ective m ass" 2m.

Energy of a soliton in an external edd. In this paragraph we will show that equation (3) for the energy of a soliton, obtained for an uniform condensate, is actually valid also for a trapped condensate in the local density approximation. Thus the trapping potential does not enter explicitly in the expression for the energy of a soliton.

To take properly into account the expelling of atom s from the soliton, it is more convenient to work not at constant number of atom s, but at constant chem icalpotential . Thus, instead of the energy E, we will consider the "grand canonical energy" $E^0 = E$ the GP approximation this energy is $E^0 = e^0 dx$, where

Let the soliton center be at $x = X_{R}$ We separate the integration on two domains $E^{0} = \frac{1}{j_{K} \times j_{F}} e^{0} dx + \frac{1}{j_{K} \times j_{F}} e^{0} dx$ where L '. In the rst integral one can use the TF approximation for the energy, neglecting the gradient term: $e_{TF}^{0} (x) = \frac{1}{2}g_{1}n_{TF} (x)^{2} + (U(x))$

 n_{TF} (x), while, taking into account the sm ooth behavior of the potential, in the second term one can approximate U (x) $_{R}$ U (X). Next, one can add to the rst term an integral $x_{XK} = e_{TF}^{0}$ dx and, correspondingly, deduct

it from the second term in E^0 . Such an addition transform s the rst term in the total energy of the condensate in the absence of the soliton, which will be designated $E_0^{\,0}$. In the second term one can safely change the smooth function $e^0_{T\,F}$ (x) to $e^0_{T\,F}$ (X). Finally we arrive at the result

Now we can use the theorem about small increments (see [10], x16). A coording to this theorem small corrections to E and E⁰, are equal, being expressed, correspondingly, in terms of N and . Thus to obtain a correction to the energy, we must express the second term in (14) in terms of the density. One may eliminate from (14) by taking into account that, according to (7), $(U(X)) = gn_{TF}(X)$. Owing to the fast convergence of the integral, it is also possible to change form ally the integration limits from X to to 1 respectivily. Finally we get $E = E_0 + E$ where

Equation (15) does not contain the trapping potential explicitly. Substituting (x) from (2) and integrating, we obtain equation (3), where n is changed to $n_{T\,F}$ (X). Equation (1) ensures now conservation of E.

Perturbative approach to grey-soliton dynamics. In the previous paragraphs investigating the soliton dynam – ics we postulated, in the spirit of the Landau theory, that when the soliton m oves in a weakly-inhom ogeneous background its local energy stays constant. Let us now investigate the relation between the above phenom enological approach and the evolution of a grey soliton emerging from the dynamical approach, based on the mean- eld GP equation (1).

A grey soliton propagates against a background, and thus the rst step to obtain the soliton dynam ics is to determ ine the background (which above was approxim ated by the TF density distribution). One can do this by m eans of the ansatz $[\beta] = \exp(\frac{1}{2}t)F(x)$ (x;t) where F (x) is a real-value solution of the nonlinear eigenvalue problem

with F (0) = 1; F_x (0) = 0 and $\lim_{x \le 1} F(x) = 0$. As above we stipulate that U (0) = 0 and without loss of generality in pose the norm alization condition on F (x) at x = 0 assuming that the soliton is placed in the interval x 2 (X₁; X₁), where X₁ L. The function (x;t)

then solves the equation

which is subject to the boundary conditions $\lim_{x!} 1 j (x;t) j = \frac{p}{n} \cdot R[$; F] is given by

An explicit form of Eq.(17) appears to be useful if R [;F] is small compared with the left hand side of that equation. In order to estimate it we recall condition (4), which can be viewed as a de nition of the small parameter of the problem = '=L. We restrict our discussion to a soliton near the center of the trap, where $jJ(x)j=g_1n = O()$ and the potential is smooth enough, which enables one to neglect third order in the expansion around x = 0. One can ensure then that gn and R [;F] = O(gn) in the domain speci ed above.

This naturally leads one to use perturbation theory, the rst step of which would be an adiabatic approxim ation, i.e. an approximation in which the soliton shape is given by (2) with slowly varying parameters. This straightforward approach, however meets di culties in the case at hand because of the st term in the right hand side of Eq. (18). Mathematical reasons for this are discussed in [3, 4]. Here we will use a more physical approach. Namely, we will prove that it is possible to de ne an adiabatic approximation for a dark soliton, such that in the leading order the number of particles associated to the soliton is constant. In other words, one has to prove that there exist a function (x;t), satisfying (1) in the leading order and preserving the quantity $N_s[] = j \int dx$. Because both N_s and E are expressed in terms of the same quantity u, the energy E is also an integral of motion in accordance with the Landau theory. By direct algebra, one may verify that the rst term in the r.h.s. of (18) results in change of the num ber of particles in the case of a nonzero current [/ $\frac{F_x}{F}$ (x $_{\rm x}$)dx]. In order to apply our arguments, we again assume that in the adiabatic approximation the soliton is given by (2). One can then ensure that the imaginary part of all terms in (17) becomes orecisely zero in the vicinity of the point x = X (t) except

for the st term in the rhs., which even grows with X (t). This behavior originates from non-adiabatic effects, which must be taken into account before one passes to the Landau quasiparticle description the soliton.

In order to avoid this di culty, let us take into account that the solution we are interested in is a function of t and $= x \quad X$ (t), where X (t) is the coordinate of the soliton center and can be associated with a coordinate in the Lagrangian description of the condensate ow. Then, we make the substitution

Here can be associated with the soliton wave function while the second term on the rhs. of Eq. (19) is an internal mode excited when a soliton moves in a potential. Neglecting the terms of orders higher than one obtains the equation for (x;t)

Now one can verify that dN_s [=dt = 0 (²), ie (x;t) describes a soliton with a constant mass. Indeed, while the last two terms in the r.h.s. of (21) obviously give zero contribution to the change of the num ber of particles, in order to treat the rst one we recall the above requirement of the sm oothness of the potential U (x). One then easily estim ates

It is signi cant that the rh.s. is an odd function of x X. On the other hand $_{x} _{x}$, with given by the rh.s. of (2), is an even function. Thus, in computing dN_s[]=dt, the rst term contains an odd function of x X, which yields zero to the leading order.

A coording to the previous reasoning, the result obtained proves the conservation of the soliton energy.

Vortex ring. The method developed in this letter can be applied to other localized excitations. The most interesting example is a vortex ring. Let a sm all ring m oves along the axis of the trapped condensate. The energy of the ring in an uniform condensate can be written as $E = \frac{P}{n}$ (v=c), where function is a decreasing function of its argument. (It was calculated in [12], see also [8], x 5.4.) Then it follows from conservation of E that when the ring moves in the direction of decreased density, the ratio v=c (and v itself) decreases and its radius increases. On the contrary, moving in the direction of increasing n, the ring accelerates. If the central density is big enough, the ring velocity can reach its maximal value v = 0.93c. The behavior of the system near this point cannot be described in the local density approximation. Probably the excitation collapses beyond this point.

In conclusion, we have shown that considering a grey soliton as a quasiparticle in the spirit of the Landau theory of super uidity, one can obtain a simple solution of the problem of soliton motion in a trapped 1D condensate. The energy and the shape of the soliton are preserved during its motion and soliton moves in a trapping potential as a particle of mass 2m.
