Rotational Correlation Functions of Single Molecules

Single molecule rotational correlation functions are analyzed for several reorientation geometries. Even for the simplest model of isotropic rotational diusion our notings predict non-exponential correlation functions to be observed by polarization sensitive single molecule uorescence microscopy. This may have a deep impact on interpreting the results of molecular reorientation measurements in heterogeneous environments.

Reorientation of smallmolecules or segments of macrom olecules undergoing conform ational changes are elem entary processes and often of crucial importance for the properties of materials. In most of the experimentaltechniques probing rotational dynamics, ensembles of m olecules have been monitored [1, 2, 3]. A ctually, many chem ical and biological systems are heterogeneous, a fact that e.g. is re ected in their dynam ical properties. In the context of the non-exponential decay of bulk correlations in supercooled liquids this has been term ed dynam ic heterogeneity. Proteins, polymers, colloids and coarsening system s share this feature of non-exponential relaxation. In the past, bulk techniques have been developed that allow a characterization of heterogeneous rotational dynamics in complex systems in terms of a distribution of reorientational rates uctuating in time [4, 5]. There are, however, hints that even without (bulk) heterogeneity rotational correlations functions (RCFs) show deviations from exponential decay on a microscopic scale [6]. Such a behavior has also been found in num erical calculations on spin glasses [7,8].

In order to get a deeper insight into the nature of the rotational dynamics and its relation to structural properties of heterogeneous materials, it is highly desirable to conduct experim ents providing local (as opposed to averaged bulk) information. It has been shown by numerous exam ples that a single m olecule is an exquisitely sensitive probe of dynamical processes in its local environment [9, 10]. A long these lines, temporal uctuations of excited state lifetim es [11], excitation [12] and em ission spectra [13] and electronic coupling strengths[14] have been studied by single molecule spectroscopy and analyzed in terms of uctuating environments. Here we focus on the rotational dynamics of single uorophores investigated by polarization resolved microscopy [15, 16, 17, 18, 19, 20]. In order to extract quantitative and reliable inform ation from such measurements, a detailed analysis of local RCFs is of utmost importance. It is the purpose of the present letter to provide such an analysis for the simple m odel of rotational di usion of single uorophores.




FIG. 1: Schem atic experimental setup: The polarization of light emitted by a single uorophore depends on the orientation of the transition dipoles with respect to the detection system. The two orthogonally polarized components of the signal are separated by a polarizing cube beam splitter.

F horophores preferentially absorb photons whose electric eld vectors are aligned parallel to the transition dipoles of the molecule [21]. These dipoles have a well de ned orientation with respect to the molecular axes. Similarly, emission also occurs with light polarized along a xed axis. The experimental situation we will analyze in the remainder of this paper is depicted in Fig. 1 together with the denition of the axes system and the angles used. The orthogonal polarization resolved emission signals $\rm I_p$ and $\rm I_s$ depend on both, absorption and emission e ciency. The contributions of $\rm I_p$ and $\rm I_s$ to the signals collected in uorescence correlation spectroscopy have been analyzed in detail[22, 23].

A custom ary measure of dipole orientation can be obtained by calculating the reduced linear dichroism d from $\rm I_{\rm D}$ and $\rm I_{\rm S}$ via

This frequently used quantity [17, 18, 19, 20, 24] uctuates in the course of time due to molecular rotational dynamics. The normalization ensures that depends solely on the orientation of the emission dipole and not on the absorption eciency. Hence we represent the transition dipoles not by vectors but by their orientation using angles; We want to point out that the analogy of d to what is often called polarization [21] could lead to the wrong assumption to use the anisotropy values instead. However, in contrast to ucrescence depolarization methods this would not make any sense here. Subsequently the auto-correlation function of d(t) is calculated,

In the present letter we will show that C_d (t) is a non-trivial correlation function which nevertheless gives valuable inform ation about the time scale and the geometric aspects of molecular reorientations. It should be noted that in principle the fraction $I_p = I_s$ leads to the azim uth , however, an extremely well S/N ratio would be needed for reliable values.

Wellknown bulk techniques allowing to monitorm olecular rotational dynamics are provided by dynamic light scattering [1], dielectric spectroscopy [2] or nuclear magnetic resonance (NMR) [3]. Due to the dierent ranks 1

of the respective interaction tensors distinct RCFs

of the relevant Legendre polynom ial are obtained. Here, is de ned in the same way as in Fig.1. For instance, the interaction of a perm anent electric dipole moment with an applied electric eld transforms in the same way as the rst order Legendre polynom ial P_1 (cos) = cos and therefore C_1 (t) is observed in dielectric spectroscopy. NMR and light scattering are l=2 techniques and yield C_2 (t). Below it will be shown that C_d (t), apart from being a local correlation function, cannot be related to one of the C_1 (t) in a simple manner.

The theoretical description of reorientational dynam ics in molecular liquids is a complicated many particle problem. For a qualitative understanding of the behavior of rotational correlation functions, however, a treatment in terms of rotational B rownian motion is usually su cient. In the present letter we restrict ourselves to the simple model of anisotropic rotational diusion, thus neglecting inertial e ects completely. This approximation is well suited for the systems we have in mind, namely biological systems or supercooled liquids and glasses, where the time scale of the relevant relaxational modes is slow compared to typical vibrational frequencies.

In all following considerations we assume the transition dipole matrix elements to be stationary quantities. In this case we have C_d (t) = hd(t)d(0)i, with

Note that d(;) cannot be expressed in terms of the spherical harm onics Y_{2m} (;) and this is why C_d (t) cannot be related to the corresponding RCF C_2 (t). This is to be contrasted to the optical anisotropy, the correlation function of which is directly proportional to C_2 (t).

In order to keep the treatm ent general, in the following we treat auto-correlation functions of the form

Here, X denotes some arbitrary function of the molecular orientation $_{\rm P\ L}$ of the principal axis system (P) of the

relevant interaction tensor in the laboratory xed frame (L). In the present context we are primarily interested in the case of uorescence, X=d, in which case the z-axis of the P-system coincides with the direction of the transition dipole. However, other choices like e.g. $X=e^{iqr}$ relevant for incoherent neutron scattering can be analyzed in an identical way. If the molecular orientation (t), given in terms of Eulerian angles [25], is modelled as a stochastic process, C_X (t) can be written in the form [26]:

where P (;tj $_0$) denotes the conditional probability to nd at time t given $_0$ at time t = 0. Throughout this letter we restrict ourselves to the model of anisotropic rotational diffusion of sym metric top molecules, in which case one has

Here, the D $_{\rm nm}^{\rm (l)}$ () are W igner rotation matrix elements[25]. The rotational di usion coe cients D $_{\rm Y}$ and D $_{\rm X}$ are equal, but di erent from D $_{\rm Z}$. The limit of isotropic rotational di usion is recovered for D $_{\rm X}$ =D $_{\rm Z}$. It is important to point out that in eq.(7) denotes the orientation of the di usion tensor (D) in the L-system,

In order to proceed in the calculation of C_X (t), we expand the quantity X ($_{P\,L}$) in the expression for the correlation function, eq.(5), in terms of $D_{nm}^{(l)}$, X ($_{P\,L}$ (t)) = $D_{lm}^{(l)}$ $D_{lm}^{(l)}$ D

 $_{P\ D}$) is a shape and symmetry dependent molecular quantity. Formost relevant cases X ($_{P\ D}$) has axial symmetry, which allows to replace the D $_{0m}^{(1)}$ by spherical harmonics Y_{lm} . Performing the calculation using eqns.(6) and (7) yields:

the RCFs eq.(8) are calculated num erically. Typically, it is su cient to use 1 values up to 1= 20. Thus, C $_{\rm d}$ (t) is given by a weighted sum of a large num ber of RCFs. This




FIG. 2: Rotational correlation function C $_{\rm d}$ (t) for isotropic di usion (solid line). For comparison the exponential correlation function 1= 2 (eq.10: A $_2$ = 1; A $_{16\ 2}$ = 0) is plotted as dotted line

fact has not been noticed in the literature before to the best of our know ledge. As already mentioned above, for the optical anisotropy one has $hr(t)r(0)i = C_2(t)$ which decays as a superposition of at most three exponentials.

For the case of isotropic rotational di usion, i.e. D = D $_x$ = D $_y$ = D $_z$, eq.(8) sim pli es to

For symmetry reasons, the odd components vanish. A similar expression has been reported recently [24]. In table I the pre-factors are listed up to 1= 20. The re-

sulting correlation function signi cantly deviates from an exponential decay as shown in Fig.2. From thing the computed data with a stretched exponential function f(t) = e $^{(t=\ c)}$ we obtain $_{\rm c}$ = 0.87=6D and = 0.871. Therefore, even for this simple model we not intrinsic non-exponential relaxation. The optical anisotropy decays exponentially, hr(t)r(0)i= e $^{6D\ t}$.




FIG. 3: (a) Stretching exponent depending on the anisotropy = D_z=D_x (D_x = D_y). PD denotes the angle between the z-axis of the di usion tensor and the transition dipole \sim . (b) Correlation times normalized by 0 = (D_z k \sim). and were obtained by tting C (t) with exp((t=))

The model of stochastic isotropic reorientations presents a drastic approximation as most molecules do not exhibit a spherical shape. Thus, in many cases of practical interest one is confronted with asymmetric top molecules. As noted above, however, in the present letter we restrict ourselves to the case of symmetric tops for simplicity. This means that we consider an ellipsoidal diffusion tensor with three components D $_{\rm x}=$ D $_{\rm y}$ and D $_{\rm z}$, see Fig. 3a. For standard 1=1;2 methods the RCFs

resulting for this model consist of two and three exponentials, respectively, with time constants depending on the degree of anisotropy = $D_z=D_x$. It is evident from eq.(9) that for $D_x \notin D_z$ the degree of non-exponentiality is more pronounced due to the fact that for each 1 now one has 1+1 exponentially decaying functions with different weights. However, the orientation of the transition dipoles with respect to D_z determines the degree of this additional non-exponentiality. Only for $D_z k \sim$ the same estretching exponent as for isotropic reorientation is obtained.




FIG. 4: In uence of the reorientation mechanism on the stretching () and the time scale () of the correlation function, calculated for rotational jump processes with varying jump angles . For comparison the correlation times were normalized by the pure l=2 correlation time 2.

An entirely dierent approach to the calculation of RCFs via rotational random walk simulations has proved to be successful in the context of supercooled liquids [27]. Here, molecular reorientation has been modelled by rotational jump processes. Starting from an arbitrary orientation, after a certain waiting time drawn from Poisson statistics the next orientation is chosen at random with the only restriction that starting and end position di er by an angle . In the lim it of ! O isotropic rotationaldi usion is obtained with results identical to those obtained with the analytic approach. In Fig. 4 the in uence of the jum p angle on the correlation function Cd (t) de ned by eqns.(4) and (5) is plotted. With increasing the correlation decays become more exponential, which essentially originates from an convergence of the dierent l contributions to the RCF.

So far, we have assumed that the principal axes sys-

tem (P) relevant for experim ental observables has a xed orientation $_{\rm P\,D}$ relative to the 'di usion tensor' system (D), and only the orientation of the latter with respect to the laboratory system (L) is time dependent: (t) = $_{\rm D\,L}$ (t). In principle, one can treat the case of internal rotations by assuming a composite M arkov process [26] f $_{\rm P\,D}$ (t); $_{\rm D\,L}$ (t)g and using an appropriate m aster equation for the composite process. If the internal motion is independent of the tumbling motion of the whole molecule one can factorize the corresponding probability functions and averages. This case is of particular relevance for the conform ational motions of polymers or proteins in solution and has been treated extensively in the literature to which we refer [28].

In the present analysis we have neglected the in uence of the num erical aperture (NA) on the optical path. Us-

ing very high NA objectives (NA > 1) out-of-plane contributions of the transition (em ission) dipole to the uorescence signal have to be considered [16, 18]. However, it was pointed out that even for NA = 125 the dichroism signal is only slightly in uenced by this e ect[18]. Additionally, if one were to measure rotational dynamics over an extended tem perature range, it is experim entally more convenient to use low NA (< 1) objectives. Here still an in uence of the NA is expected, which, however, becomes sm aller the sm aller the NA is. Nevertheless, the accurate incorporation of the NA into our theoretical description has still to be worked out. We also would like to mention that methods have been developed which utilize the longitudinal eld component of high NA objectives to extract the full three dimensional orientation of transition dipoles [29, 30]. Although quite powerful, such measurem ents require a very good S/N ratio for subsequent data analysis and are limited with regard to time resolution.

While in the past only bulk experimental techniques were available for studying molecular dynamics, recent experim ental progress has enabled to study dynamical processes at the single molecule level. In particular, uorescence m icroscopy has allowed to track molecular orientation in time. Here the merits of single molecule microscopy em erge in probing rotational dynam ics in heterogeneous environm ents in a direct way. We found that even for the model of isotropic rotational di usion the obtained correlation function decays non-exponentially. M otional anisotropy increases the deviation from exponentiality. If the RCFs calculated for the simple model of anisotropic rotational di usion are param etrized by a stretched exponential, we nd stretching param eters 0:85 for physically reasonable values of the anisotropy between 0:3 and 3. From this we conclude that only

values smaller than roughly 0:85 can be taken as an indication for intrinsically non-exponential dynam - ics. Our ndings suggest a careful interpretation of single molecule rotational correlation functions as obtained by polarization resolved microscopy.
