Quantum phase transitions out of the heavy Ferm iliquid

A bstract

We review recent work on the instability of the heavy Ferm i liquid state (FL) of the K ondo lattice towards a m agnetic m etal in which the local m om ents are not part of the Ferm i sea. U sing insights drawn from the theory of decon ned quantum criticality of insulating antiferrom agnets, we discuss the possibility of a direct second order transition between the heavy Ferm i liquid and such a m agnetic m etal. We suggest the presence of at least two distinct diverging time scales - the shorter one describes uctuations associated with the reconstruction of the Ferm i surface, while a longer one describes uctuations of the m agnetic order parameter. The interm ediate time scale physics on the m agnetic side is suggested to be that of a novel fractionalized Ferm i liquid (FL*) state with decon ned neutral S = 1=2 excitations. This could ultim ately devolve into the m agnetic phase with conventional order at one of the larger time scales. Experimental implications for this scenario are noted.

K ey words: quantum criticality, K ondo lattice, decon nem ent

1. Introduction

A remarkable realization of Landau's Ferm i liquid theory of metals occurs in the heavy ferm ions' class of m aterials. Indeed, it has long been known that at low tem peratures these can typically be described within the Ferm i liquid paradigm, albeit with strongly renormalized parameters (for instance, e ective masses of $order 10^2$ 10 the band m ass). M icroscopically, this class of m aterial m ay be m odelled as possessing localized magnetic moments coupled to a separate set of conduction electrons. The heavy Ferm i liquid (see Section 2 below) is understood by a lattice analog of the K ondo screening of the localized m om ents. C rudely speaking, the localized moments \dissolve" into the Ferm i sea. Luttinger's theorem for the volum e of the resulting Ferm i surface includes both the conduction electrons and those form ing the localm om ents.

In contrast, recent experim entalwork has focused on situations where the Ferm i liquid description of such m etals appears to break down in a rather strong m anner. Such non-Ferm iliquid behavior occurs most strikingly in the vicinity of zero tem perature phase transitions out of the heavy Ferm i liquid - typically to a m agnetically ordered m etal. How ever there is little theoretical understanding of this breakdown of the Ferm i liquid paradigm.

Q uite generally, two distinct kinds of magnetically ordered m etals are possible in heavy ferm ion materials. In one the magnetism is to be viewed as a spin density wave instability arising out of the parent heavy Ferm i liquid state. C rudely speaking, this magnetism may be viewed as arising from in perfectly K ondo-screened localm om ents. W e will refer to such a state as the SD W m etal. A di erent kind of magnetic metallic state is also possible where the localized moments order due to RKKY exchange interactions, and do not participate in the Ferm i surface of the metal. The \K ondo order" present in the heavy Ferm i liquid is absent in

such a material. W e will denote this second magnetically ordered m etalas a 'localm om entmagnetic metal' or LM M metal. Often the distinction between these two kinds of magnetic states can be made sharply: the Ferm i surfaces in the two states may have dierent topologies (albeit the same volum emodulo that of the B rillouin zone of the ordered state) so that they cannot be smoothly connected to one another.

There is a well developed theory for the quantum transition between the heavy Fermi liquid and the SDW metal [1] which, however, often fails to produce the non-Ferm i liquid physics observed in experim ents. It is therefore tempting to assume that when non-Ferm i liquid physics is seen at a magnetic ordering transition out of the heavy Ferm i liquid, the resulting m agnetic state is the LM M m etal rather than the SD W m etal. How ever, there is no theoretical understanding of such a transition. Indeed, a number of basic conceptual questions arise. Can there be a second order transition where the K ondo order' of the heavy Ferm i liquid disappears concom itantly with the appearance of m agnetic long range order? W hat is the theoretical description of such a transition? W ill it reproduce the observed non-Ferm i liquid physics in the heavy ferm ion m etals near their magnetic ordering transition?

The answers to these questions are not known with con dence at present. In this paper we will review our recent work on related questions in a num berofsim pler contexts. Based on the lessons from these studies we will present som e ideas on the transition from the heavy Ferm i liquid to the LM M m etal, and their im plications for experim ents.

2. The heavy Ferm iLiquid, FL

M uch of our understanding of the heavy ferm ion compounds is based on the K ondo lattice m odel:

Thism odel consists of a density n_c of conduction electrons o_k with dispersion $_k$ (k ism omentum and = ";# is a spin index) interacting with f electron spins S_r (r is a lattice position, and ~ are the P aulim atrices) via an antiferrom agnetic K ondo exchange coupling J_K .




Fig.1. Conventional theory of the FL state. A completely at f electron \band" (dashed line in (a)) m ixes with the conduction electrons to obtain the renorm alized bands in (b). There is a single Ferm i surface at k_F in the FL state containing states whose num ber equals that of the f and c electrons com bined.

There is a well accepted theory of the form ation of a heavy ferm ion liquid state (hereafter referred to as the FL state) in this model [2{4]. The charge of the f_r electrons is fully localized on the rare-earth sites, and so one initially in agines that these electrons occupy a at dispersionless band, as shown in Fig 1a. This band has to be half-lled, and so we must place it at the Ferm i level. The c_r electrons are in agined to occupy their own conduction band. Next, it is argued [2], that

the K ondo exchange is equivalent to turning on a sm all hybridization between these two bands. W e represent this hybridization by a non-zero expectation value of the bosonic operator

W ith hb_ri non-zero, the two bands will m ix and lead to the renorm alized bands shown in Fig 1b. A crucial point is that because the f band was initially dispersionless, there is absolutely no overlap between the renorm alized bands. Hence the occupied states are entirely within the lower band, and one obtains a single Ferm isurface within wavevector k_F : the volum e within k_F is determ ined by the total density of c and f electrons. This is precisely the Ferm i volum e predicted in the limit of weak interactions between the electrons by the Luttinger theorem . Moreover, as in Fig 1b, the Ferm isurface is in a region where the electrons are primarily have a f character, and consequently the band is still quite at this accounts for the large e ective m ass of the ferm ionic quasiparticles.

A key technical feature of the theory of the FL state is presence of an emergent compact U (1) gauge eld. This is a consequence of the quenching of the charge uctuations on the f electron sites i.e. the constraint X

is obeyed at every rare earth site. This constraint im plies that that theory is invariant under the spacetime dependent U (1) gauge transform ation

where is in aginary time. A fler integrating out high energy degrees of freedom, this invariance leads to the emergence of a dynam ical compact U (1) gauge eld A (is a spacetime index, and bom pact' refers to the invariance of the theory under A ! A + 2. Notice also that the bosonic eld b in Eq. (2) also carries a U (1) gauge charge. The b eld is condensed in the FL state, and so in this state the U (1) gauge theory can be considered to be in a H iggs' phase. The appearance of the bH iggs condensate also m eans that A uctuations are quenched, and so are relatively innocuous in the FL state.

W e are interested here in the manner in which this heavy FL state may be destroyed by perturbations at zero temperature (T). An important early proposal made by Doniach [5] was that the state could be unstable to magnetic ordering of the f moments, induced by a RKKY exchange coupling between them :

A ssum ing this m etallic state is the SDW m etal noted in Section 1, such a quantum phase transition can be analyzed [1] in a manner sim ilar to the SDW instability in an ordinary Ferm i liquid. In such an approach one assumes that once the heavy FL state has form ed between the f and c electrons, the resulting quasiparticles lose m em ory of their origin, and behave like ordinary light' quasiparticles.

As discussed in Section 1, here we will review our recent work [6,7] exploring another route to the breakdown of the FL state of H_K + H_H. Here, the K ondo lattice origins of the FL state play a central role, and the focus is on the breakdown of the hybridization' or K ondo screening' between the f and c bands. M agnetic order m ay well appear at very low energies (in a LM M m etal) once the FL state has been disrupted; how ever, this will be view ed as a secondary or epiphenom enon', and the prim ary physics is that of the destruction of the Higgs phase of the U (1) gauge theory.

O ther distinct points of view are in Refs. [8{10].

3. The fractionalized Ferm i liquid, FL*




Fig.2. (a) The FL* state with a cold Ferm isurface at $k_{\rm F}$. The f ferm ions form a spin liquid, and are schem atically represented by the dashed dispersion. (b) The FL state which obeys the conventional Luttinger theorem, but has two Ferm isurfaces.

As noted above, the only active degrees of freedom on the f sites are the spins, and this is captured by the $f_{\rm r}$ operators. The exchange coupling in H $_{\rm H}\,$ can move this spin between sites, and so the initial assumption above of a dispersion less f band m ay be questioned. So let us reconsider the above argum ent starting from a f band which has a dispersion of order $J_{\rm H}$, as shown in Fig 2 (a). When the hybridization energy, in Eq. (2), is on a scale larger than $J_{\rm H}$, the physics is as in Section 2. How ever, as the hybridization decreases, it is clear that eventually there will be band overlap, and the FL state will have 2 occupied bands, as shown in Fig 2b, with two Ferm iw avevectors, $k_{\rm F1}$ and $k_{\rm F2}$. Nevertheless, this is still a conventional FL state, in that the total num –

ber of states contained between both Ferm i surfaces still equals the total number of c and f electrons, and the conventional weak-coupling Luttinger theorem is still obeyed. However, it has been argued [11,6] that it is now possible to reach a nite coupling quantum critical point where the Higgs condensate disappears and hbi = 0. The nite dispersion of the f band m eans that it is not always energetically preferable to have a b condensate, as was the case in Refs. [3,4]. Furtherm ore, careful gauge-theoretic argum ents can be m ade [6] that the transition from a state with $hbi \in 0$ to a state with hbi = 0 is indeed a sharp phase transition at T = 0.H ow ever, there is no conventionalLandau order param eter for this transition, and there is no analog of such a transition at T > 0 (although a T > 0 transition between a state with $hbi \in 0$ and a state with hbi = 0does appear in mean eld theory [12]). Rather, it is a transition characterized by a change in the topological' character of the ground state wavefunction, in that the fate of the A eld dynam ics undergoes a qualitative change.

So what is the nature of the state, which we denoted FL^* , with hbi = 0 obtained by increasing J_H ? First, it is a Ferm i liquid in the sense that the celectrons form a conventional Ferm i surface, with sharp electron-like quasiparticles at k_F (see F ig 2a). How ever, the volum e enclosed by this Ferm i surface contains states whose num ber equals only the num ber of c electrons; this violates the conventional Luttinger theorem . C losely linked with this non-Luttinger Ferm ivolum e is the fate of the spin moments on the f electrons. These form a 'spin liquid' state, which does not break any lattice translational symmetries and fully preserves spin rotation invariance (i.e. there is no magnetic moment). The spin liquid state contains S = 0 excitations of the gauge eld, A, which remain gapless if the U(1) gauge group rem ains unbroken (spin liquid states with a Z₂ gauge group are also possible), along with the now charge neutral S = 1=2 f ferm ions. A fairly rigorous

argum ent can be m ade [6,13] show ing that the unusual Ferm ivolum e of the FL* phase requires the emergent collective gauge excitations represented by A $\,$.

Ourwork also presented [6] a description of the quantum critical point between the FL and FL* phases. W ithin the FL phase, as one m oves towards the FL* $\,$ phase, the two Ferm i surfaces at $k_{\rm F\,1}$ and $k_{\rm F\,2}$ behave di erently. The Ferm i surface at $k_{\rm F\,1}$ evolves into the Ferm i surface at $k_{\rm F}$ $\,$ in the FL* state, and this remains bold' near the quantum critical point: there is no strong scattering of these quasiparticles, and the electron quasiparticle residue remains nite across the transition. In contrast, the Ferm i surface at $k_{\rm F\,2}$ becom es hot': the lifetim e of the quasiparticles becom es short, and the quasiparticle residue decreases and ultim ately vanishes at the quantum critical point. The dynam ics of the quasiparticles exhibits non-Ferm i liquid behavior at the quantum critical point. Note that this anom alous behavior extends across the entire hot Ferm i surface, in contrast to the isolated hot spots' that appear in the SDW theory [1]. The self energies also have a fullm om entum dependence, in contrast to theories of 'local' criticality [9].

4. Decon ned quantum criticality in insulating antiferrom agnets

It is useful to interpret the approach of the FL state to the FL* state described above as a approach to a decon nem ent transition of the f ferm ions. In the FL state these are bound' to the c by the Higgs condensate of (2), the ultimate low energy quasiparticles carry charge e and S = 1=2, and there are no strong A uctuations. At the quantum critical point, neutral f quanta are liberated, and the A uctuations become e much stronger. The present theory [6] of this critical point treats these gauge uctuations perturbatively – for reasons explained in Ref. [6] thism ay be legitimate in spatial dimension d = 3, but not necessarily so in d = 2. In the latter case it is entirely possible that there are additional non-perturbative e ects which have not been fully accounted for.

To explore the possible consequences of such decon nement-driven quantum criticality, we consider here a simpler insulating system for which much progress has recently been made [7] in understanding the non-perturbative consequences of gauge uctuations. We describe the square lattice S = 1=2 H eisenberg antiferrom agnet, in portant in its applications to the physics of the cuprates. This is a model in the class H_H of the f m om ents alone, with no m etallic charge carriers. When the exchange interactions are predom – inantly nearest neighbor, the ground state long-range N eel order, in which the m om ents are polarized along

opposite collinear directions on the two sublattices. As is conventional, we characterize the local orientation of this order by a unit vector eld $n_r / (1)^{y+y} S_r$. It turns out to be useful to further express the vector n_r in spinor variables by

As in Eqs. (3), (4), Eq. (7) in plies that the theory for the z has a compact U (1) gauge invariance

and an associated com pact U (1) gauge eld A \cdot . In the present situation, it is possible to use spin and lattice sym m etries, and the absence of gapless Ferm isurfaces, to write down an explicit e ective action for the gauge theory in the continuum limit:

Here s is a tuning parameter which we use to destroy N eelorder, and we will then describe the consequences of gauge uctuations at the resulting quantum critical point. The N eel phase is obtained when s < 0, and the z are condensed with hz i € 0. In other words, the N eelphase is the H iggs phase of the present gauge theory, in close analogy to our discussion in Sections 2, 3 for the FL phase. Here too the H iggs condensate quenches the gauge uctuations, and m orphs them into a S = 0 collective m ode of pairs of spin waves.

Now let us approach the quantum critical point, which is at $s = s_c$ (say). Here, the z are gapless S = 1=2 quanta which interact via exchange of the gapless U (1) gauge quanta of A. In a sense, the z quanta have been decon ned, but some care has to used with this term inology because the z also acquire an anom alous dimension [14].

W e can continue the sam e analysis into the param – agnetic phase with $s > s_c$ and hz i = 0, where the properties of the theory S_z are really quite simple, and describe a U (1) spin liquid ground state. The z quanta are sharply de ned S = 1=2 quasiparticles (spinons) and they interact via exchange of A quanta, which now have a true M axwell-photonic form .

W hile simple and direct, the above story turns out to be fundam entally incomplete, and this breakdown likely has implications for the FL to FL* transition we described earlier. In taking the continuum limit to Eq. (9), we have lost information on the compactness of A (i.e. invariance under A ! A + 2). A compact U (1) gauge theory in 2+1 dimensions allows m onopole point defects, which are tunnelling events




Fig. 3. Renorm alization group ows for the S = 1=2 square lattice antiferrom agnet. The transition between the N eel and param agnetic states is tuned by s, and $_4$ is a monopole fugacity whose bare value is generically nonzero.

between sectors whose total ux di ers by 2 . In the language of the n eld, these are hedgehog' defects. Furtherm ore, a lattice scale analysis of the action of these m onopoles shows that they carry Berry phases. W e refer the reader to Ref. [14] for a review of the physics of these m onopoles at and near the quantum criticalpoint, and m erely sum m arize the results of such an analysis here. A s shown in F ig 3, it is useful to consider a two-dimensional renorm alization group (RG) ow in the tuning parameter, s, and a certain quadrupled m onopole fugacity, 4.

The properties of the theory S_z are described by the line $_4$ = 0. There is an unstable xed point at s = s_c , separating a ow towards the magnetically ordered N eel state for s < s_c , from a s > s_c ow towards the param agnetic spin liquid with a gapless U (1) photon and gapped spinon excitations. The relevant RG eigenvalue at s = s_c determ ines a spin correlation length $_{\rm spin}$ js sj which diverges as the critical point is approached. For s > s_c there is an energy gap towards spinful excitations $_{\rm spin}^{1}$ which vanishes as s! s_c^{+} .

Now consider a nonzero 4.Notice that 4 is irrelevant at the s = s_c , $_4 = 0$ xed point. Thism eans that the above description of the critical properties of Sz applies also to the underlying antiferrom agnet. There is, how ever, a crucial caveat. W hile 4 is irrelevant at the quantum critical point, for $s > s_c$ the ow of 4 eventually turns around and is attracted tow ards large values of 4. This happens because 4 is a relevant perturbation to the large s xed point describing the U (1) spin liquid phase. This phenom enon characterizes 4 as a dangerously irrelevant coupling at the critical point. For s just above s_c , the value of 4 becomes very sm all at length scales of order spin (or energy scales of order ¹_{spin}), but eventually becomes of order unity or larger at a second length scale which we denote $_{VBS}$. spin, where > 1 is a critical Thisbehaveslike _{VBS} spin . There is also a corexponent; so we have v BS $^{\downarrow}_{\rm V\,B\,S}$ which is much smaller responding energy scale than the energy gap to spin excitations.




Fig. 4. Phase diagram of the S = 1=2 square lattice antiferrom agnet. The N eel state breaks spin rotation invariance. The VBS state preserves spin rotation invariance but breaks lattice rotation and translation sym m etries. The ovals around the lattice sizes represent S = 0 com posizes of the electrons on the surrounded sizes: these are meant to schem atically indicated the pattern of lattice sym m etry breaking in the ground state wavefunction. The VBS order for s > s_c appears only at a length/tim e scale which is much larger than the spin correlation length/tim e

W hat happens at the scale v_{BS} ? In short, the properties of the param agnetic phase change com pletely. The S = 1=2 z quanta experience a con ning force, and the ground state breaks lattice translation and rotation sym m etries by the developm ent of valence bond solid (VBS) order, as illustrated in F ig 4. How ever, the rem arkable fact is that all these changes to the param agnetic phase occur w ithout m odifying our earlier theory of the quantum critical point. This is possible because the quantum critical point has two diverging length/tim e scales, one m uch larger than the other.

Returning to our discussion of the destruction of N eel order by liberation of the z quanta, we see that this blecon nem ent' happens only at the $s = s_c$ quantum critical point. The z are ultimately con ned for all $s > s_c$, but only at length/time scale so large that the con nem ent physics has no e ect on the critical theory.

5. Im plications for heavy electron criticality

W e now return to our discussion to the instability of the heavy Ferm i liquid. The analogy with our discussion in Section 4 should now be evident. In the insulating m agnets there is a direct second order transition between the N eel state and a state with a very di erent kind of order (the valence bond solid, VBS). This m ay be viewed as being analogous to a direct second order transition between the heavy Ferm i liquid and the LM M m etal where the loss of K ondo order' happens concom itantly with the appearance of m agnetic order. Indeed, both the N eel state (of the insulating m agnet) and the FL state (of the K ondo lattice) are stable H iggs phases of a com pact U (1) gauge theory. They are un-




Fig.5. Phase diagram near the conjectured FL to LM M quantum transition. The two distinct energy scales are manifested by the di ering exponents by which $T_{\rm N}$ and $T_{\rm coh}$ (or $T_{\rm coh}$) approach the quantum critical point.

stable to a 'decon nem ent' transition to the U (1) spin liquid and the FL* phases respectively. How ever, such decon ned phases are rather fragile states of m atter, and can ultim ately be unstable to con ned phases with conventional order.W e reviewed above the instability of the U (1) spin liquid into a VBS state. It is then natural to explore the instability of the FL* state to the LMM, but in a manner that the quantum criticality remains decon ned'. In the insulating magnets, the separation between the two competing orders (Neel and VBS) occurs not as a function of a tuning param eter, but dynam ically as a function of length/tim e scale. Indeed, in the param agnet, the loss of N eel correlations occurs on one length scale while the pinning of the VBS order appears on a much longer length scale VBS that diverges as a power of .By analogy, for the heavy electron systems this strongly suggests that a direct second order transition between the two appropriate competing orders (K ondo order in FL and m agnetic order in the LMM metal) is possible but requires at least two diverging length/tim e scales at the quantum critical point, with decon nem ent evident only at the shorter scale (s).

These ideas suggest interesting and important directions for experim ental work on heavy electron system s. A re there indeed two or more distinct diverging tim e/length scales near heavy ferm ion critical points? In particular, we might expect that the reconstruction of the Ferm i surface happens (if it does so at all) at a time scale which diverges slower than the time scale associated with magnetic uctuations. An immediate consequence is that the N celtern perature, $T_{\rm N}$, at which m agnetism appears in the LM M state, will vanish faster (i.e.with a larger power of the tuning parameter across the quantum phase transition) than the tem perature scale, T_{coh}, at which well-de ned quasiparticles appear at the large Ferm i surface on the FL side (see Fig 5). Further, on the LMM side, there should be an interm ediate tem perature regim e T_N Т T_{coh} in which the properties are those of the sm all Ferm is urface state FL described in Section 3. The two tem perature scales $T_{\rm coh}$ and $T_{\rm coh}$ must vanish identically on approaching the quantum critical point from opposite sides.

M ore generally, the presence of two or m ore diverging length scales will a ect the scaling properties of a num ber of physical quantities near the quantum criticalpoint-probes of them agnetic uctuations will scale with a di erent length/tim e scale from probes of uctuations associated with the Ferm isurface structure. Experim ents that elucidate the character of these two possibly di erent kinds of uctuations are in portant, and would be extrem ely helpfulin clarifying the physics behind the non-Ferm iliquid behavior near heavy ferm ion quantum critical points.
