A ntiferrom agnetic, N eutral, and Superconducting B and in La_2CuO_4

The symmetry of the Bloch functions in the conduction band of tetragonal and orthorhom bic La_2CuO_4 is examined for the existence of symmetry-adapted and optimally localizable (usual or spin-dependent) W annier functions. It turns out that such W annier functions do not exist in the tetragonal phase. In the orthorhom bic phase, on the other hand, the Bloch functions can be unitarily transformed in three different ways into optimally localizable W annier functions: they can be chosen to be adapted to each of the three phases observed in the pure or doped material, that is, to the antiferrom agnetic phase, to the superconducting phase or to the phase evincing neither magnetism nor superconductivity. This group-theoretical result is proposed to be interpreted within a nonadiabatic extension of the Heisenberg model. Within this model, atom iclike states represented by these W annier functions are responsible for the stability of each of the three phases. However, all the three atom iclike states cannot exist in the tetragonal phase, but are stabilized by the orthorhom bic distortion of the crystal. A simple model is proposed which might explain the physical properties of $La_2 \times Sr_xCuO_4$ as a function of the Sr concentration x.

1. INTRODUCTION

1.1. La_{2 x} Sr_xCuO_4

The physical properties of pure and doped $\text{La}_{2 \text{ x}} \, \text{Sr}_{\text{x}} \, \text{CuO}_4$ have been studied in a broad range of Sr concentrations x [1, 2]. Pure $\text{La}_2 \, \text{CuO}_4$ is antiferrom agnetic below about 300 K, but this magnetic long-range order disappears at a Sr concentration of x 0:015. Between x 0:015 and x 0:05 the samples evince neither an antiferrom agnetic or a superconducting state. This border region has features characteristic of spin-glass system s [3]. Finally, above x 0:05 the material becomes a high-T_G superconductor.




FIG. 1: Structure of tetragonal La_2CuO_4 , show ing the basic translations of the B ravais lattice $\frac{v}{q}$. The space group is 14 = m m m. Open circles are O, solid are Cu. La is not shown.




FIG. 2: Structure of orthorhom bic La_2CuO_4 with the space group C m ca, showing the basic translations of the B ravais lattice b_0 . Open circles are O, solid are Cu. La is not shown. The arrows * indicate the distortions of the O atom s.

Furtherm ore, La_2CuO_4 undergoes a very interesting structural phase transition at about 520 K from a hightem perature tetragonal phase to a low-tem perature orthorhom bic phase [1]. The tetragonal structure w if the space group I4=m m m is depicted in Fig. 1. The major change in the structure in the tetragonal to orthorhom-bic transition involves a \buckling of the copper-oxygen planes" [2]: in the orthorhom bic phase with the space group C m ca the oxygen atom s are slightly shifted from their tetragonal positions in such a way that the translation t_3 in Fig. 1 is doubled [1, 2], see Fig. 2. The orthorhom bic distortion is so small that the orthorhom bic and tetragonal structures are not distinguishable on the scale of the gures [2].

The buckling of the copper-oxygen planes has been established also in doped La $_2$ x Sr $_x$ CuO $_4$ for a broad range of Sr concentrations x. At zero temperature, is exists up to x 02 and disappears for higher Sr concentrations [1].

1.2. M agnetic and superconducting bands

An energy band is called \mbox{m} agnetic band with the magnetic group M " if the B loch functions of this band can be unitarily transformed into W annier functions which are

centered on the atom ic positions;

sym m etry-adapted to M; and

optim ally localizable.

\Optimally localizable" means that the Wannier functions are as well localizable as possible. Observations on the band structures of Fe [4] and Cr [5] suggest that in both Fe and Cr a narrow, roughly half-led magnetic band is responsible for the stability of the ferromagnetic and the (antiferromagnetic) spin-density wave state, respectively, in these materials. This observation can be interpreted within a nonadiabatic extension of the Heisenberg model, the \nonadiabatic Heisenberg model" (NHM) [6].

An energy band is called \superconducting band" if the B loch functions of this band can be unitarily transformed into spin-dependent W annier functions which are

centered on the atom ic positions;

symmetry-adapted to the space group of the considered material; and

optim ally localizable.

O bservations on the band structures of a great number of elemental metals suggest that narrow, roughly half-lled superconducting bands are responsible for the stability of superconducting states. Also this observation can be interpreted within the NHM [7, 8, 9].

Optimally localizable and symmetry-adapted W annier functions are dened in Appendix B. The small irreducible representations of all the magnetic or superconducting energy bands in the space groups of La $_2\text{C}$ uO $_4$ are listed in Tables XI { XVI at the end of this paper. The way to determ ine these symmetry labels is also summarized in Appendix B.

1.3. N onadiabatic H eisenberg m odel

W ithin the NHM, the electrons in narrow, half-lled bands may lower their C oulom be energy by occupying an atom iclike state as de ned by M ott [10] and Hubbard [11]: the electrons occupy as long as possible localized states and perform their band motion by hopping from one atom to another. The Ham iltonian H n within the NHM is distinguished from any adiabatic Ham iltonian by a particular feature: the sym metry of H n depends on the sym metry of the localized functions representing the localized states. As a consequence, within this model the localized states must be represented by optimally localizable W annier functions which are adapted to the sym metry of the considered phase. These W annier functions may be usual (spin-independent) or spin-dependent W annier functions.

Spin-independent W annier functions are related to magnetic bands, and, for the rst time in this paper, to a \neutral" band. In an atom iclike state represented by spin-dependent W annier functions, the conservation of crystal spin requires a strong coupling between the electron spins and the crystal spins of suitable boson excitations. Below a transition temperature, this spin-boson interaction leads to stable C ooper pairs.

The mechanism of Cooper pair form ation within such an atom iclike system resembles the familiar BCS mechanism [12]. However, the Cooper pairs are stabilized in a new way by constraining forces. Though these constraining forces neither are considered within the original BCS theory nor within the modern theory of superconductivity, it cannot be excluded that they must operate in superconducting states because electrons forming Cooper pairs possess only half of the degrees of freedom of free electrons.

The above mentioned \suitable bosons" are boson excitations bearing the crystal-spin angularm omentum 1 ~ and being su ciently stable to carry it through the crystal. The order ofm agnitude of the superconducting transition temperature is determined by the excitation energy of those stable crystal-spin-1 bosons of the crystal which have the lowest excitation energy [13].

A lithe W annier functions considered in this paper are centered at the C u atoms because La_2CuO_4 has a single conduction band [6].

2. CONDUCTION BAND OF TETRAGONAL ${\tt La_2CuO_4}$

Tetragonal La $_2\text{CuO}_4\,$ possesses a pronounced conduction band characterized by the sm all representations




FIG. 3: Band structure of tetragonal La₂CuO₄ as calculated by 0 ve Jepsen [14], with sym metry labels determined by the author. The band characterized by Z_1^+ , $_2^-$ (or Z_5^- , $_5^-$), X_3^+ + X_2^+ , P_3^- + P_5^- , and N_1^+ forms a natural narrow conduction band. However, the electrons of this nearly half-led band cannot occupy the (energetically favorable) atom iclike state because suitable sym metry-adapted and optimally localizable W annier functions do not exist in the tetragonal phase. However, when the bands are folded into the Brillouin zone of the orthorhom bic phase (see Fig. 5), the points X and become equivalent. In the new Brillouin zone we may replace the Z_1^+ and $_2^-$ Bloch functions by the X_2^+ and X_4^+ functions of nearly the same energy. W ith these new functions, the construction of sym metry-adapted W annier becomes possible.

see Fig. 3.

2.1. Exclusion of a neutral atom iclike state with usual W annier functions

B and (1) is not listed in Table X I. Hence, in the tetragonal phase of La_2C uO $_4$ the electrons of this band cannot lower their C oulom b energy by occupying an atom iclike state because suitable sym metry-adapted and optimally localizable W annier functions do not exist.

2.2. Exclusion of a superconducting band

Taking into account the electron spin, the conduction band (1) is characterized by the double-valued small representations

see Table IX . This band is not a superconducting band because it is not listed in Table X II. Hence, the electrons of this band cannot lower their C oulom b energy by occupying an atom iclike state even if the W annier functions representing the localized states are allowed to be spin-dependent. Thus, in the fram ework of the NHM we cannot expect stable C ooper pairs in the tetragonal phase of $\rm La_2C\,uO_4$.

3. EXCLUSION OF AN ANTIFERROM AGNETIC BAND W ITH THE SPACE GROUP OF ANTIFERROM AGNETIC CHROM IUM

Folding the conduction band (1) into the Brilbuin zone of antiferrom agnetic Cr (as given, e.g., in Fig. 3 of Ref. [15]), the band becomes characterized by the small representations

see Table VII. This band is not listed in Table XV. Hence, optimally localizable Wannier functions being adapted to P4=mnc do not exist. The electrons cannot lower their Coulomb energy by occupying an atomic like state represented by such antiferrom agnetic Wannier functions. Hence, a spin structure with the space group P4=mnc (that means, with the spins lying parallel to the zaxis in Fig. 1) is not predicted within the NHM.

4. CONDUCTION BAND OF ORTHORHOM BIC La_2CuO_4

In the tetragonal phase of La_2CuO_4 , it is the sym m etry of the B loch functions at point which does not allow the construction of sym m etry-adapted and optimally localizable (spin-dependent) W annier functions: the B loch functions at are negative with respect to the inversion, but at the other points of sym m etry they are positive.




FIG. 4: Brillouin zones of La₂CuO₄.

In the orthorhom bic phase of La_2CuO_4 the oxygen atoms are slightly displaced from their tetragonal positions [2], see Fig. 2. In the Brillouin zone of this phase, the tetragonal points—and X—become equivalent, see Fig. 4. Hence, in the orthorhom bic Brillouin zone we may replace the unsuited B loch functions at the tetragonal point—by suited B loch functions coming from the tetragonal point X , if they exist. In fact, there exist well-suited functions at the tetragonal point X which are positive with respect to the inversion and have nearly the same energy as the functions at the tetragonal points and Z. These are the B loch functions with X_2^+ and X_4^+ sym metry, see Fig. 3.




FIG. 5: B and structure of orthorhom bic La_2CuO_4 as calculated by 0 ve Jepsen [14], with sym m etry labels determined by the author. The bold line shows the \active band" which is proposed to be responsible for the physical properties of La_2CuO_4 . The electrons of this band could occupy an energetically favorable atom iclike state by putting their spins antiparallel as shown in Fig. 6. Such a spin structure with the space group Cm ca would not require any distortion of the tetragonal lattice. However, this spin structure is not stable because the related magnetic group does not possess suitable corepresentations. A Itematively, the electrons may occupy an atom iclike state either by producing the experimentally established spin structure with the space group P con, a \neutral" atom iclike state invariant under time—inversion (and hence, without any spin structure) or a superconducting state, all of them being stable only in a (slightly) distorted lattice with the orthorhom bic space group Cm ca.

We get the \active band" denoted in Fig. 5 by the bold line if we replace the tetragonal \mathbf{Z}_1^+ and \mathbf{Z}_2^- functions by the tetragonal X_2^+ and X_4^+ functions. This band is proposed to be responsible for the physical properties of La₂CuO₄. Sym m etry-adapted W annier functions constructed from the Bloch functions of the active band represent localized states with orthorhom bic sym metry. However, we may assume that these orthorhombic states do not strongly di er from states with tetragonal sym metry, ie, we may assume that these orthorhombic states are states of slightly distorted tetragonal sym m etry. This is because, rst, the predom inant portion of the Bloch functions of this band comes from the Bloch functions of the initial tetragonal band (1), and, second, the new tetragonal X functions have nearly the same energy as the initial tetragonal Z and functions.

The active band in the orthorhom bic structure is characterized by the representations

where $_2^+$ com es from the tetragonalX $_2^+$ state, $_3^+$ com es from X $_3^+$, Y $_2^+$ com es from X $_4^+$, Y $_3^+$ com es from X $_3^+$, too, R $_1^+$ + R $_2^+$ com es from N $_1^+$, and T $_2$ and Z $_2$ com e from states at the tetragonalU and lines, respectively, see Table VI.

B and (4) is identical to band 2 in Table X IV. Hence, the B loch functions of this band can be unitarily transformed into optimally localizable W annier functions symmetry-adapted to the space group C m ca. The electrons of this band may lower their C oulomb energy by occupying an atomiclike state represented by these W annier functions. However, the related nonadiabatic Hamiltonian H $^{\rm n}$ has no longer the symmetry of the tetragonal space group I4=mmm since it commutes only with those space group operators of the tetragonal group I4=mmm which also belong to the subgroup C m ca. Therefore,

such an atom iclike state represented by W annier functions of reduced sym m etry requires a change of the sym - m etry of the crystal.

4.1. A ntiferrom agnetic band w ith the orthorhom bic space group C m ca




FIG. 6: Hypothetical spin structure of La $_2$ CuO $_4$ with the space group Cm ca. However, this spin structure is not stable because the related m agnetic group does not possess suitable corepresentations.

The space group C m ca is the space group of the antiferrom agnetic structure depicted in Fig. 6. Thus, the electrons m ight occupy an atom iclike state by putting their spins antiparallel as shown in Fig. 6. This appears to be possible, because the W annier functions of band 2 in Table X IV can be constructed in such a way that they are sym m etry-adapted to the whole m agnetic group

where K denotes the operator of time-inversion, see Appendix B. In this case, no spatial distortion of the tetragonal lattice would be required, since the spin structure by itself together with the accompanying magnetostriction represents a change of the tetragonal symmetry.

However, within the NHM stable spin structures with the space group C m ca do not exist because M does not possess suitable corepresentations, see Appendix A.

4.2. Spatially distorted crystal with the orthorhom bic space group C m ca

Hence, the electrons can occupy the energetically favorable atom iclike state only in a spatially distorted crystal. Therefore, the system produces the experimentally established distortion with the space group C m ca. This is possible because of the favorable position of the oxygen atom s: suitable displacements of these atoms also produce a crystal with the antiferrom agnetic space group C m ca. Within the distorted system, there exist three dierent atom iclike states.

4.2.1. Neutralband

The W annier functions of band 2 in Table X IV may also be constructed so that they are sym m etry-adapted to the grey magnetic group

Thus, in this spatially distorted crystal the conduction electrons can occupy a \neutral" atom iclike state represented by these spin-independent W annier functions being invariant under time-inversion. I believe that this neutral state is responsible for the phase of La $_2$ $_{\rm X}$ Sr $_{\rm x}$ CuO $_4$ which is neither antiferrom agnetic nor superconducting.

4.2.2. Antiferrom agnetic band with the space group P cm of the experim entally established antiferrom agnetic structure




FIG. 7: Experim entally established [1] spin structure of $\rm La_2CuO_4$ with the space group P ccn. Open circles are O, solid are Cu. La is not shown. The arrows * indicate the distortions of the O atom s.

The experimentally established [1] antiferrom agnetic structure of La_2CuO_4 with the space group P can is depicted in Fig. 7. Folding the active band (4) into the Brillouin zone of P can (given in Fig. 4), we get a band consisting of four branches which is characterized by the representations

see Table V III. This band is identical to band 1 in Table XVI. Hence, the Bloch functions of this band can be unitarily transformed into optimally localizable W annier functions symmetry-adapted to the space group P ccn. Thus, within the NHM the electrons may lower their C oulomb energy by producing the antiferrom agnetic structure shown in Fig. 7. However, this spin structure is connected with the experimentally established spatial distortion of the tetragonal lattice because the spin structure alone does not produce a crystal with the space group P ccn.

Fig. 7 suggests that the related magnetic group may either be written as $\frac{1}{2}$

where still K denotes the operator of time-inversion.

The rst magnetic group (8) possesses suitable corepresentations and, hence, spin structures with this group can be stable within the NHM, see Appendix A.

4.2.3. Superconducting band

Taking into account the electron spin, the active band (4) is characterized by the double-valued representations

see Table X. This band is identical to band 1 in Table XIII. Hence, the Bloch functions of this band can be unitarily transformed into optimally localizable spin-dependent W annier functions symmetry-adapted to the space group Cm ca. The electrons may lower their Coulomb energy by occupying an atomiclike state represented by these spin-dependent W annier functions. In this case, the conservation of crystal spin requires a strong coupling between the electron spins and the crystal spins of suitable boson excitations. Below a transition temperature, this coupling leads to a superconducting state. However, this superconducting state exists only in the space group Cm ca and hence, is connected with the experimentally established spatial distortion of the tetragonal lattice.

5. SUM M ARY AND DISCUSSION

5.1. Pure La_2CuO_4

The symmetry of the optimally localizable W annier functions in the conduction band of $\rm La_2CuO_4$ suggests that some aspects of the physical properties of this compound can be understood within the NHM in terms of magnetic, neutral, and superconducting bands.

The conduction band of tetragonal La $_2$ CuO $_4$ is clearly an \antiferrom agnetic" band tending to produce the antiferrom agnetic structure with the space group Cm caillustrated in Fig. 6. The conduction electrons would be able to occupy an atom iclike state by producing this spin structure without any additional spatial distortion of the tetragonal crystal. However, the nonadiabatic Hamiltonian H $^{\rm n}$ does not possess antiferrom agnetic eigenstates with the space group Cm ca because the related magnetic group has no suitable corepresentations.

Thus, the system is forced to produce a spatial distortion of the crystalso the conduction electrons can occupy

the energetically favorable atom iclike state. We recognize the intention of the nature to stabilize the atom iclike state with the least possible distortion: the positions of the oxygen atoms are shifted in a subtlemmanner in order that the basic translation \mathfrak{T}_3 (see Fig. 1) in the tetragonal lattice becomes doubled while the other two basic translations \mathfrak{T}_1 and \mathfrak{T}_2 still connect two lattice points. This slightly distorted crystal has the experimentally established orthorhombic space group Cm ca, that is, the same space group as the spin structure in Fig. 6. Within the distorted system, the conduction electrons now have three possibilities to condense into an atom iclike state.

First, in the orthorhom bic crystal the B loch functions of the conduction band can be unitarily transformed into optim ally localizable W annier functions adapted to the symmetry of the experimentally established spin structure (depicted in Fig. 7) with the space group P ccn. In this case, the related magnetic group [given in Eq. (8)] possesses suitable corepresentations in order that H $^{\rm n}$ has eigenstates with this spin structure. Therefore, the electrons may occupy the energetically favorable atom i-




FIG. 8: Basic translations of the Bravais lattice $_{\circ}$ of the experim entally established spin structure of La₂CuO $_4$ shown in Fig. 7.

clike state by producing this antiferrom agnetic structure. However, it is the spatial orthorhom bic distortion of the crystal which stabilizes the antiferrom agnetic structure.

Secondly, the orthorhom bic distortion of the crystal need not be accompanied by a spin structure. In the distorted system there exist optimally localizable (usual) W annier functions which are adapted to the orthorhombic symmetry. I believe that the \neutral" atomiclike state represented by these W annier functions is responsible for the \spin-glass" phase [1] of doped La₂CuO₄ because this phase neither is antiferrom agnetic nor is superconducting. However, the question why such a neutral state has features of spin-glass systems [3], requires further investigation. Also in this case, it is the experimentally established orthorhom bic distortion which stabilizes the neutral phase.

Thirdly, in the orthorhombic system the conduction electrons may occupy an atom iclike state represented by spin-dependent W annier functions. In such an atom iclike state, the conservation of crystal spin requires a strong coupling between the electron spins and the crystal spins of stable crystal-spin-1 boson excitations. Below a transition temperature $T_{\rm c}$, this spin-boson interaction leads to the formation of Cooper pairs. Also this spin-boson phase is not stable in the tetragonal system but is stabilized by the orthorhombic distortion.

M ost likely, in any material the stable crystal-spin-1 bosons of lowest excitation energy are coupled phonon-

plasm on modes. In the isotropic lattices of the transition elements they have dominant phonon character. However, phonon-like excitations are not able to transport crystal-spin angular-momenta within the two-dimensional copper-oxygen layers of La₂CuO₄ [13]. Thus, in the spin-boson phase the electron spins interact with boson excitations of dominant plasm on character. The relatively high energy of these plasm on-like crystal-spin-1 bosons is proposed to be responsible for the high superconducting transition temperature observed in the doped material.

5.2. Doped La_{2 x} Sr_xCuO₄

In doped La $_2$ x Sr $_x$ CuO $_4$ the sym m etry of the crystal is disturbed and all the statem ents in the preceding section are, strictly speaking, no longer valid. However, we may assume that for small values of x the given description of the atom iclike states holds also in the doped system because the sym metry of the physically relevant copperoxygen layers is not seriously a ected by the doping.

In doped La_{2 x} Sr_xCuO₄, all three possible atom iclike states described in the preceding section are evidently realized: for 0 x < 0.015 the antiferrom agnetic state has the lowest energy, then a neutral phase is stable and above x 0.05 the material becomes superconducting [1]. I propose a simple model which might help to understand this x dependence of the physical properties of La_{2 x} Sr_xCuO₄:

At the transition from the adiabatic to the nonadiabatic system (i.e., at the transition from a purely bandlike to the atom iclike state), the total energy of the electron system decreases by the \condensation energy"

where i = 1, 2, and 3 labels the antiferrom agnetic, the neutral, and the spin-boson phase, respectively. (Below the transition temperature, the latter phase is superconducting.)

E $_{\rm i}^{\rm e}$ stands for the electronic part of the condensation energy. It is de ned in Eqs. (2.20) and (5.3) of Ref. [6] for the superconducting and m agnetic state, respectively, and m ay be assumed to be independent of the Sr concentration x since the physically relevant copper-oxygen planes are not seriously a ected by the doping.

A tom iclike states in La $_2$ CuO $_4$ require an orthorhombic distortion of the tetragonal crystal. Hence, the total condensation energy E $_i$ (x) decreases by the energy E $_i$ (x) required to distort the tetragonal crystal. The x-dependence of this \distortion energy" m ight be understood on the basis of the following assumptions.

W ith increasing x the translation sym metry of the crystal is increasingly disturbed and the points and X in the tetragonal Brillouin zone become increasingly equivalent. As a consequence, the orthorhom bic distortion that is required for that and X are (completely) equivalent, becomes smaller with increasing x (and disappears




FIG. 9: Qualitative plot of the condensation energy E $_{i}$ (x) given in Eq. (11)] as a function of the Sr concentration x within the simple model de ned by the three assumptions (12), (13), and (14). i=1,2, and 3 labels the antiferromagnetic, the neutral, and the spin-boson phase, respectively. The condensation energy is maximum for any concentration, if the phase transitions from the antiferromagnetic to the neutral and from the neutral to the spin-boson phase occur at the Sr concentrations x_{12} and x_{23} , respectively. Below a transition temperature, the spin-boson phase is superconducting.

Under these assumptions, the system undergoes the phase transitions in order that the condensation energy is maximum at any Sr concentration x, see Fig. 9.

The rst assumption (13) is in accordance with my observations on the elementalmetals, see Sec.V of Ref. [4]. The second assumption is corroborated by the fact that a spin structure alone (together with the related magnetostriction) represents a distortion of the lattice without any spatial distortion. Hence, it is conceivable that the required spatial distortion of the tetragonal crystal is smallest in the antiferrom agnetic state.

Consider a magnetic state jn i and the related magnetic group

W ithin the ${\tt NHM}$, both the magnetic state in i and the time-inverted state

are eigenstates of the nonadiabatic H am iltonian H $^{\rm n}$. Therefore, standard group-theoretical m ethods can be applied to m agnetic states, too. A stable m agnetic state jm i complies with two conditions:

jn i is basis function of a one-dimensional corepresentation of M ;

jn i and the time-inverted state jn i are basis functions of a two-dimensional irreducible corepresentation of the gray magnetic group

Consequently, a stable magnetic state can exist in the space group H if H has at least one one-dimensional single-valued representation R following

The cases (a) and (c) are de ned in Eqs. (7.3.45) and (7.3.47), respectively, in the textbook of Bradley and Cracknell [16]. The irreducible corepresentation derived from R stays one-dimensional in case (a) and becomes two-dimensional in case (c).

1. Space group C m ca

Table II lists all the irreducible representations of the space group H = C m ca of orthorhom bic La₂C uO $_4$. The second and third column of this Table specify whether the corepresentation of H + K H and H + fK $\frac{1}{2}\frac{1}{2}\frac{1}{2}gH$, respectively, derived from the given representation R follows case (a) or case (c).

The only one-dimensional representations which apparently comply with the above condition for a stable antiferrom agnetic state are the small representations at point R. However, the little group at R is not the complete space group. Therefore, a stable antiferrom agnetic state with the space group Cm ca does not exist.

2. Space group P ccn

Table III lists all the irreducible representations of the space group $H = P \, \text{cm}$. The second, third, and fourth column of this table specify whether the corepresentation of $H + K H ; H + f K : \frac{1}{2} \frac{1}{2} \, \text{OgH} ;$ and $H + f K : \frac{1}{2} \, \text{OgH} ;$ [cf. Eqs. (8) and (9)], respectively, derived from the given representation R follows case (a) or case (c).

For the group H + fK $\frac{1}{2}0\frac{1}{2}gH$ there do not exist suitable representations. However, for the group H + fK $\frac{1}{2}\frac{1}{2}0gH$ all the small representations at point R comply with the above condition for a stable antiferrom agnetic state. Since now the little group at R includes all the space-group elements, a stable antiferrom agnetic state with the space group P con is possible.
