# U J Synergy E ect for the H igh T<sub>c</sub> Superconductors

# Abstract

U sing renorm alization group with included self-energy e ects and exact diagonalization of sm all clusters we investigate the ground state phase diagram of a two-dimensional extended Hubbard model with nearest-neighbor exchange interaction J, in addition to the local C oulom b repulsion U. The main instabilities are antiferrom agnetism close to half-lling and  $d_{x^2 y^2}$  superconductivity in the doped system . We nd that self-energy e ects are fatal for superconductivity in the repulsive Hubbard model (i.e. J = 0, U > 0). The superconductivity is triggered by nite J. The combined action of J and U interactions provide a remarkably e cient mechanism to enhance both  $d_{x^2 y^2}$  superconducting and antiferrom agnetic correlations.

One of the most striking features observed in the phase diagram of the high  $T_c$  superconducting cuprates is the proximity between the insulating state with long-range antiferrom agnetic order and the superconducting phase. This remarkable issue and the fact that at optimum doping the antiferrom agnetic coherence length remains nite ( 4a for  $La_2 \ge Sr_x Cu0_4$ ), have been the source of inspiration form any theoretical works in which the pairing mechanism is proposed to be originated in the uctuations of the spin-density wave phase. Another peculiarity of these materials is that the superconducting order parameter has  $d_{x^2 = y^2}$  symmetry. The reason for this property is also thought to be the closeness to the antiferrom agnetic phase as the lines of nodes of the superconducting gap allows for the existence of gapless spin excitations and superconductivity can coexist with spin-density wave uctuations. Very recently, the proximity between these two phases supplemented with the e ect of disorder has been the basic ingredient in a phenomenological model to suggest that cobssale ects can be expected in the phase diagram of the cuprates [1].

The fact that the ground-state of the undoped m aterials is antiferrom agnetic in m ediately suggests that the Hubbard m odel could be a good candidate for a m icroscopic description of these compounds. Instead, the explanation of the superconducting mechanism in the fram ework of this model remains very controversial. A superconducting solution is found when the model is tackled with some m any-body techniques[2, 3, 4, 5, 6, 7, 8, 9, 10]. However, all the numerical works devoted to search indications of superconductivity in the repulsive Hubbard model have been negative so far [11, 12, 13, 14]. Another candidate model to provide the basis for the theoretical investigation of the high T<sub>c</sub> superconductors is the t J model, which coincides with the Hubbard Ham iltonian in the limit of U ! 1 (corresponding to J ! 0). In the case of the t J m odel, m any-body methods and numerical results seem to be in agreement concerning the possibility of a superconducting state with  $d_{x^2 y^2}$  symmetry [15, 16, 17, 18]. The range of J at which it m ay occur is, however, not precisely determined and it is likely to lie beyond the region where the mapping from the Hubbard model is valid.

This motivates the study of the t J U model

which, in addition to the Coulomb repulsion U of the usual Hubbard Ham iltonian, contains a nearest-neighbor exchange interaction J as thet J m odel. In such a way, we can expect to retain appealing features of both m odels, like the charge uctuations introduced by U but forbidden in the constrained t J m odel and the robust superconducting correlations introduced by the exchange interaction and explore the interplay between both e ects. Beside these heuristic arguments, the t J U m odel is closely related to the extended Hubbard m odel with correlated hopping, which has been derived from the three-band extended Hubbard m odel as an e ective one-band Ham iltonian to describe the low energy properties of the Cu-O planes of the high-T<sub>c</sub> m aterials [19]. The latter m odel is characterized by three di erent nearest-neighbor hopping am plitudes  $t_{AA}$ ;  $t_{AB}$ ;  $t_{BB}$  depending on the occupation of the two sites involved, as well as the usual C oulom b repulsion U,

Each of the parameters of the above model depends on the parameters of the original threeband H am iltonian and there is a degree of uncertainty in their precise values. The relevant property is that reasonable estimates indicate that  $t_{AB}$  is larger than the other two [19]. The analysis of the dimensional estimates indicate that  $t_{AB}$  is larger than the other two by  $t_{AB}$  mediates antiferror agnetic correlations. In particular, in the strong coupling limit  $U >> t_{AA}; t_{AB}; t_{BB}$ , the exchange interaction obtained by treating (2) with second order perturbation theory is  $J = 4t_{AB}^2 = U$ . Furtherm ore, when this process is suppressed, antiferrom agnetic correlations are completely eliminated and a metal-insulator transition can take place at nite U in the half-lied system [20, 21, 22]. For weak coupling, the H am iltonian (2) can be treated with mean-eld H artree-Fock and BCS-like techniques in 2D [23] and with operator product expansion and bosonization in 1D [24]. It turns out that, close to half-lling, the predicted phase diagram is equivalent to that obtained starting from an effective t J U model [25]. In summary, the relevance of the t J U model to describe the Physics of the cuprates can be also supported by its closeness to the correlated H ubbard m odel derived from the more detailed three-band H ubbard m odel for the Cu-O planes. C om ing back to the phenom enology of the superconducting cuprates, the t J U m odel provides the fram ework for recent suggestions based on a combined order parameter with superconducting and bond-density-wave components with  $d_{x^2 y^2}$  symmetries to explain the intriguing pseudogap phenom ena [26]. In general, extended H ubbard m odels in low dimensions are of interest in the context of high-T<sub>c</sub> m aterials [27, 28, 29] and also to understand the rich structure observed in the phase diagram s of organic m aterials like (TM T SF)<sub>2</sub>PF<sub>6</sub>, and (TM T SF)<sub>2</sub>C ID<sub>4</sub> [22, 24, 30, 31, 32, 33, 34, 35, 36, 37], which can not be explained on the basis the local C oulom b interaction of the usual H ubbard m odel.

The t J U model has an explicit e ective attraction mediated by J that enables a superconducting solution even within a simple BCS-like description. Numerical studies of this model in ladders indicate that superconducting correlations with  $d_{x^2 y^2}$  symmetry are enhanced in comparison to those of the usual Hubbard model [38]. More recently, an analysis based on the Landau Fermiliquid picture has been adopted to argue that the pairing interaction mediated by J combined by a strong renormalization of the elective density of states caused by U results in a signi cant enhancement of the superconducting order parameter while quantum M onte C arlo simulations based on a variational wave function with a BCS structure support this picture [39]. Investigations of the weak coupling phase diagram at van Hove llings of the two dimensional version of this model supplemented by a nearest-neighbor C oulomb repulsion and next-nearest neighbor hopping am plitude have also been reported [40].

The aim of this work is to investigate the two-dimensional phase diagram of the t J = Umodel with two complementary techniques: exact diagonalization (ED) of a small cluster with 4 d sites and the one-loop renormalization group (RG) technique presented in Refs. [6, 41]. The latter are expected to provide reliable indications of the main instabilities of the Ferm i liquid in the limit of weak interactions. ED is an unbiased method that consists in the exact calculation of the ground state wave function, allowing for the direct evaluation of the relevant correlation functions but has the draw back that the size of the clusters that are amenable to be treated is small. In spite of that limitation, in the case of the t J model, the conclusions based on numerical results on such small clusters are among the most robust ones regarding superconductivity [17]. It is therefore interesting to analyze the predictions of these two methods and to compare them with previous results.

The article is organized as follows, in section II we provide som e technical details on the

m ethods we employ. In particular, we describe the procedure followed to include self energy corrections in the RG treatment. An important reference is the behavior of the relevant susceptibilities evaluated with this RG procedure for the usual Hubbard model. This is discussed in Section III. In sections IV and V we present the results for the t J U model using RG and ED, respectively. Section VI is devoted to sum mary and conclusions.

#### TECHNICAL DETAILS

### R enorm alization group m ethod

The basic hypothesis of the renorm alization group m ethod is that the norm al state is well described by the elective action for quasiparticles near the Ferm i surface. The description of the many body problem is done in terms of the two-body elective interaction  $U_1(_1;_2;_3)$  and the quasiparticle weight  $Z_1($ ). In the W ilson's renorm alization scheme,  $U_1(_1;_2;_3)$  is the electron between electrons within the ring around the Ferm i surface. This interaction is renorm alized by the scattering processes involving all electrons outside the ring . A physical interpretation of the cuto is that it plays the role of an electric term perature or the experimental problem frequency. In previous versions of RG [6, 8, 9, 40], it was assumed  $Z_1()=1$ . In what follows, we summarize the improved RG method of Ref. [41] which also considers self-energy corrections by taking into account the renorm alization of the quasiparticle weight.

An important issue to note is the fact that  $U_1(_1;_2;_3)$  and  $Z_1()$  depend only on the angles  $_i$  that parametrize the positions of the particles on the Ferm i surface. This is justified by a simple power counting which tells us that only the angular dependence of the elective interaction is marginal (or marginally-relevant) and only terms up to linear in energy are to be kept in the renormalization of the angle-dependent self-energy [41]. In the renormalization group procedure, these functions are continuously renormalized as the energy cuto , parametrized by the scale las = 8 texp(1) is reduced. The ensuing equation for the evolution of  $U_1$  within the one-loop renormalization group scheme has the following structure:




FIG. 1: From the left: Particle-particle (Cooper) and particle-hole (density-wave) di erential bubbles  $_{pp}(_{1};_{2};_{3})$  and  $_{ph}(_{1};_{2};_{3})$ . Propagators corresponding to degrees of freedom at the Ferm i surface and outside the ring are indicated with a bar and a >, respectively.

that (3) is a functional ow equation, i.e.  $U_1$  and all terms on the right-hand side depend on three angles (1; 2; 3). Particle-particle (Cooper) and particle-hole (density-wave) differential bubbles pp and ph are shown on g.1. To solve numerically Eq.(3) we discretize the angle which de ness the so-called N-patch model. The function  $U_1(1; 2; 3)$  is then represented by a set of coupling constants labeled by three discrete indexes. For thet J U m odel, the initial condition is

where  $(x_i; y_i)$  are components of the wave vector  $k_i$ , corresponding to the angle i at the noninteracting Ferm isurface. All coupling constants are found to diverge at the same critical scale  $l_i$  like

where the weights U are model dependent constants. This type of solution is called the xed-pole solution in contrast to the mobile-pole solution, where di erent coupling constants diverge at di erent critical scales. For realistic system s, where the initial coupling is not extrem ely small, only xed poles are relevant [42]. The critical scale  $l_c$  depends on the bare coupling constants U and J and on the band lling param etrized by the chem ical potential. The critical cuto  $_c = 8 \text{texp}(l_c)$  appears to be the characteristic tem perature of the model. The most precise non-restrictive interpretation of  $_c$  is that at this energy electrons start to build bound states. Nam ely, the poles in Eq.5 are the two-particle propagator poles,

indicating the on-set of bound states. These bound states can be of charge, spin or superconducting kind and all of them renorm alize the one-particle weight. This renorm alization is angle dependent and its evolution is described by the following expression

with the initial condition  $Z_1() = 1$ . The function J(;) is the angle dependent density of states at the energy (measured from the Ferm i level). The quantity  $_1(;^0)$  contains particle-particle (pp) and particle-hole (ph) contributions

with all terms on the right-hand side taken with external legs  $(_1; _2; _3) = (; ^0; ^0)$ . The interaction inserted in all beta functions obeys the scaling equation (3). The relation between interaction  $U_1$  and the usual physical interaction contains the rescaling Z-factors, [41]:

To nd out which correlations are relevant and candidates for order parameter we must allow the theory to choose between all possible 2-particle correlations. For this reason we have to follow the renormalization of several angle-resolved correlation functions. The superconducting correlation function  $_{1}^{SC}(_{1};_{2})$  measures correlations between the Cooper pairs ( $_{1};_{1}+$ ) and ( $_{2};_{2}+$ ), all states being at the Ferm isurface. The antiferrormagnetic correlation function  $_{1}^{AF}(_{1};_{2})$  correlates two nested electron-hole pairs  $c_{k(1)}^{Y}$   $q_{k(1)+(;)}$ and  $c_{k(2)}^{Y}$   $q_{k(2)+(;)}$ . The charge density wave correlation function  $_{1}^{CDW}(_{1};_{2})$  correlates the nested charge-like electron-hole pairs. To get the renormalization group ow of all correlation functions we follow the procedure given in Ref.[6] but dressing the electronic propagators with Z {factors as in Ref.[41]. We get

A fler discretization we integrate num erically equations (9) and (12). The relevant susceptibility in each channel is the dom inant eigenvalue of the angle-resolved correlation function. The corresponding eigenvector determ ines the angular dependence of the order param eter.

Exact diagonalization

This method consists in the exact computation, by recourse to Lanczos algorithm, of the ground state (GS) wave function of the model Ham iltonian (1) on a small cluster. We consider a cluster containing 4 4 lattice sites.

Due to the nite size of the cluster, its reciprocal lattice contains just some few (N = 16) points. As several instabilities are expected to be competitive in this model, the rough mesh of available k-vectors can produce an important bias and lead to an articial enhancement of some kind of correlation. The only resort to minimize this drawback is to consider di erent kinds of boundary conditions, which is equivalent to consider di erent choices of the 16 k-points. An arbitrary choice of boundary conditions breaks the point group symmetry of the original lattice. Exceptions are the periodic (P) and antiperiodic (AP) boundary




FIG. 2: Reciprocal lattice of the 4 4 cluster assuming (a) mixed boundary conditions, (b) periodic boundary conditions and (c) antiperiodic boundary conditions. Ground state con gurations corresponding to the llings n = 0.75 (thick arrows) and n = 0.875 (adding the thin arrows to the previous case) are also sketched.

conditions, which lead to the mesh indicated in Figs2b and c, respectively. Mixed (M)boundary conditions (periodic in one direction and antiperiodic in the other) lead to the pattern depicted in Fig.2a. The latter breaks som e of the symmetries of the  $C_{4v}$  group of the original lattice, the corresponding point group being C<sub>2v</sub>. Typically, these three choices of boundary conditions are the ones leading to the lowest energy. In our study, we compute the GS of (1), considering all the three possibilities above mentioned within the subspaces corresponding to the di erent one-dimensional representations of the point group and total k = (0;0). In the noninteracting system, it is easy to see that closed-shell con gurations are those leading to the lowest energy. For some densities of particles this condition is, however, not possible to be fullled for any choice of the boundary conditions and the GS is degenerate. The interactions norm ally lift most of the degeneracies. In some cases, it is observed that when the interactions overcom e som e particular value, a change is produced in the BC leading to the lowest energy. The latter e ect is an indication that interactions lead to some qualitative change in the behavior of the GS. This is, of course, a mere nite size e ect but provides a valuable information, since it re ects that the system prefers a change in the population of available k-points in order to take advantage of the interactions

and thus lower the energy.

To investigate the superconducting correlations in the GS it is useful to study the behavior of the pair correlation function (PCF)

where j<sub>0</sub> i is the ground-state wave function while  $\int_{0}^{y} (R_{i}) = c_{i}^{y} c_{i}^{y}$  for on-site s pairing,  $Y(R_{i}) = \int_{0}^{p} f() [f_{1+}^{y} (C_{i+}^{y} (C_{i+}^{y} (C_{i+}^{y}))]^{p} \overline{8}, with f_{es}() = 1$  for extended s pairing, and  $f_{d}() = 1$  ( $f_{d}() = 1$ ) when = (1;0) (= (0;1)) for  $f_{i+}^{y} (C_{i+}^{y})^{2}$  pairing. This function is normalized in such a way that  $j^{y}(i) j_{0} i j^{2} = 1$ . A superconducting state with pairs of a given symmetry is expected to have sizable correlations between pairs far separated by arbitrary large distances. In the case of the 4 4 cluster, the largest available distance is r = (2;2). The PCF between pairs separated by this maximum distance is denoted  $P_{m}$ . A seven in the noninteracting limit the PCF can be nite, we interpret an enhancement of the corresponding PCF relative to its value at U = 0; J = 0 as an indication of the superconducting instability.

To study the spin-density-wave (SDW) correlations it is useful to compute the spin-spin correlation function,

which provides information on the nature of the correlations between spins.

RENORMALIZATION GROUP RESULTS FOR HUBBARD MODEL W ITH RE-PULSIVE AND ATTRACTIVE INTERACTION

In this section we present results for the usual H ubbard m odel obtained by the RG m ethod described in the previous section. The m otivation is twofold. For the case of the U > 0 m odel, it was shown in Ref. [41] that self-energy corrections included in the renormalization of Z () are important to predict the antiferrom agnetic instability at half-lling in 2D and




FIG.3: (Coloronline) AF (upperpanels) and  $d_{x^2 y^2}$  SC (lowerpanels) susceptibilities as functions of the scale 1 for Hubbard model with U = 1:6t and densities determined by 1 = 1 (left-hand panels) and 1 = 3 (right-hand panels), corresponding, respectively, to half-lling (parquet regime) and high doping (within the BCS regime). Thick and this lines correspond to results with and without self-energy corrections, respectively. The noninteracting particle-particle and particle-hole susceptibilities are shown in dashed lines. The critical scale  $l_c$  as well as the scale 1 at which the susceptibility departs from the behavior of the noninteracting one are indicated with magenta and cyan arrows, respectively.

to recover the correct expression for the jump at the Ferm i points in 1D but the behavior of the susceptibilities away from half-lling has not been analyzed so far. On another hand, for U < 0 the model is a paradigm atic example of a superconductor and it is, therefore, an important reference point to analyze the behavior of the superconducting correlations. The results shown correspond to a discretization of 32 patches.

W hen applied to the usual Hubbard model with repulsive interactions (U > 0), the RG without considering self-energy corrections [6, 8, 9], predicts that at some critical scale  $l_c$ , the superconducting susceptibility with  $d_{x^2 y^2}$  symmetry together with AF susceptibility diverge within the parquet regime (j j< ), even at half-lling. This feature is expected to be an artifact of the approximation since for n = 1 um klapp processes are active and they are expected to drive the system toward an insulating AF state. In Ref. [41] it was shown that, due to the renormalization of the quasiparticle weight, the SC susceptibility is suppressed below its noninteracting value, while the AF susceptibility remains enhanced, although weakly, relative to the noninteracting particle-hole one.

Fig. 3 shows the behavior for the di erent susceptibilities as functions of the scale l, at di erent densities de ned by the chem ical potential = 8 texp(1). The susceptibilities with and without self-energy corrections are respectively plotted in thin and thick lines. The two left-hand panels correspond to half-lling (l = 1) and sum marize the results of Ref. [41]. Without self-energy corrections both SC and AF susceptibilities diverge at  $l_c$ , AF being dom inant. Self-energy e ects suppress the divergence, decreasing the SC susceptibility below its noninteracting value. The AF susceptibility is also renorm alized by self-energy e ects but remains larger than the noninteracting one. The scale 1 (see Fig. 3) at which the AF susceptibility begins to depart from the behavior of the noninteracting one is, how ever, not a ected by the self-energy corrections. This kind of behavior extends along the parquet regin e, de ned by the condition j j<.

The region at lower densities such that j j > is usually called BCS regime becauseonly Cooper channel has logarithm ic contributions to the elective interaction. The tworight-hand panels of Fig. 3 show how in this regime both AF and SC susceptibilities remainslightly larger than their noninteracting values when self-energy corrections are taken intoaccount.

These results need some discussion. Up to now it was rather widely accepted that the 2D Hubbard model has a  $d_{x^2 y^2}$  SC state away from half-lling. On the contrary results on the right-hand panels of Fig. 3 do not convincingly indicate a strong superconducting instability. The SC correlation functions being only weakly enhanced and the scale 1 being strongly renom alized towards high values when self-energy e ects are taken into account (see right-hand lower panel of Fig. 3). This indicates that the energy = 8texp (1) at which superconducting correlations begin to manifest them selves decreases when self-energy e ects are considered. At <sub>c</sub> there is a creation of bound states because the 4-points vertex (5) has poles. These bound states are the gapless modes that destroy the one-particle coherence via self-energy corrections and the result is that the phase transition is suppressed, probably to some nite lower energy.

To justify the above interpretation we calculated for comparison the RG  $\,$  ow of the attractive Hubbard model, for which the instabilities are better known. The U < 0 model is a paradigmatic example of s-wave type superconductor and its phase diagram has been investigated in detail by mean-eld and numerical techniques. Unlike the repulsive counterpart, predictions by different methods agree about the main instabilities expected in its




FIG. 4: (Color online) CDW (upper panels) and s-wave SC (lower panels) susceptibilities as functions of the scale 1 for U = 0.8t and densities determ ined by 1 = 1;5;3, corresponding to half-lling and two densities within the BCS regime (from left to right). O ther details are the same as in Fig. 3.

phase diagram [43, 44]: At weak coupling, the explicit local negative interaction leads to BCS-like superconductivity away from half-lling. For n = 1, bcalCDW is believed to be degenerate with s-wave superconductivity in the GS [43]. In 1D, such degeneracy is exact due to sym m etry reasons. This is because the repulsive m odel has dom inant AF correlations with a power law decay. Since no breaking of the SU (2) symmetry is possible, the behavior of the correlations in any of the spacial direction must behave in the same way. On another hand, there is an exact transform ation  $c_{j''}^y$ ! (1)<sup>i</sup> $c_{i''}$ ,  $c_{j\#}^y$ !  $c_{j\#}^y$ , which m aps the repulsive m odel into the attractive one, while m aps the degenerate z and x; y components of the dominant SDW correlations of the U > 0 model to the CDW and superconducting ones, respectively, of the U < 0 counterpart. The above reasoning can also be extended to the 2D case provided that no symmetry breaking in the ground state of the U > 0 model takes place. Results obtained with RG for the attractive model in 2D shown in Fig 4 are in very good agreem ent with the description provided by num ericalm ethods [43, 44]. At half-lling (1 = 1, see left-hand panels of Fig. 4), the most remarkable feature is the degeneracy observed between CDW and SC susceptibility with local s-wave symmetry, which remain slightly larger than the noninteracting one when self-energy corrections are considered. This

should be rather expected since the present m ethod provides a description of the norm al state and only the on-set of the instability towards the sym m etry broken state is captured. Bellow half-lling (1 = 5; 3, cf. m iddle and right-hand panels of F ig 4), CDW susceptibility becomes weaker, approximately equal to the noninteracting one, while the superconducting susceptibility becomes m ore enhanced. Self-energy e ects suppress the divergence of the di erent instabilities but do not renorm alize the scale 1.

Bellow half-lling, the s-wave type SC susceptibility is clearly larger than the noninteracting particle-particle one. As expected, the CDW remains non-renormalized. Compared to the repulsive Hubbard model (Fig.3), the enhancement of SC correlations is more convincing and in the present case we can indeed assign the divergence at l<sub>e</sub> to the on-set of the s-wave superconductivity. A ltogether, the attractive Hubbard model away from half-lling shows strong tendencies towards the s-wave superconductivity even when the self-energy corrections are taken into account. This is in contrast to the repulsive case where the selfenergy e ects have a more pronounced e ect against the  $d_{x^2 y^2}$  superconductivity. The reason for this behavior is rather simple: the s-wave superconductivity in the attractive Hubbard model is an e ect of rst order in U, while the self-energy corrections are of second order. As long as the coupling is weak the BCS like instability is a good approximation. Form ally this means that the mean-eld and the K osterlitz-Thouless transitions are close to one another. In the case of the repulsive interaction the  $d_{x^2 y^2}$  superconductivity and the self-energy corrections are both of second order in U, so that by decreasing U one cannot prom ote only superconductivity and make the uctuations subdom inant.

RENORMALIZATION-GROUP RESULTS FOR THE t J U MODEL.




FIG.5: (Coloronline) AF (upperpanels) and  $d_{x^2 y^2}$  SC (low erpanels) susceptibilities as functions of the scale 1 for H ubbard m odel with U = J = 1:6t and densities determ ined by l = 1 (left-hand panels) and l = 3 (right-hand panels), corresponding, respectively, to half-lling (parquet regim e) and high doping (within the BCS regim e). O ther details are the sam e as in Fig. 3.

We present results for the relevant susceptibilities in the t J U model in Fig. 5. The left-hand panels correspond to half-lling and the behavior is similar to that of the Hubbard case. Namely, SC susceptibility with  $d_{x^2 y^2}$  symmetry evolves to values below of the noninteracting one, while AF susceptibility remains higher than its noninteracting value, indicating that at n = 1, the system ow stowards an AF insulating state. Upon doping the  $d_{x^2 y^2}$  superconductivity gets progressively stronger and becomes the dominant instability at about the crossover line = , just as in the Hubbard model. The right-hand panels show a typical ow of the susceptibility in the BCS regime ( < ) where the dominant

### correlations are of superconductivity type.

The above picture shares som e features with the behavior observed in the Hubbard model, discussed in the previous section. Im portant issues to highlight are: (i) At half-lling the behavior of the relevant susceptibilities is very sim ilar to that of the repulsive Hubbard model. However, the scale  $l_c$  at which the on-set of the AF instability takes place as well as the scale 1 are smaller than for the J = 0 case. The susceptibility is also significantly larger than the noninteracting one, even when self-energy corrections are included in the RG procedure. These features indicate that J contributes to increase the AF correlations and the Neelten perature. (ii) At higher dopings, within the BCS regime, AF susceptibility coincides with the noninteracting one while SC correlations become signi cantly enhanced. This is in contrast to the behavior of the repulsive model (cf. Fig. 3) where SC correlations are only weakly enhanced. Instead, the behavior on the right panels of Fig. 5 resembles the one of the attractive Hubbard model, if we associate  $d_{x^2 \ v^2}$  SC and AF susceptibilities in Fig. 5 respectively to s-wave SC and CDW susceptibilities on middle and right panels of Fig. 4. A loo note that, as in the attractive model, the scale 1 remains una ected by self-energy e ects. In addition, the scale  $l_c$  at which the on-set of the superconducting instability is observed is small in the t J U model, implying a high critical temperature. We have carried out a sim ilar analysis for other values of the parameters J and U and found that the




FIG.6: (Color online) Phase diagram showing combined action of U and J interactions. The \critical temperature" is de ned as  $T_c_c = 8 \text{texp}(l_c)$  (see text). Left and right panels correspond to J = 1.6t and J = 0.4t, respectively. Plots in blue circles correspond to U = 0;0.4t;0.8t;t;1.6t;3.2t. The ones corresponding to the lowest and highest U are drawn in open and dark lled symbols, respectively. The plot in red squares corresponds to the usual Hubbard m odel (J = 0 and U = 1.6t). The line T = separates the regions where the SDW and  $d_{x^2 y^2}$  superconducting (dSC) instabilities are the dom inant ones.

symmetry of the dominant superconducting correlations is always  $d_{x^2 y^2}$ . We have veried the reliability of these results upon increasing number of patches up to 64 patches. The reason for the robustness of the SC correlations is in the fact that the J interaction has an attractive  $d_{x^2 y^2}$  SC component, so that superconductivity exists already at rst order of U<sub>1</sub> while the uctuations are only subdom inant, just as in the attractive Hubbard case.

In order to have a m ore quantitative representation of the role played by both interactions we present the phase diagram in Fig. 6. The \critical tem perature" plotted in the gure is de ned as  $T_c$  , where  $c = 8texp(l_c)$ . Results for the repulsive Hubbard model are also shown for comparison. By comparing the plots for J = 0; U = 1:6t and J = 1:6t; U = 0 in the left panel and for J = 0; U = 1:6t and J = 0:4t; U = 1:6t in the right panel (the arrows are drawn to ease the reading), it is clear that J is a rem arkably e cient m echanism to drive AF close to half-lling and  $d_{x^2 y^2}$  superconductivity in the doped system . Another in portant feature is that at xed J, the e ect of U is to increase the \critical tem perature". This m eans that the two interactions are not com petitive but, instead, cooperate to increase the strength of antiferrom agnetic and superconducting correlations.

EXACT  $\rightarrow$  IAGONALIZATION RESULTS FOR THE t J UMODEL IN THE 4 4 CLUSTER.

The results of the previous section suggest that the combined e ect of the interactions J and U drives superconductivity with  $d_{x^2 \ y^2}$  symmetry in the doped system, leading to a signi cant enhancement of the superconducting correlations. As in the case of the pure H ubbard m odel numerical methods fail to detect the tendency towards  $d_{x^2 \ y^2}$ -superconductivity, it is interesting to analyze the case of nite J.

We show below results obtained by following the strategy explained in Section II. We computed the exact GS energy and wave function in a 4 d cluster and calculated the correlation functions between pairs with local and extended s-wave and  $d_{x^2 y^2}$  symmetries. We focused our attention on the study of three diment llings (n = 0:625;0:75;0:875), corresponding to N = 10;12;14 particles in the cluster.

Let us begin with the analysis of the boundary conditions leading to the lowest energy. For the case n = 0:625, the GS is obtained for PBC. In the noninteracting limit, it corresponds to a closed-shell con guration and for all the explored values of the interactions, it lies in the subspace associated to the representation of the point group with s-wave like character. The k-points lying on the Ferm i surface of the noninteracting system are (=2;0) and the symmetry related points. For these points, the structure factors  $f_{es}(k) = \cos(k_x) + \cos(k_y)$ and  $f_d(k) = \cos(k_x) - \cos(k_y)$ , corresponding to BCS gaps with extended s and  $d_{x^2-y^2}$ -wave symmetries have exactly the same strength  $jf_d j = jf_{es} j = 1$ .

For llings n = 0.75 and n = 0.875, the lowest energy in the noninteracting case is achieved by considering MBC. In this limit, the only ingredient playing a role in the energetic balance is the kinetic energy gain. As interactions are switched on, the GS corresponds to APBC for su ciently large J and U. This indicates that the k-points tuned by APBC are able to take advantage of som e e ect of the interactions, compensating the loss of kinetic energy. For the latter boundary conditions, the Ferm i points of the noninteracting system lie on the lines of nodes of  $f_{es}$ . Therefore, it is likely that the most favored instability by such a change of population in the k-space is  $d_{x^2 y^2}$ -wave superconductivity. Som e values of the GS energy per site are shown in tables I and II.

It is interesting to note that, for the density n = 0.75, the GS belongs to the representation of the point symmetry group with s-wave-like character within the region where the GS

corresponds to APBC. Instead, for n = 0.875 and also within the region of parameters where the GS corresponds to APBC, the character of the point-group representation is  $d_{x^2 y^2}$ -wave like. Since in the present cluster n = 0.875, di ers from n = 0.75 in two particles, this change of representation is consistent with the idea that a pair of particles with  $d_{x^2 y^2}$ wave symmetry was added to a many-particle background with totals-wave symmetry. We actually speculate that such a background is also made up of paired particles.




FIG. 7: (C olor online) Pair correlation function at the maximum distance,  $P_m$ , of the cluster for a density of particles n = 0.625. B lue circles correspond to pairs with  $d_{x^2 y^2}$  and red diamonds to extended s symmetry. D i erent plots correspond to J = 0.025,0.5,0.75,1. Open and led dark symbols correspond to the low est and highest value of J, respectively. The dotted-dashed line indicates the value of  $P_m$  in the noninteracting limit.

The behavior of  $P_m$ , the pair correlation function (15) corresponding to pairs separated by the maximum possible distance of the cluster, for a particle density n = 0.625 is shown in Fig.7. The correlation function corresponding to local pairs with s-wave symmetry is much weaker and is not shown. The corresponding values for the noninteracting system are indicated in dot-dashed lines to ease the comparison. In the latter limit, correlations of pairs with  $d_{x^2 y^2}$  symmetry remain weaker than those of the noninteracting case while s-wave ones are slightly enhanced for small enough U. The elect of J is to produce a weak enhancement of  $P_m$  within the two symmetry channels in comparison to the pure Hubbard case. In particular,  $d_{x^2 y^2}$  ones become stronger than those of the noninteracting case for




FIG.8: (Color online) Pair correlation function at the maximum distance of the 4 d cluster,  $P_m$ , for a density of particles n = 0.75. D i erent plots correspond to J = 0.025, 0.5, 0.75, 1, 1.5, 1.75, 2. Upper and lower panels correspond to APB and MBC respectively. O ther details are as in Fig. 7.

sm allenough U .

The pairing function  $P_m$  for the density n = 0.75 is shown in Fig.8. We have analyzed the behavior using the two boundary conditions leading to the lowest energy. In the case of APBC shown in the upper panel of Fig. 8, only the correlation of pairs with  $d_{x^2 y^2}$  sym metry is shown, since those with local s- and extended s-wave are negligibly small in comparison. In the case of MBC shown in the lower panel, correlations in both, extended s-wave and  $d_{x^2 y^2}$ -sym metry channels are only slightly enhanced for some values of J and suppressed for others. Instead, for APBC, a clear enhancement of the correlations of pairs with  $d_{x^2 y^2}$ is observed as J is switched on. Note that, in contrast to the case J = 0, the correlation function  $P_m$  lies above the line indicating the magnitude of  $P_m$  in the noninteracting case.




FIG.9: (Color online) Pair correlation function at the maximum distance of the 4 d cluster,  $P_m$ , for a density of particles n = 0.875. O ther details are as in Fig. 8.

Similar remarks apply to the behavior of  $P_m$  at the density n = 0.875, shown in Fig.9. The enhancement of  $d_{x^2 y^2}$  pairing correlations for the case of APBC is related to the fact that the available k vectors mainly populated in the ground state contribute with a sizable structure factor to a pairing interaction at the Ferm i surface with  $d_{x^2 y^2}$  symmetry.




FIG. 10: (C olor online) Pair correlation function at the maximum distance of the 4 d cluster,  $P_m$ , for pairs with  $d_{x^2 y^2}$  symmetry corresponding to the optimal boundary conditions for the ground state. Upper and lower panels correspond to densities of particles n = 0.75 and n = 0.875, respectively. O ther details are as in Figs. 7 and 8.

If, for the latter densities, we plot the pair correlation function in the GS corresponding to the optim al boundary condition (i.e. that leading to the lowest energy), we obtain the picture shown in Fig. 10. In good agreement with the analysis done in the discussion about




FIG.11: (Color online) Fourier transform of the spin-spin correlation function for n = 0.75 and MBC.Dierent panels correspond to dierent U. Open and lled dark symbols correspond to J = 0 and J = 1, respectively. Other plots correspond to intermediate equally spaced values of J.




FIG.12: (Coloronline) The same as Fig. 11 for n = 0.875.

the behavior of the GS energy, we see that the change in the boundary condition leading to the low est energy, is accompanied with an enhancement of the  $d_{x^2 - y^2}$ -wave pairing correlation function. The pairing correlation functions with extended s symmetry are, instead, vanishing small within all the range of parameters. This could be an unfortunate consequence of the small size of the cluster and to the fact that the most populated k-points when the boundary conditions change, lie on the lines of nodes of the structure factor  $f_{es}$ . However, this behavior is in agreement with the results predicted by RG.

To nalize, we present some results on the behavior of spin-spin correlation functions.

Fig. 11 and Fig 12 show some typical plots corresponding to the GS in the cluster with MBC. In the case of Fig. 11 the latter boundary condition corresponds to the one leading to the lowest energy within the range of parameters shown. In Fig. 12 this is not always the case but we found that there are only slight quantitative di erences between the results of the gure and the corresponding ones with APBC. The important feature to note is that the e ect of J is to increase the peak of S (; ). By comparing the height of the latter peak for the two densities it is clear that AF correlations increase as the system approaches to half-lling. Forn = 0:75, S (k) shows a wide structure for the usual H ubbard m odel, and for large U the peak is placed at incommensurate positions k  $\in$  (;) (cf. lower panels of Fig. 11). Remarkably, the elect of J is to shift these peaks to the AF vectors. All these features are consistent with the idea that J drives an enhancem ent of AF correlations relative to the usual Hubbard case. The sm all size of the cluster does not allow s us to have an estim ate of the AF correlation length. It can be, how ever, noted that for the lower density (cf. Fig. 11) S (k) spreads out on a wide range of k vectors surrounding (; ), consistent with a picture of short-range AF correlations. Instead, for lower doping, the structure evolves to a sharper peak around (;) suggesting larger coherence lengths. It is also interesting to note that the increment of AF correlations (from n = 0.75 to n = 0.375) is accompanied by a decrease of the pairing correlations (see Fig. 6), in agreem ent with the RG results from the previous section.

#### SUMMARY AND CONCLUSIONS

The main result of the present study is that the cooperative e ect between the nearest neighbor exchange interaction J and the on-site C oulomb repulsion U increases in a larger than simply additive way the antiferrom agnetic and  $d_{x^2 y^2}$  superconducting tendencies in 2D. For our analysis we used the angle resolved renorm alization group including self-energy corrections and the exact diagonalization m ethods.

We have rst considered the repulsive and the attractive H ubbard m odels and we have calculated the self-energy-dressed dom inant correlation functions at half-lling and at nite doping. In the repulsive (U > 0) case self-energy e ects reduce radically all two-particle correlations and destroy their divergences near the critical scale. At half-lling the SC correlation function is below its U = 0 value, while the AF one remains stronger than

its value for U = 0, but loses the divergence. This behavior, discussed in Ref.[41], is a signature of the M ott localization tendencies with simultaneous build-up of short ranged AF correlations. At nite doping, surprisingly and contrary to previous predictions made by the RG theory without self-energy corrections (Ref.[6]), the superconducting instabilities are strongly reduced by self-energy corrections even deeply in the BCS regime, i.e. when the Ferm i surface is badly nested and um klapps are irrelevant. In the case of the attractive interaction (U < 0) our RG results are in complete agreem ent with previous studies [43, 44]. At half-lling the s-wave superconductivity and the charge density wave correlations are degenerate. The ow of the two correlation functions books sim ilar to the one of the AF correlation function for repulsive Hubbard model at half-lling. Just as in the repulsive case, the self-energy e ect regularizes the ow of correlation functions near c at half-lling and no phase transition occurs at this scale. The elective action of the regime below was discussed by Schulz [45]. Contrary to the half-led case, at nite doping the attractive Hubbard model shows a convincing on-set of the superconductivity. In comparison to the repulsive case where  $d_{x^2 y^2}$  SC susceptibility is only weakly enhanced, in the attractive case the s-wave SC correlations at  $_{\rm c}$  are not destroyed by the self-energy, while CDW susceptibility remains stuck to its U = 0 value. At this point some general remarks are in order. We have seen that there are fundamental dierences between RG ows of the repulsive and of the attractive Hubbard models. The uctuations in the repulsive model are much stronger and probably fatal for superconductivity. They tend not only to decrease the magnitude of the SC susceptibility but also to decrease the energy = 8 texp(1) atwhich it begins to depart from the behavior of the noninteracting one. Our present study is unable to say if the superconductivity is stabilized or not at some energy lower than ... However, the absence of all divergences indicates that the scenarios with pre-form ed pairs of AF and SC type are relevant even in the weak coupling limit. These RG results agree with the ED analysis for the intermediate-to-strong couplings, where no superconductivity was detected. The situation is fundamentally dierent in the attractive Hubbard model, where the superconducting instability is robust upon self-energy corrections. This is the RG version of the well known fact that the incoherent preform ed pairs can live only at interm ediate-to-strong interaction [46].

The study of the two Hubbard models was a necessary introduction to the RG analysis of the t J U model. The question that we answer is if the superconductivity of the

t J U model is enhanced or reduced with respect to the simple cases J = 0 and U = 0. The answer is that J and U cooperate to a) increase the critical cuto b) keeping the renormalized susceptibility enhanced relative to the noninteracting one. W e also found that the latter e ect is observed not only on the superconducting side of the phase diagram but also on the antiferrom agnetic one. W e thus have an evidence for the U-J synergy e ect. The phase diagram on Fig. 6 shows in particular the cases (U = 1:6t; J = 0), (U = 0; J = 1:6t) and (U = 1:6t; J = 1:6t). The critical tem perature of the third case is much higher than for the rst two, while the onset of  $d_{x^2 y^2}$  SC remains convincingly large in the ow of the correlation function.

Exact-diagonalization results support the above picture. In fact, for large enough J and U, we nd below half-lling a clear enhancem ent of the SC correlations with  $d_{x^2 v^2}$  symmetry which is accompanied by a change in the type of boundary conditions leading to the lowest energy. This behavior is consistent with the idea that the large Coulomb repulsion spreads out the Ferm i surface towards sectors of the Brillouin zone where the interaction J has the largest amplitude in the BCS channel with  $d_{x^2 v^2}$  symmetry. In such a way, we can think that particles are pushed to a region of the phase space, where the attractive interaction is m ost e cient to organize them into pairs. Sim ilar argum ents can be proposed to explain the enhancem ent of AF correlations at half-lling since the J interaction has components along AF and SC channels. In particular, in Ref. [41] it has been found that the angle-resolved quasiparticle weight Z () renormalizes in such a way that it displays a maximum in regions of the Ferm i surface that are separated by the magnetic vector Q = (;). We have not found strong di erences between the behavior of Z ( ) in the usual H ubbard m odel and the t J U one neither at half-lling nor for nite doping. Therefore, the most likely scenario at half-lling is that the larger population of convenient regions of the k-space becom e available to be exploited by the component of the J interaction along the AF channel.

W e have not found any indication of bond-order-like instability. This is in disagreement with some mean-eld predictions [26] but in full agreement with other RG studies on van-Hove llings of the t  $t^0$  J U models [40]. Our conclusion regarding the combined J U mechanism to drive large superconducting correlations is also in agreement with previous investigations based on Ferm i liquid arguments and quantum M onte C arb simulations [39]. Within the repulsive Hubbard model, we obtained by renormalization group that the selfenergy corrections are fatal for superconductivity and by exact diagonalization that the superconductivity is unlikely. This result is important because it reconciles the N-patch RG with exact diagonalization and with a number of other approaches. Our results show that while the  $d_{x^2 y^2}$  pairing exists in the Hubbard model (because vertex indeed diverges), the onset of macroscopic superconductivity is suppressed. This result is in agreement with the very recent indigs by Plekhanov and co-workers [47].

A llabove remarks indicate that the J interaction is vital for the superconductivity while the U interaction increases considerably the tendency towards pair formation. They also suggest that minimalm icroscopic models supporting recent phenomenological proposals for colossal e ects in the phase diagram of the high  $T_c$  compounds [1] may be based on these two interactions. In fact, our results indicate that the interaction J provides a kick to the potential or weak antiferrom agnetic and superconducting tendencies of the H ubbard model, that triggers a gigantic response in the system. This picture resembles the behavior of manganites where colossal magnetoresistance e ects take place in response to external magnetic ekis and this analogy is behind the proposal of Ref. [1]. The appropriate microscopic approach should be based on a recently developed N-patch renorm alization group theory for disordered and interacting in perfectly nested system [48]. On the other hand, as discussed in our introductory section, derivations starting from the three band model for the cuprates also support the idea that the t J U model is a good candidate for a minimal one-band H am iltonian for these materials.
