SR study of the quantum dynam ics in the frustrated  $S = \frac{3}{2}$  kagom e bilayers

We present SR experiments in the  $S=\frac{3}{2}$  kagome bilayer compound Ba $_2$ Sn $_2$ ZnGa $_{10}$  7 $_p$ C r $_{1p}$ O  $_{22}$  (BSZCGO (p)) and compare it to the isostructural SrC r $_{9p}$ G a $_{12}$  9 $_p$ O  $_{19}$  (SCGO (p)), including for the latter new results for p 0:89. Quantum-dynamical low energy magnetic excitations are evidenced in this novel compound. We study the evolution of the muon relaxation rate with p, T and eld. A phenomenological model for the muon relaxation based on sporadic dynamics due to spin excitations in a singlet sea proposed by U emura et al. [Phys. Rev. Lett. 73, 3306 (1994)]. is extended to all elds and T-range. Its connexion to the RVB picture is discussed, and we argue that such coherent states might mediate the interactions between \impurities" which induce the spin glass freezing.

The stabilization of a spin liquid state, in which all kinds of magnetic correlation functions are short ranged, seem snow granted theoretically in the S =  $\frac{1}{2}$  H eisenberg kagom e lattice with nearest neighbour (NN) antiferrom agnetic interactions. The ground state (GS) is probably of resonating valence bond type (RVB), built from a m acroscopic num ber of singlet states [1]. If any, a gap between the GS and the rst triplet state is expected to be fairly sm all (J=20) [2] in comparison with the exchange constant J. Most striking, due to both comer sharing geom etry and half integer spins, an exponential density of low lying singlet excitations, with energies smaller than the gap, is predicted [3] and yields an extensive entropy at T = 0 [4]. Finally, the nature of the rst magnetic excitations, such as uncon ned spinons, are still under debate [4].

Am ong all comer sharing highly frustrated magnets, only a few are good candidates ful lling the important conditions of the pure Heisenberg lattice with NN couplings. The combination of the weakness of the singleion anisotropy and of a direct overlap exchange are certainly the major advantages of the recently discovered chrom ate  $S = \frac{3}{2}$  kagom e bilayer BSZCGO (p) [5, 6] and the long studied SCGO (p) [7], where p is the  $Cr^{3+}$  network covering rate. Beyond the absence of ordering well below the Curie-Weiss temperature, the unusual large value of the speci cheat unveils a high density of low lying excitations [5, 8] and its eld independence suggests that the excited states are mostly singlets [9]. Moreover, their GS is found essentially uctuating as proven by neutron experiments [10], and SR for SCGO (p) [11, 12], although an intrinsic spin glass (SG) signature is observed in susceptibility measurements [7, 13]. The origin of such a SG state in a disorder-free system still awaits for a com plete understanding although recent theoretical approaches catch som e of the facets of this original GS [14].

In this context BSZCGO (p) appears as a unique com -

pound : it has a more pronounced 2D character than SCGO (p), with a larger interbilayer distance [5] and all the magnetic sites lying on a corner sharing lattice [22]. In addition, a twice lower SG temperature  $T_g$  has been reported [5] and a new type of defects other than non-magnetic substitutions (likely bond defects), dominates the low-T susceptibility [6]. This o ers the possibility of probing the in uence of  $T_g$  and the relevance of dilution on the evolution of the T  $\,!\,$  O dynamics, by a simple comparison of two quasi-identical kagom e bilayers.

In this Letter, we present the rst M uon Spin Relaxation (SR) study of the spin dynamics in BSZCGO (p) and revisit the case of SCGO (p) for low dilutions now available. This technique has proven to be a front tool for the study of quantum dynamical states in a vast fam ily of singlet GS systems. W hereas specic heat is sensitive to all kinds of excitations, including likely dom inant low lying singlets at low-T [9], muons ( $^{+}$ , S =  $\frac{1}{2}$ ) probe magnetic excitations only. Their relaxation rate is linked to the spin-spin time correlation function hS (0) S (t)i $\cos$ (H  $_{\rm LF}$  t)dt, where H  $_{\rm LF}$  is the external eld applied along the 'initial polarization is the + gyrom agnetic ratio. The typical time window (10 ns-10 s) allows to observe spin uctuations which set in the speci c range of frequencies ( 10° Hz) in between NMR and neutron experiments. Not only in SCGO [11, 12] and in other kagom e system s [15, 16] but also in other spin-singlet compounds [17], the signature of the quantum dynamics when T! 0 could be identied to the occurrence of a plateau of and a eld-independent in itial G aussian shape of the  $\,^{+}$  polarisation P  $_{z}$  (t). Extending the original guess of U em ura et al. to explain this exotic uctuating GS [11], we propose for the rst time a phenomenological model which explains both Tand eld-dependence of Pz (t) for all p in these kagom e

In order to illustrate the evolution of the properties




FIG. 1: a,b) T-dependence of the  $^+$  polarization  $P_z$  (t) in BSZCGO under weak (10 G for p = 0.43 and 100 G for p = 0.97) longitudinal eld. Notice the dierent time scales for both samples. c,d) H  $_{\rm L\,F}$ -dependence at base-T. The line for p = 0.43, ZF, is a square-root exponential multiplied by the K ubo-Toyabe function in zero eld ( $_{\rm N\,D}$ 0.08 s  $^1$ ), to take into accunt the nuclear dipole contribution. The other lines are ts described in the text.

with dilution, we rst focus on the qualitative di erences (Fig. 1) between two typical low and high occupations p of the kagom e bilayers. Starting from high-T (T > 6 K in Fig. 1 (a,b)), a conventional param agnetic behavior is found for both cases, with an exponential variation of  $P_z$  (t) in the dense case and square root exponential in the dilute case. The evolution of Pz (t) at low-T is markedly dierent. For p = 0.97, the relaxation rate increases by more than two orders of magnitude to reach a Tindependent value for T .  $T_{\alpha}$ 1:5 K [5] (Fig. 1(b)). For T = 0.03 K,  $P_z$  (t) displays a shape in between exponential and Gaussian at early times and reaches zero value at long times (Fig. 1(d)). It also displays a much weaker eld dependence than for a frozen magnetic state.  $2 ext{ s}^{1}$ , a 500 G eld would completely Indeed, for decouple the + polarisation [11]. Following the arguments initially developed for SCGO (p) [11, 12], all these properties are the rst indications of a quantum dynam icalm agnetic state in BSZCGO (0:97). For p = 0:43, we also nd a dynam ical state but, at variance with the previous case, only a weak T-dependence is observed. A lso, the polarization displays a square root exponential decay for all T (Fig. 1(a)) and for any eld H  $_{\rm LF}$  (Fig. 1(c)). A




FIG. 2: Comparison of the evolution of the  $^{^+}$  relaxation rate  $\,$  vs. T in BSZCGO (0.97) and SCGO (0.95), from a 1=e analysis. Inset: recovery of a part of the asym m etry at low-T and long times in SCGO below  $T_{\rm g}$  (log-log scale).

weak plateau of the relaxation rate is still observed below 0.5 K. However the relaxation rate increases weakly but continuously when T decreases for p=0.3, with a very weak H  $_{\rm LF}$  -dependence. This is typical of the pure param agnetic fast uctuations lim it for diluted m agnetic system s, although strongly frustrated antiferrom agnetic interactions are still reported [6].

In a rst step of analysis, we estimate the  $^+$  relaxation rate using the  $\frac{1}{e}$  point of P  $_{\rm z}$  (t), as discussed in [12]. This allows to single out information about two important issues using a simple model-independent analysis: the role of the SG-like transition and the impact of the non-magnetic dilutions on the dynamics.

From high-T, increases by more than two orders of magnitude down to  $T_g$  for both purest samples, to reach the relaxation rate plateau  $_{\rm T\,!\,0}$  for T .  $T_g$ . With a T-scale twice larger for SCGO (0.95) than in BSZCGO (0.97), (T) perfectly scales on the T axis as shown in Fig.2 [23]. This ratio is very close to their  $T_g$  ratio of 2.3 (2), which points to a link between the form ation of the SG-like state and the presence of quantum uctuations. This seem s to be a quite common feature of various systems with singlet GS systems [11, 12, 15, 16, 17].




FIG.3: p-dependence of  $_{\text{T!0}}$  for BSZCGO (open symbols) and SCGO (full symbols). Continuous (dashed) lines are  $p^3+1.9(3)p^6$  (/  $p^3$ , [12]) ts.

In Fig. 3 we report the variation of  $_{\rm T}$ ! 0 (T) for various B SZCGO (p) sam ples and compare them to SCGO (p) [11,12]. A lthough additionnal p-independent defects are dominant in BSZCGO (p) and evidenced from a large Curie-like term in macroscopic susceptibility at low-T [6], it is very surprising to nd a very similar quantitative  $_{\rm T}$ ! 0 variation in the whole prange for both systems. Therefore we conclude that only defects related to dilution in uence the relaxation rate.

In a classical framework, a coplanar arrangement with zero-energy excitation modes, involving spins on hexagons, was proposed in the literature to be selected at low-T [18]. Inelastic neutron scattering experiments on

the spinel compound ZnC  $r_2O_4$  are the first recent indication in favor of such excitations [19]. Therefore, one expects the  $^+$  relaxation to scale with the number of fully occupied hexagons, /  $p^6$ . The BSZCGO (p) data altogether with our SCGO 0:89 p 0:95 samples indicate that  $_{\rm T\,!\,0}$  (p) is well accounted for by adding a dominant  $p^6$  term to the /  $p^3$  term proposed for SCGO (p 0:89) in [12] (Fig. 3). This certainly indicates that the relaxation is not induced by single spin excitations but rather collective excitation processes extending at least on triangles and hexagons.

One of the pending challenges in the analysis of SR in kagom e frustrated antiferrom agnets is to nd a theoretical model reproducing Pz (t) for all elds and all tem peratures. In the quantum framework of a singlet GS, one needs unpaired spins in order to generate magnetic excitations responsible for the + relaxation. Such excitations can be ascribed by spin  $\frac{1}{2}$  uncon ned spinons. Their location vary in time with no loss of coherence of the excited state. Hence, a given + couples to a spin only a short fraction ft of the time t after implantation and one can use a model of \sporadic" eld uctuations to describe P, (t). This was the initial quess by U em ura et al to account for the weakness of the eld dependence of  $P_{z}$  (t) at low-T in SCGO (0.89) [11]. This polarization is given by a \sporadic" dynam ical K ubo-Toyabe function which can be approximated by the Keren analytical function  $P_z^K$  (ft; ;H  $_{\rm LF}$ ; ) =  $P_z^K$  (t;f ;fH  $_{\rm LF}$ ;f ), valid in [20], quite appropriate here. = local eld created on the + site by a param agnetic neighbouring released spin, with a corresponding exponential time correlation function, exp (t), characterized by a uctuation frequency . is related to the  $\phantom{a}^{\dagger}$  location in the unit cell and its value is therefore p-independent for a given system but is expected to vary from BSZCGO to SCGO. The Gaussian at early times, the weakness of the eld dependence and a dynam ical relaxation down to




FIG. 4: Fitting parameters of Eq. 1. a,b)  $\rm H_{LF}-$  and T-dependence of x for BSZCGO(p) (open symbols) and SCGO(p) (full symbols). c) p-dependence of f. d) T-dependence of  $^{0}$ .

0 are altogether related to the f factor and . In addition to this sporadic relaxation, we found that a more conventional M arkovian relaxation channel needs to be introduced in order to t the long times tail (t & 3 s) for all elds and T, which yields an exponential variation of  $P_z$  (t). We therefore write

$$P_z(t) = xP_z^{K}(t; f; fH_{LF}; f) + (1 x)e^{-0t};$$

where x represents the weight of the short time sporadic dynamical function, associated with the spinons dynamics. In the following, we set detail how all these parameters can be reliably deduced from the data and sketch a physical picture consistent with our results.

We rst present our analysis for T Tq in BSZ-CGO (p). In order to lim it the num ber of free param eters, we make the minimal assumption that the external eld does not in uence the dynamics of the coherent spinon and values are shared for all p and H  $_{
m LF}$  and are set by our data taken at low  $\,$  elds (H  $_{\rm L\,F}$  < 500 G) for various p. f is adjusted for each p and its variation accounts for the evolution of T = 0 (p). For low elds, x is found close to 1 for the purest samples (Fig. 1(a,b)), making 0 a non-relevant thing parameter. On the contrary, the high eld data enable us to track the evolution of x with H  $_{
m LF}$  and to determ ine a value of  $^{
m 0}$ . We could not extend the ts below  $p = 0.71 \sin ce$  the weak eld dependence prevents an unambiguous determination of the param eters.

We nd perfect ts of our data (Fig. 1(d)) with 1000 s  $^1$ , 350 s  $^1$  4 kG and an average value of f 0.006. We nd a nearly at p-independent long time relaxation rate for T  $T_g$  ( $^0$  0.05 s  $^1$ , F in Fig. 4(d)). An important nding is that x is of the order of p at low elds (Fig. 4(a,b)). This may be re-

lated to theoretical computations show ing that the correlations are enhanced around spin vacancies in the kagom e lattice [21], which would destroy locally the liquid state. Besides, x decreases appreciably for H  $_{\rm LF}$   $\,$  10 kG whatever the value of p. We can associate this decrease to the existence of an energy scale  $\,$  1 K , which is of the order of T  $_{\rm g}$  . Finally, we observe a linear variation of f with p (Fig. 4(c)) and f tends to vanish around p  $\,$  0.5, a limit consistent with our classical approach (Fig. 3). This indicates that even far from the substituted sites, the coherent state is somehow a ected, e.g. the density of spinons could be smaller.

As suggested by the similar p-variation of  $_{\text{T!}}$  0 in both BSZCGO and SCGO, we assume that the excitation modes are identical in both systems, i.e., f and are kept the same for comparable p. We nd  $1200 \text{ s}^{-1}$ for our SCGO samples (p 0:89), in agreem entwith previous work on SCGO (0.89) [11]. In order to cross-check these values of  $\,$  , we use the high-T  $\,$  (  $\,$  50 K ) data for  $0.01 \, \text{s}^{-1} \, (0.03 \, \text{s}^{-1})$ . In the ap-BSZCGO (SCGO), propriate param agnetic lim it, the uctuation rate can be 2 10<sup>3</sup> s <sup>1</sup> [11] using zJS=k<sub>B</sub> ~ estim ated from a coupling J = 40 K [6] and an average number z = 5:14of Cr NN [7]. We extract = =2 (600 s 1), consistent with our ts. It is quite rewarding to nd that a comm on physical picture underlies all the sets of data at low-T for both kagom e bilayers.

We now extend the  $ts of P_z$  (t) to the whole T-range (Fig.1 (b)), xing f to its low-T value in order to lim it the number of free parameters. As expected from the change of shape around  $T_g$  [11, 12], the weight x of the sporadic term decreases to nally enter a high-T regime (Fig.4 (b)) where the  $^+$  relaxation becomes exponential (x ! 0). Notice the similarity between the eld and T-dependence of x which indicates that the sporadic regime is destroyed when the energy is of the order of  $T_g$ . Fig. 3 (b) displays a sharp crossover from one state to the other, between  $T_g$  and  $T_g$ , corresponding to the steep decrease (Fig.2), for both BSZCGO (p) and SCGO (p). For  $T > T_g$ , and  $T_g$ .

At high-T, it is natural to think in term s of param agnetic uctuating spins. Lowering T, 0 seems to diverge at  $T_{\alpha}$  and below, the weight of the exponential term at low elds (1 X 1 p) could correspond to localized frozen spins, re ecting a glassy component. It is noteworthy that  $T_q$  does not increase with 1 p but rather decreases, at the opposite of the case of canonical spin glasses. We could further con m the existence of such a frozen component in SCGO (p = 0.95 0:89), since a clear recovery of a small part ( 4%) of the asym metry is found at long times (e.g. Fig. 2 (inset)). It is observed 100 <sup>1</sup>, which is out of the experim ental range in the case of BSZCGO (p).

To sum marize, the picture based on a coherent RVB state, which magnetic excitations are mobile uctuating

spins  $\frac{1}{2}$  on the kagom e lattice, explains well the data, provided that (i) these excitations can be generated even for T ! 0. This underlines the smallness of the \magnetic" gap, if any, typically < J=1000 ; (ii) an energy scale related to  $T_g$  (elds of the order of 10 kG or, equivalently, temperatures of the order of  $T_g$ , which vary very little with p) are high enough to destroy the coherent RVB type state ; (iii) the substitution defects are accounted for by an additional classical relaxation process.

The absence of energy scale for spin  $\frac{1}{2}$  excitations could explain quite well why the transition to the SG state is fairly independent of p. Indeed, in this fram ework, spinons could mediate the interactions between magnetic defects localized around spin vacancies. This is corroborated by all the scaling properties in  $T=T_g$ . The transition to the SG state corresponds then to the formation of the coherent singlet state rather than any interaction strength between defects.

eld experim ents show for instance a larger linewidth in SCGO(0.95) than in BSZCGO(0.91) (D.Bono et al., unpublished) despite a lower defect term [6].
