Evidence for charged critical behavior in the pyrochlore superconductor R b0 s_2 0 $_6$

W e analyze m agnetic penetration depth () data of the recently discovered superconducting pyrochlore oxide RbO s_2O_6 . Our results strongly suggest that in RbO s_2O_6 charged critical uctuations dom inate the temperature dependence of near T_c . This is in contrast to the mean-eld behavior observed in conventional superconductors and the uncharged critical behavior found in nearly optimally doped cuprate superconductors. However, this noting agrees with the theoretical predictions for charged criticality and the charged criticality observed in underdoped Y Ba₂C u₃O $_{6:59}$.

Transition metal (TM) oxides are of considerable interest because their properties range from metal-insulator transitions to colossalm agnetoresistance and superconductivity. TM oxide com pounds with the pyrochlore structure have long been studied and have found m any applications [1], but it is not until recently that superconductivity was discovered in one such a material, namely $Cd_2Re_2O_7$ at $T_c = 1 K$ [24]. Subsequently, superconductivity was also discovered in the pyrochlore oxides KOs_2O_6 (T_c 9:6K) [5], RbOs₂O₆ with (T_c 6:3 K) [6] and $C = 0.5 \times 0.6 \text{ with}$ 3:3 K) [7]. A lthough the T_c's are rather low the discovery of superconductivity in the pyrochlore oxides opens (T_{c}) research in this area to a new class of materials and raises, of course, the question of the underlying mechanism . Based on a Cd and ReNMR/NQR study V yaselev et al. [3] concluded that $Cd_2Re_2O_7$ behaves as a weak-coupling BCS superconductor with a nearly isotropic gap, in agreem ent with speci c heat m easurem ents [9]. On the other hand, K oda et al. [10] interpreted their penetration depth m easurements on KO 5,06 in terms of unconventional superconductivity, while the recent speci c heat [11], m agnetization, m uon-spin-rotation (SR) m easurem ents of the m agnetic penetration depth [12,13], and the pressure e ect m easurements [12] on RbO s_2O_6 reveal consistent evidence form ean-eld behavior, except close to T_c, where therm al uctuations are expected to occur. Hence, a careful study of the therm odynam ic properties of these m aterials close to T_c should allow to discrim inate between m ean-eld, charged and uncharged critical behavior.

In this work, we focus on RbO s_2O_6 and analyze the extended m easurem ents of the tem perature dependence of the magnetic penetration depth [13]. Our results strongly suggest that RbO s_2O_6 falls in the universality class of charged superconductors because charged critical uctuations are found to dom inate the tem perature dependence of

near T_c. It di ers from the m ean- eld behavior observed in conventional superconductors and the uncharged critical behavior found in nearly optim ally doped cuprate superconductors [14{18}, but agrees with the theoretical predictions for charged criticality [19{23}] and the charged critical behavior observed in underdoped Y B a_2 C u_3 O $_{6:59}$ [24].

As long as the elective dimensionless charge e = = 1 = [14] is small, where is the Ginzburg-Landau parameter, the crossover upon approaching T_c is initially to the critical regime of a weakly charged super uid where the uctuations of the order parameter are essentially those of an uncharged super uid [14{18}]. How ever, superconductors with rather low T_c 's and far away from any quantum critical point are expected to exhibit mean-eld ground state properties. In this case the Ginzburg-Landau parameter scales with the specie cheat coeccient as $/ (2 \ 0)^{p} - T_c$ [25]. Thus, the superconducting pyrochlores, with rather low T_c 's and moderate and (0) values appear to open up a window onto the charged critical regime.

Here we concentrate on the analysis of the magnetic penetration depth data derived from M eissner fraction m easurements [13]. These data are in excellent agreement with the SR measurements [12,13] and su ciently dense to explore the critical behavior near T_c . As required for the determination of the magnetic penetration depth from the M eissner fraction measurements the sample was ground in order to obtain small grains [13]. A sum ing spherical grains of radius R their size distribution was deduced from SEM (scanning electron microscope) photographs. The resulting particle size distribution N (R) is shown in Fig.1.

The data for the tem perature dependence of the penetration depth was deduced by K hasanov et al. [13] from the m easured M eissner fraction f (T) by using the Shoenberg form ula [27] m odi ed for the known grain size distribution [28],

where $g(R) = N(R)R^3$ is the fraction distribution.

In Fig 2 we depicted the resulting data in terms of (dln =dT) 1 vs. T. In a hom ogeneous and in nite system diverges as

where e = 1=2 for a conventionalm ean-eld superconductor, e = 1=3 when uncharged therm al uctuations dom in the [14{17}] and e = 2=3 when the charge of the pairs is relevant [19{23}]. Furtherm ore, when charged uctuations dom in the penetration depth and the correlation length are near T_c related by [19{23}]

contrary to the uncharged case, where / p^{-} . denotes the G inzburg-Landau parameter. In the plot (dln =dT) ¹ vs. T shown in Fig.2 critical behavior is then uncovered if the data collapse close to T_c on a line with slope 1=e. Interestingly enough the data points clearly to charged critical behavior (solid line with 1=e' 3=2), limited by a nite size e ect due to the nite extent of the grains and/or inhom ogeneities within the grains. Indeed, although charged criticality is attained there is no sharp transition, because = cannot grow beyond the limiting length L and with that does not diverge at T_c .

To explore the evidence for charged critical behavior and the nature of the nite size e ect further, we displayed in Fig. 3 1= $_{ab}$ and d(1= $_{ab}$)=dT vs. T. The solid line is Eq. (2) with $T_c = 6.52$ K, $_0 = 0.212$ m and e = 2=3, appropriate for charged criticality, and the dashed one its derivative. Approaching T_c of the ctitious hom ogeneous and in nite system the data reveals clearly a crossover to charged critical behavior, while the tail in 1= vs. T around T_c points to a nite size e ect, because d =dT does not diverge at T_c but exhibits at T_p ' 6.48 K an extrem um . For this reason 1= (T) possesses an in ection point at T_p and the correlation length attains the limiting length L.

In this case the penetration depth adopts the nite size scaling form [29,30]

with e' 2=3 and $(T_p) = {}_0 f_p j^e = L$. Fortsmall and L ! 1 the scaling variable tends to y ! 1 where g(y ! 1) = 1 and g(y ! + 1) = 1, while for t = 0 and $L \in 0, g(y ! 0) = g_0 j y j^{2=3} = g_0 j = t_p j^{2=3}$. In this limit we obtain

In Fig. 4 we displayed the nite size scaling function g (y) deduced from the measured data and the parameters emerging from the ts shown in Fig.3. The solid line indicates the asymptotic behavior g (y ! 0) = $g_0 y j^{2=3}$ with $g_0 = 0.92$. The upper branch corresponding to $T < T_c$ tends to g (y j! 1) = 1, while the lower one referring to $T > T_c$ approaches g (j j! 1) = 0. Consequently, the absence of a sharp transition (see Figs. 2 and 3), is fully consistent with a nite size e ect arising from a limiting length L, attributable to the nite extent of the grains and/or inhom ogeneities within the grains. To disentangle these options we invoke Eq.(5) yielding with (T_c ;L) ' 6.45 m, $_0$ 0.212 m and $g_0 = 0.92$, $L = _0$ 33. An estimate of $_0$ can be derived from the magnetic eld dependence of the maximum of the speci c heat doe cient [32]. As a remnant of the zero- eld singularity, there is for xed eld strength a peak adopting its maximum at T_p (H) which is located below T_c . T_p (H) is given by (1 T_p (H)= T_c)⁴⁼³ = aH $_0^2 = _0$, where a ' 3.12. From the speci c heat data of B nuhwiler et al. [11] we derive $_0$ 0.008 m. Accordingly, L 33 $_0$ 0.26 m. On the other hand, a glance to Fig.1 shows that the grain size distribution of the RbO s₂O $_6$ sam ple exhibits a maximum at 0.69 m and decreases steeply for sm allergrains. Hence, the sm eared transition is not attributable to the nite extent of the grains but most likely due to inhom ogeneities within the grains.

In sum mary, we have presented an extended analysis of penetration depth data for RbO s_2O_6 near T_c providing consistent evidence for charged critical behavior of the superconductor to normal state transition in type II superconductors ($_0 > 1 = 2$). The crossover upon approaching T_c is thus to the charged critical regim e, while in nearly optim ally doped cuprates it is to the critical regim e of a weakly charged super uid where the uctuations of the order parameter are essentially those of an uncharged super uid. However, there is the inhom ogeneity induced nite size e ect which renders the asymptotic critical regim e di cult to attain [31{33}. Nevertheless, our analysis of the penetration depth data of RbO s_2O_6 provides remarkable consistency for critical uctuations, consistent with the charged universality class, limited close to T_c of the criticous in nite and hom ogeneous counterpart by a nite size e ect predom inantly due to inhom ogeneities within the grains. A coordingly our analysis strongly suggests that RbO s_2O_6 is not a conventionalm ean- eld superconductor because charged critical uctuations dom inate the tem perature dependence of the penetration depth near T_c . These uctuations should also a ect the speci c heat [34] and the magnetic properties. How ever, more extended measurements near criticality are needed to uncover this behavior.
