## Role of non-magnetic disorder in a doped U (1) spin liquid

Recently we investigated a role of non-magnetic disorder on the stability of a U (1) spin liquid (U1SL) [cond-m at/0407151; Phys. Rev. B (R) accepted]. In the present paper we exam ine an e ect of the non-m agnetic disorder on a doped U 1SL. In a recent study [cond-m at/0408236] we have show n that the doped U1SL shows decon ned massive spinon excitations in the superconducting phase as a result of holon condensation. We nd that the massive spinon is trapped by the non-magnetic disorder. Owing to the localized spin the non-magnetic disorder acts as magnetic one.

It is now believed that non-magnetic disorder induces a local magnetic moment of S =  $\frac{1}{2}$  in underdoped cuprates[1, 2, 3, 4, 5]. The localized moment is expected to result in a Curie-W eiss behavior of a magnetic susceptibility [1, 3, 5] and increase antiferrom agnetic correlations [2]. Despite of these successful descriptions there exists controversy. Sachdev et al. claim ed that em ergence of the localm om ent in a non-m agnetic im purity can be understood by con nem ent of a spinon in the underdoped cuprates [4, 6]. But the previous studies [1, 3] are based on a decon nem ent phase which is described by a slave particle mean eld theory. It has been correctly pointed out that in the slave boson mean eld theories strong gauge uctuations mediating interactions between the slave particles are not appropriately treated [7, 8]. Thus it is not clear that if strong gauge uctuations are appropriately treated, the conclusions in the previous studies[1, 3] are sustained. It is necessary to treat both the gauge uctuations and non-magnetic in purities on equal footing.

Lastly Senthilet al. claim ed that instanton excitations originating from strong gauge uctuations can be suppressed by critical uctuations of massless D irac ferm ions in the large avor  $\lim it[9]$ . As a result an elective eld theory to describe a spin degree of freedom in the underdoped cuprates is obtained to be QED<sub>3</sub> in terms of massless Dirac ferm ions (spinons carrying only spin  $\frac{1}{2}$ ) interacting via non-compact U (1) gauge elds[9, 10]. The state described by this critical eld theory is usually called a U (1) spin liquid (U1SL).

Recently we examined a role of non-magnetic disorder on the stability of the UISL using a renorm alization group calculation [11]. In other words, we treated both strong gauge uctuations and non-m agnetic im purities on equal footing. In the study we found that the U1SL remains stable against weak disorder. The IR xed point of Q E D<sub>3</sub> to govern the U 1S L is stable against the presence of the weak non-m agnetic disorder and thus the U1SL is sustained. This shows that the massless Dirac spinon is not localized by the weak disorder in the U 1SL, which is in contrast with the results of the slave particle mean eld theories [1, 3].

In the present paper we investigate an e ect of the non-magnetic disorder on a hole doped U1SL.Not only

strong gauge uctuations and non-magnetic impurities but also hole doping is treated on equal footing. Recently we showed that hole doping to the U1SL can give rise to serious change in the UISL [12]. In the study we claim ed that condensation of holons (representing doped holes) results in a ferm ion (spinon) zero mode in the presence of an instanton potential. As a result instanton excitations are suppressed and thus decon nement of the spinons and holons are expected to occur. Further, in the superconducting phase resulting from holon condensation we found that the zero mode gives rise to a mass to the D irac ferm ion [12]. As a consequence the massive spinons are decon ned in the underdoped superconducting state. W e call this spin state a gapped U1SL. This decon nem ent mechanism is totally dierent from that in the undoped UISL. In the UISL critical uctuations of the D irac spinons are expected to suppress the instanton excitations and thus the massless spinons are decon ned [9, 10]. We nd that the massive spinon in the gapped U 1SL is localized in the non-m agnetic disorder in contrast with the case of the gapless U 1SL. In the criticalU 1SL the massless spinon remains delocalized even in the presence of the weak disorder [11] as discussed above. Owing to the localized spin the non-magnetic disorder acts as m agnetic one.

First we review a one dimensional hole doped M ott insulator. Reviewing this, we can understand a role of doped holes in a Mott insulator. Further, we will see that doped holes in a two dimensional doped U1SL play a similar role as the case of the one dimensional doped Mott insulator. We consider the t J Ham iltonian to describe a doped M ott insulator

In the absence of hole doping hopping of electrons denoted by the rst term is suppressed and thus the t J Ham iltonian is reduced to the Heisenberg Ham iltonian describing a quantum antiferrom agnetic spin chain. Low energy physics of the quantum spin chain can be described by a non-linear model with a Berry phase term [13]. Utilizing CP<sup>1</sup> representation, one can represent the non-linear model in terms of bosonic spinons

interacting via compact U (1) gauge elds in the presence of the Berry phase [13]. In the case of integer spin the Berry phase is ignorable. Strong quantum uctuations originating from low dimensionality lead the bosonic spinons to be massive[13]. The integer spin chain becom es disordered. The massive spinons are conned via a linearly increasing gauge potential in a distance which results from Maxwell kinetic energy of the gauge eld [14, 15]. As a consequence mesons (spinonantispinon bound states, here spin excitons) are expected to appear [14, 15]. In the case of half-odd integer spin the Berry phase plays a crucial role to cause destructive interference between quantum uctuations, thus weakening quantum uctuations. Owing to the Berry phase contribution the half-odd integer spin chain is expected to be ordered. But low dimensionality leads the system not to be ordered but to be critical[13]. As a result the spinons are massless [14, 15]. The massless spinons are expected to be decon ned [15] because critical uctuations of the spinons can weaken gauge uctuations via screening.

Now we consider hole doping to the spin chain. Then hopping of doped holes is admitted. Shankar showed that the doped holes are represented by massless D irac fermions and the fermionic holes interact with the bosonic spinons via U (1) gauge elds[16]. A low energy e ective eld theory is obtained to be[16]

Here z is a bosonic spinon (spin) and  $_{A(B)}$ , a ferm ionic holon (charge) in a sublattice A (B). The spinons and holons interact via the compact U (1) gauge eld a .g <sup>1</sup> is a sti ness parameter, m<sup>2</sup>, a mass of the spinons, and u, a strength of self-interaction [15]. A detailed derivation is given by Ref. [16]. A key question is what an e ect of the massless D irac ferm ions on spinon dynamics is. The massless D irac ferm ions are shown to kill the Berry phase e ect [17]. In order to see this we utilize a standard bosonization method [16, 17]

Here  $_{\rm A}$  and  $_{\rm B}$  are bosonic elds in each sublattice. Inserting these into the above action Eq. (2), we obtain

Shifteld to  $+ \frac{p}{2}$ , we can easily see that ing the the Berry phase term is wiped out from the action. Thus half-odd integer spin chains are not distinguishable from integer spin chains. The bosonic spinon in the doped half-odd integer spin chain is expected to be massive like that in the undoped integer spin chain. But the spinons here are not con ned in contrast with the case of integer spin chains [16, 17]. Integrating over the eld, we nd that the U (1) gauge eld becom es m assive and thus it is ignorable in the low energy lim it. As a consequence the massive spinons are decon ned. A U (1) spin liquid with m assive spinon excitations em erges in a doped antiferromagnetic spin chain. If we introduce an electrom agnetic eld A , we obtain a coupling term of i  $\frac{2}{+}$  + 0 A . Integrating over the + eld, we obtain a mass of the electrom agnetic eld. This im plies superconductivity in the doped spin chain, which is consistent with the result of Shankar [16]. In sum m ary, doped holes lead a spin degree of freedom to be a gapped U1SL and a charge degree of freedom to be superconducting. It should be noted that this result is exact in the low energy lim it [16]. As will be seen below, these roles of the doped holes in a one dim ensional M ott insulator are very sim ilar to that

Now we investigate a role of non-magnetic disorder in this massive U1SL. An impurity action is given by  $S_{im p} = d^2 x V(x) j_r \int [18]$ . Here V(x) is a random potential resulting from quenched disorder. The random potential is random only in space but static in time, i.e., V(x) = V(r). We assume that V(r) is a gaussian random potential with < V(r)V(r<sup>0</sup>) > = W(r r<sup>0</sup>) and < V(r) > = 0. Integrating over the massive U(1) gauge ekl a and using the standard replica trick to average over the gaussian random potential, we obtain an e ective action in the presence of non-magnetic disorder

in a two dimensional one.

Here ; are replica indices and the limit N ! 0 is to be taken at the end. In the above a local current interaction originating from integration over the massive gauge eld a is not explicitly taken into account because it is expected to be irrelevant (marginally) in the low energy limit. From this e ective action one can easily see a fate of the spinon. It is well known that the non-magnetic disorder results in localization of massive particles in (1 + 1)D [11, 19]. The spinon is trapped by the disorder. The non-magnetic disorder is expected to act as magnetic disorder owing to the trapped spinon.

Next we consider a two dimensional doped U1SL which is suggested to describe physics of the pseudogap phase [9, 10]. The problem of hole doping to the U1SL

is exam ined in the context of a SU (2) slave boson theory developed by Lee, W en, and cow orkers [20]. Following W en and Lee, we consider the staggered ux phase as an ansatz for the pseudogap state. In the staggered ux phase a spin degree of freedom is described by QED<sub>3</sub> in term s of the massless D irac spinons interacting via com – pact U (1) gauge elds. D oped holes are represented by holons carrying only a charge degree of freedom [21]. In the SU (2) slave boson theory the holons have two com – ponents in association with the SU (2) sym m etry [22]. A n e ective Lagrangian for the holon eld is given by a non– linear model coupled to the spinons via the com pact U (1) gauge eld [20]. The problem of hole doing to the U 1SL is investigated by an eld ective Lagrangian in the staggered ux phase [12]

is a 4 component massless D irac ferm ion with Here an isospin index = 1;2, and z, a phase eld of a holon doublet [22]. V (z) is an elective potential for easy plane an isotropy, resulting from contributions of high energy ferm ions[12, 20]. g  $^{1}$ x is a phase sti ness of the holon eld with hole concentration x, and G x, a coupling constant between spinon and holon isospins. acts on SU (2) isospin space. ein is an e ective internal gauge charge. The spinons and holons interact via not only the gauge eld a<sup>3</sup> but also their isospins. The coupling between the spinon and holon isospins is expected to result from gauge interactions mediated by the time com ponent of the SU (2) gauge elds[12]. Sim ilar consideration can be found in Ref. [20]. The kinetic energy of the gauge eld results from particle-hole excitations of high energy quasiparticles. Utilizing this e ective Lagrangian, recently we showed that antiferrom agnetism (AFM) can coexist with d wave superconductivity (dSC) [12]. The AFM results from the Dirac fermions and the dSC, holon condensation. Holon condensation is shown to result in a zero mode of a nodal ferm ion (spinon) in a single instanton potential[12]. Thus instanton excitations are suppressed. The coupling between the spinon and holon isospins is very crucial for existence of the zero mode. If the term is ignored, the ferm ion zero mode is not found [24]. Since the coupling constant G is proportional to hole concentration x, there exists no ferm ion zero mode at half lling. Suppression of instanton excitations resulting from the ferm ion zero m ode leads to decon nem ent of the spinons and holons at T = 0K in underdoped superconducting phase. Further, an instanton in the presence of the ferm ion zero m ode induces a ferm ion mass[12]. The mass results in AFM [23, 24].

Thus the AFM of the nodal fermions is expected to coexist with the dSC in the underdoped cuprates. Despite the coexistence the AFM has little e ect on the dSC [12]. A sa result a superconductor to insulator transition in the underdoped region is found to fall in the XY universality class consistent with experiments [25].

Now we derive an elective action for the massive D irac ferm ions as we do Eq. (5) in (1+1)D. Perform ing a standard duality transform ation of the non-linear model for the holon elds[12, 15], we obtain

Here " $_{(\#)}$  is a vortex eld with isospin "(#) and c" $_{(\#)}$ , its corresponding vortex gauge eld mediating interactions between the vortices. V (j "jj #j) is an e ective potential including vortex m ass and self-interactions.

 $g^{1}$  x originates from the phase stiness with the hole concentration x. m is a mass of the nodal ferm ion. Suppression of instantons originating from the ferm ion zero mode leads the U (1) gauge eld  $a^{3}$  to be non-compact. In the superconducting state the vortex elds are not condensed. As a result the vortex gauge elds remain massless. Integrating over the massless vortex gauge elds, we obtain a massive U (1) gauge eld. W e note that in one dimension integration over the

eld results in the massive gauge eld. Integrating over the massive internal gauge eld, we obtain an elective action for the massive spinons which is essentially same as Eq. (5) (in the absence of the disorder)

Here a local current interaction term  $\frac{1}{2}j$   $\frac{1}{2}j$  generated by integration over the massive gauge eld is irrelevant in the low energy limit and thus can be safely ignored. In summary, holon condensation in the doped U1SL leads a spin degree of freedom to be a gapped U1SL and a charge degree of freedom to be superconducting. This is essentially same as the one dimensional case except the fact that the spinon is a ferm ion here while it is a boson in one dimensional case.

Now we exam ine a role of the non-m agnetic in purities in the U (1) spin liquid with the massive spinons. An in purity action is given by [11]

Here V (x) is a random potential as discussed in one dimension. It does not depend on time, i.e., V (x) = V (r).

W e also assume that V (r) is a gaussian random potential with  $\langle V(r)V(r^0) \rangle = W$  (r  $r^0$ ) and  $\langle V(r) \rangle = 0.0 s$ ing the standard replica trick to average over the gaussian random potential, we obtain an elective action in the presence of the non-magnetic disorder

Here k; lare replica indices and the limit M ! 0 is to be taken at the end. This elective action is essentially same as Eq. [5] except the fact that the spinons are ferm ions here. It is well known that the massive D irac ferm ion is localized by the non-magnetic impurities in (2 + 1)D [11]. The non-magnetic impurity is expected to act as a magnetic impurity.

W e believe that the localized m agnetic m om ent is not screened by other spinons. This is because the spinons

U sing the slave-ferm ion constraint  $P_{i=1} \neq i f + f_i^y f_i = 1$ 

are m assive and thus there are no density of states at the Ferm i energy. As a result the localized m agnetic m om ent is expected to act as a free spin. We think that this is the origin to cause a Curie-W eiss behavior of a m agnetic susceptibility [1, 3, 5] and enhancem ent of antiferrom agnetic correlations [2]. But we adm it that our conclusion is based on T = 0 K calculation. It is not clear whether our results hold at  $T \in 0$  K. This is because an instanton e ect is not clearly understood at nite tem perature. The role of non-m agnetic disorder in a doped U 1SL at nite tem perature is left for future study.

Hole doping to a M ott insulator leads a critical spin liquid to a gapped spin liquid in both one and two dimensions. We examined the role of non-magnetic im purities in the gapped spin liquid. We showed that the massive spinon is localized in the non-magnetic disorder. The localized magnetic moment in the non-magnetic disorder is expected to explain the Curie-W eiss behavior of a magnetic susceptibility [1, 3, 5].

But in the two dimensional doped M ott insulator we used a slave-boson representation. In this case a spin degree of freedom is represented by a ferm ionic spinon and a charge degree of freedom, a bosonic holon.
- [22] In the SU (2) slave boson theory a local SU (2) sym metry originates from the sym metry of a spin " spinon and a spin # anti-spinon at half lling[20]. As a result of the SU (2) sym metry many U (1) ground states such as a staggered ux phase, d wave pairing state, and rotated states between the two are exactly degenerate at half lling[20]. In underdoped region the U (1) ground states are expected to rem ain nearly degenerate. Thism otivates W en and Lee to extend the SU (2) sym metry at half lling away from half lling[20]. In the SU (2) slave boson theory uctuations between the nearly degenerate U (1) states can be easily taken into account via introduction of the holon doublets[20].
