Tunneling and rattling in clathrate crystal

We present tunneling and rattling motions of an o -center guest atom in cage referring to a clathrate crystal La₃Pd₂₀Ge₆. The elastic constant C₄₄ of La₃Pd₂₀Ge₆ shows a Debye-type dispersion around 20 K obeying a relaxation time = $_0 \exp(E = k_B T)$ with an attempt time $_0 = 2.0 \ 10^{-12}$ sec and an activation energy $E = 197 \ K$. At low temperatures below 3 K down to 20 m K, the C₄₄ shows a softening of C₄₄ = C⁰₄₄ (T T⁰_C) = (T) with T⁰_C = 337.970 m K and = 338.044 m K. These facts are attributed to two di erent types of the o -center motions with $_5$ symmetry in 4a-site cage of La₃Pd₂₀Ge₆, a therm ally activated rattling motion over the potential hill and a tunneling motion through the potential hill at low temperatures.

I. IN TRODUCTION

It has recently been found that led skutterudites RM₄Sb₁₂ (R:LaorCe, M:FeorCo) [1], clathrate sem iconductor com pounds $Sr_8Ga_{16}Ge_{30}$ [2] and $Eu_8Ga_{16}Ge_{30}$ [3] show considerable reduction of the therm al conductivity. The rattling motion of an o -center guest atom over a potential hill in oversized cage in these clathrate com pounds brings about reduction in therm al phonon transport by a resonant phonon scattering, which is favorable for them oelectric devices with pro table qure ofmerit [4]. Furthermore, the low-tem perature behavior T² and ultrasonic atof therm al conductivity (T) T^{3} in Sr₈Ga₁₆Ge₃₀ [2] rem inds us of tenuation (T) the two-level system due to tunneling motions in glasses with structural disorder [5-8]. It should be noted that the o -center guest atom s of clathrate com pounds is located in cages forming an ideal periodic lattice. The ocenter tunneling in clathrate crystals, therefore, m ay be regarded as a new quantum degrees of freedom associated with a localE instein phonon with a large density of state.

Quite recently, our group has found the frequency dependence in the elastic constant C_{44} of $Ce_3Pd_{20}Ge_6$ showing a ferroquadrupole ordering [9,10] and in (C₁₁ C₁₂)=2 of a lled skutterudite PrOs₄Sb₁₂ showing a heavy ferm ion superconductivity [11]. The ultrasonic dispersion in these compounds shows the fact that a relaxation time for the rattling motion obeys therm al activation-type tem perature dependence. W e have successfully projected out the o -centerm ode in cage, which couples to appropriate ultrasonic mode. The phenom ena associated with the tunneling motion are expected at low tem peratures, where the therm ally activated rattling m otion dies out com pletely. How ever, the ferroquadrupole ordering at $T_0 = 1.25$ K in $Ce_3Pd_{20}Ge_6$ and the superconductivity at $T_C = 1.85 \text{ K}$ in PrO $s_4 \text{Sb}_{12}$ sm ear out the characteristic low -tem perature properties due to tunneling motions. In the present paper, we have made

ultrasonic measurements on $La_3Pd_{20}Ge_6$ with a cubic $Cr_{23}C_6$ -type structure in order to exam ine the tunneling and rattling motions in the system being absent of the 4f-electron.

II. EXPERIMENT

An image furnace equipped with two ellipsoidalm irrorswasem ployed to grow a single crystalofLa3Pd20Ge6 with residual resistivity $_0 = 2.7$ cm. The plane parallel surfaces with (100) or (110) orientation were determ ined by x-ray photograph. The sound waves were generated and detected by the piezoelectric LiNbO3 transducers bonded on the surfaces of specimen. The change of sound velocity v was detected by a phase com parator based on m ixer technology. The elastic constant $C = v^2$ was estimated by the mass density = $10:179 \text{ g/cm}^3 \text{ of}$ $La_3Pd_{20}Ge_6$ with lattice parameter a = 12:482 A [11]. A 3 He-evaporation refrigerator down to 450 mK and a 3 He-⁴He dilution refrigerator down to 20 mK were em ployed for low -tem perature ultrasonic m easurem ents. O bærvation of the de Haas oscillation in elastic constants [12] ensures good quality of the present single crystal.

III. RESULTS AND DISCUSSIONS




FIG.1: Temperature dependence of elastic constants C_{11} , $(C_{11} C_{12})=2$ and C_{44} of $La_3 P d_{20} G e_6$. A step-like anomaly in C_{44} around 20 K indicates the ultrasonic dispersion.

We show tem perature dependence of elastic constants C_{11} , $(C_{11} C_{12})=2$ and C_{44} of $La_3Pd_{20}Ge_6$ in Fig. 1. Here the longitudinal sound wave with frequencies of 70 MHz was employed for measurements of C_{11} and transverse one with 40 MHz for $(C_{11} C_{12})=2$ and C_{44} . W ith lowering temperature we have found a step-like increase around 20 K in C_{44} , while otherm odes of C_{11} and $(C_{11} C_{12})=2$ exhibit monotonous increase only.




FIG.2: (a) Frequency dependence of the elastic constant C₄₄ m easured by the transverse ultrasonic waves with frequencies of 9 M Hz, 40 M Hz and 150 M Hz. A rrows in (a) indicate the tem peratures satisfying with the resonance condition of ! = 1. Inset in (a) represents a t by the D ebye-type dispersion of Eq. (1) for frequencies of 9 M Hz, 40 M Hz, and 150 M Hz. (b) shows the A mhenius plot of relaxation time = $_0 \exp(\text{E} = k_B T)$ in La₃P d₂₀G e₆ together with the results of C e₃P d₂₀G e₆ and P rO s₄Sb₁₂ [9,11].

The elastic constant C $_{44}$ of transverse acoustic m ode in La₃P d₂₀G e₆ in Fig. 2 (a) exhibits a marked dependence in frequencies for 9 M Hz, 40 M Hz and 150 M Hz. This

result indicates the ultrasonic dispersion in the C₄₄ m ode as similar as that in isom orphous compound $C e_3 P d_{20} G e_6$ [9]. These results show the fact that $R_3Pd_{20}Ge_6$ (R = La, Ce) exhibit com m only a therm ally activated rattling motion of the o -center rare-earth ion. As was noted in Fig. 1, the ultrasonic dispersion has been found only in C_{44} , but no sign of dispersion in (C_{11} C_{12})=2 and C_{11} . This result in mediately means that the o -centermotion has the 5 symmetry. Consequently, the charge uctuation due to the o -center motion couples to the acoustic transverse C₄₄ m ode. On the other hand, a lled skutterudite PrOs₄Sb₁₂ of heavy ferm ion superconductor exhibits ultrasonic dispersion in $(C_{11} \quad C_{12})=2$ indicating the 23 symmetry of the o -center mode in cage [11]. It is worthwhile to emphasize that the symmetry transverse ultrasonic mode is a useful probe to determ ine the symmetry of the o -center motion in cage.

The frequency dependence of the elastic constant in Fig. 2(a) is described by the D ebye-type dispersion as

The calculation of inset of Fig. 2(a) reproduces well the experim ental results in Fig. 2(a). Here ! is the angular frequency of the sound wave. The relaxation time of the rattling motion in Fig. 2(b) revealed the thermally activated-type temperature dependence. C_{44} (0) and C_{44} (1) are low – and high-frequency limits, respectively. A rrows in Fig. 2(a) indicate the temperatures being satis ed with the resonant condition, where the relaxation time coincides with the sound frequency ! as ! = 1. The ultrasonic attenuation of the transverse

 C_{44} m ode, that is not presented here, show s a peak at the tem peratures satis ed with ! = 1. This resonance scattering of the ultrasonic C_{44} wave by the rattling m otion in cage m ay bring about a reduction of therm al conductivity by the phonon transport.

It should be noted that the specied 5 symmetry of the transverse C₄₄ wave may give rise to an isotropic phonon transport depending on the crystallographic orientation. The longitudinal C_{11} mode as well as the transverse C₄₄ m ode participates in the therm alphonon transport along the [100] direction. The later C₄₄ mode is scattered by the rattling motin, while the former C₁₁ mode propagate transparently without any scattering by the rattling. In the case of thermal phonon transport along the [111] direction, the longitudinal (C_{11} + $2C_{12}$ + $4C_{44}$)=3 as well as the transverse $(C_{11} \quad 2C_{12} + C_{44})=3$ are scattered by the rattling, because both modes contain the pure C_{44} mode in part [13]. These anisotropic properties of acoustic phonon m ay bring about the anisotropy of the therm al conductivity by phonons. The investigation of the ratting by ultrasonic measurements would be protable way to develop the therm celectric device with high qure of merit.

As one can see in an Amhenius plot of Fig. 2(b), the relaxation time of $La_3Pd_{20}Ge_6$ obeys the thermal activation-type temperature depen-= $_0 \exp(E = k_B T)$ with an attempt time dence $_0 = 2.0$ 10 12 sec and an activation energy E = 197 K. The relaxation times in CepPd₂₀Ge₆ with $_{0} = 3:1$ 10 ¹¹ sec, E = 70 K [9] and in PrO s₄Sb₁₂ with $_0 = 8.8 \quad 10^{-11} \text{ sec}$, E = 168 K [11] are also presented in Fig. 2(b) for comparison. These relaxations originate from the thermally assisted rattling motion of the o -center rare-earth ion over a potential hill with height E = 70200 K. It is of importance to contrast with the charge uctuation time of 4f electron in inhomogeneous mixed valence compound Sm₃Te₄ showing the activation-type temperature dependence with $_0 = 2:5$ 10 ¹³ sec and E = 1600 K [14]. The 10 11 relatively slow relaxation time $_0 = 0.2$ 8:8 sec as well as relatively small activation energy E = 70 200 K in $La_3Pd_{20}Ge_6$, $Ce_3Pd_{20}Ge_6$ and PrOs₄Sb₁₂ indicate the rattling motions of the o -center rare-earth ions with heavy masses. The motion of rare-earth atom described by a harm onic oscillation of $(z) = (1 = z_0)^{1=2} \exp(z^2 = 2z_0^2)$ in cage spreads in space with a mean square displacement $z_0 = (1=2)$ (h $_0=M$)¹⁼² [15]. The attempt time $_0 = 2.0 \quad 10^{-12}$ sec and the mass M = $139m_p$ of La atom in La₃Pd₂₀Ge₆, where m $_{\rm p}$ is proton m ass, lead to a m ean square displacem ent $z_0 = 0.12$ A being comparable to $z_0 = 0.48$ A of $Ce_3Pd_{20}Ge_6$, $z_0 = 0.79 A of PrOs_4Sb_{12}$ [9,11]. Furtherm ore neutron scattering on $Eu_8Ga_{16}Ge_{30}$ show $sz_0 = 0.8$ A [16].




FIG.3: The low-temperature softening in elastic constant C_{44} of $La_3Pd_{20}Ge_6$ below 3 K down to 20 mK. Solid line is a tby $C_{44} = C_{44}^0$ (T T_c^0)=(T) with the parameters in the text. Inset presents low-temperature behavior of C_{44} and $(C_{11} C_{12})=2$.

In order to exam ine low tem perature properties due to tunneling motions of $La_3Pd_{20}Ge_6$, we have made ultrasonic measurements down to 20 mK.As shown in Fig. 3, we have observed a remarkable softening of C_{44} with relative change 200 ppm below 3 K down to 20 m K by use of the dilution refrigerator. The $(C_{11} \quad C_{12})=2 \text{ m ode}$ in inset of Fig. 3 shows a softening of 20 ppm, which is much smaller than the 200 ppm softening of C_{44} . The characteristic softening in C₄₄ of Fig. 3 in particular promises the 5 symmetry of the o-center tunneling motion in cage. The tunneling frequency is estimated about 60 GHz corresponding to the onset temperature 3 K in the elastic softening of Fig. 3. The present ultrasonic m easurem ents with frequencies 10 200 M H z are able to observe the static strain susceptibility for the o -center tunneling mode. Magnetic elds up to 8 T do not make any appreciable change in the low-tem perature softening of C₄₄. This result, which is not presented here, ensures that the softening of C_{44} is intrinsic e ect being independent of magnetic impurity e ects.

In the present clathrate compound ${\rm La_3P\,d_{20}G\,e_6}$ with space group symmetry Fm 3m, there are two dierent types of cages containing La ion. The unit cell of ${\rm La_3P\,d_{20}G\,e_6}$ with a lattice parameter a = 12:482 A consists of four molecular units with 116 atoms. The 4a-site cage with La1 atom consisting of twelve Pd-atoms with distances $d_{\rm La1\ Pd2}$ = 3:084 A and six Ge-atoms

with d_{La1} Ge = 3:350 A form sa face center cubic lattice. The 8c-site cage with La2 atom consisting sixteen Pd atom s with $d_{La2 Pd1} = 2.884$ A and $d_{La2 Pd2} = 3.392$ A forms a simple cubic lattice [10]. The trivalent La ion with radii 1.88 A in former oversized 4a-site cage may favor the rattling motion over o -center positions. Actually neutron scatterings on $R_3Pd_{20}Ge_6$ ($R = Ce_7$) Pr, Nd) observed well-de ned crystalline electric eld excitations of 8c site, while they detected obscure peak only for 4a site [17]. These facts are consistent with the o -center motion of the rare-earth ion in the 4a site cage of $R_3Pd_{20}Ge_6$. Because the absence of Pd- or Geatom on the three-fold [111] axis in the 4a-site cage, the potential for La1 ion may possess o -center minima at $r_1 = (a;a;a), r_2 = (a; a;a), r_3 = (a;a; a),$ $r_4 = (a; a; a), r_5 = (a;a; a), r_6 = (a; a; a),$ $r_7 = (a; a;a), r_8 = (a;a;a)$ with $a z_0 = 2 = 0.06$ A. Here $r_i (i = 1;2;:::;8)$ denotes distance from the center of the 4a-site cage.




FIG. 4: Schematic view of the 5 o -center mode $_{5;xy} = 1 + 2$ 3 4 + 5 + 6 7 8 possessing fractional states of Lal-ion over eight o -center potential minima along three fold [111] axis in 4a-site cage of La₃P d₂₀G e₆.

It is useful to project out the irreducible representation for the o -centerm odes consisting of the atom ic densities (r_i) at the o-center positions r_i in 4a-site cage i = with the site symmetry O_h [9, 18, 19]. The o-center motion over the eight o -center positions is reduced into direct sum 1 2 4 $_5$. Because the C $_{44}$ m ode with 5 sym m etry in La₃P d₂₀G e₆ shows the ultrasonic dispersion around 20 K in Fig. 2 (a) and the appreciable low-tem perature softening below 3 K in Fig. 3, the $_5$ o -centerm ode $_{5,yz} = 1 _{2} _{3} + 4 _{5} + 6$ 7**+** 8, 5;zx = 1 2 + 3 4 5 + 6 + 7 8**,** 5;xy = 1 + 2 3 4 + 5 + 6 7 ₈ is relevant for the ground state in the present system . The 5 m ode consists of an isotropic fractional atom ic state over eight o -center positions r_i (i = 1;2; ...;8). The _{5;xy} mode of Fig. 4, for instance, has fraction 1/4 at r_1 ; r_2 ; r_5 ; r_6 positions and nullat r_3 ; r_4 ; r_7 ; r_8 . O therm odes with 1; 2 or 4 sym metry probably correspond to exited states and hence they are disregarded here. The Schrodinger equation for the o -center atom in multipotential wells is a faithful way to analyze the o -center tunneling state [20,21]. The present group theoretical analysis is a proper way instead of rigorous treatment.

Because the La ion is trivalent, the charge density associated with the $_5$ o -center mode in the 4a-site cage is described as = Q_{yz} $_{5;yz} + Q_{zx}$ $_{5;zx} + Q_{xy}$ $_{5;xy}$ [18,19]. Here Q_{yz} ; Q_{zx} and Q_{xy} denote the norm alcoordinate describing the $_5$ o -center mode in Fig. 4. It is notable that the hexadecapole as well as quadrupole are relevant for the charge distribution of the 5 o -center mode. As the tem perature is low ered, the phase transi- Θ 0 due to the condensation of the symmetry tion breaking 5 mode would be expected in principle. We refer Y b₄A s₃ to the phase transition due to charge ordering [18]. The present system , how ever, no phase transition has been observed down to 20 mK. Consequently, the tunneling motion of the o -center La-ion through the potential hill in keeping the O_h site sym m etry is relevant even at low tem peratures.

The interaction of the $_5$ o -center tunneling mode in cage to the elastic strain " $_{yz}$;" $_{xx}$;" $_{xy}$ of the C₄₄ mode is described as [22-24]

Here g $_5$ is a coupling constant and $_i$ m eans sum m ation over cages at site i. The inter-cage coupling of the $_5$ o -center tunneling m ode accompanying the charge uctuation is introduced as

Here g_{5}^{0} is a coupling constant and hQ_{ij}i(i; j = x; y; z) denotes a mean eld. The low-temperature elastic softening in C₄₄ below 3 K in Fig. 3 is described by

Here N is the number of cages in unit volume. The strain susceptibility for the $_5$ o -center mode in cage is written as $g_{5}^2 = (T) = C_Q = T = 2 = T$. Here is $= (C_Q)^{1=2}$ is a deformation coupling energy for the $_5$ ground state. Consequently, one obtains $C_{44} = C_{44}^0 (T - T_C^0) = (T -)$ with $= (g_{5}^0 = g_{5}^2)C_Q$ and $T_C^0 = N C_Q = C_{44}^0 + .$ The solid line in Fig. 3 is a t by the characteristic temperatures = 338.044 mK, $T_C^0 = 222027$ mV and $L_Q^0 = C_{44}^0 + C_{$

337:970 mK and a back ground $C_{44}^{0} = 3:33085 \quad 10^{10}$ J/m³. The low-temperature softening of C_{44} proportional to reciprocal temperature in La₃Pd₂₀Ge₆ is attributed to the ₅ tunneling mode with the symmetry

breaking character in the present system. This is strikingly di erent from m inim a in elastic constants of NaCl, which has an o-center tunneling motion with $_1$ singlet ground state of in purity OH ion [25,26].

= 0:074 m K corre-The value of N C_Q = $C_{44}^{0} = T_{C}^{0}$ sponds to the energy gain due to the coupling of the 5 o -center mode to the elastic strain as similar as the Jahn-Teller energy in d- or f-electron system [22-24]. Employing the number of the 4a site in unit volume, N = $2.057 \quad 10^{21}$ cm³, one obtains the deformation coupling energy = 9:3 K corresponding to the energy shift for the 5 m ode by unit external strain. It is rem arkable that the deform ation coupling of about 10 K for the present tunneling mode is order of magnitude smaller than that of 100 K in 4f-electron system of rareearth compounds and of 1000 K in 3d-electron system of transition m etal com pounds. This m eans that the charge uctuation due to the tunneling motion is well screened by the cage. The negative value of = 338.044 mKindicates the antiferro-type inter-cage interaction of the 5 m ode am ong the 4a-site cages with nearest neighbor distance 8.8 A.

The tunneling motion in the two-level system of many structural glasses [5,27] provides the principal concept to elucidate the o -center tunneling motion of the clathrate crystals. The two-level system in ram dom potential of structural glasses losses its symmetry property. This is strikingly dierent from the specic 5 symmetry of the o -center tunneling motion in periodically arrayed cages of the clathrate crystal $La_3Pd_{20}Ge_6$. As was already shown, the o -center tunneling in the present La3Pd20Ge6 has sm all antiferro-type inter-cage interaction = 338:044 m K. Therefore, the collective motion of the o -center tunneling in periodically arrayed cages is expected to show a at dispersion being mostly independent of the wave vector. The triply degenerate 5 tunneling state m ay be regarded as a local E instein phonon with large density of state.

It is expected that the o -center tunneling motion in cage of $La_3Pd_{20}Ge_6$ interacts to the conduction electron consisting of the 4d orbit of Pd and 4p orbit of Ge of cage. This interaction of the local Einstein phonon to

the electrons may play a crucial role to bring about the sm all activation energy E = 197 K and the appreciable mean square displacement $z_0 = 0.12$ A. We noted many theoretical investigations showing that in a strong electron-phonon coupling regime, the renormalized potential for a guest atom may favor o -center positions and reduction of the excitation energy [15, 28-29]. The screening of the o -center tunneling mode, namely local E instein phonon is mapped to the multi-channel K ondo m odel of the non-K ramers doublet in f-electron systems [29].

In the case of the heavy Fermion superconductor $PrOs_4Sb_{12}$, the ultrasonic dispersion has been found in the (C₁₁ C₁₂)=2 mode [11]. The doubly degenerate ₂₃ tunneling state accompanying the charge uctuation may couple with the quadrupole uctuation of the 1-

 $_{4}^{(2)}$ pseudo quartet CEF state as well as the conduction band [31]. This interaction of the local phonon to the electrons is of crucial importance for the form ation of the heavy Ferm ion state and its Cooper pair of the superconductivity. The tunneling state with doubly or triply degeneracy in cage of clathrate compounds may regarded as a new quantum degrees of freedom leading to exotic low temperature properties concerning the sym – m etry breaking phase transition, superconductivity, and the multi-channel K ondo e ect. IV. CONCLUSION

In conclusion, the present ultrasonic m easurem ents on the clathrate compound $La_3Pd_{20}Ge_6$ revealed the dispersion in the transverse C_{44} mode around 20 K due to the therm ally assisted rattling motion over the potential hill. We have also found the appreciable elastic softening of C_{44} below 3 K down to 20 m K attributed to the o-center tunneling motion through the potential hill. The o-center motion in the present clathrate crystal $La_3Pd_{20}Ge_6$ is an ideal local E instein oscillator with triple degeneracy in periodically arrayed cages. The clari cation of the exotic properties of the local E instein phonon being strongly coupled to electrons in metallic clathrate com pounds is an interesting issue of strongly correlated physics in future.
