Solitary waveson nite-size antiferrom agnetic quantum Heisenberg spin rings

A bstract

M otivated by the successful synthesis of several m olecular quantum spin rings we are investigating whether such system s can host m agnetic solitary waves. The sm all size of these spin system s forbids the application of a classical or continuum limit. We therefore investigate whether the time-dependent Schrodinger equation itself perm its solitary waves. E xam ple solutions are obtained via com plete diagonalization of the underlying H eisenberg H am iltonian. c 2024 E lsevier B *N* . All rights reserved.

1. Introduction

M agnetic solitons are detected in m any m agnetic system s due to their special in uence on m agnetic observables [1{5]. From a theoretical point of view m agnetic solitons are solutions of non-linear di erential equations, e.g. of the cubic Schrodinger equation [6{8], which result from classical approximations of the respective quantum spin problem. The cubic Schrodinger equation for instance is obtained if the spins are replaced by a classical spin density [6].

D ue to the success of coordination chem istry one can now adays realize nite size quantum spin rings in the form of magnetic ring molecules. Such wheels { Fe_6 , Fe_{10} , and Cr_8 rings as the most prom inent exam – ples { are almost perfect H eisenberg spin rings with a single isotropic antiferrom agnetic exchange parameter and weak uniaxial anisotropy [9{12].

The aim of the present article is to discuss whether solitary waves can exist on such spin rings and if they do, how they look like. The nite size and the resulting discreteness of the energy spectrum forbid any classical or continuum limit. We therefore investigate, whether the ordinary linear time-dependent Schrodinger equation allows for solitary waves. Solitary excitations in quantum spin chains of Ising or sine-G ordon type have already been discussed [7]. Nevertheless, such soliton solutions are approximate in the sense that a kind of Holstein-Primakov series expansion is applied, and the results are accurate only for an isotropies large com – pared to the spin-spin coupling [7]. This article deals with antiferrom agnetic Heisenberg chains without an isotropy, where such derivations cannot be applied. Starting from the time-dependent Schrodinger equation therefore automatically addresses the questions how soliton solutions might be approached starting from a full quantum treatment { a question that to the best of our know ledge is not yet answered [13].

In order to apply the concept of solitons or solitary waves to the linear Schrödinger equation some redefinitions are necessary. The strede nition concerns the term soliton itself. It is mostly used for domain-wall like solitons which are of topological character. It is also applied to localized deviations of the magnetization or energy distribution (envelope solitons), here one distinguishes between bright and dark solitons.W e will generalize this class of objects and speak only of solitary waves in the following.W e call a state j slitary wave if there exists a time for which the time evolution equals (up to a global phase) the shift by one site on the spin ring. This means that solitary waves

travel with perm anent shape. The property that two solitons scatter into soliton states cannot be used as a de nition in the context of the Schrodinger equation since it is trivially ful lled for a linear di erential equation.

A nontrivial question concerns useful observables in order to visualize solitary waves j si. The expectation value of the local operator s_z (i), which rejects a local magnetization is used classically and meaningful also as a quantum mechanical expectation value. Then nontrivial, i.e. non-constant magnetization distributions h $_{\rm s}$ js_z (i) j $_{\rm s}$ i arise only for those solitary waves which possess components with a common total magnetic quantum number M, because matrix elements of s_z (i) between states of dierent total m agnetic quantum num ber van ish. The energy density which in classical calculations is also used to picture solitons, could quantum mechanically be de ned as s (i) s(i+ 1) starting from a Heisenberg Ham iltonian, com pare Eq. (1). It turns out that this observable is not so useful since it is featureless in most cases because the o -diagonal elements for energy eigenstates belonging to di erent total spin S are zero.

The article is organized as follows. In Sec. 2 we shortly introduce the H eisenberg m odel and the used notation, while in Sec. 3 solitary waves are de ned. W e will then discuss the construction and stability of (approximate) solitary waves in Sec. 4. A number of example spin systems will be investigated in Sec. 5. The article closes with conclusions in Sec. 6.

2. H eisenberg m odel

TheH am ilton operator of theH eisenberg m odelw ith antiferrom agnetic, isotropic nearest neighbor interaction between spins of equal spin quantum numbers is given by

H is invariant under cyclic shifts generated by the shift operator T . T is de ned by its action on the product basis im i

where the product basis is constructed from single-particle eigenstates of all ${\rm s}_{\rm z}$ (i)

The shift quantum number k = 0; :::; N 1 m odub N labels the eigenvalues of T which are the N -th roots of unity

k is related to the \crystalm om entum "via p = 2 k=N .

A ltogether H , T , the square S^2 , and the z-component S_z of the total spin are four commuting operators.

3. Solitary waves

We call a state j_s i solitary wave if there exists a time for which the time evolution equals (up to a global phase) the shift by one site on the spin ring either to the left or to the right, i.e.

Decomposing j $_{\rm s}{\rm i}$ into simultaneous eigenstates j iofH and T,

The set $I_{\rm s}$ contains the indices of those eigenstates which contribute to the solitary wave. Therefore,

Equation (8) means nothing else than that solitary waves are form ed from such simultaneous eigenstates j i of H and T which full a (generalized) linear dispersion relation.

Since our de nition (8) is rather general it com prises several solutions. Som e of them are rather trivial waves whereas others indeed do possess soliton character:

- { Single eigenstates j i of the H am iltonian ful llthe de nition, but they are of course stationary and they possess a constant m agnetization distribution. O ne would not call these states solitary waves or solitons.
- { Superpositions of two eigenstates j i and j i with di erent shift quantum numbers k and k are also solutions of de nition (8) since two points are always on a line in the E-k-plane. It is clear that such a state cannot be well localized because of the very limited number of m om entum components. N evertheless, these states m ove around the spin ring with perm anent shape.

An example of such solitary waves are superpositions consisting of ground state and rst excited state which have already been investigated under a di erent focus [14]. The characteristic time tom ove by one site is related to the frequency of the coherent spin quantum dynam ics discussed for these special superpositions [14,15].

- { The existence of m one than two eigenstates with linear dispersion relation cannot be proven for H eisenberg m odels in contrast to the Ising m odel [7]. In fact it is very likely that such a combination does not exist at all for a sm all system . Therefore, superpositions of three or m ore eigenstates will { hopefully only slightly { deviate from the linear dispersion relation and therefore describe (slow ly) decaying solitary waves. This will be explained in detail below .
- { The character of the solitary waves assembled according to de nition (8) can be di erent. A section 5 will show some of them are localized m agnetization distributions (envelope solitons) which could be denoted as bright or dark solitary waves others are of topological nature as for example in the case of superpositions of the ground state and the rst excited state on an odd membered spin ring. Nevertheless, the distinction is not sharp. A s shown in R ef. [16] envelope solitons can be of topological nature when looked at from a di erent perspective.

4. C onstruction and stability of solitary waves

W hen constructing solitary waves we focus on two principles:

- { Energetically low -lying solitons can be form ed by superim posing the ground state with low -lying excited states. For this purpose it is advantageous that for antiferrom agnetic rings the low est energy eigenvalues depend on m om entum approxim ately via a sine function. Therefore, for large system s, where the sine function can be approxim ated by its argum ent, an alm ost linear dependence between k and E is expected.
- { General solitons can be formed by superimposing states with arbitrary pairs (k; E) as long as they full (8). For this purpose two states are selected which de ne a straight line in E k{space. Then a search algorithm is used to nd other states whose energy and momentum quantum numbers constitute a point on (or in close vicinity) of the line. The search extends not only to the rst B rilluoin zone, but also to higher zones.

It is clear that in a nite system the linear dispersion relation (8) m ight only be fulled approximately which leads to decaying solitary waves. That the time evolution must be recurrent in a Hilbert space of nite dimension is only of principle interest since the recurrence time would be very long.

A good m easure of the stability of a solitary wave is the overlap of the tim e-evolved state and the shifted one. For perfect stability these two states coincide. Let's assume that the wave travels in the same direction as the shift operator acts, then we de ne the stability measure as

() is a complex number, and for dispersionless movement it's absolute value equals one. Decomposing the approximate solitary wave j $_{\rm s}$ i into simultaneous eigenstates j i of H and T yields

where is the energy m ism atch of energy level . In order to consider a m otion across n sites the exponent has to be multiplied by n.

As a simple example we want to consider an approxim ate solitary wave which consists of three eigenstates as for instance in the example of Fig. 4. The rst two levels de ne the linear dependence, and the third level deviates by $_3$ from that dependence. Then, taking the norm alization condition into account, the overlap turns out to be

Thus we face a decaying overlap which later oscillates back to one. For the speci c exam ple of F ig. 4 we can estimate how much time this will take. The characteristic time is given by




Fig. 1. Energy spectrum of a antiferrom agnetic spin ring with N = 12 and s = 1=2: The solid as well as the dashed line connect states which are superim posed to form a solitary wave. The num bers label these states.

which is approximately 3 in the given units, compare Fig. 1. The energy m ismatch is of the order of 10^{2}. In order to have a deviation of the exponential in (11) of 1% from unity the argument has to grow up to 0.1, which means that the solitary wave has to move across about 30 sites. Or in other words, the approximate three state solitary wave of Fig. 4 has to circum vent the spin ring three times in order to produce a deviation of the overlap with the original state of about one percent. Thism eans that such approximate solitary waves are rather stable. Nevertheless, with increasing energy mismatch the situation will be worse.

5. Special solutions for spin rings

In this section we discuss some typical examples for magnetic solitary waves on nite spin rings. We have chosen exam ples which are as large as num erically possible, i.e. N = 11;12;14 and s = 1=2, because a too sm all size yields only a very limited number of eigenstates with di erent shift (i.e. momentum) quantum numbers that can be superim posed to form the solitary wave. Then, the solitary waves obviously cannot be of such perfect shape and localization as known from continuousm odels. Nevertheless, our general ideas are applicable as well to system sw ith spin quantum numbers s > 1=2, which in future investigations m ight be accessible by means of D ensity M atrix R enorm alization G roup (DMRG) techniques [17].

Figure 1 shows a typical spectrum for an antiferrom agnetically coupled H eisenberg ring. The ground state of such a ring is a singlet with k = 0 for the special case of N = 12. The rst excited state is a triplet with k = 6, com pare the theorem sofLieb, Schultz, and M attis [18{20] for quantum numbers of ring systems with an even number of sites and R ef. [21] for quantum numbers of ring system s with an odd number of sites.




Fig. 2. Solitary wave for N = 12 and s = 1=2 consisting of ground state and rst excited state with M = 0 (crosses). The curve is drawn as a guide for the eye. In the course of time such a wave moves around the spin ring without dispersion. The local magnetization distribution is the quantum expression of the classical N eel state.

Two basic types of low-energy solitary waves can be form ed. The rst one is a superposition of the ground state and the triplet state with M = 0 (dashed line in Fig. 1). If added up the result is a sinusoidal magnetization function { sometimes also called spin-density wave { which is depicted in Fig. 2. A subtraction leads to an inverted local magnetization. In the course of time these distributions just move along the spin ring without dispersion. This dynam ics is equivalent to an oscillation of the local magnetization, which was intensely discussed under the aspect of tunneling of the N eel vector [14,22,15].




Fig. 3. Solitary wave for N = 11 and s = 1 consisting of ground state (k = 0) and rst excited state (k = 5) with M = 0 (crosses). The curve is drawn as a guide for the eye. The local magnetization distribution is the quantum expression of a topological solitary wave, where the N eel up-down sequence is broken and continued with a displacement of one site. This state propagates without dispersion.

A lthough these states look rather unspectacular the sam e procedure applied to rings of an odd num ber of spins leads to topological solitary waves. The reason is that due the periodic boundary condition the antiferrom agnetic order is frustrated in such cases. Figure 3 shows the case of eleven spins with s = 1. Here the ground state has S = 0 and k = 0 and the rst excited one, which is sixfold degenerate, has S = 1 and k = 5as well as k = 6. The superposition which is depicted in Fig. 3 consists of the non-degenerate ground state and the (M = 0; k = 5)-component of the rst excited state. One realizes that this state describes a displacem ent of the classical N eelorder by one site. A s sketched by the arrows the Neel order starts at the lh.s. as a sequence where up spins are located at even sites and down spins at odd sites. This sequence is separated by a \dom ain wall region " from the sequence at the r.h.s. where up spins are located at odd sites and down spins at even sites. Such a behavior of the local magnetization can equally well be pictured as a M obius strip, compare Ref. [23], although the system discussed in that reference does not possess translational sym m etry.




Fig. 4. Several solitary waves depending on contributing eigenstates of H and T with $M = 0.A \, \text{ll}$ states contribute with the same weight in this presentation. A ll states with m ore than two components disperse slow ly according to (12). We estimate that the overlap with the initial state decreases by about 1 % after two cycles around the ring.

The second basic type of low-energy solitary waves is built of states along the solid line in F ig. 1. A dding up two to ve components with the same am plitude yields the magnetization distributions shown in F ig. 4. These solitary waves are sim ilar to two dom ain walls on a larger ring system which separate a spin-up region from a spin-down region (T wo dom ain walls are needed because the ring has an even number of sites.). For a small system such as the investigated one the size of the two dom ain walls is sim ilar to the size of the whole system. The solitary waves in F ig. 4 with m ore than two components are not stable because they ful 11 the linear dispersion relation (8) only approximately, com pare Sec. 4.




Fig. 5. Solitary wave built of six components for N = 14, s = 1=2, and M = 2 [24]. The deviation of the energy levels from a strict linear behavior is less than 10⁻⁴, which m eans that this state disperses very slow ly, i.e., it can perform m any cycles around the ring without noticable deviation from the initial shape.

The above discussed low -energy solitary waves have a magnetic quantum number M = 0 and are accessible in low -tem perature experiments. Of course, solitary waves can be constructed also for larger magnetic quantum numbers M although it might not be easy to excite or detect them .F igure 5 presents an example of a rather well localized solitary wave in a subspace with non-zero magnetic quantum number [24].

6. Conclusions

Sum m arizing, we have presented a fram ework to discuss solutions of the tim e-dependent Schrodinger equation which are of perm anent shape, i.e. travel without dispersion. Besides solutions which have a close a nity to solitary waves our rather general de nition (8) also com prises solutions which are simpler waves, which nevertheless propagate without dispersion. In general one can say, that due to the two reasons that the investigated system s are sm all and that the H eisenberg H am iltonian (1) does not possess any anisotropy the observed solitary waves are rather broad.

The special case of a superposition of the ground state and the rst excited state of a spin ring should be well observable at low tem peratures for instance by NuclearM agnetic R esonance (NMR).Forrings with an even num ber of sites this is currently aim ed at [14,15]. R ings with an odd num ber of sites are di cult to produce due to steric arrangem ent problem s of the extended ligands. F irst attem pts resulted in rings where one param agnetic ion is di erent from the others [23]. The prospects of interesting features due to frustration nevertheless fuel future e orts to synthesize odd rings.




Fig. 6. Top panel: Low -lying energy spectrum of a antiferrom agnetic spin ring with N = 6 and s = 5=2: The dashed line connects the ground state and the rst excited state. Bottom panel: Solitary wave for N = 6 and s = 5=2 consisting of ground state (k = 3) and rst excited state (k = 0) with M = 0 (crosses). The curve is drawn as a guide for the eye.

A nother in portant aspect is the role of an isotropic term s in the H am iltonian. Such term s are relevant for the magnetic properties of several magnetic molecules, e.g. for ferric wheels comprising six iron ions of spin s = 5=2 [25,26,22]. Easy axis an isotropy would for instance amplify the magnetization oscillations, which arise when ground state and state are superim posed. Figure 6 shows in its bottom panel such oscillations again, this time for a hexanuclear iron ring. One notices that the local magnetization reaches at most an amplitude of 1.6 due to strong quantum uctuations in the Heisenberg model. Increasing easy axis anisotropy would result in more Ising-like behavior with increased localm agnetizations. It will be the subject of further studies how that in general would in uence solitary waves, but it is already clear that under such conditions solitary waves would be more localized [27].
