Transient behavior of a population dynamical model

The transient behavior of an ecosystem with N random interacting species in the presence of a multiplicative noise is analyzed. The multiplicative noise m im ics the interaction with the environment. We investigate dierent asymptotic dynamical regimes and the role of the external noise on the probability distribution of the local eld.

x1. Introduction

Population dynamics attracted a lot of attention in recent years and became the object of any studies as well by biologists as by physicists. Tools developed in the context of nonequilibrium statistical physics to analyze nonequilibrium nonlinear physical systems provide new insights and at the same time new approaches to study biological system s. Biological population dynamics has many interesting, and still not solved, problem s such as pattern form ation, $6^{(6)(9)}$ the role of the noise on complex ecosystem behaviour, and the noise-induced e ects, such as stochastic resonance, noise delayed extinction, quasi periodic oscillations etc... 10)(18) The dynam ical behavior of ecological systems of interacting species evolves towards the equilibrium states through the long, slow, and complex process of nonlinear relaxation, which is strongly dependent on the random interaction between the species, the initial conditions and the random interaction with environment. A good mathematical model to analyze the dynam ics of N biological species with spatially homogeneous densities is the generalized Lotka-Volterra system with a Malthus-Verhulst modelization of the self regulation mechanism, in the presence of a multiplicative noise. $^{19}(21)$ By neglecting the uctuations of the local eld we derive a quasi-stationary probability of the populations. We obtain the asymptotic analytical expressions for dierent nonlinear relaxation regimes, and we analyze the role of the multiplicative noise on the probability distribution of the local eld.

x2. The model and results

The dynam ical evolution of our ecosystem composed by N interacting species in a noisy environment and in the presence of an absorbing barrier is described by the following Ito stochastic dierential equation

where $x_i(t) = 0$ is the population density of the i^{th} species at time t and the function $g_i(x_i(t))$

describes the developm ent of the i^{th} species without interacting with other species. In Equation (1), is the growth parameter, the interaction matrix J_{ij} models the interaction between dierent species ($i \in j$), and w_i is the Wiener process whose increment dw_i satisfies the usual statistical properties $< dw_i(t) > = 0$, and $< dw_i(t)dw_j(t^0) > = i_j$ (to t^0) dt. We consider a random asymmetric interaction matrix J_{ij} , whose elements are independently distributed according to a Gaussian distribution with $hJ_{ij}i=0$, $hJ_{ij}J_{ji}i=0$, and $hJ_{ij}=1$ are respectively. With this choice of interaction with species $hJ_{ij}=1$ and $hJ_$

is the local eld acting on the i^{th} population and represents the in uence of other species on the di erential grow th rate. We note that the dynam ical behavior of the i^{th} population depends on the time integral of the process z_i (t) and the time integral of the local eld. For a large number of interacting species we can assume that the local eld i (t) is Gaussian with zero mean and variance $i_i^2 = h_i^2 i = J^2 h x_i^2 i$.

As a consequence, in the absence of external multiplicative noise, from the xed-point equation x_i ($x_i + i$) = 0, the stationary probability distribution of the populations is the sum of a truncated Gaussian distribution at $x_i = 0$ ($x_i > 0$ always) and a delta function for extinct species. The initial values of the populations x_i (0) have also Gaussian distribution with mean value hx_i (0) i = 1, and variance $\frac{2}{x(0)} = 0.01; 0.03; 0.03; 0.05$.

The interaction strength between the species J determ ines two di erent dynam ical behaviors of the ecosystem . Above a critical value $J_c=1:1$, the system is unstable and at least one of the populations diverges. Below J_c the system is stable and asymptotically reaches an equilibrium state. The equilibrium values of the populations depend both on their initial values and on the interaction matrix. If we consider a quenched random interaction matrix, the ecosystem has a great number of equilibrium con gurations, each one with its attraction basin. For an interaction strength J=1 and an intrinsic growth parameter =1 we obtain: $< x_i >= 1:4387; < x_i^2 >= 4:514;$ and $\frac{2}{x_i} = 2:44$. These values agree with that obtained from numerical simulation of Equation (1). From the Fokker-Planck equation associated to the Langevin equation (1)

we obtain a quasi stationary distribution by neglecting the uctuations of the local eld in the asymptotic regim e

and is the Heaviside unit step function. Now we focus on the statistical properties of the time integral of the i^{th} population X $_i$ (t)

in the asymptotic regime. From Eqs. (3) and (10)we have

We use the same approximation of the mean eld interaction, $^{(19)}$ and after dierentiating Eq.(11), we get the asymptotic solution of X_i(t) as

where $w_{m ax_i}$ (t) = $\sup_{0 < t^0 < t^w}$ (t⁰) and \max_i (t) = $\sup_{0 < t^0 < t}$ (t⁰). Eq. (12) is valid for 0, that is, when the system relaxes toward an equilibrium population and at the critical point. A fler making the ensemble average, we obtain for the time average of the ith population X_i



where N $_{\rm W}$ and N $_{\rm W}$ are variables with a sem i-G aussian distribution $^{19)}$ and N $_{\rm W}$ must be determined self-consistently from the variance of the local eld (Eq. (5)). We obtain, consistently with mean eld approximation, the typical long time tail behavior (t $^{1=2}$) dependence, which characterizes nonlinear relaxation regimes when




Fig. 1. The local and the cavity elds in the absence of noise, = 0.

0. When the system relaxes toward the absorbing barrier (< 0), the time average of the i^{th} population X_i is a functional of the local eld and the W iener process. We have also analyzed the dynam ics of the ecosystem when one species is absent. Speci cally, we considered the cavity eld, which is the eld acting on the i^{th} population when this population is absent. The probability distributions for both local and cavity eld have been obtained by simulations for a time t=200 (a. u.) in absence of external noise, and for dierent species. We found that the probability distributions of the cavity elds dier substantially from those of local elds for the same species, while in the presence of noise the two elds overlap (see Figs. 1 and 2).

This overlap is dierent for dierent species and depends on the variance of the initial species distribution. This strange behavior, found for some populations, is rem iniscent of the phase-transition phenomenon, and it is related to the following peculiarities of our dynamical system: (i) all the populations are positive; (ii) dierent initial conditions drive the ecosystem into dierent attraction basins; and (iii) the complex structure of the attraction basins of our dynamical system. While, in the presence of noise, all the populations seem to be equivalent from the dynamical

point of view, som e populations, in the absence of external noise, have an asymptotical dynamical behavior such that they signicantly in uence the dynamics of other species.

x3. Conclusions

We analyzed the nonlinear relaxation of an ecosystem composed by N interacting species. We obtain the quasi-stationary probability distribution of the population in the presence of multiplicative noise. By using an approximation of the integral equation, which gives the stochastic evolution of the system, we obtained asymptotic behavior for different nonlinear relaxation regimes. We observe an interesting phenomenon: the local and the cavity elds, whose probability distributions are different in the absence of noise, coincide for some populations in the presence of multiplicative noise. This phenomenon can be ascribed to the peculiarity of the dynamical system ($x_i > 0$; always), the in wence of different initial conditions on the asymptotic regime, and the complex structure of the attraction basins of our ecosystem.
