# C ollective oscillations of one-dim ensional B ose E instein gas in a tim e-varying trap potential and atom ic scattering length

#### Abstract

The collective oscillations of 1 D repulsive Bose gas $w$ th extemal harm onic con nem ent in two di erent regim es are studied. The rst regin e is them ean eld regim ewhen the density ishigh. T he second regim e is the Tonks-G irardeau regim ew hen the density is low. W e investigate the resonances under periodic $m$ odulations of the trap potential and the e ective nonlinearity. M odulations of the e ective nonlinear coe cient result from $m$ odulations of the atom ic scattering length by the Feshbach resonance $m$ ethod or variations of the transverse trap frequency. In the $m$ ean eld regim $e$ we predict the bistability in the nonlinear oscillations of the condensate. In the Tonks-G irardeau regim e the resonance has the character of a linear param etric resonance. In the case of rapid strong $m$ odulations of the nonlinear coe cient we nd analytical expressions for the nonlinearity $m$ anaged soliton width and the frequency of the slow secondary oscillations near the xed point. Wecon m the analytical predictions by direct num erical sim ulations of 1 D G ross P itaevskiiequation and the e ective nonlinear Schrodinger equation with quintic nonlinearity and trap potential.

## I. INTRODUCTION

Low dim ensional B oseモinstein condensates (BECs) in highly asymm etric traps have recently been achieved, which opens new possibilities in the investigation of clouds ofbosonic
 properties which distinguish them from 3D systems. O ne of them is the grow th of the interaction when the density is decreased. As a result the system enters into the TonksG irardeau (TG) regim e. The properties of the B ose gas then coincide $w$ th the gas of free ferm ions. This follows from the exact solution to the problem of hard-core bosons w ith
 interaction (high density case) is the m ean eld (MF) regim e [ō1].

The TG and M F regim es can be characterized by the param eter which is equal to the ratio of the interaction energy and the kinetic energy of the ground state of gas, i.e. = $m g_{1 D}=\left(\sim^{2} n_{1 D}\right) . H$ erem is the atom icm ass, $g_{1 D}$ is the one-dim ensionalcoupling constant, and $\mathrm{n}_{1 \mathrm{D}}$ is the 1D density. The case 1 corresponds to high densities, when the description by the mean eld theory is valid. The case 1 corresponds to the strong repulsive interaction - the TonksG irardeau regim e. The m odem experim ents w ith B ose gas in highly elongated traps now are in the region 1 [i"].

O ne of the im portant phenom ena for the experim ents is the collective oscillations of the B ose gas in the di erent regim es. It is particularly interesting to investigate the dynam ics of breathing and dipole m odes for M F and $T G$ regim es, as well as the crossover betw een them. The theoreticalpredictions for the frequencies in harm onic longitudinaltraps $V(z)=$
 in the $m$ ean eld regim e is $\bar{P} \overline{3}!_{z}$, while it is $2!_{z}$ in the $T G$ regim e. The last value coincides $w$ ith the one observed for the therm al gas. For the 3 D cigar the frequency is $\mathrm{P} \overline{5=2}!_{\mathrm{z}}$. These investigations involve the combination of the exact solution by Lieb and Liniger, the local density approxim ation, the hydrodynam ic equations, and the extended nonlinear Schrodinger equation. N ote that inform ation for oscillations in the high-dim ensional regim es can be found in the review $[1 \overline{1} \overline{-1}]$. In this w ork we shall study resonances in the oscillations of 1D B ose gas in both regim es. The periodic and random $m$ odulations of the trap potential and the atom ic scattering length are sub ject to our analysis.

The M F regim e is described by the 1D G rossP itaevskii (GP) equation w ith two-body

$T$ his equation is derived from the 3D GP equation in a strongly anisotropic extemal poten－ tial．The dynam ics in the radialdirection is then averaged out［⿶凵⿱乛⿻上丨．$]$ and the longitudinalpro le of the wave function satis es Eq．（［ī）．The wave function is norm alized so that the num ber
 which is assum ed in this work to be harm onic $V(z ; t)=m!{ }_{z}^{2} z^{2} F(t)=2$ ．The function $F$（ $t$ ） describes the variation in tim e of the trap．The e ective nonlinear coupling constant is $g_{1 D}$ ． In the case of a ham onic transverse trap potentialm $!_{?}^{2}\left(x^{2}+y^{2}\right)=2$ ，Eq．$(\overline{1})$ ）is valid under the assum ption ！？$\quad!_{z}$ and we have $g_{1 D}=2 \sim a_{s}!$ ？The function $(t)$ describes the vari－ ation in tim e of the e ective nonlinearity．A rst $m$ ethod to vary the e ective nonlinearity is to $m$ odulate in tim e the transverse trap $w i d t h$ or equivalently the transverse frequency ！？．The m odulations of the transverse frequency im pose variations of the BEC density in the（ $x ; y$ ）－plane，which in tum involve variations of the nonlinear interaction $[\underline{1} \overline{-} \overline{-}]$ ．N onlinear resonances in 2D BEC for such $m$ odulations have been studied in＂ī1，＇ī］．A second $m$ ethod to vary the e ective nonlinearity is to $m$ odulate the atom ic scattering length by the so－called Feshbach resonance technique［in 171 ］．

Theoretical and experim ental studies have dem onstrated that variation of the swave scattering length，including a possibility to change its sign，can be achieved by using the Feshbach resonance

$a_{s}$ is the value of the scattering length far from resonance，$B(t)$ is the tim e－dependent extemalm agnetic eld，is the width of the resonance，and $B 0$ is the resonant value of the m agnetic eld．Feshbach resonances have been observed in ${ }^{23} \mathrm{Na}$ at 853 and 907 G ［ī̄$\overline{1}$ in ${ }^{7}$ Li at 725 G ［1］$\left.\overline{1}\right]$ ，and in ${ }^{85} \mathrm{Rb}$ at 164 G w ith $=11 \mathrm{G}$［19］．In the case of resonance dynam ics where $a_{s}$ is slow ly varying and keeps a constant sign atom losses are negligible． H ow ever atom lossesm ay be im portant when crossing the resonance［ī of the ${ }^{23} \mathrm{Na}$ condensate where it is necessary to cross the Feshbach resonance to change the sign of the atom ic scattering length．The approach developed in this paper should then be $m$ odi ed to take into account this phenom enon．If we are not close to the resonance，losses are sm all and in a rst approxim ation they can be taken into account by a tim e－varying
num ber of atom $s$ in the e ective variational equation for the $w$ idth. This should lead to dam ped secondary oscillations w ith a tim e scale larger than the oscillations tim e. H ow ever atom $s$ losses can be minim ized down to a negligible level by certain experim ental control
 Ref. [1]i-1] it is dem onstrated in the case of ${ }^{7}$ Lithat a change of the sign of the scattering length can be obtained w thout crossing the resonance by the so-called coupled channel m ethod. O ur study of the nonlinear $m$ anagem ent is triggered by these experim ental achievem ents.

A ccording to Kolom eisky et al. [2] Schrodinger equation $w$ th quintic nonlinearity and trap potential

It is known that this $m$ odeldoes not capture every aspect of the dynam ics of an atom ic gas in the TG regim e, in particular it overestim ates the coherence in interference pattems at sm all num ber of particles
 therm ore we shall show that it also gives the correct frequency of oscillations as predicted theoretically and observed experim entally [ $\underline{\eta}_{i}$. . A s our attention is focused on resonance phenom ena, Eq. $(\underset{2}{\operatorname{G}})$ seem s to be a good m odel, both physically relevant and m athem atically tractable. U sing the tim e-dependent variationalm ethod or the hydrodynam ic approach we shall derive the equation for the TG gas width and study resonances in oscillations under periodic and random $m$ odulations of the trap potential.

The paper is organized as follow s. In Sections II-IV we analyze the nonlinear resonances in gas oscillations in the $m$ ean eld regim e using the 1D m ean- eld GP equation. W eapply a tim e-dependent variational approach and introduce action-angle variables in Section II. Section III, resp. IV, is devoted to the resonances driven by periodic and random mod ulations of the trap frequency, resp. the nonlinearity. In Section $V$ we address the same problem s for the 1D TG regime.
II. THE MEAN FIELD CASE

## A . Variational approach

B . A ction-angle variables

W e assume in this section that $(t)=0+\sim(t)$ where the average nonlinear coe cient $0>0$ which corresponds to the repulsive case, while $\sim$ represents a zero-m ean periodic or random com ponent. Sim ilarly, we take $f(t)=1+f^{\sim}(t)$. The unperturbed problem consists in taking $\sim(t)=\tilde{f}^{\sim}(t)=0$. Assume that 0 is large so that the kinetic term $1=a^{3}$ can be neglected in Eq. (두) . T he energy E of the unperturbed BEC is given by:

If the initial conditions $\left(a(0) ; a_{t}(0)\right)$ correspond to an energy above $\mathrm{E}_{\mathrm{g}}$, then the orbit of the $m$ otion is closed, comesponding to periodic oscillations. III. RESONANCES IN THE MEAN FIELD CASE DRIVEN BY A TMEVARYING NONLINEARITY

In this section we address the role of a tim e-varying nonlinearity and assum e that the trap is stationary $f^{\prime}(t)=0$. We shall $m$ ainly focus our attention to the periodic $m$ anagem ent $(t)=0^{+}{ }_{1} \sin (\mathrm{~g} t)$, but we shall also consider random uctuations of the e ective nonlinearity in the 1D GP equation.
A. High-frequency nonlinear managem ent

W e shall rst address the case where the oscillation frequency of the nonlinear $m$ anage$m$ ent is $m$ uch higher than the trapping frequency, ie. $g \quad!_{z}$. Wemust also assum $e$ $g \quad!$ ? to prevent from exciting the transverse $m$ odes. In such a case the in uence of the nonlinearm anagem ent is negligible unless the nonlinear m anagem ent am plinude is large. The problem of nonlinearity $m$ anagem ent for BEC, the so-called Feshbach resonance (FR)


$m$ anagem ent, based on a tim e-periodic change of the $m$ agnitude and sign of the scattering length by a resonantly tuned acm agnetic eld. The FR m anagem ent resem bles the so-called dispersion-m anagem ent (DM) technique in ber optics, which is based on a periodic concatenation of bers w ith opposite signs of the group-velocity dispersion. TheDM technique has been shown to support robust breathing pulses, the so-called D M solitons celebrated in
 nam ed FR $m$ anaged $m$ atter wave soliton. Here, in distinction from alytical expressions for the xed point (corresponding to the FR managed soliton) and the frequency of slow secondary oscillations. M ore precisely, we introduce the sm all param eter

$a_{g}$ increases with 1 and goes from the value 1 for ${ }_{1}=0$ to the asym ptotic behavior $a_{g}{ }_{1}^{2=3}$ for large ${ }_{1}$. The linear stability analysis of the e ective equation (1-5디) show $s$ that the xed point is stable. If the initial condition is close to this point, then the width a oscillates around the value $\mathrm{a}_{\mathrm{g}} \mathrm{w}$ th the oscillation frequency $!={ }^{\mathrm{q}} \overline{6} \quad 2==_{g}^{4}$ which increases from 2 for ${ }_{1}=0$ to its $\lim$ it value ${ }^{\mathrm{P}} \bar{\sigma}$. W e have carried out num erical sim ulations of the O D E m odel ( to check the theoretical predictions of the asym ptotic analysis ! 0 (see Figure ${ }_{-1}^{1} \bar{Z}$ ). N ote that stable BEC s can be achieved w ith a negative (i.e. attractive) or positive (ie. repulsive) average nonlinear coe cient 0 .

Let us estim ate the param eters for a realistic experim ent. For the ${ }^{85} \mathrm{Rb}$ condensate w ith
 $1=2$, we nd that the condensate $w$ idth is $a_{g} \quad 0: 71$ and the frequency of the secondary oscillations is! $2: 6!_{\mathrm{z}}$.

## B . R esonant nonlinear $m$ anagem ent

In this section we address the case w here the periodic nonlinear managem ent is resonant or close to resonant. W e shall focus our attention to the particularly interesting case where the num ber of atom $s N$ is large, which in tum im plies that the dim ensionless param eter 0 is large (say at least 5). We shall see that a periodic m odulation of the nonlinear coe cient

This departure originates from the fact that the two stationary pro les do not coincide. N ote that the stationary point is $\mathrm{C}^{1=4}$, so that the di erence is around 5\% which is negligible in practical situations. Eventually, the BEC dynam ics is found to be govemed by the sam e e ective equation according to both approaches.

## C. Periodic m odulations of the trap potential

The dynam ics of the $H$ illequation driven by a periodic m odulation $f(t)=1+f_{1} \sin (t)$ is characterized by a param etric resonance phenom enon studied in stability of the solutions to the $H$ ill equation depends on the param eters $f_{1}$ and. The theoretical prediction is that the stationary solution $\mathrm{a}_{\mathrm{g}}$ is unstable when the m odulation frequency is close enough to the eigenfrequency of the BEC, m ore precisely

D. $R$ andom $m$ odulations of the trap potential

W e exam ine in this section the e ects of random $m$ odulations of the trap potential of the form $f(t)=1+\quad(t)$ where is a zerom ean stochastic process. The dynam ics then
 case, we alw ays observe an exponential grow th of the oscillations of the BEC width, unless the random $m$ odulation has a vanishing pow er spectraldensity in the vicinity of the resonant eigen frequency 2. M ore precisely, we get that a periodically oscillates betw een the values $a_{g} \quad a_{s c}(t) w$ th $a_{o s c}$ that grow $s$ exponentially as

$T$ his is due to the fact that som e exceptional realizations of the random uctuations $m$ ay induce very strong oscillations, and these exceptional realizations actually im pose the value of the expected value.

The sim plest way to take into account stochastic resonance is to $m$ ultiply the previous expression by the exponential dam ping term $\exp \left({ }^{2} t=2\right.$ ). There exists a m ore accurate way based on ItO's calculus. A ssum e that the initial state is $a(0)=a_{0}, a^{0}(0)=0$. The colum $n$ vector $X=\left(h a^{2} i ; h a b i ; h^{2} i\right)^{T}$ satis es the closed system
starting from $X(0)=V_{0}=a_{0}^{2} ; 0 ; C^{\sim}=a_{0}^{2}$. As a rst application we can com pute the exact expression of the largest eigenvalue ofM which govems the exponential grow th of the m odulation ha ${ }^{2}$ i:

 of the trap potential to check the predictions obtained with the variational approach. We have taken the $m$ odelw here $(t)$ is stepw ise constant over elem entary intervals $w$ ith duration $t_{c}$ and takes random values uniform ly distributed between 1 and $1 . \mathrm{W}$ ith $\mathrm{t}=0: 06$ we then have $c=0: 01$. W e com pare the results of num erical sim ulations $w$ th the theoretical predictions in Figure ${ }_{-1} \bar{T}_{1}$. W e can see that $\left(\overline{3} \overline{9} \bar{g}_{1}\right)$ e ciently predicts the in oscillation am plitude, but it is necessary to take into account stochastic resonance when the am plinude becom es larger.

## VI. CONCLUSION

In this work we have considered the resonances in collective oscillations of 1D B ose gas under tim e-dependent variations of the trap potential and the e ective nonlinearily. T wo regim es have been studied - the $m$ ean eld regim e and the TonksG irardeau regim e. The analysis show $s$ that in the $m$ ean eld regim e the resonances are nonlinear and bistability exists in the vicinity of a critical frequency which is signi cantly above the eigen frequency of the BEC. T he dynam ics is then characterized by stable oscillations w ith large am plitudes which depend on the frequency detuning betw een the frequency of the breathing $m$ ode and them odulation frequency. This type ofdynam ics is also predicted for them odulations of the trap as well as for the m odulations of the atom ic scattering length. In the TonksG irardeau regim e the theory based on the nonlinear Schrodinger equation with quintic nonlinearity predicts the linear param etric resonance in the gas oscillations. T he e ect re ects the B oseFerm im ap existing for the B ose gas in this regim e [1] 11$]$. W e also study the oscillations under random variations of the trap potential and e ective nonlinearity. T he analysis show that the dynam ics is nonlinear in them ean eld regim e. In the TonksG irardeau regim e the study predicts stochastic param etric resonance. W e also investigate the dynam ics of 1D B ose gas in the $m$ ean eld regim e under rapid and strong $m$ odulations of the atom ic scattering length. $T$ his problem has recently attracted a great attention since the dynam ically stable nonlin-
earity $m$ anaged atom ic $m$ atter solitons can be generated. $W$ e nd the analyticalexpressions for the stationary value of the width and frequency of the slow secondary oscillations of the width. All theoretical predictions tum out to be well supported by direct num erical sim ulations of the 1D GP equation and the quintic nonlinear Schrodinger equation.
