Collective oscillations of one-dim ensional Bose-Einstein gas in a time-varying trap potential and atom ic scattering length

Abstract

The collective oscillations of 1D repulsive Bose gas with external harm onic con nement in two di erent regim es are studied. The rst regim e is them ean eld regim e when the density is high. The second regim e is the Tonks-G irardeau regim e when the density is low. We investigate the resonances under periodic modulations of the trap potential and the elective nonlinearity. Modulations of the elective nonlinear coel cient result from modulations of the atomic scattering length by the Feshbach resonance method or variations of the transverse trap frequency. In the mean eld regime we predict the bistability in the nonlinear oscillations of the condensate. In the Tonks-G irardeau regime the resonance has the character of a linear parametric resonance. In the case of rapid strong modulations of the nonlinear coelient we not analytical expressions for the nonlinearity managed soliton width and the frequency of the slow secondary oscillations near the xed point. We con mothe analytical predictions by direct number as a unitations of 1D G ross-P itaevskii equation and the elective nonlinear Schrödinger equation with quintic nonlinearity and trap potential.

I. INTRODUCTION

Low dimensional Bose-Einstein condensates (BECs) in highly asymmetric traps have recently been achieved, which opens new possibilities in the investigation of clouds of bosonic and ferm ionic gases [1, 2, 3]. Low-dimensional bosonic systems have many remarkable properties which distinguish them from 3D systems. One of them is the growth of the interaction when the density is decreased. As a result the system enters into the Tonks-Girardeau (TG) regime. The properties of the Bose gas then coincide with the gas of free fermions. This follows from the exact solution to the problem of hard-core bosons with repulsive interaction obtained by Lieb and Liniger [4, 5]. The opposite regime with weak interaction (high density case) is the mean eld (MF) regime [6].

The TG and MF regimes can be characterized by the parameter—which is equal to the ratio of the interaction energy and the kinetic energy of the ground state of gas, i.e. = $m g_{1D} = (\sim^2 n_{1D})$. Here m is the atom icm ass, g_{1D} is the one-dimensional coupling constant, and n_{1D} is the 1D density. The case—1 corresponds to high densities, when the description by the mean—eld theory is valid. The case—1 corresponds to the strong repulsive interaction—the Tonks-G irardeau regime. The modern experiments with Bose gas in highly elongated traps now—are in the region—1 [7].

One of the important phenomena for the experiments is the collective oscillations of the Bose gas in the dierent regimes. It is particularly interesting to investigate the dynamics of breathing and dipole modes for MF and TG regimes, as well as the crossover between them. The theoretical predictions for the frequencies in harmonic longitudinal traps V (z) = $\text{m}!_z^2 z^2 = 2$ are obtained in Refs. [8, 9, 10, 11, 12]. It is shown that the frequency of oscillations in the mean eld regime is $\frac{p}{3!}z$, while it is 2!z in the TG regime. The last value coincides with the one observed for the thermal gas. For the 3D cigar the frequency is $\frac{p}{5=2!}z$. These investigations involve the combination of the exact solution by Lieb and Liniger, the local density approximation, the hydrodynamic equations, and the extended nonlinear Schrödinger equation. Note that information for oscillations in the high-dimensional regimes can be found in the review [13]. In this work we shall study resonances in the oscillations of 1D Bose gas in both regimes. The periodic and random modulations of the trap potential and the atom it scattering length are subject to our analysis.

The MF regime is described by the 1D Gross-Pitaevskii (GP) equation with two-body

This equation is derived from the 3D GP equation in a strongly anisotropic external potential. The dynam ics in the radial direction is then averaged out [6] and the longitudinal pro le of the wave function satis es Eq. (1). The wave function is normalized so that the number of atom s in the BEC is N = R j (t;x) 2 dx. V (z;t) is the longitudinal trapping potential, which is assumed in this work to be harm onic V (z;t) = m ! $\frac{2}{z}$ z 2 F (t)=2. The function F (t) describes the variation in time of the trap. The elective nonlinear coupling constant is g_{1D} . In the case of a harm onic transverse trap potential $m!_{2}^{2}(x^{2}+y^{2})=2$, Eq. (1) is valid under $!_{z}$ and we have $g_{1D} = 2 \sim a_{s}!_{?}$. The function (t) describes the varithe assum ption !? ation in time of the elective nonlinearity. A rst method to vary the elective nonlinearity is to modulate in time the transverse trap width or equivalently the transverse frequency $!_{\, ?}$. The modulations of the transverse frequency in pose variations of the BEC density in the (x;y)-plane, which in turn involve variations of the nonlinear interaction [14]. Nonlinear resonances in 2D BEC for such modulations have been studied in [15, 16]. A second method to vary the e ective nonlinearity is to modulate the atom ic scattering length by the so-called Feshbach resonance technique [17].

Theoretical and experimental studies have demonstrated that variation of the s-wave scattering length, including a possibility to change its sign, can be achieved by using the Feshbach resonance

 a_s is the value of the scattering length far from resonance, B (t) is the time-dependent external magnetic eld, is the width of the resonance, and B $_0$ is the resonant value of the magnetic eld. Feshbach resonances have been observed in 23 Na at 853 and 907 G [17], in 7 Li at 725 G [18], and in 85 Rb at 164 G with = 11 G [19]. In the case of resonance dynamics where a_s is slow by varying and keeps a constant sign atom losses are negligible. However atom bosses may be important when crossing the resonance [17, 20]. This is the case of the 23 Na condensate where it is necessary to cross the Feshbach resonance to change the sign of the atom ic scattering length. The approach developed in this paper should then be modiled to take into account this phenomenon. If we are not close to the resonance, losses are small and in a ret approximation they can be taken into account by a time-varying

number of atoms in the elective variational equation for the width. This should lead to damped secondary oscillations with a time scale larger than the oscillations time. However atoms losses can be minimized down to a negligible level by certain experimental control that have been implemented in particular in the ⁸⁵Rb case [21, 22, 23, 24]. Furthermore in Ref. [18] it is demonstrated in the case of ⁷Lithat a change of the sign of the scattering length can be obtained without crossing the resonance by the so-called coupled channel method. Our study of the nonlinear management is triggered by these experimental achievements.

According to Kolomeisky et al. [25] the TG regime is described by the nonlinear Schrodinger equation with quintic nonlinearity and trap potential

It is known that this model does not capture every aspect of the dynam ics of an atom ic gas in the TG regime, in particular it overestimates the coherence in interference patterns at small number of particles [26]. However Eq. (2) has been shown to reproduce the collective spectrum of a gas in the TG regime within a local density approximation [11, 27]. Furthermore we shall show that it also gives the correct frequency of oscillations as predicted theoretically and observed experimentally [7]. As our attention is focused on resonance phenomena, Eq. (2) seems to be a good model, both physically relevant and mathematically tractable. Using the time-dependent variational method or the hydrodynamic approach we shall derive the equation for the TG gas width and study resonances in oscillations under periodic and random modulations of the trap potential.

The paper is organized as follows. In Sections II-IV we analyze the nonlinear resonances in gas oscillations in the mean eld regime using the 1D mean-eld GP equation. We apply a time-dependent variational approach and introduce action-angle variables in Section II. Section III, resp. IV, is devoted to the resonances driven by periodic and random modulations of the trap frequency, resp. the nonlinearity. In Section V we address the same problems for the 1D TG regime.

II. THE MEAN FIELD CASE

A. Variational approach

We rst put Eq. (1) into dimensionless form by setting $t^0 = !_z t$, $x = z = l_z$, $l_z = p$ and u = p 2 $ja_s j!_z = l_z$. In the following we omit primes, so the mean-eld GP equation reads

Note that the equation for the gas center of mass is decoupled from the equations for oscillations so we did not take it into consideration. The ansatz yields a closed-form evolution equation for the width

In the dimensional variables we get $L_c = [(2a_s l_z^2!, N)(p-1)]^{1-3}$, that agrees (up to a numerical multiplicative constant) with the Thomas-Fermi value for the 1D BEC width.

B. Action-angle variables

We assume in this section that $(t) = {}_{0} + {}_{\sim}(t)$ where the average nonlinear coe cient ${}_{0} > 0$ which corresponds to the repulsive case, while ${}_{\sim}$ represents a zero-mean periodic or random component. Similarly, we take f(t) = 1 + f'(t). The unperturbed problem consists in taking ${}_{\sim}(t) = f'(t) = 0$. Assume that ${}_{0}$ is large so that the kinetic term $1=a^{3}$ can be neglected in Eq. (5). The energy E of the unperturbed BEC is given by:

In absence of uctuations the energy E is an integral of motion. The BEC width obeys a $ext{sim}$ ple dynam ics with $ext{H}$ am iltonian structure

with q=a, $p=a_t$. The potential U possesses a unique minimum $a_g=0^{1-3}$ which is a stable xed point with oscillation frequency ! = $\frac{p}{3}$. The corresponding ground state has energy $E_g=U(a_g)=(3-2)_0^{2-3}$.

If the initial conditions $(a(0); a_t(0))$ correspond to an energy above E_g , then the orbit of the motion is closed, corresponding to periodic oscillations. In order to explicit the periodic structure of the variables a and a_t , we introduce the action-angle variables. The orbits are determined by the energy in posed by the initial conditions

The transform ation (E;a)! (I;) can be inverted to give the functions E(I) and A(I;). The BEC width oscillates between the minimum value a_1 (E) and the maximum value a_2 (E).

The energy E as well as the action I are constant and determ ined by the initial conditions, so the evolution of the BEC width is governed by

III. RESONANCES IN THE MEAN FIELD CASE DRIVEN BY A TIME-VARYING NONLINEARITY

In this section we address the role of a time-varying nonlinearity and assume that the trap is stationary f'(t) = 0. We shall mainly focus our attention to the periodic management $(t) = {}_{0} + {}_{1}\sin({}_{g}t)$, but we shall also consider random uctuations of the elective nonlinearity in the 1D GP equation.

A. High-frequency nonlinear management

We shall rst address the case where the oscillation frequency of the nonlinear management is much higher than the trapping frequency, i.e. $_{\rm g}$! . We must also assume $_{\rm g}$! . The problem of nonlinearity management for BEC, the so-called Feshbach resonance (FR) management, has already been considered for 1D BEC in Refs. [24, 28] and for 2D BEC in Refs. [29, 30]. In Ref. [24] the authors were the rst ones to propose a technique of FR

m anagem ent, based on a time-periodic change of the magnitude and sign of the scattering length by a resonantly tuned acm agnetic eld. The FR management resembles the so-called dispersion-management (DM) technique in ber optics, which is based on a periodic concatenation of bers with opposite signs of the group-velocity dispersion. The DM technique has been shown to support robust breathing pulses, the so-called DM solitons celebrated in optics [31]. The FR technique is shown in Refs. [24, 28] to drive stable localized structures, named FR managed matter wave soliton. Here, in distinction from [24, 28], we give the analytical expressions for the xed point (corresponding to the FR managed soliton) and the frequency of slow secondary oscillations. More precisely, we introduce the small parameter $= !_z = *_g$ and we assume that the nonlinear management amplitude is large compared to the average value. We write accordingly

where a (0) and a⁰(0) are the initial values of the width and its time-derivative. The ground state can then be analytically studied. Let us rst deal with the case $_0 = 0$. 


FIG.1:BEC width (picture a) and oscillation frequency (picture b) as predicted by the theoretical model (in dimensionless units). For $_0$ 1 the BEC width is $_0^{1=3}$ and the oscillation frequency is $p_{\frac{1}{3}}$

 a_g increases with $_1$ and goes from the value 1 for $_1$ = 0 to the asymptotic behavior a_g $_1^{2=3}$ for large $_1$. The linear stability analysis of the elective equation (15) shows that the xed point is stable. If the initial condition is close to this point, then the width a oscillates around the value a_g with the oscillation frequency ! = 6 $2=\frac{4}{9}$ which increases from 2 for $_1$ = 0 to its lim it value $_0^p$ 6. In the general case $_0$ 6 0, $_1$ 6 0, there exists a unique xed point which is the unique positive zero of the equation a^2 $a^6 + a^3 + a^2 = 0$. It is plotted in Figure 1a, and the corresponding oscillation frequency is plotted in Figure 1b.




FIG. 2: BEC width in presence of high-frequency periodic modulation of the nonlinear coecient. Here $(t) = 0 + 2\sin(10t)$ with 0 = 1 (picture a) and 0 = 1 (picture b). The solid and dashed lines stand for full numerical simulations of the PDE system with two dierent initial conditions (dashed lines: theoretical ground states), while the dotted lines represent the theoretical predictions.

We have carried out numerical simulations of the ODE model (5) and the PDE model (3) to check the theoretical predictions of the asymptotic analysis! 0 (see Figure 2). Note that stable BECs can be achieved with a negative (i.e. attractive) or positive (i.e. repulsive) average nonlinear coecient $_{0}$.

B. Resonant nonlinear management

In this section we address the case where the periodic nonlinear management is resonant or close to resonant. We shall focus our attention to the particularly interesting case where the number of atoms N is large, which in turn implies that the dimensionless parameter $_{0}$ is large (say at least 5). We shall see that a periodic modulation of the nonlinear one cient

m ay dram atically modify the dynam ics, and this phenom enon will be noticeable when the dim ensionless parameter $_1$ is of order 1. If $_0$ 5, then Eq. (5) can be simplied into

In absence of periodic modulation $_1=0$, the ground state is $a_g=\frac{p_g}{0}$ and the oscillation frequency of the BEC is $!=\frac{p_g}{3}$ in dimensionless units. We now consider a periodic modulation of the nonlinear coecient with an amplitude $_1$ smaller than $_0$ and with frequency of the same order as !. We expand $a=a_g+a$ where a satisfies

This yields a system of dierential equations that give the zeroth and second harm onics in terms of the rst one, and a compatibility condition which reads as a system of two dierential equations for the rst-harm onic α_1 and the slow phase

The rst harm onic is dom inant so that the BEC width evolution can be described at rst order as a(t) = $a_g + a_1$ (t) cos(t+ (t)). The stability analysis shows very interesting features. It appears that the strongest resonance occurs when the nonlinear management has the frequency

which is above the oscillation frequency of the BEC. Resonance is still noticeable for a modulation frequency in a vicinity of $_{\rm c}$ with bandwidth of order! ($_{\rm 1=0}$) $^{2=3}$. More precisely, if < $_{\rm c}$, then there exists a unique xed point to system (17-18). The value of $a_{\rm 1}$ corresponding to this xed point is

A linear stability analysis shows that this xed point is stable. If > c, then there are three xed points. A bistability in the condensate oscillations occurs. The intermediate xed point is always unstable. The upper xed point is the continuation of the xed point exhibited in the case < c. It can be observed by increasing slowly and carefully the modulation frequency from a frequency below c to a frequency above c. The lower xed point is the




FIG. 3: O scillation amplitude as predicted by the theoretical model (solid lines). Here $_0=10$ and $_1=1$. Comparisons with simulations with the ODE model (crosses) with the PDE model (circles).

one that is observed when imposing without any particular precaution a modulation with frequency > c, or when perturbing the metastable upper xed point. The value of the stable xed point is

Thus the system encounters a jump in the oscillation amplitude when the modulation frequency crosses the value $_{\rm c}$. Evaluating the two expressions of $a_{\rm osc}$ just above and just below the critical frequency $_{\rm c}$, we get that the amplitude of the jump is $a_{\rm osc}(_{\rm c})$ $a_{\rm osc}(_{\rm c})$ = $\frac{1}{1}\frac{1}{1}$.




FIG. 4: BEC width versus time for a nonlinear management with frequency = 1.5. We compare the theoretical envelope of the oscillation with numerical simulations of the ODE model (picture a) and the PDE model (picture b). Here $_0 = 10$ and $_1 = 1$. For the simulation of the PDE model the initial state is the Gaussian ansatz with $a_g = 2:15$, which corresponds to the theoretical xed point in absence of nonlinear management. The solid lines represent the theoretical slow ly varying envelope a (t) = $a_g + 2a_{osc}$ jsin (!osct=2) j.

In Figure 3 we plot the values of the oscillation amplitude as a function of the frequency of the nonlinear management in the case $_0 = 10$ and $_1 = 1$. The theoretical prediction is that the modulation frequency driving the most resonant response is $_c$ ' 1:823 which is above the eigenfrequency ! = $_3$ ' 1:732. We have carried out numerical experiments with the ODE model (5) and the full PDE model (3) to check this prediction. The results for the frequency = 1:5 are plotted in Figure 4. For each frequency we can detect the amplitude of the oscillations and report on Figure 3 to compare with the theoretical predictions. We have numerically determined that the frequency driving the most important resonance is ' 1:84

which is indeed above the eigenfrequency $\frac{p}{3}$ and very close to the theoretical prediction $_{c}$. The numerical simulations con $_{m}$ the jump in the oscillation amplitude when crossing the critical frequency.

Let us estimate parameters for a realistic experiment. The magnetic trap can be taken with parameters $!_2 = 2 \cdot 10^3 \; \text{Hz}$, $!_z = 2 \cdot 10 \; \text{Hz}$, and the number of atoms of ^{85}Rb N = $5 \cdot 10^4$. For the external eld B = $159 \; \text{G}$, $a_s = 0.8 \; \text{nm}$ (repulsive gas). Then, for = $18.25 \; \text{Hz}$, we should observe large oscillations with $a_{osc} = 2.11$, while at = $15 \; \text{Hz}$ we should observe much smaller oscillations with $a_{osc} = 0.31$. Practically, if we start from the xed point a_g given by (6), we should observe oscillations of the BEC width with the maximum $a_g + 2a_{osc}$.

C. Random uctuations of the nonlinear coe cient

We assume here that the scattering length or the transverse frequency $!_{?}$ is random by varying inducing random uctuations of the nonlinear coe cient of the GP equation

where (t) is a normalized random noise with standard deviation of order 1 and $_1>0$ represents the amplitude of the random uctuations. This model also presents interest for the study of nonlinear management schemes in spatial optical solitons if the widths of the nonlinear layers in arrays of waveguides are randomly distributed [34]. We use the angleaction formalism introduced in Section IIB. In presence of perturbations, the motion of a is not purely oscillatory, because the energy and the action are slowly varying in time. We adopt the action-angle formalism, because it allows us to separate the fast scale of the locally periodic motion and the slow scale of the evolution of the action. We assume that $_1$ is smaller than $_0$ and introduce the dimensionless parameter $_1 = _1 = _0$. Thus, after rescaling t = $_1 = _0$. Thus, after

and the brackets stand for a statistical averaging with respect to the distribution of the noise . This means in particular that the probability density function of I satis es the Fokker-Planck equation $@p = Lp, p(=0;I) = (I - 1), where I_0$ is the initial value of the action at time 0. As long as the energy remains close to the the one of the ground state, we can use the asymptotic expansions (12) to expand the elective dilusion coel cient A (I). In the original time scale we then establish that the growth of the action is

In the white noise case h (0) (t)i = 2^2 (t), there exists a direct way to compute the growth of the rms amplitude. It consists in writing a closed form system for the second-order moments of the BEC width and its derivative. We expand $a = a_g + a$ and denote $b = a_t$. By considering the column vector X (t) = a_t i; a_t , we get by applying Itô's calculus that X satis es the closed-form system




FIG. 5: Rm softhe BEC width in presence of random uctuations of the nonlinear coe cient. The theoretical result [Eq. (22)] is plotted in dashed line. The results of numerical simulations of the PDE model are plotted in solid line and correspond to the averaging of 1000 dierent realizations of the random noise.

In Figure 5 we compare the statistical predictions with a set of numerical simulations of the PDE model. We have taken $_0=_1=10$. We have adopted a stepwise constant model for (t). is constant over elementary intervals with duration to and takes random values uniformly distributed between $_1$ and $_2$. IV. RESONANCES IN THE MEAN FIELD CASE DRIVEN BY A TIME-VARYING POTENTIAL TRAP

We rst focus our attention to the periodic management f (t) = $1 + f_1 \sin(t)$, and second we address random uctuations of the trap.

A. High-frequency periodic modulation of the trap

We shall rst address the case where the oscillation frequency of the trap modulation is higher than the trapping frequency, i.e. $! = \frac{p}{3}$. In such a case the in where of the modulation is negligible unless its amplitude is large. We introduce the small parameter = 1 and assume that the trap modulation amplitude is large, of order 1 . We write accordingly

and perform an asymptotic analysis! 0 following the same line as in Section IIIA. We get that the slowly varying envelope of the BEC width obeys the elective equation

The high-frequency modulation thus involves a shift of the e ective potential which in turn implies a shift of the ground state (see also [36]).

B. Resonances due slow periodic variations of the trap potential

The study is similar to the nonlinear management, and qualitatively the same conclusion holds true, especially concerning the bistable diagram. We shall only point out the main dierences. First, the strongest resonance occurs when the periodic modulation of the trap has the frequency

which is above the eigenfrequency of the BEC. Note that $_{\rm c}$ does not depend on the nonlinear coe cient $_{\rm 0}$ and is proportional to the eigenfrequency of the BEC. The oscillation amplitude of the BEC turns out to be also proportional to the BEC width. The resonant bandwidth is of order $jf_1 j^{2-3}$!. More precisely, if $<_{\rm c}$, then the oscillation amplitude of the BEC is

Evaluating the two expressions of $a_{\rm osc}$ around the critical frequency $_{\rm c}$, we get that the amplitude of the jump is $a_{\rm osc}(_{\rm c})$ $a_{\rm osc}(_{\rm c})$ = $jf_1 \stackrel{1}{j}^{=3} \stackrel{1=3}{0}$.

C. Random uctuations of the trap

We consider in this section a random modulation of the trap

This means that the BEC spreads out at the di usive rate rm s^2 (a) (t) = $_cf_1^2$ $_0^{2=3}$ t= $(2!^2)$. The doubling of the width is observed after a time of order $!^2=(_cf_1^2)$. In the case of an optical trap imposed by a laser eld whose intensity is uctuating the typical uctuations level is of the order of $_c$ 0.01. If the trap frequency $!_z=2$ 300H z, then we predict that the doubling of the width should be observed after a time of the order of a few seconds.

V. RESONANCES IN THE TONKS-GIRARDEAU REGIME

As it is shown in Ref. [25] the variety of properties of the hard-core Bose gas with repulsive interaction in the dilute regime can be described by the nonlinear Schrödinger equation with quintic nonlinearity

where V (z;t) is the time dependent trap potential. In principle it can include an anharm onic part together with the harm onic component. Below we will restrict ourselves the harm onic case V (z;t) = $m!_z^2 z^2 F$ (t)=2. The wave function is normalized to the number of atoms R j fdz = N. This equation takes correctly into account the dependence on the density of the energy of the ground state of 1D Bose gas and reproduces correctly the collective modes [11]. It was shown in [26] by means of numerical simulations for small number of atoms, that the interference elects are overestimated by this equation. It should be noted that

the nonlinear coe cient does not depend on the scattering length, i.e. the details of the interaction. A coordingly this param eter cannot be managed. Introducing $x=z=l_z$, $t^0=t!_z$, $u=\frac{p}{l_z}=2^{1-4}$, $l_z=\frac{p}{r}=\frac{m!}{r}$ we can write the equation in the dimensionless form

where we have dropped the primes and f (t) = F (t=!z). As can be expected the change in the exponent of the nonlinear term induces strong dierences between the MF regime and the TG regime. The quintic nonlinearity is especially interesting in the 1D case as it represents the critical nonlinearity for the NLS equation. Indeed, for a given dimension d, there exists a critical exponent = 2=d for the nonlinear term juj u which separates two dierent regimes [37]. These regimes are dierent in terms of global existence, blow-up, instability growth,... In the 1D case, this exponent is = 2 (quintic NLS), in the 2D case it is = 1 (cubic NLS). In the BEC framework, this leads for the repulsive gas to the parametric instability in a trapped 1D quintic system similarly to the parametric instability observed in a trapped 2D cubic system. For the attractive gas this leads to the collapse in a 1D quintic system with a number of atoms N > Nc as well as the collapse in a 2D cubic system for N > Nc.

A. Variational approach

We apply the variational approach with the Gaussian ansatz (4). We not that the equation for the phase is decoupled from the equation for the atom ic cloud width that reads

In the dimensional variables the BEC width is $L_c = [(2)^{1=4}=3^{3=8}]^p \overline{N} l_z$. Linearizing near this solution the variational equation (27), we obtain the frequency of oscillations 2! z that coincides with the hydrodynamic calculations based on the local eld approximation (see

the next section). Equation (27) belongs to so-called E m akov-Penney equations [12, 38, 39] and the solution is

 $W = c_t$ is the constant W ronskian, and (0) = a(0), $(0) = a^0(0)$, c(0) = 0, $c^0(0) = 1$. For a periodic function f, Eq. (29) is the so-called H ill equation which has been extensively studied [40]. So, in spite of the nonlinear character of Eq. (27), the resonant response of gas has a linear character and, in particular, the frequency of oscillations does not depend on the am plitude.

B. Hydrodynam ic approach

Eq. (26) can be cast in the form of Landau hydrodynamic equations by setting $u=p-\exp(i)$ [11,41]. Furtherm one we get the Thom as-Ferm isolution by neglecting the kinetic energy term with respect to the interaction term, so that the equations read

where $C = {}^2 = 2C^2 = {}^2$. Note that we have normalized the density proless that $a = {}^p - 2$ is the rms width, which is the same as for the Gaussian ansatz (4). We can thus compare the result (27) obtained with the variational approach using the Gaussian ansatz with the result (35) obtained with the hydrodynamic approach. Taking into account that the hydrodynamic approach is derived in the framework of a large number of atoms to neglect the kinetic term, we get that both approaches give the same elective equation, up to a smallmismatch in the numerical value of $C = 0.245C^2$ (variational approach) and $C = 0.203C^2$ (hydrodynamic approach). This departure originates from the fact that the two stationary proless do not coincide. Note that the stationary point is C^{1-4} , so that the difference is around 5% which is negligible in practical situations. Eventually, the BEC dynamics is found to be governed by the same elective equation according to both approaches.

C. Periodic modulations of the trap potential

The dynam ics of the H ill equation driven by a periodic m odulation f (t) = $1 + f_1 \sin(t)$ is characterized by a parametric resonance phenomenon studied in [32]. In particular the stability of the solutions to the H ill equation depends on the parameters f_1 and . The theoretical prediction is that the stationary solution a_g is unstable when the modulation frequency is close enough to the eigenfrequency of the BEC, more precisely




FIG. 6: Contour levels of the oscillation amplitude of the BEC width in TG regime in presence of periodic modulation of the trap potential $f(t) = 1 + f_1 \sin(t)$. The gray area corresponds to the congurations where a blow-up of the solution has been numerically observed.

We have performed numerical simulations of the PDE (26) to check this theoretical prediction. We have initiated the PDE with the initial condition given by the theoretically stationary Gaussian prolewith $C = 5 = \frac{p}{2}$. The initial width is then a_g '2:36. Note in Figure 6 the presence of a cone of instability in the $(f_1;)$ landscape, in full agreement with Eq. (36). We have found numerically that the dynamics is unstable if j = 2j = 0.55 if j.

Note that the equation for the oscillations of a cloud of nonineracting ferm ions in a time-dependent elongated trap has the same form as Eq. (27) (see for example [33]). As a consequence the linear parametric resonance for the width of ferm ionic cloud at the same

frequency exists. In that sense we can say that the Ferm i-Bose mapping still exists for the Tonks gas in an oscillating trap potential.

D. Random modulations of the trap potential

We exam ine in this section the elects of random modulations of the trap potential of the form f(t) = 1 + (t) where is a zero-mean stochastic process. The dynamics then exhibits stochastic resonance as shown for instance in [42, 43]. Contrarily to the periodic case, we always observe an exponential growth of the oscillations of the BEC width, unless the random modulation has a vanishing power spectral density in the vicinity of the resonant eigenfrequency 2. More precisely, we get that a periodically oscillates between the values $a_g = a_{sc}(t)$ with a_{osc} that grows exponentially as

where $_{\rm c}=\frac{R_1}{_0}$ h (0) (s)icos(2s)ds and W $_{\rm t}$ is a Brownian motion. If is a white noise h (0) (t)i= 2^2 (t), then we simply have $_{\rm c}=^2$. The long-time behavior of a is dominated by the deterministic exponential growth term exp($_{\rm c}$ t=4) with very high probability because W $_{\rm t}$ t. Note however that taking the expectation of Eq. (37) yields a different exponential growth rate

This is due to the fact that some exceptional realizations of the random uctuations may induce very strong oscillations, and these exceptional realizations actually impose the value of the expected value.

In the white noise case h (0) (t) $i = 2^2$ (t), using the same linearization procedure as in Section IIIC we can get precise expressions for the rms amplitude as long as stochastic resonance can be neglected

where !=2 is the eigenfrequency. The simplest way to take into account stochastic resonance is to multiply the previous expression by the exponential damping term $\exp(^2t=2)$. There exists a more accurate way based on Itô's calculus. A ssum e that the initial state is $a(0) = a_0$, $a^0(0) = 0$. The column vector $X = (ha^2i;habi;hb^2i)^T$ satis es the closed system

starting from $X(0) = V_0 = a_0^2;0;C=a_0^2$. As a rst application we can compute the exact expression of the largest eigenvalue of M which governs the exponential growth of the modulation ha^2i :

Note that we recover formula (38) by expanding this expression for $1: max'^2 + 0$ (6). A straightforward num erical integration of Eq. (38) gives the exact evolution of max^2 . We have performed num erical simulations of the PDE system (26) with a random modulation of the trap potential to check the predictions obtained with the variational approach. We have taken the model where (t) is stepwise constant over elementary intervals with duration max and takes random values uniformly distributed between max and 1. With max = 0.06 we then have max = 0.01. We can see that (39) exciently predicts the initial growth of the oscillation amplitude, but it is necessary to take into account stochastic resonance when the amplitude becomes larger.




FIG. 7: Rm softhe BEC width obtained from the averaging over a set of 1000 num erical simulations (solid line) and compared with the theoretical growth rate without stochastic resonance (dotted line) and with stochastic resonance (dashed line). The initial state is the Gaussian ansatz with $C = 5 = \frac{p}{2}$ and $a(0) = a_0 = 2:36$.

VI. CONCLUSION

In this work we have considered the resonances in collective oscillations of 1D Bose gas under time-dependent variations of the trap potential and the elective nonlinearity. Two regim es have been studied - the mean eld regim e and the Tonks-Girardeau regim e. The analysis shows that in the mean eld regime the resonances are nonlinear and bistability exists in the vicinity of a critical frequency which is signi cantly above the eigenfrequency of the BEC. The dynamics is then characterized by stable oscillations with large amplitudes which depend on the frequency detuning between the frequency of the breathing mode and the modulation frequency. This type of dynamics is also predicted for the modulations of the trap as well as for the modulations of the atom ic scattering length. In the Tonks-G irandeau regime the theory based on the nonlinear Schrodinger equation with quintic nonlinearity predicts the linear param etric resonance in the gas oscillations. The e ect re ects the Bose-Ferm im ap existing for the Bose gas in this regim e [11]. We also study the oscillations under random variations of the trap potential and e ective nonlinearity. The analysis shows that the dynamics is nonlinear in the mean eld regime. In the Tonks-Girardeau regime the study predicts stochastic param etric resonance. We also investigate the dynamics of 1D Bose gas in the mean eld regime under rapid and strong modulations of the atom ic scattering length. This problem has recently attracted a great attention since the dynamically stable nonlinearity managed atom ic matter solitons can be generated. We not the analytical expressions for the stationary value of the width and frequency of the slow secondary oscillations of the width. All theoretical predictions turn out to be well supported by direct numerical simulations of the 1D GP equation and the quintic nonlinear Schrodinger equation.
