Study of the tem perature dependence of single-particle and pair coherent condensate densities for a Bose liquid with a "depleted" single-particle Bose-Einstein condensate (BEC) at T & 0

#### A bstract

We study the temperature dependence of single-particle and pair coherent condensate densities for a Bose liquid with a "depleted" single-particle Bose-E instein condensate (BEC) at T  $\in$  0. Our investigations were based on the eld-theoretical Green's functions. On the basis of the use of empirical data about the speeds of the rst and second sounds is described super uid state at T  $\in$  0: It is studied the structure of super uid state taking into account appearance with the dierent from zero temperatures of normal component and taking into account the branch of the second sound, whose speed approaches zero at T ! T . The bare interaction between bosons was chosen in the form of a repulsive A zis potential, the Fourier component of which was an oscillatory and sign-varying function of the momentum. The obtained temperature dependence of single-particle and pair coherent condensate and total densities has a good agreement with experiment data.

# 1 Introduction

Despite the big progress achieved in the theory of super uidity since the pioneer works by Landau [1], Bogolyubov [2], Feynman [3] and others [4]-[22], the task of constructing a microscopic theory of a super uid (SF) state of a <sup>4</sup>He Bose liquid cannot be considered complete. Analysis of experimental and theoretical activities concerning with unique super uidity phenomena investigation has one conclude that microscopic theory of super uidity is still incomplete. There are some unsolved contradictions between theory and experiment as concerned with super uid liquid hydrodynamics as with structure of quasiparticle spectrum. These contradictions reduce to the question of quantum -mechanical structure of super uid <sup>4</sup>He component below the -point. This question is crucial in creation of consistent microscopic super uid theory of Bose liquid both for the case of zero temperature and for the case of dierent from zero temperatures.

In works [23], [24] one introduces at T=0 the microscopic model of the SF state of a Bose liquid with a single-particle Bose-Einstein condensate (BEC) suppressed because of interaction, based upon a renormalized eld perturbation theory with combined variables [11]{ [14], allows one to obtain a self-consistent \short" system of nonlinear integral equations for the self-energy parts  $\tilde{a}_{ij}$  (p; ), by means of truncating the in nite series in the small density of the BEC ( $n_i=n_i=1$ ). By the same token, one can work out a self-consistent microscopic theory of a super uid Bose liquid and performan ab initio calculation of the spectrum of elementary excitations E (p), starting from realistic models of pair interaction potential U (r):

In this work we will study of the super uid state structure of Bose-liquid  $^4\text{H}\,\text{e}$  under nonzero tem perature (0 < T < T ): The same task was consider in work [25] on the basic of Chester [26] IBG wave function  $_{\text{IB}\,\text{G}}$  by Jastrow factors F =  $f_{ij}$ . We use the microscopic model proposed in [27] for the super uid Bose liquid with a "depleted" BEC. The small parameter of these model is the ratio of the density of the BEC to the total density Bose liquid  $_{0}$ =  $_{\text{S}}$  1 in contrast to the Bogolyubov theory [2] for a almost ideal Bose gas, where the small parameter is the ratio of the number of overcondensate excitations to the number of particles in the intense BEC (n  $_{\text{N}}$ )= $_{\text{N}}$ =0 1:

Such approach is based on the analysis of the num erous precise experim ental data on neutron inelastic scattering [22], [28] [30] and to results in quantum evaporation of <sup>4</sup>He atoms [31], according to which the maximal density  $_0$  of the single-particle BEC in the  $^4\mathrm{HeBose}$  liquid even at T does not exceed 10% of the total density of liquid <sup>4</sup>He, whereas very low tem peratures T the density of the SF component s! at T! 0 [10]. Such a low density of the BEC is implied by strong interaction between  $^4$ H e atoms and is an indication of the fact that the quantum structure of the part of the SF condensate in He II carrying the \excess" density (  $_{\rm S}$ calls for a more thorough investigation. So, in this case the density of the super uid component  $_{\rm S}$  is determ ined by the quantity of the renorm alized anom alous self-energy parts  $^{\sim}_{12}$  (0;0), which is a superposition of the "depleted" single-particle BEC and the intense "Cooper" pair coherent condensate (PCC), with coincident phases (sings) of the corresponding order parameters. Such a PCC em erges due to an e ective attraction between bosons in som e regions of momentum space, which results from an oscillating sign-changing momentum dependence of the Fourier component V (p) of the interaction potentials U (r) with the in ection points in the radial dependence.

The system of Dyson-Belyaev equations [5], which describe the super uid (SF) state of a Bose liquid with strong interaction between bosons and a weak single-particle Bose-E instein condensate (BEC) and which allows one to express the normal  $G_{11}$  and anomalous  $G_{12}$  renormalized single-particle boson G reen functions in terms of the respective self-energy parts  $\tilde{a}_{11}$  and  $\tilde{a}_{12}$ , has the next analytic form of [27]:

where V (p) is the Fourier component of the bare potential of the pair interaction of the bosons; V (p; ) is the renormalized (screened) pair interaction between bosons because of many-particle collective e ects; (p; ) is the boson's polarization operator which describe many-particle correlation e ects V

where (p;  $\chi$ ;!) is the vertex part (three-pole) describing many-particles correlations of the local eld's type; (p; ) = (p; ;0;0) = (0;0;p; ) is the vertex part with zero values of input momentum and energy; and  $n_0$  is the number particles in BEC,  $n_1 = n$   $n_0$  is the number of overcondensate particles ( $n_1$   $n_0$ ); which is determined by the condition of the total particle number conservation:

Take into account the residues at the poles of single-particle G reen functions  $G_{ij}(p;)$ , neglecting the contributions of eventual poles of the functions p; k; l and p; l, which do not coincide with the poles of  $G_{ij}(p;)$ , the functions  $C_{ij}(p;)$  on the \mass shell l = E (p) assume the following form (at l = 0):

The quasiparticle spectrum corresponding to the poles of Green's function is determined in general, with allowance for relations (1,2), by the next expression

# 2 The structure of the super uid Bose liquid state at T $\pm$ 0

The main purpose of our research is the investigation of super uid helium condensate structure by means of nding temperature dependence of single-particle and pair coherent condensate densities under assumption that super uid component is a superposition of a weak single-particle BEC and an intensive PCC.

Let's consider the super uid bose liquid state at T  $\in$  0 when there are super uid component density  $_{\rm S}$  (T) and normal component density  $_{\rm R}$  (T) simultaneously. As it was shown in [13, 14] the expression for the renormalized G reen's function  $G_{\rm ij}$  (p) is constructed with help of combined variables:

In the long-wavelength region  $f(j) < k_0$  (where k is some characteristic momentum) this variables are just the hydrodynamics variables  $L_L$  (x) in the spirit of Landau quantum hydrodynamics [1], and in the short-wavelength region  $f(j) > k_0$  they coincide with the usual eld operators  $L_L$  (x):

Such an approach means that the separation of the Bose system into a macroscopic coherent condensate and a gas of supracondensate excitations is made not on the statistical level, like in the case of a weakly nonideal Bose gas [2], but on the level of ab initio eld operators, which are used to construct a microscopic theory of the Bose liquid.

In the region of small p & 0 at T! OG reen's functions have the form

where g (p) are the "hydrodynam ics" G reen's functions, which are associated with the long-wavelength uctuations of the phase and density of the condensate ( = '). The expressions for  $g_7$ , (p);  $g_7$ , (p) was calculated in [12] for  $g_7$ , 0. It contains sum s of two pole terms, corresponding to rst and second sound with velocities  $g_7$  and  $g_7$  in the Bose liquid with the normal and super uid components:

where =  $_n$  +  $_s$  is the total density of the liquid, and the coe cients a ;d and b are independent of T at low temperatures. This result establishes a unique correspondence between the microscopic eld theory of super uidity [5, 7] and the macroscopic two-uid hydrodynamics [8, 10].

It follows from Eqs. (14), (15) and (17) that the pole parts of the renormalized G reen's functions  $G_{ij}$  can be represented in the form

We henceforth assume that expression (18) is valid in the entire temperature interval T < T. It follows from Eqs. (18) that for T : 0, where n : 0, the leading contribution to the integral

over energy in (3) comes from the rst-sound pole = gk of the G reen's functions. However, at higher tem peratures T > 1K, where gk, the main part, because of the strong inequality gk gk, is played by the low-energy pole = gk which corresponds to second sound.

At nite temperatures (T  $\stackrel{\leftarrow}{\bullet}$  0), after taking into account the contributions of the rst and second poles of the G reen's functions (18), we obtain for the self-energy parts in = 1.5 approximation

It should be emphasized that the long-wavelength approximation for the G reen's functions (18) in this case are valid because of the divergence of the temperature factor  $\coth(c_2q=2T)$  at q! 0 and the rather rapid decay of the interaction kernel (q! 1). Moreover, the system of equations (19) does not need to be matched with the expression for the renormalized quasi-particle spectrum E (k), as it is ordinarily done in microscopic eld theory for T! 0. It's true because the substitution of the empirical spectra of the rst and second sound (with the experimental values of the velocities  $c_1$  and  $c_2$ ) into the expressions for the G reen's functions  $G_{ij}$  (p) corresponds to automatically taking all the necessary renormalizations into account.

U sing (19), one can determ ine the super uid order param eter for T  $\odot$  0:

Since under T=0 the density of the super uid component  $_{\rm s}$  coincides with the total mass density of the Bose liquid = mn and is proportionate to  $_{12}$  (0;0) (it plays a part of super uid order parameter) we can write the following expression

where  $_0$  = m  $n_0$  is the density of the single-particle BEC and  $_{\rm S}$  is the density of "Cooper" PCC. On the other hand, the temperature dependence of BEC density  $_0$  (T) = m  $n_0$  (T) is due to entire particle number conservation condition (5) will be determined the following expression

Thus the "Cooper" PCC density at T=0 in our model can be found in two independent ways. We can not it directly with help of expression (26) or we can subtract (27) from (28) and then not result at T=0: Thus we can verify the self-consistency of the proposed model via comparison the results of independent calculations of the PCC density of super uid component for the zero temperature.

# 3 The iterative scheme of calculation and results

In order to calculate the tem perature dependence of single-particle and pair coherent condensate densities within the model of a Bose liquid with a suppressed BEC considered, at rst, we have to nd the Fourier component of the bare potential of the pair interaction of the bosons and then, to nd the renormalized (screened) pair interaction between bosons, which is determined (4), so we must to calculate the boson polarization operator (5).

The pair interaction between bosons was chosen in the form of a regularized repulsive potential in the the Aziz potential [32, 33]:

where A = 1.8443101  $10^6$  K, = 10.43329537 A  $^1$ , = 2.27965105 A  $^2$ ,  $c_6$  = 1.36745214 K A  $^6$ ,  $c_8$  = 0.42123807 K A  $^8$ ,  $c_{10}$  = 0.17473318 K A  $^{10}$ . Such potential remain nite at r = 0 due to the nonanalytic exponential dependence on r, which suppresses any power divergence at r! 0: It has the Fourier component V (p); which is an oscillatory and sign-varying function of the momentum p as a result of the "excluded volume" e ect and the quantum di raction of the particles on one another.

Then, in order to calculate the polarization operator, using Eqs. (7) and (8), a numerical calculation in the rst approximation of the functions  $_1$  (p)  $_{11}$  (p;E $_0$  (p)) and  $_1$  (p)  $_{12}$  (p;E $_0$  (p)), was conducted. For the zeroth approximation, the \screened" potential (4) were taken:

at some constant negative value of  $_0$ . Then, using the functions  $_1$  (p) and  $_1$  (p) obtained, the rst approximation for the polarization operator  $_1$  (p) was calculated, using Eqs. (14) { (16), (18) at  $_1$  = 1. The limiting value  $_1$  (0) was compared with the exact thermodynamic value of the polarization operator of the  $^4$ HeBose liquid at p = 0 and ! = 0, which determines the compressibility of the Bose system [13]:  $_1$  (0;0) =  $_1$   $_2$  :

The absolute value j (0;0) j turned out to be almost 1.5 times greater than the calculated value j  $_1$  (0) j. This provides for an estimate of the vertex at p=0 in the rst approximation as

 $_1$   $_1$   $_1$  1.5. The second approximation  $_2$  (p) and  $_2$  (p) was obtained from Eqs. (7), (8) with the constant value  $_1$   $_1$  and the rst approximation for the renormalized pseudopotential, Eq. (4):

Such an iterative procedure was repeated four to six times and used to improve precision in the calculation of the polarization operator. At each stage, equations (9) and (11) were used to reproduce the quasiparticle spectrum E (p), and the rate of convergence of the iterations was watched, as well as the degree of proximity of E (p) to the empirical spectrum  $E_{\rm exp}$  (p). The thing parameter in these calculations was the amplitude  $V_0$  of the seed potential (29) at the value of  $a=2.44~{\rm A}$ , which is equal to twice the quantum radius of the  $^4{\rm He}$  atom. The BEC density, in accordance with the experimental data [28] [31], was xed at  $n_0=9\%$  n=1.95 1.9

For the numerical computation of temperature dependencies of single-particle and pair coherent condensate density we have to take into account that the rst (hydrodynamics) sound velocity is practically independent of T and in the given approximation can be determined as  $c_1 = \nabla$  (0)n=m (here m is the elective mass of quasiparticles), whereas the velocity of second sound  $c_2$  is substantially T-dependent, varying from  $c_2$  (0) =  $c_1$ =  $\frac{p}{3}$  at T = 0 to a value  $c_2$  (T) '20m/s in the region T > 1K [8]. At T! T the velocity  $c_2$ ! 0. Thus as the point is approached the main part, owing to the strong inequality  $c_1$   $c_2$ , begins to be played by the last terms in the integrands in (21), (27), which are proportional to B<sub>12</sub> and B<sub>11</sub> and contain the temperature factor

which diverges quadratically as q! 0. At the same time the width of the singular peak increases rapidly with increasing T and decreasing  $c_2$ . (the momentum dependence of temperature factor, obtained for dierent temperatures, is depicted in g.1). As a result, with increasing T there is an increase of the contribution to the integral (21) from the repulsive part of the potential V(q) > 0 in the long-wavelength region q < = a and a decrease of the function  $v_0(T)$ . The function  $v_0(T)$  plays a part of the super uid order parameter and is positive at low  $v_0(T)$  quadratical temperature  $v_0(T)$  attraction  $v_0(T)$  goes to zero and then becomes negative (for  $v_0(T)$ ), that corresponds to destruction of the super uid state  $v_0(T)$ , i.e.  $v_0(T)$  coincides with the point.

In a sim ilarway with increasing T, there is increase of the negative contribution to the integral (27) and decrease of  $_0$  (T) until at a certain point T =  $T_0$  the density of the BEC vanishes and form ally becomes negative for T >  $T_0$ .

The results of the num erical calculations of the temperature dependence of the densities of single-particle and paired parts of super uid density in the range of temperatures from zero to the point of lambda-transition, are depicted on g2.

# 4 Conclusions

Thus, on the basis of the use of empirical data about the speeds of the rst and second sounds in this work is described super uid state at T  $\leftarrow$  0: It is studied the structure of super uid state taking into account appearance with the dierent from zero temperatures of normal component and taking into account the branch of the second sound, whose speed approaches zero at T! T. We obtained the analytic expression (27, 28) for computation of and second densities, and constructed and realized the numerical scheme for computation of the temperature dependence of single-particle and pair coherent condensate densities. The temperature dependence of the densities of single-particle condensate and total density of super uid component are obtained on the basis of the microscopic model of super uid state of Bose-liquid with the depressed single-particle BEC in the range from T = 0 to temperatures close to the environment of point of transition.

Note also that the self-consistency of this model is corroborated by the fact that the theoretical value of total particle density calculated from Eq. (6),  $n_{\rm th}=2.1$  1% cm  $^3$ , is quite close to the experimental value of the density of particles in liquid  $^4{\rm He}$ , n=2.17 1% cm  $^3$  (at  $n_0=9\%$  n). On the other hand, the density  $n_1$  of supracondensate particles, calculated from Eqs. (26) at T=0 at the values of the parameters indicated, is about 0.93 n, which is also in good accordance with experiment, taking into account that the BEC density is determined up to  $0.01\,\rm n$ .

It goes without saying, the given results, which correspond to the approximation of self-consistent eld, cannot be used directly near the -point, where them odynamic uctuations play the key role. But the dependences, depicted in g2, qualitatively correctly describe the temperature dependence of the density of super uid component.




Fig. 1.The m om entum dependence of the tem perature factor (32), obtained for di erent tem - peratures.




Fig. 2. The tem perature dependence of the density of BEC (lower curve) and total density of super uid component (upper curve), obtained according (27) and (28) for next parameters  $A_{11}=6:14K$ ;  $D_{11}=2:03K$ ;  $B_{11}=0:00018K$ ;  $A_{12}=6:21K$ ;  $D_{12}=3:12K$ ;  $B_{12}=0:00225K$ . The empirical temperature dependence of of super uid component [8] (circles).
