W e study by extensive M onte C arlo (M C) simulations and analytical G reen function (G F) m ethod e ects of flustrated surfaces on the properties of thin lm sm ade of stacked triangular layers of atom s bearing H eisenberg spins with an Ising-like interaction anisotropy. W e suppose that the in-plane surface interaction J_s can be antiferrom agnetic or ferrom agnetic while all other interactions are ferrom agnetic. W e show that the ground-state spin con guration is non linear when J_s is lower than a critical value J_s^c . The lm surfaces are then flustrated. In the flustrated case, there are two phase transitions related to disorderings of surface and interior layers. There is a good agreem ent between M C and G F results. In addition, we show from M C histogram calculation that the value of the ratio of critical exponents = of the observed transitions is deviated from the values of two and three Ising universality classes. The origin of this deviation is discussed with general physical argum ents.

I. IN TRODUCTION

This paper deals with the e ect of the fustration in m agnetic thin lms. The fustration is known to cause spectacular e ects in various bulk spin systems. Its effects have been extensively studied during the last decade theoretically, experimentally and numerically. Frustrated m odel systems serve not only as testing ground for theories and approximations, but also to compare with experiments.¹

On the other hand, surface physics and systems of nanoscales have been also enorm ously studied during the last twenty years. This is due in particular to applications in magnetic recording, let alone fundamental theoretical interests. M uch is understood theoretically and experimentally in thin $\ln s$ where surfaces are 'clean' i.e. no impurities, no steps etc.^{2,3,4,5,6,7} Less is known at least theoretically on complicated thin $\ln s$ with special surface conditions such as defects^{8,9}, arrays of dots and m agnetization reversal phenomenon.^{10,11,12,13,14,15,16}

In this paper we study the frustration e ect on properties of thin Im s m ade of stacked triangular lattices. In-plane interaction of the surfaces is antiferrom agnetic and that of interior layers is ferrom agnetic. The Im surfaces are frustrated.

The paper is organized as follows. Section II is devoted to the description of our model. The ground state in the case of classical spins is determined as a function of the surface interaction. In section III, we consider the case of quantum spins and we apply the G reen function technique to determ ine the layer magnetizations and the transition temperature as a function of the surface interaction. The classical ground state determ ined in section II is used here as starting (input) con guration for quantum spins. We are interested here in the e ect of magnetic frustration on magnetic properties of thin lms. A phase diagram is established showing interesting surface behaviors. Results from M onte C arlo simulations for classical spins are shown in section IV and compared to those obtained by the G reen function method. We also calculate by M onte C arlo histogram technique the critical behavior of the phase transition observed here. C oncluding remarks are given in Section V.

II. MODEL

It is known that m any well-established theories failed to deal with frustrated spin system s.¹ Am ong known striking e ects due to frustration, let usmention the high ground-state (GS) degeneracy associated often with new symmetries which give rise sometimes to new kinds of phase transition. One of the systems which are most studied is the antiferrom agnetic triangular lattice. Due to its geometry, the spins are frustrated under nearestneighbor (NN) antiferrom agnetic interaction. In the case of H eisenberg m odel, the frustration results in a 120 GS structure: the NN spins form a 120 angle alternately in the clockw ise and counter-clockw ise senses which are called left and right chiralities.

A. Ham iltonian

In this paper we consider a thin $\lim m$ ade up by stacking N_z planes of triangular lattice of L L lattice sites. The H am iltonian is given by

where S_i is the H eisenberg spin at the lattice site i, $P_{hi;ji}$ indicates the sum over the NN spin pairs S_i and S_j . The

last term, which will be taken to be very small, is needed to make the lm with a nite thickness to have a phase transition at a nite temperature in the case where all exchange interactions $J_{i;j}$ are ferrom agnetic. This guarantees the existence of a phase transition at nite temperature, since it is known that a strictly two-dimensional system with an isotropic non-Ising spin model (XY or H eisenberg model) does not have long-range ordering at nite temperature¹⁷

Interaction between two NN surface spins is equal to J_s . Interaction between layers and interaction between NN in interior layers are supposed to be ferrom agnetic and allequal to J = 1 for simplicity. The two surfaces of

the ~lm are frustrated if J is antiferrom agnetic (J $_{\rm s}$ < 0) .

In this paragraph, we suppose that the spins are classical. The classical ground state (G S) can be easily determined as shown below. Note that for antiferrom agnetic system s, even for bulk materials, the quantum G S cannot be exactly determined. The classical Neel state is often used as starting con guration for quantum spins. We will follow the same line hereafter.

For $J_s > 0$ (ferrom agnetic interaction), the m agnetic G S is ferrom agnetic. However, when J_s is negative the surface spins are frustrated. Therefore, there is a competition between the non collinear surface ordering and the ferrom agnetic ordering due to the ferrom agnetic interaction from the spins of the beneath layer.




FIG.1: Non collinear surface spin con guration. Angles between spins on layer 1 are all equal (noted), while angles between vertical spins are $\$.

We rst determ ine the GS con guration for I = J =0:1 by using the steepest descent m ethod : starting from a random spin con guration, we calculate the magnetic local eld at each site and align the spin of the site in its local eld. In doing so for all spins and repeat until the convergence is reached, we obtain in general the GS con guration, without m etastable states in the present m odel. The result shows that when J_{s} is sm aller than a critical value J_s^c the magnetic GS is obtained from the planar 120 spin structure, supposed to be in the X Y plane, by pulling them out of the spin X Y plane by an angle. The three spins on a triangle on the surface form thus an 'um brella' with an angle between them and an angle between a surface spin and its beneath neighbor (see Fig. 1). This non planar structure is due to the interaction of the spins on the beneath layer, just like an external applied eld in the z direction. O f course, when J_s is larger than J_s^c one has the collinear ferrom agnetic GS as expected: the frustration is not strong enough to resist the ferrom agnetic interaction from the beneath layer.

W e show in Fig. $2\cos()$ and $\cos()$ as functions of J_s . The critical value J_s^c is found between -0.18 and -0.19. This value can be calculated analytically by assuming the 'um brella structure'. For GS analysis, it su ces to consider just a cell shown in Fig.1. This is justi ed by the num erical determ ination discussed above. Further-




FIG.2: cos() (diamonds) and cos() (crosses) as functions of $J_{\rm s}$. Critical value of $J_{\rm s}^{\rm c}$ is shown by the arrow .

more, we consider as a single solution all congurations obtained from each other by any global spin rotation.

Let us consider the fullH am iltonian (1). For simplicity, the interaction inside the surface layer is set equal J_s (1 J 1) and all others are set equal to J > 0. A lso, we suppose that $I_{i;j} = I_s$ for spins on the surfaces with the same sign as J_s and all other $I_{i;j}$ are equal to I > 0 for the inside spins including interaction between a surface spin and the spin on the beneath layer.

The spins are numbered as in Fig. 1: S_1 , S_2 and S_3 are the spins in the surface layer (rst layer), S_1^0 , S_2^0 and S_3^0 are the spins in the internal layer (second layer). The H am iltonian for the cell is written as

Let us decompose each spin into two components: an xy component, which is a vector, and a z component $S_i = (S_i^k; S_i^z)$. Only surface spins have xy vector components. The angle between these xy components of NN

surface spins is $_{i,j}$ which is chosen by ($_{i,j}$ is in fact the projection of de ned above on the xy plane)

For given values of I_s and I, we see that the solution (6) exists for J_s J_s^c where the critical value J_s^c is determined by 1 cos 1. For $I = {}_s I = 0.1$, J_s^c 0.1889J in excellent agreement with the num erical result.

The classical GS determ ined here will be used as input GS con guration for quantum spins considered in the next section.

III. GREEN FUNCTION METHOD

Let us consider the quantum spin case. For a given value of J_s , we shall use the G reen function method to calculate the layer magnetizations as functions of tem - perature. The details of the method in the case of non collinear spin con guration have been given in Ref.⁸. We brie y recall it here and show the application to the present model.

A. Form alism

We can rewrite the full Hamiltonian (1) in the local framework of the classical GS conguration as

where $\cos(i_{j})$ is the angle between two NN spins determined classically in the previous section.

We neglect higher order correlations by using the Tyablikov decoupling schem e^{20} which is known to be valid for exchange term s^{21} . Then, we introduce the Fourier transform s

where ! is the spin-wave frequency, k_{xy} denotes the wavevector parallel to xy planes, R_i is the position of the spin at the site i, n and n⁰ are respectively the index of the layers where the sites i and j belong to. The integral over k_{xy} is performed in the rst B rillouin zone whose surface is in the xy reciprocal plane.

The Fourier transform softhe retarded G reen functions satisfy a set of equations rew ritten under a matrix form

Here, for compactness we have used the following notations:

i) J_n and I_n are the in-plane interactions. In the present model J_n is equal to J_s for the two surface layers and equal to J for the interior layers. All I_n are set to be I.

ii) $J_{n,n-1}$ and $I_{n,n-1}$ are the interactions between a spin in the nth layer and its neighbor in the $(n \ 1)^{th}$ layer. Of course, $J_{n,n-1} = I_{n,n-1} = 0$ if n = 1, $J_{n,n+1} = I_{n,n+1} = 0$ if $n = N_z$.

Solving det M j= 0, we obtain the spin-wave spectrum ! of the present system . The solution for the G reen function $g_{n,n}$ is given by

In the following we shall use the case of spin one-half. Note that for the case of general S, the expression for $hS_i^{\,z}\,i$ is more complicated since it involves higher quantities such as $(S_i^{\,z}\,)^2$.

U sing the G reen function presented above, we can calculate self-consistently various physical quantities as functions of temperature T. The rst important quantity is the temperature dependence of the angle between each spin pair. This can be calculated in a self-consistent m anner at any temperature by m inimizing the free energy at each temperature to get the correct value of the angle as it has been done for a frustrated bulk spin system s.²³ In this paper, we limit ourselves to the self-consistent calculation of the layer m agnetizations which allows us to establish the phase diagram as seen in the follow ing.

For num erical calculation, we used I=0:1J with J=1. For positive J_s , we take $I_s=0:1$ and for negative J_s , we use $I_s=0:1$. A size of 80^2 points in the $\,$ rst B rillouin zone is used for num erical integration. We start the self-consistent calculation from T=0 with a small step for tem perature 5 $\,10^{\,3}$ or $10^{\,1}\,$ (in units of $J=k_B$). The convergence precision has been $\,$ xed at the fourth gure of the values obtained for the layerm agnetizations.

B. Phase transition and phase diagram of the quantum case




FIG.3: First two layer magnetizations obtained by the G reen function technique vs. T for $J_{\rm s}=0.5$ with I = $~I_{\rm s}=0.1$. The surface-layer magnetization (low er curve) is much sm aller than the second-layer one. See text for comments.

We rst show an example where J = 0.5 in Fig.3. As seen, the surface-layer magnetization is much smaller than the second-layer one. In addition there is a strong spin contraction at T = 0 for the surface layer. This is due to the antiferrom agnetic nature of the in-plane surface interaction J_s . One sees that the surface becomes disordered at a temperature T_1 ' 0.2557 while the second layer remains ordered up to T_2 ' 1.522. Therefore,

the system is partially disordered for temperatures between T_1 and T_2 . This result is very interesting because it con ms again the existence of the partial disorder in quantum spin system s observed earlier in bulk fustrated quantum spin system s.^{18,23} Note that between T_1 and T_2 , the ordering of the second layer acts as an external

eld on the rst layer, inducing therefore a sm all value of its m agnetization. A further evidence of the existence of the surface transition will be provided with the surface susceptibility in the M C results shown below.




FIG .4: First two layer-m agnetizations obtained by the G reen function technique vs. T for $J_{\rm s}$ = 0.5 with I = $I_{\rm s}$ = 0.1.

Figure 4 shows the non frustrated case where $J_s = 0.5$, with $I = I_s = 0.1$. As seen, the rst-layer magnetization is smaller than the second-layer one. There is only one transition temperature. Note the diculty for numerical convergency when the magnetizations come close to zero.




FIG.5: Phase diagram in the space $(J_s;T)$ for the quantum H eisenberg m odel with N_z = 4, I = $jI_s j$ = 0:1. See text for the description of phases I to III.

We show in Fig. 5 the phase diagram in the space $(J_s;T)$. Phase I denotes the ordered phase with surface non collinear spin con guration, phase II indicates the collinear ordered state, and phase III is the param agnetic phase. Note that the surface transition does not exist for $J_s = J_s^c$.

IV. MONTE CARLO RESULTS

It is known that methods for quantum spins, such as spin-wave theory or Green function method presented above, su er at high tem peratures. Spin-wave theory, even with magnon-magnon interactions taken into account, cannot go to temperatures close to T_c . Green function m ethod on the other hand can go up to ${\rm T_c}$ but due to the decoupling scheme, it cannot give correct critical behavior at T_c. Fortunately, we know that quantum spin system s behave as their classical counterparts at high T. So, to see if the phase diagram obtained in the previous section for the quantum model is precise or not, we can consider its classical version and use M C simulations to obtain the phase diagram for comparison. M C simulations are excellent means to overcom e approxim ations used in analytic calculations for the high T region as discussed above.

In this paragraph, we show the results obtained by M C simulations with the H am iltonian (1) but the spins are the classical H eisenberg m odel of m agnitude S = 1.

The lm sizes are L L Nwhere N_z = 4 is the num – ber of layers (lm thickness) taken as in the quantum case presented above. We use here L = 24;36;48;60 to study nite-size e ects as shown below. Periodic boundary conditions are used in the X Y planes. The equilibrating time is about 10^6 MC steps per spin and the averaging time is 2 10^6 MC steps per spin. J = 1 is taken as unit of energy in the following.




FIG.6: M agnetizations of layer 1 (circles) and layer 2 (diam onds) versus temperature T in unit of $J=k_B$ for $J_s = 0.5$ with I = I_s = 0.1, L = 36.

Let us show in Fig. 6 the layer magnetization of the rst two layers as a function of T , in the case $J_{z} = 0.5$ with N $_{z} = 4$ (the third and fourth layers are symmetric). Though we observe a smaller magnetization for the surface layer, there is clearly no surface transition just as in the quantum case.




FIG. 7: M agnetizations of layer 1 (circles) and layer 2 (diamonds) versus temperature T in unit of $J=k_B$ for $J_s = 0.5$ with $I = I_s = 0.1, L = 36$.

In Fig. 7 we show a frustrated case where $J_s = 0.5$. The surface layer in this case becomes disordered at a temperature much lower than that for the second layer. Note that the surface magnetization is not saturated to 1 at T = 0. This is because the surface spins make an

angle with the z axis so their z component is less than 1 in the GS.




FIG.8: Susceptibilities of layer 1 (circles) and layer 2 (diamonds) versus temperature T in unit of $J=k_B$ for $J_s = 0.5$ with $I = I_s = 0.1$, L = 36.




FIG.9: Susceptibility of layer 1 (circles) and layer 2 (diamonds) versus temperature T in unit of $J=k_B$ for $J_s = 0.5$ with I = $I_s = 0.1$, L = 36. Note that for clarity, the susceptibility of the layer 2 has been multiplied by a factor 5.

Figures 8 shows the susceptibilities of the rst and second layers in the case where $J_s = 0.5$ with $I = I_s = 0.1$ where one observes the peaks at the same temperature indicating a single transition in contrast to the frustrated case shown in Fig. 9. These results con rm the above results of layer magnetizations.




FIG.10: Phase diagram in the space $(J_s;T)$ for the classical H eisenberg m odel with N $_z = 4$, I = $jI_s j= 0.1$. Phases I to III have the same m eanings as those in Fig. 5.

To establish the phase diagram, the transition tem peratures are taken at the change of curvature of the layer m agnetizations, i.e. at the maxim a of layer susceptibilities shown before. Figure 10 shows the phase diagram obtained in the space $(J_s;T)$. Interesting enough, this phase diagram resembles remarkably to that obtained for the quantum counterpart model shown in Fig. 5.

Let us study the nite size e ect of the phase transitions shown in Fig. 10. To this end we use the histogram technique which has been proved so far to be excellent for the calculation of critical exponents.^{24,25,26} The principle is as follows. Using the M etropolis algorithm to determ ine approximately the critical temperature region, then choosing a temperature T_0 as close as possible to the presupposed transition temperature. We then make a very long run at T_0 to establish an energy histogram. From

form ulae established using the statistical canonical distribution, we can calculate physical quantities in a continuous manner for tem peratures around T_0 .^{24,25,26} W e do not have problem to identify the transition tem perature as well as the maximal values of uctuation quantities such as speci c heat and susceptibility.




FIG.11: Susceptibility versus T for L = 36;48;60 with $J_{\rm s}$ = 0.5 and I = $I_{\rm s}$ = 0.1.

Figure 11 shows the susceptibility versus T for L = 36;48;60 in the case of $J_s = 0.5$. For presentation convenience, the size L = 24 has been removed since the peak for this case is rather at in the scale of the gure. How - ever, it shall be used to calculate the critical exponent

for the transition. As seen, the maximum ^{max} of the susceptibility increases with increasing L.




FIG. 12: Transition tem perature versus L with $J_s = 0.5$ and $I = I_s = 0.1$. The inset shows the enlarged scale.

For completeness, we show in Fig. 12 the transition temperature as a function of L. A rough extrapolation to in nity gives T_1^1 ' 1.86 0.02.




FIG.13: Layer susceptibilities versus T for L = 36;48;60 with $J_s = 0.5 \text{ and } I = I_s = 0.1$. Left (right) gure corresponds to the rst (second) layer susceptibility.

In the frustrated case, i.e. $J_s < J_s^c$, we perform the same calculation for nite-size e ect. Note that in this case there are two phase transitions. We show in Fig. 13 the layer susceptibilities as functions of T for di erent L. A s seen, both surface and second-layer transitions have a strong size dependence.




FIG.14: Transition temperature versus L for the surface layer in the case $J_s = 0.5$ with $I = I_s = 0.1$. The inset shows the enlarged scale.




FIG.15: Transition temperature versus L for the second layer in the case $J_s = 0.5$ with $I = I_s = 0.1$. The inset shows the enlarged scale.

We show in Fig. 14 and 15 the size dependence of the transition temperatures T_1 (surface transition) and T_2 (second-layer transition).

The size dependence of the maxim a observed above allows us to estimate the ratio = . We show now \ln^{max} as a function of $\ln L$ for the dimensional error cases studied above. Figure 16(a) and (b) correspond respectively to the transitions of surface and second layer occurring in the frustrated case with $J_s = 0.5$, while Figure 16(c) corre-

sponds to the unique transition occurring in the non frustrated case with $J_s = 0.5$. The slopes of these straight lines give = ' 1.864 0.034 (a), 1.878 0.027 (b), 1.801 0.027 (c). The errors were estimated from the




FIG.16: Maximum of surface-layer susceptibility versus L for L = 24;36;48;60 with $J_s = 0.5$ (a,b), $J_s = 0.5$ (c) and I = $j_s j = 0.1$, in the ln ln scale. The slope gives = indicated in the gure for each case. See text for comments.

m ean least-square tting and errors on the peak values obtained with di erent values of T_0 (multihistogram technique). W ithin errors, the rst two values, which correspond to the frustrated case, can be considered as identical, while the last one corresponding to the non frustrated case is di erent. W e will return to this point later.

At this stage, we would like to emphasize the following points. First, we observe that these values of = are found to be between those of the two-dimensional (2D) Ising model (= = 1:75) and the three-dimensional one (= = 1:241=0:63 ' 1:97). A question which naturally arises on the role of the Ising-like anisotropy term, of the two-fold chiral symmetry and of the Im thickness. The role of the anisotropy term and the chiral symmetry is obvious: the Ising character should be observed in the result (we return to this point below). It is however not clear for the e ect of the thickness. Some arguments, such as those from renormalization group, say that the correlation length in the direction perpendicular to the

In is nite, hence it is irrelevant to the criticality, the 2D character therefore should be theoretically preserved. We think that such arguments are not always true because it is di cult to conceive that when the lm thickness becom es larger and larger the 2D universality should remain. Instead, we believe that that the nite thickness of the lm a ects the 2D universality in one way or another, giving rise to "e ective" critical exponents with values deviated from the 2D ones. The larger the thickness is, the stronger this deviation becomes. The observed values of = shown above may contain an effect of a 2D-3D cross-over. At this point, we would like to emphasize that, in the case of simple surface conditions, i.e. no signi cant deviation of the surface param eters with respect to those of the bulk, the bulk behavior is observed when the thickness becom es larger than a dozen of atom ic layers:^{4,5} surface e ects are insigni cant on therm odynamic properties of the lm. There are therefore reasons to believe that there should be a crossover from 2D to 3D at some Im thickness. Of course,

this is an important issue which needs to be theoretically clari ed in the future. We return now to the e ect of Ising an isotropy and chiral symmetry. The deviation from the 2D values may result in part from a complex coupling between the Ising symmetry, due to anisotropy and chirality, and the continuous nature of the classical Heisenberg spins studied here. This deviation may be important if the anisotropy constant I is small. For the e ect chiral symmetry, it is a complex matter. To show the complexity in determining the critical universality with chiral sym metry, let us discuss about a simpler case with similar chiral symmetry: the XY model on the fully frustrated Villain's lattice. There has been a large num ber of investigations on the nature of the transition observed in this 2D case in the context of the frustration e $ects^{1,27,28}$ In this model, though the chirality sym metry argument says that the transition should be of 2D Ising universality class, many investigators found a deviation of critical exponents from those of the 2D case (see review in Ref.²⁸). For example, the following values are found for the critical exponent : = 0.889^9 and = $0:313^{30}$ These values are close to that obtained for the single transition in a m ixed X Y -Ising m odel which is 0.85.^{31,32} It is now believed that the XY character of the spinsa ects the Ising chiral sym metry giving rise to those deviated critical exponents. Sim ilarly, in the case of thin

In studied here, we do not deal with the discrete Ising model but rather an Ising-like Heisenberg model. The Ising character due to chiral symmetry of the transition at the surface is believed to be perturbed by the continuous nature of Heisenberg spins. The transition of interior layer shown in Fig. 16 (b) su ers similar but not the same e ects because of the absence of chiral symmetry on this layer. So the value = is a little di erent. In the non frustrated case shown in Fig. 16 (c), the deviation from the 2D Ising universality class is less in portant because of the absence of the chiral symmetry. This small deviation is believed to stem mainly from the continuous nature of Heisenberg spins.

To conclude this paragraph, we believe, from physical arguments given above, that the deviation from 2D Ising universality class of the transitions observed here is due to, in an decreasing order of importance, the elect of the coupling between the continuous degree of freedom of H eisenberg spin to the chiral symmetry, the small Isinglike anisotropy and the lm thickness.

V. CONCLUDING REMARKS

W e have studied, by m eans of a G reen function m ethod and M C simulations, the H eisenberg spin m odel with an Ising-like interaction anisotropy in thin Im s of stacked triangular lattices. The two surfaces of the Im are frustrated. W e found that surface spin con guration is non collinear when surface antiferrom agnetic interaction is sm aller than a critical value J_s^c . In the non collinear regime, the surface layer is disordered at a temperature lower than that for interior layers ("soft" surface). This can explain the so-called "m agnetically dead surface" observed in som em aterials.^{33,34} The surface transition disappears for J_s larger than the critical value J_s^c . A phase diagram is established in the space (T; J_s). A good agreement between the G reen function method and the M C simulation is observed. This is due to the fact that at high temperatures where the transition takes place, the quantum nature of spins used in the GF is lost so that we should nd results of classical spins used in M C simulations. We have also studied by M C histogram technique the critical behavior of the phase transition using the nite-size e ects. The result of the ratio of critical exponents = show s that the nature of spece transition is complicated due to the in uence of several physical mechni

anism s. The sym m etry of the ground state alone cannot explain such a result. We have outlined a number of the most relevant m echanism s. Finally, we note that in surface m agnetism the low surface m agnetization experim entally observed^{33,34} has been generally attributed to the e ects of the reduction of m agnetic m om ents of surface atom s and/or the surface-localized low -lying m agnon m odes. The m odel considered in this paper adds another origin for the low surface m agnetization: surface fustration. It com pletes the list of possible explanations for experimental observations in thin Im s.
