## Uniform ly frustrated XY model without vortex-pattern ordering

The uniform ly frustrated X Y model with f = 1=3 on a dice lattice is shown to possess a so well developed accidental degeneracy of its ground states that the di erence between the free energies of uctuations does not lead to the stabilization of a particular vortex pattern down to zero tem – perature. N onetheless, at low tem peratures the system is characterized by a nite helicity modulus whose vanishing (at a nite tem perature) is related with the dissociation of half-vortex pairs.

It is well known that in the presence of external magnetic eld a regular two-dimensional Josephson junction array can be described by the H am iltonian of a uniform ly frustrated X Y model [1]:

$$H = \int_{(jk)}^{\Lambda} \cos(\prime_{k} \prime_{j} A_{jk}); \qquad (1)$$

where J is the Josephson coupling constant, the uctuating variables '  $_{j}$  are the phases of the order param eter on superconducting grains form ing the array, the quenched variables A  $_{jk}$  are determ ined by the vector potential of the eld and the sum mation is taken over all pairs of grains connected by a junction. The form of Eq. (1) assum esthat the currents in the array are su ciently sm all, so their proper magnetic elds can be neglected.

The directed sum of the variables  $A_{jk}$   $A_{kj}$  along the perimeter of each plaquette should be equal to f, the ratio of the magnetic ux perplaquette to the ux quantum 0. It is su cient to consider the interval f 2 [0;  $\frac{1}{2}$ ], because all other values of f can be reduced to this interval by a simple replacement of variables [1]. The case of f = 0 corresponds to the absence of frustration.

For rational f the nature of the vortex pattern in the low-tem perature phase of a uniform ly frustrated X Y m odel is usually unambiguously determ ined by the structure of its ground states. The best known examples belonging to this class are the models with f = 1=2 and square or triangular lattice [2]. On the other hand, quite often the ground states of a uniform ly frustrated X Y m odel are characterized by an accidental degeneracy not related to symmetry [3, 4]. In such cases the nature of vortex ordering at low temperatures cannot be determ ined without comparing the free energies of uctuations in the vicinities of di erent degenerate ground states [5].

Q uite offen (for exam ple, when the lattice is triangular and f = 1=3 or 1=4 [4]), this mechanism of the rem ovalof an accidental degeneracy works already at the harm onic level, but in some situations (at f = 1=2 on honeycom b, dice and kagom e lattices) one has to take into account the anharm onicites [6]. However, in all the cases investigated insofar, at low enough tem peratures a particular periodic vortex pattern can be expected to be stabilized by uctuations (in the therm odynam ic lim it).

In the present work we dem on strate that the uniform ly frustrated X Y model with f = 1=3 and dice lattice (see Fig. 1) has rather unique properties. Namely, this is the rst example of a frustrated X Y model in which the accidental degeneracy of ground states is so well developed that vortex pattern rem ains disordered at arbitrarily low tem perature, although the free energies of uctuations are di erent for di erent periodic patterns. As a consequence, the only phase transition which takes place in this system with the increase of tem perature is related to dissociation of pairs of fractional vortices with topological charges 1=2. A possibility for the stabilization of a speci c periodic pattern can appear only if one goes beyond the lim its of the X Y model. In the conclusion we brie y discuss the rem oval of the accidental degeneracy by magnetic interactions and its possible consequences.

The interest to magnetically frustrated superconducting systems with a dice lattice have been motivated by the unusual properties of a single electron spectrum in this geometry [7]. In recent years superconducting wire networks and Josephson junction arrays with a dice lattice have become the subject of active experimental investigations [8, 9, 10] and numerical simulations [11]. Magnetically frustrated Josephson junction arrays formed by rhom bic plaquettes have been also discussed in the context of creation of topologically protected qubits [12].

Since both '  $_{\rm j}$  and A  $_{\rm jk}$  depend on a particular choice of the gauge, it is more convenient to describe di erent states of the system in term softhe gauge-invariant phase di erences

which below are always assumed to be reduced to the interval (; ). The subscripts j and k will be used to denote six-and threefold coordinated sites respectively. If one de nes the variable m<sub>jj</sub> to be given by the directed sum of variables over the perimeter of the plaquette hjk  $fk^{0}i$  divided by 2, the plaquettes for which m<sub>jj</sub> is equal to 1 f (rather then to f) are usually referred to as containing vortices. D i erent local minim a of (1) can be then classi ed by specifying the positions of vortices, whose concentration for f = 1=3 should be exactly equal to one third.

The remarkable property of the considered X Y model is that all m in in a of (1) corresponding to di erent vortex con gurations in which vortices do not occupy adfacent plaquettes have the same energy (per bond),  $E_{0} =$ (2=3)J. Som e of these states are schem atically shown in Fig. 2. In all such states the variables are equal to =3 on all bonds surrounding a vortex and to zero on all other bonds (shared by two plaquettes without vortices). It is evident that these states correspond to the absolute m in im um of energy, because they m in im ize the energy separately for each plaquette containing a vortex and for each of the remaining bonds. The barriers between the \neighboring" ground states have the height  $E_b = 6(2)$ 3)J 1**:**61J.

All these ground states [whose degeneracy survives even if the interaction in (1) deviates from cosine] can be put into correspondence with the ground states of the antiferrom agnetic Ising model de ned on the triangular lattice T form ed by the sixfold coordinated sites fig. In all ground states of such a model each triangular plaquette should contain exactly one bond with parallel spins  $(s_j s_j = 1)$  [13]. The existence of a mapping becomes evident as soon as one notices that in all ground states of the considered X Y model each hexagon form ed by three neighboring plaquettes should contain exactly one

vortex. The plaquettes with vortices can be then identied with the bonds connecting parallel spins by setting  $s_{i}s_{i}p = 2m_{i}p = 1=3$ .

At zero temperature, T = 0, the antiferrom agnetic Ising m odel on a triangular lattice is characterized by an algebraic decay of correlation functions [14] and a nite extensive entropy, which is related to the possibility of creation of zero-energy dom ain walls form ing closed loops [13]. The same partition function can be interpreted as the partition function of the SOS (solid-on-solid) m odel suitable for the description of the height uctuations on the (111) facet of a crystal with a sim ple cubic lattice [15]. In term s of this SOS m odel zero-energy dom ain walls correspond to zero-energy steps, and the algebraic correlations of spins are translated into logarithm ic correlations of integer variables  $h_j$  and  $n_k$ , which can be associated with the height of the surface. These variables can be introduced follow ing the relations

where e (with = 1;2;3) are the three basic vectors  $(e_1 + e_2 + e_3 = 0)$  of T and j(k) are the three nearest neighbors of k on the dice lattice. A coording to R ef. 15, for  $k_1 = k_2 j = 1$

The form of Eq. (2) demonstrates that the SOS model is in the rough phase and that at T = 0 the large-scales uctuations of n can be described by a continuous G aussian H am iltonian,

$$H = \frac{K}{2}^{Z} d^{2}r(rn)^{2}; \qquad (3)$$

where the dimensionless elective rigidity K (which is of entropic origin) is equal to  $K_0 = -9$  [15]. The phase transition of the SOS model to the smooth phase would take place when K = -2 [16], thus the system is situated relatively far from the transition point.

The simplest periodic ground state shown in Fig.2(a) (the striped state) has been discussed in Ref.11. In terms of the SOS representation this state has the maximal possible slope, whereas a at state of the SOS model (with  $n_k = \text{const}$ ) corresponds to the honeycomb vortex pattern of Fig.2(b). Fig.2(d) shows two parallel steps (of opposite signs) which separate at states with n = 1. If the left step of Fig.2(d) is repeated as often as possible, one obtains the striped state of Fig.2(a). On the other hand, the repetition of the right step of Fig.2(d) leads to the zigzag state shown in Fig.2(c). However, the steps do not have to be straight, and a typical ground state looks rather disordered, Fig.2(e).

If the SOS model would be in a smooth phase, the vortex con guration would be characterized by the long-

range order corresponding to the form ation of the honeycom b pattern of Fig. 2 (b). The uctuations of  $n_k$  and  $h_j$  lead to the replacement of the true long-range order by an algebraic decay of correlations of  $m_{jl}$ ,

where = 2, as follows from the results of R ef. 14. H ow ever, one can expect this correlation function to be m odulated according to the honeycom b pattern.

At nite temperature, T > 0, the equivalence between the considered X Y model and the Ising model is no longer exact, because the X Y model (i) allows for the existence of continuous uctuations (spin waves) and (ii) has a more complex classi cation of topological defects. Numerical calculation of the integrals over the B rillouin zone which determ ine the free energies of harmonic uctuations in the vicinity of the three periodic ground states shown in Figs. 2 (a), 2 (b) and 2 (c) reveals that this free energy is the lowest in the honeycomb state [17]. The di erence between the free energies of uctuations in the zigzag and honeycomb states (norm alized per single site of T) is given by T, where 227 1Å.

Since in term s of the SOS m odel the zigzag state can be considered as the sequence of steps with the unit density, the same quantity can be also used as an estim ate for the e ective energy of a step per elementary T . The positiveness of  $E_{\mathrm{st}}$  should lead segment, E<sub>st</sub> to a decrease of uctuations of  $n_k$ , but since one always has E<sub>st</sub>=T 1, this decrease has to be relatively small. In term s of (3) the in uence of a small step energy, T, is translated into a very sm all (< 1%) correc-E <sub>st</sub> tion to  $K_0, K = K_0 + (2=3)$ . This de nitely leaves the system far from the transition to the sm ooth phase, and, therefore, cannot lead to any qualitative changes from the zero-tem perature behavior.

In terms of the original X Y model each step of the SOS model corresponds to a line whose crossing shifts the phase variables  $'_j$  by (with respect to what they would be in the absence of this step) on one of the three sublattice into which the triangular lattice T can be split. A fler crossing three steps of the same sign the variables  $'_j$  are shifted by for all three sublattices. In other words, the state which is obtained in such a way di ers from the original state by a global rotation of all phases by . As

a consequence, the elementary topological excitation of the considered X Y model is an object where three steps of the same sign merge together (see Fig. 3) that looks like a screw dislocation with Burgers number b = -3, on going around which the phase experiences a continuous rotation by . For brevity we shall call such defects half-vortices. Since the phase shift by can be achieved by a phase rotation in both directions, the signs of the two topological charges of a half-vortex (the Burgers number and the vorticity) are not related to each other and can be arbitrary.

The core of a half-vortex can be associated with the three-plaquette cluster which instead of containing exactly one vortex contains either two vortices or no vortices at all (see Fig. 3). In the fram ework of the antiferrom agnetic Ising m odel the analogous defect cannot exist, because each plaquette can contain only an odd number (1 or 3) of bonds with  $s_j s_{j^0} = 1$ . The core energy of a half-vortex should be of the order of J.

In accordance with the double nature of half-vortices their interaction consists of two contributions of di erent origin. Both of them are logarithm ic. The stone (the direct interaction) is related to the energy which is required to create the phase twist around the cores and is completely analogous to the interaction of ordinary vortices (with integer vorticity). This interaction is characterized by the prelogarithm ic factor  $P_V$  = (=2), where is the helicity modulus of the system [at T = 0 in the honeycomb state =  $_0$  (5=4 $\overline{3}$ )J]. The second contribution is of entropic origin and is related to the interaction of half-vortices as dislocations. It follows from Eq. (3) that for this interaction the prelogarithm ic factor is given by

$$P_{\rm D}$$
 (b) =  $\frac{K b^2}{2} T$ ; (4)

where one should put b = 3.

At low tem peratures (T J) the direct interaction of half-vortices is dom inant, which binds them into small pairs with zero total vorticity. How ever, the Burgers num ber of such a pair does not have to be zero, but can be also equal to 6. This returns one to the situation in the antiferrom agnetic Ising model in which the elementary topological excitations are the dislocations with b = 6 [16, 18], the only di erence being a slightly larger value  $K_0 = -9$  and b = 6 in Eq. (4) ofK .Substitution ofK 2, which is insu cient for such dislocations gives  $P_D$  (6) to be bound in pairs [16]. The application of the Debye-Huckel approximation to the two-dimensional Coulomb gas form ed by dislocations shows that  $q_0$ , the concentration of free dislocations, should be exponentially sm all in 1=T. The value of c\_ determ ines a tem perature dependent correlation radius  $r_{\rm c}$  (T ) /  $\,c_{\rm D}^{-1=2}$  , beyond which K  $\,$  is renorm alized to zero and even the algebraic correlations of vortex pattern are destroyed.

The presence of free dislocations leads to the screening of the entropic part of the logarthm ic interaction of half-vortices at the scales which are large in comparison with  $r_c(T)$ . Nonetheless, at low temperatures the system will be characterized by a nite value of (T), since all half-vortices will be bound in pairs by their direct interaction.W ith increasing temperature a phase transition will occur related to appearance of free half-vortices and vanishing of (T). It will be completely analogous to the Berezinskii-K osterlitz-T houlessphase transition in the conventional X Y m odel (without frustration), the main di erence being that half-vortex pairs dissociate when T = (=8) (T) [19], whereas the pairs of ordinary vortices dissociate when T = (=2) (T) [20].

Thus, in the present work we have shown that in the frustrated X Y m odel with a dice lattice and f = 1=3 the vortex pattern is disordered at any tem perature (becom - ing quasi-ordered only at T = 0). Nonetheless, at low tem peratures the helicity m odulus is nite and jumps to zero only at T =  $T_{\rm HV}$  (=8) 0 0.28 J, where the pairs of half-vortices dissociate. This estimate is not far from the value of the transition tem perature,  $T_c$  0.2 J, obtained in num erical simulations of Ref. 11.

A possibility of vortex pattern ordering appears only when one goes beyond the lim its of the X Y model and takes into account som e additional mechanism of the rem oval of an accidental degeneracy. In the case of a proximity coupled array [10] the main role will belong to the energy related to the magnetic elds of currents in the array, which is minimized in the striped state [21]. In terms of the SO S model this leads to a negative step energy,  $E_{\rm st} < 0$ . In the limit of weak screening, when the corrections to currents from their proper magnetic elds can be neglected,  $E_{\rm st} = -J^2 = E_{\rm o}$ , where  $E_{\rm o} = -\frac{2}{0} = 4^{-2}a_{\rm o}$  is the characteristic energy, a is the lattice constant (of a dice lattice) and the numerical coe cient for both types of steps shown in Fig. 2 (d) can be written as

 $_{i}$  I<sub>2</sub>=a > 0 being the dimensionless values of mutual inductances, L<sub>i</sub>, between dice lattice plaquettes [22]. For a 8 m [0] E  $10^{4}$  K.

W ith decrease of T the ratio  $E_{st} \neq T$  is increased, which for E<sub>st</sub> j=T 1 will manifest itself only in the decrease of K in Eq. (3). W ith further decrease of T a phase transition can be expected to occur to a phase with a non-zero slope. In terms of vortices this phase will be characterized by a true long-range order manifesting itself in deviation of occupation probabilities for plaquettes with di erent orientations from 1=3. This phase transition can be expected to happen when  $E_{st}$ T, i.e.,  $(T = E)^{1=2}$ 10  $^2$ , and, according to the re-T=J sults of Ref. 23, has to be of the st order. However, at T=J < 0.05 the relaxation of vortex pattern is likely to be dynamically quenched [at T=J = 0.05 one has

exp( $E_b=T$ ) 10<sup>14</sup>], which m ay prevent the observation of such an ordering in experiments or simulations.
