# A model for the microwave assisted zero resistance states

#### A bstract

In this work we present a model for the photoconductivity of a two dimensional electron system (2DES) subjected to a magnetic eld. The model includes them icrow ave and Landau contributions in a non-perturbative exact way, Impurity scattering e ects are treated perturbatively. Based on this formalism, we provide a Kubo-like formula that takes into account the oscillatory F loquet structure of the problem. We discuss results related with the recently discovered zero-resistance states.

#### 1 Introduction.

Recently, two experimental groups [1, 2, 3, 4], reported the observation of a novel phenomenon: the existence of zero-resistance states in an ultrackan G aA s=A  $l_x$  G  $a_1 x$  As sample subjected to microwave radiation and moderate magnetic elds. The magnetoresistance exhibits strong oscillations with regions of zero resistance governed by the ratio  $!=!_c$ , where  $!_c$  is the cyclotron frequency. A coording to Zudov etal:, the oscillation am plitudes reach maxim a at  $!=!_c = j$  and minim a at  $!=!_c = j+1=2$ , for j an integer. On the other hand M ani. etal: reported also a periodic oscillatory behavior, but with maxim a at  $!=!_c = j = 1=4$  and minim a at  $!=!_c = j+1=4$ .

In spite of a large num ber of theoretical works, a complete understanding has not yet been achieved. A pioneer work put forward by Ryzhii [5,6] predicted the existence of negative-resistance states. Durst and collaborators [7] also found negative-resistance states in a a diagram matic calculation of the photoexcited electron scattered by a disorder potential. A possible connection between the calculated negative-resistance states and the observed vanishing resistance was put forward in reference [8], noting that a general analysis of M axwell equations show s that negative resistance induces an instability that drives the system into a zero-resistance state. In our model, the Landau-F loquet states act coherently with respect to the oscillating eld of the in purities, that in turn induces transitions from levels below Ferm ito levels above it. This form alism is com plem ented with a generalization of the K ubo form alism in order to correctly include the F loquet structure of the problem.

## 2 Themodel.

W e consider the motion of an electron in two dimensions, subject to a uniform magnetic eld B perpendicular to the plane and driven by microwave radiation. In the long-wave limit the dynamics is governed by the Schrödinger equation

here H  $_{fB;!g}$  is the Landau ham iltonian coupled to the radiation H  $_{fB;!g} = \frac{1}{2m} 2;m$  is the electron mass, = p + eA, and the vector potential A includes the external magnetic eld and radiation eld (in the ! 1 limit) contributions:  $A = \frac{1}{2}r$   $B + Re = \frac{E}{!}expf$  i!tg. The impurity scattering potential is decomposed in a Fourier expansion V (r) =  $\frac{1}{2}d^2qV(q)expfiq$  (r  $r_1)g;where r_1$  is the position of the ith in purity, and the explicit form of the potential coe cient V (q) for neutral impurity scattering is V (q) =  $\frac{2^{-2}h^2V_0}{m} \frac{E_F}{E_F}$ , whereas for charged impurities localized within the doped layer of thickness d: V (q) =  $\frac{h^2}{m}e^{-qd} = 1 + \frac{q}{q_{r,F}}$ ; with  $q_{r,F} = e^{2m} - 2_{-0}bh^2$ .

A three step procedure is enforced in order to solve the problem posed by eq. (1): (1) The Ham iltonian H<sub>fB;!g</sub> can be exactly diagonalized by a transform ation of the form W  ${}^{y}$ H<sub>fB;!g</sub>W = !<sub>c</sub>  $\frac{1}{2}$  +  $a_{1}^{y}a_{1}$  H<sub>0</sub>, with the W (t) operator given by

where the functions  $_{i}(t)$  and  $_{i}(t)$  represent the solutions to the classical equations of motion and the (Q ;P ) operators are the generators of the electric magnetic translation symmetries [9, 10]. (2) The transformation induced by W is applied to the Schrodinger eq. (1), transformed into  $ih\frac{\theta^{(W)}}{\theta t} = (H_{0} + V_{W}(t))^{(W)}$ ; where  $V_{W}(t) = W(t)V(r)W^{-1}(t)$  and  $^{(W)} = W(t)$ . Note that the inpurity potential acquires a time dependence brought by the W (t) transformation. (3) The problem is now solved in terms of an evolution

operator U (t), using the interaction representation and storder time dependence perturbation theory. The solution to the original Schrodinger equation in eq. (1) has been achieved by means of three successive transform ations

The explicit expressions for the matrix element of these operators in the Landau-F loquet base appear in detail in reference [11].

### 3 K ubo form ula for F loquet states.

The usual K ubo formula for the conductivity must be modied in order to include the F loquet dynamics. In the presence of an additional D C electric eld the complete H am iltonian is H<sub>T</sub> = H + V<sub>ext</sub>; where H is the H am iltonian in eq. (1) and V<sub>ext</sub> =  $\frac{1}{m}$  A<sub>ext</sub> with A<sub>ext</sub> =  $\frac{E_0}{!} \sin(t) \exp(-\frac{1}{2}t)$ : The static limit is obtained with ! 0, and represents the rate at which the perturbation is turned on and o . In order to calculate the expectation value of the current density, we need the density matrix (t) which obeys the von N eum ann equation

We write to rst order =  $_0$  + , where the density matrix  $_0$  satisfies the equation  $ih\frac{\theta_0}{\theta_1} = [H; 0]$ . In agreement with eq. (3) the density matrix is transformed as  $(t) = U^{\gamma} \exp fiH_0 tgW$  (t)  $W^{\gamma} \exp f iH_0 tgU$ , and obeys the equation  $ih \frac{e^{-}}{e^{+}} = \tilde{V}_{ext}; \sim_0;$  where  $\tilde{V}_{ext}$  and  $\sim_0$  are the external potential and quasi-equilibrium density matrix transformed in the same manner as ~. The transform ed quasi-equilibrium density matrix is assumed to have the form  $\sim_0 =$ jif ( )h j; where f ( ) is the usual Ferm i function and the Landau-F loquet levels. The argument behind this selection is an adiabatic assum ption that the original H am iltonian H produces a quasi equilibrium state characterized by the Landau-F loquet eigenvalues. We then obtain the expectation value of  $\sim$  (t) in the Landau-F loquet base, from, which the current density is evaluated according to hJ (t;r)i = Tr  $\sim$  (t) J (t) . The m acroscopic conductivity tensor that relates the average current density to the averaged electric eld, is obtained perform ing a space-time average, as well as an impurity average, assuming non correlated in purities. We take into account the lifetime = 2 =of the quasiparticles induced by the weak scattering, in the usual B om approximation. We work out explicit expressions for the longitudinal and Hall conductivities (both for the dark and microwave induced contributions) [11], and quote the result for the longitudinal photoconductivity

where  $n_{\rm I}$  is the two dimensional impurity density, and the broadened spectral function is given as

In eq. (5)  $J_1$  (j j) is the B essel function with  $= \frac{! c l_B^2 eE}{! (!^2 ! c_z^2 + i!)} [! (q_x e_x + q_y e_y) + i! c (q_x e_y q_y e_x)],$   $l_B = \frac{h}{eB}$  being the magnetic length, the electron radiative decay width and the polarization vector. Finally D (q) =  $e^{\frac{1}{2} \frac{jq}{2}} q - \frac{l}{lL} \frac{jq}{jq}^2$ ; with L being the generalized Laguerre polynom ial and  $q = il_B (q_x iq_y) = \overline{2}$ .




Figure 1: Longitudinal resistance as a function of  $!=!_c$  for three selections of the mobility.

#### 4 Results and conclusions

W e have selected parameter values corresponding to reported experiments [1, 3]: e ective electron m ass m =  $0.067 \text{ m}_{e}$ , relative perm ittivity b 13.18, ferm i energy  $_{\rm F} = 8 \, {\rm meV}$ , electron mobility  $0:5 2:5 10^7 \text{ cm}^2 = \text{V} \text{ s, electron}$ density  $n = 3 \quad 10^{11}$  cm<sup>2</sup>, m icrowave frequency f = 100 G hz, m agnetic elds in the range 0:05 0:4 Tesla and tem peratures T 1K. Typical microw ave power is 10 40 nW from which the electric eld intensity is estimated as  $\mathbf{F}$  j 250V=m. The broadening is known to increase with the square root of the magnetic eld, hence we take  $^{2} = h!_{c}$  (2 h= ), which is connected through the relaxation time with the zero eld mobility = e = m . In the case of charged in purity scattering, the distance d between the in purity and the 2DES is taken as d 30 nm, and  $n_{I}$  is estimated as  $n_{I}$  7 10<sup>11</sup> cm<sup>2</sup>. Explicit calculations dem onstrate that results for charged neutral in purity scattering are very sin ilar [11]. Finally, the electron radiative decay , is interpreted as coherent dipole re-radiation of the oscillating 2D electrons excited by m icrowaves; hence, it is given by  $= ne^2 = (6_0 \text{ cm})$ , using the values of n and m given above, it yields 0:38m eV.

One of the puzzling properties of the observed giant magnetoresistance oscillations is related to the fact that they appear only in sam ples with an electron mobility exceeding  $1.5 \quad 10^7$  cm<sup>2</sup>=V s. This phenomenon is absent in sam ples in which is reduced by one-order of magnitude. This behavior is well reproduced by the present form alism . Figure (1) displays the xx vs:  $!=!_{c}$  plot for three selected values of . For 0:5 10  $^{7}$  cm  $^{2}$ =V s the expected alm ost linear behavior  $_{\rm xx}$  / B is clearly depicted. As the electron m obility increases 1:5  $10^7$  cm<sup>2</sup>=V s the m agnetoresistance oscillations are clearly observed, to but negative resistance states only appear when 2:5  $10^7$  cm<sup>2</sup>=V s. W e notice that  $_{xx}$  vanishes at  $!=!_{c}=j$  for j integer. The oscillations follow a pattern with m inim a at  $!=!_c = j+$ , and m axim a at  $!=!_c = j$ , adjusted w ith 1=10.

Eqs. (5–7) contain the main ingredients that explain the huge increase observed in the longitudinal conductance when the material is irradiated by microwaves. In the standard expression for the K ubo form ula there are no F loquet replica contribution, hence ! can be set to zero in (7), in which case B <sup>(1)</sup> becomes proportional to the energy derivative of the Ferm i distribution, that in the T ! 0 limit becomes of the form ( $_F$ ), and the conductivity depends only on the states at the Ferm i energy. On the other hand as a result of the periodic structure induced by the microwave radiation, B <sup>(1)</sup> is dominated by terms proportional to  $\frac{d}{d}A$  (+1!), hence several contributions arise from the transitions between di erent Landau levels.

The model can also be used in order to test quirality e ects induced by the magnetic eld. In reference [11] we carried out calculations for di erent E eld polarizations with respect to the current. The amplitudes of the resistivity oscillation are bigger for transverse polarization as compared to longitudinal polarization. Selecting negative circular polarization, the oscillation amplitudes get the maximum possible value. Instead, the negative resistance states disappear

for positive circular polarization. These results are easily understood, because for negative circular polarization and !  $!_c$  the electric eld rotates in phase with respect to the electron cyclotron rotation. Finally, we mention that the above discussed results are well described by single photon processes, however the present form alism is well suited to explore the non-linear regime in which multiple photon exchange play an essential role.
