# D ynam ical C onductivity of D isordered Q uantum H all Stripes

We present a detailed theory for nite-frequency conductivities Re[ (!)] of quantum Hall stripes, which form at Landau level N 2 close to half lling, in the presence of weak Gaussian disorder. We use an elective elastic theory to describe the low -energy dynam ics of the stripes with the dynam ical matrix being determ ined through matching the density-density correlation function obtained in the microscopic time-dependent Hartree-Fock approximation. We then apply replicas and the Gaussian variational method to deal with the disorder. Within this method, a set of saddle point equations for the retarded self energies are obtained, which are solved num erically to get (!)]. We nd a quantum depinning transition as , the fractional part of the lling fac-Reĺ  $_{\rm c}$  from below. For  $_{\rm c}$ , the pinned state is realized in tor, approaches a critical value < a replica symmetry breaking (RSB) solution, and the frequency-dependent conductivities in both the directions perpendicular and parallel to the stripes show resonant peaks. These peaks shift to zero frequency as  $_{\rm c}$  , we nd a partial RSB (PRSB) solution in which 1  $_{\rm c}$ . For there is R SB perpendicular to the stripes, but replica symmetry along the stripes, leading to free sliding along the stripe direction. The quantum depinning transition is in the Kosterlitz-Thouless universality class. The result is consistent with a previous renorm alization group analysis.

### I. IN TRODUCTION

Charge density waves (CDW s) may form in many correlated electronic systems when the Coulomb interaction dom inates over the kinetic energy. For a two-dimensional electron gas in a perpendicular magnetic eld, the quantization of the kinetic energy into Landau levels can enhance this possibility<sup>1</sup> . Each Landau level is highly degenerate, with the number of states equal to the number of magnetic ux quanta passing through the system. If the eld and corresponding degeneracy is su ciently large, the low energy physics of the system may then be dom inated by electrons in the highest partially occupied (N th) Landau level, with the other electrons essentially renorm alizing the e ective C oulom b interaction in this level<sup>2</sup>. In this situation, the kinetic energy is quenched and the system arranges itself in order to m inim ize the interactions. The Hartree Fock approximation<sup>1</sup> predicts the formation of CDW ground 2. These CDW sevolve from W igner crystals to \bubble states<sup>ni</sup> as the partial Landau-level lling states for N & 0.4, the bubble states give way to stripe states (also called unidirectional CDW s.) This factor increases. For Hartree Fock result is corroborated by density matrix renormalization group calculations<sup>3</sup> and exact diagonalization studies $^4$  . D C transport experiments indeed observe highly anisotropic, and apparently metallic, conductivity $^5$  near half-lling of higher Landau levels (N 2). This is likely due to the form ation of stripe states.

Because the stripe state breaks translational symmetry in only one direction, it has the symmetry of a smectic liquid crystal<sup>6</sup>, and as in that system supports a set of gapless phonon  $m \operatorname{odes}^7$ . These modes are present because the stripe state lacks any restoring force when a single stripe slides with respect to the others. In the context of an electron system, the smectic state can be thought of as a self-organized array of Luttinger liquids<sup>6,8</sup>, a state of ferm ions that does not obey Landau Ferm i liquid theory and (so far) is known to exist only in one dimension<sup>9</sup>. One way of viewing the Luttinger liquid is in terms of a one dimensional crystal that has lost long-range order due to quantum uctuations<sup>10</sup>. This idea is easily generalized to the case of stripes<sup>11</sup>, and suggests that the low-energy degrees of freedom for the system may be described in terms of a displacement eld. This will be the basic language for our study.

It has long been recognized that disorder can pin a CDW and render it insulating<sup>12,13</sup>. (Sim ilarly, Luttinger liquids may be pinned by in purities in spite of their liquid-like correlations<sup>14</sup>.) In this situation, the real part of the zero wavevector, nite-frequency conductivity (!) vanishes as !! 0, and has a resonance at higher ! with a peak (or pinning) frequency and width that are determined by the electrive restoring force due to the disorder<sup>12</sup>. Such behavior has indeed been observed in high Landau levels for su ciently far away from 1/2 so that one expects the electrons to be organized into bubble states<sup>15</sup>. As is increased, there is a general trend for the pinning frequency to decrease, eventually becom ing lost in the noise as the lling factor approaches the value at which the DC conductivity becom es an isotropic and m etallic<sup>5</sup>. Experiments to better resolve the dynamical conductivity as the stripe phase is entered are currently underway<sup>16</sup>.

A fundam ental question that arises in this context is whether the apparent m etallic behavior seen in DC transport experiments represents the true zero temperature behavior in the stripe state. While current data suggests the diagonal conductivities  $_{xx}$  and  $_{yy}$  saturate to nite values at low temperatures, presumably such experiments can answer this fundam ental question unam biguously only by reaching signi cantly low er temperatures than are currently available. The possibility that near half-lling the stripes m ay not be fully pinned is extremely intriguing because, if this is indeed the case, then the electrons have avoided becoming localized and the resulting an isotropic m etal cannot be a Ferm i liquid. Thus this state could well be a higher dimensional analogue of a Luttinger liquid. Developing and understanding the results of experiments beyond DC transport { such as measurements of the dynamical conductivity<sup>15</sup> { then take on an additional signi cance.

O ne possible route to m etallic behavior for the stripe system could be via a depinning transition. In principle this could happen in a one dimensional Luttinger liquid, if one could continuously tune the interactions from repulsive to attractive<sup>14</sup>. Because the stripe system has a larger parameter space needed to describe its elastic properties than the single sti ness that describes a one-dimensional solid (speci cally, one needs to estimate the dynam ical matrix along a line in the B rillouin zone, as we discuss below), it is possible to arrive at this depinning transition even when the bare interaction parameters among the electrons are purely repulsive<sup>11</sup>. The question of whether stripes may become depinned must be answered via a detailed calculation of the stripe elasticity, and depending on how one estimates this, di erent answers are possible<sup>8,17</sup>, as we discuss in more detail below.


FIG.1: Schematic diagram of quasione-dimensional arrays modelling the QH stripes. The stripes are along the 🖇 direction, and  $u_x$  and  $u_y$  are the displacement elds. The shaded area is the unit cell of the stripes crystal with the volume  $a_x a_y$ .

In what follows, we will adopt an approach that models the quantum Hall (QH) stripe system as an array of one dimensional, quantum disordered solids as shown in Fig. 1. We estimate the dynamical matrix of this system by matching the elastic theory to the results of a microscopic calculation within the time-dependent Hartree-Fock approximation (TDHFA). This approach was taken by some of  $us^{17}$  in a perturbative renormalization group (RG) calculation, which demonstrated that a quantum depinning transition can occur as ! . . from below, with the critical partial lling . depending on the details of the system : Landau level index, layer thickness, disorder strength, etc. Our goal is to compute the dynamical conductivity as the system passes through the transition, to identify signatures that would indicate that the system has passed into an unpinned stripe state. A brief sum mary of our major results has been published elsewhere<sup>18</sup>. In this article, we provide details of the calculations as well as some further results.

O ur general approach to this problem is to use replicas<sup>19</sup> and the G aussian variationalm ethod (GVM), as was rst introduced by M ezard and Parisi for elastic m anifolds<sup>20</sup> and then further developed by G iam archiand Le D oussal and their cow orkers in applications to a variety of condensed m atter system  $s^{21,22,23,24}$ . In the Q H system s, this m ethod was used by C hitra et al.<sup>24</sup> for pinned W igner crystals in the N = 0 Landau level, and by O rignac and C hitra<sup>25</sup> for stripes, in the latter case using a di erent set of approximations than us and yielding very di erent results than those described below. Because of the strong uctuations inherent in the depinning transition, we have found that one cannot correctly solve for the dynam ical conductivity using the \sem iclassical approximation" to the saddle point equations (SPE's), which we review below, that has given this approach its attractive sim plicity. By relaxing this approximation we will see that in the depinned state the dynam ical conductivity can have a surprising power-law frequency dependence, and a discontinuous behavior at the transition that is analogous to the universal sti ness jump that occurs at a K osterlitz-T houless (KT) transition<sup>26</sup>. M oreover, we will see that the solution to the SPE's that yield this behavior have an unusual structure involving breaking the replica sym metry form otion perpendicular to the stripes, while preserving it parallel to the stripes. This partial replica sym metry breaking (PR SB) indicates that the stripes may be pinned for perpendicular motion while free to slide relative to one another. This qualitative behavior was anticipated by the perturbative RG study<sup>17</sup>.

As discussed above, when the system is pinned there are resonant peaks which appear in  $_{xx}$  and  $_{yy}$ . (We choose the x direction to be perpendicular to the stripes, and the  $\hat{y}$  direction to be parallel to it as shown in Fig. 1. Of course, the two diagonal conductivities are not the same due to the anisotropy of the stripe state.) The peaks drop to zero frequency as  $_{c}$  is approached from below, with their weights increasing for motion along the stripes, and decreasing form otion perpendicular to them. A sthe transition is approached, the resonance peaks become increasingly asymmetric. Upon crossing the transition,  $_{yy}$  develops a -function at ! = 0, indicating superconducting behavior, while  $_{xx}$  rises from zero as a power of !. This unusual behavior is a result of the power-law correlations associated with the Luttinger liquid-like behavior of the unpinned state. We note that our ! = 0 results are not consistent with the DC conductivity results seen in experiments, although preliminary experimental results for nite frequency do bear some resemblance to our predictions<sup>16</sup>. We will comment below on what is missing from our model that we believe leads to this discrepancy.

This paper is organized as follows. In Sec. II we review the procedure for determining the dynamical matrix in the elastic model. This is followed by a review in Sec. III of the qualitative elects of disorder within the RG analysis. In Sec. IV, we review the replica and GVM which leads to a set of saddle point equations (SPE's) for the self energy. Solutions of the SPE's and the result for the conductivities are presented in Sec. V, focusing on the pinned state for  $<_{c}$ , and in Sec. VI, which is devoted to the depinned state for  $>_{c}$ . We discuss the nature of the depinning transition in Sec. VII, and conclude in Sec. VIII. There are four appendices: the rst sum marizes the

Hartree-Fock (HF) and the TD HFA form alism s, the result of which is used for determ ination of the dynam icalm atrix; the second gives a derivation for the inversion rules needed for hierarchical matrices of the type dealt with in this paper; the third discusses analytic continuation of the dynam ical conductivity from in aginary time to real time; and the forth discusses another possible solution to the SPE's that has unphysical properties.

## II. ELASTIC MODEL OF QH STRIPES

### A. Elastic action

In our approach, low energy distortions from the mean-eld state are described by an elastic model, with displacement elds  $u_x$  (r) and  $u_y$  (r) representing the elds  $u_x$  dynamical variables of the QH stripes. Fig. 1 shows schem atically the one-dimensional a<u>mays</u> modelling the stripes. They obey single Landau level dynamics<sup>27</sup>  $[u_x(R); u_y(R^0)] = il_{B-R;R^0}^2$ , where  $l_{B} = - c = B$  is the magnetic length. In the pure limit, the Euclidean action of the elastic model may be written as (throughout this work, we use the unit  $k_B = \sim = 1$ )

is the unperturbed G reen's function of the displacement elds with D (q) being the dynamical matrix and

being a general expression for phonon modes of a charged elastic system in a strong magnetic eld (magnetophonon m odes). As always for a Gaussian theory, the correlation function m ay be expressed in term s of the G reen's function via

where h  $_{S_0}$  denotes an average over the displacement elds with the usual weighting factor e  $^{S_0}$ , and T is the in aginary time ordering operator.

To perform quantitative calculations, it is necessary to produce estimates of the dynamical matrix elements D (q) for the QH stripe states. We do this with a matching procedure that uses results from microscopic TDHFA computations. Below we brie y review this matching procedure.

# B. Relation between G<sup>(0)</sup> (q;!) and guiding-center density-density correlation function

In a classical model, each site of the crystal is occupied by an electron whose charge density is specified by a form factor f(r) (with drf(r) = 1). In the absence of any uctuations these electrons will lie on the oblique B ravais lattice as shown in Fig.1. Fluctuations around this reference state are given in terms of the displacement elds u (R). The time-dependent electronic density is then written as

The Fourier transform of this density is given by

where  $N_s$  is the number of crystal sites or electrons and K is a reciprocal lattice vector. The form factor f(r) is real and has inversion symmetry so that f(q) is real.

The fact that the density uctuations are related to the displacem ent eld via

Here  $\binom{(n,n)}{K,K^{\circ}}$  (q; ) is a quantity that we compute in the microscopic TDHFA<sup>7</sup>. In Appendix A, we sum marize the HF and TDHF form alism s. Eq. (A14) there will be used for the determination of the dynamical matrix. Substituting Eq. (2) in Eq. (14) yields

where W<sub>i</sub> (q + K;q + K<sup>0</sup>) is the weight associated with the magnetophonon frequency "<sub>i</sub> in the TDHFA response and = N=N, is the lling factor of the partially lled level. The magnetophonon frequency "<sub>i</sub> is found, at small wavevector q, by locating the eigenvalue "<sub>i</sub> of the matrix M de ned in Eq. A careful exam ination shows that, because  $!_q$  is given by the determ inant of the m atrix  $\hat{D}$ , the quantity  $_1=2!_q$  is unchanged if all the components of the dynam ical matrix are multiplied by some constant. Eq. (20) is thus indeterm inate. To avoid this, we replace  $!_q$  by  $"_i$  in this equation. Our nalequation is then

W ith this equation, we can determ ine the 3 components of the dynam icalm atrix as well as the form factors f (q + K):

### C. M atching procedure

At this point, it is worthwhile remarking that, in the HFA, there is an extremely small energy di erence (of order 10<sup>6</sup>  $e^2 = \frac{1}{2}$ ) between the energies of the stripe crystals with in-phase and out-of-phase modulation on adjacent stripes. As a result, the magnetophonon dispersion in the TDHFA has a very small gap in the perpendicular direction. This interstripe locking energy is, however, not accessible within our numerical accuracy so that our calculated magnetophonon dispersion is that appropriate for a smectic. In particular, it contains a line of gapless modes for  $q_x \in 0$ ;  $q_y = 0$ . Because of this nodal line, we need to t the dynam ical matrix for small  $q_y$  i.e., for long wavelengths along the stripes, and for all values of  $q_x$  in the B rillouin zone. Indeed, these low-energy modes play a crucial role in determining the elects of both quantum and thermal uctuations on the system.

We choose to solve Eq. (21) for the shortest three reciprocal lattice vectors:  $K ; K^0 = (0;0); (0; K_{y0})$  where  $K_{y0} = 2 = a_y$  with  $a_y$  being the lattice constant along the stripes direction (see Fig. 1). For each q, the TD HFA calculation provides ten independent numbers, nine in the 3 3 Herm itian matrix  $W_{\pm}$  (q + K; q + K<sup>0</sup>) and one in "<sub>i</sub>. We use six of them to determ ine  $D_{xx}$ ,  $D_{xy}$ ,  $D_{yy}$ , and the three real parameters f (q + K). The rest m ay be used to check the consistency of the num erical procedure. The nal result<sup>17</sup> indicates that the matching is very accurate.




FIG. 2: Dynamical matrix D<sub>yy</sub> as a function of  $q_y$  at small  $q_y$  and  $q_x = K_{x0}=2$ . Curves from right to left correspond to = 0:36;0:38;0:4;0:42;0:44;0:46;0:48, respectively.

A typical result for  $D_{yy}(q)$  as a function of  $q_y$  at small  $q_y$  and  $q_x = K_{x0}=2$  is shown in Fig.2. Clearly  $D_{yy}(q)$  is quadratic in  $q_y$ . Indeed, based on symmetry considerations<sup>7</sup>,<sup>8</sup>, the low energy sector of D (q) should have the form for small  $q_y$ :

where  $_{b}$  is the bending coe cient. The absence of a quadratic  $q_{y}$  term in D<sub>xx</sub> follows from rotational symmetry and is the major difference between a smectric and a crystal dynamical matrix. In our calculation below, we will use this smectric form, determining  $d_{xx}$  ( $q_{x}$ ),  $d_{xy}$  ( $q_{x}$ ) and  $d_{yy}$  ( $q_{x}$ ) on a grid of  $q_{x}$  points numerically. The  $_{b}q_{y}^{4}$  in Eq. (22) rejects the bending energy of the stripes. In practice, this term merely plays the role of high- $q_{y}$  cuto and thus  $_{b}$  is chosen for convenience to be 2 in our numerical calculation.

Inserting Eqs. (22-24) into Eq. (3) yields

Once the Green's function has been determ ined, we can easily compute the conductivity. Since the electric current is carried by the charge, the current density can be expressed as

where  $a_x$  is the distance between the centers of two neighboring stripes (see Fig. 1). It is easy to check that in the pure limit, the electrom agnetic response of the system is purely transverse. Calculating G<sup>ret</sup> in the presence of disorder is our next (and indeed most im portant) task.

# III. QUALITATIVE EFFECT OF DISORDER

# A. M odeling the disorder

W e assume that the disorder can be modeled as a G aussian random potential V (r). The disorder action reads

The electron density operator n (r; ) in Eq. (28) must, in order to capture the possibility of pinning by disorder, be approximated more accurately than was needed in the matching procedure discussed in the preceding section. Following G iam archiand Le Doussal<sup>22</sup>, under the assumption of small r u (r) (which is justified for weak disorder) we write

This di ers from our approximation in Eq. (12) essentially via the last term which captures the short wavelength oscillations in the charge density and allows pinning by impurities. In employing Eq. 32, since only the last term can actually lead to pinning<sup>22</sup>, we will drop the rst two terms upon substitution into Eq. 28. Moreover, in the reciprocal lattice sum we retain only the smallest non-trivial wavevectors, so that in what follows (unless otherwise specified)

 $K_{K_{0}0}$  really means sum over  $K = (K_{x0}; 0); (0; K_{y0}); (K_{x0}; K_{y0}), where <math>K_{x0} = 2 = a_x$ . These simplications, we will see, allow us to compute the Green's function in a relatively straightforward manner while retaining the essential physics of pinning so that our results are qualitatively correct. The major elect of these approximations is to replace the soft cuto in wavevector that would enter through the form factor with a hard one in the reciprocal lattice sum. With these approximations, the impurity action with which we work is

### B. Review of the RG analysis

Before proceeding with our replica analysis, we review the highlights of the perturbative RG analysis previously undertaken by some of  $us^{17}$  to set the stage for our expectations for the results. In the RG approach, one perform s m om entum shell integrals for large (absolute values of) frequency and  $q_v$ , rescales the lengths and times to keep the cuto s xed, and then examines how the parameters of the theory evolve under this transform ation. The power of this approach is that it m ay be carried out perturbatively in the disorder, allow ing one to avoid the subtleties that arise from the employment of replicas or other m ethods needed to handle disorder averages when V (r) remains in the exponent.

A nother useful feature of the RG approach is that it allows one to look at the contributions to the impurity action individually. Specifically, one must modify Eq. (33) to read

(34) indicates that the stripes can undergo a quantum phase transition, from one in which they are pinned form otion parallel to the stripes ( $K = (2 = a_y)\hat{y}$  relevant) to one in which they are unpinned ( $K = (2 = a_y)\hat{y}$  irrelevant) and free to slide. As can be seen from Eq. (36), which state the system ends up in depends in detail on the elastic sti ness of the stripes. For the N = 3 Landau level, using the same m atching procedure as we described above, it was found that the stripes undergo a quantum depinning transition around 0:43 for very weak disorder, with the unpinned state occurring for the larger values of . From the form of Eq. (34), one can see the depinning occurs via a KT transition <sup>17</sup>.

The RG analysis is more complicated if K is perpendicular to the stripes. In this case, for any  $K = (K_x; 0)$ , the free energy F in Du exp  $S_0 = S_{imp}^0$  diverges at low temperatures as T<sup>2=5</sup> for any . This indicates that

pinning perpendicular to the stripes is always relevant. Our interpretation of this is that the stripes will be trapped in channels; however, they are still free to move along the channels so that this would not spoil the phase transition described above.

The perturbative RG thus leads us to expect a quantum phase transition from a pinned to an unpinned state as increases towards 1/2. We will see that the replica analysis discussed below bears out this expectation, and gives results very much in harm ony with those of the perturbative RG.

Before closing this section, we believe it is important to point out that di erent methods for estimating the dynamical matrix D will lead to di erent values of  $_{\rm K}$ , and may ultimately lead to di erent conclusions regarding whether there is a depinning transition in this system. Speci cally, calculations based on edge state models for the low energy states of the stripes<sup>8,25</sup> lead to estimates in which the stripes are always in the pinned phase for all € 1=2. This di erence does not come as a result of a fundamental di erence in the assumed degrees of freedom for the underlying low energy model; indeed, one may show the edge state and disordered solid models can be mapped onto one another<sup>8,28</sup>. The di erence arises purely as a result of the di erent estimates one arrives at for the dynamical matrix using the two di erent approaches.

A convincing argument has been made<sup>8</sup> in the context of the edge state model that the stripes should be in the pinned state provided the system preserves particle-hole symmetry at = 1=2. This is not the situation for the model we have adopted: by modeling the stripes as quantum disordered crystals, we assume the system is isomorphic to one in which the system is composed of point particles, which does not have this symmetry. This is natural for our starting point, the modulated stripe HF ground state. These states are highly reminiscent of a collection of electrons in wavepackets, and it is natural to suppose the low-energy uctuations will consist of displacements of these wavepackets. Moreover, the HF ground states from which we start spontaneously breaks particle-hole symmetry at = 1=2, arriving at a lower energy state than the uniform, particle-hole symmetric one. A lthough the sliding uctuations modify the density to one where the particle-hole symmetry breaking may not be in mediately apparent, one does expect to see the broken symmetry in pair correlation functions. Since our estimates of the dynamical matrix elements are taken from the density response function, which is closely related to the pair correlation function, it is not surprising that our nal result does not respect the limit set by particle-hole symmetry.

An interesting aspect of our approach is that it predicts, in the clean limit, that there will be two smectic states, a particle-like one, and a hole-like one, at = 1=2. The transition between them as a function of will presum ably be rst order. W hile a direct experimental con mation of this is di cult, the predictions we make in the present study { a depinning transition, and a dynam ical conductivity whose form is characteristic of a depinned state { o er a falsi able test of whether the QH smectic actually breaks particle-hole symmetry: should experiments show that the dynam ical conductivity unam biguously displays behavior associated with the depinned state, then it is most likely that the QH smectic indeed spontaneously breaks particle-hole symmetry at = 1=2.

## IV. BEYOND PERTURBATION THEORY:REPLICAS AND THE GVM

W hen a perturbation is relevant in an RG analysis, it is necessary to develop som e m ethod for approximating the action to which the system is owing in order to compute properties of the system. For a pinned elastic system, replicas combined with the G aussian variational m ethod (GVM) make this possible. In this section, we brie y introduce this m ethod, and go on to discuss som e aspects of its application to the stripe system. A fuller discussion m ay be found in Refs. 20,21,22,23.

### A. Basic equations

The fundamental idea of the GVM is to replace a complicated action S with a variational action  $S_{var}$  that is quadratic, with coe cients chosen to best m atch the original problem. This is accomplished by m inimizing a free energy<sup>23</sup>

where  $S_{var}$  is the quadratic variational action,  $F_0$  is the free energy associated with that action, and here h  $S_{var}$  indicates a functional integral over displacements, with  $S_{var}$  as a weighting. For our problem, we would like to disorder average  $F_{var}$ , a di cult task because the disorder potential V enters  $F_{var}$  in a complicated and analytically intractable way. A standard method for dealing with this is the replica trick<sup>31</sup>, in which one creates n copies of the original action, computes the replicated partition function  $Z^n$ , and then takes the n ! 0 lim it. The identity  $F = \lim_{n \in O} (1 - Z^n) = n$  connects the disorder-averaged, replicated partition function to the free energy. In practice, one rest replicates both the G aussian variational free energy and the original action, perform s the disorder average on  $Z^n$ , and then applies

Eq. 37 to the resulting replicated e ective action, taking the n ! 0 lim it only after noting the equations that come from m inim izing  $F_{var}$ .

Following this program, the elective replicated action after disorder averaging is de ned by

In the pure limit the action is diagonal in the replica indices. D isorder averaging introduces coupling am ong the replicas through the impurity coupling  $S_{im\,p}^{(e)}$  in Eq. (41). This coupling is non-G aussian, so we next apply the GVM. We introduce the G aussian variational action  $S_{var}$  which takes the form

Equation (37) next needs to be extrem ized, which is accomplished by taking derivatives with respect to the matrix elements of G,  $@F_{var}=@G = 0$ . The resulting saddle point equations (SPE's) are most easily expressed in terms of the self-energy matrix as<sup>21,22</sup>

It is apparent at this point that the self-energy has no q dependence. Moreover, if we assume that rejection symmetry for the stripe system is not spontaneously broken after disorder averaging, it is clear that the solutions of interest to Eqs. It is now convenient to take  $n ! 0 \lim it$ . In doing so, the replica indices are taken to be continuous rather than integral, and they are taken from nunning from 1 to n to running from 1 to 0. An important aspect of taking this lim it is that one assumes the self-energy and G reen's function matrices may be written in a \hierarchical form "<sup>19,31</sup>. In the lim it n ! 0 such matrices are characterized by diagonal and o -diagonal terms, which may be written as

The quantities  $\overset{b}{G}(q;!_n = 0)$  and  $\overset{c}{G}(u)$  are related to  $\stackrel{c}{(!_n = 0)}$  and  $\stackrel{c}{(u)}$  through inversion rules that generalize the inversion of an n n hierarchical matrix to the n ! 0 limit. The inversion rules for a simple hierarchical matrix are well-known<sup>20,31</sup>, and their generalization to a situation in which the elements of the hierarchical matrix are proportional to the unit matrix { which would be the case for our matrices if the elastic system were isotropic { is trivial. However, in our case the entries of the hierarchical matrix are 2 2 matrices with a non-trivial structure. M oreover, the perturbative RG indicates we should expect the pinning properties perpendicular and parallel to the stripes to be di erent, and we need to generalize the inversion rules to allow for this possibility. W ith som e work, the m ost general inversion rules for our situation can be derived analytically, and we present this derivation in A ppendix B. A coording to Eq. (B 16), the G reen's functions are related to the self-energy by

As we proceed with our analysis, it is helpful to keep in m ind that A (f) is a spectral function, and that e  $\neq 0$  is an energy o set that in a pinned state opens a gap in the phonon spectrum, as discussed m ore fully below. Note

also that Eq. (67) indicates that  $^{\text{ret}}(!)$  at each ! point depends on the whole spectrum of A (f), and this will be complications that for this analysis cannot be avoided, as is the case for other pinned system  $s^{21,22}$ . Since quantum uctuations play a crucial role in this system, it is useful for us to de ne e ective D ebye-W aller factors via

These quantities are a measure of the mean square displacements in units of the lattice constants, and when large they indicate that quantum uctuations cannot be ignored in computing the dynamical conductivity. Clearly this will be the case in the vicinity of the quantum depinning transition. On the other hand, if W (K) are small for all K, one may expand the exponential function on the right-hand side of Eq. (68) and keep only the leading order term. Eqs. (67) then become greatly simplified, taking the form

This is called the sem iclassical approximation (SCA)<sup>21,22</sup>, and it presents a powerful simpli cation when it is valid. In particular one sees that Eq. (72) is local in the frequency, so that  $^{\text{ret}}$  (!) may be determined one frequency at a time. Unfortunately, the SCA is not valid in our present problem, and we are forced to solving the full SPE's (67) numerically. We will see how ever that the solutions have several interesting properties that give clear signatures of the depinned phase and the transition leading to it.

# C . Replica sym m etric (R S) solution vs replica sym m etry breaking (R SB) solution

Eq. (67) shows that the replica diagonal self energy <sup>ret</sup> (!) depends on the o -diagonal term s (u) through the constants e . It is instructive to rst exam ine the possible structure of (u). If (u) is a constant in u, the sym m etry of permutation of the replica indices is kept and the solution is \replica sym m etric" (RS). On the other hand, when (u) varies with u, the solution displays replica sym m etry breaking (RSB).

For m any low -dimensional systems (d 2), the appropriate solution to the SPE's is of the RSB type. O fine there is a simple \one-step RSB" solution, with (u) piecew ise constant, but stepping up or down at a single point  $u_c$  ( $0 < u_c < 1$ ). It follows from Eq. (64) that [ ]( $u_c$ )  $\in$  0 in the RSB state. On the other hand, [ ]( $u_c$ ) = 0 for the RS solution.

Following Refs. 21 and 23, one can establish a close relation between []( $u_c$ ) and e. By making use of []( $u_c$ ), Eq. (57) can be rewritten as

So e = 0 in the RS state and  $e \notin 0$  in the RSB state. The two constants  $e_x$  and  $e_y$  have signi cant physical m eanings. They may be regarded as a measure of the strength of pinning by the disorder potential and are roughly speaking proportional to the gap in the low energy magnetophonon modes. If e = 0, the phonon spectrum is gapless at q = 0 indicating the system can slide as a whole without energy cost, and is not pinned. Thus an RS solution is expected in the unpinned state. If  $e \notin 0$  as in the RSB solution, a gap opens up in the low energy magnetophonon modes, uniform sliding cannot be achieved at zero energy, and the system is pinned by disorder.

We will show in Sec.V that for < c, both  $e_x$  and  $e_y$  are nonzero and the stripes are thus fully pinned. As  $! c, e_y ! 0$ , indicating a quantum depinning transition. The solution to the SPE's is RS form otion along the stripes but RSB form otion perpendicular to the stripes. We call this type of solution to the SPE's a partial RSB state. The detailed behavior of the system in this state will be explored in Sec.VI.

### V. RESULTS FOR PINNED STATE: RSB SOLUTION

We begin by examining solutions of the SPE's for which the QH stripes are fully pinned by disorder. A coording to the RG result reviewed in Sec. IIIB, this corresponds to < c in which the disorder is relevant. In this case both

 $e_x$  and  $e_y$  are nonzero. We begin by discussing constraints on  $e_x$  and  $e_y$  which determ ine their values, allowing us to solve the SPE's without explicitly solving for (u) and  $\sim$ . We then present num erical results for the conductivity.

# A. Two constraints for $e_x$ and $e_y$

The SPE's (67) become a set of closed equations if  $e_x$  and  $e_y$  are known. Form ally,  $e_x$  and  $e_y$  need to be determined self-consistently by solving Eq. (58). The SPE's in fact have a family of solutions (parameterized by  $u_c$ ), and determining which is best generically would be determined by minimization of the free energy. In the case of spatial dimension d > 2,  $u_c$  determined this way leads to Re[(!)] !<sup>2</sup> at small!. This is consistent with arguments by M ott as well as some exact solutions<sup>29</sup> (up to a logarithm ic correction). However, for d 2, this approach can yield an unphysical result in which, in the pinned state, the conductivity shows a true gap: Re[(!)] vanishes below some gap frequency. A lternatively, one may impose the condition Re[(!)] !<sup>2</sup> at small!. It is known that the doing so generates an equation that may be understood as in posing a marginal stability on the so-called replicon mode<sup>21</sup>. A lthough this point is not fully understood, it is a common procedure that leads to physically reasonable results, and we will adopt it by imposing the condition Re[(!)] !<sup>2</sup> at small! in the pinned state. From Eq. (66), this is equivalent to Im [<sup>ret</sup>(!)] !. Note that this guarantees the magnetophonon mode density of state vanishes at zero frequency, as one should expect for a pinned system.

To obtain the explicit condition leading to  $\text{Im} [ ^{\text{ret}}(!) ] !$ , we expand the SPE's, Eqs. (67), for sm all-!. The integral over t now is dominated by the large t region. Therefore, the term  $\int_{0}^{1} df A$  (f) $e^{ift}$  in the argument of the exponential function in Eq. (68) must be sm all due to the rapidly oscillating nature of  $e^{ift}$ , leading to

This shows that the pinning of the stripes will generically be anisotropic, and serves as our second constraint for e .

The appearance of the D ebye-W aller factors W (K) in Eq. (85) has a signi cant impact: they are responsible for the change of behavior in  $^{\text{ret}}$  (!) across the depinning transition. As we shall see, whenever K  $_{\text{Y}} \notin 0$ , W (K) increases as !  $_{\text{c}}$  from below, and it eventually diverges at  $_{\text{c}}$  leading to a suppression of  $e_{\text{Y}}$ . We will discuss this in detail below. We stress that this behavior cannot be captured by the sem iclassical approximation.

### B. Num erical results

We are now in a position to solve the problem numerically. For a given pair of  $e_x$  and  $e_y$ , we use an iterative m ethod to solve for  $^{\text{ret}}(!)$  from the SPE's (67). (Typically 20-30 iterations lead to a good convergence.) The computed  $^{\text{ret}}(!)$  are then inserted in the two constraint equations (79) and (85) to generate new values of e, and the entire process is repeated until we reach self-consistency. We work in the N = 3 Landau level, although di erent Landau indices should give sim ilar results. All our calculations are obtained for a disorder level  $v_{\text{im p}} = 0.0005e^4 = l_B^2$ . This is likely to be somewhat larger than experimental values, but we choose it for numerical convenience<sup>30</sup>. We do not expect our results to qualitatively change for sm aller disorder strengths. We note that the bending term in Eq. (22) plays an in portant role of eliminating an artical ultraviolet divergence at large  $q_y$ , but beyond this has little e ect. We choose  $_b = 2$  for all the llings since this leads to a relatively fast convergence of the SPE's, although we believe the value should be som ewhat sm aller (of order 1).




FIG.3: (a) Constants  $e_x$  and  $e_y$  in units of  $e^2 = l_B^3$ , and (b) peak positions  $p_x$  and  $p_y$  in units of  $e^2 = l_B$ , as functions of in the pinned state.

Results for  $e_x$  and  $e_y$  as functions of the partial lling in the pinned state are shown in Fig.3 (a). The quantity  $e_x$  is a weak function of , but  $e_y$  decreases with increasing , and eventually vanishes at =  $_c$  ' 0:459. This is the consequence of a divergence in W (K  $_x$ ; K  $_y \in$  0) at =  $_c$ . Note  $_c$  is som ewhat larger than what was found in the perturbative RG<sup>17</sup>. This is due to the non-vanishing disorder strength; as  $v_{im p}$  decreases,  $_c$  decreases to the value found in Ref. 17.




FIG. 4: Real part of conductivity perpendicular to the stripes as a function of frequency in the pinned (RSB) state. The disorder strength  $v_{im p} = 0.0005e^4 = l_B^2$  is used. All curves start from Re[xx (!)] = 0 at ! = 0, and curves except for = 0.36 are lifted upward for clarity.

The dynam ical conductivities perpendicular to the stripes in a pinned (RSB) phase are presented in Fig. 4. For well below c 0:459, Re[xx (!)] has a pinning peak whose lineshape is qualitatively similar to what is found using the SCA.<sup>24</sup>. The prominent behavior visible in Fig. 4 is a monotonic decrease of the peak frequency px with growing , and its eventual collapse as the depinning transition is approached. The peak frequency behavior is more clearly shown in Fig. 3 (b). Notice the lineshape becomes increasingly asymmetric as the transition is approached. Experimental observations so far seem to be consistent with this<sup>15,16</sup>.




FIG. 5: Real part of conductivity along the stripes as a function of frequency in the pinned (RSB) state. The  $v_{im p}$  is the same as in Fig. 4. Curves from right to left correspond to = 0:36;0:38;0:4;0:42;0:43;0:44;0:45;0:452;0:454, respectively.

The real part of the conductivity along the stripes Re[yy (!)] is shown in Fig. 5. It also presents a pinning peak whose frequency <sub>py</sub> falls down with increasing as shown in Fig. 3 (b). But the observed peak lineshape is more interesting than that of Re[ $_{xx}$  (!)]. Below the peak frequency  $_{py}$ , in the range  $e_y < ! < _{py}$  the conductivity appears to tend toward a non-vanishing value when is su ciently below c; only for ! well below this range does one nd Re[ $_{yy}$  (!)] decreasing. The reason for this is that the quantity  $e_y$  turns out to be rather sm all [as shown in Fig. 3 (a)] due to a large Debye-W aller factor, and in this frequency range the system displays a behavior sim ilar to an incoherent m etal response<sup>32</sup>. We discuss this in m ore detail for the depinned (PRSB) phase below. For  $e_v$ , Re[ $_{vv}$  (!)] vanishes quadratically with ! (not visible on the scale of Fig. 5), as required for a pinned state. !  $_{\rm c}$ , we eventually reach a situation in which  $e_{\rm y}$  and  $_{\rm py}$  are of similar order, in which case the pinning Αs ! peak sharpens and grows quite large. This peak continuously evolves into a -function at zero frequency as the system enters into the PRSB state, so that the transition from pinned to depinned behavior is very continuous.

Interestingly, as shown in Fig. 3,  $e_y ! 0$  governs the vanishing of both  $p_x$  and  $p_y$ . To understand this, we note that there are two gapless collective modes in the absence of the magnetic eld; the magnetic eld mixes them into two other modes, one of which is at a high value (order of ~!<sub>c</sub>), leaving the other (magnetophonon) mode as the only gapless one. It is this single mode that responds to the electric eld, albeit in an anisotropic manner in the x and y directions. Technically, at !  $p_x$ ;  $p_y$ , ret (!) obeys Eqs. (77–78), and the longitudinal conductivities in Eq. (66) become

## VI. RESULTS FOR DEPINNED STATE: PARTIAL RSB (PRSB) SOLUTION

For  $_{c}$  the state is characterized by  $e_{x} \in 0$  but  $e_{y} = 0$ . As discussed in Sec. IV C, this corresponds to a RSB solution for  $_{x}$  (u) but a RS solution for  $_{y}$  (u). We call this the PRSB state. This state has various interesting properties that we will present below.

# A. Power law behavior for $\gamma_v^{\text{ret}}$ (!)

From the results of the perturbative RG, we expect the stripes to remain pinned for motion in the  $\hat{x}$  direction even as the stripes become depinned for motion in the  $\hat{y}$  direction. We therefore assume that in the PRSB state, the small-! asymptotic behavior of  $\sum_{x}^{\text{ret}}$  (!) remains the same as that in the RSB state [Eqs. (77-78)], and this turns out to yield a self-consistent solution. However,  $\sum_{y}^{\text{ret}}$  (!) is qualitatively diment in the depinned state. To see this explicitly we exam ine the SPEs (67) for  $\sum_{y}^{\text{ret}}$  (!),

The quantity  $A_y$  bears a singular 1=f term which is responsible for the unusual feature of  $\frac{2}{y}$  (!). In contrast,  $A_x$  (f) can be easily shown to converge to a constant at small f. Here  $_{!}$  is a high-energy cuto of order the m agnetophonon band width. Inserting Eq. (95) into Eq. (88) and keeping only the leading-order terms in ! we produce Eqs. (89-90) provided Eq. (91) is met. For larger values of , the solution is not self-consistent, and one must revert to the full RSB (pinned) solution.

Equations (89-91) are the criteria for the existence of a PRSB solution. The inequality (91) de nes a critical value  $_{c} = 1.5$  ince in Eq. (96) increases monotonically with , this critical value corresponds to a critical lling

c. Our num erical result shown below in Sec.VIC indicates that  $_{\rm c}$  obtained this way matches nicely with the critical lling de ned in the RSB state through the collapse of the pinning peaks. One can also see that in the vanishing disorder limit (e<sub>x</sub>; y! 0), reduces to 0 de ned in Eq. (36) that occurs in the RG ow equation (34), and the condition (91) matches the RG condition for the irrelevance of the disorder. Technically, the reason these coincide originates from the similar ways in which the Green's function enters in the SPE (88) and in the calculation of the scaling dimension of the impurity term in the RG analysis. The minor di erence is that the GVM includes the renorm alization of the Green's function by disorder, while the RG analysis, being perturbative, uses the G reen's function for the pure system . h i




FIG. 6: Low-frequency exponents (a)  $_{y}$  of Im  $_{y}^{ret}$ , and (b)  $_{x}$  of Re[ $_{xx}$  (!)] and  $_{y}$  of Re[ $_{yy}$  (!)], as functions of the partial lling  $.v_{imp}$  is the same as in Fig.4.  $_{c}$  ' 0:459 m arks the quantum depinning transition point and  $_{c}^{0}$  corresponds to the second transition point at which the system changes its behavior from divergent as !! 0 to m etallic. C incles are the num erical result.

In both the RSB and the PRSB states,  $\operatorname{Im}_{y}^{\operatorname{cret}}(!)$  shows power-law behavior  $\operatorname{Im}_{y}^{\operatorname{cret}}(!)$  !  $\stackrel{}{}$  Eqs. (78) and (90)], although the exponent is xed at 1 for the RSB state. Plotting  $_{y}$  as a function of the partial lling in Fig. 6 (a), we see that  $_{y}$  jumps from 1 in the RSB state to 2 in the PRSB state. This jump arises from an underlying jump in the low-frequency exponent in Re  $_{y}^{\operatorname{cret}}(!)$  (from 0 in the RSB state [Eq. (77)] to 2 in the PRSB state [Eq. (89)]). Such jumps are typical for a KT-type phase transition. In the next subsection we will show the corresponding jumps in the low-frequency exponents in conductivities.

### B. A nom alous low -frequency exponents for conductivities

The unusual low-frequency exponents of  $\frac{2}{y}$  (!) directly a ect the low-frequency behavior of the conductivities. Inserting Eqs. (77-78) and (89-90) in Eq. (66) we nd that at small!,

The most signi cant feature in Re[ $_{yy}$ (!)] lies in the peak at ! =  $0^{34}$ . Physically, this means that the PRSB phase is a superconducting state, and the system manages to nd an elective free path to slide along the stripes. By contrast, Re[ $_{xx}$ (! ! 0)] = 0, im plying the system is insulating for motion perpendicular to the stripes. This suggests that the PRSB state has in nite anisotropy in the DC conductivity. This is not observed in DC transport experiments<sup>5</sup>, and we comment in Sec. V III on what is missing from our model that we believes leads to this discrepancy.

The other two terms in Eq. (97) and the terms in Eq. (98) in ply an incoherent contribution at !  $\notin$  0. Interestingly, these terms compete with each other in determining the low-frequency exponents of the conductivities, leading to

a second transition. For 1 < 2, the second term in Eq. (97) and the rst term in Eq. (98) dominate, so that  $!^{(2)}$  which diverges as  $! ! 0^{35}$ . This is a very unusual nite frequency response, which arises Re[<sub>vv</sub>(!)] from the form of the G reen's function in the PRSB state and so appears to be specic to this system just after the depinning transition. The response perpendicular to the stripes is insulating but also anom alous, Re[xx(!)]increases with the lling , the low-frequency exponents of Re[vv(!)] and Re[vx(!)]with non-integer. Thus, at  $^{0}_{c}$ , the system experiences a second transition in which the nite-frequency behavior of the stripes changes. The conductivities thus have a very unusual low-frequency behavior for a small window of lling factors,  $_{\rm c}$  <  $_{\rm c}^0$ . Interestingly, such changes in power-law behavior above a KT transition is known to occur in other contexts<sup>36</sup>. The qualitative result of the unusual low-frequency behavior for a small window of lling factors,  $_{\rm c}$  < low -frequency exponents ofRe[ (!)] discussed here can be seen in Fig. 6 (b). The num erical values of  $\frac{0}{2}$  for our calculations will be discussed in the next subsection. As also shown in Fig. 6 (b), both  $_{\rm x}$  and and jum p at the depinning transition point c•

In practice, the visibility of the various term s in Eqs. (97) and (98) depends on the relative size of the coe cients of each term, which we discuss in the next subsection.

### C . Constraint for $e_{\boldsymbol{x}}$ and num erical result for the conductivities

To obtain quantitative results for the conductivities in the PRSB state, we need to numerically solve the SPEs (Eqs. 67) together with the constraint for  $e_x$ . This constraint can be obtained, under the assumption of the existence of linear-! term in  $\sum_{x}^{ret} (!)$  at small !, from the rst constraint Eq. (79) in the pinned state by examining the limit  $e_y$  ! 0. It is easy to nd that  $g_{xx}$  const;  $g_{xy}$   $\frac{1}{2}e_y^2 = 1$ , and  $g_{yy}$   $\frac{1}{2}e_y^2 = 2$ . On the other hand,  $e^{W(K_{x0};0)}$  tends to a non-vanishing constant as  $e_y$  ! 0, while both  $e^{W(0; K_{y0})}$  and  $e^{W(K_{x0}; K_{y0})}$  scale as  $\frac{1}{2}e_y j^{(+2)=2}$ , where was de ned in Eq. 


FIG. 7: Exponents and  $_0$ , de ned in Eqs. (96) and (36), respectively, as functions of . The values = 1 and  $_0 = 1$ de ne the depinning transition point  $_{c}$  for  $v_{imp} = 0.0005e^4 = l_{p}^2$  and  $_{c}^{(0)}$  in the pure limit, respectively.

In Appendix D, we discuss another way of satisfying Eq. (100) which leads to an unphysical solution.

We have carried out numerical calculations of the exponents and conductivities for the llings 0:46;0:463;0:466;0:47;0:48, all of which are in the PRSB state. Results for are shown as squares in Fig. 7. Clearly, increases monotonically with lling factor. Notice that at = 0:46 is very close to the critical value 1, and by an extrapolation we conclude that c' 0:459. By comparing with Fig.3 in the RSB state, we nd that С agrees with that from the RSB state, yielding a non-trivial check on our num erics. In Fig. 7 we also plot 0 (circles) which is computed from Eq. (36) in the pure lim it. The critical  $_0$  results in a critical lling at the vanishing disorder  $_{\rm c}^{(0)}$  / 0:432. The result of  $_{\rm c}$  >  $_{\rm c}^{(0)}$  rejects the fact that a stronger disorder strength makes pinning lim it m ore likely and so increases . As we mentioned before, the disorder level we choose is most likely larger than the experim ental situation. We expect that in the experim ental parameter regime the critical lling for the quantum depinning transition for N = 3 is some value between 0:432 and 0:459.

The numerically computed values of y, x and y are shown as circles in Fig. (6). We nd <sup>0</sup>′ 0:467.

Our num erical result also con m s the low energy behavior of the self-energy Eqs. (77-78) and (89-90). In Tab. 1, we present the coe cients of the leading term s of the self energy. It is clear that  $e_x$  is nearly a constant, and xapproaches and  $v_{\rm v}$  are also moderate functions of  $v_{\rm v}$ . But  $v_{\rm v}$  increases drastically as <sub>c</sub> from above.Wewill comment on this in Sec.VII.

It is important to note that the coe cients we nd for s  $_{v1}$  are numerically very small (see Table I), so that the anom abus divergence near ! = 0 can only be visible at very sm all frequencies. This suggests that the divergence may be in practice di cult to observe, and indeed it is beyond the num erical accuracy of our calculations too because the frequency grid required would be much  $\,$  ner than can practically be achieved. For frequencies of order ! > 10  $^5$  we nd that the anom alous divergence cannot be seen (for the param eters of our calculation) and the nite frequency

response appears to be that of an incoherent metal. Interestingly we nd that the incoherent contribution to the




FIG. 8: Real part of conductivity perpendicular to the stripes as a function of frequency in the depinned (PRSB) state. The value  $v_{im p} = 0.0005e^4 = l_E^2$  is used. Curves from left to right correspond to = 0.46;0.463;0.466;0.47 and 0.48 respectively. Note that the low energy pinning mode is absent in the PRSB.

dynam ical conductivity becomes sharply peaked for ! < :001, but this levels o to a constant when the frequency becomes small enough.

Numerical results for the conductivities perpendicular to the stripes at various llings are shown for a fairly large frequency range in Fig. 8. The low-energy pinning mode is absent, and there is instead a broad peak at high frequencies. We would like to remark that the result at such high energy scales should be taken with a grain of salt, as our elastic model only reproduces the excitation spectrum of the quantum H all stripes for low energies. The peak may be interpreted as being due to a maximum in the phonon density of states that occurs in the elastic model, and is not a pinning peak. For much lower frequencies where our computation is accurate, Re[ xx (!)] shows the power law behavior as expected. For = 0.47 and 0.48 which are larger than  $\binom{0}{c}$ , the anticipated Re[ xx (!)]' !<sup>2</sup> is not visible within our numerical accuracy. As shown in Table I, the coe cient of the !<sup>2</sup> term, S<sub>x2</sub>, is much smaller than that of the ! term, S<sub>x1</sub>, for = 0.47 and 0.48, again requiring a very ne ! grid to observe. Thus in practice one may observe the anom alous power law dependence over a relatively large range of lling factors.

# VII. QUANTUM DEPINNING TRANSITION -KT UNIVERSALITY CLASS

In the previous section, we observed jumps in the low-frequency exponents of  $\gamma_y^{\text{ret}}$ ; Re[<sub>xx</sub> (!)] and Re[<sub>yy</sub> (!)] at the quantum depinning transition point. In this section, we discuss the connection of these jumps with the universal jump in the super uid sti ness and the critical exponent of correlation functions of the KT transition<sup>26</sup>.

The depinning transition we have found is of the KT form, as is clear from the perturbative RG analysis<sup>17</sup>. Inserting the smectic form of D<sub>yy</sub> (q) in Eq. (24) into the action (40) one can see that  $d_{yy}$  ( $q_x$ ) acts as an elective still ness along the stripes direction. The action in Eqs. (39)-(41) for the stripes phase then can be viewed as a generalized quantum sine-G ordon model: for  $v_{im p} = 0$ , the action behaves as a collection of 1+1 dimensional elastic system s, one for each  $q_x$ ; the impurity term couples these system s. As is well-known, the two-dimensional classical sine-G ordon model supports a roughening transition<sup>33</sup>, which form ally is closely related to a smectic-to-crystal transition, and is a dual description of the KT vortex unbinding transition<sup>33</sup>.




FIG.9: Coe cient of the quadratic in frequency term in Re  $y^{(ret)}$  as a function of the partial lling in the depinned (PRSB) state. Inset: Re  $y^{(ret)}$  as a function of  $!^2$ . Curves from top to bottom correspond to = 0:46;0:463;0:466;0:47;0:48, respectively.

An interesting aspect of our system is that, in the pure limit, there is no term that is quadratic in ! in either diagonal component of the G reen's function, so that there is no analogue of  $d_{yy}(q_x)$  in the time direction. However, such a term is generated in the self-energy as a result of the variational method when the disorder is present, even in the depinned state. Writing Re  $\gamma^{ret}(!)$  '  $_{y}!^{2}$  for small !, we plot  $_{y}$  as a function of partial lling factor above the transition in Fig. 9. One can see the sharp increase as the transition is approached. Such an increase is consistent with the usual RG for the roughening transition, for which the sti ness increases in the RG ow s, although one needs to go to higher order in perturbation theory than was undertaken in Ref. 17 to see this. We note nally that  $_{y}$  cannot increase inde nitely: as it increases, the value of (Eq. (96)) decreases, eventually crossing the critical value and forcing the system into the fully pinned state. In this state, Re  $\gamma^{ret}(!)$  '  $_{y}!^{2}$  no longer vanishes as  $q_{y};!$  0,

but rather goes to a constant. This can be roughly interpreted as a system with an in nite sti ness, so that one may associate the transition with a jump in  $_{\rm v}$  from its critical value to in nity.

# VIII. CONCLUSION

In this paper, we have used replicas and the Gaussian variationalm ethod to calculate the nite-frequency conductivity of QH stripes in order to see its detailed behavior in the vicinity of the quantum depinning transition. The low-energy degrees of freedom of the QH stripes are described within an elective elastic model that is characterized by a dynam ical matrix which is determined by matching to microscopic TDHFA calculation. Our results show that in the pinned state for c, the system is in an RSB state, and the conductivities have resonant peaks < for excitation both parallel and perpendicular to the stripes. As approaches c from below, a Debye-W aller factor W (K  $_{x}$ ; K  $_{y} \in 0$ ) increases and eventually diverges at =  $_{\rm c}$  , resulting in a vanishing pinning energy  $e_{\rm v}$ > c, the system enters a new state with partial replica symmetry breaking for motion along the stripes. For (PRSB), in which the solution has RSB perpendicular to the stripes, but is replica symmetric along them . In this state Re[vy(!)] has a superconducting response at zero frequency and an anom alous power law behavior for both  $Re[_{xx}(!)]$  and  $Re[_{yy}(!)]$  for just above the critical value. Moreover, there are jumps in the low-frequency exponents of both the self-energy and conductivities at the transition point, as one m ight expect for a KT transition.

We conclude by discussing a prominent discrepancy between our results and those of existing experiments. In DC transport, one observes metallic behavior with nite anisotropy rather than the in nite one found in the PRSB state. We believe the missing ingredients from our model are processes allowing hopping of electrons between stripes. These processes are very dicult to incorporate into an elastic model. It is clear that, if relevant in the RG sense, such processes can broaden the -function response to yield anisotropic metallic behavior. Our results should apply at frequency scales above this broadening. Indeed, microwave absorption experiments become quite challenging at low frequencies, and it is unclear whether existing measurements of the dynamical conductivity can access the low frequency conductivity in the unpinned state, whether or not it is broadened. In any case, it is interesting to speculate that a true -function response might be accessible in structured environments where barriers between stripes may suppress electron hopping am ong stripes<sup>37</sup>, or that there may be analogous states for layered 2+1 dimensional classical system s of long string-like objects, which has been show n<sup>11</sup> to be closely related to the two-dimensional quantum stripe problem.

# APPENDIX A: SUMMARY OF HF AND TDHF FORMALISMS

In a previous work<sup>7</sup>, two of us have shown that, in the HFA, the smectic state (as in the edge state model<sup>8</sup>) is unstable with respect to density modulations along the direction of the stripes. The ground state of the twodimensional electron gas near half lling of the higher Landau levels is instead an anisotropic two-dimensionalW igner crystal with basis vectors  $R_1 = (0; a_y)$  and  $R_2 = (a_x; a_y=2)$ . (One can also see this crystal as an array of 1D W igner crystals with out-of-phase modulations on adjacent 1D crystals). The electronic density of this crystal is fully determined by the Fourier components of the electronic density flom (K) ig where K is a reciprocal lattice vector of the oblique lattice shown in Fig.1.



# APPENDIX B: INVERSION RULES FOR MATRICES

The inversion rules for hierarchical matrices in the n ! 0 limit for the case where the entries are scalars may be found in Ref.<sup>20</sup>. In this appendix we generalize these inversion rules for the situation when the entries are them selves  $n_0 = n_0$  matrices, with our problem corresponding to  $n_0 = 2$ .




FIG. 11: Real part of conductivity perpendicular to the stripes (a) and parallel to the stripes (b), in the unphysical solution. Curves from right to left correspond to = 0.46;0.44;0.42;0.4;0.38, respectively. Smaller disorder strength  $v_{im p} = 0.0001e^4 = l_B^2$  is used. Inset in (b): Peak frequencies as functions of the partial lling.

In our numerical search, we also notice the existence of another solution which we present here and argue is unphysical. Fig. 11 shows the result of the conductivities from this solution which corresponds to a much smaller disorder level. Both Re[ $_{xx}$  (!)] and Re[ $_{yy}$  (!)] show the pinning behavior and the peak frequencies move in as also shown in the inset of Fig. 11 (b). However, unlike in the solution we presented in the text, no quantum depinning transition occurs.

Interestingly, this solution displays a peak move-in behavior that is rem iniscent of what is seen in the physical solution. This is the result of a decreasing  $e_y$ , due to the increasing W (K<sub>x</sub>;K<sub>y</sub>  $\in$  0) with the partial lling . However, at small  $e_y$ , unlike in the other solution, the constraint (100) is not satis ed through  $U_{xx} = 1$ , but instead through  $U_{yy} = 1$ . This can be seen from Eq. (99), according to which  $U_{yy}$  will rapidly decrease from very large values to very small values right near = 1. This means that near this value  $U_{yy}$  must pass through one, satisfying the constraint. In this solution, remains very close to one over a range of lling factors, and does so by making  $j_x j$  very large, even for small  $v_{im p}$ . This im plies an unphysically large pinning for sliding perpendicular to the stripes. Because of this, and the close agreem ent between the other solution and the perturbative RG results, we ignore this solution to the SPE's as physically unreasonable.
