Lam ellar phase separation and dynam ic competition in La<sub>0.23</sub>C a<sub>0.77</sub>M nO<sub>3</sub>

We report the coexistence of lam ellar charge-ordered (CO) and charge-disordered (CD) domains, and their dynamical behavior, in La $_{0.23}$ Ca $_{0.77}$ M nO $_3$ . Using high resolution transmission electron microscopy (TEM), we show that below TCD 170 K a CD-monoclinic phase forms within the established CO-orthorhom bic matrix. The CD phase has a sheet-like morphology, perpendicular to the q vector of the CO superlattice (a axis of the Pnm a structure). For temperatures between 64 K and 130 K, both the TEM and resistivity experiments show a dynamic competition between the two phases: at constant T, the CD phase slowly advances over the CO one. This slow dynamics appears to be linked to the magnetic transitions occurring in this compound, suggesting important magnetoelastic elects.

Decades of research have yet to completely understand the full range of ordered phases that occur in the  $A_{1 \times} A'_{x}M$  nO  $_{3}$  perovskites (A = La, Pr, Nd and A' = Ca, Sr, Ba) [1]. For x 0.5, a complex competition occurs among ferrom agnetic (FM), param agnetic (PM), and charge-ordered (CO) antiferrom agnetic (AFM) phases. In this regime, inhom ogeneous phase separation (PS) gives rise to the well-known ColossalM agnetoresistance (CMR) e ect [2, 3, 4]. This regime has been widely studied and is reasonably well understood in terms of disorder-induced PS [3, 5], which produces a fractal-like morphology of the coexisting domains [4].

Less well exam ined, and far richer, behavior is found 1=2. In this region, electron m icroscopy and other spectroscopic tools nd strong evidence for the appearance of charge ordering. The CO phases are characterized by the appearance of superlattice di raction spots with a wave vector q = 1 x, corresponding to real-space \stripes" with a period a=(1 x), perpendicular to the a axis of the orthorhom bic perovskite structure (Pnm a space group) [6]. As the temperature is lowered below the CO transition at  $T_{CO}$ , neutron scattering shows the emergence of AFM ordering of the Mn moments at  $T_N < T_{CO}$  [7]. Because charge is discrete, we would expect a robust CO phase to occur at rational values of x; i.e. at x = 1=2, 2=3, 3=4 ... Indeed, for x = 2=3 a fully com m ensurate CO/AFM state appears. Surprisingly, P issas and K allias [8] reported recently that the x = 3-4state is unstable, phase separating into a CO/AFM state sim ilar to the x = 2=3 structure, and a C-type AFMphase not unlike that for x = 0.80 [9]. In this paper, we demonstrate that this PS is dynamic, and results in lam ellar charge-disordered regions that grow in number and size below a charge disordering temperature  $T_{\text{CD}}$  . Both the structure of the lam ellae, and the appearance of additional Bragg peaks indicate that this separation also involves a change in crystal structure. We monitor the

evolution of the phases through tim e-dependent m easurements of resistivity, m agnetization, and high-resolution transm ission electron m icroscopy (TEM) im ages.

O urpolycrystalline sam ple La<sub>0:23</sub>C a<sub>0:77</sub>M nO<sub>3</sub> was prepared by the nitrate decom position route, as described elsewhere [10], with a nal sintering process at 1500 C for 24h. In-situ tem perature dependent dark eld electron in aging and electron di raction were carried out using the JOEL 2010F (200 kV) transm ission electron microscope under the experimental conditions previously described [11]. Magnetization (M) measurements as a function of temperature were performed using a commercial SQUID magnetometer. The M data were obtained by warming the sample in a magnetic eld H = 100 O e after zero-eld-cooling (ZFC) and eld-cooling (FC) processes from 300 K to 10 K. The resistivity () was measured by the usual four probe method.

Figure 1 shows the temperature driven evolution of the microstructure of a selected region of the sample, recorded by high resolution dark eld imaging using a fundam ental re ection and the two corresponding CO superlattice spots. At T = 175 K [Fig. 1(a)] the stripe-like contrast form ed by the interference between these three re ections is evident [6, 11]. In magnetization measurements, the onset of the CO phase is indicated by a peak in the M (T) curve, as shown in the inset of Fig. 2. The occurrence of this peak was ascribed to the freezing of the double exchange interaction due to the localization of the charge carriers below  $T_{CO}$  ( 220 K in our case). However, contrary to the nearly uniform CO phase present at 175 K, in Fig. 1(b) (T = 145 K) it can be seen that som e non-striped \bands" (sheets in 3D) nucleate inside the CO regions. The disappearance of the CO stripes indicates that these bands are undergoing a transition to a charge-disordered (CD) phase, which starts to occur 170 K. As the tem perature is lowered the CD regions grow in both number and size, and the im age in

Fig. 1 (c) at  $T=99\,\mathrm{K}$  (the low est achievable tem perature for our  $T\,\mathrm{EM}$ ) exhibits a substantial amount of the CD phase. The picture presented in Fig. 1 (d) shows a larger area (0.6 m wide) indicating that the appearance of this CD phase is not a local e ect, but is spread throughout the sample with domain sizes ranging from 10 to 30 nm wide.

Several in portant observations can be made from the images shown in Fig. 1. First of all, the CD phase cannot be attributed to a chemical segregation or composition variations in the sample. The CD domains occupy the same regions where the homogeneous CO phase was present at higher temperatures. Moreover, repetitions of the same experiment show similar images, but the CD areas do not always appear at the same locations in the sample, i.e. the CD phase is not pinned to defects.

Secondly, the morphology of the lamellar phase coexistence is striking. The minority CD domains appear as sheets embedded within the CO phase, where the domain walls separating both phases are nearly perpendicular to the a axis of the orthorhom bic perovskite structure. This consideration indicates that, contrary to previous results in other phase separated manganites [3, 5], random disorder hardly could be responsible for the coexistence of phases observed in La<sub>0.23</sub>Ca<sub>0.77</sub>M nO<sub>3</sub>. In this kind of phase separation, the elastic energy must play a fundamental role in order to produce such smooth domain walls with their normals determined by the [100] propagation direction of the CO structural distortion.

In order to determ ine the nature of the CD phase we studied the electron di raction (ED) pattern of the sam ple at T = 175 K [inset of Fig. 1(a)] and T = 99 K [inset of Fig. 1 (c)]. It can be observed that around the fundamental re ections [(104) is shown] the superlattice spots of the CO phase show up at both temperatures. These CO spots appear right below  $T_{CO}$ , with a wave vector 0.23(1) indicative of the doping level x 0:77. In addition to these spots, the white arrows in the inset of Fig. 1(c) signal the presence of another set of re ections near the strong fundam ental one. These re ections are totally absent for T >  $T_{\text{C}\;\text{D}}$  , indicating that they are related to the CD phase. These satellite re ections were indexed to a m onoclinic phase sharing the com m on a and baxis with the CO-orthorhom bic phase, but with the c axis tilted by an angle of 1:3 from the orthorhom bic structure. The two spots at each side of the fundam entalre ection correspond to di erent monoclinic domains with the positive and negative tilting angle, respectively.

Therefore, below  $T_{CD}$  we observe the coexistence of the CO-orthorhom bic (CO-O) and CD-m onoclinic (CD-M) phases. The observation of the secondary CD-M phase is consistent with neutron scattering measurements [8], where 25% of the volume of  $La_{1=4}Ca_{3=4}M$  nO  $_3$  samples was found to belong to the P $_{21}$ =m monoclinic space group at low T. Also the temperature  $T_{CD}$  170 K coincides with the appearance of extra magnetic rejections

in the neutron di raction pattern. These re ections were associated to the monoclinic phase which adopts the C- type AFM structure [9].

In our magnetization curves (in set of Fig. 2) the proxim ity of the prominent \CO peak" hinders the observation of the AFM transition related to the appearance of the CD-M phase. However, the M (T) data present some other curious features. As the temperature decreases, the splitting between the ZFC and FC curves becomes significant below T<sub>S</sub> 130 K , and at  $T_{\rm C}$ 64 K a sm all but clear magnetization increase occurs. While Ts indicates the PM to AFM transition of the CO phase, the weak FM moment showing up at Tc is related to the monoclinic phase [12]. Figure 2 plots the curve of the reduced magneticmomentm (T) = M  $_{\rm F\,C}$  =M  $_{\rm Z\,F\,C}$  , where M  $_{\rm F\,C}$  and M  $_{\rm Z,F,C}$  are the m agnetization values for the FC and ZFC processes, respectively. At high tem perature the reduced m om ent rem ains close to m = 1, as expected for a norm al PM phase. On the other hand, as soon as the CO phase is formed m starts to increase. Since im mediately below  $T_{\text{CO}}$  the CO phase does not adopt any magnetic order, the value m > 1 indicates the presence of defects within the CO background with a \glassy" response to the application of a magnetic eld. The other two magnetic transition temperatures,  $T_{\text{S}}$  and  $T_{\text{C}}$  , are characterized by abrupt breaks in m (T).

The most curious characteristic of this CO-CD phase coexistence precisely occurs between the two magnetic transitions, i.e for  $T_C$  < T <  $T_S$  . In this temperature range, we observed an anomalous dynamic regime by measuring the temporal relaxation of the resistivity. Figure 3 presents data as a function of time for selected tem peratures, recorded over periods of 3 hours. For each curve, the sam ple was warm ed up to 300 K and then cooled back at 4 K/m in and stabilized at the measuring tem perature within  $2 \text{ m K} \cdot \text{For } T_S < T < T_{CO}$  the resistivity increases with time. This e ect is present even above  $T_{CD}$ , indicating that it is not related to the phase coexistence but is a property of the CO-O phase itself. Moreover, we observed the samee ect in the CO-O phase ofLa<sub>1=3</sub>Ca<sub>2=3</sub>M nO<sub>3</sub> sam ples, where the CD-M phase was not observed in the TEM studies [11]. For x = 0.77, the increase of resistivity with time is correlated with an increase in the intensity of the CO superlattice re ections (not shown), which indicates that the CO phase is becoming more ordered with time [12]. This behavior supports the existence of mobile microscopic defects in the CO-O phase, which are responsible for the aforem entioned glassy response observed in m (T) for T < T $_{\text{CO}}$  . The ability of these defects to migrate outside the CO volum e provides the mechanism for the improvement of ordering with time.

In the inset of Fig. 3 we show the logarithm ic relaxation rate  $S=d(\log t)=d(\log t)$  as a function of temperature, obtained from the time interval between 10 and 20 m inutes. The positive values of S for  $T>T_S$  relate to the

increase of with time. A similar time evolution (S > 0)is observed for T below  $T_C = 64 \text{ K. Surprisingly, in the}$ interm ediate region  $T_C$  < T <  $T_S$  the relaxation rate changes sign (S < 0) and the resistivity decreases with time. Remarkably, the changes in the dynamical behavior coincide with the magnetic transitions at  $T_{\text{S}}$  and  $T_{\text{C}}$  . In order to gain some insight on the dynamic properties of this compound we obtained dark eld images of a given region of the sam ple at dierent times. As shown in Fig. 4, when the sample is cooled to T = 99 K (at approxim ately 4 K/m in) the phase separation pattern evolves with time. Figure 4(a) shows that immediately after the sam ple is stabilized at 99 K the CD-M phase occupies a small part of the volume. However, some regions of the sam ple undergo a transition from the CO-O to the CD-M phase (see the fram ed region for example), and the volum e fraction of the latter keeps increasing with time. At 30 m inutes after the tem perature is reached [Fig. 4(d)] the CD-M phase occupies an appreciable fraction of the area of the im age. Beyond t = 30 m inutes the relaxation becomes very slow, and no obvious change was observed in the images. It is worth mentioning that similar relaxation e ects were also observed at T = 115 K.At T = 125 K the time evolution of the pattern is very slow and at  $T = 135 \,\mathrm{K} \ (> T_{\mathrm{S}})$  it becomes unobservable. Thus, all these structural changes have an absolute correlation with the resistivity relaxation.

The above results present a consistent scenario of the com plex dynamic competition between the CO and CD phases for T below  $T_{\text{S}}$  . It is well known that a chargeordered phase provides a strong insulating state due to the localized nature of the charge carriers on well-de ned M n sites. Di erently, the particular C-type AFM structure of the CD-M phase consists of antiferrom agnetically coupled FM chains, inside which the double exchange interaction [13] favors the delocalization of the charge carriers [9]. As a result, even though the AFM nature of the CD-M phase also produces an overall insulating state, the carriers' motion along these one-dimensional paths leads to a reduction of the resistivity. Therefore, contrary to the case of the upward relaxation, for  $T < T_S$ the negative d =dtm ust be due to the slow growth of the CD-M phase in the CO-O matrix. For T < 64 K, the return of the relaxation rate towards positive values indicates that the motion of the boundaries between the two phases is stopped again.

A peculiar feature about the interplay between magnetic, electronic, and structural degrees of freedom in La $_{0.23}$ Ca $_{0.77}$ M nO $_3$  is that the occurrence of a magnetic phase transform ation is able to induce a change in the dynam ic properties of the phase coexistence. The new magnetic order that appears below  $T_s=130~{\rm K}$  triggers the motion of the domain walls that separate the CO-O and CD-M domains. At lower temperature, the appearance of a FM component is able to freeze this motion again, driving the system back to a static phase sepa-

rated state. This behavior in plies the existence of strong magnetoelastic e ects [14]. Indeed, a magnetostrictive response was already observed [9] at the Neel temperature of the (orthorhom bic) G-type AFM structure in La<sub>0:12</sub>Ca<sub>0:88</sub>M nO<sub>3</sub>. This magnetic transition was also found to have an appreciable impact on the structural properties of the also present C-type AFM phase. It was previously argued that the large strain produced by the CO state on the borders of the domains greatly affects the physical properties of phase separated manganites, producing martensitic-like features [15]. In the case of our La<sub>0:23</sub>C a<sub>0:77</sub>M nO<sub>3</sub> sample, a change in the magnetic structure of the coexisting phases would produce a change in the strain elds at the boundaries between them, thus a ecting the delicate energy balance of the system and allowing (or precluding) the migration of the dom ain walls.

Sum m arizing, the close correlation between the high resolution TEM images and the physical properties allowed us to obtain a complete picture about the phase separated state in the La<sub>0:23</sub>C a<sub>0:77</sub>M nO<sub>3</sub> m anganite. Below the CO transition at  $T_{CO}$ 220 K the high resolution im ages show the typical CO stripes fully formed in the whole sample. However, on further cooling below  $T_{CD}$ 170 K som e non-€0 lam inated regions with a monoclinic structure form within the CO-orthorhom bicm atrix. The particular morphology of the charge-disordered domains and the simultaneity of magnetic and dynamic transitions observed at lower temperatures indicate that the CO-CD phase coexistence in this manganite must be driven by magnetoelastic e ects rather than being dictated by disorder. The fundam ental question that remains open is what is the real ground state of the electron doped manganites. For x 0:77, contrary to the widely expected CO phase, the present results support a monoclinic C-type-AFM ground state. The realization of such phase seems to be only impeded by the inability of the domain walls to move out of the sample fast enough, stopped by the strain elds induced by the hightem perature CO phase.
