## Program LM TART for Electronic Structure Calculations

A computer program LM TART for electronic structure calculations using full potential linear mu n{tin orbitalmethod is described.

## I. DESCRIPTION

Full{potential linear{mu n{tin{orbital (Ref.<sup>1</sup>) (FP{ LM TO) program LM TART is designed to perform band structure, total energy and force calculations of solids using methods of density functional theory (DFT) (Ref.<sup>2</sup>). The development of LM TART has been initiated in 1986 in PN. Lebedev Physical Institute. It was further extensively developed in Max{Planck Institut fur Festkorperforschung, and its most recent contributions have been done in Departments of Physics of Rutgers University and of New Jersey Institute of Technology.

LM TART performs electronic structure calculations using popular local density approximation (LDA) and generalized gradient approximation (GGA) of density functional theory<sup>2</sup>. To deal with strongly correlated systems it also implements LDA+U method<sup>3</sup> and will include the capability to study materials using spectral density functional approach and dynamical meaneld theory (DMFT)<sup>4</sup> in the nearest future. For determining equilibrium crystal structure and phonon spectra LM – TART computes total energies, forces<sup>5</sup> as well as full wavevector dependent lattice dynamics<sup>6</sup> using linear response theory. For studying optical spectral functions LM TART evaluates dipole matrix elements between various electronic states and can determ ine optical conductivity of materials.

The code im plements atom centered local mun{tin orbitals as a basis for representing one{electron wave functions in both bare and screened (tight{binding) representations with general choice of tail energies <sup>2</sup>: This allows to increase accuracy in the calculations by using multiple{ LMTO expansions. Low lying core electronic states can be resolved as bands in separate energy panels. For heavy elements, spin {orbit coupling matrix elements can be taken into account using a variational procedure proposed by Andersen<sup>1</sup>. Full three dimensional treatm ent of m agnetization in relativistic calculations including LDA + U is in plem ented to study problem s related to m agnetic anisotropy and non { collinear m agnetism . E ffect of nite tem perature can be modelled by introducing Ferm i statistics for the one{electron states. A dditionally, LM TART can determ ine tight { binding ts to the energy bands by extracting hopping integrals between various orbitals using tight { binding LM TO representation.

LM TART is written on FORTRAN 90 and uses dynam icalm em ory scheme. No additional recom pilation of the code is required when changing num bers of atoms, spins, plane waves, etc. There are two basic regimes for working with this program : the self{consistent charge density calculation and calculation of physical properties such as electronic structure, optical properties, etc.. The sim plest input to LM TART involves only atom ic charges of the atom s as well as crystal structure.

LM TART works with two di erent approxim ations related to a shape of the potential: (i) atom ic sphere approximation (ASA) and plane wave expansion (PLW). A SA uses overlapping atom ic spheres, where the potential is expanded in spherical harm on ics inside the spheres, but any contribution from the interstitial region is neglected. Such method is fast and provides reasonably good energy bands. However it is not su ciently accurate to deal with distortions and phonons. PLW is a full potential approxim ation which uses non {overlapping mun{tin spheres, where the potential is represented via spherical harm onics expansions, and the interstitial region where the potential is expanded in plane waves. The full potential regime provides the best accuracy at the price of increasing computational time. Finally, LM -TART can be run in a special tight { binding regime by supplying hopping integrals between various orbitals.

Two extensions of LM TART are available as separate program s. One is a full{potential linear{response linear{ mu n{tin{orbital package LM TO PHONONS which is designed to perform linear{response calculations of the phonon spectra for arbitrary wave vectors q. M ain features of this code include: (i) C om putations of rst{order changes in the charge density and the potential due to displacements of nuclei for arbitrary wave vectors q. (ii) C alculations of the dynam ical matrix and the phonon spectra. (iii) C alculations of electron{phonon interactions, E liashberg spectral functions  ${}^{2}F$  (!) and transport properties such as electrical and therm al resistivities. The description of the method and com plete set of references can be found in R ef.<sup>6</sup>. Num erous applications are given in R ef.<sup>7</sup>.

A lso available is an extension of LM TART to compute dynam ical susceptibilities and m agnon spectra This is a full{potential linear{response linear{m u n{tin{orbital package of program s LM TO MAGNONS designed for these purposes. As a by{product, spin wave spectra and their lifetim es are accessible as peaks in calculated im aginary spin susceptibility. A short description of the m ethod can be found in Ref.<sup>8</sup>.

Software M IND Lab which runs under M icrosoft W indows operating systems can be used to set up input les and analyze output les of LM TART. It can also be used to run the code without learning its extensive input options. This software is necessary to visualize all data withdrawn from LMTART. Currently, M IND Lab can perform the following tasks (i) Crystal group calculations. By setting atom ic positions M IND Lab shows crystal group operations found for given atom ic con guration; (ii) Fat bands calculations. Fully colored visualization of separated orbital characters on top of the band structure can be performed by mouse click operations. (iii) Density of states calculations. M IND Lab com putes and visualizes densities of states, total and orbital resolved. (iv) Extractions of hopping integrals for tight{binding ts can be perform ed quickly with M IND-Lab. (v) Optical properties calculations. D ielectric functions  $_1(!)$ ,  $_2(!)$ , and electron energy loss spectra can be computed and visualized by MINDLab. (vi) Visualizations of charge densities, full potentials, and Ferm i surfaces in both two and three dim ensions using 0 penGL graphical library implemented within MINDLab (viii) Three dim ensional visualization of crystal structures and their distortions. (ix) Full three dimensional visualization of vector elds including velocity elds on top of the Ferm i surfaces and m agnetizations.(x) Sim pli ed input for studying correlated electronic systems which currently implements LDA + U method and will include LDA+DMFT technique in the nearest future.

M IND Lab works with LM TART as with an executable le which reads input data, perform s band structure calculation, and stores output les. MINDLab controls this process, it prepares input for LM TART using dialog windows, and executes LM TART program as a separate thread. W hen the calculation is nished, LM TART noties the M IND Lab, and the output les can be visualized by simple mouse click operations. W hile running LM -TART for complicated compounds can be rather slow (it depends how many atom s per unit cell is selected), M IND Lab can be used to prepare the input, after which the les can be copied to a more powerful computer where the LM TART can be executed much faster. A fter run is perform ed, the output can be copied back to the PC and analyzed quickly by MIND Lab. All input/output les of LM TART are form atted ASCII les, and therefore system independent.

# II. A P P L IC A T IO N S

Several m ost recent applications of LM TART can be found in Refs.<sup>4,7,8,9,10</sup>. They include calculations of phonons and electron {phonon interactions in novel superconductors, such as  $M \ gB_2$ ;LiBC,  $M \ gCN$  i; studies of phonons in strongly correlated system s, e.g. N iO, Pu, com putations of m agnetic anisotropy energies of ferrom agnets Fe, Co, N i, CrO<sub>2</sub> evaluations of dynam ical spin susceptibilities and spin wave spectra, and so on.

H ere we illustrate one of the most recent calculation<sup>9</sup> of phonon spectrum in  $M \text{ gC } N_{1_2}$  using a linear response

signi cant dispersion. In general, we distinguished three panels where the top three branches around 900 K are carbon based, the m iddle three branches around 600 K are M g based and 9 lower branches are all N i based.




FIG.1: Calculated phonon spectrum of MgCN  $i_2$  along major symmetry directions of the Brillouin zone of the cubic lattice using density functional linear response method. Some curves are widened proportionally to the phonon linewidths.

We have discovered a striking feature of this phonon spectrum connected to the presence of a low {frequency acoustic mode which is very soft and is even seen to be unstable along som e points in ( 0) direction in the Brillouin zone. This mode is essentially N i based and corresponds to perpendicular movements of two N i atom s towards octahedral interstitials of the perovskite structure. The latter is made of each of the four N i atom s and two M g atom s.

The persistence of the instability which does not occur for any of the high { sym m etry point needs a non { trivial frozen {phonon analysis. As our polarization vectors prompt that the largest anham onicity is expected for the XM plane  $(q_z = 0)$  of the Brillouin zone of the cubic lattice, we have perform ed three such calculations for the points  $a = (\frac{1}{4}\frac{1}{4}0)\frac{2}{a}$ ,  $b = (\frac{1}{2}\frac{1}{4}0)\frac{2}{a}$ , and M : The results of these calculations reveal essentially anharm onic interatom ic Nipotentials. A shallow double well with a depth of the order of 20{40 K and the curvature at the equilibrium of the order of 40 {50 iK exists for the a and b points which becomes vanishing at the M point. We have found such a behavior by both total energy and force calculations for the supercells of 20 atom s (a and b points) and 10 atoms (M point). Clearly, such a small depth on the temperature scale indicates that the distortions are dynam ical and zero point motions would prevent the appearance of the static long{range order. C om plete discussion of these calculations as well as the com parisons with existing experiments can be found in  $\text{Ref.}^9$ .

Fig.1 also shows the calculated phonon linewidths a by widening some representative phonon dispersion curves  $!_q$  proportionally to  $_q$  . In particular, we found that som e phonons have rather large linew idths. This, for example holds, for all carbon based higher lying vibrational modes. The strength of the coupling,  $_{\rm q}$ ; for each mode can be obtained by dividing  $_{\rm a}$  by N ( $_{\rm F}$ )! $_{\rm q}^2$  , where N ( $_{\rm F}$ ) is the density of states at the Ferm i level equal to 5.3 st./ [eV \*cell] in our calculation. Due to large  $!_{g}^{2}$ ; this unfortunately results in strongly suppressed coupling for all carbon modes which would favor high critical tem peratures. The coupling, how ever, is relatively strong for the N ibased m odes. For exam ple, we can nd 's of the order of 1{3 for the N ibased optical phonons around 250 K. Our resulting value of electron { phonon coupling constant is found 1.51. This assumes that M gCN is a strongly coupled electron {phonon superconductor.
