# Dephasing in Rashba spin precession along mutlichannel quantum wires and nanotubes

Coherent Rashba spin precession along interacting multimede quantum channels is investigated, revisiting the theory of coupled Tomeonaga-Luttinger liquids. We identify susceptibilities as the keyparameters to govern exponents and Rashba precession lengths. In semiconducting quantum wires spins of dierent transport channels are found to dephase in their respective precession angles with respect to one another, as a result of the interaction. This could explain the experimental diculty to realize the Datta Das transistor. In single walled carbon nanotubes, on the other hand, interactions are predicted to suppress dephasing between the two avormodes at small doping.

#### I. IN TRODUCTION

Rashba precession of spins and its manipulation has been studied intensively<sup>2</sup> in recent years, aim ing to control the coherent propagation of electron spins. One goal is to realize a spin transistor<sup>3</sup>; another interesting op tion could be to switch between singlet and triplet entangled states for directing, for example, noise statistics<sup>4</sup> or for quantum computing. Despite of major e orts, manipulation of coherent Rashba precession could not be demonstrated experimentally yet in the polarizer{ analyzer type transport arrangement. Rashba spin splitting occurs near surfaces in the presence of internal or externally applied sym metry breaking electric elds perpendicular to the transport direction. Spins precess when in jected out of the spin-orbit eigendirections. Any dephasing along the structure lim its successful transistor operation. One important dephasing mechanism in spin-orbit active structures of more than one dimension arises due to momentum randomizing scattering events by impurities (elastically), by phonons (inelastically), or by electron-electron scattering events<sup>6</sup>. O ne-dim ensional structures con ne the direction of propagation, thus reducing this source of dephasing mechanism. A lready in their original proposal $^3$  D atta and D as therefore suggested to use clean one-dimensional structures for the spin-orbit active medium. The current work focuses on quantum wires and assumes absence of momentum random izing scattering events. No spin relaxing mechanisms (in the sense that o -diagonal entries of the spin density m atrix decay) will be considered here.

M ost quantum wires of current experiments accommodate more than one transport channel at the Fermi energy. This holds true also for single walled carbon nanotubes (NT) where at least two avor channels carry (spin) current. In NT spin transport has been established experimentally and studied theoretically 0 ther experimental multichannel systems consist of arrays of quantum wires fabricated articially in parallel at close proximity 10. In any multichannel wire the interesting question arises whether Rashba spin phases increase by equal amounts along dierent channels or not. Provided the kinetic energy dispersion is strictly parabolic, described by a common extinct carrier mass in each channel as in most semiconducting quantum wires, one would

expect equal spin phases in all channels as a result of the linear splitting by the Rashba energy, so that their probabilities to enter the spin selective drain contact all add up. We shalldem on strate that Coulomb interactions between charged electrons a ect their spin propagation properties and ultim ately destroy the phase relationship of Rashba precessing spins between channels in quantum wires (QW) fabricated on the basis of sem iconducting material. This limits operation of the Datta Das spin transistor. In metallic single walled nanotubes, on the other hand, with their linear kinetic energy dispersion, spins dephase between modes already without accounting for interactions; remarkably, in this case we not that the Coulomb interaction suppresses this single particle dephasing between the two avormodes, particularly at small doping, thus facilitating coherent spin precession along NT.

## II. IN TERACTING M ULTIM ODE QUANTUM W IRES

Before addressing the e ect of spin-orbit coupling let us 1st discuss the (possibly screened) Coulomb interactions within and between transport channels. One-dim ensional systems are particularly susceptible to electron-electron interactions, even when weak<sup>11</sup>. Neither in semiconducting QW 12 nor in NT 13;14 interactions can be disregarded. Contrary to higher dim ensions they show up, for example, as nonuniversal power laws at low energies. The most convenient theoretical fram ework is the Bosonic Tomonaga (Luttinger liquid  $(TL)^{15}$ developed since the sem in alwork by Haldane 16. However, a priori, it is not clear in how far the TL-model can be applied to multichannel situations. Strictly equivalent m odes of equal particle densities and interaction matrix elem ents, for example, tend to stabilize a gapped charge or spin density, non-TL low energy phase<sup>17</sup> due to the appearance of relevant (in the sense of a perturbative renorm alization group treatm ent) m om entum conserving interm ode backscattering processes. On the other hand, m ost real system s lack such a strict equivalence of m odes. In multichannel quantum wires particle densities di er at given Ferm ienergy, and even system s of Ref. 10 without ne tuning of densities, or the two avor modes of NT at not exact zero doping cease to be strictly equivalent.

Here, we therefore focus on the generic case of unequal modes which are expected to stay in the gap-less low energy TL phase.

In this phase M atveev and G lazm an (M G) have computed a power law for the density of states of spin-less electrons at the end of the n-th mode  $^{18}$ :

generalizing the single channel case  $^{11;16;19}$ . M G obtained the exponents  $_{\rm n}$  within a pure plasm on m odel by m odeling the charge density uctuations as coupled harmonic strings. Plasm on velocities so and the normalized eigenmodes  $_{\rm n}$  of a obtained from the dynamical matrix, determine  $^{18}$ 

v<sub>n</sub> is the Ferm i velocity in the n-th channel. This approach merely accounts for long wave length charge properties and can shown to be equivalent to the random phase approximation (RPA) to plasm on velocities<sup>20</sup> generalized to coupled modes<sup>21</sup>. It has been pointed out<sup>22</sup> that the RPA result deserves in provement at small particle densities. Moreover, it disregards exchange processes and spin, and tacitly presumes super'Galilei invariance of every channel individually, as discussed below. Spin properties and exchange are known to depend on short wave length properties of the interaction<sup>23</sup>.

For given m icroscopic interaction the param eters of the single channel TL m odel, and therew ith sound velocities and exponents, have been obtained from hom ogeneous and static susceptibilities  $^{22}$ , exploiting exact therm odynam ic relations  $^{16;15;24}$ . These susceptibilities, in turn, can be computed to high accuracy by standard manybody techniques from the underlying Ferm ion model, beyond the RPA or perturbative accuracies. This way the asymptotic behavior of correlation functions has been determined in the 1D Hubbard model from the Bethe Ansatz ground state energy  ${\rm E_0}^{24}$ . In the Galilei invariant charge sector of QW only the compressibility

Evidence for this has been found in recent experiment 10. Spin velocities of QW have been deduced from quantum Monte Carlomagnetic susceptibilities 26. Here we generalize this a priori exact them odynamic approach to coupled channels. Spins can be incorporated as separate <math>s = m$  odes which allows to account even for non SU (2) invariant situations, as it arises for example in the presence of a Zeem an  $-eld^{27}$ .

From the m icroscopic point of view we consider the 1D system

from the 3D-Coulomb interaction between electrons, " is the dielectric constant of the material surrounding the wire. The  $V_{n_1n_2n_3n_4}$  can be expressed analytically for m any cross sections of physical relevance  $^{28;29}$  . The Boson model  $^{16}$ , describing gapless excitations of Ferm ions in a 1D wire of length L (periodic boundary conditions) in the vicinity of the Ferm ienergy, takes the form

when generalized to M modes. Bold letters indicate M M matrices and the components of vectors refer to modes 1 n M . In Eq. (5)

describe excitations of right/left (r = += ) going Bosonic density uctuations  $%_{\rm rn}$  (q) at wave numbers q 6 0. Topological excitations [last term in Eq. (5)] describe changes in the ground state energy when particles N n or currents  $J_n$  are added to mode n at q = 0. This second part of Eq. (5) is in portant in the present context and is governed by generalized homogeneous and static compressibilities and (D rude) conductivities:

respectively. They generalize corresponding TL parameters for single channels  $^{\!15}$  (E  $_0$  is the ground state energy of the interacting electron system) and govern the complete low energy physics. As in the single channel case  $^{\!16}$

directions, assum ing  $_n$  (k) =  $_n$  ( k) and thus Ferm ivelocities (v)  $_{n\,n^{\,0}}$  =  $v_n$   $_{n\,n^{\,0}}$  of equal m agnitudes at either Ferm ipoint.

Im portantly, all entries of  $v_{\scriptscriptstyle N}$  and  $v_{\scriptscriptstyle J}$  are observable, at least in principle, and must therefore agree in Bosonic (5) or Fermionic Eq. (3) together with (7)] representation. This allows deduction  $V^{(1)}$  and  $V^{(2)}$  by standard manybody techniques from the given microscopic interaction (4) through Eqs. (7  $\mid$  9). Therefore  $v_N$  and  $v_J$  (and not exponents as often assum ed for single channel quantum wires) are the principle param eters governing the low energy physics in the multichannel case. They establish the quantitative link to the microscopic Ferm ion model (3). For real quantum wires self-consistent Hartree-Fock 22;30, diagram m atic23, or M onte Carlo techniques26 were used to deduce TL param eters from a microscopic model for electron-electron interaction potential. As a rst approach to multichannels we rely on the perturbative approxim ation below, which, when including the Fock term (as crucial in spin sector), proves already as superior to the often used random phase approximation 20 to TL param eters<sup>22</sup>.

The matrices  $V_{\scriptscriptstyle N}$  and  $V_{\scriptscriptstyle J}$  reject symmetries of the system under permutations of modes. One important case are equivalent modes when  $(v)_{nn^0} = v_{nn^0}$  in Eq. (6), and  $v_{\scriptscriptstyle N}$  and  $v_{\scriptscriptstyle J}$  both are cyclic matrices. Then Eq. (5) can be diagonalized and the Bogoliubov transform ation solving for plasm on velocities and exponents can be carried out separately in each of the resulting independent horm alm ode' TL (two equivalent channels, for example, can be separated trivially into independent  $%_1 + %_2$  and % m odes). A nother sym m etry is G alilei invariance (observed in QW and NT) for which  $Trv_J =$ stays independent of interactions. The higher sym metry, where the ground state energy changes only by the trivial kinetic part, independently of the interaction strength, under boosting any individual channel,  $J_n \,! \, J_n \,+ \, _n$  , we call 'super' Galilei invariance. It implies  $v_J = v$ , i.e.,  $V^{(1)} = V^{(2)}$  which in general is not observed by Eq. (3) though tacitly assumed often in theoretical work.

with the outcome of Eq. (11) inserted for c, s, and R, are the (generalized) plasm on velocities of P  $_{\rm q6\,0}$  H  $_{\rm q}^{\rm (1)}$  + H  $_{\rm q}^{\rm (2)}$  . The same sequence of transformations does not, in general, diagonalize the topological excitations which explains why coupled TLs cannot necessarily be decomposed into independent hormalmode TLs'.

Equations (7 | 12) allow to calculate the (asymptotic) power law behavior of any Ferm ion function, cf. Eq. (18) below . This completes the solution for low energy properties in multim ode electron liquids in 1D . In the (superform allei invariant) special case,  $(V^{(1)})_{nn^0} = (V^{(2)})_{nn^0} = V_0$  for all n and  $n^0$ , the ensuing open boundary exponent as well as the plasm on velocities Eq. (12) agree with the results of Ref. 18. As stated above, the present approach includes spins through separate modes s=1.

W ith SU (2) spin rotation invariance charge-spin separation continues to occur in multichannel system s, so that introducing the additional index = ; for the charge and spin sector, respectively, renders  $v_N$  and  $v_J$  block diagonal. Furtherm ore, the chiral SU (2) SU (2) sym m etry of the ferm ionic model at low energies provides separate spin rotation invariance of right and left movers, giving rise to  $v_N = v_J$  in spin sector. Very strong spin-orbit coupling will spoil charge-spin separation in general. In QW, however, charge and spin are mixed only to the order 0 ( 5)32 which therefore is rarely expected to be of importance [cf. Eq. (13) below, is the spin-orbit coupling param eter]. In NT, on the other hand, charge-spin separation is already broken to the order O (). Here, the very small value of , expected from the small carbon mass, leaves this breaking less im portant and justi es calculating Rashba precession lengths to the leading order in . With charge-spin separation Rashba precession is controlled solely by the spin sector = where, from now on, the index n runs only over M spatial m odes.

### III. RASHBA SPIN PRECESSION LENGTH

W e address the physical situations referred to in the Introduction by studying two model systems: QW for quantum wires and NT for nanotubes. In QW the single particle kinetic energy dispersion m ay be regarded as  $^{\circ}_{n}$  (k) =  $_{n}$  +  $k^{2}$ =2m  $_{e}$  where  $_{n}$  are subband energies and m  $_{e}$  is the elective mass. The Rashba spin-orbit energy

deem ed as independent of the mode index, adds a linear contribution k and splits  $_{n}^{\circ \ W}$  (k) into two equal parabolas intersecting at the origin (this statement holds strictly true only for not unrealistically strong spin orbit coupling strengths,  $v_{n}$ , as discussed above  $^{32;33}$ ). Both branches are indexed by the electron spin projection perpendicular to the wire axes, taken as the z-direction for convenience (the x-axes points along the wire). Within each mode, at the Fermi energy, the spin splitting yields a nite dierence of Fermi momenta  $k_{n}$ ,  $k_{n\#}=2$  me which, as important property of the QW case, does not depend on n. Spins initially polarized along the x-axes therefore precess once over a length 4 =  $k_{n}$ ,  $k_{n\#}$  j= 2 = me, equal in all channels.

otubes (NT). Here, spin-orbit coupling  $^{34}$  arise predom inantly from the curvature of the tube surface, cf. Ref. 35; in at graphite layers it vanishes by mirror symmetry. The kinetic energy dispersion may be taken as  $n^{NT}$  (k) =  $kj(k) + jk_F + kj(k)g$ , disregarding,  $f_n + v_F [jk_F]$ for sim plicity, parabolic parts of the dispersion close to the subband bottom s at  $_{\rm n}$  . Here,  $k_{\rm F}$  denotes the Ferm i m om entum at zero doping and  $v_F$  the Ferm ivelocity. For every n there exist two di erent avor branches b = depending on the magnitude  $k \not \downarrow k_F j$  of opposite velocities at given sign of k. Adding H so from Eq. (13) yields di erences k<sub>n</sub>"  $k_{n\#} = 2 (F_F + bv_F k_F) = (v_F^2)$ at the Fermi energy, and therefore Rashba precession lengths, depending now on n and, additionally, on b.

The other system we consider are metallic carbon nan-

So far we considered independent electrons for QW and NT. It has been shown recently that electron-electron interactions in uence and actually enhance Rashba precession in 2D structures  $^{36}$  and in single transport channels  $^{32}$ . To calculate Rashba lengths on the basis of the multichannel TL model (5) requires expressing Eq. (13) in Bose variables. As in single channels  $^{32}$  H  $_{\rm SO}$  is found to be proportional to the spin currents  $J_{\rm n}$ , . The expressions

however, dier in the two cases, QW and NT, as can be checked in the limit of vanishing interaction, when  $(v_N)_{nn^0}=(v_J)_{nn^0}=v_{n-nn^0}$  in Eq. (5) reproduces the Rashba precession lengths  $2=jk_{n^+}-k_{n\#}j$  in individual QW or NT channels, respectively (H  $_{50}$  is a single particle operator and does not depend on the Coulomb interaction).

With Eqs. (14) or (15) we are now in the position to calculate

employing the wellknown Boson representation for Ferm i operators  $_{ns}(x)^{16}$ . In the spirit of the Datta-Das setup the quantity f(L) can be interpreted as the probability amplitude to measure an electron at x=L with its initial spin polarization parallel to the x-axes, provided it was injected at x=0 with equal probability amplitudes into alloccupied channels. The result can be represented as

As indicated in the previous section the asymptotic power law decay of the two point function  $g_{nn^0}(x)$  jkj  $^{nn^0}$  can be expressed through the solutions of Eq. (11) for R and #:

Equation (18) generalizes the known result for the electron G reen function of single channels<sup>11;16</sup>. By virtue of conform al invariance the time dependence can be deduced, yielding the open boundary exponent

after which spins reverse their polarization in channel n. We see that the  $_n$  are governed by the matrices  $v_{_{\rm J}}$  of spin conductivities. Without electron-electron interaction  $(v_{_{\rm J}})_{n\,n^{\,0}}=v_{n\,\,n\,n^{\,0}}$  so that  $_n^{\,0\,\,\mathrm{W}}=stay$  equal in all channels of QW  $\,$  Eq. (20)]. This would yield optimum transistor operation as discussed before. Interactions, however, alter the diagonal entries and, additionally, generate o -diagonal entries in  $v_{_{\rm J}}$ , describing the coupling between channels. In general  $_n^{\,0\,\,\mathrm{W}}$  become endependent so that dierent channels dephase. Remarkably, as demonstrated now, interactions reduce spin dephasing in the two lowest avormodes of single walled NT Eq. (21)], compared to its magnitude in the absence of interactions.

### IV.PERTURBATIVE ESTIMATE

Su ciently weak interactions can justify the perturbative estim ate to  $v_{\text{J}}$ . C rucial is the m agnitude of nonzero Fourier components, which even in metallic NT are small compared to the Ferm i velocity, since the (large) q=0

component of the interaction does not a ect the spin sector and is properly accounted for on the RPA level. Im posing SU (2) sym metry [naive low order perturbation theory violates SU (2) invariance<sup>22</sup>] results in

Here,  $k_n$  denotes the Ferm im omentum of mode  $n^{37}$ .




FIG. 1. Dierence j  $_2$   $_1$ j=  $^{(0)}$  versus Ferm i energy  $_F$ =! $_0$  in units of the subband energy ! $_0$  for two channels, cf. m ain text. In QW (a) interactions always cause dephasing between both modes while in single walled NT (b) dephasing between the two avormodes can be signicantly suppressed at small doping compared to the noninteracting case (dashed).

Figure 1 (a) shows the resulting dierence j 2 of Rashba lengths relative to this length (0) in the absence of interactions in a two-channel QW of width  $d = a_B = 2$  ( $a_B$  is the Bohr radius). This phase di erence can exceed 30% and decreases only when F and the carrier density increase so that the interaction strength dim in ishes. We see that dephasing never vanishes within the regime of validity of the perturbational approach at not too small carrier densities in the second subband,  $_{\rm F}$  > 1:15!0 [note that for harm onic con ning potential the third subband (not included here) becomes occupied above  $_{\rm F}$  = !  $_{\rm 0}$  > 2]. Experim entally, it m ight be possible to disentangle two Rashba periods and thus, by monitoring their dependence on the interaction strength (carrier density), verify the predicted dephasing mechanism when two channels are occupied. For the D atta D as transistor based on sem iconductor QW sthis result clearly suggests to use only the lowest subband.

In Figure 1 (b) the di erence of Rashba lengths of the two lowest (degenerate) avor modes of metallic single wall arm chair (m;m) NT is seen for m = 5 [subband energies  $_1$  =  $_2$  = 0, the Fermi momenta  $k_{\rm f^{1}_{2}g}$  = m = 3r  $_{\rm F}=v_{\rm F}$ , r is the tube radius, and  $e^{2}$ ="v\_{\rm F}  $2:7^{14}$ ], relative to the splitting  $^{(0)}$  at zero doping. Dephasing can shown to be suppressed logarithm ically  $_{\rm F}$ =[c\_1 q ln( $_{\rm F}$ =!0)]+0( $_{\rm F}^{3}$ ) at small doping (c\_1 and c\_2 depend on the tube radius and c\_2 vanishes with the interaction), compared to the interaction free case (dashed) where c\_1 = m=2. This suggests the use of single walled NT close to the neutrality point  $^{38}$  for coherent Rashba precession along both avor channels  $^{39}$ .

We have calculated Rashba spin precession lengths n in multimode quantum wires, accounting for electronelectron interactions, using the Bosonization method. To this end we have developed an in principle exact description for the TL phase of coupled quantum channels that allows the inclusion spin. Generalized charge and spin com pressibilities and conductivities are identi ed as the key param eters to determ ine the power law exponents and to establish quantitative contact with the underlying interacting electron model. In sem iconducting wires, characterized by a parabolic kinetic energy dispersion, we nd that the n become n-dependent, giving rise to doubts whether multichannel systems can be used as active part of the Datta-Das transistor. This result could explain the up to date lack of successful transistor operation and clearly suggests to use single channel quantum wires. In metallic single walled carbon nanotubes, on the other hand, we nd that dephasing between the two avormodes, arising due to the linear kinetic energy dispersion, is suppressed by the electron-electron interaction, particularly at small doping, which could make these systems interesting for coherent spin transport.
