The anisotropic multichannel spin-S K ondo model: C alculation of scales from a novel exact solution

A novel exact solution of the multichannel spin-S K ondo model is presented, based on a lattice path integral approach of the single channel spin-1=2 case. The spin exchange between the localized m on ent and the host is of X X Z -type, including the isotropic X X X lim it. The free energy is given by a nite set of non-linear integral equations, which allow for an accurate determ ination of high-and low-tem perature scales.

1. IN TRODUCTION

The isotropic multichannel spin-S Kondo model describes the XXX-like spin scattering between noninteracting spin-1/2 ferm ions in m channels and a single localized spin-S impurity. It has been proposed by Nozieres and Blandin¹ to account for the orbital structure of spin-S impurities in metals. Physical realizations are discussed in the review article². An exact solution to this model was found by T svelick and W iegm $ann^{3,4,5}$ using the Bethe Ansatz (BA). By applying the therm odynam ic Bethe Ansatz (TBA), the therm odynam ics has been calculated by Tsvelick⁶ and Andrei and Destri⁷. In the TBA approach, the free energy is encoded by in nitely many coupled non-linear integral equations. Recently, Schlottm ann^{8,9} and Zarand et al¹⁰ obtained the free energy for the anisotropic multichannel spin-S Kondo model with X X Z -like exchange in the TBA approach. Schlottm ann observed a quantum critical point for the overscreened model in the limit of low temperatures, Zarand et al focused on the underscreened twochannelm odel. Here, we present a novel exact solution in which the free energy is encoded in a nite set of non-linear integral equations (NLE), including both the anisotropic and isotropic models for arbitrary S and m . On the one hand, we con m known results by this novel solution, on the other hand, we obtain farther reaching results as far as ratios of high-and low -tem perature scales are concerned.

In a recent publication¹¹, we proposed a lattice path integral approach to an Anderson-like in purity in a correlated host. We obtained this model from the Ham iltonian lim it of a gl(2jl) symmetric transferm atrix. The free energy contributions of both the host and the im purity were calculated exactly by combining the Trotter Suzukim apping with the quantum transferm atrix technique. We showed that the model allows for the K ondo lim it, i.e. a localized magnetic in purity in a free host with linearized energy-momentum relation. In the K ondo lim it, the symmetry of the coupling between host and im purity is reduced from gl(2jl) to su (2). In the following, we exploit this observation to propose a $U_{d}su$ (2) sym - metric quantum transfer matrix (QTM), whose largest eigenvalue yields the free energy contribution of the im purity in the therm odynam ic lim it, in close analogy to^{11} . The q-deformation accounts for an X X Z -like spin exchange between the localized m om ent and the host, including the isotropic lim it q ! 1. The transfer matrix is built from local R-operators, each acting in the tensor product space of two U_gsu (2) modules, carrying an (m + 1)-dim ensional irrep and an (l+ 1)-dim ensional irrep of U_qsu (2), respectively. Here m denotes the num ber of the electronic host channels and 1= 2S is twice the im purity spin. By making use of analyticity arguments, the free energy is represented by $(m \propto [1; m] + 1) - m \approx NLE$. These equations are investigated both analytically and num erically for the accurate calculation of scales in the lim its of low and high tem peratures.

This article is organized as follows. In the next section, the free energy contribution of the impurity is determined as the largest eigenvalue of a certain QTM. The third and fourth sections are devoted to the calculation of therm odynamic equilibrium functions and scales in the limits of low and high temperatures, respectively. In the last section, we summarize the results.

In all that follows we set $k_B = 1$, and $g_B = 1$, where k_B is Boltzm ann's constant, g is the gyrom agnetic factor and $_B$ is the Bohr m agneton. An index i (h) denotes quantities pertaining to the impurity (host).

2. CALCULATION OF THE FREE ENERGY

Let $V_q^{(1)}$ be the module carrying the l-dimensional irrep of U_q su(2); in the lim it q = 1, $V_1^{(1)}$ carries the l-dimensional irrep of su(2). Consider the matrices $R_q^{(1,m)}$ (x) 2End $V_q^{(1)}$ $V_q^{(m)}$ constructed such that the Yang-Baxter-Equation (YBE) is fulled:

The $R_q^{(l,m)}(x)$ are obtained by fusing a lattice of m l many operators $R_q^{(1;1)}$. Then $V_q^{(k)}$ is the subspace of com – $R_q^{(1)}$, with k = l;m. In¹², the explicit expression of $R_q^{(l,m)}(u)$ is given. If in the isotropic single channel case, the spectral parameter is chosen to take the special value $x_0 \approx R_q^{(l,m)}(u)$ is given. The logarithm of equation (1) is the spin exchange operator between the impurity spin S = 1=2 and one electron, where the spin-exchange coupling J is parameterized by x_0 .

It has been argued by T svelick et al³ that the exchange in the multichannel K ondo m odel is equivalent to an exchange m odel for spin-m =2 electrons scattered by the spin-S impurity. This equivalence has been proven by the equality of the exact solutions of both m odels at zero tem perature. W e expect that m ore insight into this question is possible by a lattice path integral form ulation in analogy to the S = 1=2; m = 1; = 0 case¹¹. W e leave this task as a future challenge. Here, we rely on the above m entioned equivalence, so that the H am iltonian density is given by:

where x_0 and q parameterize the coupling constants. In the following, q is given by a real constant , q = :exp(i), such that $\mathbf{6}$ 0 induces an Ising-like anisotropy, $J_? < J_{jj}$. The matrix $R_q^{(l,m)}$ acts in the electronic space with operator-valued entries in the inpurity space. Only the totally symmetric combination of spinors, with total spin m =2, interacts with the inpurity, so that the spin indices in equation (2b) are ; $^0 = m = 2; \ldots; m = 2$.

In the last line the transfer matrix $q^{(l,m)}$ is de ned as

the trace over the auxiliary space of $T_q^{(l,m)}$. In view of the de nition of the H am iltonian in equation (2b), the auxiliary space a is identi ed w ith the impurity space and the quantum spaces 1;:::; N correspond to the electrons. We will now show that under the substitution N ! i D, the largest eigenvalue $\binom{(l;1)}{1}(x_0)$ of $T_1^{(l;1)}(x_0)$ is directly related to the free energy contribution of the impurity f_1 found in¹¹,

Here D has the meaning of a bandwidth parameter of the host. A magnetic eld is introduced by twisted boundary conditions.

The largest eigenvalue in equation (4) is expressed through auxiliary functions b; \overline{b} (B = 1 + b, \overline{B} = 1 + \overline{b}) in analogy to¹⁴. A fler the substitution N ! i D, these functions are given by the non-linear integral equation

The above presented derivation of the closed set of nitely many integral equations for the impurity's free energy is speculative in the sense that an observation m ade for the well-understood case S = 1=2, m = 1 w ithin a path integral approach¹¹ is extended to the case of generals and m.W e intend to report on the generalization of¹ in a future publication. Our claim, however, that (10)-(13), (14) hold also in the general case follows by a simpler reasoning. By use of the algebra^{15,17} of fused transfer m atrices one can show that our key equations are equivalent to the in nitely many TBA equations of in the isotropic case and to the equations of^{8,9} in the anisotropic case. As an illustration, gures 1-6 show the entropy and specic heat for some special cases. The curves for = 0 agree nicely with similar graphs in^{2,18}; those for for are novel.

W e expect that in the fram ework of a generalized lattice path integral approach, additional electron-electron interactions in the host must be introduced to keep the model integrable. These interactions may lead to both a renorm alization of the Ferm i velocity vf and the electronic g-factor, analogous to the known exact solution¹³. These additional interactions will be the concern of future work; the analysis in this work is based on the model (2a)-(2c).




FIG. 1: Entropy for impurity spin S = 5=2 and dierent channel num bers. At low tem peratures, the asymptotes $\ln (m + 1)$ depend on the channel num ber, at high tem peratures, the common asymptote $\ln (2S + 1)$ is approached.

LOW TEMPERATURE EVALUATION 3.1. 2S = m : Exact screening

The rst non-vanishing order in a low tem perature, low eld expansion of the free energy in the exactly screened case can be obtained by expanding the corresponding integral in the following form

The tem perature and the eld are supposed to be small compared to T_K . A scan be seen from equations (15), the integral in equation (16) only exists for l=m. The above approximation makes sense if $T_{\rm fh}$. The integral in equation (16) can be done exactly, by a generalization of a method used in 19 leading to dilogarithm s and applied for instance to the spin-S H eisenberg chain in 17,20 .




FIG.2: Specic heat for impurity spin S = 5=2 and di erent channel numbers. The inset shows the Ferm i liquid behavior $\lim_{T \to 0} C(T)=T = const.$ for 2S = m = 5.

These relations exhibit clearly the role of T_K as a \low tem perature scale". A coording to equation (21), the im purity contribution to the speci c heat and m agnetic susceptibility are Ferm i liquid like at T;h T_{K} in the exactly screened case l = m. This is the regime of strong coupling": The anti-ferrom agnetic spin exchange leads to the formation of a many particle state between the impurity and the host electrons, which screens the magnetic m om ent of the impurity. E lem entary excitations of this bound state are Ferm i like. Nozieres^{1,21} built up a phenom enological Ferm i liquid theory to describe this regime. This Ferm i liquid behavior is to be compared with the host. It consists of spin-1/2-ferm ions of m noninteracting channels (or of m avors), so that the density of states is enhanced by a factor of m.

The coe cient of the linear T-dependence of C $_{\rm i}$ (C $_{\rm h}) is denoted by <math display="inline">_{\rm i}$ ($_{\rm h}$). The low-tem perature W ilson ratio R is de ned and calculated as

The lower bound 2 is reached for m = 1, = 0. The striking feature in comparing equations (21), (22) is that C_i is reduced by a factor of 3=(2m + 4) in comparison to C_h , if the constant $_h$ is chosen such that $_i = _h$ for = 0. This may be interpreted by the localization of the in purity: C ontrary to the host electrons, it does not m ove, so that the speci c heat is reduced.

3.2. Linearization

In this section, the ground-state and the lowest T dependent contribution to the free energy are calculated




FIG. 3: Entropy for m = 5 channels and spins S = 1=2;:::5=2. In the low temperature limit, the entropy takes the unusual value lnfsin [(2S + 1)=(m + 2)] = sin = (m + 2)g, equation (15b), whereas for high temperatures, the asymptotes are given by ln (2S + 1).

by linearizing the NLIE for $h \notin 0$. From equations (15) one observes that for $h \notin 0$ and ! 1 in the limit x ! 1 the auxiliary functions scale with h. Especially, $\lim_{n \to 1} \ln \overline{B_1} = 0 + 0$ e^{-h}, so that one can neglect $\ln \overline{B_1}$ with exponential accuracy.

The linearization is done with exponential accuracy for $_{j\mbox{ m}}$, but with only algebraic accuracy for $_{j<\mbox{ m}}$ because of the constant asymptotes of the latter functions. The rst T-contribution for these is calculated below within a di erent linearization scheme. Here, the lowest T-contribution for the exactly and under-screened single channel case $1\mbox{ m}=1$ is determined. For = 0, the results of 3 are con med.

It is convenient to de ne a matrix \hat{A}^{-1}




FIG. 4: Specic heat for m = 5 channels and spins S = 1=2; :::5=2.




FIG. 5: The entropy for the under-screened case S = 1;m = 1 with elds h = 0;0:1;1;10 and anisotropies $= 0;0:9_{max} = 0:707$ (for $_{max}$, see equation (8)).




FIG.6: The speci c heat for the under-screened case S = 1;m = 1 with elds h = 0;0:1;1;10 for anisotropies $= 0;0:9 m_{ax} = 0:707$ (for m_{ax} , see equation (8)).

The free spin value of the magnetization is approached logarithm ically at high elds. This asymptotical freedom in the weak coupling lim it is a genuine feature of the K ondo m odel. An analogouse ect occurs for low elds in the under-screened case; how ever, the st correction is of opposite sign com pared to the high-tem perature case, cf. equations (47), (48). Classical Ferm i liquid behavior appears at low temperatures if the impurity is exactly screened. The physical origin of these results has been revealed by Nozieres¹ already before the exact solution of the Kondo model was known: At high elds, corrections to the asym ptotical freedom of the impurity spin are caused by the weak anti-ferrom agnetic coupling with the host particles. At low elds, the impurity spin is partially screened due to strong anti-ferrom agnetic exchange. Two kinds of interactions with this in purity-electron system m ay occur: On the one hand, a weak ferrom agnetic coupling of the residual spin S m = 2 with the host, due to the Pauli principle (this explains the change of sign in the leading order on the rhs of equations (47), (48)). On the other hand, a polarization of the bound com plex by host electrons, analogously to the Ferm i liquid excitations at S = m = 2. This polarization is given by the poles and dom inated by the ferrom agnetic K ondo interactions, re ected by the cuts in the complex plane.

Here, we will con m A eck's ndings for m 2, extended to the anisotropic case $\notin 0$.

This means that the -factors in (69a), (69b) are constant and known, so that from measuring C_i or $_i$, the scale T_K can be determined. So the parameter T_K has the meaning of a low-temperature scale also in the overscreened case.

We did not nd an analytical expression of the integral in equation (68), but determ ined the coe cients in equations (69a), (69b) num erically. Therefore, the NLIE are solved as described in the appendix, and the coeffcient of the leading T^{4=(m + 2)}-decay of C₁(T T_K), _i(T T_K) T is extracted from the num erical data. In g. 7 som e curves are shown. The W ilson ratio for the isotropic case is

For nite anisotropy € 0, the magnetic eld is scaled by the factor 1=(1 m =) in the NLE, equation (12), (13). Furthermore, the non-integer powers in (69a), (69b) are determined by the fusion hierarchy, (65), where the anisotropy parameter does not enter explicitly. We therefore conjecture that in analogy to the exactly screened case (23) and two-channel overscreened case (60c), the W ilson ratio for nite is

This means that anisotropy is irrelevant in the renorm alization group sense, in accordance with previous treatments of the underscreened case by TBA^{8,9,10}. On the other hand it has been shown in the CFT -approach²⁴ that a generic anisotropic spin-exchange is relevant. Since the spin-exchange (2b) is a polynom ial in the spinoperators, the situation here is di erent from that in²⁴. We leave further investigations on this issue as a future task. In table I, our results are compared with equations (71), (72).




FIG. 7: The low-temperature W ilon ratios for the overscreened case with m = 5 and anisotropy $= 0; 0.2; 0.5; 0.8 \,_{max}$, where the lowest set of curves is for = 0.

4. HIGH TEMPERATURE EVALUATION

In this section, the NLIE are analyzed in the limit of high temperatures T T_K by an asymptotic linearization. The fact that contrary to the TBA approach, we deal with a nite set of NLIE, is most useful here. In the isotropic single channel case, our results are farther reaching than those obtained from the TBA equations¹³, the treatment of the isotropic multichannel case and of the anisotropic m odels in this regime is novel.

This section is divided into three parts. In the rst part, the isotropic lim it = 0 is considered. The second part treats the low-tem perature lim it of the underscreened case, which is conceptually very sim ilar to the regime of high tem peratures. The anisotropic case is treated in the last part.

In the high temperature regime, the st corrections to the asymptotic value of the free energy are given by the asymptotic corrections of the concerned auxiliary functions for x ! 1. Corrections are of algebraic and logarithm ic-algebraic nature and can be found within an asymptotic linearization scheme. This is also true for 1 > m in the low-temperature limit, referring to the region x ! 1. In this case, the set of l equations decouples into two sets of m and 1 m equations and the high-temperature-linearization is directly transferable.

O nem akes use of the know ledge of the asym ptotic behavior of the auxiliary functions derived in appendix 1 to extract the high-tem perature behavior of the free energy, the speci c heat and m agnetic susceptibility in zero ekd. Em ploying once again the approxim ation equation (A 3), this time in the integral of the free energy, we nd

Equations (73a)–(73c) constitute the rst calculation of the leading orders of the speci c heat and m agnetic susceptibility for general m in the framework of an exact solution. The single-channel case m = 1 agrees with known TBA-results,¹³. Especially, the coe cient of the (ln T=T_K) ²-decay of the m agnetic susceptibility is determ ined, from which we will calculate W ilson's number, relating the high-tem perature to the low-tem perature scale.

From equation (73c), we calculate W ilson's number for the underscreened and exactly screened cases, l m. Let us rst draw our attention to the exactly screened spin-1=2 case, $l = 1 = m \cdot W$ ilson²⁵ obtained for the zeroeld spin-1=2 susceptibility by his renorm alization group approach

A ndrei and Lowenstein²⁶ carried out a perturbative expansion of the 2S = m = 1 free energy, both for h=T 0 and T=h 0. By requiring that in the rst case, the result should depend on h=T_h, in the second case on T=F_K, they deduced the ratio T_h=f_K. Moreover, they determined the ratio T_h=T_K from the (conventional) BA.Arguing that the ratios of the energy scales are universal (unlike the scales them selves, which do depend on the cuto -schem e used), they found by combining their two results (the analytical expression is due to Hew son²⁷)

m = 1 are calculated. The ratio $T_{\rm K}$ =T_h for T = 0 is found by BA techniques for ~=~0 and agrees with ours, equation (30) for ~=~0. $T_{\rm h}$ = $\widehat{T}_{\rm K}$ is found by conventional perturbation theory. The resulting $T_{\rm K}$ = $\widehat{T}_{\rm K}$ depends exponentially on S (S + 1). We have this question to be clari ed.

By inserting equation (74), one gets for m = 1:

This result agrees with equations (75), (78). In table II, W ilson numbers for the general 1 m case are given. Note that for 2S > m, the susceptibility at low tem peratures can be obtained from that at high tem peratures by replacing l! (l m). This does not change the value of , which m eans that in the under-screened cases, only one scale (nam ely \mathbf{f}_{K}) governs the low -and high-tem perature behavior.

The over-screened case m > 1 is obtained from equations (73a), (73b), (73c) by replacing $m \cdot 1$ and inserting $\ln Y_{j=1}$ and its derivatives, equations (A13), (A26), into the de nitions of the free energy, speci c heat and susceptibility. The W ilson num bers are again given in table II, where now $m \cdot 1$, $(m \cdot 1) \cdot (1)$. In analogy to the exactly and under-screened cases, T_K has been identied as a low-temperature scale also for the over-screened case in equations (69a), (69b). From the universality of the low-temperature W ilson ratio, we expect the W ilson num ber in the over-screened case.

4.2. Low tem perature evaluation in the under-screened case

In this section, we make use of the results of appendix 2, from which one deduces the low-temperature behavior in the under-screened case of the following quantities (T T_K):

The low-temperature behavior for exact screening is given in section 3.1, where the expected Ferm i liquid behavior shows up. Sim ilarly to T = 0, a change of sign in the leading corrections to the asymptotic values of the susceptibility is observed, cf. equations (73c), (79). Its physical interpretation has been given in the sequel of equation (48). It applies analogously in this case.

4.3. A nisotropic case, 60

A coording to equation (8), the anisotropy parameter is restricted to 0 $\frac{1}{2n}$, where $n = m \operatorname{ax}(l;m)$. Since the kernelk (x) decays exponentially in direct space, corrections to $\ln B_1^{(1)}$, $\ln Y_j^{(1)}$ are expected to be exponentially sm all. Thus it is no longer permitted to replace convolutions with s(x) by algebraic multiplications. Instead, let us write equation (A1) in direct space, with the same notations as equation (A2), how ever including a nite magnetic eld from the beginning. First subtract the asymptotes (= h=2),

Note that both C $_{\rm i}$ and $_{\rm i}$ show sim ilar decays, contrary to the isotropic case.

If T_K , one argues in close analogy to the isotropic case: The decoupling into two independent sets still holds. However, the asymptotic values of the auxiliary functions for x ! 1 are related to their x ! 1 counterparts by substituting 1 ! (1 m) and scaling h ! h, = (1 m =)¹, equation (15). The constants in equations (81)–(83) di er from those in equations (84)–(86). For ease of notation, the same symbols have been used. 5. CONCLUSION

W e presented a novel exact solution to the anisotropic multichannel spin-S K ondo model. The free energy contribution of the impurity is given by a nite set of (m ax [m ; 2S]+1)-m any NLIE. By analytical and num erical studies, we con m and extend known properties of this model.

The low temperature case is characterized by Ferm i liquid behavior in the sense that W ilson ratios are dened. However, only in the exactly screened case l = m, the limits T; h! 0 commute and C_i(T)=T, i approach nite values. These values were calculated by the dilogarithm technique and for l = 1 by the dressed charge form alism, in the fram ework of a rigorous linearization.

We analysed the ground state for arbitrary anisotropy, spin and channel number and observed non-commutativity of the limits h;T ! 0 for models with $1 \notin m$. In the underscreened case, if h = 0, an asymptotic approach to free (1 m)=2 spin asymptotes was recovered for T T_K , form ally analogous to the T T_K case, paragraph 4.2. On the other hand, performing rst the limit T ! 0 while letting $h \notin 0$, a non-integer rest spin occurs for # 0 in the underscreened case, equation (43), connected to a quantum critical point^{8,9}.

W e analyzed the low-temperature behaviour of the over-screened models and found non-integer exponents of h if T = 0, equation (54) and of T if h = 0, equations (69b), (69a). Especially, we determ ined numerically low-temperature W ilson ratios for arbitrary anisotropy, con m ing and extending results by A eck ²².

At high tem peratures, T $T_{\rm K}$, the impurity spin approaches asymptotically the behavior of a free spin of m agnitude S = 1=2. Corrections to the asymptotic values depend in their amplitude on the channel number m and have been calculated analytically. Especially, W ilson numbers relating low - to high-tem perature scales are determ ined with the help of a num erical solution.

W e expect that new insight into the multichannel case is obtained by generalizing the lattice path integral approach proposed in¹¹ for the isotropic S = 1=2, m = 1 m odel. To this aim, R-m atrices must be constructed which are invariant under the action of gl(2jl), containing higher dimensional irreps of su (2),²⁹.

Finally, it should be possible to derive the quantities determined numerically in this work also by analytical methods. This question is left open for future investigations.

A fler having applied the inverse FFT, the analytically convoluted terms are re-added:

Since the kernels also decay as x², the coe cient of the x² decay of ln Y is obtained from the integral of (ln Y f), a quantity which is accessible numerically with high accuracy.
