## Zitterbew equng of electronic wave packets in sem iconductor nanostructures

W e study the zitterbew egung of electronic wave packets in III-V zinc-blende sem iconductor quantum wells due to spin-orbit coupling. Our results suggest a direct experimental proof of this fundamental e ect, con ming a long-standing theoretical prediction. For electron motion in a harm onic quantum wire, we numerically and analytically indicated a resonance condition maximizing the zitterbew egung.

The emerging eld of spintronics has generated a large deal of interest in the e ects of spin-orbit coupling in sem iconductor nanostructures and their possible applications [1]. Spin-orbit coupling is a relativistic e ect described by the D irac equation and its nonrelativistic expansion [2]. In sem iconductors spin-orbit coupling of it inerant electrons is much stronger than in vacuum . This is due to the interplay of crystal sym m etry and the strong electric elds of the atom cores [3]. In fact, the e ective models describing the band structure of III-V sem iconductors have m any sim ilarities to the D irac equation. However, the fundam ental gap between conduction and valence band in a sem icondcutor is of order an electron volt or less, which is much smaller than the gap between solutions of positive and negative energy of the free D irac equation. This observation can serve as a general heuristic explanation for the importance of spin-orbit e ects in sem iconductors [3].

A nother prediction of relativistic quantum mechanics is the zitterbewegung of electrons [2], which, however, has not been observed experimentally yet. For free electrons, i.e. in the absence of an external potential, such an oscillatory motion occurs if solutions of both positive and negative energy of the free D irac equation have a nite weight in a given quantum state. In this letter we investigate the zitterbewegung of electron wave packets under the in uence of the enhanced spin-orbit coupling in III-V zinc-blende sem iconductor quantum wells. Strong spin-orbit coupling generally requires large gradients of the external potential, as they are provided by the heavy atom cores in such system s.

An important e ective contribution to spin-orbit coupling in such systems is the Rashba term which is due to structure-inversion asymmetry of the con ning potential and takes the following form [4]

where p is the momentum of the electron con ned in a two-dimensional geometry, and ~ the vector of Pauli matrices. The Rashba coe cient is essentially proportional to the potential gradient across the well and therefore tunable by an external gate. Thus, the singleparticle H am iltonian is given by  $H = p^2 = 2m + H_R$ , where m is the elective band mass. The components of the time-dependent position operator

in the Heisenberg picture read explicitly

where the operators p and ~ on the right hand sides are in the Schrodinger picture and therefore tim e-independent.

We now proceed by evaluating the above timedependent position operators within a Gaussian wave packet with initial spin polarization along the z-direction perpendicular to the quantum well,

Clearly we have h  $j\!ej$  i = 0, h  $j\!ej$  i = hK<sub>0</sub>, and the variances of the position and momentum operators are (x)<sup>2</sup> = (y)<sup>2</sup> = d<sup>2</sup>=2, (p<sub>x</sub>)<sup>2</sup> = (p<sub>y</sub>)<sup>2</sup> = h<sup>2</sup>=2d<sup>2</sup>. Thus, the group velocity of the wave packet is given by hK<sub>0</sub>=m , while its spatial width is described by the parameter d with them inimum uncertainty product typical for G aussian wave packets, p<sub>x</sub> x = p<sub>y</sub> y = h=2.

A direct calculation gives

In the above expression, ' is a usual polar angle in the xy-plane, and q is a dimensionless integration variable. The time dependence in the integral can be viewed as a zitterbewegung the electron performs under the in uence of spin-orbit coupling. C learly, this integral contribution vanishes for  $k_{0y} = 0$ , i.e. if the group velocity is along the x-direction. M ore generally, one nds that

which m eans that the zitterbew equing is always perpendicular to the group velocity of the wave packet. Let us therefore concentrate on the case  $k_{0x} = 0$ . By expanding the exponential containing the trigonom etric functions one derives

Thus, the amplitude of the zitterbew egung is proportional to the wave length of the electron motion perpendicular to it, and the oscillatory zitterbew egung changes its sign if the translational motion is reversed. If the product dk<sub>0y</sub> is not too large, dk<sub>0y</sub> < 1, only low values of the sum mation index n lead to substantial contributions, and the G aussian factor in the integrand suppresses contributions from large values of q. Thus, a typical scale of this integration variable is leading to sizable contributions is q  $1\frac{1}{2}$ . Thus, a typical time scale in the integrand is T =  $\frac{1}{2}$  hd=, and when averaging the zitterbew egung over times scales signi cantly larger than T, the cosine term drops giving

i.e. the time-averaged guiding center of the wave packet is shifted perpendicular to its direction of motion. Note that the zitterbew equing is absent for  $k_{0y} = 0$  [5].

In the opposite case  $dk_{0y}$  1 the G aussian approaches a -function. In this lim it one nds (for  $k_{0x} = 0$ )

Here the frequency of the zitterbewegung is =  $2 k_{0y}=h$ , and the guiding center of the wave packet is also shifted in the direction perpendicular to its group velocity. Note that h is the excitation energy between the two branches of the R ashba H am iltonian H at a given m om entum  $\tilde{k} = k_{0y} \mathbf{e}_y$ .

The zitterbewegung of an electron in a quantum well as described above is naturally accompanied by a broadening of the wave packet, where the dom inant contribution stems from the dispersive e ective-mass term

in the Hamiltonian. Such a broadening might pose an obstacle for experim entally detecting the zitterbew egung. However, the broadening can be e ciently suppressed and limited if the electron moves along a quantum wire. In fact, the motion of electrons in quantum wells is generally under better control if additional lateral con nem ent is present. W e therefore consider a harmonic quantum wire along the y-direction described by  $H = p^2 = 2m + m ! ^2 x^2 = 2 + H_R$ , where the frequency ! param etrizes the con ning potential perpendicular to the wire [6,7]. For this case exact analytical progress as above does not seem to be possible, and we therefore follow a num erical approach com bined with an approxim ate analytical study. To be speci c, we consider an electron with a given momentum  $k_{0v}$  along the wire and injected initially into the lowest subband of the con ning potential with the spin pointing upwards along the z-direction, i.e. the initial wave function for the x-direction is a G aussian whose width is determined by the characteristic length

h=m! of the harm on ic con nem ent. In our num erical simulations of the exact time evolution we nd again a zitterbew equing perpendicular to the electron motion along the wire with the width of the wave function across the wire being limited by the con ning potential. M oreover, the am plitude of the zitterbew egung becom es m axin alif the resonance condition  $j_1 = j_2 k_{0y} j = h!$  is ful lled. This general nding is illustrated in Fig.1 where the wave number along the wire is xed to be  $k_{0v} = 5$ and the Rashba parameter is varied around the resonance condition. Equivalent observation are made if the Rashba coupling is xed while the wave number  $k_{0 \ensuremath{v}}$  is varied. In Fig. 2 we have plotted the amplitude of the zitterbewegung as a function of  $=! = 2 k_{0y} = h!$  for di erent values of the wave number  $k_{0v}$  along the wire. In this range of param eters, the resonance bocom es narrower with increasing  $k_{0v}$ , while its maximum value is rather independent of this quantity and rem arkably well described by = 2.

A qualitative explanation for this resonance can be given by writing the Hamiltonian in the form H =  $H_0 + H_1 \underset{p}{\text{w}} \underset{p}{\text{ith}} H_0 = h! (a^+ a + 1=2) + h^2 k_{0y}^2 = 2m + k_{0y} \overset{x}{,} H_1 = i \underset{p}{\text{hm}} != 2 (=h) (a a^+) \overset{y}{,} \text{ and } a, a^+ \text{ being the usual harm onic climbing operators [7]. The zitterbewegung is induced by the perturbation H<sub>1</sub> which can act most e ciently if the unperturbed energy levels of H<sub>0</sub> are degenerate having opposite spins. This is the case at <math>\frac{1}{2} k_{0y} j = h!$ .

 direction, and 0 and 1 stand for the ground state and the rst excited state of the harm onic potential, respectively. W hen applying the transform ation

the projected H am iltonian and in turn the time evolution operator become block-diagonal,

At resonace,  $h! = 2 k_{0y}$ , we have z = 0, and if x can be neglected compared to z (which is the case for large enough  $k_{0y}$ ) the amplitude of the zitterbew equing is approximately z = 2, in accordance with the num erics.

We note that the above resonance condition can be reached by tuning either the R ashba coupling or the wave vector of the electron in jected into the wire. For instance, for a wire of width = 50nm and the band mass of InAs being 0.023 in units of the bare electron mass, one has h! Im eV. Typical values for the R ashba parameter in InAs are of order 10<sup>11</sup> eVm [8{14}] leading to a wave length  $_{0y} = 2 = k_{0y}$  100nm at resonance. For G aAs, the band mass is larger while the R ashba coe cient is typically an order of magnitude sm aller than in InAs [15], giving a wave length of a few ten nm at resonance for = 50nm.

We are propose that electron zitterbewegung in sem iconductor nanostructures as described above can be experimentally observed using high-resolution scanningprobe m icroscopy in aging techniques as developed and discussed in Refs. [16,17]. As a possible setup, a tip su ciently smaller than the width of the wire can be m oved along the wire and centered in its middle. For an appropriate biasing of the tip, the electron density at its location is depleted leading to a reduced conductance of the wire. Since the am plitude of the zitterbew equip reects the electron density in the center of the wire, the zitterbew equip will induce beatings in the wire conductance as a function of the tip position. These beatings are most pronounced at the resonance, see Fig. 1. Note that the oscillations shown there as a function of time can be easily converted to the real-space y-coordinate by multiplying the abscissa by  $hk_{0y}$ =m. G enerally we expect spin-orbit e ects in STM experiments to be more pronounced in the presence of additional con nem ent such as in a quantum wire.

M oreover let us consider spin-orbit coupling of the D resselhaus type [18{20],

which is due to the bulk-inversion asymmetry in zincblende sem iconductors, and the coe cient is determined by the wellwidth along with a material constant [19,20]. Here the components of the time-dependent position operator of an electron in a quantum well read

In much the same way as above, these expressions lead to a zitterbew equing of electronic wave packets in a direction perpendicular to their group velocity. If both R ashba and the D resselhaus spin-orbit coupling are present, the directional dependence of the zitterbew equing is more com plicated, which can be understood term s of the anisotropic dispersion relations arising in this case [21]. The corresponding expressions are rather lengthy and shall not be detailed here. How ever, in the case where the R ashba coe cient is tuned to be equal in m agnitude to the D resselhaus term, =, the zitterbew equing is absent. This is due to the additional conserved quantity which arises at this point and cancels the m any e ects of spin-orbit coupling [22,21].

F inally we mention that sim ilar expressions can be derived for the case of heavy holes in the p-type valence band of III-V sem iconductors (as opposed to s-type electrons studied so far) being subject to spin-orbit coupling due to structure-inversion asymmetry [23,24]. A gain, the zitterbewegung of a wave packet with its spin pointing initially in the z-direction is perpendicular to the group velocity.

In conclusion, we have studied zitterbew equing of electronic wave packets in III-V zinc-blende sem iconductor quantum wells in the presence of spin-orbit coupling of the Rashba and Dresselhaus type. Our results suggest the possibility of a direct experim ental proof of this oscillatory motion due to relativistic e ects, con ming a long-standing theoretical prediction. Sim ilar results can be derived for the case of heavy holes in quantum wells under the in uence of Rashba spin-orbit coupling. A very prom ising route for such experim ents are high-resolution im aging techniques developed recently [16,17]. If the spin of the electron is initially aligned along the z-direction, the zitterbew egung is alw ays perpendicular to the group velocity of the wave packet. For possible experiments quantum wires are particularly attractive. For this case we nd a resonance condition maxim izing the zitterbewegung. This resonance can be reached by either tuning the Rashba coupling or the electron velocity along the wire.
