R eply to C om m ent on \U niversal D ecoherence in Solids"

The C om m ent of O penov [1] on my Physical R eview Letter [2] does not a ect the universality of the decoherence m echanism described in the Letter [2]. The Letter addressed the question of decoherence of quantum oscillations of a two-state system in a solid when the oscillation frequency, !₀, is below the D ebye frequency, !_D 10^3 s^{-1} . Ihave shown that conservation laws (that is, sym m etry) m and ate param eter-free interaction of the tunneling variable with the phonon displacem ent eld u. For, e.g., a particle of m ass m, oscillating between degenerate m inim a, R = R₀, of a potential U (R), conservation of the total linearm om entum (particle + solid) results in a decohering interaction

In quantum theory

$$\mathbf{R} = \frac{1}{2} \left[\mathbf{H} ; \mathbf{R} \right]; \qquad (2)$$

where H is the Ham iltonian of the system, while

where is the momentum density of phonons, canonically conjugate to u. Here V and are the volume and the mass density of the system, a_{ki}^{Y} and a_{ki} are operators of creation and annihilation of phonons, $!_{ki}$ is the frequency of the phonon of wave vector k and polarization i, and e_i are unit vectors of polarization of the phonons.

For an orbital moment or a spin, I, oscillating, e.g., between I projections onto a quantization axis, conservation of the total angular momentum (I + angular momentum of a solid) results in a decohering interaction

$$\frac{1}{2} I (r \underline{u}); \qquad (4)$$

with \underline{u} given by Eq. (3).

Equations (1) and (4) were used in my Letter [2] to obtain universal lower bound on the decoherence of solid-state qubits. Parameter-free decoherence rates were computed within perturbation theory, making use of the Fermi golden rule. It gives accurate results for, e.g., tunneling of electron or tunneling of a spin, and applies to all solid-state systems that t de nition of a $\sim !_0$, the decoherence qubit. At low tem perature, $k_B T$ occurs due to spontaneous resonant em ission of a phonon of frequency $!_0$. Openov observed [1] that for a heavy particle oscillating at a high frequency, the decoherence due to Eq. (1) may become so strong that standard perturbation theory and the Ferm i golden rule may no longer apply. I would like to stress that this observation in no way a ects the universality of the mechanism of decoherence pointed out in my Letter. Parameter-free equations (1) and (4) describe unavoidable decohering e ect of the elastic environment, which is mandated by the conservation laws regardless of the strength of decoherence. They apply to all problem s of quantum tunneling of a particle in a solid [2], to transitions between quantum states of a spin in a crystal eld [2, 3, 4], and to tunneling between m acroscopic quantum states of a superconducting current [5].
