Inform ation Horizons in Networks


We investigate and quantify the interplay between topology and ability to send specic signals in complex networks. We not that in a majority of investigated real-world networks the ability to communicate is favored by the network topology on small distances, but disfavored at larger distances. We further discuss how the ability to locate specic nodes can be improved if information associated to the overall tractin the network is available.

Not all dierent parts interact directly with all other parts in a complex system. Rather each element interacts directly only with a few particular elements. Distant parts of the thereby formed network can consequently com m unicate through sequences of local interactions. In this way all parts of the network in principle can be reached from other parts, but not all such communications are equally easy or accurate. The network is thus a description of the limited ability to send specic signals in the system [1]. We stress the dierence between specic signaling in networks and the contrary unspeci c broadcasting: W here speci c signaling only focuses on locating one speci c node without disturbing the remaining network, the non-speciabroadcasting amplies by transfering signals to all exit links of every node along all branching paths. Speci c signaling is thus constructive communication, whereas non-specic broadcasting rather is of relevance for disease spreading or computer virus propagation [2, 3].

One can imagine various ways of searching a specic node in a network, dependent on the available information when the search is performed [4]. In present paper we compare ways to guide the search based on locating the shortest path between a source and a target in the network. Thus we are only characterizing specic signaling, where any deviations from shortest paths mean the loss of the signal. In other words, the cost of deviating from the shortest path is assumed to be in nite, and we simply quantify the search in terms of the number of questions needed to follow the shortest path to the target.

First let us consider the Search Inform ation introduced in [7]. The Search Inform ation of going from source node s to target node t, S (s ! t), is the number of bits of inform ation one needs to go from s to tusing the shortest paths: In the beginning, when starting at node s, one has to not the right exit link, leading to the second node on the shortest path to the target node t. We assume that each node is a simplistic autonomous system that knows which of its exit links that leads to the target. The number of questions one has to ask such an autonomous system in a source node is $\log_2{(k_s)}$, where



 k_s is the degree of the source. At the subsequent node, j, along the shortest path to the target the number of questions is reduced to $\log_2{(k_j-1)}$ since the incoming link is known. That means that the number of questions one has to ask when walking along the path from the source to the target is S (s!t) = $\log_2{(\frac{1}{k_s}-\frac{1}{j}\frac{1}{k_j-1})}$. If there are more than one shortest path between s and t, then:

where the sum runs over the set fp(s;t)g of degenerate shortest paths between s and t, see Fig. 1. In the previous work [7] we investigated S for a number of networks




FIG. 2: A nalysis of real world networks. Here City is the inform ation city network of Malmo [8] with roads mapped to nodes and intersections to links. The Internet refers to the hardwired networks of autonomous systems [14], the CEO to the network of cooperate executives in US [9] and Fly to the protein-protein network of D rosophilia Melanogaster [10]. In a) we compare S(1) with the similar search performed in a randomized version of the network. One observes that search on short distances 1 2 3 is relatively optimized in the real networks. In b) we compare S with the search obtained when one uses the information associated to overall tracin the network. We see that such global tracin formation helps the search at all long distances.

and found that one needs more information to orient in real-than in random networks. By random networks we mean the networks random ized by the reshu ing of links in such a way as to preserve the degree sequence and keep the network connected [11]. To explore the nature of these complications in real world networks we, in Fig. 2, look at the average Search Information for nodes separated by 1 links and compare it with the corresponding quantity in a random ized counterpart. From S(l) = hS(l)i $hS_{random}(l)iwe$ see that essentially all the contribution to the global excess of S $_{p}$ = S $_{random}$ com es from large distances 1> 3 (S = $\frac{1}{N^{\,2}}$ $_{s;t}$ S (s ! t)). For som e of the networks, as for exam ple Internet, Yeast and Fly, the S(l) is even negative at short distances, which implies that these real networks are organized to optim ize the search at these short distances. Thus local speci city is favored whereas communication beyond the horizon l= l_{search} 3 is disfavored.

To uncover how the topology and the search information, quanti ed by S, are coupled we, in Fig. 3 investigate a number of model networks. Fig. 3(a) shows S(l) S_{random} (l) for the various model networks. We see that the search is easy at distance 1 3 in the modular network, whereas a random ly rewired network provides better search options for 1 > 3. The hierarchical club network, on the other hand, clearly does worse than a random network on all scales. Here we have obtained a surprising and counterintuitive result that hierarchies are not always optimal for search. That (club) hierarchies are used in many hum an organizations may thus be seen as a way to regulate and thus limit the information exchange, rather than to optimize overall specic communication [15].

The search information S de ned above is based on a




FIG. 3: A nalysis ofm odel networks in terms of the quantities in Fig. 2. The simple modular network is constructed of C modules with C nodes in each, with 0 2C connections between nodes in modules and 0 2C connections between the modules (C = $\overline{\rm N}$). The club tree is a hierarchical network with club structure at each level, a construction intended to mimic our view of social organization. We used a version with lki = 6 neighbors per node and with log (N)=log (kki=2) hierarchical levels. The scale-free network is an example of networks with broad degree-distributions, here scaling as 1=k^{2.4}. In all cases we simulate N = 5000 node networks.

m in in alapproach where one at each node knows nothing about the relative in portance of the neighbors. However, in real social networks one often knows who is best connected to the rest of the system. For example in a military hierarchy, every soldier knows who their im mediate superior is. This know ledge can be obtained self consistently at any node in any network by monitoring the tra c of orders past this node. In order to explore how the search can be simplied by additional know ledge we introduce a slightly di erent quanti cation of search inform ation. That is, we explore the inform ation needed to search if one knows the overall tracow. When questioning the minimal autonomous system at a node, we weight the questions according to the betweenness of the links to the node [5, 6]. Thereby we de ne the weighted search information

where j labels the node on the path p(s;t), starting at j=1 for neighbor node to s. $b_{j;j+1}=b_{j;j+1}=b_{k-j;k}$ is the betweenness of the link from node with label j to node with label j+1, divided by the sum of the betweennesses of all k links from j. $b_{j;j+1}^0$ is similarly dened except that the normalization excludes the link to the preceding node of j on the shortest path between s and t.

To understand the di erence between S and S_w we consider a city (de ned through the city network where each node is a road, and each link an intersection [8]). By orienting yourself with the strategy behind S small and large roads are weighted equally. However, S_w cap-

tures that large roads more often take you closer to the target than small roads. For all investigated networks one in average gains by using the weighted search strategy. However, the contribution is not hom ogeneously distributed over distance. As one can see in Fig. 2(b) the weighted strategy is more e cient at longer distances, $1>3. \text{ How ever } S_w > S \text{ for } 1$ 3 and thus it turns out to be ine cient to follow the ow when the target is nearby. This re ects the fact that if you follow the ow you will nearly always overlook small roads in your neighborhood. In terms of navigating in a city, the S_w (1) S (1) di erence shows that it pays o to follow the large roads until you are within a few turns from your end target. Then it naturally pays o to change strategy and disregard the main stream. The distance where S_w (1) com es negative therefore de nes a characteristic search horizon, llocal global, at which one should switch from localto global search strategy.

We next study the relative advantage of local versus global search strategies for som e m odel networks in Fig. 3 (b). Like the real world networks, also the model networks have $S_w > S$ at small distances, and $S_w < S$ at large distances. In particular, the club tree (hierarchy) does extremely bad at short distances because there is a strong bias to go along the main ow, and one thus needs a lot of e ort to locate peripheral neighbors. For a random scale-free network, on the other hand, the overall trace very fast guides you to the center, and therefore S_w is a good search strategy at nearly all distances. The scale-free network represents topologies with very broad degree distributions and in these one nearly always benet by following the ow [4].

In between these two networks is the modular network, where the global ow confuses local search (S (1 < 3) < $S_{\rm w}$ (1 < 3)), but helps tracto other modules and thus to the more distant targets. Returning to the realworld networks in Fig. 2(b) their $l_{\rm local~global}$ 2 horizon for trac guided search may be seen as a combination of a short $l_{\rm local~global}$ 1 horizon associated to their broad degree distribution (scale free in Fig. 3(b)), and a larger $l_{\rm local~global}$ horizon associated to modular or hierarchical features.

One may ask whether the two search strategies can be combined, such that one uses local information for local search, and global tracinformation for long distance search. In terms of tracin a city the picture is that there are multiple types of trac, from pedestrian to short distance targets, bicycles to intermediate distance targets, to cars for the distant targets. In accordance to this picture we introduce the limited betweenness measures $b_{ij}(r)$ for the links j around a node i, dened by trac between all pairs of nodes that only moves at maximum a distance r between the source and the target. Given this set of r dependent trace weights, we in analogy with Eq. 2, dene a set of search measures $S_{w(r)}(l)$. For r=1, $S_{w(l)}(s!t)=S(s!t)$,




FIG. 4: Investigations of search strategies in a model network a) and information city network of Malmob). The gures illustrate 3 simple search strategies, and one optim ized (shaded). $S_{w(r)}$ (1) denotes the search information based only on tra c between nodes separated by not more than r steps in the network. We see that nodes on short distance are best found by using local search strategy (S $_{\rm w\ (r=\ 1)}$ = S , whereas search to distant nodes are best performed by using inform ation from global tra c. However, nodes at interm ediate distances are best found by using tra c between nodes at interm ediate distances. To optim ize search we also show a different search strategy $S_{\text{scale adjusted}}$, where one at each step j along the path to the target adjust the tra c horizon to the rem aining distance to the target. We furtherm ore restrict the tracbias to the subset of tracthat are targeted to the node j one is currently at (see Fig. 5).

whereas $S_{w\ (r=1\)}$ (s ! t) = S_{w} (s ! t) and thus $S_{w\ (r)}$ naturally interpolates between the non-weighted and the tra c-weighted search approaches. In Fig. 4 (a) we examine $S_{w\ (r)}$ (l) for the club-hierarchy network from Fig. 3. In accordance with Fig. 3 (a) we again see that the longer distances indeed are best searched by using long distance tra c. In addition we see that intermediate distances 1=3 7 are best searched by using a search weighted by tra c traveling intermediate distances r 5, as quantied by $S_{w\ (5)}$ (l).




FIG. 5: Illustration of optim alsearch strategy on an inform ation city network of G am la stan, Stockholm [8]: At each step the contribution to the tracbias is limited by sequentially decreasing horizons (circles). The radius of each horizon reects the node distance to the target. In case of the large city, each horizon corresponds to the type of transportation one should consider: Within the big circle one looks for cars and within the smallest circle for pedestrians. The path is indicated in black.

Fig. 4(b) shows the optimal search strategy in a real network, here the information city network of Malmo [8]. Again the search e ciency is improved by adjusting the tra chorizon to the search distance. In fact the search can be further optim ized by, at each step, adjusting the tra c horizon r to the remaining distance to the target. In the language of city networks, when searching a distant road, one rst uses information from car trafc, but as distance to target becomes smaller than say 5 intersections, one instead uses bicycle- and then subsequently pedestrian tra c. This overall feature of optim izing search works best when one weights the exit link from each node j by the fraction of overall tra c target explicitly to j. Thus, the optim alsearch indicated by the shaded area in Fig. 4 corresponds to a search strategy, where one at each step j from s to t bias the search according to the subpart of the tra c that is targeted at j, and which has a source at distance that are not further away than the target t (see Fig. 5). The di erence to the normal betweenness is that the target betweenness e ectively partitions the network around each node j, such that each exit link is weighted by the fraction of the network that it leads to. This therefore provides a more e cient guess on the direction to the rest of the network from j than the normal betweenness.

O by iously the optim alsearch strategy can only be used if one has access to this distant-dependent tra c information. However, as in a city, such information can for exam ple be quite well estim ated in social networks. Consider M ilgram 's fam ous result of a m ail locating a target person in a chain of typically six acquaintances between two persons in USA [12]. The nontrivial result of Milgram 's experim ent is not that the distance between two persons is just six, since the dim ension in social networks are high [13], but the fact that short paths were found in the experiment. In terms of our optimal search strategy, M ilgram 's experim ent is interpreted the following way: Every participant that receives a mail aim ed to a distant target person, gives this in his turn to a friend, with a chance weighted to how often this friend travels on distances up to the scale of the target distance. With such a search strategy, that at each point along the path is adjusted to the horizon to the target, the mail will nd a short path to the target person with high probability (low inform ation cost). We speculate that hum ans inherently tend to use such a scale-free search strategy, and by this facilitate robust communication on all scales ranging from a single rem ote village to the whole planet. The information gain by doing so in the city Malmo is illustrated by the dierence between the black curve and the

shaded area in Fig. 4 (b).

In the present work we have quanti ed the inform ation cost associated to transm ission of speci c signals across a complex network. By comparing real—and random networks, we have shown that many real-world networks tend to have optim ized searchability at rather short distance 1 3. The cost of this optim ization is that beyond this horizon one must use more intelligent methods to facilitate searchability. In the spirit of communication we have investigated methods based on global tractoberard at local level and interpreted them in real-world examples.

In many networks, in particular social or trace networks, the search strategy can be adjusted according to average trace ow. The distance at which global trafcebecomes superior to unbiased search de ness a horizon associated to the largest scale of modules in a network. In general, any network we have investigated are best searched by using the \scale invariant" strategy, where directions are selected according to the average trace to nodes at distances similar to that of the searched target node.

In that case the S m easured from the top is $\log_2(N+1)$ 1 2=N+4 $\log_2(N+1)$ =(N (N+1)) $\log_2(N=2)$ which is a smaller search information than for any other organization of a network consisting of N nodes.
