On voltage-current characteristics and critical current in Bi-2212

V (I) characteristics have been performed in a monocrystalline microbridge of Bi[b] 2212. The vortex phase diagram has been greatly investigated. Linear but non-ohmic Voltage (Current) (V (I)) curves with well dened critical current have been observed. A departure from this behavior is observed near the peak elect where an out of equilibrium high threshold current can be stabilized. At high temperature, the critical current persists in the "liquid" state despite the dissipation at the lowest bias. Some implications of these results are discussed. In particular, it is proposed that the surface disorder, rather than the bulk disorder, is responsible for the vortex pinning in this sample.

The generic vortex phase diagram in cuprates is now described in terms of into dierent therm odynamic phases of vortex [1]. The main idea is that an ordered Vortex Lattice (VL) is present at low eld and low temperature, and that it develops into a phase possessing a degraded order when the thermal uctuations or the static disorder are increased. This corresponds respectively to (ordered solid/liquid) and (ordered solid/disordered solid) transitions. The strong experim ental facts which have justi ed these ideas are the disappearance of the vortex pinning in the "liquid" phase and the increase of this vortex pinning (the peak e ect) when crossing the disordering transition. The highly anisotropic cuprate Bi-2212 can be taken as a representative sam ple where these three states can appear. Nevertheless, recent experim ents suggest to qualify this point of view. Indeed, it has been found that both the high eld and the high temperature properties can be interpreted with the same state of vortex matter, meaning that no dierence between them should be presupposed [2, 3]. Another striking result is that VL translational order is not a good order param eter to characterize the rst order transition [4], whereas one could have expected the contrary for a genuine melting. From an experimental point of view, the VL behavior in Bi-2212 has been tackled at low eld by magneto-optic imaging or local ac probes [2, 3], which are sensitive to pinning induced screening currents on the surface of the samples. If the magnetic eld is increased, the limited resolution of the above-cited experim ents strongly restricts their ability to give inform ation on the VL pinning and dynam ical properties. One complementary and easily understandable experim ent is the measure of a voltage versus current (V (I)) curve. The critical current $I_{\rm c}$, which gives the pinning ability of the medium, can be extracted without the need of complicated and possibly unjustied assumptions. Furtherm ore, it has been shown by num erous theories and simulations [5, 6, 7] that the nature of the VL

should govern the variation of its velocity as function of a bulk training force. To the extent that this force is directly given by the amount of applied transport current, these signatures are directly expected in the V (I) curves. For example, there is some consensus concerning the dynamical properties of a VL [1]. They are expected to be dominated by hopping over barriers at low currents, with a transition to a free ow and 0 hm ic-like regime at high current. Fig.1 is a schematic representation of the di erent V (I) curves which can be expected for the di erent VL states, namely ordered state (Bragg Glass) and disordered states (vortex G lass and vortex liquid). We note that if num erical sim ulations of velocity versus force curves are extremely numerous in the literature, very few direct m easurem ents have been perform ed in cuprates to see if the main expectations compare well with the experim ents. In the present experim ent, we are thus principally interested in the qualitative di erences (if any) between the functional form of the V (I) curves, for di erent locations (B,T) in the phase diagram.

Them easurem ent of a V (I) curve is conceptually a very simple method and is currently used as a useful probe of vortex properties in low T c m aterials. On the contrary, it was unem ployed for high T c's, except using very low current densities. The reason is practical: quasi-perfect contacts are usual in low T $_{\rm c}$ m aterials (R $_{\rm contacts}$. 0:001) but not in cuprates (R contacts & 1-2). It is thus di cult to avoid any overheating in these rather resistive contacts as soon as the current exceeds tens of milliAm peres. Typically, under normal Helium atmosphere and standard experim ental conditions, It 100 m A into a 1 m etallic contact (. mm²) is compatible with a local increase of the tem perature of about 0.1 K. This strongly restricts the value of the "safe" transport current. Extrapolating to a typical sam ple size (W = 1 m m, t = 100 m, W = w idth,t= thickness), the V (I) curves are thus di cult to perform as soon as J & 10^2 A = cm² (i & 0:5A = cm if expressed in surface current units). Since the critical current should be at least less than these values, only the depinning onset close to the high temperature rst order transition can be reliably measured. It is worth noting that similarly low current densities are usually not su cient to

overcom e unavoidable critical current inhom ogeneities at the onset of vortex depinning, even in pure superconducting m etals. In this regime, only parts of the VL are moving. To reach the ux-ow regime where the whole VL is in motion, it is necessary to increase the value of the injected current, say (I I) reasonably larger than Ic. One of the possibilities which allows to overcome the overheating problems is the use of fast current pulses. This technique was employed in [8]. Both stable linear and metastable V (I) curves with a S-shape were measured. Since the pulse of current in jection is very fast (about 100 s), a normal skin e ect can a ect the preceding results and it is not completely clear if they can be taken as representative of the steady state of the moving VL.A con mation of this experiment, using a continuous transport current, appears thus necessary. For that, we have studied monocrystalline bridges of 100 or 200 m ofwidth. This ensures a good hom ogeneity of the current in jection. Above all, for a sam e current I, a largest current density (I=tW = J or I=2W = i) is obtained when using a microbridge rather than a bulk sample. This let the possibility of working in the ux-ow regime without the overheating at the resistive contact pads, even at low tem perature.

In this experiment, we would like to address simple experimental facts to the following questions:

-W hat are the fundam ental di erences, if any, in the shapes of the V (I) curves for the di erent V L states? - Is it possible to explain the critical current values?

The samples used in this study are slightly Pb doped single crystals of the Bi-2212 family (B $i_{1:8}$ P $b_{0:2}$ S r_2 C aC u_2 O $_{8+}$). They were grown by the self-ux technique as previously described [9]. Each cleaved single crystal was laser tailored in the form of a microbridge with a controlled pattern of (W = 200 *L=400) m² or (W=100 * L=400) m² (Fig.2). The thickness is about 100 m. The crystalwas after annealed under a controlled pure oxygen gas ow and is in the slightly overdoped regim e ($T_c = 79.5 \text{ K}$). Low resistance electrical contacts (1) were made by bonding gold wires with silver epoxy. The DC transport measurem ents were performed using a standard four probe method (cryostat Quantum Design with a 9T horizontal coil, external current source A dret and nanovolm eter Keithley). The results presented here correspond to the m icrobridge with W = 200 m, otherwise it will be speci ed in the text.

RESULTS IN THE LOW TEMPERATURE REGIME We have st performed V(I) curves at low temperature (T = 5K) in order to minimize the elect of the thermal uctuations. Let us discuss the results for high magnetic eld values (IT B 9T, Fig. 3). The V(I) curves are very similar to those observed for a conventional vortex lattice, as it can be measured in low Tc metals or alloys. In particular, they present the usual form V = Rff (I $_{\rm E}$) as soon as I is slightly higher than the critical current Ic (Rff is the ux-ow resistance of the VL). There is no evidence of an ohm ic regime at low

applied current and the depinning is rather sti. Furtherm ore, we have tried to compare the elects of a Field Cooling (FC) and of a Zero Field Cooling (ZFC), or of a FC under dierent cooling rates. A lways the same dissipation has been measured in the time scale of our experiment. In particular, no aging elect is observed on the critical current. This is not in agreement with a glassy nature of the VL governing transport properties.

When the magnetic eld is decreased, a dierent behavior is observed in a restricted region of the phase diagram (0:05T 02T). If the VL is prepared af-В ter a FC, the V (I) curve exhibits a S-shape with a high threshold current I_{high} [10], but only for the rst increase of the current. After this initial ramp, a reproducible $I_c < I_{h \, igh}$ is always measured (Fig. 4). This has been previously observed in the pulsed-current experiments, and this state with a "high threshold current" has been evidenced as a metastable state with a very long relaxation time [8, 11]. Our measurement using a dc current proves that the observation of this state is not due to the kind of stimulation used. This observation is also in agreem ent with the observed supercooling of a high critical current state using a time-resolved local induction measurement [2]. We observe a hierarchy in the accessible threshold currents. Depending on the exact preparation of the FC state (cooling rate, value of the initial eld, rate of the current injection ramp), num erous threshold values are accessible between $\rm I_{h\,iqh}$ and $\rm I_{c}$. It is clear that in such a regim e where it is easy to lock an out of equilibrium state, most of the measurements will give transient and spurious relaxation e ects if the eld is ram ped or quenched as it is done in m agnetization m easurements. We nd some traces of this metastability up to about 1T, but the most obvious e ects are restricted in the region (0.05-0.2T) (Fig.5). For $I > I_{high}$, the V (I) curve is observed disrupted. If the width of the microbridge is narrower, multiple steps in the current induced m oving state can even be observed (inset of g. 4). Even sm all (100 m), this width is much larger than any superconducting length. It is thus likely that these structures in the V (I) curves can not be explained by phase slippage processes as observed in one dim ensional superconductors [12]. This m im ics rather the voltage steps which have been observed in the current-induced resistive state of type I superconductor [13] and can be the counterpart of a coexistence between two states possessing dierent critical currents and comparable spatial extensions. This dynamic is close to what is observed in a current carrying inhom ogeneous superconductor. It can not be exclude that the high values of the threshold current are responsible for local heating in the interfaces between the domains and favor the formation of resistive "electrotherm al" structures [14]. Concerning the metastable V (I) curves, the peak e ect in the critical current, the coexistence of two VL states, the same kind of behavior is currently observed in 2H N bS e [15]. The strong di erence is that the peak e ect and the associated m etastable e ects appear close to B c2 in N b Se2 but is here restricted

to a very low eld value. Since the applied tem perature is very similar in both experiments, the explanation of this eld value dierence has to be found in the large dierence between the electronic anisotropies. For a eld lower than about 0.05T, we do not observe any hysteresis within the V (I) curves. This is summarized in g. 5 where $\rm I_{\rm G}$ versus B is shown.

One has to remark that the variation of $I_c(B)$, if one excepts the small low eld part where metastability takes place, looks like what is measured in soft low T_c materials. To some extent, one can speculate that the same pinning mechanism is acting without involving a dierent VL phase. Qualitatively, the functional form of $I_c(B)$ is very close to the one of the reversible magnetization of a high anisotropic superconductor [17], meaning that I_c is linked to the weight of the diamagnetic screening currents. This has to be brought close to the linear V (I) curves that we measured. We will return to this point later.

HIGH TEMPERATURE RESULTS: THE "LIQUID" STATE

Let us now discuss the V (I) curves obtained at high tem perature. The tem perature T was xed at 50 K and the magnetic eld B was varied from 0.001T to 9T, in order to cross the transition between the so-called "solid" and "liquid" vortex phases. In Bi-2212, them odynam ical consistency required by the respect of the C lausius-C lapeyron relations [18] can not be proved, because up to now no transition can be detected using speci c heat m easurem ents. The small step usually observed in the m agnetization [16], added to the reasonable idea that the sam e physics is acting both in Bi-2212 and in YBaCuO, can be taken as a good indication that this transition is of rst order. The appearance of an approximate linear resistivity when the sample is probed at very low current density is also usually taken as a good criteria. The underlying ideas are that a liquid state of 2D vortices can not be pinned and that the resistive properties are close to that of a metal (0 hm ic regime). Using the sam e criterion, the transition would be located at about 0.08 T (g. 6), in agreem ent with values currently reported in the literature (0.065 T in [16] for a Bi-2212 with an equivalent doping). Nevertheless, we observe that for magnetic elds largely higher, in a large part of what is identied as the "liquid" state, the V (I) curves are clearly non ohmic (g. 7). A non linear response in this resistive state has already been observed. It has been interpreted as the feature of a highly viscous liquid of vortices [19], or by the edge e ect of surface barriers (SB) [20]. Roughly speaking, SB are expected to be negligible for elds B $B_{c1} = \ln ()$ 20B_{c1} for high superconductor (= 100) with an ideal at surface [21]. Any real sample also possesses surface irregularities which facilitate vortex nucleation and decrease this value. We estimate that, taken Bc1 300G, SB e ects can be neglected when a magnetic eld of several Teslas is applied. We note also that other experiments performed using the Corbino geometry do not evidence any e ect of

SB at high tem perature [22]. We have also checked that a decrease of the sample width decreases I_c , con m ing that neglecting SB is reasonable, at least as far as critical current properties at high eld values are involved. W e stress on the following points: the high current part of the V (I) curves is linear and its extrapolation never goes to zero (g. 7), at least for B 9 T. In other term s, putting aside the rounded dissipation on set, V (I) curves can be expressed as $V = R_{ff}$ (I I) as it was observed at low temperature. It can not be explained by a non linearm echanism in which a depinning energy would be a function of the driving force required to overcome barriers, because the high current regime is linear but does not reach an asymptotic 0 hm ic regime (V = R : I). This demonstrates the existence of a real critical cur-10m A in this high tem perature state. This critical current exhibits a eld dependence that com pares well with the one obtained at low tem perature. It is thus reasonable to think that the same pinning mechanism occurs at low and high tem peratures. The di erence in the low dissipation level can be understandable in term sofan additive process which appears at high tem perature, and a them ally activated process which assists the depinning is a natural candidate. This was largely studied in the literature [1]. This de nes a threshold current I* above which a small dissipation appears but pinning continues to exist (Fig.6).

D ISCUSSION

From a theoretical point of view, vortex lattice depinning is generally described like a critical phenomena: the bulk depinning of an elastic system in a random media. Driven states are described with an overdam ped dynam ical equation and it is expected that without them al activation the velocity v just above the depinning scales F_c) where F is the applied force, F_c the bulk pinning force and is the critical exponent [1, 23]. The usual analysis supposes that (F F_c) identies with J), J being a current bulk density. At high velocity, disorder is found not relevant that leads to a velocity v F. Experim entally, this should correspond to an 0 hm ic regime. Clearly, the experimental results are di erent. Even without performing a detailed analysis, one can realize that the V (I) curves at the depinning onset are never observed convex. is never lower than 1 even at low temperature where the vortex Creep driven by them al activation is negligible. One excludes from this discussion the peculiar case of the peak e ect where a convex part is e ectively observed but is very likely due to the macroscopic inhomogeneity of the state. It is more im portant to remark that, when I Ic, the velocity is found to vary like (I &) and not like I. This means that the pinning force felt by the VL remains constant even at "high velocity", in apparent contradiction with an explanation in terms of a bulk depinning. One could object that the applied current in our experiment is not sufciently high to reach the predicted 0 hm ic-like regim e. This problem can never be strictly resolved because Joule heating is always a limitation when increasing the cur-

rent in a transport experiment. Nevertheless, one can refer to low T_c m aterials where the experim ental situation is much more attractive. Under very controlled temperature, it is possible to verify V (I I_c) up to at least 301. This is thus the generic shape of a V (I) curve in a type II superconductor, and the present experim ent shows that the same dissipation mechanisms are acting in Bi-2212 sam ples. It has been also veri ed by inelastic neutron scattering that, in this regime, the VL is moving freely as a whole [24]. This latter result means that the bulk disorder can be estimated to be no more e ective. At the same time, the former result shows that the velocity does not reach the asymptotic regime where the velocity should vary linearly with the total current. To be coherent with the above mentioned theories [23], one possible solution is to replace by hand the applied force F (resp I) that acts against bulk disorder by (F (resp (I I,)) (Fig. 9). Physically, this solution appears in the case of vortex pinning by the surface roughness [25]. The main idea is that the surface disorder (a quite standard surface roughness) allows, thanks to boundary conditions, for the ow of non dissipative super cial current $(i_c(A = cm)) = I_c = 2W)$. This is only when all the super cial non dissipative paths are exhausted, precisely Į, that the excess of current (I Į) penetrates the bulk. To some extent, a bulk force makes then sense and a "bulk depinning" can occurs, but involving only the over critical part of the applied current. The bulk disorder can be averaged by the motion without a ecting the main critical current which re ects the surface pinning ability, explaining the experim ental shape of the V (I) curves. As an further indication that this mechanism can occur in the Bi-2212 sam ples, quantitative expressions for I_c (B) are predicted and can be checked. The case of very anisotropic samples is specially interesting, because it is predicted that for not too low magnetic eld values and for a m oderate surface roughness, the surface critical current is may become independent of the surface quality and depends then solely on the param eters of the condensate [17]. For clarity, we restrict the comparison to the high eld values in order to use the Abrikosov lim iting expressions [17]:

$$i_c = \frac{B_{c2}}{2_{0 A}} (1)^2 (1)^2 (1)^{2-3}$$

Here, $_{2==c}$ (T) is the generalized G inzburg-Landau param eter, the electronic anisotropy and B $_{c2}$ the second critical eld. For the small temperature dependence of $_2$, we use the microscopic G L derivation [26]. This expression describes rather well the data (Fig.10), with the use of a restricted number of param eters. = 60 was obtained from angular resolved resistivity measurements using scaling arguments [27]. With $_2=-$, B $_{c2}=\frac{0}{2}$, we nd $_{(0)}=3:3$ nm; $_{(0)}=2080$ nm consistent with the slightly overdoped regime [28]). The approximate eld dependence of the critical current in a restricted eld range is an indication but can not be taken as a proof of

the validity of the model. Other eld dependence would be acceptable. In particular, in a log-log representation, it is reasonable to estimate that I_c varies like B $^{0.5}$, as it is often observed ([8] and references herein) and interpreted as a 2D strong bulk pinning regime. A possible lim itation of this latter analysis is the relevance of the strong bulk pinning centers in clean single crystals. It is m ore important to note that the absolute value of the critical current is the one expected if only the surface contributes to pinning. To compare with other experim ents, we measured i_c 0.1-0.5 A/cm at (T = 5K, B =9 to 1T) in our microbridge, and 0.4-1 A/cm was measured in [8]. These values seem representative of Bi-2212 crystals. Now it can be objected that the current distribution in Bi-2212 can be strongly in uenced by the very large electronic anisotropy [32]. This leads to a very sm all current penetration in the norm aland in the superconducting state and this has a priori no link with any pinning mechanism. It remains that if a current owing under the surface is non dissipative up to a critical value, a surface pinning mechanism should apply. Finally, it seems that there is no need to involve bulk disorder in order to explain the critical current and the shape of the V (I) curves at least outside the peak e ect region. O ther experim ents will soon be performed to evaluate more precisely the validity of this hypothesis and the speci c case of the peak e ect will be discussed in another paper.

It is clear that this interpretation of the VL pinning in Bi-2212 is at odds with the currently accepted view that the pinning is driven by the bulk disorder (collective bulk pinning). We need to add some comments to replace this result in the context of recent experiments.

In Bi-2212, the peak e ect should separate a high eld disordered phase with glassy properties the low eld ordered VL. The VL, corresponding to the V (I) curves of the g3, is expected to be in this glassy state, whereas we observe a conventional VL dynam ic rather than a glassy dynam ic in its proper sense. The experim ental proof of a disordered high eld state in Bi-2212 is also not com pletely obvious. Sm all Angle Neutron Scattering experiments can e ectively be interpreted in terms of a VL disordering transition at very low eld [29]. This interpretation relies in the strong decrease of the di racted intensity when the density of vortices increases, whereas a simple London model which disregards the nite size of the vortex core predicts only a smooth decrease due to geom etrical factors. Nevertheless, recent theoretical progresses allow to calculate the microscopic eld distribution and its Fourier components are found to be strongly eld dependent even at low eld (for high kappa and/or anisotropic superconductors) [30], meaning that involving a transition in the VL may be not necessary. This can explain why other experiments with a largest intensity are showing that a well ordered VL with good Bragg peaks survives at higher elds [31]. We note also that recent experim ents suggest that the V L order is not relevant for the nature of the "melting" transition in Bi-2212 [4], m eaning that the order param eter of this transition

is not linked to the topology of the VL. Experim ental data suggest that the line of the peak e ect in the phase diagram is the continuation of the rst order line into the low-tem perature [16]. This implies that the same state of the VL is present at low and high temperature. Our experiment suggests that the pinning of the vortex lattice is also of the sam e nature, even if therm al uctuations are responsible for a low dissipation background at high tem perature. Finally, it has been recently proposed that the renormalization of the (non-local) line tension by them al uctuations for large wave vectors is at the origin of the rst order transition [33]. As the line tension is the controlling param eter for the surface pinning, this o ers a scenario m ore compatible with our results than the occurrence of a genuine melting transition. Furtherm ore, even if the bulk condensate is strongly uctuating with eventually disrupted vortices, a small dissipationless current can persist under the surfaces. A wellknown example is the case of surface superconductivity where a critical current does exist in the surface sheath even if the bulk develops into its norm al state.

To conclude, the use of monocrystalline microbridges of Bi-2212 allowed us to measure V (I) curves in dierent parts of the VL phase diagram. They appear conventional and a clear critical current can be de ned by extrapolating the high current linear part. A metastable high threshold state can be stabilized by Field Cooling. This corresponds to the peak e ect region and m im ics what is observed much closer to B_{C2} in NbSe₂. The values of the m easured critical currents and the shapes of the V (I) curves suggest that the pinning by the surface roughness can not be ignored for understanding the vortex lattice dynam ic in Bi-2212. We observe that this super cial critical current survives in a large part of the so-called liquid state. Finally, the overall picture suggests that the VL pinning and dynamic in Bi-2212 are m ore sim ilar to what is currently observed in low $T_{\rm c}$ m aterials than it is often suggested.




FIG.1: V (I) curves expected for di erent phases of the V L (A Q uasi-Lattice (B ragg G lass), B G lass, C L iquid). J_1 represents the depinning current in the phase A , J_2 in the phase B .



FIG. 2: The monocrystalline microbridge $(200*400 \text{ m}^2)$ of Bi-2212.




FIG. 3: Reversible V (I) curves (T = 5 K, B = 1, 3, 5, 9 T from the right to the left). The dashed and straight line is a guide for the eyes and evidences the ux ow regime.




FIG. 4: Hysteretic V (I) curve (T = 5 K, B = 0.15 T after a FC).1/ The st increase of current de nes I_{high} and 2/ The following decrease of the current de nes I_c . In the inset is shown the same kind of curve in the microbridge with a smallest width (T = 5 K, B = 0.05 T). Note the steps in the V (I) curve.




FIG. 5: Peak e ect in the critical current (T = 5K. Black points, I_{high} and empty points, I_c). In the inset is shown the variation of I_c at high eld.




FIG .6: Low dissipation level of the V (I) curves (T = 50K, from the left to the right: B = 0.14 T, 0.12 T, 0.1 T, 0.08 T, 0.04 T, 0.04 T, 0.02 T). As shown in the gure, I_c is de ned using a criterion of 0.2 V and is nearly zero for B & 0.08 T.




FIG .7: Reversible V (I) curves (T = 50 K, B = 1, 3, 5, 9 T from the right to the left). The dashed and straight line is a guide for the eyes. This linear extrapolation de nes I_c . Note that the regime is clearly non ohm ic up to at least B = 9 T.




FIG.8: $I_c(B)$ at I = 50 K. In the inset is shown the low eld part using a sem i-log representation (black point, I point, I_c). Note the disappearance of I at $I_m = 0.08$ T whereas I_c keeps a non zero value. and em pty





FIG. 9: Dierences between the V (I) curves corresponding to (1) a bulk depinning involving all the current (V and (2) a surface depinning with Ic (non resistive) remaining close to the surface at high velocity (V (I I_c) I_{c}) in ux-ow).
