Statistical Approach to Fractal-Structured Physico-Chemical System s: Analysis of non-Fickian di usion

Abstract

C om peting styles in Statistical M echanics have been introduced to investigate physico-chem ical system s displaying com plex structures, when one faces di culties to handle the standard form alism in the well established B oltzm ann-G ibbs statistics. A fler a brief description of the question, we consider the particular case of R enyi statistics whose use is illustrated in a study of the question of the "anom alous" (non-F ickian) di usion that it is involved in experiments of cyclic voltam m etry in electro-physical chem istry. In them one is dealing with the fractal-like structure of the thin In m orphology present in electrodes in m icrobatteries which leads to fractional-power laws for describing voltam m etry m easurements and in the determ ination of the interphase width derived using atom ic force m icroscopy. The fractional-powers associated to these quantities are related to each other and to the statistical fractal dimension, and can be expressed in term s of a power index, on which depends R enyi's statistical m echanics. It is clari ed the in portant fact that this index, which is limited to a given interval, provides a measure of the m icroroughness of the electrode surface, and is related to the dynam ics involved, the non-equilibrium therm odynam ic state of the system , and to the experimental protocol.

KEYWORDS:Complex structured systems, anom alous di usion, fractal surfaces, unconventional statistics, Renyi's statistics.

I. IN TRODUCTION

A couple of decades ago M ontroll and Shlesinger [1] stated that in the world of investigation of complex phenom ena that requires statistical modeling and interpretation, several competing styles have been emerging, each with its own champions. Lately a good amount of e ortshave been devoted to the topic. What is at play consists in that in the study of certain physico-chem ical system swem ay face di culties when handling situations involving fractallike structures, correlations (spatial and tem poral) with some type of scaling, turbulent and chaotic motion, sm all size (nanom eter scale) system swith eventually a low num ber of degrees of freedom and complicate boundary conditions, and so on. The interest has been now adays enhanced as a result that such situations are present in electronics, opto-electronics, etc, devices of the present day point-rst technologies, on which is so dependent our society, also in disordered systems, polymeric solutions, ion conducting glasses, microbatteries, and others. Most cases involve, what in the literature on the subject are called "anom alous" physical properties (let them be transport, optical, hydrodynam ical, etc. ones). As a rule what is noticed is that the observable experim ental data can be theoretically adjusted by means of fractional-power laws in place of the standard ones. We can mention one type, related to the one presented here, consisting into "anom alous" (non-Fickian) di usion in m icelles [2, 3, 4, 5], where the analysis of data used to be done introducing the so-called Levy statistics. In this paper we present a closed statistical theory of a large scope in place of such approach.

In these situations the di culties consist, as a rule, in that the researcher is in paired, for one reason or other, to satisfy F isher's criteria of ciency and su ciency [6] in the standard form alism to implement the conventional, well established, physically and logically sound Boltzm ann-G ibbs statistics, meaning an impairement to correctly include the presence of large uctuations (and eventually higher-order variances) and to account for the relevant and proper characteristics of the system, respectively. To contour these di culties, and to be able to make predictions { providing and understanding, even partial, of the physico-chemical properties of the system of interest, for example, in analyzing technological characteristic of a device { there has been developed e orts along the line of introducing heterotypical statistics for providing an auxiliary method for fullling such purposes.

Am ong existing approaches it can be mentioned, what we call Generalized Statistical Me-

chanics as used by P.T. Landsberg showing that functional properties of the (inform ational) entropy (which is a generating functional of probability distributions) provides di erent types of therm odynamics, and rise the question of how to select a "proper" one, that is, are some better than others? [7]; Superstatistics as used by C.Beck and E.G.D.Cohen for nonequilibrium systems with complex dynamics in stationary states with large uctuations on long-time scales[8, 9].

So-called nonextensive statistics based on Havrda-Charvat statistics [10] applied to a number of cases are described in the Conference Proceedings of Ref.[11]. Renyi statistics [12, 13] has been introduced in the scientic literature [14], with T. Arim itzu and P. Jizba [15, 16] recently introducing an extensive analysis in a paper intitled "The world according to Renyi; K appa (sometimes called D eformational) statistics { a particular case of Sharma-M ittal statistics [17] { was used in problem s of plasm a physics in celestial mechanics [18] and by G. K anadiakis in the case of relativistic system s[19].

The introduction of these alternative statistics resides on the fact, already stated, that the well established mechanical-statistical treatment via Boltzmann-Gibbs ensemble formalism, let it be around equilibrium (as in the usual response function theory) or for system s arbitrarily away from equilibrium [20], has its application in paired because of the complications set forth by the presence of spatial correlations, resulting for example in the illustration here presented from spatially varying microroughened boundaries showing a fractal structure. Such fractal structure introduces a degree of fuzziness in data and inform ation, which consists in the lack of information on the space correlations in posed by the fractal-like microroughness of the electrode surface. Hence, as noticed, it is not satis ed Fisher's criteria of e ciency and su ciency in the characterization of the system, that is, the chosen description does not sum marize the whole relevant information for the situation in hands. Hence the use of form ulations based on unconventional statistics [22] to perform calculations of average values and response functions in which the accompanying heterotypical probability distributions preferentially weight the probabilities of the states that contribute to the dynam ics involved [23, 24]. We restate that the use of unconventional (index dependent) heterotypical statistical mechanics for system s displaying correlation e ects of one kind or other, is a circum venting way for overcom ing the di culty to assess such characteristics that should be incorporated in the conventional form ulation within the well established Boltzm ann-Gibbs theory.

W e consider here Renyi statistics [12, 13] applied in statistical mechanics [15, 16, 23, 24], illustrating its use and utility in the case of a particular experiment, namely, observation and measurements using cyclic voltammentry in the study of fractal-structure electrodes in microbatteries. First, we begin again noticing that the advanced technologies that keep evolving now adays present challenges for the associated physics which describes the phenom ena that are in them involved thus, requiring a carefuluse of the accompanying theoretical physics to face the di culties associated with the handling of these new situations. They involve aspects of the physics of soft-m atter and disordered system s, com plex structured system s, the already m entioned sm all system s, and others, as well as the question of functioning in far-from equilibrium conditions and in the presence of ultrafast (pico- and fem to-second time scales) relaxation and pumping e ects. We are dealing in all these cases with condensed m atter and then, we recall, it is inevitable for their study at the physico-chem ical level to resort to statistical mechanics { in a sense it can be said that the physics of condensed matter is statistical mechanics by antonom asia. We consider here a particular situation which provides an excellent illustration of what can be called Unconventional Statistical Mechanics at work. We begin noticing that as a consequence of the now adays large interest associated to the technological applications in displays, electrochrom ic windows and microbatteries (see, for example, Ref.[25]), the study of growth, annealing and surface morphology of thin lm depositions has acquired particular relevance. These kind of systems involve the presence of m icroroughened surface boundaries in a geom etrically constrained region, when fractal characteristics can be expected to greatly in uence the physical properties [26]. It can be recalled that fractals display self-sim ilarity, but the latter is said to come in two avors: exact and statistical, the latter being the one with which we are dealing here. M oreover, fractals are characterized in terms of their, in general, fractional "dimension" { as we shall see in the present case { which is a "measure" of the complexity of the structure.

Hence, we do have that the dynam ics or hydrodynam ics involved in the functioning of such devices can be expected to be governed by som e type or other of scaling laws [27, 28, 29]. terization of the fractal properties (scaling laws) of the system . Particularly, through cyclic voltam metry it can be evidenced the property of the so-called "anom alous" (more properly called non-Fickian) di usion in these systems. It is our aim to present here a theory appropriate to deal with these kind of situations. For dealing with transport processes in electrochem ical cells we introduce two di erent aspects of recent therm o-hydrodynam ic theory: one is Inform ational Statistical Therm odynam ics (IST for short [32, 33], which provides statistical foundations to Extended Inveversible Therm odynam ics [34]), and a non-equilibrium ensemble form alism [21]. However, for the kind of experiments to be analyzed one needs, as noticed, to resort to a modi ed form of the standard form alism in the original and well established Boltzm ann-Gibbs foundations of statistical mechanics. O riginally, the relation between irreversible therm odynam ics and transport laws, as Fick and Fourier laws, were well established { and kinetic and mechanical statistical foundations given { in the framework of classical (or O nsagerian) irreversible therm odynam ics. But, it faces limitations since the theory is restricted to weak amplitudes of movement, with a linear relationship between uxes (currents) and therm odynam ic forces, sm ooth variation in space and time, locality in space and instantaneously in time (i.e. neglecting space and time correlations) and weak uctuations, and then does not cover the case of fractal-structured systems. To remove these restrictions appeared a variety of approaches, a most convenient one is the already mentioned Extended Irreversible Thermodynamics and its statistical counterpart Inform ational Statistical Therm odynam ics, and for a practical handling of fractal and nanom etric system s one can resort to unconventional statistics. IST is founded on a non-equilibrium ensemble form alism which provides a generalized nonequilibrium grand-canonical ensemble [21, 35, 36]. On the other hand, unconventional statistics applies to system s displaying longrange interactions, persistent m em ory, evolution in a fractal space, etc [23, 24]. It has been applied to som e kind of studies of "anom alous" di usion, as for exam ple in Refs.[37-39], and we reconsider the question here, speci ed to the situation in fractal-structured electrodes of m icrobatteries leading to "anom alous" results in experim ents involving cyclic voltam m etry.

II. THEORETICALANALYSIS

W ithin the variational approach to Statistical M echanics [21] the use of unconventional (index-dependent) inform ational entropies (better called m easure of uncertainty of inform a-

tion, and not to be confused with the physical entropy which is a property of the therm odynam ic state of physical system s, while the inform ational one is a property of any probability distribution [23, 24, 40]) [22] leads to the construction of alternative Statistical M echanics as described in Refs.[23,24]. Basically the process consists of two steps: (1) The choice of an heterotypical probability distribution [22, 23, 24], say h, and (2) the use of an escort probability [41] of order in terms of this heterotypical distribution, say D f_h^a , namely, in the calculation of average values it is used the de nition

where the escort probability of order is given by

where is a real positive number (see for example R ef.[41], where the name escort probability is used, and the concept generalized, and also in Chapter IX, pp. 569 et seq. of R ef.[13]). An in depth presentation and discussion is given elsewhere [23, 24], here su ces to say that what the heterotypical distribution does is providing a weighting of the probabilities of the states involved, and the escort probability accounts for the in uence of correlations and higher-order variances.

A coording to Beck and Schogl [41], the use of the escort probability introduces an increase in information (by incorporating self-consistently correlations and variances) in the sense that, for the case of index -dependent R envi distribution % (see below)

where I is the quantity of information (the negative of Renyi's informational entropy in terms of %), and the right-hand side is interpreted as the information gain when using the escort probability D built in terms of the original one %.

Let us now proceed to dealw ith the problem on hands, when we make use of an unconventional statistics in R enyi approach in order to provide a statistical-therm odynam ic treatment of the "anom abus" di usion law proposed to account for the experimental results obtained using cyclic voltammetry in the system of fractal-structured electrodes in microbatteries. It involves the process of motion of charges in the electrolyte bordered by a fractal-structured thin lm on the electrode, motion which is usually considered that can be described as a process of di usion governed by Fick law [31]. But the use of standard Fick di usion equation does not properly describe the experimental results, which show some kind of power law (see below) di ering from the expected one. This is a consequence that in a constrained (nanom etric scaled) fractal-like geom etry, Fickian-di usion does not apply because are not satis ed the quite restrictive conditions mentioned in the Introduction. A proper description using the conventional approach in statistical mechanics for providing foundations for hydrodynam ics requires the use of a generalized higher-order therm o-hydrodynam ics [42, 43, 44], that is, the description including as basic macrovariables the density of energy, the density of particles, h(r;t) and n(r;t), their uxes of all orders, $I_n(r;t)$, $I_n(r;t)$, $I_n(r;t)$, w ith $r = 2;3; \dots$ indicating the order of the ux and its tensorial rank; all the quantities are de ned in Refs. [21] and [42]. To resort to this higher order hydrodynam ics (which provides at the microscopic, i.e., statistical mechanical level, generalizations of super-Burnett and super-G ruyer-K rum hansl equations (see R efs.[45] and [38]), even in the linear aproxim ation and neglecting uctuations is a form idable task in the present case with spatially varying boundary conditions (in a nanom etric scale and with a complex structure). Moreover, even though a contraction in the choice of the basic set of macrovariables can be introduced [21, 45], it is di cult to establish the order of the truncation. Therefore, what can be attempted in order to obtain a description of som e properties of the system, is to introduce an unconventional statistics, leading to an unconventional hydrodynamics, in terms of a low -order truncation, in which one keeps only the variables

that is, the energy density, the density of particles and the rst-order ux (current). In that way we are led to obtain an "anom alous" di usion equation depending on a fractional-power which is determ ined by the dynam ics, the fractality, the geom etry and dimensions, and the therm odynam ic state of the system (the unconventional generalized higher-order therm o-hydrodynam ics is presented elsewhere [47, 48]). Let us proceed to derive their equations of evolution using R enyi approach to unconventional statistics [23, 24]. For that purpose, rst we separate the H am iltonian in the form

where $\hat{H_0}$ is the kinetic energy and $\hat{H^0}$ contains all the interactions that are present in the system. Moreover, in a classical approach, the basic dynam ic variables, whose average values

where the integration is over the phase space. M oreover, according to the theory [13, 21, 23, 24] it is used the corresponding escort probability distribution (cf. Eq.(A 11) in Appendix A)

and it can be noticed that the order of the escort probability is the same of the index in Renyi's distribution [13], so we keep only one parameter in the theory (the so-called infoentropic index), with Renyi's heterotypical distribution of probability % (); given in Eq.(A13) after using Eq. (A14), both in Appendix A. The equations of evolution for the basic variables associated to the material motion (the one of interest for us here) derived in the context of a nonlinear kinetic theory [21, 42] are

At this point we recall, and stress, that the "anom alous" di usion equation is an equation appropriate for approximately describing the hydrodynam icm otion, being an artifact (thus the use of the word anom alous between quotation marks) of having applied an unconventional statistics in the truncated description as given in Eq. (4). As already noticed, in the conventional (well established and parameter free) form alism for satisfying the principle of su ciency it must be used a higher-order hydrodynam ics.

We proceed to analyze this question of "anom alous" results in measurements using cyclic voltammetry in fractal-structured electrodes in terms of the previous results. Let us, for the sake of completeness, brie y summarize the case: The dierence of them ical potential between an anode and a cathode with a thin lm (nanometric fractal surface) of, say, nickel oxides, produces a movement of the dierence circulate from the former to the latter. In a cyclic voltammetry experiment, these charges circulate as a result of the application of a potential V (t), with particular characteristics: It keeps increasing linearly in time as $V_0 + vt$, where v is a scanning velocity, during an interval, say t, and next decreases with the same sweep rate, i.e. as $V_0 + v.4$ t vt, until recovering the value V_0 . A current i(t) is produced in the closed circuit, which following the potential V (t) keeps increasing up to a peak value $\frac{1}{p}$, and next decreases. This current is the result of the movement of the

charges that keep arriving to the thin Im fractal-like cathode. It is found that there follows a power law relation between the peak value, i_p , of the current and the rate of change v of the electric eld, namely i_p v. The value of the current to circulate in the cathode, i(t), is proportional to the charge at the interface, that is, the value at it of n (x;t), to be given by the solution of Eq.(26) which in one dimension, say, the x-direction norm alto the electrode surface, is given by [50, 51]

where a (which ensures the norm alization) and b are constants of no specic interest in what follows and then we om it to write them down, and

Hence the charge at each given point x at the interface is given by Eq.(26), and the current to be produced in the electrode -m otion of this charge arriving at it under the action of the eld to be applied -is proportional to it, and then we have the law

In the conditions of the work of Pa kossy and N yicos [26], the fractal power is related to the fractal dimension d_f of the electrode rough surface by the relation ' (d_f 1)=2, and

then in experiments when it holds, from the log-log plot of i_p vs v there follows the value of and, consequently, the fractal dimension can be estimated. U sing Eq.(31) we arrive to the relation between fractal dimension and the parameter , namely = $(8 \quad 3)=(4 \quad 1)$, and then

We can see that for $d_f = 2$ (a perfectly at surface) we have = 1 as it should, while for the other possible extrem e lim it of $d_f = 3$, it follows = 5=3. As already noticed, the theory precisely restricts the values of to this interval; outside it the calculations present singularities. Then as a consequence the exponent is also limited, and we can only expect for it values in the interval 0.5 < 1. Hence, we stress that these are the permited limiting values of the indexes and : the value which adjusts the experimental data is to be contained between these limits, being dependent on the system's dynamics, geometry and size, m acroscopic therm odynamic state, and the experimental protocol (in the present case depends on the scanning velocity v, as shall be shown in the next section). We can see that the three quantities, ; and d_f are related and give a kind of measure of the microroughness of the electrode surface. A perfect one (a totally sm ooth surface) corresponds to = 1; = 0.5 and $d_f = 2$, and as the surface becomes m ore and m ore in perfect, these quantities increase, above those values, but with upper boundaries, being 1.666 for , 1 for and 3 for d_f .

On the other hand, atom ic force m icroscopy allows to obtain the fractal dimension and a kind of degree of m icroroughness of the surface. A coording to the method [29], it is calculated the so-called interface width, namely

where L is the number of partitions in which the surface is divided and h_i h is the deviation, within each partition, of the height with respect to the average value. There exists a power law between W and L, namely W L^r , where r is called the roughness exponent, which is related to the fractal dimension as d_f ' 3 r. Therefore, comparing with the theory developed for the case of cyclic voltammetry, we obtain relationships relating the different quantities, nam ely

Recalling that, according to the theory, 1 < 5=3, we have that r can only attain the values 0 < r 1, comprising the conditions between highest roughness to a perfectly smooth surface, and thus can be used as a kind of "order parameter", or, better to say, "degree of fractality parameter".

III. THEORY AND EXPERIMENT

We apply the preceding theory to the study of a class of experiments [52]. In that work, the fractal dimension of nickel oxide thin \mbox{Im} swas analyzed by means of cyclic voltammetry and compared with the results obtained by atom ic force microscopy (AFM).

Figure 1 shows the dependence of the peak current with the sweep-rate velocity v. We can notice that the peak value of the current increases continuosly with v, and also that it can be identied two regions where the dependence is very approximately linear (one in the range 1 v 10 mVs¹ with a more pronounced slope that the other in the range 20 v up to 100 mVs¹). Once we do have a log-log plot, consequently it can be identied two values of the exponent , in accordance with Eq.(30). Moreover, from equation Eq.(31) we obtain that

and two values of the infoentropic index can also be determ ined. The calculated values are presented in Table I. The associated statistical fractal dimension values $(d_f, Eq.(32))$ are also presented in this table. The larger d_f values are obtained in the slow-sweep ranges, in comparison with those obtained at faster scans. The fact that can be identified from this is that the fractal dimension depends on the observational scale, which is limited by the experimental protocol, here the scanning velocity range: At low values of v, the ions are constrained in a spatial region close to the electrode (known as the di usion layer), and are able to sense the ne details of the microroughness at the interface. On the other hand, increasing the scan rate also increases the length of the di usion layer, and the global morphology of the electrode surface becom es predom inant. This behavior is particularly expected in the case of sensing by som e experim entalm ethod the surface m orphology of the thin lm: this surface presents grains, and two distinct statistical processes are responsible either for the form ation of the local surface m orphology of individual grains or the global thin

In surface m orphology, form ed by the assemblage of all grains. The experimental values determined in this work for the infoentropic index are within the expected theoretical range (1 < 5=3), and the d_f values obtained by cyclic voltammetry (Table 1) indicate that a stronger asperity can be associated to the local grain m orphology, in constrast to a smoother thin lm globalm orphology.




FIG.1: Log-bg plot of peak current i_p versus sweep rate v .




FIG.2: AFM m icrograph, 1000 nm 1000 nm 23 nm.

Figure 2 presents a typical AFM m icrography. The presence of structured grains, with m ean size 180 nm, can be clearly seen. Figure 3 presents a log-log plot of the interface width W (L) as a function of the partitions L. Two scaling regions (at short and m edium L ranges) are evidenced, separated by a transition L value of 140 nm, close to the m ean grain size. The roughness exponent r values calculated in accordance with Eq.(34), and the associated AFM in ages statistical fractal dim ension values are listed in Table I. The calculated statistical fractal dim ensions from both techniques are in good agreem ent. R etuming to Fig.1, it is worth noticing that the full curve of dependence of i_p with v, once we take into account Eqs.(30) and (31), can be approximated by the law

It can be noticed that this law in fact reproduces to a good degree of approximation (error smaller than 10%) the two straight lines in the given intervals described, and interpreted, above. We can also see that it is veried, as it should, a saturating behavior, namely, the infoentropic index tends to the value 1 for large v, the minimum value it can take. Hence, according to Eq.(2) it follow that d_f tends to 2, what can be interpreted, as already noticed, that as v increases the charges keep "feeling" less and less the microroughness at the interface. Hence, for v very large there follows that d_f ' 2 (an averaged sm ooth surface), while the limit of v going to zero would evidence the more detailed e ect of the fractal topography, given in this case the values d_f ' 2.8 (then near 3 and then indicating a strong roughness) and ' 1:62 0.08, in accordance with the fact that must remain in the interval as given by Eq.(25), and of course 2 d_f < 3.

IV. CONCLUDING REMARKS

We have considered in detail a quite interesting case consisting of a situation present in certain classes of system s where it becomes di cult for the researcher to apply the standard form alism in the conventional, well established, logically and physically sound Boltzm ann-G ibbs statistics, because of the presence of inhom ogeneous uctuations which are "anom a-bus" in some sense and eventually, as in the case here, involving one type or other of fractality. In that cases { as already noticed { it may be convenient to depart from conventional statistics, introducing alternative ones. In other words, the appropriate use of the Boltzm ann-G ibbs form alism may in some problem s be quite complicated to apply or, and more fundamental, we may be faced with an inaccessible characterization constraints (inform ation): thus, simplicity or the force of circum stances, respectively, would require setting on the use of other measures of inform ational entropies leading to heterotypical probability distributions [22] accompanied, as noticed, by the use of their associated escort probability [13, 23, 24, 41], and here we found convenient to use a physical statistical mechanics based on Renyi⁶s statistics [15, 16, 23, 24].

The matter has been illustrated in this paper by considering its application in a theoretical study of transport in electrodes in m icrobatteries, particularly cyclic voltam m etry, which provides inform ation on the fractal-like m icroroughened texture of them, providing an excellent illustration for the use and validation of such statistical theory. In ideal conditions (quite sm ooth surface) the peak current in the voltam m etry experim ent is proportional to the square root of the sweep-rate velocity, with which the applied eld is changing. The standard theory relates this result to the di usion of the charges that are going to reach the thin Im electrode. But experimental data show that it is veried a power law, with a power di erent than 0.5, and this is referred to as resulting from a process of "anom alous" di usion, as noted in the previous sections. As we have noticed, a description in terms of a process of di usion does not apply, once the hydrodynam ic motion that proceeds at the interphase electrolyte-electrode where is present a morphology with variations (asperity) ranging in the nano- to sub-nanom etric scale. Hence, a proper description of the hydrodynam ic motion requires to go well beyond the long-wavelength lim it of classical (Onsagerian) therm o-hydrodynam ics, being required to introduce an extended higher-order (som etim es referred-to as m esoscopic) therm o-hydrodynam ics, together with the introduction of com -

plicated boundary conditions.

As shown in the Appendix, using Renyi's statistics but ignoring the nano- to subnanom etric-sized roughness of the thin Im electrode, it is derived an "anom alous" (non-Fickian) di usion equation, which allows to describe the experimental results in cyclic voltammetry. The relevant point is that the index , that the Renyi statistics contains, determines the power law in the voltammetry experiment which allows to estimate the roughness of the electrode surface and, then, its quality and in uence on the functioning of the device.

In section III has been presented a theoretical analysis of results in a given experiment (cyclic voltammetry and atom ic forcem icroscopy): in tables and gures are shown the results of the study of the index of R envistatistics, together with other power indexes (determined by the former) and the statistical fractal dimension, all depending on the experimental protocol.

C losing this section we notice that the use of an alternative statistics even though does not provide a complete physical picture of the problem in hands { once we do have an utter di culty to handle the appropriate extended non-classical therm ohydrodynam ics to be applied { the sophistication of the form alism allow us to obtain a good insight into the physical aspects of the situation. On the one hand, as noticed, the use of the escort probability takes care of introducing correlations (uctuations and higher-order variances), and on the other hand the heterotypical probability distribution (the one of Renyihere) m odi es the weight of the Fourier am plitudes in (Q) jof the density in relation to their classical values in the linear Onsagerian regime [47, 48]. As previously noticed and discussed, classical therm o-hydrodynam ics together with Fick's di usion equation is a satisfactory approach while jn (Q) jhas leading contributions for small Q (large wavelengths) and negligible for interm ediate to large wavenum bers (interm ediate to short wavelengths). When not only small wavenum bers but ever increasing ones becom e relevant for the description of the motion, i.e. associated to non-negligible amplitudes jn (Q) j contributing in the Fourier analysis of the density, we need to introduce a higher-order therm o-hydrodynam ics (with now equations of evolution of the Maxwell-Cattano-type, Burnett and super-Burnett-type, and so on) [43, 44]. In the case we have analyzed, R envi heterotypical distribution, which leads to obtain the "anom alous" di usion equation of Eq.(24), and where > 1, in the restricted hydrodynam ic description used, decreases what would be the values of in (Q) in the standard treatment for short wavenum bers, that is, in the domain of classical hydrodynamics, while increases those amplitudes outside that region, i.e. in the regime of the higher order therm o-hydrodynamics.

Let us consider is the conventional case of di usion, when the principle of su ciency is satis ed, meaning that the several stringent restrictions its validity requires are met, namely, bcal equilibrium, linear Onsager relations and symmetry laws, condition of movement with long wavelengths and very low frequencies, and weak uctuations, are veried. - Figure 3 -Log-log plot of interface width W (L) versus partitions L.




FIG.3: Log-log plot of interface width W $\,$ (L) versus partitions L.
