## Dynamics of quasisolitons in degenerate ferm ionic gases

We investigate the dynam ics of the system of multiple bright and dark quasisolitons generated in a one-component ultracold Fermigas via the phase imprinting technique in terms of atom ic orbitals approach. In particular, we analyze the collision between two bright quasisolitons and nd that quasisolitons are subject to the superposition principle.

Solitons are already well established phenomena in the area of dilute atom ic quantum gases. They have been observed in several experiments with trapped bosonic atoms as well as described in many theoretical papers. The latter usually involves the mean-eld approach and the resulting Gross-Pitaevskii equation for the condensate wave function. The intrinsic nonlinearity of this equation is originating from the interparticle interactions. As the elective interaction between atoms can be both repulsive or attractive, two types of solitonic excitations [1] are possible in Bose-Einstein condensates.

Dark solitons were realized experimentally rst [2, 3, 4] whereas there have been problems with generating bright solitons in plied by the occurrence of the collapse in the attractive condensates. Finally, two ways turned out to be successful. In experiments of Refs. [5, 6] a large condensate with positive scattering length is prepared and next the interatom ic interactions are changed to attractive ones (with small negative value of the scattering length) by using Feshbach resonances. In this case the single bright soliton or a train of solitons were observed. Another way of creating bright solitons was dem onstrated in the experiment of Ref. [7] where the condensate still remains repulsive but appropriate engineering of atoms in a periodic potential allows for a change of the sign of the e ective mass and results in the generation of bright gap solitons. Recently, another concept of bright matter waves in a repulsive condensate has been developed that involves degenerate Fermigas as a "stabilizing medium" [8].

In a series of papers [9, 10] we have shown that sim ilar structures can also be created in a one-component ultracold ferm ionic gases even though to a very good approximation spin-polarized fermions at zero temperature do not interact. These structures exist both in the systems with uniform and nonuniform densities under a quasi-one-dim ensional con nem ent. They can be generated by using the technique of phase imprinting and its appearance is related to the Ferm i statistics. There exists the regime of parameters, de ned by the condition that the width of the imprinted phase is bigger than the Ferm i length, where only states with momentum close to the Fermin on entum are excited. Hence, the life time of generated structures can be long enough (in comparison with the Ferm i time) allowing for observation and making them similar to solitons.

The method of phase imprinting has been already employed in the experiments where dark solitons have been generated [2, 3]. The strong and short enough oresonance laser pulse is passing as through the appropriately tailored absorption plate and next through the sample of atoms. Under such conditions the motion of atoms is frozen and the only result of the interaction of light with the atoms is imprinting the phase on the atom ic wave functions. After the light is gone, the density and the phase change and desired structures (like solitons or vortices) appear in the system, according to the pattern written in the absorption plate.

In this paper we further investigate the motion of ferm ionic quasisolitons by analytical calculations based on the propagator technique. These calculations allow us for a detailed description of the collision between ferm ionic quasisolitons. We come about the conclusion that quasisolitons full the superposition principle, i.e. the sum of two quasisolitons is a two-quasisoliton solution.

So, we consider a system of N ferm ionic atoms con ned in a one-dimensional box with periodic boundary conditions at zero temperature. We assume that the many-body wave function of such a system is well described by the Slater determinant

The gas is spin-polarized and therefore the s-wave scattering, dom inant at low tem peratures, is absent and e ectively the gas becomes the system of noninteracting particles. Them any-body Schrodinger equation is then equivalent to the set of one-particle equations, each of them describing the evolution of a particular single-particle orbital'  $_1$  (x); :::;  $^\prime$   $_N$  (x) under the same H am iltonian. Thus these orbitals remain orthogonal during the evolution and the one-particle density matrix is at any time given by the following formula

and its diagonal part is the particle density




FIG. 1: Phase pattern leading to the generation of a single bright-dark quasisolitons pair.

At zero tem perature particles occupy the lowest possible levels. The corresponding eigenstates are just the plane waves '  $_n$  (x) = exp (ip $_n$  x=~)=  $\overline{L}$  with momenta  $p_n$  quantized according to  $p_n$  = 2 ~ n=L, where n = 0; 1; 2;::. The evolution of the single-particle wave function can be calculated based on the propagator technique

where  $K(x;x^0;t)$  is the propagator function for a onedimensional box with periodic boundary conditions

It is convenient now to increase simultaneously the number of particles and the length of the box in such a way that their ratio (i.e. the Ferm im omentum) remains constant. Increasing both quantities to in nity denes the, so called, therm odynam ic limit. In this limit the propagator takes the same form as for a free particle and is given by

To simplify further calculations we assume the follow-ing form of the imprinted phase (see Fig. 1)

where the parameters a and w de ne the width and the jump of the imprinted phase, respectively. The Ferm i m om entum in one-dimensional space, de ned as hN = (2L), determines the characteristic length  $_F$  via the relation  $_F = h = p_F = 2L = N$ . From now on we choose the Ferm i length as a unit of length. This quantity does not change while realizing the therm odynamic limit procedure. Simultaneously, the expression  $h = ^{\mathbf{u}}_F$  gives a unit of time. Hence, according to the formula (6) the single particle wave function evolves as

where the wave number  $k_n = p_n = w$  as introduced.




FIG. 2: Evolution of a single bright-dark quasisolitons pair. Successive fram es show the ferm ionic density (normalized to N=2) of 501 atoms after writing a single phase step of height and the width a =  $4_{\rm F}$ . The corresponding times are 3, 5, 7, and 8 in units of h= $^{\rm H}_{\rm F}$ .

Calculating the integral (8) one obtains an explicit formula for the explicition of the single particle wave function (in units of  $1=\frac{1}{F}$ )

where C (z) and S (z) are the Fresnel integrals [11] and their arguments are the following functions of position and time

The ferm ionic density (the diagonal part of one-particle density matrix) is just the sum of single-particle densities obtained from single-particle orbitals given by (9). Fig. 2 shows such a density for a system of 501 atoms at various times after writing a phase step of height and the width 4  $_{\rm F}$ . As already reported in Ref. [9, 10] the bright and the dark quasisolitons are generated. They propagate with dierent velocities and in opposite direction. The speed of bright quasisoliton is slightly higher than the speed of sound (equal to  $p_{\rm F}$  =m) whereas opposite is true for the dark quasisoliton. We can mall the details of dynamics of such a system described earlier in Ref. [9, 10], especially its dependence on the ratio a=  $_{\rm F}$  of the width of the imprinted phase step and the Fermi length.




FIG. 3: Phase pattern used for generating two bright-dark quasisolitons pairs. In this case bright quasisolitons move towards each other and collide.

The purpose of the present paper is, however, to investigate the collision between bright ferm ionic quasisolitons. To this end, we in print the phase pattern as in Fig. 3 on the ferm ionic gas. It results in a creation of two pairs of bright-dark quasisolitons with bright quasisolitons moving towards each other. It turns out that the time evolution of individual orbitals can be expressed in terms of the evolution corresponding to the phase pattern already considered in Fig. 1 and given by the formula (9). First, let us notice that the phase shown in Fig. 3 can be split in the following way  $^{1r} = ^{1} + ^{r}$  w, where  $^{1}$  and  $^{r}$  are the left and the right cuts of the phase shown in Fig. 3, respectively. Next, using the formula (8) one gets

and superscripts '1' and 'r' indicate that the wave functions are propagated after the imprinting the single step

patterns  $^1$  and  $^{\rm r}$ , respectively. The superscript 'lr' m eans the evolution according to the phase pattern plotted in Fig. 3.




FIG. 4: The relative (with respect to 1=L) oscillations of the expression B + 2=L as a function of position for a particular (n = 200) single-particle orbital. The length of the box L = 250  $_{\rm F}$  and the time is 12 in units of h=" $_{\rm F}$ . 0 ther parameters: c = 15; d<sub>1</sub> = 4; d<sub>2</sub> = 5; in units of  $_{\rm F}$ , and w = (the case of the last frame of Fig. 5).

Both orbitals  $'\frac{1}{n}$  (x;t) and  $'\frac{r}{n}$  (x;t) can be calculated based on the following rules that connect the time evolution due to the phase pattern given in Fig. 1 with the evolution resulting from patterns obtained by the shiff  $('\frac{s}{n})$  (x;t), the rejection  $('\frac{ref}{n})$  (x;t), and a combination of the rejection and the shift  $('\frac{ref}{n})$  (x;t)) of that one shown in Fig. 1

The relation (11) can be rewritten now in term softhe single-particle densities




FIG. 5: Two bright quasisolitons collision. Successive fram es show the ferm ionic density (norm alized to N =2) of 501 atoms after writing two phase step pattern (as in Fig. 3) of height and the widths equal to 4  $_{\rm F}$  (the left one) and 5  $_{\rm F}$  (the right one). The corresponding times are 5, 7, 8:3, 9, 10, and 12 in units of h=" $_{\rm F}$ . O ther parameters: c = 15 in units of  $_{\rm F}$ .

In fact, what is left, i.e. the expression B + 2=L, oscillates as a function of position around zero with a relative (in comparison with 1=L) amplitude usually of the order of  $10^{-4}\,$  right after the quasisolitons are created. This amplitude increases in time but remains at the low level  $(10^{-2})$  even after the collision of quasisolitons. An example of that is given in Fig. 4 where we consider the box of length L = 250  $_{\rm F}\,$  (it corresponds to the last frame of Fig. 5). Only when the imprinted phase step gets very sharp the relative amplitude becomes as large as  $10^{-1}$ . The total density is the sum of single-particle densities and equals

Here, the density is normalized to the number of particles divided by 2. Therefore, in the thermodynamic limit, i.e. when the size of the box and the number of atoms increase to in nity while keeping their ratio constant, one gets the following rule

First, this formula generalizes the results already obtained in Ref. [10] (and expressed by solution (24)) to

any perturbation of the initial density. Secondly, it happens that going from (16) to (17) the "noise" present for each orbital (see Fig. 4), even if it is large, adds destructively causing that the relation (18) is satis ed almost perfectly. It has to be noticed that the same property of additivity (18) is shared by the solutions of the wave equation. Here, however, single-particle densities satisfy the nonlinear hydrodynam ic equations according to the M adelung representation of the Schrodinger equation [12]

where  $_n$  and  $v_n$  are the density and the velocity  $\,$  elds, respectively, associated with the orbital '  $_n^{\rm lr}$  (x;t).

In Fig. 5 we illustrate the collision of two bright ferm ionic quasisolitons. Successive fram es show the total density calculated based on the formulas (11), (14), and (9). No interference, as a consequence of (18), is observed when both peaks meet at the center of the box what distinguishes this case from the case of collision of usualwave packets. It is not surprising, since building the quasisoliton we add probabilities (see (3)) rather than the amplitudes. A fter the collision both quasisolitons reappear, however no phase shift, usually expected when two solitons collide, is observed. This is another consequence of formula (18). So, what we have is a solution (in a sense of (3)) of a set of nonlinear hydrodynam ic equations (19) that is a sum of quasisolitons not only well before and after the collision but all the time.

In conclusion, we have investigated the dynam ics of ferm ionic quasisolitons generated in ultracold ferm ionic gas by using the technique of phase imprinting. We obtained an analytic formula that describes the propagation of a bright-dark quasisoliton pair. Based on this formula we were able to study the collision of two bright ferm ionic quasisolitons and found that the quasisolitons are subject to the superposition principle { the sum of two quasisolitons is a two-quasisoliton solution.
