Unconventional Superconductivity in Heavy Ferm ion System s

We review the studies on the emergent phases of superconductivity and magnetism in the felectron derived heavy-ferm ion (HF) systems by means of the nuclear-quadrupole-resonance (NQR) under pressure. These studies have unraveled a rich variety of the phenomena in the ground state of HF systems. In this article, we highlight the novel phase diagram s of magnetism and unconventional superconductivity (SC) in CeCu₂Si₂, HF antiferrom agnets CeRhIn₅, and CeIn₃. A new light is shed on the di erence and common features on the interplay between magnetism and SC on the magnetic criticality.

I. IN TRODUCTION

Many of lanthanide (Ce, Yb, etc) and actinide (U, Pu, etc) compounds behave as if they consist of an assem bly of local m om ents at tem peratures m uch higher than the characteristic energy of hybridization or intersite exchange interaction. This quasi-independent behavior continues som etim es down to low tem peratures. In the case where the hybridization energy is larger than the crystal electric eld (CEF) level splittings, the splittings are sm eared out. Then the large degeneracy n associated with the J multiplet plays an important role in determ ining the characteristic energy scale which is typically 100 K. For example we have n = 6 for Ce^{3+} and n = 8 for Yb^{3+} . In many lanthanide compounds, the valence uctuating state has been probed by means of X -ray photoem ission spectroscopy, m easurem ents of lattice constant and M ossbauer isom er shift. In the valence uctuation regime, the strong hybridization e ect leads to both charge and spin uctuations. As a consequence the number n_f of f electrons is less than one.

On the contrary, if the hybridization between the fand conduction electrons is relatively weak, the charge uctuation is suppressed since the Coulomb repulsion between f electrons is strong. In the latter case the hybridization generates the exchange interaction $J_{\rm cf}$ between f-and conduction electron spins. This case is referred to as the K ondo regime [1, 2, 3]. The characteristic energy scale, $T_{\rm K}$, in the K ondo regime is typically 10 K. In m ost cases, the CEF splitting becomes larger than $T_{\rm K}$.

At high temperatures, an assembly of local moments behaves as independent K ondo scattering centers. For example, the Curie-W eiss behavior of the susceptibility appears and the log T -anomalies of the resistivity take places. Therefore, various aspects of the K ondo e ect including the dynamical characteristics can be investigated by means of nuclear-magnetic resonance (NMR) and neutron scattering experiments of su cient accuracy. The di erence in the characteristic energy scales between the valence uctuation and the K ondo regimes manifests itself in the T dependence of the magnetic relaxation rate. If the dynamical susceptibility is isotropic and can be approximated by a Lorentzian with the magnetic relaxation rate $% T_{1}$, nuclear spin lattice relaxation rate $1{=}T_{1}$ is expressed as

where A_{hf} is the average hyper ne eld. For quasielastic neutron scattering, the magnetic cross section is derived as

Thus appears as the halfwidth in the quasielastic neutron scattering spectrum. In the limit of small !, the imaginary part of (!) obeys the Korringa-Shiba relation [4]. A coordingly, with the $T_1T = \text{constant}$ law at low temperatures we can estimate by the relation

The NMR relaxation rate and the half-width of the quasi-elastic magnetic neutron scattering spectrum can be understood in a consistent way. The width of the quasi-elastic spectrum is a measure of the strength of the hybridization or the exchange interaction between the f- and the conduction electrons. In rare earth compounds with a magnetically stable 4f con guration, one expects a Korringa behavior for the quasi-elastic linewidth, namely = $k_B T$ where is typically 10³, while the valence uctuation compounds show an alm ost T independent , reaching typically to 20 30 meV.

In contrast to these, the relaxation rate in the K ondo regim e exhibits a characteristic T dependence and probes the presence of a very low energy scale of 10 30 K. Then the presence of such a low energy scale is related to the huge linear term of the speci c heat which amounts to about 1 J/m oleK². N am ely the system can be described by renorm alized heavy quasi-particles at low tem peratures. For antiferrom agnets with heavy quasi-particles, quasi-elastic Lorentzian intensities still survive even below a magnetic transition temperature T_M and then, show a distinct deviation from a T-linear dependence. In most cases, (T) seen s to follow roughly a square-root dependence of $= A^{P} T$ [5].

W e would say that the spin dynam ics probed by NM R and neutron scattering techniques can be sem iquantitatively interpreted within such in purity models as the degenerate Anderson [6] and the C ogblin-Schrie er [7] models as long as high tem perature behaviors are concerned. In this article, we shall see how the strong interaction e ects am ong electrons in K ondo lattice com pounds lead to richer and more fascinating behaviors in heavy-ferm ion (HF) state at low tem peratures via the microscopic probe by NM R and nuclear-quadrupole resonance (NQR).

II. EXPERIMENTALDETAILS

For understanding speci c properties of HF system s, it is in portant to investigate and describe low energy excitations. In this context, both NMR/NQR and neutron scattering experim ents play central roles in obtaining inform ation about the dynam ical response of HF system s. W hereas the NMR/NQR probes the local environment of one particular nucleus and, therefore, a wave-vector average of the dynam ical response function with a sm all energy transfer com parable to the nuclear Zeem an energy (10⁵ 10^3 m eV), neutron scattering experiments can scan wider energies and wave vectors corresponding to the whole Brillouin zone. In real situations the energy transfer is usually lim ited below about 100 m eV with use of therm al neutrons. Thus, both experiments are com plem entary. The advantage of NMR/NQR is that it can extract the lowest energy excitation and detect a magnetic instability with a tiny moment if it appears. Furtherm ore in the superconducting state, NMR/NQR can provide a detailed structure of response function reliably. For more detailed descriptions on NMR/NQR, we refer to the textbooks [8].

III. FORMATION OF HEAVY FERM ION METALS WITH MAGNETIC CORRELATIONS

M agnetic and therm alproperties of heavy ferm ions are basically determ ined by strong local correlation. A signature of the local nature is that the susceptibility and specic heat are roughly proportional to concentration of Ce in systems such as Ce_xLa_{1 x} Cu₆ or Ce_xLa_{1 x} B₆.[9] The RKKY interaction is operative in bringing about magnetic ordering. The energy scale of it is given by J^2 _c where J is the exchange interaction be-J_{RKKY} tween f and conduction electrons and _c is the density of conduction band states per site. The RKKY interaction competes with the K ondo e ect which points to the non-magnetic singlet ground state. There exists a rather detailed balance between these two tendencies. It is expected that T_M , if it exists, is low ered due to the K ondo e ect. In the opposite case of T_{κ} J^2_{c} , no magnetic order should occur.

Even in the singlet ground state, intersite interaction should in uence residual interactions among renorm alized heavy quasi-particles. It is this residual interaction that leads to a rich variety in the ground states such as HF superconductivity, HF band m agnetism, etc. Shortrangem agnetic correlation m ight survive even if the dom inating K ondo e ect prevents development of long-range order. There, electrical resistivity reveals growing im portance of coherence upon increasing concentration of rare-earth ions at low tem peratures.

Direct evidence for heavy quasi-particles com es from the de Haas-van Alphen (dHvA) e ect that is the oscillation of the magnetic susceptibility coming from Landau quantization of the electron orbits [10]. Geometry of the Ferm i surface can be obtained from the period of oscillation in the di erential magnetic susceptibility as a function of 1=H with H the magnetic eld. The effective mass can be deduced from T dependence of the oscillation amplitude. To observe these oscillations, the m ean free path 1 of a heavy quasiparticle must be larger than the cyclotron radius: $1 v_F = !_H$ where v_F is the Ferm i velocity, and $!_{H} = eH = m c$ is the elective cyclotron frequency of a heavy quasi-particle with e ective mass m . Furtherm ore therm alsm earing at the Ferm i surface must be su ciently small: T ! H . W ith large e ective m asses and short m ean free paths, these conditions require that experim ent should be perform ed at low tem perature and in high eld. Measurem ents of dHvA oscillations have been m ade on UPt₃ [11, 12], CeRu₂Si₂ [12, 13] and CeCu₆ [14]. In all these cases, heavy e ective m asses have been observed.

For UPt₃, the Ferm i surface obtained by the dHvA effect is in good agreem entwith that obtained from energyband theory [15]. The e ective mass on some sheets of the Ferm i surface, however, is about 10 to 30 times larger than that deduced from band-structure calculations. This fact shows that there are signi cant many body e ects that are not described by the standard band theory.

Here, we shall review param agnetic HF states that have metallic phase. In the following we focus on the growth of intersite coherence, or the itinerant character of f electrons, mainly in dynamic magnetic properties. As speci c examples to see the subtle role of the intersite correlation in the HF state, we take typical systems C eC u_6 and C eR u_2 Si₂ where the Ferm i-liquid remains stable at low temperatures even with signi cant magnetic correlations.





FIG .1: Tem perature dependences of $(1{=}T_1)$ of $^{63}C\,u$ in $C\,eC\,u_6$ () and ^{29}Si in $C\,eR\,u_2\,Si_2$ ().[16] Solid line denotes a $T_1\,T$ = constant law .

Figure 1 shows the T dependence of $1=T_1$ for CeCu₆ and CeRu₂Si₂.[16] In the latter case $1=T_{1?}$ of ²⁹Si is measured under the condition that the c-axis is aligned along the magnetic eld. For CeCu₆, $1=T_1$ of ⁶³Cu was measured in zero eld by Cu NQR. As seen in the gure, $1=T_1$ is almost independent of tem perature above 6 K for CeCu₆ and 12 K for CeRu₂Si₂. Then $1=T_1$ begins to decrease gradually above 50 K for CeRu₂Si₂. This relaxation behavior shares a comm on feature with other HF system s at high tem peratures. Spin correlations between di erent sites can be ignored at high tem peratures, and $1=T_1$ is described by the local spin susceptibility (T)

and the magnetic relaxation rate $\ .$

The tem perature below which $1=T_1$ begins to decrease is close to the K ondo tem perature T_K which is extracted from analysis of the resistivity and the magnetic speci c heat. W ith further decrease of tem perature, $1=T_1$ follows a behavior $T_1T = \text{constant}$, which is called the K orringa law. To see this clearly, Fig 2 shows $(T_1T)^{-1}$ vs T. It

turns out that the K orringa law is valid below $T_{\rm F\,L}=0.2,$ 3 and 8 K for ${\rm CeC\,u_6},$ ${\rm CeC\,u_2Si_2}$ and ${\rm CeR\,u_2Si_2}$, respectively. The characteristic tem perature $T_{\rm F\,L}$ in each case is de ned as the e ective Ferm i liquid tem perature. The Ferm i liquid ground state leads to the K orringa law at tem peratures lower than $T_{\rm F\,L}$. This is independent of whether the system is hom ogeneous or a local Ferm i liquid. In the tem perature range where the local Ferm i liquid description is valid, the K orringa relation should hold.

In contrast to the expectation based on the single-ion

model of spin uctuations, the ratio of $T_{FL} = T_K$ quite depends on systems; $T_{FL} = T_K = 0.2/6 = 0.03$, 3/10 = 0.3 and 8/12 = 0.67 for $C \in Cu_6$, $C \in Cu_2 Si_2$ and $C \in Ru_2 Si_2$, respectively. Furtherm ore T_{FL} decreases to 0.08 K in $C = 0.75 La_{0.25} Cu_6$.[9] These results show that the energy scale T_K is not su cient to describe the HF systems. It should also be specified by the elective Ferm i tem perature, T_{FL} below which HF bands are form ed. In contrast to the universal behavior of the K ondo impurity, the dispersion relations of heavy quasi-particles depend on materials.

IV. UNCONVENTIONAL SUPERCONDUCTIVITY IN HEAVY-FERMION SYSTEMS

A. O verview

Superconductivity, which was one of the best understood many-body problems in physics, became again a challenging problem when a new kind of superconductivity was discovered in $C \in Cu_2 Si_2$ by Steglich et al.[17] The system is one of HF materials close to magnetic instability. In the subsequent decade, intensive investigations of a class of uranium compounds established a new eld of HF superconductivity by successive discoveries of superconductivity in UBe₁₃, UPt₃, URu₂Si₂, UPd₂A b and UN i/A h. [18, 19] The most important characteristics for a series of uranium HF superconductors are that superconductivity coexists with the antiferrom agnetism except for UBe_{13} , and that the speci c heat coe cient lies in a broad range from 700 m J/m ole K 2 (UBe₁₃) to 60 m J/m ole K² (UR u_2 Si₂). The f-shell electrons, which are strongly correlated by C oulom b repulsive interaction, determ ine the properties of heavy quasi-particles at the Ferm i level. This gives rise to a large value as well as an enhanced spin susceptibility. Hence, the Ferm ienergy is also quite sm all: $T_{FL} = 10$ 100K and, as a result, the transition temperature is also small, ranging from $T_c = 0.5K$ to 2K. The magnetic ordering temperature $T_{N} = 5$ 20K is by one order of m agnitude higher than T_c . A jump (C_s C_n)= C_n of the speci c heat normalized by the value C_n just above T_c is of 0 (1) in all com pounds. This result dem onstrates that the superconductivity is produced mainly by the heavy quasi-particles. Due to the strong C oulom b repulsion among f electrons, it seems hard for the heavy quasi-particles to form ordinary s-wave Cooper pairs with large am plitude at zero separation of the pair. In order to avoid Coulomb repulsion, the system would favor an anisotropic pairing channel like spin triplet p-wave or spin singlet d-wave.

As listed in Table 1, the HF superconductors discovered to date may be classi ed into two groups depending on their di erent magnetic behaviors and extent of quasi-particle renormalization. The rst group comprises $CeCu_2Si_2$, $CeIrIn_5$, $CeCoIn_5$, UBe_{13} , and UPt_3 , which

exhibit no magnetic order or quasi-static order. The quasi-particle masses as derived from the speci c-heat

coe cient = C (T)=T are as large as 400 m J/m ole K^2 . The highest T_c is 2.3 K in CeCoIn₅ [20, 21].

In this context, all unconventional superconductors discovered to date possess the line-node gap on the Ferm isurface regardless of either spin-singlet d wave or spin-triplet p-wave.

The second group includes URu₂Si₂, UNi₂Al₃ and UPd₂Al₃, which show antiferror agnetic order. The effective masses are not so large with 100 m J/m ole K². M ost rem arkably, UNi₂Al₃ and UPd₂Al₃ possess sizable magneticm on ents of 0.24 and 0.85 $_{\rm B}$ / (U atom), respectively. In both groups, heavy quasi-particles are responsible for the superconductivity. This follows from the large jump of the speci c heat C at T $_{\rm c}$ with C = T $_{\rm c}$ 1, which is close to the value 1.43 for conventional superconductors, and from the large slope of the upper critical eld (dH $_{\rm c2}$ =dT)_{T = T c}.

Nuclear spin-lattice relaxation rate $1=T_1$ is expressed as,

Here (T) expresses an enhancement factor due to electron correlation e ect. The T dependence of (T) is neglected for the present. $A_{\rm hf}$ is the hyper ne-coupling constant. E and f(E) are the energy of the quasi-particles and the Ferm i function, respectively. The den-

sity of states of the quasi-particles N $_{\rm s}$ (E) and the anom alous density of states M $_{\rm s}$ (E) associated with the coherence e ect are expressed as follow s:

For the s-wave with isotropic gap $_0$, the respective eqs. (4) and (5) are simplied to

The density of states, N_{BCS} (E) diverges at E = . Near T_c , where $f^0()$ j is still large, the divergence of N_{BCS} (E) gives rise to a divergence of $1=T_1$. However, the life-time e ect of quasi-particles by the electron-phonon and/or the electron-electron interactions, and the anisotropy of the energy gap due to the crystal structure broadens the quasi-particle density of states. This results in the suppression of the divergence of $1=T_1$. Instead, a peak of $1=T_1$ is seen just below T_c . This peak, which is characteristic of singlet pairing, was observed rst by Hebel

and Slichter[56] in the nuclear relaxation rate of A l, and is called the coherence peak. At low temperatures, $1=T_1$ decreases exponentially due to the uniform gap.




FIG.3: (a) Tem perature dependences of $1=T_1$ of 205 T land 119 Sn in strong and weak coupling s-wave superconductors, T M $_{06}$ Se_{7:5} and Sn_{1:1}M $_{06}$ Se_{7:5} and of 63 C u in Y B $_{22}$ C u_3O $_7$ at zero eld. Solid lines above and below T_c represent the T_1 T = constant law and the exponential law with $1=T_1$ = A exp ($=k_{\rm B}$ T), respectively. 2 =k $_{\rm B}$ $T_c=4.5$ and 3.6 are obtained for T M $_{06}$ Se_8 and SnM $_{06}$ Se_8, respectively.[57] (b) Tem perature dependence of 27 (1=T_1) in zero eld A l+N Q R for U P d_2A l_3.[39] The solid line shows T 3 dependence deduced from the d-wave model by using () = cos(), with 2 =k_{\rm B} T_c=5.5.

The coherence peak is not always seen in the case of strong-coupling superconductors. As an example of the relaxation behavior for weak and strong coupling s-wave superconductors, Fig.3(a) shows $1=T_1$ of 119 Sn and 205 Tl in the Chevrel phase superconductors, Sn_{1:1}M o₆Se_{7:5} and T M o₆Se_{7:5} with T_c= 4.2 K and T_c= 12.2 K, respectively.[57] In the normal state, the

 $T_1T = constant$ law holds for both compounds. In the superconducting state, $1=T_1$ of ¹¹⁹Sn in Sn_{1:1}M o₆Se_{7:5} has a coherence peak just below T_c and decreases exponentially with 2 = 3:6k $_{\rm B}$ T $_{\rm c}$, while 1=T $_1$ of 205 T l in the strong coupling superconductor T M 06Se7:5 has no coherence peak just below T_c and decreases exponentially over ve orders of m agnitude below 0.8T_c (10 K) with $2 = 4.5k_B T_c$. Even though the coherence peak is depressed, the s-wave picture is evidenced by the exponential decrease of $1=T_1$ below T_c . Figures 3 (a) and 3 (b) also show another important example, the high-T_c cuprates and HF antiferrom agnetic superconductor UPd_2Al_3 [39]. W hen the gap disappears on a line or points on the Ferm i surface for p- or d-wave pairing, the divergence at the gap edge is weak. Then, note that for the spin-triplet pwave $M_s(E) = 0$, and for the spin-singlet d-wave (;) in M s (E) disappears when averaged out over the Ferm i surface. In the case of a line node, $N_{s}(E)$ Eforsmall E and $1=T_1$ is given by

In these compounds listed up in the Table I, the dynamical magnetic properties are di erent in each case. N evertheless in all these the superconducting energy gap vanishes along lines on the Ferm i surface as evidenced from a rather universal behavior of $1=T_1 / T^3$ even in the d-wave for high-T_c oxides and the p-wave for Sr₂R uO₄. It is alm ost certain that an isotropic order param eters with spin singlet are realized in $C \in C u_2 S i_2$ and $U P d_2 A l_3$, and that a di erent anisotropic order param eter with nonunitary spin-triplet pairing is realized in UPt₃ which is the rst example of this pairing symmetry in charged many body systems, and UN i2A b is reported to belong to a class of spin-triplet pairing as well [37]. These variations of the anisotropic order parameter could be due to the di erent characters of the magnetic uctuations that lead to the Cooper pairing. We note that the integrated spectral weight of magnetic uctuations is smaller for Ce com pounds with the $4f^1$ than for U com pounds with $5f^2$ $5f^3$. An important feature is that the ground state ad jacent to the antiferrom agnetic phase in $C \in Cu_2Si_2$ and $C \in C u_2 G \in C$ is not the norm alphase but the superconducting one. Next we dealw ith an intim ate interplay between antiferrom agnetism and superconductivity.

V. NOVEL SUPERCONDUCTIVITY ON THE MAGNETIC CRITICALITY IN HEAVY-FERM ION SYSTEM S




FIG. 4: Schematic phase diagrams of HF compounds: (a) $C\,eP\,d_2\,Si_2$ [41, 42, 47], $C\,eIn_3$ [41, 42, 43, 44, 45] and $C\,eR\,h_2\,Si_2$ [48, 49]: (b) $C\,eC\,u_2\,Si_2$ [17, 22, 23, 24, 25] and $C\,eR\,hIn_5$,[50, 51] D otted and solid lines indicate the P dependence of T_N and $T_c,$ respectively.

The most common kind of superconductivity (SC) is based on bound electron pairs coupled by deform ation of the lattice. However, SC of more subtle origins is rife in strongly correlated electron systems including many HF, cuprate and organic superconductors. In particular, a number of studies on f-electron compounds revealed that unconventional SC arises at or close to a quantum critical point (QCP), where m agnetic order disappears at low tem perature as a function of lattice density via application of hydrostatic pressure (P) [40, 41, 48, 50]. These ndings suggest that the mechanism forming Cooper pairs can be m agnetic in origin. Namely, on the verge of m agnetic order, the m agnetically soft electron liquid can m ediate spin-dependent attractive interactions between the charge carriers [41]. However, the nature of SC and magnetism is still unclear when SC appears very close to the antiferrom agnetism (AFM). Therefore, in light of an exotic interplay between these phases, unconventional electronic and magnetic properties around QCP have attracted much attention and a lot of experim ental and theoretical works are being extensively made. The phase diagram, schematically shown in Fig. 4(a), has been observed in antiferrom agnetic HF com pounds such as CePd₂Si₂,[41, 42, 47] CeIn₃,[41, 42, 43, 44, 45] and CeRh₂Si₂. [48, 49] M arkedly di erent behavior, schem atically shown in Fig.4 (b), has been found in the archetypalHF superconductor CeCu₂Si₂ [17, 22, 23, 24, 25] and the more recently discovered CeRhIn₅.[50, 51] Although an analogous behavior relevant to a magnetic QCP has been demonstrated in these compounds, it is noteworthy that the associated superconducting region extends


to higher densities than in the other compounds; their value of T_c reaches its maximum away from the verge of AFM .[22, 23, 51]

In the following sections, we review the recent studies under P on C eC $u_2 Si_2$, C eR hIn₅ and C eIn₃ via NQR m easurements. These systematic works have revealed the homogeneous coexistent phase of SC and AFM and that its novel superconducting nature exhibits the gapless nature in the low-lying excitations below T_c , which dier from the superconducting characteristics for the HF superconductors reported to possess the line-node gap.[25, 53, 58]

VI. EXOTIC MAGNETISM AND SUPERCONDUCTIVITY ON THE MAGNETIC CRITICALITY IN CECU₂SI₂

A. The tem perature versus pressure phase diagram

The rstly-discovered HF superconductor CeCu₂Si₂ is located just at the border to the AFM at P = 0.[27, 59]This was evidenced by various magnetic anomalies observed above T_c [60] and by the fact that the magnetic A-phase appears when SC is suppressed by a magnetic eld H .[61] Furtherm ore, the transport, therm odynam ic and NQR m easurem ents consistently indicated that nom inally o -tuned $Ce_{0:99}Cu_{2:02}Si_2$ is located just at P_c and crosses its QCP by applying a m inute pressure of P = 0.2GPa.[24, 59] The magnetic and superconducting properties in $C \in C u_2 S i_2$ were investigated around the QCP as the functions of P for Cen.99Cu2.02Sip just at the border to AFM and of G e content x for C eC u₂ (Si_{1 x} G e_x)₂ by Cu-NQR measurements [24, 62]. Figure 5 shows the phase diagram referred from the literature. [62] Here, T_{FL} is an e ective Ferm i tem perature below which 1=T1 di-

vided by temperature $(1=T_1T)$ stays constant and T_m is a temperature below which antiferrom agnetic critical uctuations start to develop. Note that a prim ary effect of Ge doping expands the lattice [63] and that its chemical pressure is $0.076~{\rm GPa}$ per 1% Ge doping as suggested from the P variation of Cu-NQR frequency $_{\rm Q}$ in CeCu_2Ge_ and CeCu_2Si_2.[64] In the norm al state, the antiferrom agnetic critical uctuations develop below T_m 1.2 K without the onset of AFM . The exotic SC emerges in Ce_{0:99}Cu_{2:02}Si_2 below T_c 0.65 K, where antiferrom agnetic critical uctuations remain active even below T_c .

B. The uniform ly coexistent phase of AFM and SC in CeCu2 (Si $_{\rm x}$ S ex)2

M arkedly by substituting only 1% Ge, AFM emerges at $T_N = 0.7$ K, followed by the SC at $T_c = 0.5$ K. Unexpectedly, $1=T_1$ does not show any signi cant reduction at T_c , but follows a $1=T_1T = const.$ behavior well below T_c as observed in $Ce_{0:99}Cu_{2:02}Si_2$ as presented in Fig. 6(a). As Ge content increases, T_N progressively increases, while T_c steeply decreases. For the sam ples at m ore than x = 0.06, the m agnetic properties above T_N progressively change to those in a localized regime as observed in CeCu₂Ge₂.[64]

Further insight into the exotic SC is obtained on $C eC u_2 (Si_{0.98}G e_{0:02})_2$ that reveals the uniform ly coexistent phase of AFM ($T_N = 0.75 \text{ K}$) and SC ($T_c = 0.4 \text{ K}$) under P = 0. Figure 6(a) shows the T dependence of $1=T_1$ at P = 0 GPa (closed circles), 0.56 GPa (open circles) and 0.91 GPa (closed squares). In the entire T range, $1=T_1$ is suppressed with increasing P. Once

AFM is suppressed at pressures exceeding P = 0:19 GPa, any trace of anomaly associated with it is not observed at all down to T_c 0.45 K at P = 0.56 GPa and 0.91 GPa. It is, therefore, considered that the AFM in C eCu₂ (Si_{0:98}G e_{0:02})₂ is not triggered by some disorder e ect but by the intrinsic lattice expansion due to the G e doping.




FIG. 6: (a) The T dependence of $1=T_1$ of $C \in Cu_2$ $(Si_{0.98}G e_{0.02})_2$ at several pressures. Inset shows the T dependence of $1=T_1$ T of $C \in Cu_2$ $(Si_{0.98}G e_{0.02})_2$ at P = 0 GPa (closed circles) and 0.91 GPa (closed squares) and those of $Ce_{0.99}Cu_{2:02}Si_2$ at P = 0 (open squares) and 0.85 GPa (open triangles). A rrow sindicate T_N 0:75 K and T_c 0.4 K at P = 0 GPa for $CeCu_2$ $(Si_{0.98}G e_{0:02})_2$. (b) The T dependence of I(T) T at several pressures, where I(T) is an NQR intensity norm alized by the value at 4.2 K.

In order to demonstrate a system atic evolution of antiferrom agnetic critical uctuations at the param agnetic state, the inset of Fig. 6(a) shows the T dependence of $1=T_1T$ in CeCu₂ (Si_{0:98}Ge_{0:02})₂ at P = 0 GPa (closed circles) and 0.91 GPa (closed squares) along with the results in Ce_{0:99}Cu_{2:02}Si₂ at P = 0 GPa (open squares) and 0.85 GPa (open triangles).[24, 62] The result of $1=T_1T$ in CeCu₂ (Si_{0:98}Ge_{0:02})₂ at P = 0 GPa is well explained by the spin- uctuations theory for weakly itinerant AFM in T_c < T < 1:5 K.[24, 62, 65] The good agreement between the experiment and the calculation indicates that a long-range nature of the AFM is in the itinerant regime. At P = 0.91 GPa, $1=T_1T$ is suppressed and resembles a behavior that would be expected at an intermediate pressure between P = 0 GPa and 0.85 GPa for $C e_{0.99}C u_{2.02}Si_2$.

Next, we discuss an intim ate P-induced evolution of antiferrom agnetic critical uctuations in the superconducting state. As seen in Fig. 6(a) and its inset, the $1=T_1$ and $1=T_1T$ at P = 0 GPa do not show a distinct reduction below T_c , but instead, a $T_1T = const.$ behavior em erges well below T_c . At P = 0.56 GPa, the AFM is depressed, but antiferrom agnetic critical uctuations develop in the norm al state. It is noteworthy that the relation of 1=T $_1$ / T is still valid below T $_c$, resembling the behavior for $Ce_{0:99}Cu_{2:02}Si_2$ at P = 0GPa.[24, 27] By contrast, $1=T_1$ at P = 0.91 GPa follows a relation of $1=T_1 / T^3$ below $T_c = 0.45$ K, consistent with the line-node gap. This typical HF-SC was observed in $Ce_{0:99}Cu_{2:02}Si_2$ at pressures exceeding P = 0.85 GPa as well.[24] Therefore, it is considered that the unconventional SC at P = 0 G Pa and 0.56 G Pa evolves into the typical HF-SC with the line-node gap at pressures exceeding P = 0.91 GPa. Apparently, these results exclude a possible in purity e ect as a primary cause for the T_1T = const.behaviorbelow T_c at P = 0 G Pa.W e point out that a reason why the $1=T_1$ at P = 0 GPa is deviated from $1=T_1 / T^3$ below T_c is ascribed not to the impurity e ect but to the presence of low -lying excitations inherent to the exotic superconducting state.

C. Evidence for antiferrom agnetic critical uctuations at the boundary between AFM and SC

Figure 6(b) indicates the T dependence of NQR intensity multiplied by temperature I(T) T in $C \in C u_2$ (Si_{0.98}G $e_{0.02}$)₂ at P = 0, 0.19, 0.56, and 0.91 G P a. Here, the I(T) normalized by the value at 4.2 K is an integrated intensity over frequencies where NQR spectrum was observed. Note that I(T) T stays constant generally, if T_1 and/or T_2 range in the observable time window that is typically more than severalm icroseconds. Therefore, the distinct reduction in I(T) T upon cooling is ascribed to the development of antiferrom agnetic critical uctuations, since it leads to an extraordinary short relaxation time of 0.14 sec.[27]

T = 1 at P = 0 GPa decreases down to The I(T) about I(T) $T = 0.55 \text{ at } T_N$ 0:75 K upon cooling 1.2~K . Its reduction stops around $T_{\!N}$, but below T_m does no longer recover with further decreasing T. Note that its reduction below T_c 0:4 K is due to the superconducting diam agnetic shielding of rf eld for the NQR measurement. As P increases, T_m becomes smaller, in agreement with the result presented in the phase diagram of Fig. 5, and the reduction in I(T) T becom es moderate in the normal state. With further increasing P up to 0.91 GPa, eventually, I(T) T remains nearly

constant down to $T_{\rm c}$ $0.45~{\rm K}$, indicative of no anomaly related to antiferrom agnetic critical uctuations. This behavior resembles the result observed at pressures exceeding P = $0.85~{\rm G\,Pa}$ in ${\rm C\,e_{0.99}C\,u_{2:02}Si_2}$. These results also assure that the G e substitution expands the lattice of C $e_{0:99}C\,u_{2:02}Si_2$. It seems, therefore, that these exotic SC could be rather robust against the persistence of antiferrom agnetic critical uctuations and yet the appearance of AFM .

D. Towards a new concept for superconductivity

Remarkably this antiferrom agnetic critical uctuations, which emerge closely at the border between AFM and SC, is not in a completely static regime, but in a dynamical one with a characteristic fre-3 M H z.[66] A T₁ 0.14 sec, that is obquency !_c tained from the relation $1=T_1 / !_c (T) = (!_c (T)^2 + !_{NOR}^2)$, are too fast for the NQR signal to be observed.[27] Here, !_{NOR} (3.4 MHz) is a central NQR frequency. Neutron scattering experiments have, on the other hand, observed the long-range incommensurate AFM as the nature of antiferrom agnetic critical uctuations [67] because its resolution of characteristic frequencies is higher than in the NQR experiments. As a matter of fact, once a small amount of Ge are substituted for Si to expand its lattice, antiferrom agnetic critical uctuations are suddenly replaced by the static AFM, [62, 63] whereas they survive down to 0.012 K at x = 0. W ith increasing x, T_N progressively increases, while T_c steeply decreases. Correspondingly, antiferrom agnetic critical uctuations are suppressed for the samples at more than x = 0.06. It is noteworthy that the static AFM seems to suddenly disappear at x = 0 as if T_N were replaced by T_c . Eventually, the SC at x = 0 emerges under the dom inance of antiferrom agnetic critical uctuations.[66] However, when the application of H suppresses the SC, the rst-order like transition from SC to a magnetic Aphase takes place.[61] Since T_N becomes comparable to T_c, som e superconducting uctuations may prevent the onset of static AFM .[65] Once the application of pressure exceeding P = 0.2 GP a suppresses antiferrom agnetic critical uctuations, the typical HF-SC takes place with the line-node gap.

In C eC u₂ (Si₁ $_x$ G e_x)₂, one 4f electron per C e ion plays vital role for both SC and AFM, leading to the novel states of m atter. W e have proposed that the uniform ly coexistent phase of AFM and SC in the slightly G e substituted com pounds, and the m agnetic- eld induced A - phase for the hom ogeneous C eC u₂Si₂ in 0 < P < 0.2 G Pa are accounted for on the basis of an SO (5) theory.[65, 68] C oncerning the interplay between AFM and SC, we would propose that the antiferrom agnetic critical uctuations in the superconducting state at x = 0 m ay correspond to a pseudo G oldstone m ode due to the broken

U (1) symmetry. Due to the closeness to the magnetic QCP, however, such the gapped mode in the SC should be characterized by an extremely tiny excitation (resonance) energy.

The intim ate interplay between SC and AFM found in CeCu₂Si₂ has been a long-standing problem – unresolved for over a decade. We have proposed that the SO (5) theory constructed on the basis of quantum – eld theory m ay give a coherent interpretation for these exotic phases found in CeCu₂Si₂.[65] In this context, we would suggest that the SC in CeCu₂Si₂ could be mediated by the same m agnetic interaction as leads to the AFM in CeCu₂(Si_{1 x} Ge_x)₂. This is in marked contrast to the BCS superconductors in which the pair binding is mediated by phonons vibrations of the lattice density.

V II. UN IFORM LY COEX ISTENT PHASE OF ANT IFERROM AGNET ISM AND SUPERCONDUCT IV ITY IN CERH IN 5 UNDER PRESSURE

A. The tem perature versus pressure phase diagram




FIG.7: The P vs T phase diagram for CeRhIn₅. The respective marks denoted by solid square and open triangle correspond to the pseudogap temperature $T_{P\,G}^{N\,Q\,R}$ and the antiferrom agnetic ordering temperature T_N at the In site. The open and solid circles correspond to the onset temperature T_c^{onset} and $T_c^{M\,F}$ of superconducting transition (see text). D otted line denotes the position for P = 1:6 GPa. Shaded region indicates the P region where both phases of AFM and SC coexist uniform ly.

A new antiferrom agnetic HF com pound CeRhIn₅ undergoes the helical magnetic order at a Neel temperature $T_N = 3.8$ K with an incommensurate wave vector $q_M = (1=2;1=2;0:297)$.[69] A neutron experiment revealed the reduced Ce magnetic moments M_s 0.8 B.[70, 71] The P-induced transition from AFM to SC takes place at a relatively lower critical pressure $P_c = 1.63$ GPa and higher $T_c = 2.2$ K than in previous examples.[40, 41, 43, 47, 48, 50] Figure 7 indicates the P vs T phase diagram of CeRhIn₅ for AFM and SC that was determined by the In-NQR measurements under P. The NQR study showed that T_N gradually increases up to 4 K as P increases up to P = 1:0 GPa and decreases with further increasing P. [53, 72, 73] In addition, the T dependence of $1=T_1$ probed the pseudogap behavior at P = 1:23 and 1.6 GPa.[72] This suggests that CeRhIn₅ m ay resemble other strongly correlated electron system s.[74, 75] N ote that the value of bulk superconducting transition tem perature $T_{\rm c}^{\rm M~F}$ is progressively reduced as shown by closed circle in Fig. 7. For $P_c = 2.0 \text{ GPa} < P$ where AFM disappears, $1=T_1$ decreases obeying a T³ law without the coherence peak just below T_c .[53, 76] This indicates that the SC of CeRhIn₅ is unconventional with the line-node gap.[53, 77]

B. Gapless magnetic and quasi-particles excitations due to the uniform ly coexistent phase of AFM and SC




FIG.8:Plots of H $_{\rm int}$ (T)=H $_{\rm int}$ (O) vs T=T_N at P = 0 and 1.6 GPa (see text). Inset shows the $^{115}\,\rm{Im}$ -NQR spectra of 1 $_Q$ at P = 1.6 GPa above and below T_N = 2.8 K.

We present microscopic evidence for the exotic SC at the uniform ly coexistent phase of AFM and SC in CeRhIn₅ at P = 1:6 GPa. The inset of Fig. 8 displays the NQR spectra above and below T_N at P = 1:6 GPa.

Below $T_N = 2.8$ K, the NQR spectrum splits into two peaks due to the appearance of H_{int} at the In site. This is clear evidence for the occurrence of AFM at P = 1.6 GPa. The plots of H_{int} (T)=H_{int} (0) = M_s (T)=M_s (0) vs (T=T_N) at P = 0 and 1.6 GPa are compared in Fig. 8, showing nearly the same behavior. Here H_{int} (0) is the value extrapolated to zero at T = 0 K and M_s (T) is the T dependence of spontaneous staggered m agnetic m om ent. The character of AFM at P = 1:6 GPa is expected to be

not so much di erent from that at P = 0.




FIG.9: The T dependence of $1=T_1$ at P = 1.6 GPa.Both dotted lines correspond to $1=T_1$ / T and $1=T_1$ / T³. Inset indicates the T dependence of $^{27}A \ ln QR$ $1=T_1$ of UPd₂A l₃ cited from the literature.[39] Solid line corresponds to $1=T_1$ / T³.

Figure 9 indicates the T dependence of $1=T_1$ at P = 1.6GPa. A clear peak in $1=T_1$ is due to antiferrom agnetic critical uctuations at $T_N = 2.8$ K.Below $T_N = 2.8$ K, 1=T₁ continues to decrease moderately down to $T_{c}^{M F}$ = 0:9 K even though passing across $T_c^{on set}$ 2 K. This relaxation behavior suggests that SC does not develop following the mean-eld (MF) approximation below T_c^{onset} . M arkedly, 1=T_1 decreases below ${\rm T_c^M}^{\rm F}$, exhibiting a faint T³ behavior in a narrow T range. W ith further decreasing T, $1=T_1$ becomes proportional to the tem perature, indicative of the gapless nature in low-lying excitation spectrum in the uniform ly coexistent state of SC and AFM . Thus the T_1 m easurem ent has revealed that the intim ate interplay between AFM and SC gives rise to an am plitude uctuation of superconducting order param eter between T_c^{onset} and T_c^{MF} . Such uctuations may be responsible for the broad transition in resistance and ac-susceptibility (ac) measurements. Furthermore, the $T_1T = const.$ behavior well below $T_c^{M F}$ evidences the gapless nature in low-lying excitations at the uniform ly coexistent phase of AFM and SC. This result is consistent with those in $CeCu_2Si_2$ at the border to AFM [24] and a series of C eC u2 (Si x G e2)2 com pounds that show the uniform ly coexistent phase of AFM and SC .[62, 65] It

is noteworthy that such the T_1T = const. behavior is not observed below $T_{\rm c}$ at P = 2.1 GPa.[53] This means that the origin for the T_1T = const. behavior below $T_{\rm c}^{\rm M~F}$ at P = 1:6 GPa is not associated with some in purity e ect. If it were the case, the residual density of states below $T_{\rm c}$ should not depend on P . This novel feature di ers

from the uranium (U)-based HF antiferrom agnetic superconductor UPd₂A \natural which has multiple 5f electrons. In UPd₂A \natural , a superconducting transition occurs at T_c = 1.8 K well below T_N = 14.3 K .[78, 79] As indicated in Fig.3 (b) and the inset of Fig. 9,[39] in UPd₂A \natural , 1=T₁ decreases obeying a T 3 law over three orders of m agnitude below the onset of T_c without any trace for the T_1T = const. behavior. This is consistent with the line-node gap even in the uniform ly coexistent phase of AFM and SC .

C. Superconducting uctuations due to the uniform ly coexistent phase of AFM and SC $\,$





FIG.10: (a) The T dependence of $1=T_1T$ at P = 1:6 G Pa. (b) The T dependencies of d $_{ac}$ =dT at P = 1:6 G Pa and resistance at P = 1:63 G Pa cited from the literature.[50] T_c^{M-F} and T_c^{onset} correspond to the respective tem peratures at which d $_{ac}$ =dT has a peak and below which $_{ac}$ starts to decrease. T_N corresponds to the antiferrom agnetic ordering tem perature at which $1=T_1T$ exhibits a peak and T_p^{N-Q-R} to the pseudogap tem perature below which it starts to decrease. A solid line is an eye guide for the T - linear variation in resistance at tem peratures higher than $T_{P,G}^{N-Q-R}$.

In order to highlight the novel SC on a microscopic level, the T dependence of $1=T_1T$ is shown in Fig. 10(a) at P = 1.6 G Pa in T = 0.05 6 K and is compared with the T dependence of the resistance R (T) at P = 1.63 G P a referred from the literature.[50] A lthough each value of P is not exactly the same, they only dier by 2%. We rem ark that the T dependence of $1=T_1T$ points to the pseudogap behavior around $T_{P\,G}^{N\,Q\,R}$ = 4.2 K, the AFM at $T_N = 2.8$ K, and the SC at $T_c^{M F} = 0.9$ K at which d ac=dT has a peak as seen in Fig. 10(b). This result itself evidences the uniform ly coexistent state of AFM and SC.A comparison of $1=T_1T$ with the R (T) at P = 1:63 GPa in Fig. 10 (b) is informative in shedding light on the uniqueness of AFM and SC .Below $T_{P\,G}^{N\,Q\,R}$, R (I) starts to decrease m ore rapidly than a T-linear variation extrapolated from a high T side. It continues to decrease across $T_{\rm N}$ = 2.8 K, reaching the zero resistance at $T_{\rm c}^{\rm zero}$ 1.5 к.

The resistive superconducting transition width becom es broader. Note that this broad transition is not due to the distribution in T_c caused by som e distribution in values of pressure because the value of T_1 , the m icroscopic quantity, is uniquely determined in the T range in concern. Unexpectedly, T_c^{on set} 2 K, that is de ned as the tem perature below which the diam agnetism starts to appear, is higher than T_c^{zero} 1.5 K. Any signature for the onset of SC from the $1=T_1$ measurement is not evident in between $T_{\rm c}^{\,\rm on\,set}$ and $T_{\rm c}^{\,\rm M}$ $^{\rm F}$, dem onstrating that the mean-eld type of gap does not grow up down to T_c^{M F} 0.9 K . In $T_{\rm c}^{\rm on\,set}$ > T > $T_{\rm c}^{\rm M}$ $^{\rm F}$, therefore, the SC is not in the conventional mean-eld regime that accompanies a gap form ation at the Ferm i level below $T_c^{on set}$, but in a gapless regime with a pairing correlation. In this context, we would propose that the presence of som e uctuations of antiferrom agnetic order param eter (OP) ormagnetic density uctuations bring about the uctuations of superconducting OP, making the superconducting transition very broad. As the antiferrom agnetic OP fully develops at tem peratures low er than $T_{\rm c}^{\,\rm on\,set}$, the SC reveals the gap form ation below $T_c^{MF} = 0.5 T_c^{onset}$.

D. A novel interplay between AFM and SC

Recent neutron-di raction experiment suggests that the size of staggered moment M_s in the AFM is almost independent of P.[71] Its relatively large size of moment with M_s 0.8 _B seems to support such a picture that the same f-electron exhibits simultaneously itinerant and localized dual nature, because there is only one 4f-electron per Ce³⁺ ion. In this context, it is natural to consider that the superconducting nature in the uniform ly coexistent phase of AFM and SC belongs to a novel class of phase which di ers from the unconventional d-wave SC with the line-node gap. As a matter of fact, a theoretical model has been recently put forth to address the underlying issue in the uniform ly coexistent phase of AFM and SC.[80]



A. The tem perature versus pressure phase diagram





FIG.11: The P vs T phase diagram of CeIn₃ determined by the In-NQR measurement under P. Solid circle denotes the Neel temperature $T_{\rm N}$ where antiferrom agnetic order takes place. P = 228 GPa is an end point of the rst-order transition and P_c 2:43 GPa is the critical pressure at which the rst-order transition occurs from AFM to PM .Note that the phase separation into AFM and PM occurs at P_c, revealing alm ost equivalent fraction of each phase. Regardless of this phase separation, SC emerges at both phases.

Figure 11 indicates the P vs T phase diagram in $CeIn_3$ around P_c that is the critical pressure at which a rst-order transition occurs from AFM to paramagnetism (PM). This work has deepened the understanding of the physical properties on the verge of AFM in $CeIn_3$ that exhibits the archetypalphase diagram shown in Fig. 4 (a).[46] At P = 2:65 G P a larger than P_c , the measurements of $1=T_1$ and a_c down to T = 50 mK provided the rst evidence of unconventional SC at $T_c = 95 \text{ mK}$ in CeIn₃, which arises in the HF state fully established below $T_{FL} = 5 \text{ K} \cdot [81] \text{ By contrast, in P} = 2.28$ 2:50GPa, the phase separation into AFM and PM is evidenced in CeIn₃ from the observation of two kinds of NQR spectra. Nevertheless, it is highlighted that the SC in $CeIn_3$ occurs in both AFM and PM at $P_c = 2:43$ GPa. The maximum value of $T_c^{max} = 230 \text{ mK}$ is observed for the SC for PM at Pc, whereas, markedly, the SC also sets in at $T_c = 190 \text{ mK}$ for AFM with $T_N = 2.5 \text{ K}$. The present results indicate that the rst-order phase transition occurs at P_c 2:43 GPa from the uniform ly coexistent phase of SC and AFM to the single phase of SC under the param agnetic HF state. Therefore, a QCP is absent in $CeIn_3.[46]$

 $C\,eIn_3$ form s in the cubic $A\,uC\,u_3$ structure and orders antiferrom agnetically below $T_N~=~10.2$ K at P =~0 with

an ordering vector Q = (1/2,1/2,1/2) and C e m agnetic m om ent M_S $0.5_{\rm B}$, which were determ ined by NQR m easurem ents [82,83] and the neutron-di raction experim ent on single crystals,[84] respectively. The resistivity m easurem ents of C eIn₃ have clari ed the P vs T phase diagram of AFM and SC:T_N decreases with increasing P. On the verge of AFM, the SC emerges in a narrow P range of about 0.5 GPa, exhibiting a maximum value of T_c 0.2 K at P_c = 2.5 GPa where AFM disappears.[41, 42, 43, 44, 45]


B. Evidence for the rst-order transition from AFM to PM

Figure 12 shows the NQR spectra of 1 $_{\rm Q}$ transition for the PM at (a) P = 2.37 GPa and for temperatures lower than T_N and T_c at (b) P = 2.37 GPa, (c) P_c = 2.43 GPa and (d) P = 2.50 GPa. Note that the 1 $_{\rm Q}$ transition can sensitively probe the appearance of internal eld H _{int} (T) associated with even tiny Ce ordered moments on the verge of AFM . As a matter of fact, as seen in Figs. 12 (a) and 12 (b), a drastic change in the NQR spectral shape is observed due to the occurrence of H _{int} (T) at the In nucleibelow T_N . By contrast, the spectra at Fig.12 (c) at P = 2:43 G Pa and F ig 12(d) at P = 2:50 G Pa include two kinds of spectra arising from AFM and PM provides m m icroscopic evidence for the em ergence of magnetic phase separation. It should be noted that the phase separations at P = 2:28 and 2:37 G Pa are observed only in the respective ranges T = 3 K and $T_N = 5:2$ K and T = 1 K and $T_N = 4:9$ K.

C . The novelSC under both the backgrounds of $$\ensuremath{\mathsf{AFM}}$$ and $\ensuremath{\mathsf{PM}}$

The uniform ly coexistent phase of AFM and SC is corroborated by direct evidence from the T dependence of $1=T_1T$ that can probe the low-lying excitations due to quasiparticles in SC and the magnetic excitations in AFM . Figure 13 shows the drastic evolution in the P and T dependencies of $1=T_1T$ for AFM (solid symbols) and PM (open symbols) at P = 2.17, 2.28, 2.43 and 2.50 GPa. Here, T_N was determined as the tem perature below which the NQR intensity for PM decreases due to the emergence of AFM associated with the magnetic phase separation. The T₁ for AFM and PM is separately measured at respective NQR peaks which are clearly distinguished from each other, as shown in Figs.12(b), 12(c) and 12(d). Thus, the respective T_c^{AFM} and T_c^{PM} for AFM and PM are determined as the tem perature below which $1=T_1T$ decreases markedly due to the opening of superconducting gap. These results verify that the uniform ly coexistent phase of AFM and SC takes place on a microscopic level in the range P = 2:28 2:43 G Pa. In the PM at P = 2:43 and 2.50 GPa, the $1=T_1T = const$. 32 K and relation is valid below T_{FL} 3:5 K, respectively, which indicates that the Ferm i-liquid state is realized. This result is in good agreem ent with that of the previous resistivity measurement from which the T 2 dependence in resistance was con rm ed.[45] Note that the $1=T_1$ for the SC in the PM at P = 2.50 GPa follows a T 3 dependence below T $_{\rm c}$ = 190 mK, consistent with the line-node gap m odel characteristic for unconventional HF-SC.

At P = 2:17 GPa, no phase separation occurs below $T_N = 5.5 \text{ K}$ and $1=T_1T = \text{const.}$ behavior is observed wellbelow T_N . At P = 2:28 G Pa, that is the end point of rst-order transition, the T dependence of $1=T_1T$ resem bles the behavior at P = 2:17 GPa above T 1 K. However, the phase separation into AFM and PM occurs in the smallT window between $T_N = 52$ K and 3 K. In contrast to the behavior of $1=T_1T = const.$ at P = 2:17 GPa, the 1= T_1T at P = 2:28 GPa continues to increase in spite of antiferrom agnetic spin polarization being induced upon cooling below ${\rm T}_{\rm N}$. These results suggest that they are required for the onset of SC to exceed the end point for the rst-order transition of AFM and to experience the large enhancem ent in the low-lying m agnetic excitations spectrum below T_N . This feature is also seen for the AFM at $P_c = 2:43$ GPa. Some spin-density uctuations m ay be responsible for this feature in association

with the rst-order transition from AFM to PM at $P_{\rm c}$. In this context, C eIn₃ is not in a magnetically soft electron liquid state,[41] but instead, the relevant magnetic excitations, such as spin-density uctuations, induced by the rst-order transition from AFM to PM might mediate attractive interaction. W hatever its pairing mechanism is at P = 2.28 GPa where AFM is realized over the whole sam ple below T = 3 K, the clear decrease in 1=T₁T that coincides with the appearance of diam agnetism in $_{\rm ac}$ provide convincing evidence for the uniform ly coexistent phase of AFM and SC in CeIn₃.

Further evidence for the new type of SC uniform ly coexisting with AFM was obtained from the results at $P_c = 2.43 \text{ GPa}$, as indicated in Fig. 13(b). Unexpectedly, the magnitude of $1=T_1T = \text{const.}$ well below T_c for AFM and PM coincides one another. It should be noted that this behavior of $1=T_1T = \text{const.}$ at $P_c = 2.43 \text{ GPa}$

cannot be ascribed to some in purity e ect. This is because the $1=T_1$ at P = 2.50 GPa follows a T³ behavior that is consistent with the line-node gap, nevertheless its T_c goes down from $T_c^{PM} = 230$ mK at $P_c = 2.43$ GPa to 190 mK at P = 2.50 GPa. This means that the quasiparticle excitations for the uniform ly coexistent phase of SC and AFM m ay be the same in origin as for the phase of SC in PM . How does this happen? It may be possible that both the phases at P_c are dynamically uctuating with frequencies smaller than the NQR frequency so as to make each superconducting phase under AFM and PM uniform. In this context, the observed magnetically separated phases and the relevant phases of SC may belong to new phases of matter that may be caused by quantum phase separation through the Josephson coupling.

D. A new superconducting phenom enon m ediated by spin-density uctuations near the rst-order m agnetic criticality in C eIn₃

We have provided evidence for the rst-order transition at P_c 2:43 GPa and the new type of SC uniform ly coexisting with the AFM in the range P = 228GPa and $P_c = 2:43$ GPa. It has been found that the highest value of $T_c = 230 \text{ mK}$ in $CeIn_3$ is observed for the PM at Pc. The present experiments have revealed that this new type of SC uniform ly coexisting with the AFM is mediated by a novel pairing interaction in association with the rst-order transition. In this uniform ly coexistent phase of AFM and SC, the $1=T_1T$ measurem ents have revealed the large enhancem ent of the low lying m agnetic excitations at the antiferrom agnetic state well below $T_{\rm N}$, being larger than the value for PM , as shown in Figs.13(a) and 13(b). This is because the uctuations in transverse component of internal elds at the In site are induced by such magnetic density uctuations even below T_N , making low-lying magnetic excitations develop. We propose that the antiferrom agnetic spindensity uctuations, in association with the rst-order m agnetic criticality, m ight m ediate attractive interaction to form Cooper pairs in $CeIn_3$; this is indeed a new type of pairing mechanism.

IX. TOWARDS UNDERSTANDING OF UNIVERSAL CONCEPT FOR THE SUPERCONDUCTIVITY IN HEAVY FERMIONS SYSTEMS

The SC in HF compounds has not yet been explained from the microscopic point of view, mainly due to the strong correlation e ect and the complicated band structures. An essential task seem s to identify the residual interaction between quasi-particles through analyzing the e ective f-band m odel by choosing dom inant bands.[85] H ere, we have demonstrated that HF superconductors possess a great variety of ground states at the bound-

A genuine uniform ly coexistent phase of AFM and SC has been observed in $CeCu_2Si_2$ and $CeRhIn_5$ in the P vs T phase diagram through the extensive and precise NQR measurements under P. In other strongly correlated electron systems, the SC appears near the boundary to the AFM . Even though the underlying solid-state chem istries are rather di erent, the resulting phase diagram s are strikingly similar and robust. This similarity suggests that the overall feature of all these phase diagrams is controlled by a single energy scale. In order to gain an insight into the interplay between AFM and SC, here, we try to focus on a particular theory, which unies the AFM and SC of the heavy-ferm ion systems based on an SO (5) theory, because sym m etry uni es apparently di erent physical phenom ena into a common fram ework as all fundam ental laws of Nature.[86] The uniform ly coexistent phase diagram of AFM and SC and the exotic SC emerging under strong antiferrom agnetic uctuations could be understood in terms of an SO (5) superspin picture.[65, 68]

By contrast, CeIn₃ has revealed the P-induced rstorder transition from AFM to PM as functions of pressure and tem perature near the boundary at Pc. Unexpectedly, how ever, the SC is robust even though the rstorder transition takes place at Pc from AFM to PM. The SC for the PM at Pc occurs under the Ferm i-liquid state established below T 32K without the developm ent of antiferrom agnetic spin uctuations. The SC uniform ly coexisting with the AFM in between P $\,$ and P $_{\rm c}$ has revealed the mean-eld type of transition. The SC revealing the gapless excitations for both AFM and PM at Pc strikingly di er from the SC revealing the line-node gap for the PM in $P > P_c$. The longitudinal spin-density uctuations below T_N develop in association with the rst-order magnetic criticality from AFM to PM, leading to the onset of the SC uniform ly coexisting with the AFM. These new phenomena observed in CeIn₃ should be understood in terms of a quantum st-order transition because these new phases of matter are induced by applying pressure. In Ferm ion systems, if the magnetic critical tem perature at the term ination point of the rstorder transition is suppressed at Pc, the diverging m agnetic density uctuations inherent at the critical point from AFM to PM become involved in the quantum Fermi degeneracy region. The Ferm i degeneracy by itself generates various instabilities called as the Ferm i surface effects, one of which is a superconducting transition. On the basis of a general argum ent on quantum criticality, it is shown that the coexistence of the Ferm i degeneracy and the critical density uctuations yield a new type of quantum criticality.[87] In this context, the results on $C e In_3$ deserve further theoretical investigations.

We believe that the results presented here on $C \in Cu_2Si_2$, $C \in RhIn_5$ and $C \in In_3$ provide vital clue to unravel the essential interplay between AFM and SC, and to extend the universality of the understanding on the

SC in strongly correlated electron system s.
