Voting and Catalytic Processes with Inhom ogeneities

We consider the dynam ics of the voter m odel and of the m onom erm onom er catalytic process in the presence of m any \com peting" inhom ogeneities and show, through exact calculations and num erical simulations, that their presence results in a nontrivial uctuating steady state whose properties are studied and turn out to speci cally depend on the dimensionality of the system, the strength of the inhom ogeneities and their separating distances. In fact, in arbitrary dimensions, we obtain an exact (yet form al) expression of the order parameters (m agnetization and concentration of adsorbed particles) in the presence of an arbitrary number n of inhom ogeneities (\zeabts" in the voter language) and form al similarities with suitable electrostatic systems are pointed out. In the nontrivial cases n = 1;2, we explicitly com pute the static and long-time properties of the order parameters and therefore capture the generic features of the system s. W hen n > 2, the problem s are studied through num erical simulations. In one spatial dimension, we also com pute the expressions of the stationary order parameters in the com pletely disordered case, where n is arbitrary large. P articular attention is paid to the spatial dependence of the stationary order parameters and form al connections with electrostatics.

I. IN TRODUCTION

Recently, much attention has been devoted to the eld of nonequilibrium many-body stochastic processes [1]. In particular the study of exact solutions of prototypicalm odels such as the voter m odel [2] has proved to be fruit ful for understanding a broad class of nonequilibrium phenomena [1]. In modeling nonequilibrium systems, it is often assumed that the underlying spatial structure is hom ogeneous. How ever, in real situations stochastic processes take place in the presence of in perfections (dislocations, defects, etc) that modify locally the interactions (see e.g. [1, 3] and references therein). It is therefore highly desirable to take into account the e ects of disorder, inhom ogeneities and defects or other spatial constraints within simple and mathematically amenable models. M otivated by the above considerations, in a recent letter [4], the properties of a paradigm atic nonequilibrium statistical mechanics model (the voter model) in the presence of one single inhom ogeneity (a zealot) have been studied and it was shown that the presence of single zealot has dram atic e ects on the dynam ics and the steady state. For this model, in low dimensions, all of the agents eventually follow the zealot. Obviously, real system s are quite complex and the case of a single defect cannot be considered as being generic. To gain som e insight on m ore realistic situations, w e present here an approach allowing us to compute exact properties, in arbitrary dimensions, of a class of stochastic manybody systems in the presence of n competing inhom ogeneities. This study is carried out in the context of

two physically relevant systems: the voterm odel and the m onom er-m onom er catalytic reaction (in the reactioncontrolled limit). We consider such a study as a further contribution toward the understanding of a class of disordered nonequilibrium many-body processes (where inhom ogeneities would not be spatially xed but would be random ly distributed). We show that the presence of \com peting inhom ogeneities" (in the sense of locally perturbing the otherwise hom ogeneous dynamics) generally results in a space-dependent uctuating steady state. The amenable case where n = 2 is analytically studied in detail and the static and long-tim e properties of the order param eters are obtained and their spatial dependence are computed. The situation where n 2 is investigated by num erical sim ulations. A lso, in one spatial dim ension, we are able to compute the stationary order parameters in the completely disordered case (i.e when n is arbitrary large). We therefore show how the stationary magnetization/concentration depends on the dim ensionality of the system, the strength of the inhom ogeneities and their separating distances. In particular, we show that the bcalperturbation of the dynam ics m ay give rise to subtle coarsening phenom ena. In 1D and 2D, when the density of the inhom ogeneities is vanishing in the therm odynam ic lim it there is still coarsening in the system . Oppositely, when the density of the competing inhomogeneities is non-zero there is no coarsening, even in one and two dimensions. We obtain an exact, yet form al, expression of the order parameters (magnetization and concentration of adsorbed particles) in arbitrary dimension. In dimensions d = 2;3 we pay special attention to the radial and polar dependence of these quantities. A lso, form al sim ilarities with electrostatic systems are pointed out. The organization of this work is the following: In the next section we introduce the inhom ogeneous voter m odel. In

Section III, we present the generalm athem atical set-up and the form al solution of the problem. In Section IV, we study analytically the voterm odel in the presence of two \competing zealots" in one, two and three dimensions and provide numerical results for the case where n = 2. In Section IV B, for the one-dimensional case, we also derive the expression of the static magnetization in the completely disordered situation where n is arbitrary large. Section V is devoted to the study of the process ofm onom errm onom er catalysis reaction on an inhom ogeneous substrate, whose mathem atical form ulation is very close to that of the (inhom ogeneous) voterm odel and in Section V I we sum marize and present our conclusions.

II. VOTER DYNAM ICS IN THE PRESENCE OF COMPETING ZEALOTS

The (hom ogeneous) voter model is an Ising-like model where a spin (\individual"), associated to a lattice site r, can have two di erent \opinions" $_{r} =$ 1 [2]. The dynamics of such system is implemented by random ly choosing one spin and changing its state to the value of one of its random ly chosen nearest neighbors. In the (hom ogeneous) voter m odel, the global m agnetization is conserved and the dynam ics is Z₂ symmetric (invariance under the global inversion r! $_{\rm r}$). The importance of the voter m odel stem s from the fact that it is one of a very few stochastic many-body systems that are solvable in any dimension. It is useful for describing the kinetics of catalytic reactions [5, 6], for studying coarsening phenom ena [7, 8] and also serves as a prototype m odel for opinion dynam ics [4, 9, 10].

Concepts inspired by statistical mechanics have already been employed to some extent in the last two decades to m in ic social issues [11]. Very recently variants of the voter m odel and m odern tools of nonequilibrium statistical physics, such as various mean-eld-like approaches and exact m ethods [4, 12, 15], num erical sim ulations [9, 13, 14, 16], form ulation on random networks [10, 16] (see also references therein), were used intensively to quantitatively study further, both m athem atically and num erically, collective phenom ena, such as the opinion form ation, inspired by socio-cultural situations. In this context, the voterm odel and its variants play a key rôle, as it is often used as a reference model. Despite of all these e orts, voter-like m odels have m ainly be studied on hom ogeneous and/or translationally-invariant spatial structures.

In contrast to most of the previous works, here we study, using exact analyticalm ethods and num ericalsim – ulations, a spatially inhom ogeneous voter model. It is de ned on a hypercubic lattice of size $(2L + 1)^d$, where individuals, labeled by a vector r having components L r L (with $i = 1; \ldots; d$), m ay interact according to the usual voter dynam ics. In addition, we now consider that there are n zealots (labeled $j = 1; \ldots; n$), occupying the sites fa^j = (a_1^j; \ldots; a_d^j)g. These agents

interact with their neighboring spins in a biased fashion. A zealot at site a^j favors one of the opinions $_j = 1$, i.e. it ips with an additional rate $_j > 0$ (additional to the usual voter rate) toward his favorite state. As the zealots interact e ectively with all of the spins on the lattice, there is a competition between them aiming at \convincing" as m any spins as possible. C learly, because the zealots perturb the dynamics locally, the system is disordered, not translationally invariant and the m agnetization is not conserved.

A coording to the spin form ulation of the model, the state of the system is described by the collection of all spins: S f_rg . In this language, the dynam ics of the model is governed by the usual voter model transition-rate [2, 5, 6] supplemented by local terms involving the zealots' reaction. The spin- ip rate, $w_r(S) = w(r!)$

Here the sum on right-hand side (rh.s.) runs over the 2d nearest neighbors r^0 of site r and 1=d > 0 de nes the time scale. The probability distribution P (S;t) satisfies the master equation:

where the state S^r di ers from con guration S only by the spin- ip of $_r$. Using the master equation (2), in the therm odynamic lim it L $\,!\,$ 1, the equation of motion ρf the local magnetization at site r, denoted by S_r (t)

s r P (S;t), reads:

Here r denotes the discrete Laplace operator: $2ds(t) + \frac{1}{r^0} S_{r^0}(t)$. We can immedirSr (t) ately notice from (3) that the stationary magnetization obeys a discrete Poisson-like equation: ${}_{r}S_{r}(1) =$ " j=1 j (S_aj(1) j) _{r;a}j. There is an obvious and striking resem blance between this equation and the wellknown equation for the electrostatic potential generated by n classical point charges located at fa¹g. Therefore, one may be tempted to form ally identify S_r (1) with an electrostatic potential and think that the problem could be solved easily. In fact, the problem is much harder since the quantities playing the rôle of charges depend them selves on the magnetization. In other words, the problem of nding the stationary magnetization is isom orphic to the problem of determ ining the electrostatic potential in a discrete system where the value of the charges depends on the potential itself. Because of this fact, the calculation of S_r (1) cannot be inferred directly from the results known from electrostatics and the computations have to be carried out in a self-consistent manner, as described hereafter.

III. GENERAL SET-UP AND FORMAL SOLUTION

In this section, we show how to compute the magnetization of the voter model in the presence of an arbitrary number of inhom ogeneities (competing zealots) and provide a form al" solution of Eq. (3).

The quantity $\hat{f}_r(s)$ can be rewritten in terms of W atson integrals, or \lattice G reen-functions":

For technical simplicity, we have considered that the system is initially in a state with zero magnetization: $S_{r}(0) = 0$. Inverse Fourier transform ing Eq. (7), we get the Laplace transform $\hat{S}_{r}(s)$ of the magnetization:

As both right and left hand-side (lh.s.) still depend on the Laplace transform of the magnetization (through A^{j} (s) on the lh.s.), to obtain an explicit expression for $\hat{S}_{a^{j}}$ (s), we have to nd a self-consistent solution of Eq.(8) for all of the a^{j} 's by plugging $r = a^{j}$ into Eq.(8). Solving the resulting linear system, in therm odynam ic limit (L ! 1) we obtain:

To obtain the two last equalities, we used the integral representation (4). We now introduce another symmetric n n matrix, N, de ned by:

At this point, we can get an explicit expression for the Laplace transform of the magnetization by plugging back (12) into (8). In the therm odynam ic lim it (L ! 1), we have:

This expression m eans that we have recast the problem of solving the inhom ogeneous voterm odel in the presence of arbitrary m any inhom ogeneities into a well-de ned linear algebra problem whose m ain, but nontrivial, analytic di culty resides in the inversion of the m atrix N. The steady state of the m agnetization for L ! 1 can be directly inferred from Eq.(14) as follows:

The exact expression for the long-time magnetization is obtained by Laplace-inverting the s! 0 expansion of Eq.(14), after having subtracted the static contribution S_r (1)=s, and by paying due attention to the situations where the integrals (4) are divergent. It is also worth mentioning that the properties of the modiled Bessel functions of the rst kind, I_r (t) [20], allow us to write a

form aland implicit solution of Eq.(3) for L ! 1 , which reads :

To solve it explicitly for S_r (t), one has to Laplace transform (17) and then solve the resulting linear system [4], which is equivalent to the procedure described above. The expression (17) is advantageous if one is interested in the globalm agnetization of the system. In fact, as we consider an initially hom ogeneous and \neutral" system (S_k (0) = 0), using Eqs (17), the globalm agnetization of the system can be written:

The situation considered here is particularly interesting when the zealots favor di erent opinions and there is an elective competition occurring in the system. In this case we expect nontrivial nonequilibrium space-dependent steady states. Of course, we can easily check that in the presence of one single zealot (n = 1) located at site 0, with strength _1 = and _1 = 1, we recover the results reported in R efference [4]. In this case we simply have: N ¹ = $\hat{f}_0(s) + 1$ and, together with (8), we recover $\hat{S}_r(s) = \frac{\hat{f}_r(s)}{s(\hat{f}_0(s)+1)}$. In Ref. [4], one of us has shown that in low dimensions the voter model with only one zealot evolves tow and the unanim ous state favored by the inhom ogeneity.

IV. THE VOTER MODEL IN THE PRESENCE OF TW O COMPETING ZEALOTS

In this section we speci cally consider the case where two competing zealots are present (j=1;2): One, with strength $_1$ = , located at site a^1 = 0 and the other located at site a^2 = x with a strength $_2$ = . This case is explicitly tractable and displays interesting features, which turns out to be generic for the case n > 1 as illustrated by numerical simulations. where $_{1;2} = 1$. O by iously, the inhom ogeneous system with two zealots is interesting in the case when $_1 = _2$. In fact, it is clear from Ref. [4] that in 1D and 2D the condition $_1 = _2$ implies that $S_r(1) = _1$. In this situation, the long-time approach toward the unanimous steady state is $S_r(t) = _1 (1)'$ At $^{1=2}$ in one dimension and $S_r(t) = _S_r(1)'$ B = lnt in two dimensions. Thus, in low dimensions, when $_1 = _2$, only the long-time am - plitudes A and B change with respect to the case where n = 1 and $= \frac{1}{1}$ [4].

From now on, without loss of generality, we consider the more interesting situation when there is a competition between the zealots: $_1 = _2 = 1$. Namely, the zealot at the origin favors the +1 opinion, whereas the zealot at site x favors the opposite 1 state. In this case, Eq. (19) simpli es as follow s:

explicit calculation of the stationary magnetization and its long-time behavior.

A. Results in 1D

First we focus on the one-dimensional situation and consider the case when both competing zealots are separated by a nite distance x [See Fig. 1 (a)]. It is worth studying the properties of the one-dimensional version of the inhom ogeneous voter m odel because of its physical implication for the catalysis (see Section V) and its close relationship with the Ising m odel with G lauber dynamics, which is an important theoretical model, known to have m any physical applications [1, 4]. In fact, in the absence of zealots the one-dimensional voterm odel coincides with the G lauber-Ising model with zero tem perature dynamics [17, 18].

In 1D, one computes explicitly \hat{I}_r (s) in Eq. (4) as follows [20, 21]:




where erfc(x) = $2 \frac{R_1}{x} \stackrel{dy}{=} e^{y^2}$ is the usual complem en-

tary error function. We infer from (22) that in the nite interval separating the two zealots, the stationary magnetization pro le decays linearly with a slope 2 = (+ + x). Outside from this interval, the nal magnetization is uniform on the right and left hand side from both inhom ogeneities. In fact, (23) and (24) show that the static magnetization of the spins is S $_{r}(1) = \frac{x}{+ + x}$ (see Figs. 1(b), 2). These plateaus




FIG.2: The stationary distribution S_r (1) on a L = 1024 lattice with two competing zealots. The zealot favoring the positive opinion (dot) is located at the origin with = 0.02 and the other one favoring the negative opinion (square) is at r = 430 with = 0.01. The agreement with the theoretical results for an in nite system is excellent.

dier signicantly from the values 1 only when when is comparable to x^{-1} . Therefore in 1D, the product the nalstationary solution, which is sum marized on Fig. 1(b), is polarized and can be understood as being the solution of a discrete one-dimensional electrostatic Poisson equation with peculiar boundary conditions. In fact, it is well known that in 1D the electrostatic potential varies linearly with the distance to the charges. Here, the nontrivial part of the analysis is to compute in a self-consistent m anner the heights of the plateaus. All these pro les are approached algebraically in time, i.e. S_r (1) ' At ¹⁼² (as in the case with only one Sr (t) zealot [4]), with am plitude depending nontrivially of all parameters of the system $A = \mathcal{R}(; ; x)r$. Obviously, because there is a distance x separating the zealot at the origin from the other, the expression for S_r (t) is not sym m etric with respect to the site 0. W e can notice that the expressions (22), (23) and (24) sim plify when the strength of the zealot is in nite (= = 1). In this case, the zealots have a nalm agnetization $S_0(1) =$ $S_x(1) = 1$.

Result (25) tells us that for spins in nitely far away from the zealots, the magnetization evolves as a smooth scaling function of the variable u $\frac{r}{2^{b}t}$. This scaling function di ers from zero (the initial condition) after a long time (i.e. t r^{2} ! 1), when the variable u has a nite value. It follows from Eqs.(23),(24) and (25) that in 1D the e ect of the zealots is felt and propagates as $t^{1=2}$! 1. For large time and distance, when 1 t r^{2} , we see from Eq.(25) that $S_{r}(t)$ is still close to its initial value. When t r^{2} , all the agents approach as t $^{1=2}$ the active and uctuating stationary magnetization (23). From Eqs. (22) and (18), we can infer the long-time behavior of the global magnetization in the system . As $(1 S_{0}(t))$ $(1 + S_{k}(t))' \frac{2()}{t}$

when \notin , the average number of voters following the strongest zealot evolves (at long-time) as the square-root of time: M (t) ' $\frac{4(\)}{++\ x}$ $\frac{1}{t}$. This result in plies that the time T necessary for the strongest zealot to dom inate (on average) the whole 1D system scales as T L^2 , where L ! 1. When = , the system is exactly symmmetric with respect to x=2, and in average there are as many +1 spins than 1 ones in the whole system.

On Fig. 2 we show the stationary magnetization S_r (1)on a nite lattice with L = 1024 for two competing zealots obtained from M onte Carlo simulations. For sim ulating the model we use random sequential dynamics by picking random ly an \active" site (either one of the zealots or a site that has at least one nearest neighbor in a di erent state) and ipping it with a rate given by Eq. (1). The time after an attempt for a ip is updated with the amount $1=N_a$, where N_a is the number of active sites before the current update. To account for the fact that the simulations are on a nite lattice, where the spin at the left (right) boundary site has only one nearest neighbor on the right (left), the spin- ip rate at the boundaries is modi ed such that it depends only on the state of a single neighbor. The rst 2 10° M onte Carlo steps (MCS) are discarded and typically we sample the con gurations on the lattice every 5000 M C S for the next 10^9 M C S. The stationary distribution for S_r (1) ob-5 tained from the simulations is in an excellent agreem ent with the theoretical values obtained for a in nite lattice and sketched on Fig. 1(b).




FIG. 3: Coarsening on the one-dimensional model with two competing zealots. The gure shows the average number of interfaces vs. time, the average magnetization of the two zealots (see the text) S_0 (t) and S_x (t), and also S_0 (t) S_0 (1) S_0 (t) and S_x (t) S_x (1) S_x (1) S_x (1) S_x (1) S_x (1) S_x (1). The simulation is on L = 8192 lattice for = 0.5, = 0.2 and x = 3000 and the continuous lines shown have a slope 0.5, as predicted by Eq. (22). For this choice of the parameters, the average number of interfaces decays algebraically toward a small but nite value (here, 2:0 10^4).

Fig. 3 shows the result from M onte Carlo simulations on a relatively sm all (L = 8192) lattice for various average quantities. The long time behavior of the local magnetization S_0 (t) S_0 (1) S_0 (t) and S_x (t) S_x (1) S_x (t) clearly show the t ¹⁼² long time behavior, in agreem ent with Eq.(22). In Fig. 3 we also report num erical results for the average num ber of interfaces (i.e. two neighboring sites with di erent spins) vs. tim e. This quantity gives us a good qualitative and quantitative picture of the coarsening of the system . Fig. 3 shows that the average value of the interfaces, which equals to the num ber of the clusters of +1 and 1 spins, evolves as t ¹⁼² before saturating at a sm all non-zero value. O ne can notice that for a long time the system evolves and coarsens as in the hom ogeneous voter m odel [6], but due to the presence of the two competing zealots, subtleties appear at long tim es. In fact, one has to distinguish between the three possible situations for the coarsening: (i) when we have n < 2 (i.e. none or only one zealot on the lattice), there is the usual coarsening (an in nite dom ain spans the entire system) [6]; (ii) when 2 n and the density (n=L) of the competing inhom ogeneities is zero for L! 1, there is still coarsening in the sense that the size of the di erent dom ains form ed increases with the size of the lattice but never spans the entire lattice; (iii) when the density of the competing zealots has a non-zero value in the therm odynam ic lim it, there is no longer coarsening as the form ation of large dom ains is prevented by

the interaction with the num erous (competing) inhom ogeneities.

After having discussed in detail the case n = 2, we would like to point out that in one spatial dimension it is possible to compute the stationary magnetization for an arbitrary number n of zealots in a more direct and intuitive fashion than relying on Eq.(16). In fact, let us consider that the zealots, labeled by j = 1; ...; n are at sites $1 < a_1 < a_2 <$ $_{n}$ << al . 


FIG.4: An example for num erical simulation of the case with 4 zealots on a L = 1024 lattice (see the text). The bias of the zealots from left to right is 0.01 (negative), 0.02 (positive), 0.013 (negative) and 0.003 (positive).

A s an example, let us consider the case where there are four zealots on the chain, as illustrated in Fig. 4. This gure shows that the one-dim ensional stationary magnetization pro le is a piecewise function, as predicted by Eqs.(31)-(33). W hen n = 4, as in Fig. 4, Eqs. (27) explicitly read :

The set of Eqs.(34) can be solved explicitly and gives rise to very cum bersom e expressions. P lugging into the latter the values corresponding to the system simulated in Fig. 4, i.e. $_1 = 0.01; _1 = 1, _2 = 0.02; _2 = +1,$ $_{3} = 0.013; _{3} = 1$ and $_{4} = 0.003; _{4} = +1$, and $x_1 = 230; x_2 = 240; x_3 = 130$, we obtain: $S_{a^1}(1) =$ $0:529; S_{a^2}(1) = +0:556; S_{a^3}(1) = 0:441; S_{a^4}(1) =$

0:0367. These values can be compared to the results of the simulations, reported in Fig. 4, where we obtained $S_{a^1}(1) = 0.53 \quad 0.01; S_2(1) = +0.55$ $0:01;S_{a^3}(1) = 0:45 \quad 0:01;S_4(1) =$ 0:04 0:005. These comparisons show that there is an excellent agreem ent between the theoretical values predicted by the solution (30) of the system (34) and the num erical results. This agreem ent is som ewhat surprising as the simulations reported in Fig. 4 have been carried on a relatively sm all system (L = 1024), whereas all the theoretical results (27)-(34) have been derived in the therm odynam ic lim it. This fact indicates that our analytic results m ay be quantitatively accurate even for large, but non-in nite, system s. In the lim it where the strength of the zealots

is $_1 = _n = 1$, all the expressions simplify and it follows from (27) that $S_{a^{j}}(1) = j$, while, for a^{j} r \dot{a}^{i+1} , $S_{r}(1) = \frac{1}{j} + \frac{j+1}{a^{j+1}} \frac{j}{a^{j}}$ (r a_{j}). When n=1, this 1D system can be related to 1 = the one-dimensional spin model with G lauber dynamics (at zero-tem perature) in the presence of quenched random elds of in nite strength [18]: in the voter language, the situation considered by the authors of Ref. [18] would correspond to the case where at each site j a \voter" would have a probability p to be a zealot favoring the opinion j = 1 with strength j = 1 and would have a probability 1 2p to be an ordinary agent. The (slight) di erence between such a model and the one studied in Ref.[18] is the fact that each zealot (even when he is endowed with an in nite strength) can be \forced" to ip by his two neighbors, while in Ref.[18] the (random) m agnetic elds pin the spins along their direction. How ever, as i = 1, each zealot j rapidly ips back to his preferable opinion i and thus both models are very close and display the sam e stationary m agnetization.

W e also would like to emphasize that the results (27), (30) provide the exact magnetization of the completely disordered one-dim ensional voter-m odel, where each site is endowed with a specic spin-ip rate. In this case, one would have n = L ! 1 zealots in the system with $x_j = a^{j+1}$ $a^j = 1$, and the structure of the matrix P is rather simple [see Eq.(28)].

B. Results in 2D

In two dimensions, the integral of Eq.(4) is also divergent in the long-time regimes! 0 and therefore itsm ain contribution arises from $q^2 = q^2 + q_2^2 + q_3^2$. In this sense, we rst expand Eq.(4) for sm alls in the case when r = 0:

(36), we obtain the stationary magnetization of the zealots: S_0 (1) ' $\frac{+-\ln x}{++-\ln x}$ and S_x (1) ' $-\frac{\ln x}{+ + - \ln x}$. Interestingly these expressions resemble to the ones obtained in 1D [see Eqs (23), (24)]. The only change is in the dependence on separating distance: W ith respect to the 1D case, one has




FIG. 5: Sketch of the typical 2D spatial dependence of the stationary magnetization when L ! 1 . At the origin, indicated by a dot, is the zealot favoring the state +1 with a strength = 1. At a distance x 1, indicated by a square, is the zealot favoring the state 1 with a strength ' 0.9. A coording to Eq. (37), the agents within the disk of center c' 2x and of radius R' 1:4x have a negative nalmagnetization (denoted simply S_r in the gure). Outside the disk, the nalmagnetization of the agents is positive (see the text), while on the circle the agents are in a \neutral" nal state. The static magnetization S_r (1) exhibits both radial and polar dependence.

These results show that, because of the competition between the two zealots, the stationary m agnetization is a uctuating steady state exhibiting nontrivial radial and polar dependence. Also, when = = 1, Eq.(37) reduces to $S_r(1)$ r 1; jr x j 1 $\frac{\ln \frac{jr \times j}{r}}{\ln x + (-\ln 2)}$ and $S_0(1) = S_x(1) = 1$.

Regarding the dynamical behavior, in the regime where t $\max(jr \times j;r^2)$, the long-time behavior of the magnetization is the following:

For t 2[(r^2 . ln t + + -- fln x+ (ln 2)g these results tell us that the 2D system evolves logarithm ically slow ly toward a space-dependent uctuating steady state. As in the presence of only one zealot, we can see that in 2D the magnetization does not exhibit a scaling expression between r and twhen r^2 t 1 [4]. This is due to the logarithm ic term s, speci c to the twodim ensional situation, appearing in (35) and (36). Natural questions arise regarding the spatial distribution of \opinions": W hat is the spatial voting distribution in the steady-state? W hich region is characterized by a majority of positive/negative opinion ? How does the strength of and a ect the nalspatial opinion distribution?

To answer these questions, we use Eq.(37) and notice that in the limit r 1 and \dot{r} x j 1, the spatial

This result, together with (37) and (40), in plies that in 2D, for ϵ , the agents bcated on the circle C (c;R) are \neutral" they have zero nal magnetization as illustrated in Fig. 5. From (37) and (40) we can also conclude that:

If > 1, i.e. > , the agents that are within (outside) the disk IntC (c;R) have a positive (negative) m agnetization.

If < 1, i.e. < , the agents that are within




FIG. 6: The stationary site magnetization S_r (1) on a (128 128) lattice in the presence of six zealots. Three of the zealots favor the +1 state and other three the 1 opinion. The picture on the left shows a 3D plot of S_r (1) (along the vertical axis) and the picture on the right is the corresponding contour plot. The strengths of the positive zealots are 2:0;12;0:8 and the strengths of the negative ones are 1:6;1:4;1:0.

(outside) the disk IntC(c;R) have a negative (positive) m agnetization. This case is sketched in Figure 2.

These results show that the majority of the voters, except the ones enclosed in the disk, tend to follow the opinion favored by the strongest zealot. The details of the neutral region C (c;R) depend nontrivially on all the parameters ; and x and, interestingly, the radius grow s with the di erence of the strength of the zealots as R / 1= sinhu, where u 1 ¹. Also, R increases linearly with the separating distance x.

The case = (including = = 1), i.e. = 1, is special. In this situation, it follows from (40) that the region with zero-nalm agnetization is no longer a closed curve but an in nite line given by the equation $r = \frac{x}{2\cos}$ which separates the two-dimensional space into two sem in nite halfplanes.

For the num ber of zealots n > 2 the analytical calculations becom e very tedious and we illustrate the results of a M onte C arlo simulation of the case with six zealots on Fig. 6. The simulation is carried on a (128 128) lattice and due to the $1 = \ln(t)$ approach to the steady state enormous sam pling times are required. Again when simulating the system one has to be carefulw ith the sites on the boundaries: if the site lies on the edges then it has only three nearest neighbors; and if it is at the corners, then it has only two nearest neighbors. The stochastic rules have to be slightly modi ed to account for the boundary sites. The geometry of the zealots can be seen from contour plot on Fig. 6 where three of the zealots are positively biased and three are biased negatively. The left picture on Fig. 6 shows the average magnetization S_r (1) on the di erent sites of the lattice. For these particular values of the bias of the zealots and their position on the lattice, in the stationary state, we observe one large region of positive on average opinion (a curved central \stripe" in Fig. 6) and two smaller disconnected regions of a negative opinion (near the left boundary and top right edge

ofFig.6).

Regarding the coarsening of the 2D system, we again distinguish three situations: (i) when n < 2, there is usual coarsening and an in nite dom ain eventually spans the entire system; (ii) when there is a nite number of competing zealots large dom ains still develop but their size is limited by the zealots; (iii) when the density of the competing zealots is nite in the therm odynam ic limit, there is no longer coarsening as the form ation of large dom ains is prevented by the interaction with the num erous inhom ogeneities.

To conclude this section, as in 1D, we notice that (1 $S_0(1)$) = (1+ $S_x(1)$) which im plies, with Eq.(18), that the globalm agnetization evolves, following the strongest zealot (\notin), as M (t) t= lnt. As a consequence, the time T necessary for the strongest zealot to dom inate (on average) the whole 2D system is T $L^2 \ln L$ (where L ! 1). In the symmetric case (=), as explained above, the 2D space is exactly separated in two sem in nite halfplanes with opposite totalm agnetization.

C. Results in 3D

Above two dimensions, the integrals in Eq. (4) are well de ned for all values of s and in particular when s! 0. Therefore, in contrast to what happens in 1D and 2D, to determ ine the long-time behavior of the magnetization we cannot simply focus on the q! 0 expansion of (4). This also means that in dimensions d 3 in the presence of n zealots the static magnetization readily follows from from Eq.(16):

From now on, for the sake of concreteness, we focus on the case where we have two competing zealots, $_1 = _2 = 1$, and thus the expression (43) becomes $S_r(1) = \frac{\hat{f}_r(0) - \hat{f}_r(0) + (\hat{f}_r(0) - \hat{f}_r(0))(\hat{f}_0(0) + \hat{f}_r(0))}{1 + (+)\hat{f}_0(0) + (\hat{f}_0^2(0) - \hat{f}_r^2(0))}$. As we are mainly interested in the large r limit, one can observe that $\hat{f}_r(0)$ is just the static solution of the Poisson equation $_r\hat{f}_r(0) = _{r;0}$, which solution in the continuum limit is $\hat{f}_r(0) - \hat{f}(r) = \frac{1}{4r}$ (r > 0). This result, obtained from an velectrostatic reform ulation", is valid on the discrete lattice for r = 1 [31]. With the help of (43), this result allows to compute the 3D stationary localm agnetization for r = 1 and jr = xj = 1:

Again, the resem – blance with electrostatics is striking: the static magnetization is form ally the electrostatic potential generated by the \charges" C_1 at site 0 and C_2 at x. As already noticed, the di culty resides in the fact that the charges C1 and C2 are a priori unknown and have been computed in a self-consistent way (assuming a large enough separating distance x), with the help of the exact and discrete results (42), (43) [32]. Even though the result (44) is formally valid for r = x = 1, as explained above, it gives 1 and x is nite already accurate predictions when r but large enough (e.g. already when x = 6). It is suggestive that in the lim it where = = 1, the \charges" $C_2 = G_1 = 2 = g_0$. In this case the magnetization in Eq. (44) can be viewed as the potential of the electric dipole of charges 2=g. To make the connection with electrostatics even m ore transparent, it is worthwhile to notice that the expression (44) can be rew ritten using a multipole expansion. Also, when = 0, we recover $S_r(1)$ / 1=r, as reported in Ref. [4]. In fact, one has \dot{r} x j¹= (r² + x² 2r:x) ¹⁼² = $\frac{1}{r}^{P} \frac{1}{m} \frac{x}{m} P_{m}$ (∞ s), where $\infty \frac{x:r}{xr}$ and the P_{m} (∞ s) are the Legendre polynom ials. At this point it is important to mention a major di erence with the case where only a single zealot is present. In the latter situation, as showed in Ref.[4], just by taking the continuum limit of the equation for the magnetization, one could anticipate that $S_r(1) / r^{-1}$ (i.e it has only radial dependence) in three dimensions, which is the main desired information. In the two-zealot case, as there is a competition between the elects of the \charges" C₁ and C₂, we really need to determ ine S_r(1) through Eqs. (42),(43), to obtain the nontrivial spatial dependence of the stationary magnetization through (44), (45).

Regarding the dynam ical approach toward the steady state, it is di cult to study the smalls behavior of \hat{I}_r (s) and to rigorously obtain the long-time approach toward the stationary magnetization. However, it follows from Eq. (17) that:

This result is expected to be accurate in the regimewhere t! 1; r 1 and jr x j 1. A spreviously mentioned, we can can discuss about the regions with positive or negative stationary magnetization. To determ ine the \neutral" region (where $S_r(1) = 0$) it follows from (44) that, in the limit where r 1 and jr x j 1, one has to solve

When ϵ , i.e. for ϵ 1, the equation can again be recast into the following form: $r^2 + \frac{2rx}{2} \cos \frac{x^2}{2} = 0$.

Such an expression is the polar equation of a sphere (C ;R) centered at C = $\frac{1}{1-2}x$ with a radius R = $\frac{x}{j1-2}$. From Eq.(44), we can also infer the following:

If > 1, i.e. > , the agents that are within (outside) the sphere (c;R) have a positive (negative) m agnetization.

If < 1, i.e. < , the agents that are within (outside) the sphere (C ;R) have a negative (positive) m agnetization.

These results show that majority of the voters, except the ones enclosed in the sphere (C;R), tends to follow the opinion favored by the strongest zealot. The details of the neutral region (C;R) depend nontrivially on all the parameters; and x. In particular, we notice that R increases linearly with the separating distance x.

The case where = , i.e. = 1, is special because thus the \e ective charges" are such that $f_{1}j = C_{2}$. In particular, this is the case when = = 1. It thus follows from (47) that the region with zero- nalm agnetization is no longer a surface but an in nite plane, given by $r = \frac{x}{2\cos}$, that separates the 3D space into two regions.

In 3D, $(1 S_0 (1)) \in (1 + S_x (1))$ when \in , and thus the global magnetization of the above inhomogeneous voter model evolves linearly with the time: M (t) t. This implies that the time T necessary for the strongest zealot to dom inate (on average) the whole 3D system scales as T L^3 , where L ! 1. On the other hand, when = , the space is divided in two symmetric regions with opposite total magnetization.

Finally, in the case where both zealots favor the same opinion = 1, i.e. $_1 = _2 = _2$, one has just to modify the expressions of \charges" in Eqs (44), (45) and (46). In fact, these results are still valid with $C_1 = \frac{2}{2+g_0}$ and $C_2 = \frac{2}{2+g_0}$.

V. MONOM ER MONOM ER CATALYTIC REACTION ON AN INHOMOGENEOUS SUBSTRATE

The other m odel that we speci cally consider in this work is the m onom er-m onom er catalytic reaction. Such a process is of considerable interest in m any elds of science and the technology. In the catalysis the rate of a chem – ical reaction is enhanced by the presence of a suitable catalytic m aterial, such as the platinum used to catalyze the oxidation of carbon m onoxide $(2CO + O_2 ! 2CO_2)$ [19, 23]. Because of the num erous and practical im plications of the catalytic reaction, it is of prime interest to be able to m odel its quantitative and qualitative behavior. In general, these processes are described within m ean-

eld like approaches where it is assumed that molecules are random ly distributed on the substrate [19, 23]. Spatial uctuations and excluded volume constraints are thus ignored, despite of the fact that these e ects are shown to play often a crucial rôle [24]. In the modeling of catalysis [23], the monomermonomer surface reaction model plays an important part at least from a theoretical point of view because the sim – plicity of the model allows to address several issues analytically, such as the rôle of the uctuations [5, 24], the interfacial roughening [25], and the di usion of the adsorbents [26].

The monomermonomercatalytic process on an homogeneous substrate is by now well understood and it com prises the following reactions [5, 6]:

The A and B particles impinge upon a substrate with rates k_A and k_B , respectively, adsorb onto vacant sites (;) and form a monolayers of adsorbed particles, A $_{\rm S}$ and B_S. Nearest-neighbor pairs of di erent adsorbed particles, $A_S B_S$, react and desorb with rate k_r , leaving two vacant sites (2;) on the substrate. The dynam ics on a spatially hom ogeneous substrate is most interesting in dim ensions d 2, when $k_{\rm A} = k_{\rm B}$ (otherwise the species with the bigger rate will rapidly saturate the substrate). In this case there is coarsening on the substrate induced by uctuations and islands of A_s and B_s particles grow. As in Refs. [5, 6], we will consider the reaction-controlled $k_{\rm A} = k_{\rm B}$. This lim it turns out to be limit, where k_r useful from a technical point of view and, most importantly, provides qualitatively the same kind of behavior as the general case [5, 6, 24]. In the reaction-controlled lim it, the substrate quickly becomes fully occupied and stays covered with A $_{\rm S}$'s and B $_{\rm S}$'s for ever (vacancies are im mediately re lled). The kinetics of monomer-monomer substrate reaction m odel is therefore a two-state system that can be m apped onto the voter m odel supplem ented by an in nite-tem perature Kawasaki exchange process [5, 6]. In fact, in the monom er-monom er catalytic reaction under consideration, A_s and B_s desorb and the resulting empty sites are instantaneously re lled either by $A_S B_S$ (no reaction), $A_S A_S$; $B_S B_S$ (voter dynamics), or by B_SA_S (Kawasaki exchange dynamics at in nite tem perature).

C learly, more realistic situations should include the presence of inhom ogeneities which could deeply a ect the properties of the system. In fact, real substrates (in 1D and 2D) display generally some degrees of spatial heterogeneity which are attributed to imperfections, such as dislocations and defects [27] that modify locally the interactions on the substrate. In some previous works translationally-invariant disordered models for catalysis have been considered within mean-eld like approaches, i.e. rate equations and pair approximation [28]. In these works, it was shown that quenched substrate imperfections dramatically a ect the dynamics resulting in a reactive steady-state. One should emphasize that both the physical systems (in this work, the inhom ogeneities are not random ly distributed but xed) and the analytic m ethods (we obtain exact results in arbitrary dim ensions, while the authors of [28] em ployed m ean- eld-like approaches) considered here di er from , and are thus com plem entary to, those of R ef.[28]. A lso, very recently, an equilibrium m odel for m onom er-m onom er catalysis on a disordered substrate was solved [29].

Hereafter we study the static and dynamical e ects of local inhom ogeneities in the monom er-monom er catalytic reaction-controlled process and show how to take advantage of the results obtained for the inhom ogeneous voter model to infer som e exact properties. In fact, we consider the genuine nonequilibrium situation where the substrate is spatially inhom ogeneous, because of the presence of a collection of n inhom ogeneities located at sites $fa^{j}g; j = 1; \dots; n$ favoring the local adsorption of A's or B's. We show that the inhom ogeneities induce spatially dependent reactive steady-state when n > 1. As a substrate, as described in Section II, we consider an hypercubic lattice with $(2L + 1)^d$ sites and introduce a set of parameters $\frac{0}{1}$ taking the values 0 or 1 and consider, in addition to the usual hom ogeneous catalytic reaction described above, that some inhom ogeneities bcally favor the presence of A via desorption of B's (and vice versa) through the additional reactions B_S ! Α_s, ! B_s , where $\int_{j^0}^{0} = 0$. We therewhere $\frac{0}{1} = 1$, and A_S

fore consider the following hom ogeneous processes (voter + in nite-tem perature K awasaki dynamics), all occurring with the same rates 1=2, and local (inhom ogeneous) reactions at sites a^{j} and $a^{j^{0} \in j}$, occurring respectively with rates $_{j}$ and $_{j^{0}}$:

Here, the bin olecular reactions correspond to the voter dynamics supplemented by Kawasaki in nitetemperature exchange process, whereas monom olecular processes correspond to reactions induced by local inhomogeneities favoring the adsorption of one species. Following the same steps as in Refs [5, 6], for this spatially inhom ogeneous monom errm onom er catalytic process, in the therm odynam ic limit we obtain the following equation of motion for the concentration c_r (t) of A_s at site r of the substrate:

O f course, the concentration of B_s at site r is simply given by 1 G(t). The resemblance of Equation (48) with (3) is striking (the only difference is that here ${}_{j}^{0} = 0;1$) and one can immediately infer the solution of (48) from (15 and (20)). In particular, in the therm odynam ic limit, starting from a system initially completely occupied by B $_{\rm S}$ particles, the Laplace transform of the concentration of A $_{\rm S}$ reads:

Next, we restrain ourself to physical situations and consider in detail the monom errm onom er catalytic reaction in the presence of one and two inhom ogeneities in one and two dimensions.

A. Inhom ogeneous m onom er-m onom er catalytic reaction in the presence of one single \defect"

Here, we consider the case where there is a single inhom ogeneity at site $a^1 = 0$, with strength $_1 =$ and $_1 = 1$. In this case, we simply have N $^1 = \frac{1}{1 + \hat{f}_0(s)}$. Therefore, starting from a system initially fullofB_S particle (i.e. $c_r(0) = 0$) we obtain:

On the right-hand side of this equation, one recognizes in mediately the same expression as the Laplace transform of the magnetization obtained in Ref. [4]. From previous results, we can immediately infer the long-time behavior of the concentration of A_s particles.

1. Results in 1D

Following the same steps as in Ref. [4], on a onedimensional substrate we nd from (52) that the longtime behavior of the concentration of A_s reads:

As in the one-dimensional case, the stationary concentration of $A_{\rm S}$ corresponds again to a substrate fully covered with $A_{\rm S}$ particles, i.e. $c_{\rm r}$ (1) = 1. Therefore, the presence of a single inhom ogeneity favoring locally the adsorption of $A_{\rm S}$ is enough to completely cover the substrate with $A_{\rm S}$ in spite of the fact that initially only $B_{\rm S}$ particles were present. From the expressions (53), (55) and (51), we can also compute the total number of $A_{\rm S}$ particles on the substrate at time t 1. In so doing, one obtains M $^{0}(t)$ t in the one-dimensional case and M $^{0}(t)$ t = lnt in 2D.

B. Inhom ogeneous m onom er-m onom er catalytic reaction in the presence of two defects

Here, we consider the case where two \com peting" inhom ogeneities are present: one is at site $a^1 = 0$, with strength $_1 =$ and $_1 = 1$ and the other at site $a^2 = x$, with strength $_2 =$ and $_2 = 0$.

In this case, using Eqs.(49) and (11), we obtain the following expression for the Laplace transform of the concentration of A_s at site r, starting from $c_r(0) = 0$:

In one dimension, without loss of generality, we assume that the inhom ogeneity at site $a^2 = x, x = jx j$ is on the right side of the origin.

P roceeding as in section IV A, we study the static and long-time behavior of the concentration of A_s with $c_r(0) = 0$, and distinguish various situations:

These results show that in the interval between the of inhom ogeneities, the static concentration pro les varies linearly from the origin with a slope =(++x).Outside from this interval, the static concentration is uniform on the right and left side of the origin: on the right, c_r (1) = $\frac{(1+x)}{++x}$, whereas on the left c_r (1) = + + -x. Such a static pro le can again be interpreted as the solution of a discrete 1D electrostatic Poisson equation with peculiar and suitable boundary conditions. Again, the static concentration is reached according to a t 1=2) and with am plitudes dependpower-law (c_r (t) ing nontrivially on all parameters of the system . At very large distances, and long time, the concentration displays a scaling form which amplitude depends on which inhomogeneity is the closest. Of course, it is easy to check that in the limit ! 0, as the system is initially full of B_s , then $c_r(t) = 0$. Also, when = 0, we recover the expressions (53) and (54). From Eqs (51) and (58) we obtain the average number of adsorbed particles which evolves (at long-time) as M 0 (t) t.

Again, in one dimension we can obtain the stationary concentration of adsorbed A_s particle in the completely disordered case, i.e when n is arbitrary large just by replacing respectively $S_{a^j}(1); S_r(1); j$ by $c_{a^j}(1); c_r(1); j$ in the expressions (27)-(33). As illustrated in Fig.4, in this case the stationary concentration pro le is piecew ise. A lso, when the num ber of competing inhom ogeneities is nite the system coarsens as described in Section IV A.

2. Results in 2D

In two dimensions and at large distance from both inhomogeneities, i.e for r 1 and jr хj 1, we nd a non-scaling expression for both static and timedependent concentration of the A_s particles:

W e can notice that in 2D the stationary concentration

of the A_S particles is a uctuating reactive state exhibiting nontrivial radial and polar dependence. Regarding the approach toward the steady state, proceeding as in the section IV B, we obtain:

where the amplitude $B^{0} = \frac{-\ln x f \ln jr x j}{+ + - [\ln x + (\ln 2)]}$ exhibits a nontrivial spatial dependence. A gain, the result (64) shows that the stationary concentration pro le (63) is reached logarithm ically slow ly. Using Eq. (51) we can also notice that the average number of particles A_S adsorbed on the substrate evolves (at long-time) as M ⁰(t) t=lnt.

There is a practical interest in understanding the spatial distribution of adsorbed particles in the steady state [30] and one can thus ask W hat is the region of the 2D substrate where one can nd more As particles?

To answer this question, from Eq. (63), we proceed as in Section IV B and, according to Eq.(40), we see that when > (>), the region richer in A_s particles is outside (within) the disk IntC (c;R) [de ned in Section IV B], where the concentration of A_s is $c_r (1)$ $(c_r (1) \frac{1}{2})$. When = , the 2D substrate is separated into two half-planes with concentration of $A_s > 1=2$ in the region including the origin.

VI. SUMMARY AND CONCLUSION

In this work we have shown how to compute some exact properties of a class of m any-body stochastic system s in the presence of an arbitrary number of inhom ogeneities n, and have speci cally focused on the voter m odel and m onom er-m onom er catalytic reaction (in the reactioncontrolled limit). We have studied the elects of local perturbations of the dynam ical rules on the static and tim e-dependent properties of these m odels by obtaining both general (yet form al) and many explicit results in the presence of one and two inhom ogeneities. In fact, the latter situation already displays and covers most of the generic features of the models. Namely, when there

is only one inhom ogeneity present, it is responsible for a uniform and \unanim ous" steady state in low dim ensions [4], while in the presence of competing inhom ogeneities (n > 1) the steady state is uctuating and reactive. For the sake of concreteness we have mainly focused on the am enable case with two inhom ogeneities and have shown quantitatively how the local interactions deeply a ect the properties of these system s. Neither the stationary nor the time-dependent expression of the order parameters are translationally-invariant but exhibit nontrivial radial and polar dependence (when d > 1).

From a sociophysical perspective, in the voter model language, this means that a system which tolerates the presence of \com peting zealots", i.e. which accepts the competition between opposite points of view, will never reach a unanimous state but always end into a nal conguration where both opinions coexist and uctuate. Of course, such a conclusion seem s to be consistent with the results of electoral competitions in modern dem ocracies.

In the presence of competing inhomogeneities (n > 1)in low dimensions, subtle coarsening phenomena take place in 1D and 2D. In fact, the local and competing perturbations of the dynam ics lead us to distinguish the case where the number of inhom openeities is nite and the case where their number is comparable to the size of the system . In the form er case the system coarsens and large dom ains develop, but their size are typically lim ited by the num ber of com peting inhom ogeneities, while in the latter case coarsening is prevented by the interaction with all the num erous inhom ogeneities.

M ore speci cally, in this work we have obtained exact, yet form al, expressions of the static and tim e-dependent order parameters (see (15) and (50)). The main technical problem to carry out detailed calculation resides in the inversion of the n n matrix N . The case with one single inhom ogeneity in the voterm odel was already considered in [4] and here we show that such results can be translated in the language of the catalysis reaction. In particular we have shown that on 1D and 2D substrates, the presence of a single spatial inhom ogeneity favoring the adsorption of one species, say A_{S} , with respect to the other is su cient to ensure that eventually the substrate will be completely led with A_S particles. W hen we have two competing inhom ogeneities, favoring locally opposite states or the adsorption of particles of di erent species, we have obtained rich behavior. In 1D, between the two inhom ogeneities, the stationary pro les of the order parameters vary linearly with the distance from the origin (22), (58) and then reaches two plateaus (23), (24) and (59), (60). These static pro les are always reached algebraically in 1D: S_r (t) S_r (1) 'At $^{1=2}$ and c_r (t) c_r (1) ' A⁰t ¹⁼², where the amplitudes A and A⁰ depend nontrivially on all parameters of the problem and in particular on the separating distance between the inhom ogeneities [see Eqs (23), (24) and (59), (60)]. Far away from the inhom ogeneities, the order parameters display scaling expression of the variable r=t (see (25) and (61), (62)]. In one dimension, we have also been able to

com pute the expression of the stationary m agnetization in the completely disordered situation where the number of zealots is arbitrary large [see Eqs. (27)-(33)]. In two dimensions, for n = 2, in the presence of two competing inhom ogeneities, we have obtained non-uniform and nontrivial stationary pro les for the order param eters, in agreem ent with an electrostatic-like reform ulation, the latter display logarithm ic spatial dependence (radial and polar) [(37) and (63)]. The approach toward the reactive $S_r(1)$ / B = lnt andsteady state is very slow: S_r (t) $c(1)' B^0 = \ln t$, with amplitudes B and B⁰ dec_r (t) pending again nontrivially on all param eters of the problem [see (39) and (64)]. In 2D, for the inhom ogeneous voterm odel, we have also studied the spatial regions with positive/negative static magnetization and have shown that only within a circle, whose center and radius depend on the strength of the \zealots" and on the distance between the latter, the sign of the magnetization is the one favorite by the \weakest" zealot. W hen both zealots have the same strength, there is positive/negative m agnetization in half-space. In three dimensions, for n = 2and in the continuum lim it, we have shown that the stationary m agnetization of the inhom ogeneous voterm odel displays a radial and polar dependence that can be recast into a multipole expansion (44), corresponding form ally to the electrostatic potential generated by two \charges" that are determ ined self-consistently using exact results from the discrete lattice system. The connection with electrostatics is particularly striking in the lim it where both zealots have an in nite strength, thus the stationary m agnetization corresponds to the potential of an electric dipole. The approach toward the static magnetization follows a power-law: S_r (t) S_r (1) 'Ct ¹⁼² (see (46)). A lso, in 3D we have studied the spatial regions with positive/negative magnetization and have shown that outside from a sphere whose center and radius depend on the parameters of the system and varies linearly with the distance separating the zealots, the sign of the nal m agnetization is the one favored by the strongest zealot.

The results obtained from M onte C arlo simulations of one and two-dimensional lattices show excellent agreement with the theoretical results obtained for an in nite system. In the presence of multiple (n > 2) competing inhom ogeneities the calculations in two dimensions become very tedious and we consider this case by num eri-

calsimulations which con m the extremely slow dynam ics and the existence of nontrivial spatial dependence of the order param eters. We also would like to point out one intriguing and interesting fact about the sm all time behavior of the magnetization of the zealots in the onedimensional case. As it can be extracted from Fig. 3, S_0 (t) and S_x (t), for small t, evolve as a power law with an exponent num erically sm aller than 0:50. The sm all time behavior of the site magnetization of the usual onedim ensional voter m odel (no inhom ogeneities) is linear, ie. Sr (t) $S_r(0)$ / t for any site r on the lattice. W e think it would be interesting to investigate further this \anom alous" sm allt behavior of the m agnetizations of the zealots in the one and the two-dimensional cases and we plan to do it in our future work. Various generalizations of this work could also be investigated. For instance, it would be worthwhile to consider that the inhom ogeneities would not be xed but spatially distributed according to some function P (fa^jg). In this case, one should also average on the quenched disorder (on the samples) and one would have to compute: $f_{a^{j}g}P$ (fa^{j}g)S_r (fa^{j}g;t), where S_r (fa^{j}g;t) is S_r(t) / the quantity studied in this work for a given set of inhom ogeneities at sites fa jg. In the sam e m anner, it would be quite interesting to consider the disordered case where the strength of the inhom ogeneities yould follow a distribution function such as $\mathbb{P}(f_jg) / \bigcap_{j=1}^n e^{(j_j-j)^2} = 2$. In this case, one would be interested in the quan-² jd j ^p (f jg)S_r (fa^jg;f ^jg;t), where tity: \mathfrak{S}_r (t) = S_r (fa^jg; f^jg; t) is the magnetization computed in this work for a given set of inhom ogeneities at sites fa^jg, with strength f ^jg.
