# A nalytic calculation of energy transfer and heat ux in a one-dim ensional system

#### Abstract

In the context of the problem of heat conduction in one-dim ensional system s , we present an analytical calculation of the instantaneous energy transfer across a tagged particle in a one-dim ensional gas of equalm ass, hard-point particles. From this, we obtain a form ula for the steady-state energy ux, and identify and separate the $m$ echanical work and heat conduction contributions to it. The nature of the Fourier law for the $m$ odel, and the nonlinear dependence of the rate of $m$ echanical work on the stationary drift velocity of the tagged particle, are analyzed and elucidated.

## I. IN TRODUCTION

H eat conduction in one-dim ensionalsystem s has evoked a considerable am ount ofinterest in recent years. In particular, the validity or otherw ise of the Fourier law of heat conduction in such system $s$ is a non-trivial question, and hence one that has been the sub ject of lively discussion $[\underline{1}-1]$. A com prehensive account of the current status of the problem is provided in Ref. [|=1-1.

M ost of the results know $n$ in this regard are based on num erical studies of lattioe m odels. A $n$ altemative and useful line of developm ent is the analytical study of a m odel system, albeit a sim pli ed one, which we call the Jepsen gas: a system of N identical classical point-particles of $m$ ass $m \mathrm{~m}$ oving on a line and undergoing perfectly elastic collisions when neighboring particles $m$ eet[3]-1]. This system is a special case of the $m$ ore general $m$ odel investigated in the context of the so-called adiabatic piston problem [依] in whidh a central heavy particle of $m$ ass $M$ is in a gas of particles of $m$ ass $m$ on its left and right. The problem then is to analyze the dynam ics of the centralparticle in the therm odynam ic lim it in which the one-dim ensionalgases to its left and right are in therm alequilibrium at speci ed tem peratures and densities. T he Jepsen gas is a singular lim iting case of the unequalm ass situation. The latter is not integrable, in $m$ arked contrast to the case $M=m$, which is integrable. N otw ithstanding this sim pli cation, non-trivial irreversible behavior is observed in the Jepsen gas in the lim it N ! 1 when appropriate averages over initial conditions are perform ed. In the in itial studies of this system [ix, the statistics of the displacem ent and velocity of one of the particles, which we shall refer to as the central or tagged particle (or \piston", as it is the counterpart of the adiabatic piston in the $m$ odel at hand), have been calculated exactly by perform ing an average over equilibrium intial conditions for the rest of the particles. In particular, it can be show $n$ that the $m$ otion of this tagged particle becom es di usive asym ptotically, i.e., converges to B row nian m otion.
 tivating factors being its relationship to the adiabatic piston problem. T he non-equilibrium situation im plied by di erent velocity distributions for the gases to the left and right of the tagged particle has been analyzed. In general, this particle acquires, in the therm odynam ic lim it, a system atic drift velocity over and above its di usive m otion. A notable feature is
that this drift velocity is exclusively uctuation-inducedi[6]. In the special case when the velocity distributions of the gases on the two sides are M axwellian, so that the pressure of each gas can be identi ed w ith $k_{B}$ times the product of its (linear) number density and tem perature, an interesting feature em erges: even when the pressures of the two gases are equal, the drift velocity of the tagged particle does not vanish. R ather, it is directed from the low er tem perature (higher density) side to the higher tem perature (low er density) side. T he drift velocity vanishes w hen the product of the num ber density and the square root of the tem perature is the sam e on the two sides of the tagged particle, a condition already recognized in R ef. $\left.{ }_{\underline{1}+1}^{-1}\right]$.

In the context of heat conduction in one dim ension, the question that arises naturally is whether the heat ux can be calculated for the Jepsen gas. W e show in this paper that this problem can be solved analytically: it is possible to calculate exactly the am ount of energy that is transfered through the tagged particle or piston. At rst, it w ould appear that the issue is a trivial one in the sam e way as it is in a linear chain of harm onic oscillators. In the latter system, the energy just travels ballistically, being carried by phonon m odes which do not interact w ith each other. In a sim ilar fashion, the kinetic energy carried by any particle in the Jepsen gas is just transfered upon collision to the next particle, and hence m oves ballistically along the line. As a result, a Fourier law, which predicts the di usive spreading of therm al energy, does not appear to be valid. We will show by an exact and explicit calculation that this \hand-w aving" argum ent, while form ally correct, is nevertheless m isleading in the sense that a non-trivial energy ux obtains in the m odel. A closed expression can be derived for this quantity, com prising two com ponents. O ne of these involves the asym ptotic drift velocity of the tagged particle, while the other is present even when the drift velocity vanishes. This perm its the identi cation, and hence a natural separation, of the \m echanical work" and \heat" contributions, respectively, to the energy transfer. In particular, for initial conditions corresponding to therm al equilibrium of the gases to the left and right of the tagged particle ( w ith densities n and $\mathrm{n}^{+}$and tem peratures $T$ and $T^{+}$, respectively) such that $n \quad \mathrm{P} \bar{T}=n^{+}{ }^{P} \overline{T^{+}}$, so that the drift velocity is zero, the asym ptotic steady-state energy ux through the tagged particle is shown to converge to a constant value. For sm all values of ( $\mathrm{T}^{+} \mathrm{T}$ ); this quantity is linearly proportional to the tem perature di erence itself, which can be intenpreted as a m anifestation of the Fourier law . M oreover, the $\backslash m$ echanical work" contribution itself is shown to have a part that is linear
in the drift velocity, as $m$ ight be expected, as well as a nonlinear part that starts (for sm all drift velocities) w ith the fourth power of the drift velocity.

W e reiterate the follow ing point. The Jepsen gas is adm ittedly a sim pli ed special case of the $m$ ore \realistic" $m$ odels of one-dim ensional transport that have been the sub ject of $m$ uch attention. N evertheless, it is the fact that analytical (and hence unam biguous) results can be obtained for this m odel that $m$ akes it worth studying, because these results help shed light on several of the essential issues involved in energy transport in one dim ension.

The plan of the rest of this paper is as follows. In the next section, we introduce the notation and sum $m$ arize the salient results pertaining to the Jepsen gas for the purpose at hand. In Sec. 位 (and the A ppendix), an exact form ula is derived for the energy transfer across the piston at any instant of tim $e$. This leads to a form ula for the totalenergy $u x$ in
 to the energy ux com ing from the stationary heat $u x$ is identi ed, and the nature of the Fourier law for the $m$ odel is clari ed. The rate ofm echanical work is also deduced, and its nonlinear dependence on the stationary drift velocity elucidated. Section ī京 contains a few conchuding rem arks.

## II. NOTATION AND RECAPITULATION

It is helpfulto recapinulate in brief the relevant features of the $m$ odel, in the notation used
 $\mathrm{V}_{0}$, separates a gas ofN particles in the interval $\left[\mathrm{L} ; 0\right.$ ) on its left from a gas ofN ${ }^{+}$particles to its right, in $(0 ; L]$. Their initialpositions $X_{j}$ (where $N \quad j \quad 1$ for the gas on the left, and $1 \quad j \mathrm{~N}^{+}$for the gas on the right) are independently and uniform ly distributed in the corresponding intervals. Their initial velocities $\mathrm{V}_{j}$ are drawn from norm alized distributions
(V) and ${ }^{+}$(V ), respectively. To avoid unnecessary com plications, we shall assum e that these are sym m etric distributions, i.e., $\quad(\mathrm{V})=(\mathrm{V})$. It can be shown that the system has a therm odynam ic lim it in which $\mathrm{N}^{+}!1, \mathrm{~L}!1$ with nite densities $\lim \mathrm{N}=\mathrm{L}=\mathrm{n}$, provided only that the $m$ ean speeds $h j \underset{j}{ }={ }_{1}$ dV V (V) are nite. N ote that need not be $M$ axw ellian distributions, although this is the case of direct interest in the present context of heat conduction. A s all the particles (including the tagged particle) have equal $m$ asses, they $m$ erely exchange their identities on their original linear trajectories $X_{j}$ ( $t$ )
$X_{j}+V_{j} t$ in each collision. This is what enables one to derive exact results for the system . Am ong other quantities, the exact one-particle distribution function of the tagged particle, $P\left(X ; V ; t-j ; V_{0}\right)$, can be found. The com plicated stochastic $m$ otion of the tagged particle (henceforth term ed the \piston") can be interpreted $\left[\underline{1}{ }_{1}\right]$ as being driven by two independent P oisson processes (corresponding to collisions from its left and right, respectively) w ith stateand tim e-dependent intensities $n \quad(X=t)$ and $n^{+} \quad(X=t)$, where

The system does not equilibrate in the conventional sense of the term : the initial set of trajectories persists for all $t$. The piston acquires an asym ptotic $m$ ean drift velocity $\bar{W}$ given by the unique solution of the im plicit equation [ब्-1]

The asym ptotic velocity distribution of the piston is a superposition of ${ }^{+}(V)$ and $(V)$, and is given by

is the norm alization factor. O nly in the special case of the hom ogeneous system, de ned by $\mathrm{n}=\mathrm{n}^{+}=\mathrm{n}$ and ${ }^{+}(\mathrm{V})=(\mathrm{V})=(\mathrm{V})$, can one have stationarity and an approach to equilibrium, in the sense that $\overline{\mathrm{W}}=0$ and $\mathrm{P}_{\text {st }}(\mathrm{V}) \quad(\mathrm{V})$. N ote that $\overline{\mathrm{W}} \mathrm{m}$ ay vanish even in the inhom ogeneous system, if the condition $n \quad \begin{gathered}R_{1} \\ 0\end{gathered} d V V \quad(V)=n^{+}{ }_{0}^{R_{1}} d V V{ }^{+}(V)$ (or $n h j \neq \ddot{j}=n^{+} h j \ddot{j}^{+}$) happens to be satis ed: that is, the $m$ ean rates at which the piston su ers collisions from its left and right, respectively, are equal.

W epoint out at this juncture that the stationary distribution $P_{\text {st }}(V)$ in $E q$. ( $\left.\bar{\sim}\right) \mathrm{m}$ ay in fact be anticipated on physical grounds, as follow s. In the equalm ass case under consideration, wem ay regard the particles as sim ply \passing through" each other in each collision, because they are identical particles. In the stationary state, after the $m$ em ory of the initial velocity of the piston has been lost, it will only encounter such particles via collisions from its left, as have velocities greater than its asym ptotic $m$ ean drift velocity $W$, whatever that be
(tra jectories corresponding to $V<W$ from the gas on the left $w$ ill never again intersect the piston's tra jectory). Sim ilarly, the piston will encounter only those particles from the gas on its right as have velocities less than W . M oreover, after each collision, the piston sim ply acquires the velocity of the particle it collided with. H ence the stationary velocity distribution m ust necessarily be a superposition of the form

apart from a norm alization factor. The latter is easily seen to be just $1=(\mathbb{W})$ where the function is as given by Eq. (- ${ }^{(\overline{4}) \text {. Taking the rst } m \text { om ent of this equation, we nd that }}$ consistency dem ands that $W$ satisfy precisely the sam e im plicit equation (Eq. (2̄)) as that w ritten down above for the drift velocity $\bar{W}$. In other words, not only is the form in Eq. ( $\overline{\mathrm{B}}$ ) for $\mathrm{P}_{\text {st }}$ (V) deducible on direct physical grounds, but also the existence of an asym ptotic drift velocity $\overline{\mathrm{W}}$ and the im plicit equation satis ed by it.

## III. EXACT EXPRESSION FOR ENERGY TRANSFER

To derive of an exact form ula for the rate of transport of energy across the piston, we rst calculate the di erence $E(t)$ betw een the $m$ ean energy $E(t)$ of the gas on the left of the piston at time $t$ and its in itial value E ( 0 ) .

IV. FORMULA FOR THE STATIONARY ENERGYFLUX

To nd the asym ptotic or steady-state rate of transpont of energy across the piston, we pass to the long-time lim it of the expression for $E(t)$. U sing the asym ptotic behavior $I_{r}(z) \quad e^{z}=(2 \mathrm{z})^{1=2}$ as $\dot{\mathrm{k}} \mathrm{j}^{\prime}$ ! 1 , it is evident from Eq. ( $\left.\bar{A} \overline{\mathrm{~B}}_{1}^{\prime}\right)$ that $\mathrm{E}^{0}(\mathrm{t})$ decays exponentially to zero ast! 1 , unless it so happens that $n \quad(0)=n^{+} \quad(0)$, i.e., the asym ptotic drift velocity of the piston is zero. In that case $E^{0}(t) \quad t^{1=2}$ at long tim es; but this again im plies a rate of transport that vanishes (like $t^{1=2}$ ) ast! 1 . Therefore $E^{0}(t) m$ ay be dropped from further consideration.

Tuming to Eqs. $\left(A_{-}^{-} \overline{-} \bar{\prime}\right)$ and $\left(\overline{A^{-}} \overline{1}^{-1}\right)$ for $E(t)$ and $E^{+}(t)$, we observe that the asym ptotic behavior of the modi ed $\mathrm{i}_{2}$ Bessel functions leads to the occurrence of a factor $\exp \quad t^{h} n(w)^{1=2} n^{+}(w)^{1=2^{1_{2}}}$ in the integration over $w$ (which runs from 1 to +1 ). Since the exponent has a unique zero at precisely the asym ptotic drift velocity $\bar{W}$ as de ned in Eq. '(T), the long-tim e behavior of $E(t)$ can be deduced by a standard

G aussian approxim ation about $\mathrm{w}=\overline{\mathrm{W}}$. The leading asym ptotic behavior of each of these two contributions is then seen to be $\quad t$, implying the existence of a nite, non-vanishing stationary rate of energy transfer $\lim _{t!} 1 \mathrm{~d} E(t)=d t$, that we denote by $\quad E_{s t}$. C arrying out the algebra required, our nal result for this quantity is rem arkably simple (for reasons to be explained shortly). We nd

For ready reference, we recall that the asym ptotic drift velocity $\bar{W}$ of the piston is given by the im plicit equation ( $\left.\underline{2}_{\overline{2}}\right)$, which $m$ ay be w ritten in the altemative form

W e rem ark that the result in Eq. (1-in) is valid for arbitrary initial velocity distributions
(V ), and not just form axw ellian (see below ). It m ust also be noted that the existence of the third $m$ om ent of the speed, hJV ${ }^{3} i$, is necessary in order that $\mathrm{E}_{\text {st }}$ be nite. The exact result in Eq. (1-ī) has several other notew orthy features, that we take up in tum.
(i) P hysical interpretation:T he form ula in Eq. (1̄-ī) can be given a direct physical interpretation, extending the heuristic argum ent described in Sec. II for $P_{s t}(V)$ and $\bar{W}$ : once again, the fact that the particles m erely exchange velocities upon colliding im plies that the $m$ ean stationary rate of energy transfer across the piston can be constructed by an energy balance argum ent. If the piston has a stationary drift velocity $\bar{W}$, the tra jectories belonging originally to the gas on its right that collide w ith it are those corresponding to velocities from 1 to $\overline{\mathrm{W}}$. The energy carried by (a particle on) each such trajectory is $\frac{1}{2} \mathrm{~m} \mathrm{U}^{2}$. The rate of collisions of such trajectories $w$ ith that of the piston is $n^{+} \overline{(W} \quad U$ ), the second factor being the relative velocity between the two. T herefore

is the $m$ ean rate at which energy is transferred to the piston by the gas on its right, in the stationary state. E xactly the sam e argum ent show s that

is the $m$ ean rate at which the gas on the left transfers energy to the piston. The di erence betw een the two is precisely the form ula ofEq. (1̄2̄) for the $m$ ean stationary rate of transfer of energy from the right to the left across the piston. O ur rigorous derivation serves to corroborate this physical argum ent, in addition to providing an exact result for the tim edependent transients as well.
(ii) D ichotom ous and three-valued velocity distributions: The dichotom ous velocity distribution

yields, as always, a sim ple and tractable special case that serves as a useful check on the calculations. $W$ e have, in this case, $\bar{W}=C\left(\begin{array}{ll}n & n^{+}\end{array}\right)=\left(n+n^{+}\right)$. Evaluating the various quantities appearing in Eq. (1̄2̄), we nd that $\mathrm{E}_{\text {st }}$ vanishes identically for the dichotom ous distribution above. where $0 \ll 1$. It has been shown in Ref. [ī $]$ that the introduction of a non-vanishing probability $m$ ass at $V=0$ signi cantly alters the long-tim e properties of the hom ogeneous system. For instance, the velocity autocorrelation function acquires a $t^{3=2}$ tail, in contrast to its exponential decay in the case of a didhotom ous ( V ). In the present context, too, a non-vanishing value of leads to a strikingly di erent result for $\mathrm{E}_{\text {st }}$. W e have in this instance

Thus Est vanishes identically if $\mathrm{n}^{+}=\mathrm{n}=\mathrm{n}$ (which, together w ith ${ }^{+}=$as already im posed by Eq. (İ-1 $\mathbf{I}_{1}$, im plies a hom ogeneous system ), as itm ust in the hom ogeneous system. Sim ilarly, Est vanishes when $=0$ (the case of a dichotom ous $(V)$ ), or when $=1$
(the trivial case of no motion at all). C om paring the expressions in Eqs. (1] $\overline{1}$ ) and ( $(\overline{1} \overline{1} 9)$, we observe that $E_{\text {st }}$ can be written in this case in the revealing form

(Recall that we have de ned E- as the rate of transfer of energy to the gas on the left of the piston, and that $\bar{W}$ is negative if $n^{+}>n$, i.e., if the piston drifts to the left.) (iii) The case of $M$ axw ellian distributions: The situation that is of direct physical interest is of course that of $M$ axw ellian velocity distributions $(V)$ characterized by tem peratures T. For arbitrary densities $\mathrm{n}^{+}$and n , the asym ptotic drift velocity $\overline{\mathrm{W}}$ is still given by the solution of a transoendental equation, which reads in this case

The nonlinear dependence of $E_{s t}$ on $\bar{W}$ is explicit in this formula. We shall com $m$ ent further on this subsequently. It is also clear that $\mathrm{E}_{\text {st }}$ is not proportional to the tem perature di erence ( $I^{+} T$ ), though onem ight perhaps naively expect such a proportionality based on an incorrect identi cation of $\mathrm{E}_{\text {st }} \mathrm{w}$ ith the heat $u x$,together w ith an application of the Fourier law to the system under discussion.
(iv) M echanical work and heat contributions: This brings us, nally, to a very im portant point. The generalexpression obtained in Eq. (1̄2̄) for $\mathrm{E}_{\text {st }}$ incorporates the e ects (on the energy transfer rate) ofboth the drift of the piston and its di usive m otion (or uctuations about itsm ean position, nam ely, about $\bar{W} t$ ). In broad term $s$, onem ight regard the respective contributions as the rate ofm echanical w ork done upon the gas on the left of the piston (W) being the rate of com pression or expansion, depending on whether $\overline{\mathrm{W}}<0$ or $\overline{\mathrm{W}}>0$ ), and the rate at which its entropy changes. H ow ever, these contributions are intricately $m$ ixed up in the form ula for $\mathrm{E}_{\text {st }}$. M oreover, the dependence of $\mathrm{E}_{\text {st }}$ upon $\bar{W}$ is in general highly nonlinear. D isentangling these contributions w illenable us, in principle, to isolate the parts
of $E_{s t}$ that $m$ ay be identi ed with the \heat $u x " Q_{s t}$ and the \rate ofm echanicalw ork", respectively. In som e cases, the form er $m$ ay vanish altogether | as in the exam ple of the
 from the drift of the piston. In general, how ever, such a clear separation does not occur in the system under study. It is also im portant to bear in $m$ ind the fact that a non-vanishing drift velocity $\bar{W}$ is itself a consequence of the statistics of collisions in the system under


## V. STATIONARY HEAT FLUX

A direct way to isolate and exam ine the \heat ux" is to im pose the condition of zero drift ( $\bar{W}=0$ ) by adjusting, for instance, the value of the ration $n=n^{+}$of the densities of the tw o gases. A s we shall now see, this leads to considerable simpli cation in the formula for $E_{\text {st }}$, which we are now justi ed in re-labeling as $Q_{s t}$.

A s em phasized m ore than once, the asym ptotic drift velocity $\bar{W}$ of the piston vanishes if the densities $n$ and initial velocity distributions are related by the condition $n \quad(0)=$
 from the gases on either side of it are equal. Them otion of the piston is then purely di usive in the long-tim e lim it, w ith a variance $h X^{2}(t) i$ that tends asym ptotically to $2 \mathrm{D} t$, where the

W e note that the hom ogeneous system (de ned by $\mathrm{n}=\mathrm{n}^{+}$; $={ }^{+}$) autom atically has $\overline{\mathrm{W}}=0$. The converse is not necessarily true, of course: $\overline{\mathrm{W}}=0$ does not necessarily im ply a hom ogeneous system . Recall also that we have already considered situations in which ${ }^{+}(V)=(V)=(V)$, but $n^{+} \cap$; we then have an inhom ogeneous system in which, moreover, $\overline{\mathrm{W}}$ \& 0 .

of the particle speed in the two gases. For the hom ogeneous system, of course, Qust vanishes identically, as it m ust.

Tuming again to the case of $M$ axwellian distributions $(V)$ at tem peratures $T$, the drift velocily $\bar{W}$ vanishes, as is well known, if $n \mathrm{P} \overline{\mathrm{T}}=\mathrm{n}^{+} \mathrm{P}^{\mathrm{T}^{+}}$. Equation ( $\overline{2} \overline{2}_{\mathbf{1}}$ ) then reduces to

W e see that the heat $u x$ is indeed given by the Fourier law in this case, w ith a looe cient of therm al conductivity" that is proportional to the square root of the tem perature.

It is revealing and instructive to pause at this stage to com pare the result in Eq. (2్̄̄́) w ith that for the heat ux betw een two reservoirs held at di erent tem peratures and densities, coupled by virtue of their sharing a com $m$ on piston $[\underline{9}]$. $W$ hen the $m$ ass of the latter is equal to that of the gas particles, the B oltzm ann equation can be solved exactly for the stationary distribution; concom itantly, the heat ux conveyed via the shared piston from one reservoir
 is slightly $m$ ore com plicated than that of Eq. (2̄-̄) above, it reduces to the latter result to leading order in the tem perature di erence ( $\mathrm{T}^{+} \mathrm{T}$ ), apart from an extra num erical factor $\stackrel{P}{=} \overline{2}$. This lends additional support to our identi cation of the portion of the energy ux that corresponds to the heat ux. The fact that the heat ux is about tw ige as large in the case of the shared piston is readily understood by recalling that the piston now su ers collisions w th the gas particles belonging to both reservoirs, so that the e ective rate of collisions is roughly tw ice as large. For a detailed discussion of the relevance of the problem of the shared piston to the general questions addressed here, we refer to $[\underline{\underline{q}}]$.
$F$ inally, let us retum to the fullexpression for the stationary energy ux Est in Eq. (īi), and analyze its dependence on the drift velocity $\bar{W}$. Forsu ciently sm all $\bar{W}$, wem ay expand $\mathrm{E}_{\text {st }}$ in powers of $\bar{W}$, taking care to inconporate the fact that $\bar{W}=0$ im poses the condition $n h \neq j$ ii $=n^{+} h J$ ij $^{+}$on the param eters occurring in the coe cients of the expansion. (T his has been done in the $M$ axw ellian case, Eq. (2̄-̄) above, to reduce $n^{+}\left(T^{+}\right)^{3=2} \quad n \quad(T \quad)^{3=2}$ to $\mathrm{n}^{+}\left(\mathrm{T}^{+}\right)^{1=2}\left(\mathrm{~T}^{+} \quad \mathrm{T}\right.$ ).) C onsidering the M axw ellian case once again, we nd

In contrast to the relatively sim ple expression to which $\mathrm{E}_{\text {st }}$ reduces when $n{ }^{\mathrm{P}} \overline{\mathrm{T}}=\mathrm{n}^{+}{ }^{\mathrm{P}} \overline{\mathrm{T}^{+}}$(Eq. (2̄-1) ), no signi cant simpli cation of the general expression in Eq. (2̄2̄) occurs when $n=n^{+} T^{+}$(equal pressures on either side of the piston). Som e sim pli cation does occur, how ever, when the tem peratures on the two sides are equal, $\mathrm{T}^{+}=\mathrm{T}=\mathrm{T}$ (but $\mathrm{n}^{+} \mathrm{n}$ ). We nd that the drift velocity is now given by the im plicit equation

Finally, if the two densities are equal ( $\mathrm{n}^{+}=\mathrm{n}=\mathrm{n}$, but $\mathrm{T}^{+} \in \mathrm{T}$ ), we nd that $\overline{\mathrm{W}}$ becom es independent of $n$, and $E_{\text {st }}$ is directly proportional to $n$.

## VI. CONCLUDING REMARKS

W e have already com $m$ ented at the appropriate junctures on the special and interesting features of the structure of our analytical result for the stationary rate ofenergy transfer, as
 or otherw ise of the heat conductivity of the system under study $[\underline{-1}, 1,1 / 2 \overline{1}]$. It $m$ ay be argued that the coe cient of heat conductivity of our system is essentially in nite: The contention is that in the expression for the heat ux, the conductivity is the coe cient of the gradient of the temperature, and the latter is $/\left(T^{+} \quad T \quad\right)=L$. This gradient tends to zero in the therm odynam ic lim it, although a nite energy ux persists in the long time lim it. Hence the coe cient m ultiplying the gradient has to diverge.

W hile we agree w ith this argum ent, we point out that the system can be view ed in a di erent way: the gases on the left and right of the piston are heat reservoirs whidh have a single $m$ icroscopic degree of contact, nam ely, the tagged particle we have term ed the piston. There is no relevant length scale in the problem, so the \heat ux" is expected to appear solely as a result of this them al contact. T he fact that the B oltzm ann calculation gives a com parable value for the conductivity supports the m eaningfilness of our result. Furthem ore, one can construct a physical system that will display exactly the behavior predicted by our m odel calculation. C onsider a tw o- or three-dim ensional cylinder of axial length 2 L w ith a centralpiston that can $m$ ove $w$ ithout friction along the axis of the cylinder. The com partm ents to its left and right are lled w ith gases in equilibrium, at respective densities and tem peratures $n$; $T$. In the lim it of low densities and $L!1$, the dynam ics of the piston will be exactly as described by the one-dim ensional model: in the physical set-up, the particles only interact w ith the piston, while in our one-dim ensionalm odel, they exchange velocities upon collision, which is e ectively tantam ount to their passing through each other w ithout interaction.
