Local heat ux and energy loss in a 2D vibrated granular gas

Abstract

We perform ed event-driven simulations of a two-dimensional granular gas between two vibrating walls and directly measured the local heat—ux and energy dissipation rate in the stationary state. Describing the local heat—ux as a function of the coordinate x in the direction perpendicular to the driving walls, we use a generalization of Fourier's law, q(x) = rT(x) + r(x), to relate the local heat—ux to the local gradients of the temperature and density. This ansatz accounts for the fact that density gradients also generate heat—ux, not only temperature gradients. The transport coe cients—and—are assumed to be independent of x, and we check the validity of this assumption in the simulations. Both—and—are determined for different system parameters, in particular, for a wide range of coe-cients of restitution. We also compare our numerical results to existing hydrodynamic theories. A green ent is found for—for very small inelasticities only. Beyond this region,—and—exhibit a striking non-monotonic behavior.

D riven granular gases have attracted much attention in recent years [1, 2, 3, 4, 5]. This is partly because in these systems, energy loss in inelastic collisions is eventually balanced by energy input from the driving so that a stationary state can be attained. In physically realistic models, the driving usually acts at the boundaries of the system, e.g. in terms of shearing forces or vibrating walls. Thus, maintaining a stationary state requires a subtle and well-balanced mechanism to transfer energy from the system's boundaries to its interior. The local energy (or heat) ux and the local energy-dissipation rate are therefore at the heart of every hydrodynamic description [4, 6, 7, 8, 9] of the stationary state of driven granular gases.

Fourier's law states for elastic systems that the heat current is proportional to the local temperature gradient, the proportionality constant being the thermal conductivity [10]. For inelastic systems there is an additional contribution to the heat current from density gradients [6]. The corresponding transport coe cient—has no analog in elastic systems. Theoretical approaches start from the Boltzmann {Enskog equation to account for these e ects. Jenkins and Richman [6] have used Grad's moment expansion to compute the heat ux for small inelasticity, whereas Duffy et al. [7] have pushed kinetic models using a stosszahlansatz to simplify the collision operator. MD simulations have been performed by Soto et al. [11] to study—for a granular gas on a vibrated plane in the dilute limit.




FIG. 1: Model of N disks, driven in the x-direction with periodic boundary conditions in the y-direction.

In this paper we study the local heat ux and local energy-loss rate, as well as the for a driven granular gas in 2 dimensions. To do so, we transport coe cients and perform event-driven simulations for the dynamics of N identical inelastic smooth hard disks of diameter a and mass m which are con ned to a rectangular box with edges of length L_x and L_v . Periodic boundary conditions are imposed in the y-direction, and the gas is driven through the walls perpendicular to the x-direction, see Fig. 1 for a typical snapshot. The left and right wall vibrate in an idealized saw-tooth manner, characterized by the driving velocity $v_{drive} > 0$: Upon a collision of a particle with the left/right wall at $L_x=2$, its x-component of the velocity changes according to Varive, see also [12]. Inelastic inter-particle collisions are modeled using a constant coe cient of normal $_{1\!\!/2}$. Here, $\hat{\mathbf{n}}$ denotes the unit vector of 0 1 1 2]0;1[according to n 'n the particles' relative center-ofm ass positions, and v_{12} , resp. v_{12}^0 are the pre-, resp. postcollisional relative center-of-m ass velocities.

A psim ple estim ate in [12] yields for the spatially averaged granular tem perature T_0 = N $^{-1}$ $^{N}_{i=1}$ m v_i^2 =2 in the stationary state

Here "= 1 and $= \frac{p}{2}$ are dimensionless parameters. The latter involves the pair correlation at contact of the corresponding elastic system and the line density $= N = L_y$.

In the following discussion of heat ux and dissipation we will, inter alia, be interested in a scaling limit " # 0 towards an elastic system. In order to prevent the system from heating up inde nitely when switching o dissipation, we also need to scale the driving velocity $v_{\rm drive}$ =: " v_0 , where v_0 is xed. Hence, the driving vanishes in the elastic scaling limit, and the spatially averaged temperature reaches a nite value, approximately given by T_0 (2= $\frac{3}{2}$ () 2 m v_0^2 according to Eq. (1).

Locally, the translational energy changes due to collisions as well as due to free stream ing of the particles in between collisions. The latter gives rise to a kinetic contribution to the heat current, $q^{\rm kin}$, whereas the collisions are responsible for the energy loss—as well as for

the collisional contribution to the heat current q^{int} . For vanishing m acroscopic velocity the energy balance equation is usually formulated as [6, 7]

for the hydrodynam ic elds of density , tem perature T , total heat current $q=q^{\rm kin}+q^{\rm int}$ and local energy dissipation rate .

To compare our simulations to the hydrodynamic theory, we need to introduce a coarse graining function (r) [13], which is nonzero in a small area centered at ronly. We require of course dr (r) = 1. In the absence of a velocity eld, the coarse grained kinetic heat current is defined by

The coarse grained density (r) and temperature T (r) are de ned analogously.

The change of energy during a binary collision in a small time interval t can be decomposed into a source term and a divergence of a ux. The coarse grained energy dissipation rate (r;t) can be calculated analogous to [13] and is given by

in terms of the change of energy E_{ijj} of particle i due to a collision with particle j in the time interval [t;t+t]. The prime at the summation sign restricts i and j to those particles colliding in t. The energy dissipation rate trivially vanishes in the elastic case, when $E_{ijj} = E_{jij}$. Similarly, the collisional contribution to the heat current is given by




FIG. 2: The heat ux in the x-direction q_x for a system of N = 256 particles in a box of size L_x = 20 and L_y = 25, corresponding to a total area fraction of $_0$ = 0:4. The dotted line shows the kinetic part q_x^{kin} , the dashed line is the collisional part q_x^{int} , and the full line represents the total heat ux q_x . The inset displays the local energy-loss rate .

where $r_{ij}=r_i$ r_j . In our simulations we have never found any signi cant variations of the long time averages of the hydrodynamic elds in the y-direction parallel to the driving walls. Hence we coarse grain our system by subdividing the box into stripes of width x.

In the following we report num erical results on the stationary state only. The reader who is interested in more details of the simulations, such as initialization or relaxation towards the stationary state, is referred to [12]. For dimensional reasons, the driving velocity v_0 sets the time and energy scale and is chosen to be 1. Likewise, the particle mass and diameter set the mass and length scales and are set to 1, too.

We rst present data for the heat—ux pro le in Fig. 2 for a system of global area fraction $_0$:= N = $(4L_xL_y)$ = 0.4 and coe cient of normal restitution = 0.9. More precisely, the gure displays the x-component of the heat ux and its kinetic and collisional part as a function of the normalized position $x=L_x$. The inset shows the local energy-loss rate and will be discussed below. The heat ux is antisymmetric about the middle of the system as expected. We clearly see that its collisional part (5), which is represented by the dashed line cannot be neglected. It is of the same order as the kinetic contribution depicted by the dotted line and corresponding to Eq. (3). For lower density systems the collisional contribution becomes less in portant but still it is not negligible for global area fractions even as low as $_0$ = 0:1.

Now we turn to the dependence of the heat ux on the coe cient of restitution in the elastic scaling limit. We recall that the driving strength has been adjusted such that the




FIG. 3: Rescaled heat ux (1 2) 1 (1 +) 2 q_x for a wide range of coe cients of restitution 0:6 0:995 for otherwise xed system s (L $_x$ = 20, N =L $_y$ = 10:24 [$_0$ = 0:4]).

granular gas attains a nite tem perature as "! 0. The heat ux is proportional to the tem perature per time and hence expected to scale like $T_0 v_{\rm drive}$ ", cf. 1). This argument is checked by plotting q_k =" for dierent coecients of restitution. The collapse of dierent data sets is excellent for almost elastic systems (" 1). With a slight modication of the scaling according to q_k =["(1+)²], the data collapse also works approximately for the full range 0:6 < 0:995 and is shown in Fig. 3.




FIG. 4: Rescaled heat ux $L_x q_x$ for a wide range of box edges (area fraction 0:001 $_0$ 0% at xed line density $N = L_y = 10.24$ and xed coe cient of restitution = 0:99. This graph looks almost the same for all 0:9.

In Fig. 4 we show the heat ux for a xed coe cient of restitution = 0:99 and various system sizes L_x . It has been shown [12] that the scale for temperature inhomogeneities is set by L_x , so that we expect the heat ux to scale like L_x^{-1} , if plotted versus $x=L_x$. In Fig. 4 we plot q_xL_x for various system sizes L_x and get a decent data collapse for dilute system s. For higher densities this scaling captures at least the correct order of magnitude.

It is a characteristic feature of hydrodynam ics of inelastically colliding particles that a heat current can be generated not only by a nonuniform temperature but also by density inhom ogeneities. If the spatial variations of temperature or density are restricted to long wavelengths, one would expect a gradient expansion to hold. The simplest constitutive equation for the heat ux is thus a straightforward generalization of Fourier's law, as discussed in the literature, cf. [10]. Chapm an {Enskog expansions of both the Boltzmann and the Boltzmann {Enskog equations predict that the heat ux of an inelastic system is given by

where is the heat conductivity and is a new transport coe cient that has no analog for elastic systems [6, 7].




FIG. 5: Transport coe cients and as functions of the coe cient of restitution for systems of size $L_x = 20$ and line density $N = L_y = 10.24$ ($_0 = 0.4$).

To estimate the transport coe cients from our data, we assume that both, and , do not depend on the position x, i.e. we assume them to be constant throughout the box. It is then straightforward to extract them from a tofour data to the above expression (6). In Fig. 5 we show both transport coe cients and =".Both are non-monotonic in. In the elastic limit we not that tends to a non-zero constant, while / ". The tofthe heat ux as computed from Eq. (6) with constant and is very good for all investigated, e.g. for = 0.9 it cannot be distinguished from the data shown in Fig. 2.

Both transport one cients have been computed within kinetic theory for small inelastic ities by Jenkins and Richman [6], who not for the thermal conductivity

where r = (1 +) = 2. We use the Henderson approximation [14] for the pair correlation at contact which is a function of the area fraction only. Inserting the local temperature T (x) and local area fraction (x) from our simulations into (7), we obtain a spatially dependent transport coe cient $_{loc}(x)$ and, from a corresponding equation in [6], $_{loc}(x)$. The resulting heat ux from (6) is shown in the inset of Fig. 4 and found to agree very well with the simulations for 0:99. The agreement is reasonable even up to 0:96. For larger inelasticities the theoretical curves capture the correct order of magnitude, but overestimate the curvature of $q_x(x)$.

A liternatively we can use the global or mean temperature T_0 and area fraction $_0$ to

evaluate Eq. (7) and the respective equation from [6] for . In Fig. 5 we compare this $_0$ to the thermal conductivity we obtained from thing our simulations to Eq. (6). The agreement is good as long as 0.99. As to $_0$ (not shown), the deviations to are quite strong. Note, however, that the theory of Ref. [6] as well as the simulations of Ref. [11] apply to the low density limit and not to $_0$ = 0.4. Furthermore, the diculties in our thing procedure increase considerably as $_0$! 1 because the temperature gradient becomes proportional to the density gradient. Consequently, it is not possible for $_0$! 1 to determine two parameters from the tunambiguously.

The di erence between $_{loc}$ (x) and $_{0}$ is only a few percent for 0.99. The di erence in heat ux is even less, because the strongest inhom ogeneities in the transport coe cients occur in the m iddle of the sample where the gradients of tem perature and density vanish. The heat ux, computed using the constant transport coe cients $_{0}$ and $_{0}$, is also shown in the inset of Fig. 4 for comparison. The uctuations of the transport coe cients with x increase with increasing inelasticity, e.g. for $_{0}$ = 0.9 we nd $_{0}$ (0)= 1.5.

To estimate the degree of inhom ogeneity we have divided the box into an inner and an outer part and tted the heat current using data from either half of the box only. The scattering of the data from the inner and outer part is shown in Fig. 5 and provides a rough measure for the elects of inhom ogeneous transport. The results for the outer half are almost identical to the ones for the full system. This is also true for the inner part except for the weakly inelastic systems for which the absolute value of the heat lux in the middle of the sample is so small that statistical uctuations dominate.

The local energy loss, as de ned in Eq. (4), is shown in the inset of Fig. 2. Again, for > 0.99 the agreement with the predicted $= 16^{\circ}$ (T =)³⁼² from [6] is very

good (not shown). For very dilute quasi-elastic systems ($_0$. 0:1, & 0:95) the dissipation is highest in the middle of the sample. For denser and/or more inelastic systems we not the absolute value of (the dissipation) to be greatest in an intermediate region $x = 0:3 \, L_x$. Even though the density is largest in the middle of the sample, energy dissipation is not very pronounced there because the mean kinetic energy is already comparatively small. Integrated over the whole box, the local energy loss has to full lithe conservation law q_x ($L_x=2$) $q_x (+L_x=2) = \frac{R_{L_x=2}}{L_{x=2}}$ (x) dx. This, of course, is con rmed in the simulations, but requires careful measurements of the heat ux at the boundaries.

In this paper we have discussed the heat current in a granular gas driven by vibrating walls. We have measured the collisional contribution to the heat current and have shown that it cannot be neglected, not even in low density systems. We have extracted transport one cients, the therm alconductivity , as well as the transport one cient , which accounts for a heat ux due to density inhom ogeneities. Both transport coe cients have been determ ined for a wide range of inelasticities 0:6 0:995 and area fractions 0:01 We have studied in detail the elastic lim it which is reached by scaling the driving velocity with ", so that the tem perature tends to a nite value as ! 1. Comparing our data to theoretical work in two dimensions [6] we found good agreement for 0:99. For stronger inelasticities non-monotonic behavior is observed: The thermal conductivity with increasing ", goes through a minimum around 0:96 and then increases again. The transport coe cient =" rst increases with ", goes through a maximum at then decreases again. Furtherm ore a rough estimate of the uctuations of the transport coe cients with spatial position in the box has been given. These e ects are expected to be strong for moderately inelastic systems which are characterized by nonuniform density and tem perature and need further investigation.
