Current noise spectrum of a quantum shuttle

A bstract

W e present a m ethod for calculating the full current noise spectrum S(!) for the class of nano-electrom echanical system s (NEM S) that can be described by a M arkovian generalized m aster equation. As a speci c exam ple we apply the m ethod to a quantum shuttle. The noise spectrum of the shuttle has peaks at integer multiples of the m echanical frequency, which is slightly renorm alized. The renorm alization explains a previously observed sm all deviation of the shuttle current com pared to the expected value given by the product of the natural m echanical frequency and the electron charge. For a certain param eter range the quantum shuttle exhibits a coexistence regim e, where the charges are transported by two di erent m echanisms: shuttling and sequential tunneling. In our previous studies we show ed that characteristic features in the zero-frequency noise could be quantitatively understood as a slow switching process between the two current channels, and the present study shows that this interpretation holds also qualitatively at nite frequency.

1. Introduction

A decade of advances in microfabrication technology has pushed the typical length scales of electrom echanical system s to the limit, where quantum mechanical e ects of the mechanical motion must be taken into account [1]. Such nano-electrom echanical system s (NEM S) exhibit a strong interplay between mechanical and electronic (or magnetic) degrees of freedom, and their electronic transport properties re ect this interplay in an intricate manner. A modern trend in transport studies of mesoscopic systems has been to not only consider the currentvoltage characteristics of a given device, but also to exam ine the noise properties, or even the higher cumulants (i.e. the full counting statistics (FCS)) of the current distribution [2,3]. The current noise, either its zero-frequency component or thew hole frequency spectrum, provides more information than just the mean current and can be used to discern am ong di erent possible mechanisms resulting in the same mean current. W hile the noise spectra in generic mesoscopic systems have been studied well over a decade, it is only very recently that the study of noise spectra of NEM S has been initiated [4{6].

The aforem entioned three studies dealwith the noise spectra of a classical shuttle, a classical nanom echanical resonator coupled to a single electron transistor (SET), and the C $_{60}$ -SET in a strong electrom echanical coupling regime, respectively. The st two studies [4,5] found peaks in the current noise spectra at the rst twomultiples of the mechanical frequency. For low bias voltages and strong electrom echnical coupling the third study [6] found a power-law frequency dependence of the noise spectrum attributed to scale-free avalanche charge transfer processes. In all three cases the noise spectra revealed interesting details about the system s. From the technical point of view, two of the studies [4,6] used M onte C arlo sim ulations, w hereas [5] used a model-speci c num erical evaluation of the Mac-Donald form ula (see below).

In this work, we present a study of the full frequency spectrum of the current noise of a quantum shuttle [7{ 9].W e extend the general form alism developed for the zero-frequency noise [10,11] and the FCS [12] calculations for NEM S described by a M arkovian generalized m aster equation. The presented form alism applies not only to the shuttle studied here but could equally well be used for all three systems from the previous studies [4{6] for the determ ination of the noise spectra.

W e apply the developed theory to com pute num erically the noise spectrum of the shuttle in the deep quantum regim e^2 as function of the dam ping ∞e^{-1} cient. The spectrum has peaks at integer multiples of the slightly renorm alized m echanical frequency. The renorm alization of the bare oscillator frequency as read o from the current spectrum explains a sm all but observable deviation from the expected value of the current in the shuttling regim $e I_{shut} = e!_0 = 2$ [8]. It turns out that it is the renorm alized oscillator frequency c_0 which should enter this relation. Finally, we focus on the low -frequency part of the spectrum when approaching the sem i-classical regim e for interm ediate values of the dam ping, i.e. in the coexistence regime, where both shuttling and tunneling are e ective. W e use the frequency dependence of the spectrum for ! !₀ to identify additional qualitative evidence for the bistable behavior of the shuttle in this regime described by a




Fig.1. The quantum shuttle consists of a nanosized grain m oving in a harm onic potential between two leads. A high bias between the leads drives electrons through the grain.

simple analytical theory of a slow switching between two current channels (compare with Refs. [12,13]).

2. M odel

We consider the model of a quantum shuttle described in [7{10]. The shuttle consists of a mechanically oscillating nanoscale grain situated between two leads (see Fig.1). In the strong C oulom b blockade regime the grain can be treated as having a single electronic level only. A high bias between the leads drives electrons through the grain and exerts an electrostatic force on the grain, when charged. The grain is assumed to move in a harm onic potential, and the oscillations of the grain are treated fully quantum mechanically. D am ping of the oscillations is described by interactions with a surrounding heat bath.

From the H am iltonian of the model one can derive a generalized master equation (GME) resolved with respect to the number of electrons n that have been collected in the right lead during the time span 0 to t. The n-resolved GME describes the time evolution of the n-resolved system density matrix $^{(n)}$ (t), where the system ' consists of the electronic level of the grain and the quantized oscillations. In the following we only need the n-resolved GME for the part of $^{(n)}$ (t) that is diagonal in the electronic components, which reads [10]

The term sproportional to $_{L(R)}$ describe transfer processes from the left (to the right) lead with hopping amplitudes that depend exponentially on the ratio between position \hat{x} and the electron tunneling length . A ssum ing that the system tends exponentially to a stationary state $^{\text{stat}}$ the Liouvillean has a single eigenvalue equal to zero w ith $^{\text{stat}}$ being the (unique and normalized) right eigenvector which we denote by jDii [11]. where we have introduced the frequency dependent superoperator R (!), which is well-de ned even for ! = 0, since the inversion in that case is perform ed only in the subspace where L is regular.

3. Theory

In order to calculate the current noise m easurable in, say, the right lead one must recognize that the current running in the lead is a sum of two contributions, namely the tunnel current through the right junction and a displacement current induced by electrons tunneling between leads and grain. This is receted in the R am o-Shockley theorem [2]

since the zero-frequency tunnel current noise is the sam eat both junctions and the second term is real [11].

The num erical evaluation of Eq. (35) is only possible by truncating the num ber of oscillator states. A s in previous studies [8,10,12] we retain the 100 lowest oscillator states, which however still leaves us with the task of dealing num erically with the matrix representations of the relevant superoperators, which are of size 20000 20000. A sexplained in [11] the stationary density matrix $^{\text{stat}}$ (or jDii) can be found using the A moldi iteration scheme, and R (!) can be evaluated using the generalized minimum residualmethod (GMR es). Both methods are iterative and rely crucially on an appropriate choice of preconditioner to ensure that the iterations. It should be stressed that noting a suitable preconditioner for a given problem is by no means simple. For

nding ^{stat} and R (0) it turns out that the Sylvester part of the Liouvillean, which is the part that can be written $L_{sylv} = \hat{A}^{+} + \hat{A}^{y}$, is well-suited for preconditioning [11]. This preconditioner separates the zero eigenvalue from the rest of the spectrum of L leading to a decrease in computation tim e.

For nding R (!) the original preconditionerm us be modi ed in order to separate the relevant eigenvalue from the rest of the spectrum. A reasonable choice is the superoperator M de ned as

For the range of param eters discussed in the present paper this choice of preconditioner was su cient for convergence, however the obtained computational speedup is considerably smaller than the speedup provided by L_{sylv} , when computing R (0). This observation combined with the fact that GMRes fails to converge for certain param eters in the sem i-classical regime indicates that the identic cation of the optimal preconditioner for the problem at hand remains an open problem.

4. Results




Fig.2.The ratio between the current noise and the current F (!) = S_{II} (!) = \hat{hI} is a function of the damping and frequency !. The other parameters are $_{L} = _{R} = _{D} \frac{0.05!_{0}}{\sim = m!_{0}}$, = x₀; d eE =m!₀² = 0.5x₀, where x₀ = $\frac{1}{\sim = m!_{0}}$. Peaks are seen at ! ' 1.03!₀, 2:06!₀; 3:09!₀. The peak at ! ' 2:06!₀ reaches values of F (!) ' 20 (not shown) for = 0:02 and decreases monotonously with increasing to F (!) ' 6 for = 0:09. The insert shows a representative curve (= 0:05).

In Fig. 2 we show results for the current noise spectrum of the quantum shuttle in the deep quantum regime. In accordance with previous studies [4,5] we nd peaks at integer multiples of the mechanical frequency. A close look at the spectrum reveals a slight renorm alization of the mechanical frequency with the peaks appearing at $! = \frac{1}{2}; 2\frac{1}{2}; 3\frac{1}{2}, where \frac{1}{2}$ $1:03!_0$. In the shuttling regim e the current is expected to saturate at a value expressed as one electron per cycle of the mechanical vibrations. For a shuttle with mechanical frequency $!_0$ this implies that the saturated shuttle current is $I_{shut} = !_0=2$ ' 0:159! 0. For the given param eters the num erical calculation yields a slightly higher value, namely $I_{shut} = 0.164!_0 =$ 0:159 $1:03!_0$ ' $t_0=2$, and this can now be understood in light of the observed renorm alization of the m echanical frequency.

In [12,13] it was shown that an observed giant enhancement of the zero-frequency noise [10] in the coexistence regime of a shuttle approaching the semiclassical regime can be understood in term s of a simple model of a bistable system switching slowly between two current channels (shuttling and tunneling). Denoting the currents of the two channels⁶ as I_S and I_T, respectively, and the switching rates $_{\rm S}$ $_{\rm T}$ and $_{\rm T}$ $_{\rm S}$, one can show (following [13]) that the ratio between the current noise spectrum and the current (in the zero-frequency limit known as the Fano factor) F (!) = S (!)=I for the bistable system has the Lorentzian form

The two switching rates, $_{\rm S}$ $_{\rm T}$ and $_{\rm T}$ $_{\rm S}$, can be extracted from the numerical values of current and zero-frequency noise, and by comparing Eq. (38) with the noise spectrum obtained numerically, one can perform another independent test of the hypothesis that the shuttle behaves as a bistable system in the coexistence regin e.




Fig. 3. The ratio between the current noise and the current $F(!) = S_{II}(!) = h\hat{I}i$ for low frequencies (! $!_0$). The parameters are = 0:035! (lowest curve), 0:04!0;0:045!0;0:05!0 (topmost curve), $= p_{0}^{0} = 1:5x_{0}; d$ $eE = m !_0^2 = 0:5x_0$, L = R ~=m ! 0. The circles indicate num erical rewhere $x_0 =$ sults, while the full lines indicate the analytic results for the current noise spectrum of a bistable system . It should be noted that in order to obtain the agreem ent between the num erical and analytic results it is necessary to assum e that the shuttling current for the given values of is not fully saturated to the value $I_{shut} = 1:03!_0=2$. Corresponding to the dierent values of we have used $I_{shut} = 1:01!_0=2$ (for = 0:03!_0), 1:00!_0=2, 0:98!_0=2, $0:94!_0=2$ (for = $0:05!_0$), respectively.

In Fig. 3 we show numerical results for the lowfrequency current noise of the quantum shuttle in the coexistence regime. Together with the numerical results we show the analytic expression for the current noise of the bistable system (Eq. (38)) with rates extracted from the numerical values of current and zerofrequency noise. It should be noted that the agreem ent between the numerical and analytic results could only be obtained by assuming that the shuttling current for the given values of the damping is not fully saturated to the value $I_{shut} = t_0=2$. The current noise spectrum thus provides us with qualitative evidence for the shuttle behaving as a bistable system in the coexistence

regime, while it, however, leaves us with an open question concerning the saturation of the shuttling current.

5. Conclusion

We have presented a theory for the calculation of the current noise spectrum of a large class of nanoelectrom echanical systems, nam ely those that can be described by a Markovian generalized master equation. As a speci c example we have applied the theory to a quantum shuttle. For the quantum shuttle num erical calculations of the current noise spectrum in the deep quantum regime revealed a slight renormalization of the mechanical frequency { this, in turn, explains an observed small deviation of the shuttle current com pared to the expected value given by the product of the natural mechanical frequency and the electron charge. W hen approaching the sem i-classical regime the low-frequency noise served as another evidence for the quantum shuttle behaving as a bistable system, switching slow ly between two current channels, thus supporting this claim, previously based on the calculation of the full counting statistics of the quantum shuttle. The theory presented here has a broad range of applicability, encom passing the few previous studies of the current noise spectra of nano-electrom echanical system s.
