The ideal gas as an um model: derivation of the entropy form ula

A bstract

The approach of an ideal gas to equilibrium is simulated through a generalization of the Ehrenfest ball-and-box m odel. In the present m odel, the interior of each box is discretized, i.e., balls/particles live in cells whose occupation can be either multiple or single. M oreover, particles occasionally undergo random, but elastic, collisions between each other and against the container walls. I show, both analitically and num erically, that the num ber and energy of particles in a given box eventually evolve to an equilibrium distribution W which, depending on cell occupations, is binom ial or hypergeom etric in the particle number and beta-like in the energy. Furtherm ore, the long-run probability density of particle velocities is M axwellian, whereas the Boltzm ann entropy In Wexactly reproduces the ideal-gas entropy. Besides its own interest, this exercise is also relevant for pedagogical purposes since it provides, although in a sim ple case, an explicit probabilistic foundation for the ergodic hypothesis and for the maximum -entropy principle of therm odynam ics. For this reason, its discussion can pro tably be included in a graduate course on statistical mechanics.

1 Introduction

A fier the pioneering work of Boltzm ann, there is now a general consensus on the idea that a dynam ically chaotic motion generically leads, in systems of very m any particles, to therm odynam ic behaviour. A general proof of this statem ent is however lacking, and one's intuition usually appeals to simplied dynamical models which allow for some analytic treatment. Statistical toy-models that illustrate how therm odynam ic equilibrium is established in practice are especially helpful for educational scope, since they supply students with a plain justication and a direct understanding of the basic assumptions of thermodynamics and statistical mechanics. In particular, an intuitive picture of the emergence of the Second Law of thermodynamics from mechanics is provided by the behaviour of stochastic unmodels, where balls/particles are subjected to a probabilistic evolution which, eventually, drives the system towards a stationary state [1]. O bviously, this stochastic (M arkovian) dynamics is only a caricature of the merges after averaging over many instances of the complicated short-time motion.

In the Ehrenfest model, N numbered balls are distributed into two ums; at each time step, a number between 1 and N is extracted at random, and the ball with that label is moved from the um where it resides to the other. Eventually, the average number of balls in each um becomes equal to N = 2, with relative uctuations around the mean that are negligible in the large-N limit. This stochastic process, which K ac considered as \probably one of the most instructive models in the whole of Physics" [2], gives an illustration of the irreversible di usive dynam ics of two dilute gases of the same species, hosted in two communicating, but globally isolated, vessels of equal volume. As we learn from therm odynam ics, and is conmmed by experience, the two gases eventually attain an equilibrium state being characterized by an equal number of particles in the two vessels.

In order to include also energetic considerations into the description, I consider a generalization of the Ehrenfest model where the balls/particles are endowed with both a discrete position and a continuous velocity. To be specified, we are given two boxes, 1 and 2, and N labelled particles distributed between the boxes. Box 1 (2) is divided into V_1 (V_2) identical cells, $V = V_1 + V_2$ being the total cell number. The occupation number c of the -th cell (= 1; :::;V) can be either Boxe-like (c = 0;1;2;:::) or Ferm i-like (c = 0;1), with both possibilities being considered in the following. The velocity of the a-th particle (a = 1; :::;N) is v_a , a three-dimensional vector with components v_{ak} ; k = 1;2;3.

To make some progress in the analytic treatment of the model, a drastic simpli cation is made, namely that the position dynamics is totally decoupled from the velocity dynamics. This is obtained by an independent and alternate updating of positions and velocities, in such a way that free di usive motion and collisions will run in parallel, yet staying separate. In particular, the equilibrium of one set of variables can be analysed without making reference to the other. The assumption of decoupling between position and velocity updating is tantam ount to the hypothesis that 1) the M arkov time step, while being much longer than any m icroscopic collision time, is nevertheless shorter than the time needed for the velocity distribution to relax (i.e., to reach equilibrium); 2) velocity relaxation occurs on a time scale that is also well separated from (typically much longer than) the equilibration time of the number density.

I argue, and indeed is veried a posteriori, that this model gives a representation of the ideal-gas dynam ics once de ning the entropy with the logarithm of the probability density of macrostate variables. Hence, by this route one arrives at a novel (i.e., not based on the microcanonical ensemble) microscopic foundation of the ideal-gas expression for the entropy and, at the same time, at a probabilistic justication of the maximum -entropy principle of thermodynamics. Furthermore, this simple model gives the opportunity to discuss at length the issue of ergodicity of a probabilistic evolution and its relevance for the actual deterministic dynamics of a many-particle system. This point is usually hardly understood by graduate students in statistical physics, who in dit rather obscure. The present model could come in useful for providing an easy access to such basic theoretical questions.

The outline of this paper is the following: in Sections 2 and 4, I describe the stochastic dynamics of particle positions and velocities, respectively. Section 3 is an interm ezzo, mainly of illustrative value, where I show an example of exact derivation of a macro-variable (coarse-grained) evolution from the microscopic dynamics. Further comments and conclusions are given in Section 5.

2 Update of positions

Let us st suppose that each cell in the boxes can host whatever number of particles. A positions update consists of 1) choosing at random one particle, a_r , and one cell, _r; and 2) moving particle a_r into cell _r. In terms of the macrovariable n, which counts how many particles are currently found in box 1, this de ness a stationary stochastic process of the M arkov type, being characterized by the following conditional (or transition) probabilities:

In Eq.(1), $t = 0; 1; 2; \dots$ is a discrete time. The ensuing master equation for n reads:

It is immediate to realize, by direct inspection, that Eq.(2) admits the binomial distribution !

as unique stationary distribution. Since the M arkov chain is ergodic (i.e., there is a path connecting every (m acro)state n to every other n⁰), any initial distribution P (n;0) will converge, in the long run, to W (n). Observe that W (n) gives the chance that, upon random ly distributing N labelled particles into two boxes, with di erent a priori probabilities for the boxes, the num ber of particles in box 1 be n. M oreover, the multiplicity of m acrostate n, i.e., the num ber of com plexions (m icrostates) of N distinguishable particles in the boxes, such that box 1 contains n particles, is V^N W (n). Hereafter, I list a num ber of properties which hold for the dynam ics ruled by Eq. (2).

First, I calculate the average n and n^2 at any time by explicitly evaluating the two sum \boldsymbol{s}

The set of the di errence equations (4) adm its a solution hni (t) = a + bx, for suitable a; b, and x. One easily nds:

i.e., an irreversible exponential approach to N $V_1=V$, a value corresponding to having the same density of particles in every box. Sim ilarly, the second of Eqs. (4) has a solution of the form

A ssum ing n; N $n; V_1; V_2 = O(N)$ 1 and using the Stirling approximation ln N != N (ln N 1) + O (ln N), the equilibrium entropy S (n), de ned as the logarithm of the multiplicity V^NW (n), turns out to be additive over the boxes and extensive with n:

being maximum for $n = N V_1 = V$ (subextensive terms in (8) are ignored). Note that the superextensive N ln N term turns into an extensive constant if $V^N W$ (n) is multiplied by the G ibbs factor of 1=N !, whose origin is quantum -m echanical (it arises as a required correction to the partition function of a system of identical particles in the classical limit, i.e., under the hypothesis of low particle density at all temperatures). In Eq (8), we recognize the volume contribution to the ideal-gas entropy. Therefore, the equilibrium (and asymptotic) value of n is the outcom e of the entropy maximization, as indeed prescribed by therm odynamics.

It easily follows from Eq.(3) that the pro $\mbox{le of }W$ (n) around the maximum is Gaussian,

n = n NV₁=V being the deviation from the abscissa of the maximum. The last term in Eq.(9) is negligible for standard deviations n = O(N).

Nothing changes in the asymptotics if r is forbidden to be the same original cell of a_r . In this case,

but the form of W (n) is unchanged. However,

W hile all of the above sounds quite \standard", novel results are those I obtain for the case of single-occupation cells. Now, at each step of the process, the selected particle a_r is moved into a cell $_r$ that is chosen at random among the vacant sites. The transition probabilities now read (with $V_1;V_2$ N):

W (n) gives the chance that, upon random ly choosing N cells (i.e., the occupied ones) among a total of V distinguishable sites, the number of particles in box 1 be n. Stated it di erently, $n \atop n$ is the number of ways n numbered particles can be sorted out from a set of N, while

is the number of ways these n particles can be allocated in box 1 (the other N n being attributed to box 2 instead). The product of ${}_{n}^{N}$ by (15) gives again W (n). Finally, the multiplicity of state n, i.e., the number of ways N indistinguishable particles can be arranged into V distinguishable cells, in such a way that n particles reside in box 1, is equal to ${}_{n}^{V_{1}} {}_{N} {}_{n}^{V_{2}} = {}_{N}^{V} W$ (n).

The average n and n^2 at time t are given by:

being maximum for $n = N V_1 = V$. Equation (18) is nothing but the thermodynamic entropy of two ideal lattice gases that can mutually exchange energy and particles.

Finally, it immediately follows from Eq.(13) that the prole of W (n) around the maximum is Gaussian,

3 Derivation of a coarse-grained dynam ics from the m icrostate dynam ics

For a speci c instance of stochastic dynam ics of cell occupation numbers, I provide in this paragraph the detailed derivation of the coarse-grained evolution of a macro-variable (i.e., the number n of occupied cells in box 1).

In the example considered here, the occupation numbers c = 0;1 are made to evolve according to the following rules: at each time step, 1) two cells are chosen at random (either in the same box or in dierent boxes), and 2) their occupation numbers are mutually { and unconditionally { exchanged (observe that the overall number N of occupied cells is conserved by the dynamics). The ensuing M onte C arb/M arkovian evolution is thus specied by the transition probabilities

Let the V cells be numbered in such a way that the $rst V_1$ cells in the list do belong to box 1, while those from $V_1 + 1$ to V belong to box 2. The probability of observing the macrostate n at time t is then

I aim at nding an equation of evolution for this P, namely a master equation that is valid at a less fundam ental, coarse-grained level of description.

First, I note that every sum over all distinct pairs of cells (like that appearing p on the r.h.s. of Eq. (23)) can be decomposed into three sum s, $V_1 + V_1 +$

Let S_n be the set of all the $\begin{bmatrix} V_1 & V_2 \\ n & N \end{bmatrix}_n$ m icrostates fog such that $\begin{bmatrix} P & V_1 \\ = 1 \end{bmatrix} c = n$. Now observe that, for each m icrostate of S_n , there are exactly N $_{P}^{(3)}$ term s in the sum $V_{1<}$ (:::;c;::;c;::;t) that refer to m icrostates of S_{n-1} . Hence, the coe cient of P (n 1;t) in the master equation (i.e., the num ber of times any speci cm icrostate of S_{n-1} is repeated in the sum P_{P}^{P} (:::;c;::;t))

is given by the product of N $_{i}^{(3)}$ times the number of S_n m icrostates, divided by the total number of S_{n-1} m icrostates:

One can easily extract from the above equation the expression of the transition probabilities, with the result:

The latter probabilities, although not identical to the (12), nonetheless lead to the same stationary distribution (13), as can be checked directly. This is not strange, since the transition probabilities (31) are obtained by multiplying the (12) for the constant factor 2N (V N)=[V (V 1)].

4 Update of velocities

The collision dynamics of a set of equalmass particles can be schematized, at the roughest level of description, as a succession of random binary events which are nevertheless required to obey energy and momentum conservation [3]. On the macroscopic side, such collision rules go along with the conservation of total kinetic energy and totalmomentum, thus being appropriate only to a very dilute (gaseous) system of particles. If, moreover, we want to drop the momentum constraint, provision should be made also for elastic collisions of particles against the (cubic) container walls, causing the reversal of one component only of the velocity of the hitting particle (say, the x com ponent if the collision occurs against the wall that is orthogonal to the x axis).

As far as the mutual collisions are concerned, the conservation laws by them - selves require that the velocities of the colliding particles, say a and b, be updated as:

where $v = (v_b \quad v_a)$ f, and all that we know about the unit-length vector f is that it forms an acute angle with $v_b \quad v_a$ (i.e., v > 0). In particular, note that a general property of an elastic collision is:

The full speci cation off would require more know ledge about the collision (i.e., the peculiar geom etry of the in pact and the exact law of interaction between the particles). Instead, the collision rules considered here are such that the outcome of a mutual collision is as maxim ally random as possible: that is, at each step of the game, \hat{r} is picked up at random from the emisphere of unit vectors forming an acute angle with $v_b = v_a$ [4]. Note that in one dimension only is the vector \hat{r} nonetheless univocally determined: this is consistent with the known fact that, for particles moving on a straight line and colliding elastically, the conservation laws su ce to determ in the post-collision velocities from the initial ones. I point out that the duration of velocity relaxation in a real system is rather sensitive to the peculiarities of the interaction between particles. However, this may not be the case for the asymptotic shape of the velocity distribution, which is only aware of the conservation laws that rule the outcom e of an individual collision.

If collisions against walls and between particles occur at a rate of 1 p and p, respectively (where p is any number between 0 and 1), the master equation for the velocities reads:

Note that the two kernels $_1$ and $_2$ are separately normalized. In particular, the factor $1=(2 \ y_a \ v_b)$ is the outcome of a six-dimensional integration of

An outstanding exception is p = 1, where the more general stationary solution to Eq.(34) is instead F (v_1^2 + \sum_{N}^{2} + $Gv(v_1$ + \sum_{N} +, for arbitrary F and G functions.

Next, I consider the one-and two-body velocity distributions at time t. These are marginal distributions that are built over (fvg;t):

Seeking for an exact equation of evolution for f_1 , I calculate $f_1(v_1;t+1)$ by inserting Eq.(34) into the st of Eqs.(38). While the term arising from $_1$ can be easily worked out, less straightforward is the derivation of the other one, involving $_2$:

where the latter sum is actually made of N 1 identical contributions. Then, considerations similar to those leading to Eq. (36) allow one to further simplify the r.h.s. of Eq. (39) and to arrive at the nal equation for f_1 , whose status is akin to that of the fam ous B oltzm ann equation in the kinetic theory of gases:

W hile it seems problem atic to derive a sort of H-theorem from Eq.(40), a more easy program to fulliston dtime-independent solutions for this equation. It is immediate to check that the ansatz $f_2^{(eq)}(v_1;v_2) = (v_1^2 + v_2^2)$ gives a stationary solution to Eq.(40) for any appropriate function (for p = 1, the more general time-independent solution is instead $(v_1^2 + v_2^2)$ ($v_1 + v_2$)). However, in case of an isolated system with total energy U [5], the only admissible solution (37) is the microcanonical density

which is the nite-N M axwell-Boltzm ann (M B) distribution [6]. In the N; U ! 1 lim it (with U=N = O (1)), one recovers from Eq. (43) the more familiar G aussian form:

with = 3N = (2U), corresponding to an average v_a^2 of U = N for all a. Note that full independence of v_1 and v_2 , namely $f_2^{(eq)}(v_1;v_2) = f_1^{(eq)}(v_1)f_1^{(eq)}(v_2)$, requires the therm odynamic limit N ! 1 and U = O(N).

As a further comment, I emphasize that a distribution like (37) is a meaningful solution to Eq.(34) also for F not being a delta function. In fact, the t = 0

velocity distribution need not necessarily correspond to a single m icrostate or to a m ixture of m icrostates all having the same energy U. It is an equally valid possibility that the initial state encom passes a whole distribution of m icrostate energies. In this case, and taken for granted that the evolution is ergodic, the collisions w illeventually suppress any di erence in weight between them icrostates having the same energy, but preserving the overall frequency of occurrence of every energy value in the m ixture.

A normalized w distribution of the form (37) requires that F satis es

The above distributions have not generally a G aussian prole, even in the therm odynam ic limit (an exception is F (U) = ${}^{3N=2} \exp(U)$, which leads to $f_1^{(eq)}(v_1) =$

 $^{3=2} \exp(v_1^2)$ and $f_1^{(eq)}(v_1;v_2) = ^{3} \exp(v_1^2 - v_2^2))$.

I have carried out a computer simulation of the evolution encoded in Eq. (34) in order to check whether the stationary distribution (43) is also an asymptotic, t ! 1 solution to Eq. (34), as one m ay sum ise (at least for 0) from the likely ergodic character of its kernel . First, I set N = 3 and U = 0.06, with p = 0.5 (note that the choice of U is rather immaterial, it just sets the range of uctuations of a single velocity component to approximately a value of 2 U=(3N)). Starting from a system of velocities in any particular microstate of energy U, I collect in a hystogram the values, at regular time intervals, of the three components of, say, the velocity of particle 1. A look at Fig.1 indeed shows that this hystogram has, in the long run, the nite-N MB form. This is indirect evidence that the simulation trajectory samples uniform ly, at least e ectively if not literally, the 3N -dimensional hypersurface of energy U. I note that ergodicity does not hold for p = 0 (i.e., when collisions against the walls are the only present), whereas the stochastic evolution for p = 1 (i.e., only mutual collisions present) retains memory of the initial value of the total momentum.

A fiterwards, I take N = 1000 and U = 20 (i.e., same U=N as in the case before), and follow the evolution of the same hystogram as above, now starting

from velocity values that are random ly extracted from e.g. a (bounded) uniform one-particle distribution of zero average and variance equal to U = (3N) (I have checked that nothing changes in the results if the shape of the initial one-velocity distribution were di erent, e.g. truncated quadratic). A fler discarding the initial part of the simulation trajectory, the long-run distribution of values for velocity no.1 now compares well with a Gaussian (see Fig.2), that is with the large-N form of the MB distribution. In fact, also the instantaneous velocities of all particles are asym ptotically distributed, for large N , according to the sam e Gaussian (see Fig.3). This indicates that: 1) the vast majority of points in the energy hypersurface is made of \typical" states, i.e., microstates that look more or less similar as far as low-order, marginal distributions like f_1 are concerned; 2) the m icrostate at which the evolution (34) was started is actually untypical; and 3) this evolution moves eventually the initial state into the manifold of typical m icrostates. It is believed that such features of the stochastic dynam ics (34)-(35)are owned also by the determ inistic dynamics of a typical many-particle system. In particular, it is in the weak or e ective sense being clari ed in point 3) above that the ergodic hypothesis of statistical mechanics may actually be relevant for mechanical systems (and are the most) that are not strictly ergodic [7].

For a given num bern of particles in box 1, the equilibrium probability density W_n (u) of their total energy u can be calculated exactly for w (fvg) / $(v_1^2 + v_N^2 - U)$, by evaluating the probability that the num ber $v_1^2 + \frac{2}{n}$ become prised in an interval (a;b), with a > 0. Once again, this probability is calculated by transform ing to hyperspherical coordinates:

that is, the variable u=U is beta-distributed with an average of n=N and a variance of (n=N)(1 n=N)=(3N=2+1) (which is 0 (N⁻¹) for n = 0 (N)). O fall n-velocity m icrostates, the fraction of those states whose energy lies between u and u + u is W_n(u) u (for u u). In particular, the Boltzmann entropy associated with Eq. (49) is, for n; N n = 0 (N) 1:

5 Conclusions

Simple, yet non trivial, theoretical models hold a prominent place in our own understanding of the physical reality, since they help in corroborating in ourm ind the general abstract principles. This is especially true for the learning of statistical mechanics, where the appeal of students to their physical intuition, which is grounded on every-day experience, is not as easy as for classical mechanics and therefore the convinced acceptance of basic principles by them would require a proper mediation.

An example is the hypothesis of equal a priori probability of all microstates, which is crucial for getting at the microcanonical and canonical ensembles. In this paper, I have introduced a stochastic process of the Ehrenfest type which, am ong other things, provides a microscopic justication for the expression of the therm odynamic entropy of an ideal gas, i.e., without relying on any ergodic hypothesis. Rather, the validity of this hypothesis, at least in an elective sense, arises automatically from the stochastic dynamics itself. However, in order to make the asymptotics of the present model solvable a rather strong assumption was made, i.e., that positions and velocities actually behave as uncorrelated random variables. This is only justified so long as the two sets of variables relax on very different time scales, which is a fair assumption only for low-density gases (i.e., for particles undergoing only sporadic encounters). The proposed derivation of the ideal-gas entropy somehow recalls the heuristic estimate of the multiplicity by [8, 9], though being de nitely more rigorous.

In them odynam ics, the Second Law requires the maxim izization of the total entropy S under the given constraints (here, the total number of particles N and the total energy U of two ideal gases being in grand-canonical contact with each other) in order to nd the equilibrium state of an overall isolated system. In the present m odel, this very same prescription emerges naturally, when de ning the entropy a la Boltzm ann, as the condition upon which the partition of N and U between the gases be, in the long-time regime, the (overwhelm ing for U; N 1) m ost probable. Hopefully, a discussion of this model with the students can serve to deepen their com prehension of the hypotheses underlying statistical mechanics.

The full curve is the theoretical, nite-N MB distribution per single velocity component, which is appreciably di erent from the in nite-N limit (i.e., the G aussian = exp(\vec{v}), with = 3N = (2U) { broken curve}. Bottom : Here is plotted the di erence between the hystogram and the nite-N MB distribution.
- Fig.2 : Numerical simulation of Eq. (34). Top: Hystogram of velocity values for particle 1 (same symbols and notation as in Fig.1). Now, N = 1000 and U = 20 (i.e., same U=N as in Fig.1). Initially, the v_a vectors are extracted from a uniform one-particle distribution having zero average and a variance of U=(3N) (hence the maximum speed $v_{max} = U=N$). Then, velocities are rescaled to t the chosen U value. A fter discarding 10⁴ CPP, a huge number of collisions is performed (10⁶ per particle, with p = 0.5). Similarly to N = 3, data are grouped in bins of width v = $2v_{max}$ =31 and the hystogram is updated every 10 <u>CPP</u>. The full curve is the theoretical distribution, that is the Gaussian = exp(\vec{v}), with = 3N = (2U). Bottom : D i erence between the hystogram and the above Gaussian.
- Fig.3 : Numerical simulation of Eq. (34). Top: Particle velocities at the end of the simulation run for N = 1000 and U = 20 (see Fig.2, caption; sam e symbols and notation as in Fig.1). The distribution of all-particle velocities at a given time strongly resembles the same G aussian as in Fig.2 (full curve). Bottom : Di erence between the above hystogram and this G aussian law (note the change of scale with respect to Figs.1 and 2).






