Magnetoelastic Coupling in the Spin-D im er System TLCuCl₃

W e present high-resolution m easurem ents of the therm al expansion and the m agnetostriction of T L uC b which shows eld-induced antiferrom agnetic order. W e nd pronounced anom alies in the eld and tem perature dependence of di erent directions of the lattice signaling a large m agnetoelastic coupling. The phase boundary is extrem ely sensitive to pressure, e.g. the transition eld would change by about 185 % /G Pa under uniaxial pressure applied along certain directions. This drastic e ect can unam biguously be traced back to changes of the intradim er coupling under uniaxial pressure. The interdim er couplings rem aim essentially unchanged under pressure, but strongly change when T l is replaced by K.

One of the most simple quantum spin system is a spin-1/2 dimer. If such dimers are weakly coupled to each other, very rich and fascinating physical properties are predicted for various theoretical models and can be observed experimentally in suitable materials. For exam ple, the two-dim ensional Shastry-Sutherland m odel [1] is realized experimentally by SrCu₂ (BO₃)₂ and its lowtemperature magnetization as a function of magnetic eld show s distinct plateaus at certain fractional values of the saturation m agnetization [2]. M agnetization plateaus are also observed in the three-dim ensional spin-dim er system NH_4CuC_{1} [3]. Such plateaus are, how ever, absent in its iso-structural (at 300K) counterparts RCuCh with R = Tland K, which both have a non-m agnetic ground state up to a certain magnetic eld [4]. Above this eld a Neelorderwith staggered magnetization perpendicular to the applied eld occurs [5, 6] and it has been proposed that this transition should be viewed as a Bose-E instein condensation (BEC) of magnons [7, 8, 9, 10]. A ccording to a recent neutron scattering study, the di erent behavior of NH₄CuCL is connected with two structural phase transitions in that compound [11]. Despite their qualitative sim ilarity, the magnetic system s of T IC uC L and KCuCL show pronounced quantitative di erences. The triplet excitations of T L uC b are strongly dispersive, whereas those of KCuCh have a weak dispersion [10, 12, 13]. Consequently, the minimum gap 8K is signi cantly sm aller than the intradim er coupling J ' 64K for TLCuCL, whereas this di erence is much weakerforKCuCb (' 30K and J ' 50K) [10, 12, 13]. The very di erent behavior of the RCuCl₃ series shows that small structural di erences strongly in uence the m agnetic subsystem . Evidence for a strong m agnetoelastic coupling in TICuCL is also found in ultrasound and NMR data, which indicate that the phase transition of TICuCL has a signi cant contribution of rst-order character [14, 15]. A BEC is expected to be of second order, but spin-phonon coupling can drive a continuous transition into a rst-order phase transition [16]. Moreover,

hydrostatic pressure of less than 0.5 GPa is already su - cient to close and to induce antiferrom agnetic order in T L uC $l_{\rm S}$ without magnetic eld [17, 18]. A microscopic understanding of the relevant changes under pressure is still missing. In particular, it is not clear why external pressure decreases , whereas the substitution of the T l^+ ions by the smaller K^+ ions increases .

W e present high-resolution m easurem ents of the therm alexpansion and the magnetostriction of a single crystalofT LC uC L. U sing a capacitance dilatom eterwe studied the length changes perpendicular to the (010) and (102) cleavage planes of the monoclinic crystal structure [5]. V ia therm odynam ic relations we derive the uniaxial pressure dependencies of the transition tem peratures T_c , of the transition elds H_c , of the spin gap , and of the magnetic coupling constants. For we nd huge pressure dependencies of about 185% /GPa for uniaxial pressure perpendicular to the (010) or $(10\overline{2})$ planes, respectively. The uniaxial pressure dependencies of unambiguously correlate with changes of the intradim er coupling J under pressure. In contrast to recent assumptions [10], pressure-dependent changes of the interdim er coupling J^0 play a m inor role. Thus, the weaker J^0 of K C u C \downarrow is not a consequence of chem ical pressure. This gives clear evidence that the T I^{\dagger} and K $^{+}$ ions are directly involved in the superexchange which is responsible for the relevant interdim er coupling and experim entally con m s the theoretical result of a signi cantly stronger superexchange via TI^{\dagger} than via K^{\dagger} for $RCuCl_{2}$ [19].




FIG.1: Them al expansion $_{1}$ perpendicular to the (010) and (102) planes for di erent m agnetic- eld strengths applied parallel to the respective m easurem ent direction.

In Fig. 1 we show the longitudinal therm al expansion $_i$ along di erent directions i for various values of a magnetic eld applied parallel to the respective measurement directions. In low elds there are no anom alies of $_i$, whereas above 6 T strong anom alies of opposite signs appear for both directions. With increasing eld the anom alies increase and system atically shift to higher tem perature. These anom alies signal spontaneous distortions below the phase transition: a spontaneous elongation perpendicular to the (010) and a spontaneous con-

traction perpendicular to the $(10\overline{2})$ plane.




FIG.2: Magnetostriction $_{i} = L_{i} = L_{i}$ perpendicular to the (010) and the (102) planes at selected tem peratures. Panel (a) shows $_{i}$ vs:H and (b) $_{i}$ vs:H², respectively. Panel (c) displays the eld-derivatives $\frac{\theta_{i}}{\theta_{H}}$ for i = (010) obtained with increasing (line) and decreasing (symbols) eld at T = 3.8 K.

Fig. 2 displays representative magnetostriction measurem ents at di erent constant tem peratures for both m easurem ent directions. The relative length changes $_{i}$ = L $_{i}$ (H)=L $_{i}$ as a function of eld for i = (010) and $(10\overline{2})$ are again of comparable size but of opposite sign. The phase transition causes a sharp kink in i as a function of eld. W ith increasing temperature these kinks shift to higher elds and cannot be observed anym ore in the studied eld range above about 9K.For $H > H_{c,i}$ changes essentially linear with eld, whereas for smaller elds or for higher tem peratures $_{i}$ is proportional to H 2 (see Fig.2b). A kink in i is typical for a second-order phase transition, which should give rise to a jump-like anom aly in the eld-derivative Q i=QH . As mentioned above, there is som e indication for a rst-order contribution to the phase transition in T L uC k. A sm all region of coexisting phases around H_c as proposed from the NMR data [15] can be neither con med nor ruled out by our m easurements of the macroscopic length changes. We can, how ever, exclude that there is a signi cant hysteresis of about 0:5 T between the H $_{\rm c}$ values obtained with increasing and decreasing magnetic eld as has been observed in an ultrasound study [14]. In Fig.2c we com pare 0 i=0H obtained with increasing and decreasing magnetic eld. A s expected for a second-order phase transition there is a (broadened) jump at H $_{\rm c}$ and both curves agree well with each other over the entire eld range. Thus, any hysteresis of H $_{\rm c}$ is restricted to less than our eld resolution of about 50 m T.




FIG.3: Phase diagram of T L uC l_{0} from the magnetostriction and thermal expansion measurements perpendicular to the (010) () and (102) () planes normalized by the respective g factors [20]. The triangles display the hypothetical shift of selected T_c and H_c values for a uniaxial pressure of 0.1 G Pa perpendicular to (010) (N) and (102) (H) calculated by Eq.1. The lines are power-law ts of the phase boundaries.

In Fig. 3 we show the phase diagram obtained from our data (circles) together with a power-law t (solid line) of the form $(g=2) [H_c(T) H_c(0)] / T$. This t yields = 2.6 and $H_c(0) = 5.6T$. The exponent is larger than the value of 2.1 obtained in Ref. [20] (for T < 4K), but agrees well with the result of Quantum M onte C arb (QMC) simulations [21]. A coording to a more recent QMC study [22], sensitively depends

on the temperature range of the t and in the lowtemperature lim it = 1:5 is approached, which agrees to the expected value for a BEC. Thus, our larger value of arises most probably from the used temperature range (3K < T < 9K), but one should also keep in m ind that could change due to the nite spin-phonon coupling, which is not considered in the m odels [7, 8, 21, 22].

The anom alies at the phase boundary allow to derive the uniaxial pressure dependencies of $T_{\rm c}$ and H $_{\rm c}$ by the Ehrenfest relations

Here, V_m is the molar volume, i is the height of the therm al-expansion anomaly (see Fig. 1) and C $_p$ that of the corresponding speci c-heat anomaly [20], $\frac{\theta i}{\theta H}$ is the slope change of i at H $_c$ (see Fig. 2) and $\frac{\theta M mol}{\theta H}$ the corresponding slope change of the magnetization [4].

With C_p and M from Refs. [4, 20] we nd huge uniaxial pressure dependencies of T_c and H_c , e.g. $\frac{@T_c}{@p_{010}}$, 9K/GPa for $T_c = 72K$ and H = 12T, or $\frac{@H_c}{@p_{102}}$, 8T/GPa for $H_c = 6T$ and T = 4K. A hypotheticaluniaxial pressure of 0.1GPa on (010) would strongly shift the phase boundary tow and shigher H_c and low er T_c values, respectively, whereas uniaxial pressure on (102) would cause a shift in the opposite direction as shown in Fig. 3 by the upw and and dow nw and triangles, respectively. The dashed and dotted lines represent pow er-law ts (keeping xed) of these hypothetical phase boundaries under uniaxial pressure, and their extrapolations to T = 0K reveal the uniaxial pressure dependencies of

These are huge values, but due to the opposite signs, they alm ost canceleach other under hydrostatic pressure. N evertheless, a strong decrease of has been observed under hydrostatic pressure [17, 18]. Thus should also strongly decrease for uniaxial pressure along the [201] direction, which is perpendicular to both directions of our measurem ents. The geom etry of our crystal did not allow measurem ents along the [201] direction, but we expect that there will be similar anom alies at the phase boundary as those perpendicular to the $(10\overline{2})$ plane.

In a m odel of dim ers coupled by an elective interdimer coupling J^0 the magnitude of is determined by the balance of J and $J^0[10]$. An increase of J will enlarge , whereas an increase of J^0 will enhance the bandwidth of the triplet excitations and therefore lower . Due to the small value of compared to J (and J⁰) in T L uC l₃ already moderate pressure-dependent changes of J (or J^0) m ay cause drastic changes of . In order to gain information whether these changes arise from a pressuredependence of J or of J^0 , we t the magnetic susceptibility [23] for temperatures well above the gap by




FIG. 4: Magnetic susceptibility () with a t for coupled dimers (solid line, Eq.2). The dashed and dotted lines show the expected changes of for an increase of J and a decrease of J^0 , respectively. Both cases would cause an increase of the spin gap (see text.).

Here, $_0$ (T) is the susceptibility of non-interacting spin dimers with intradimer coupling J, and $_{\rm M\,F}$ accounts for a mean-eld correction with an elective interdimer coupling J⁰. As shown by the solid line in Fig. 4 the t for T > 25K yields a good description of the experimental data for J = 60K, J⁰ = 53K, and g = 1:48. Our value of J is close to the neutron scattering result J' 64K [8, 10, 12, 13], whereas our J⁰ is signi cantly

larger than the largest interdimer coupling (37 K) and our g factor is signi cantly smaller than $g_{010} = 2.06 \text{ ob-}$ tained by ESR [20]. One has to expect quantitative discrepancies due to our oversimplied model. However, this does hardly a ect the following analysis of the relative variations around the maximum of (T) arising from pressure-dependent changes of J or J⁰, because the main result is obtained from the signs of the uniaxial pressure dependencies of and , respectively.

Let us discuss the case that increases as it would under uniaxial pressure on (010). This may result either from an increase of J or from a decrease of J^0 . For both cases (T) can be modeled by Eq.2. As shown in Fig. 4 the maximum max decreases if J increases (dashed line) whereas max increases if J^0 decreases (dotted line). Thus, the sign of the uniaxial pressure dependence of max allows an unambiguous decision whether the uniaxial pressure dependence of results from a change of J or of J^0 . Measurements of under uniaxial pressure do not exist. However, the uniaxial pressure dependence of is related to the magnetostriction by a Maxwell relation, and $_i / H^2$ is expected for a param – agnetic material with M = H, i.e.

As shown in Fig. 2c, the relation $_{i}$ / H² is indeed fulled and for the discussed case one nds $_{010} > 0$ (upper panel), which implies @ $_{m ax}$ =@p₀₁₀ < 0. A decreasing $_{m ax}$ m eans that the intradim er coupling J increases (see Fig.4). The same argum entation with inverted signs for all the uniaxial pressure dependencies is valid for pressure on (102). Thus, J is the relevant parameter which changes under pressure!

The anisotropy of $\frac{\theta_{max}}{\theta_{p_1}}$ for i = (010) and $(10\overline{2})$ agrees well with that of $\frac{\theta_{max}}{\theta_{p_1}}$. This indicates that J^0 hardly

changes under pressure [24]. Setting $\frac{\theta J^0}{\theta p_i} = 0$, our model yields $\frac{\theta \ln m ax}{\theta p_i}$ / $0.7 \frac{\theta \ln J}{\theta p_i}$ and allow s us to estimate

 $\frac{2 \ln J}{2 \ln \sqrt{2}}$ ' $34 \frac{\%}{GPa}$ and $\frac{2 \ln J}{2 \ln \sqrt{2}}$ ' $+ 39 \frac{\%}{GPa}$:

The relative changes of J are much sm aller than those of , but because is much sm aller than J, the absolute changes of J and are not too di erent (22 K/GP a and

14K/GPa, respectively). This can be interpreted as follows. The pressure-induced change of J causes mainly a shift of the center of mass of the triplet excitations, but hardly changes its bandwidth. This is completely di erent from what is observed when Tl is substituted by K: The triplet excitations of KCuCh have a much smaller bandwidth than those of TLCuCk. Our analysis of the pressure dependencies clearly shows that this smaller bandwidth is not a consequence of chemical pressure, although K $^+$ is signi cantly sm aller than T l^+ . Thus the very dierent values of J^0 in KCuCh and TLuCh mean that the K^+ and TI^+ ions directly in uence the e ective interdimer coupling. This conclusion has been proposed also from a bandstructure calculation [19] and is now experimentally con med by our data. The smaller J⁰ arises most probably from a weaker overlap via the small [Ar] shell of K^+ than via Tl^+ with the con quration $X = [4f^{14}5d^{10}6s^2]$.

Although it is, in general, di cult to predict the microscopic changes under (uniaxial) pressure, one m ay understand qualitatively the uniaxial pressure dependencies of J in a simple microscopic picture. The dimers are form ed by the Cu^{2+} spins of two neighboring $CuCl_{k}$ octahedra, which are connected via a common edge of their basal planes. The Cu{Cl{Cu bond angle am ounts to ' 96 . Thus the weak antiferrom agnetic coupling of T LC uC 1/2 agrees with the expectation of the G oodenough-K anam ori-Anderson rules that the coupling changes from weakly ferro-to strongly antiferrom agnetic when the Cu { Cl{Cu bond angle increases from 90 to 180. Since the line connecting the two Cl ions and the [010] direction have an angle of about 29, one may expect that pressure along [010] will shorten the Cl{Cldistance. This would increase the Cu{Cl{Cu bond angle and enhance J. The opposite m ay be expected for pressure along [201], since this direction has an angle of about 25 with the connection of the Cu^{2+} ions, and a shortening of the $Cu\{Cu\}$ distance would lower the Cu{Cl{Cu bond angle and decrease J. The norm alof the $(10\overline{2})$ plane is nearly perpendicular to both, the Cu{Cu (' 82) and the Cl{Cl line (' 77). Thus one may expect that pressure on the (102) plane will hardly change the Cu{Cl{Cu bond angle, but will slightly increase both the Cu{Cu and the Cl{Cldistance. Therefore the Cu{Cldistances will increase and J decreases, since the overlap between the Cu-3d and C 1-2p orbitals becom es weaker.

In summary, we have presented high-resolution mea-

surements of thermal expansion and magnetostriction perpendicular to the (010) and $(10\overline{2})$ planes of T \mathbb{C} uC \mathbb{L}_{1} . For both directions the eld-induced Neel order causes very pronounced anom alies, which allow a detailed determ ination of the phase boundary. There is essentially no hysteresis as expected for a second-order phase transition. The anom alies signal huge uniaxial pressure dependencies of the phase boundary, e.g. 185% /GPa for the spin gap obtained from H_c (OK) with the signs depending on the direction of pressure. Large uniaxial pressure dependencies of opposite signs are also present for the susceptibility around 40K.Our analysis unam biguously reveals that the huge pressure dependencies of arise from pressure-dependent changes of the intradim er coupling, whereas changes of the interdimer coupling play a minor role. Thus, the smaller interdimer coupling in KCuCk compared to TLCuCk is clearly not a consequence of chem ical pressure.
