The low-energy electronic structure and the orbital magnetism in N iO

The orbital and spin m om ent of the N f^+ ion in N iO has been calculated within the quasiatom ic approach. The orbital moment of 0.46 B amounts at 0 K, in the magneticallyordered state, to about 20% of the total moment (2.45 B). For this outcome, being in nice agreem ent with the recent experim ental nding of the orbitalm om ent, taking into account the intra-atom ic spin-orbit coupling is indispensable.

1. Introduction

N iO attracts large attention of the magnetic community by more than 50 years. Despite of its sim plicity (two atoms, NaCl structure, well-de ned antiferrom agnetism (AF) with $T_{\rm N}$ of 525 K) and enormous theoretical and experimental works the consistent description of its properties, reconciling its insulating state with the un led 3d band is still not reached [1, 2, 3, 4, 5].

The aim of this paper is to report the calculations of the magnetic moment of Nio. We attribute this m om ent to the N \hat{I}^+ ions. We have calculated the m om ent of the N \hat{I}^+ ion, its spin and orbital parts, in the N iO $_6$ octahedral com plex and the orbital m om ent as large as 0.46 $_{
m B}$ at 0 K has been revealed. The approach used can be called the quasi-atom ic approach as the starting point for the description of a solid is the consideration of the atom ic-like electronic structure of the constituting atom s/ions, in the present case of the N 1^{2+} ions.

2. Theoretical outline

We have treated the 8 outer electrons of the N i^{2+} ion as form ing the highly-correlated electron system $3d^8$. Its ground term is described by two Hund's rules yielding S=1 and L=3, i.e. the ground term ³F [6]. Such the localized highly-correlated electron system interacts in a solid with the charge and spin surroundings. The charge surrounding has the octahedral sym metry owing to




FIG. 1: The calculated ne electronic structure of the highly-correlated $3\mathring{d}$ electronic system. a) the 21-fold degenerated 3F term given by two H und's rules: S=1 and L=3. b) the e ect of the cubic octahedral crystal-eld, c) the combined action of the spin-orbit coupling and the octahedral crystal eld: $E_1=+2$ m eV, $E_2=-41$ m eV.

the NaC l-type of structure of NiO.Our Ham iltonian for NiO consists of two terms: the single-ion-like term H_d of the $3d^8$ system and the d-d intersite spin-dependent term. Calculations somehow resemble those performed for rare-earth systems, see e.g. Ref. [7] and they have been recently applied successfully to 3d compounds [8, 9]. For the calculations of the quasi-atomic single-ion-like Ham iltonian of the $3d^8$ system we take into account the crystaled interactions of the octahedral symmetry and the spin-orbit coupling (the octahedral CEF parameter B_4 = +2 meV - its sign is directly related to the oxygen anion surroundings, the spin-orbit coupling constant B_8 0 = -41 meV [6], p. 399). The single-ion states under the octahedral crystaled and the spin-orbit coupling have been calculated by consideration of the Ham iltonian:




FIG. 2: The calculated temperature dependence of the energy of the three lowest levels showing the splitting of the triplet in the magnetic state (below $T_N = 525 \text{ K}$).

These calculations have revealed the existence of the ne electronic structure, Fig. 1, with the charge-form ed states containing three groups of localized states. The higher groups are at 12 and 21 eV. For low- and room temperature properties the lowest triplet, originating from the cubic subterm ${}^{3}A_{2q}$, is the most important as the higher states are not thermally populated. The triplet states are characterized by the total moment of 0 and 2.26 B. For the doublet the orbital m om ent amounts to 0.27 $_{\rm B}$. It, however, fully cancels in the paramagnetic state and reveals itself only in the presence of the magnetic eld, external or internal in the case of the m agnetically-ordered state. The magnetic eld polarizes two states of the doublet. The intersite spin-dependent interactions cause the (antiferro-)m agnetic ordering. They have been considered in the mean-eld approximation with the molecular-eld coe cient nacting between magnetic m om ents m $_d=$ (L+2S) $_B$. The value of n in the H am iltonian H $_d$ d = n $_d$ m $_d$ + $\frac{1}{2}$ m $_d^E$

has been adjusted in order to reproduce the experimentally-observed Neel temperature. The tted value of n has been found to be -122 m eV / $_{\rm B}^2$ (= 210 T / $_{\rm B}$). It m eans that the N i ion in the m agnetically-ordered state experiences the molecular eld of 518 T (at 0 K).

3. Results and discussion




FIG. 3: The calculated tem perature dependence of the N \mathring{f}^+ -ion m om ent in N io . At 0 K the total m om ent of 2.45 $_B$ is built up from the orbital and spin m om ent of 0.46 and 1.99 $_B$. The calculations have been performed for the quasi-atomic parameters of the octahedral crystal eld B_4 = +2 m eV, the spin-orbit coupling constant $_{S\ o}$ = -41 m eV and intersite spin-dependent interactions given by the moleculared coecient n = -122 m eV / $_B^2$.

The calculated value of the magnetic moment at 0 K in the magnetically-ordered state amounts to 2.45 $_{\rm B}$, Fig. 2. It is built up from the spin m oment m $_{\rm S}$ of 1.99 $_{\rm B}$ (S $_{\rm Z}$ =0.995) and the orbital m om ent m $_{\circ}$ of 0.46 $_{\rm B}$, Fig. 3. The increase of m $_{\circ}$ in comparison to the paramagnetic state, 0.27 B, is caused by the further polarization of the ground-state eigenfunction by the internal m olecular magnetic eld. The orbital moment is quite substantial being about 20% of the total

m om ent. Our theoretical outcome, revealing the substantial orbital moment is in nice agreement with the very recent experimental result of 2.2 0.3 $_{\rm B}$ for the N imoment at 300 K [10, 11]. This magnetic x-ray experiment has revealed the orbital moment of 0.32 0.05 $_{\rm B}$ and the spin moment of 1.90 0.20 $_{\rm B}$ at 300 K. From the calculated temperature dependence of the total moment, shown in Fig. 3, one sees that the calculated by us moment at 300 K amounts to 2.20 $_{\rm B}$ (m $_{\rm S}$ = 1.79 $_{\rm B}$, m $_{\rm O}$ = 0.41 $_{\rm B}$) fully reproducing the experimental result. The ground state triplet is further split by the trigonal distortion and/or by the internal molecular eld as shown in Fig. 2. Exect of the small trigonal distortion experimentally observed will be discussed elsewhere. It turns out that the trigonal distortion is important for the detailed formation of the AF structure and the direction of the magnetic moment but it only slightly in unexes the spin and orbital moments.




FIG. 4: The calculated temperature dependence of the 3d contribution to the heat capacity of N iO. The spike peaks to 214 J/K m ol. This calculated c_d (T) dependence is in nice agreement with experimental data shown of Refs 12 and 13, where the spike reaches a value of 272 J/K m ol.

We would like to point out that the evaluation of the orbital moment is possible provided the intra-atom ic spin-orbit coupling is taken into account. It can must he importance of the spin-orbit coupling for the description of the 3d-ion compounds despite of relative weakness of the spin-orbit coupling. The present model allows, apart of the ordered moment and its spin and orbital components, to calculate many physically important properties like temperature dependence of the magnetic susceptibility, temperature dependence of the heat capacity (shown in Fig. 4), the spectroscopic g factor, the ne electronic structure in the energy window below 3 eV with at least

20 localized states, Fig. 1. The spike-like peak at T_N is in perfect agreement with experimental data [12] obtained on a single-crystal specimen that yields "very large, very narrow peak of 65 cal/K m ol" [13]. M oreover, we have got that the magnetically-ordered state of N iO has lower energy than the paramagnetic one by $3.4~\rm kJ/m$ ol (= $35~\rm m\,eV/ion$) at $0~\rm K$. Of course, the energies of magnetic and paramagnetic states become equal at T_N .

Finally, we would like to point out that our approach should not be considered as the treatment of an isolated ion only -we consider the N \dot{f}^+ ion in the oxygen octahedron. The physical relevance of our calculations to macroscopic N \dot{i} O is obvious - the NaCl structure is built up from the edge sharing N \dot{f}^+ octahedra.

4. Conclusions

The orbital and spin m om ent of the N 2 ion in N io has been calculated within the quasi-atom ic approach. The orbital m om ent of 0.46 $_{\rm B}$ am ounts at 0 K in the magnetically-ordered state, to about 20% of the total m om ent (2.45 $_{\rm B}$). For this theoretical outcome, being in nice agreement with the recent experimental inding, taking into account the intra-atomic spin-orbit coupling is indispensable. In our atomic approach we take two Hund's rules to be valid for description of the ground state of the N 2 ion - it means that according to our model the N i atom s preserve their atomic electronic structure also being the full part of a solid. The presented approach explains in a very natural way the insulating state of N io - in fact, N io is one of the best insulators. G ood description of many physical properties indicates that 3d electrons in N io are in the extremely strongly-correlated limit. In contrary to many considerations yielding a continuous electronic

structure our atom ic approach yields the discrete energy states for 3d-electrons in N iO and is in the thinking line of the atom ic considerations of R efs. [10] and [11]. As an extra result, these studies have revealed that the N \hat{r}^+ ion is the Jahn-Teller ion.
