## Therm alm elting of density waves on the square lattice

We present the theory of the elect of therm all uctuations on commensurate p p density wave ordering on the square lattice (p 3, integer). For the case in which this order is lost by a second order transition, we argue that the adjacent state is generically an incommensurate striped state, with commensurate p-periodic long range order along one direction, and incommensurate quasi-longrange order along the orthogonal direction. We also present the routes by which the fully disordered high temperature state can be reached. For p = 4, and at special commensurate densities, the 4 4 commensurate state can melt directly into the disordered state via a self-dual critical point with non-universal exponents.

I. IN TRODUCTION

A variety of rem arkable recent low tem perature scanning tunneling m icroscopy (STM ) observations have revealed periodic modulations in the local density of states of the cuprate superconductors<sup>1,2,3,4</sup>. Notably, the observations of H anaguri et al<sup>3</sup> C a<sub>2 x</sub>N a<sub>x</sub> C uO <sub>2</sub>C  $l_2$  clearly show that the m odulations have a commensurate period of 4 lattice spacings along both directions of the underlying square lattice (4 4 ordering). C losely related, but not identical, modulations have been observed in higher tem perature STM<sup>5</sup>, and in neutron scattering<sup>6,7,8,9</sup> observations. The di erences between the various experiments relate (i) to the period of the ordering, which is incommensurate in Ref. 5, and (ii) to whether the ordering extends along one or both of the x and y axes neutron scattering experiments are more easily explained by an isotropic ordering along one of the axes directions<sup>10,11,12</sup>. An im portant open question is whether these di erences re ect a fundam ental distinction in the underlying electronic structure of the cuprates, or they can be explained by the di ering experim ental param eters of tem perature and carrier concentration.

This paper will begin with the assumption that at very low T, for a sm all range of carrier densities, and in a su ciently clean sample, the system has perfect 4 4 density wave order (and, more generally, p p order with p 3, integer). W e will then present a general phenom enological theory of the e ect of therm al uctuations on such an ordered state, describing the phases that appear at higher T and for a wide range of carrier concentration. Because we focus exclusively on therm al uctuations, our results are quite general and independent of the precise m icroscopic nature of the density wave ordering; in particular, the ordering could be a site charge density wave, or a modulation in exchange or pairing energies due to valence bond solid order. Our results depend only on the fact that spin-singlet observables acquire a periodic m odulation at low T, and follow completely from the symmetry properties of such states. The therm al uctuations of such an ordered state can, and will, be described by a purely classical theory of the density wave order param eters.

There is a actually large early literature on the melting of a variety to two-dimensional solids on di erent substrates, and on the commensurate-incommensurate transition<sup>13,14,15,16,17,18,19,20</sup>. However, most of this work considered the case of the triangular solid on substrates with six-fold symmetry, or the commensurate-incommensurate transition on anisotropic solids. The particular case of interest here, a square lattice substrate and isotropic p p ordering, appears not to have been considered previously. We will therefore present an extension of this earlier theory to the situation appropriate for the cuprate superconductors. As we will show below, our results have a num ber of novel features not found in the cases studied earlier.




FIG.1: Mean eld phase diagram of the free energy F Eq. (2.4). Although all parameters in F are functions of both tem perature and carrier concentration, the vertical axis above, s, is primarily a function of tem perature. The horizontal axis is tuned by -, which is mainly a measure of carrier concentration away from the commensurate value appropriate to the p p ordered state. There are three stable m ean eld phases separated by a rst order transition (thick line), a second order transition (solid line), and a second-order critical point at s = - = 0. The phases A, B, C, are described in the text. For phases A and B we show a schematic of the density m odulation (r) for the special case p = 4, with the points representing the underlying lattice. Upon including uctuations, the transition between phases A and B can become second-order; in this situation the phase adjacent to phase A is a new phase B<sub>s</sub>, the incommensurate striped phase. The phase B<sub>S</sub> preempts a portion (or all) of phase B. See Fig 4 for the uctuation-corrected phase diagram of phases A and в.

W e will begin in Section II by de ning the order param eters of the commensurate p p solid on the square lattice. Symmetry considerations then allow us to obtain a phenomenological free energy density controlling therm al uctuations of the order parameter, and a corresponding mean eld phase diagram shown in Fig. 1. At this stage, this phase diagram contains 3 phases whose characteristics we summarize below:

(A) C om m en surate solid: This is the ground state with long-range density wave order with period p along both the x and y axes.

(B) In commensurate, oating solid: In mean eld theory, this phase has density waves with the same incommensurate period along both the x and y directions. This order is only quasi-long-range i.e. density wave correlations decay with a power-law at long distances.

(C) Liquid: This is the high temperature phase in which all density wave correlations decay exponentially with distance.

The remainder of the paper will consider uctuation corrections to this mean eld phase diagram .

In mean eld theory, the transition between phases A and B is rst order, with a jump in the period of the density wave from a commensurate to an incommensurate value. We know from previous work on anisotropic phases<sup>15,17,18,19</sup> that such commensurate-incommensurate transitions are driven by the proliferation of dom ain walls, and we consider the dom ain wall theory for such a transition in Section III. In our case there are two sets of dom ain walls, running predom i

nantly in the x and y directions, and a key parameter will be the intersection energy,  $f_{T}$ , of these dom ain walls. If  $f_I < 0$ , then the mean eld prediction of a rst order transition to an isotropic oating solid is maintained. However, for the case of a positive intersection energy  $(f_{I} > 0)$ , we will demonstrate that there is a second order transition to an anisotropic, incommensurate striped" state, which we denote B<sub>S</sub>. The B<sub>S</sub> state has commensurate long range order with a period of p lattice along one axis, and incommensurate quasi-longrange order along the orthogonal axis. Because B<sub>S</sub> has long-range order only along one direction, it m ay also be labelled a 'sm ectic' $^{21,22}$ ; how ever the presence of the underlying lattice makes its uctuations quite di erent from a conventional sm ectic liquid crystal. The striped solid  $B_S$  will replace a portion of phase B, so that  $B_S$  covers at least the entire second-order phase boundary to phase A (see Fig 4). The remainder of phase B could remain an isotropic oating solid, or it could be anisotropic in its entirety.

Section IV will consider the transitions from the incommensurate states in phase B to the disordered liquid C.Two distinct scenarios are possible, depending upon the whether the transition takes place from an isotropic oating solid B, or from the anisotropic solid (B<sub>S</sub>) which has incommensurate order along only one axis. In either case, the transition is driven by the unbinding of dislocations<sup>13,14</sup>, and the complete theory for such transitions will be presented.

Finally, Section V will present the theory of the direct transition from the commensurate p = p solid A to the liquid state C. From Fig. 1 it appears that such a transition is only possible at special commensurate values of the density. For the physically relevant case of p = 4 we will not that a direct second order transition is possible. It is described by a self-dual theory with continuously varying exponents, and is a generalization of the theory found in Ref. 23 for the XY m odel.

# II. ORDER PARAM ETERS AND MEAN FIELD THEORY

As noted in Section I, all phases and transitions exam ined here are associated with the order of a generic density', which could be any observable invariant under spin rotations and time reversal. We represent this density by (r). At su ciently low temperatures, in weak disorder, and for some range of carrier concentration, we assume that this density prefers to order with a period of plattice spacings (p = 4 is the case of interest for the cuprates). We can therefore write

where  $K_x = (2 = a) (1=p;0)$ ,  $K_y = (2 = a) (0;1=p)$ , and  $x_{iy}$  are complex order parameters which vary slow ly the on the scale of a lattice spacing.

We now want to write down the most general free energy for  $_{x,y}$  consistent with the symmetries of the underlying lattice. Among these are  $T_{x,y}$  which translate by a lattice spacing in the x;y directions, and  $I_{x,y}$  which re ect the x;y axes. These operations lead to

This symmetry is absent in some of the cuprate com pounds (most notably, in YBCO), and it is not di cult to extend our considerations to include this case.

We can now write down the most general free energy density, expanded in powers of  $x_{iy}$  and its gradients, consistent with the symmetries in Eqs. (2.2) and (2.3)

(see also Refs. 24 and 25). This is

Here s is a parameter which we will tune to drive the transition; it is assumed to contain the primary dependence on temperature, and will also have some dependence on carrier density.

The term proportional to - is allowed by the symmetries. It indicates that at su ciently high temperature, the density correlations are generically incommensurate. This incommensurability is a consequence of the values of the domain wall energies between the p commensurate ordered states<sup>16,20</sup>: a domain wall between state 1 and state 2 (say) will generally have a di erent energy than a domain wallbetween state 1 and state p. In other words, if we represent the p states along one direction by a p state clock model, then the interactions of the clock model are 'thiral'.<sup>16</sup>

The sign of the parameter v implies a preference for either isotropic order (v < 0 prefers both h  $_xi$  and h  $_yi$  non-zero), or anisotropic order (v > 0 prefers only one of h  $_xi$  or  $_y$  non-zero). We will assume throughout this paperthat v < 0, so that h  $_xi$  and h  $_yi$  are both non-zero at su ciently low temperatures. Nevertheless, we will nd that therm al uctuations can induce an anisotropic striped state over an interm ediate temperature range.

The complex parameter w accounts for the commensurability lock-in energy. It ensures that at su ciently low temperatures (speci cally, fors su ciently negative), the order has a commensurate period of plattice spacings. For v < 0 (assumed throughout), the ordering will be platter phase of w controls the phase of this ordering (Site-centered' or bond-centered'). None of our results will be sensitive to this phase, and will apply equally to all of them.

## A. M ean eld theory

Now we present the results of a simple mean eld minim ization of F , leading to the phase diagram in Fig.1. As described in the introduction we nd three distinct phases. The low temperature ground state, labelled by A has long rage density wave order with period p characterized by

The inset in Fig.1 A shows the locked in solid for the special case of a bond-centered phase with p = 4 where the positions of the underlying atom s are indicated by the light gray circles. This commensurate phase has a rst order transition described by the line

The magnitude of both  $_x$  and  $_y$  are equal and they have the same incommensurate period along perpendicular directions. For the special case of p = 4 the oating state is shown as an inset in Fig.1 B. The oating solid can melt via a second order phase transition de ned by the line

to a fully disordered state C with  $_x = _y = 0$ . Finally, there is a tri-critical point for s = - = 0 where the com - mensurate solid A can melt directly to the liquid phase C.

## III. DOMAIN WALL THEORY OF THE COMMENSURATE -INCOMMENSURATE TRANSITION

In Section IIA we found a mean-eld rst order transition between the commensurate p p solid A and the incommensurate, isotropic oating solid B. This section will examine uctuations near this transition more carefully. We will not that the transition can actually be second order under suitable conditions, and the secondorder order transition is to an anisotropic, striped state with commensurate p period order along one direction, and incommensurate order along the orthogonal direction.

For our study of the initial melting of the commensurate ordered state, we will assume that dislocations can be ignored. The e ect of dislocations will be considered in Section IV, and we will then verify the self-consistency of this assumption. Instead, the primary actors will be domain walls between the commensurate states, as is also the case in previous theories<sup>15</sup> of the commensurateincommensurate transition in anisotropic systems.

In the absence of dislocations, we can focus on globally de ned single-valued angular variables  $x_{xy}$  with

Note that the values of  $_{x,y}$  span over all real numbers, and not just modulo 2 . However, periodic boundary

All terms above are, in principle, obtained from those in Eq. (2.4), but now we have retained terms up to second order in spatial gradients. Now, the incommensuration is induced by the total derivative terms proportional to

: these are non-zero because the angular elds can accumulate an integer multiple of 2 even under periodic boundary conditions. Sim ilarly, we do not have the freedom to integrate by parts, and so combine the term sproportional to K<sub>3</sub> and K<sub>4</sub>. The commensurability energy is now imposed by the p-fold eld  $h_p$ .

W e willbegin in Section IIIA by describing the meaneld structure of the domain wall (or 'soliton') excitations of F . Then, in Section IIIB we will present the theory of the commensurate-incommensurate transition driven by the proliferation of these domain walls. Section IIIC will address the nature of density uctuations within the incommensurate phases: we will estimate the elastic constants of these phases using the domain wall theory of Section IIIB.

#### A. Energetics of dom ain walls

Consider starting at low tem peratures from a fully ordered two-dimensional crystal. In this state  $_x = 2$  n=p,  $_y = 2$  n<sup>0</sup>=p, where n, n<sup>0</sup> are integers, at all points in space. We are now interested in the deviations from this perfectly ordered state as measured by the continuum free energy F in Eq. (3.2).

The simplest deviation is a single line dom ain wall in which  $_{\rm x}$  increases by 2 =p across the dom ain wall. For

> 0 (which we assume, without loss of generality), such a dom ain wall will preferentially run in the y direction i.e. the dom ain wall has  $_{\rm y}$  constant, and  $_{\rm x}$  a function of x only. The x dependence of  $_{\rm x}$  can be determined by the sine-G ordon saddle point equation

Similarly, there is a corresponding domain wall in  $_{y}$ , with identical physical properties.

Now we consider the interesting case with domain walls running in both the x and y directions. These walls will intersect, and we are interested in the nature of the intersection, and of the intersection free energy  $f_I$ . We can focus in on a single domain wallcrossing by in posing the boundary conditions of Eq. (3.4) in both the x and y directions. For the special case of perfectly straight domain walls, x(x;y) = x(x) and y(x;y) = y(y), the only interaction term in Eq. (3.2) can be integrated exactly to give




FIG.2: Eight possible con gurations of the free energy density for domain wall crossings depending on the numerical values of K<sub>2</sub>, K<sub>3</sub> and K<sub>4</sub> with p = 4. The grey scale plots the size of the local free energy density and all sti nesses and energies are in units of K<sub>1</sub>. Panels a. through h. show decreasing domain wall intersection energy f<sub>I</sub>, and for straight walls, the numerically computed value can be compared with ( $^{2}$ =4)K<sub>4</sub>.

indicating that the sign of the dom ain wall intersection energy is equal to the sign of K<sub>4</sub>. W hen the dom ain walls are not straight, the interaction energy can be found by num erically m in im izing F and evaluating the interaction terms at the ground state eld con gurations as seen in Fig.2. For the following discussion we refer to Fig.2 and it is assumed that all stinesses are measured in units of  $K_1$ . For positive values of  $K_4$  and  $K_2 = 1.0$  (panels a through c) we observe straight dom ain walls for K  $_3 < K_2$ and only observe deviation when K  $_3$  ' K  $_2.$  In panel d,  $K_3 ' K_2 < K_4$  and we nd that the walls wander quite signi cantly. Panels a through d all have  $K_4 > 0$  and in agreem ent with our earlier discussion,  $f_I > 0$  in all four con gurations. Panele has no interaction term s (K  $_3$  =  $K_4 = 0$ ) and consequently  $f_I = 0$ . For negative values of  $K_4$  we nd that the domain wall intersection energy changes to a negative value. For  $K_3 j < K_2$  the walls remain straight (panels f and g) but as K  $_3$  ' K  $_4$  ' K  $_2$ the intersection energy becom es large and negative and the system attempts to extend the domain wall overlap over a nite region (panelh).

A lthough we have only presented eight distinct con gurations here, all of the K<sub>j</sub> parameter space was examined. W hen the magnitude of K<sub>3</sub> and K<sub>4</sub> are small with respect to K<sub>2</sub> and K<sub>1</sub> we always nd con gurations with domain walls crossing at right angles where the domain wall intersection energy can be calculated using Eq. (3.7).

#### B. Proliferation of dom ain walls

Now we in agine increasing the parameter so that the total free energy per unit length of a dom ain wall is eventually negative. In such a situation we expect a proliferation of dom ain walls, leading to the appearance of a oating solid with incom mensurate density correlations. This section will discuss the theory of such a transition.

Let the incom m ensurate state have dom ain walls in  $_{\rm X}$  with an average spacing  $`_{\rm X}$ , and dom ain walls in  $_{\rm Y}$  with an average spacing  $_{\rm Y}$ . From the energy per unit length of these dom ain walls, and their intersection energy, com – puted in Section IIIA, there is a clearly a contribution to the free energy per unit area, F  $_{\rm d}$ , given by (see Fig.2)




FIG.3: A net of wandering dom ain walls constructed using random walkers on a lattice with both hard-core repulsion and restricted phase space. If the dom ain walls are separated on average by a distance 'x in the x direction and 'y in the y direction, then we observe collisions between dom ain walls running in the same direction with separation on the order of  $\frac{v_x^2}{v_y}$  or  $\frac{v_y^2}{v_y}$  ('x = 'y here).

However, in addition to the simple energetic contributions in Eq. (3.8), we also have to consider the entropic contribution of the wandering of the dom ain walls (Fig. 3). This can be computed using the elegant free ferm ion mapping of Pokrovsky and Talapov<sup>15</sup>, which applies here (essentially unchanged) separately to the dom ain walls in each direction. Brie y, the argument runs as follows. Let  $u_x$  (y) represent the x co-ordinate of a dom ain wall in x. Any y dependence in  $u_x$  increases the total length of the dom ain wall, and so leads to a free energy cost

Now the partition function at a temperature T of such dom ain walls can be mapped onto that for free ferm ions with a density  $1='_x$  and mass =T. From the ground state energy of such a free ferm ion system, we then obtain the contribution of the wandering of the dom ain walls to the free energy density

We are now faced with the simple problem of minim izing the free energy density

as a function of  $'_x$  and  $'_y$  to determ ine the nature of the commensurate-incommensurate transition. This simple




FIG.4: Phase diagram of the commensurate-incommensurate transition obtained by the minimization of Eq. (3.11) over the values of the mean domain wall spacing 'x and 'y.

calculation turns out to have some interesting structure which we will now describe. The results of such a minim ization are summarized in Fig 4. The nature of the phases appearing here depends upon the sign of the domain wall intersection energy  $f_{\rm I}$ .

For negative  $f_{\rm I}$  corresponding to K  $_4 < 0$  in F , as we increase the value of the mean eld prediction is preserved, and the ground state with long range charge density wave order melts via a rst order transition to an isotropic incommensurate oating solid which we labelled as B. This transition occurs when

which has dom ain walls running in either the x or y direction but not both. This anisotropic oating solid or incommensurate striped state which we labelB<sub>S</sub> has long range charge density wave order with period p in one direction and quasi long range order with power law decay in the perpendicular direction. Near the second-order transition between A and B<sub>S</sub>, insertion of Eq. (3.15) into Eq. (3.11) shows that F<sub>d</sub> (2 =p)<sup>g=2</sup>.

As  $% A_{\rm S}$  is increased further for  $f_{\rm I}$  > 0, the phase  $B_{\rm S}$  persists until

where there is a rst order transition to the isotropic incommensurate oating solid B with  $`_x$  and  $`_y$  stillgiven by Eq. (3.13). In fact, the solution in Eq. (3.13) is a local m inim um of the free energy for all > p = (2). However, its free energy behaves like  $F_{\rm d}$  ( $2 = p \hat{f}$  upon approaching phase A . C base enough to phase A , this free energy is always larger than the free energy for phase  $B_{\rm S}$ .

Therefore, if the intersection energy for domain walls is positive, the melting of the commensurate solid A always occurs via a second-order transition to the striped anisotropic state  $B_{\rm S}$ .

# C . R enorm alization of elastic constants in incom m ensurate phases

Once the domain walls have proliferated in phases B and  $B_s$ , the density correlations become incommensurate and appear at wavevectors which are shifted from the commensurate values in Eq. (2.1). We are interested here in the long wavelength \spinwave" density uctuations about this incommensurate state.

First, let us consider the phase B.R ather than de ning the spin-wave variables about the commensurate state as in Eq. (3.1), we now need to look at uctuations above an incommensurate ordered state. So now we write

It is not dicult to see that this action in the oating phase B has the same structure as F in Eq. (3.2), except that now = h = 0:

An important point is that the sti nesses K<sub>1 4</sub> in Eqs. (3.18) and (3.19) be strongly renorm alized from the bare values in Eq. (3.2). Follow ing the analysis of R ef. 17, we will now estimate their renorm alized values K<sub>1 4</sub><sup>R</sup> in terms of the parameters appearing in the domain wall free energies in Section IIIB (the superscript R will be used for clarity only in this subsection).

First, in agine that we impose a uniform compressional strain  $@_{x x}$  on the oating solid. On the average, this will cause the dom ain walls to move closer to each other, and change the value of 'x to 'x 'x. Because x changes by 2 =p across each dom ain wall, we conclude that  $@_{x x} = (2 = p)$  'x =  $\frac{2}{x}$ . The change in 'x will cause a change in free energy that can be computed from Eq. (3.11), and so we conclude

Consequently there is no change to the free energy beyond that already accounted for by K $_2^R$ , and hence

# IV. DISLOCATION MEDIATED MELTING OF FLOATING SOLIDS

W e will now consider the transition from the isotropic oating solid B and the striped oating solid  $B_s$  to the disordered liquid phase C. These transitions are driven by the unbinding of dislocations.

W ith the param eters of the \spin-wave" theory at hand in Section IIIC, we can address the energetics of the the dislocations. We will derive the elective action for the dislocations in Section IV A and then obtain the renormalization group (RG) ow equations in Section IV B.

### A. D islocation interactions

For the m ost part, this section will be restricted to a discussion of dislocations in phase B. The simpler case of the anisotropic phase  $B_S$  is easily obtained by only including those terms arising from the uctuations of  $_x$ .

D is locations are simply 'vortices' in the angular elds  $_{\rm x,v}$  under which

where  $m_{x,y}$  are integers at the vortex (i.e. dislocation) site  $r_v$ , and the integral is over a contour that encloses  $r_v$ . Each dislocation is therefore characterized by a doublet of integers ( $m_x$ ; $m_y$ ).

To compute the interactions between these vortices, it is useful to de ne continuum vortex densities by

At this point these de nitions of the  $\[mathcal{R}^2_1\]_4\]$  m ay be viewed as arbitrary variables, but we will see later in Section V and Appendix B that these are the couplings that appear in a self-dualm apping of the theory F . Also, from

Appendix B, note that the  $\Re_{1-4}$  couplings appear upon taking the inverse of the matrix of couplings between the strains in F<sub>B</sub>; consequently, the inverse expressions for the K<sub>1-4</sub> in terms of the  $\Re_{1-4}$  have exactly the same structure as in Eq. ## B. Renorm alization group ow s

W ith the knowledge of the interactions between the dislocations, the renorm alization group equations can be derived by the methods already described in Refs. 13 and 14. We introduce a vortex fugacity,  $y = e^{E_c = T}$  and exam ine the elect of integrating out pairs of dislocations in an expansion in powers of y. A simple and standard analysis shows that the low equation for the fugacity is

The renorm alization of the K<sub>i</sub> from the vortices can be computed by the method described in Appendix B of Ref. 14. We compute the renorm alization of the elastic constants, K<sub>i</sub> by determ ining the contribution of the vortices to a two-point correlation of the strains. Such a procedure leads naturally to ow equations for the 'inverse' or 'dual'  $\mathcal{R}_i$  couplings, and we obtain

W hile complex in appearance, the ow equations Eq. (4.12) and (4.14) predict a melting transition of the oating phase B into the liquid phase C which is in a universality class closely related to that of the K osterlitz-Thouless (KT) transition. The phase B is stable provided  $\mathbf{\hat{E}}_0 > 8 = (p^2 T)$ . Evaluating  $\mathbf{\hat{E}}_0$  at the values of the  $K_i^R$ determined in Section IIIC, we nd that phase B is stable everywhere for p = 4 towards an in nitesim al vortex fugacity for the elastic constants in the dom ain wall theory; this justi as the neglect of dislocations in our study of dom ain wall proliferation in Section III. The present equations Eq. (4.14) show how phase B will ultimately become unstable to a vortex unbinding transition once the vortex fugacity becomes larger. The ow equations in Eq. (4.14) imply singularities in the elastic constants just before the melting transition which can be computed as in Ref. 26. Som e of the universalam plitude ratios here willbedi erent from the KT transition, but all exponents and critical singularities will be as in the KT transition.

The ow equations for the melting of the anisotropic phase  $B_S$  can be easily obtained from Eq. (4.14) simply by setting  $K_3 = K_4 = 0$ . In this case, the values of the elastic constants in Section IIIC and Eq. (4.10) imply that

The equation for the vortex fugacity Eq. (4.12) in plies then that the vortex fugacity ows to zero as long as  $1^7$   $p^2 > 8$ , which is certainly the case for p > 3. Hence the oating phase  $B_S$  is also initially stable to dislocation unbinding. At higher temperatures, there can be a dislocation unbinding transition in the K osterlitz-Thouless universality class. Note that in this sequence of transitions, even after such a transition has occurred from the phase  $B_S$ , order has only been lost in x direction, and commensurate long-range order remains in  $_y$ . So the system is still strongly \striped" and anisotropic. Full isotropy will be restored only after a second set of similar transitions in  $_y$ , and then a dislocation unbinding transition to the liquid phase C.

## V. DIRECT MELTING OF THE COMMENSURATE SOLID

A swe noted in Section I and F ig 1, it is possible that the low temperature 4 4 commensurate solid can melt directly into the high temperature liquid state. In the theories F in Eq. (2.4) and F in Eq. (3.2), such a transition appears possible at commensurate densities at which  $\overline{\phantom{0}} = 0$ . So this section will neglect the in unce of

and perform a full renormalization group analysis of the theory F, including both dislocations and the p-fold lock-in eld h.

A key property which aids the analysis is a self-duality of the action in which the dislocation fugacity, y, and the lock-in eld h are interchanged. The origin of this self-duality is similar to that discussed in Ref. 23, and we present a brief derivation in Appendix B. From this analysis we obtain the the partition function F , including dislocations, obeys

W e will con ne our analysis of Eq. (5.2) to the physically in portant case of p = 4. For this case, we rst searched for an interm ediate phase with power-law correlations: such a phase would obtain if there was a set of values of K<sub>1 4</sub> for which both y and h owed to zero. As shown in Appendix A, there is no such regime of param – eters.

However, the ow equations in Eq. (5.2) do predict a direct second-order transition between the 4 d com – m ensurate solid A and isotropic liquid C. This transition is described by a manifold of xed points. In the 6-dim ensional space of couplings, there is 2-dim ensional m anifold of xed points specied by

(5.2) to linear order in , K, K<sub>3</sub>, and K<sub>4</sub>, and after diagonalization of the ow equations, obtained the following renorm alization group eigenvalues in this 4-dimensional subspace:

where the last eigenvalue is doubly degenerate. It is evident that for all , there are 3 negative eigenvalues and 1 positive eigenvalue. This ow therefore describes a conventional second-order transition, with the correlation length exponent equal to the inverse of the positive eigenvalue.

## VI. CONCLUSIONS

We have shown that therm al uctuations on 4 4 ordered state lead generically to a rather rich phase diagram as a function of temperature and carrier concentration. This phase diagram generically must have regions with incommensurate and anisotropic ordering. Thus it is remains within the realm of possibility that the underlying physics of density wave ordering in all the cuprates is the same, and the distinctions between the experiments are entirely due to their distinct locations in our phase diagram.

For easy reference, we conclude by listing the various routes the 4 solid A can melt into the liquid C. The list below is not exhaustive, and om its certain possibilities involving strong rst order transitions between unrelated phases.

- 1. Phase A undergoes a second order Pokrovsky-Talapov<sup>15</sup> (PT) transition to the incommensurate striped phase  $B_s$ , as described in Section IIIB. This is followed by a rst order transition into phase B as also described in Section IIIB and F ig 4. Then phase B undergoes a dislocation mediated melting transition into phase C which is described by Eqs. (4.12) and (4.14). This last transition is in a universality class which is nearly, but not exactly, KT.
- 2.PT transition from phase A to phase B<sub>S</sub> as in 1. Phase B<sub>S</sub> then has a KT transition to a striped state which has long range order with period 4 along one direction, and exponentially decaying correlations along the other. This striped set melts into C after a second set of similar transitions: a PT transition into a state with incommensurate quasilong range order in one direction only, and then nally a KT transition in C.
- 3. First order transition from A to B as described in Section IIIB and Fig 4. Then, a transition from B to C as in 2.
- 4. At special commensurate densities, there is a direct, self-dual, second-order transition from A to C, described in Section V, with continuously varying exponents.




FIG.5: The signs of (h) and (y) in the K<sub>1</sub> K<sub>2</sub> plane for  $K_3 = 3K_2=5$  and  $K_4 = 4K_1=5$ . The line which indicates (h) = 0 always lies below the line describing (y) = 0 and consequently h and y are never both irrelevant.
