The statistics of particle velocities in dense granular ow s

We present measurements of the particle velocity distribution in the ow of granular material through vertical channels. Our study is conned to dense, slow ows where the material shears like a uid only in thin layers adjacent to the walls, while a large core moves without continuous deformation, like a solid. We not the velocity distribution to be non-Gaussian, anisotropic, and to follow a power law at large velocities. Remarkably, the distribution is identical in the uid-like and solid-like regions. The velocity variance is maximum at the core, defying predictions of hydrodynamic theories. We show evidence of spatially correlated motion, and propose a mechanism for the generation of uctuationalmotion in the absence of shear.

Granular ow sare ubiquitous in nature (rock and snow avalanches, movem ent of sand dunes) and in industrial processes (transport of food grains, ores, pharm aceutical powders), yet they are poorly understood. In the regime of dense, slow ow there is enduring contact between particles, and shear stresses are generated primarily by dry friction [1, 2]. In this regime, it is often observed [3, 4, 5]that there is uid-like deformation only in thin layers, while large regions resist continuous deform ation despite the action of a nite shear stress, like a solid. As in molecular uids, know ledge of the statistics of particle motion will enhance our understanding of the hydrodynam ics of granularm aterials, and provide insight into the m icroscopic basis of the uid-like and solid-like response. M oreover, the m arked di erence in the way dense granular materials and conventional uids respond to applied forces prompts the question of whether there is a fundamentaldi erence in their statistical nature.

P revious experim ental studies on the statistics of granular ow shave focused mainly on the rapid ow regime, where grains interact through in pulsive inelastic collisions [6, 7]. Studies on the statistics of dense, slow OW S have been far few er, perhaps due to di culties in probing dense and opaque system s. M easurem ent of the distribution of the contact forces [8] in a monolayer of disks revealan anisotropic and inhom ogeneous network of \force chains", which has also been corroborated by particle dynam ics simulations [9]. Measurem ents of particle displacem ents by an indirect, spatially averaged technique [10] and by direct particle tracking near a transparent wall [11] show di usive motion at long time scales, but the studies di er on their inferences of the microscopic mechanism at play - the form er concludes that di usion arises after repeated in pulsive collisions between particles, while the latter attribute it to a mechanism of rearrangem ent in the network of abiding grain contacts.




FIG.1: (color online) (a) A sketch (not to scale) showing the construction and dimensions of the channel. (b) A snapshot of the owing glass beads, showing the bright spots of rejected light. (c) P rolles of the mean velocity u_x , and the root-mean-square velocity uctuation v for a rough walled channel with $W = d_p = 31.7$.

In our investigation, the ow of dry, cohesionless, spherical, almost monodisperse glass beads (Fig. 1b) of mean diameter $d_p = 0.8 \text{ mm}$ through a vertical channel was studied. A hopper fed the glass beads into the chan-

nel, and the ow rate was controlled by the size of the exit slot at the base of the channel (Fig. 1a). The front and back faces of the channel were sm ooth, transparent glass plates, and the side walls were alum inium bars, which in som e experim ents were roughened by sticking 80 grit sandpaper on them . The channel width 2W and the size of the exit slot could be easily varied. On illum inating the channel from the front, the re ected light from the beads close to the front glass face were visible as bright spots (Fig. 1b). Video im ages of the owing beads were taken with a CCD camera (mounted on a translating stage) at 25 fram es/s, for at least six m inutes at each location in the channel, and transferred simultaneously to a com puter. V isual in spection of the video m ovies clearly revealed long-term contact between particles, with rubbing and rolling interactions predom inating. Each video fram e was analyzed, using standard im age analysis techniques, to determ ine the centroids of the bright spots (Fig. 1b). The velocity components c_x and c_y of the particles were determined from the displacement of the centroids between adjacent frames. To ensure that spots in adjacent fram eswere from the same particle, the velocity of a particle was determ ined only if its displacem ent was less than $d_{p}=2$, $\lim i t i n g$ the maximum measurable velocity to roughly 10mm/s. All measurements were made far enough from the entry and exit so that the ow was fully developed, i.e. the velocity eld did not vary in the direction of ow.

The proles of mean properties were determ ined by notionally dividing the channel into vertical bins of width d_p and averaging the relevant particle properties in each bin over the entire duration of the video m ovie. Figure 1c shows a typical result for the mean velocity u_x and the root-mean-square (ms) velocity uctuation v. The mean velocity increases sharply within the shear layer, from a sm allbut nite slip at the wall to the maximum value u_b , and remains constant at u_0 in the substantial core. This feature of shear banding is in agreement with previous work on ow in channels [3, 12] and cylindrical C ouette cells [4, 5]. The dependence of the shear layer thickness

on W and the material and wall properties, and a com parison of the observed mean velocity eld with predictions of available hydrodynam ic theories will be reported elsewhere [13]. Though the shear rate is negligibly sm all in the core, we nd that v is highest there (Fig. 1c); this is a surprising observation, as we expect the conversion of energy from mean to uctuational motion to be high in regions where the shear rate is high. When a liquid (or a granularm edium in the rapid ow regime [14]) is sheared, the shear rate is high in regions where the tem perature is high, as its viscosity decreases with rise in the tem perature. Our observation of the opposite here illustrates the di erence in the microm echanics between dense frictional ows and molecular or rapid granular ows: the velocity uctuations here arise from complex, collective motion, with particles contacts being sustained almost continuously, and not from particles ying between collisions with high velocity.

The distribution of velocities in the x and y directions (vertical and horizontal directions, respectively, see Fig. 1a) were determ ined as a function of position in the channel for a range of the channel width, with rough and sm ooth side walls. Our visualization technique could not resolve m ovem ent in the z direction. The probability




FIG. 2: (color online) The probability distribution function for vertical (a) and horizontal (b) particle velocity in the uidlike shear layer. The data are for four di erent channelw idths with rough walls (see text), the legend giving the ratio $W = d_p$. The un lled symbols in the main panels represent data for negative velocity uctuations, rejected onto the positive side for accommodation in the log-log plot; the lled symbols represent data for positive velocity uctuations. The inset in each panel shows the distribution in linear-log axes. The dotted line in the inset is the G aussian distribution with the same variance. The straight lines in the main panels are power-law ts for large velocity magnitude.

distribution function $f_x(x)$, where x (c_x u_x)=v is the dimensionless velocity uctuation in the vertical direction, was determined by making a histogram of the gumber distribution of x, and normalizing it so that $f_x(x)d_x = 1$; the distribution function $f_y(y)$ for horizontal velocities was determined similarly. Figure 2 shows the distribution function in the shear layer for rough walled channels of four di errent channel widths. We note that f_x is not symmetric about x = 0 (Fig.2a), as gravity induces a preference for downward velocities. Its decay is more rapid for negative x than for positive. There is no preferred direction for horizontal velocities and the distribution is therefore symmetric about $_y = 0$ (Fig. 2b). In both directions, the distribution function decays as a power law, $f_i(_i) = j_i j^n$, when $j_i j$ is su - ciently large.




FIG.3: (color online) C om parison of the probability distribution function in the shear layer with that in the core. The layout and symbols are as in Fig.2. The su x S' and C' in the legend indicate data for the shear layer and the core, respectively.

A striking feature of Fig. 2 is the collapse of the data for all the channel widths into a single curve. We nd that data at other locations in the shear layer and for sm ooth walls (not shown) also collapse onto the same curve. As the ow rate, and therefore the shear rate, varied between all these experiments, this implies that f_x and f_y do not depend on the shear rate, but only on the local value of v. This result is further reinforced when we compare the data in the shear layer and the core (Fig. 3); the distribution function is identical in the two regions. This is a remarkable result, as the nature of the ow in the two regions is very di erent - there is continuous deform ation in the shear layer, but none in the core. Curiously, this is similar to molecular uids at thermodynamic equilibrium, where the Gaussian distribution holds regardless of the state of aggregation. However, the distribution function away from equilibrium in molecular uids depends on gradients of the velocity and tem perature [15]. Granular ows are fundamentally far from equilibrium (indeed the owing state bears no resemblance to the equilibrium, static, state), and hence the shear-rate independence is a signi cant deviation from the statistical behavior of classical uids.

O ur results are consistent with those of R ef. [11], who observed an isotropy and non-G aussian distribution of the particle displacement over a time scale of 1 m s. How – ever, they found the distribution function changing to a G aussian on coarse graining in time, but we nd it distinctly non-G aussian even with though our camera speed was 40 times slower. We found no perceptible change in the distribution function when a faster video camera (60 fram es/s) was used [13], suggesting that our data is robust and valid over a range of time scales.

The power-law exponents were determined by tting a straight line through the data in the log-log plots for large velocities (Figs 2 and 3). For the horizontal velocity the exponent n_v is 3.6, and for the vertical velocity the exponents are $n_x^+ = 2:9$ for positive x and $n_x = 7:4$ for negative x. The faster decay of the distribution for negative x is a re ection of the preference for positive (downward) velocity uctuations that gravity induces. We do not, however, expect this form of the distribution to persist to very large velocities for the following reason: if we consider the mean velocity uctuation square, or the speci c uctuational kinetic energy $[16] v_1^2 = \frac{1}{1} (c_x - u_x)^2 f(c_x) dc_x + \frac{1}{1} c_y^2 f(c_y) dc_y; we$ nd that the st integral is unbounded because $\hbar < 3$. Thus, for the mean kinetic energy of particles to be nite, there has to be a faster decay of f_x for large positive c_x. This can be veri ed if higher particle velocities are m easured, perhaps by high speed video im aging [6, 11].

The presence of velocity uctuations even in the ab-




FIG. 4: (color online) Correlation functions of the velocity uctuation in the shear layer and the core (see text for de nitions of C_y and C_t) for a rough walled channel with $W = d_p = 31.7$. The reference point y was $4d_p$ from the left wall for the shear layer, and channel center for the core. (a) The spatial correlation as a function of the horizontal separation Y, and (b) the time correlation as a function of the time delay T.

sence of a shear rate has been established in earlier studies [10, 11] on dense granular ows. Our observation that v is highest in the core is somewhat more surprising, as hydrodynam ic theories [17] give the transfer of kinetic energy from mean to uctuational motion as the product of the shear stress and the shear rate, predicting that v is minimum at the core. A plausible explanation for the production of velocity uctuations in the absence of shear is provided by considering the spatial correlation of the velocity uctuation, de ned as $hc_x^0(t;y)c_x^0(t;y+Y)$ i. Here $c_x^0(t;y)$ is the in-C_v (Y) stantaneous uctuation velocity averaged over particles in the bin centered at the reference point y, $\overline{c_x^0}$ (t; y + Y) is the same in the bin centered at y + Y, and the angle brackets indicate an average over time. Figure 4a shows that $C_v(Y)$ decays rapidly with Y, in the shear layer and the core, but not to zero. There is a nite correlation at large distances, in plying a correlated solid-like

motion of the particles superimposed over the uncorrelated uid-like motion. We believe that this solid-like motion is a result of the stick-slip [18, 19], or jammingunjamm ing, phenom ena in granularm aterials. W hen the medium is released, or unjammed, during the slip phase, the unbalanced force accelerates the particles for a short period of time, and a part of the kinetic energy acquired by the particles is retained in uctuational modes. The energy is lost in the next stick or jam m ed phase, but the cycle is repeated regularly. The decay of the tim e correlation, C_t(T) hc_x^0 (t;y) c_x^0 (t + T;y)i, to zero in Fig. 4b indicates that the stick-slip motion itself is uncorrelated beyond a time scale of roughly half a second. (Note that C_{t} (T) is not the usual autocorrelation function, as we are not tracking the velocity of individual particles in time). The relative unimportance of shear in generating uctuationalm otion im plies that shear work largely dissipates as true heat through rubbing and rolling friction [17]. It appears likely that the jamming-unjamming cycle is affected by shear, but it is not clear why shear dim inishes v but leaves the velocity distribution unchanged.

The above discussion leads to the important question of whether the velocity distribution we have reported is universal for slow granular ows, or is limited to ows driven by a body force. This is an issue of considerable im portance, and can only be answered by conducting experiments in other geometries. A kinematic variable that we have not measured in this study is the rotation velocity of the particles. Recent studies that have modelled granular media as Cosserat continua [20, 21] have shown the rotation velocity to play an important role in determining the kinematics. Though its measurement is more di cult, it will be useful in critically evaluating hydrodynamic theories and in understanding the microscopic di erence between the solid-like and uid-like regions.
