Quantum spin chains with site dissipation

We use M onte Carlo simulations to study chains of Ising—and XY—spins with dissipation coupling to the site variables. The phase diagram and critical exponents of the dissipative Ising chain in a transverse magnetic eld have been computed previously, and here we consider a universal ratio of susceptibilities. We furthermore present the phase diagram and exponents of the dissipative XY—chain, which exhibits a second order phase transition. All our results compare well with the predictions from a dissipative 4 eld theory.

KEYW ORDS: spin chains, dissipation, phase transition, M onte Carlo

Dissipation and decoherence in mesoscopic quantum systems have important practical implications, from stabilizing superconductivity in granular materials, to the loss of inform ation stored in qubits. The macroscopic degree of freedom can often be described by a spin variable of Ising or XY sym m etry. They m ight represent the lowest energy states in a double well potential, or the phase of the superconducting order parameter on some grain or island. Follow ing Caldeira and Leggett¹⁾ one can introduce dissipation in such a system by coupling this spin variable linearly in the coordinates to an in nite set of harm onic oscillators which represent the environm ent. The spectral distribution of these harm onic oscillators de nes the type of dissipation and we will consider a socalled 0 hm ic heat bath which produces linear friction. Upon integrating out the heat bath degrees of freedom one obtains an imaginary time e ective action with long ranged interactions in time.

The simplest of these models, the dissipative two-state (Ising) system, has been studied extensively, both theoretically and by numerical simulations. It exhibits a dynamical phase transition to a localized state at a critical value of the dissipation strength. We have recently studied what happens when in nitely many such two-states systems are spatially coupled. We observed a quantum phase transition in a universality class dierent from either the single site case or the non-dissipative system.

The second class ofm odels we shall study involve 'spin' degrees of freedom with a globalU (1) rotation (XY) symmetry. A single XY-spin coupled to dissipation describes the physics of the so-called single-electron box. 6,7) The integer variable conjugate to the compact phase represented by the spin corresponds to the number of excess charges on the small metallic island, which is connected to an outside lead by a tunnel junction. XY spins on higher dimensional lattices describe arrays of Josephson junctions. In resistively shunted junctions, the dissipation couples to the phase dimense and the phases are usually treated as non-compact variables. Such systems exhibit a dissipation driven superconductor-tometal transition 8(11) because the dissipation suppresses

phase slips and can restore superconductivity. Very recently, an XY-chain with site dissipation was studied in connection with the superconductor-to-metal transition in nanowires. 12

In this work, we shall consider chains of Ising—and XY—spins with 0 hm ic dissipation coupling to the site variables. The discretized action for a chain of n-component spins with on-site dissipation reads

with a = 1;:::;n and r $_{a}$ $_{a}$ 2 a = 1 on every site. An Ising chain (in a transverse magnetic eld) corresponds to n=1, a chain of XY-spins to n = 2, and so on. The number of lattice sites in the spatial and in aginary time directions are N $_{x}$ and N $_{z}$, respectively, and we apply periodic boundary conditions in both directions. The long-ranged term containing the dimensionless variable describes the 0 hm ic dissipation coupling to the site variable .

The nature of the phase transition and its universal properties have recently been discussed by Pankov et $al_{r}^{13)}$ who analyzed the dissipative n-component 4 eld theory (the chain (1) corresponds to spatial dimension d=1)

They predict a second order phase transition for > 0, whose properties should not depend on the dissipation strength. The upper critical dimension of the eld theory (2) is 2, independent of n, and an expansion to second order in = 2 dyields the following expressions for the

critical exponents 12,13)

An additional theoretical prediction concerns the Fourier transform of the spin-spin correlation function, or susceptibility $(k;i!_n)$. Here, k denotes a wave vector and $!_n = 2$ n=N is the M atsubara frequency (the absolute temperature is $T = \sim = (k_B N)$). The strong hyperscaling properties of the eld theory in Eq. (2) have interesting consequences for its universal properties at the quantum critical point. In particular, because the last j! j term in Eq. (2) does not renormalize, there is no non-universal cut-o dependence to the overall scale of $(k;!_n)$, which thence obeys the scaling form

where only the number c_1 is non-universal, and all other aspects of the scaling function—are independent of cutoscale parameters. In the present situation, we are not simulating the—eld theory in Eq. (2), but rather the lattice Ising model in Eq. (1), and so we need a relation between the overall scale of—and the Ising spins. We sidestep the ignorance of the latter scale by computing the ratio

In the lim it of an in nite spatial length (1 N N_x^2), Eq. (4) implies the remarkable result that the function (n) is a completely universal function of the integer n. We can also determ ine the lim iting behavior of this function for smalland largen. At low frequencies, ~! $k_B T$, we expect dissipative behavior with a linear j! n jdependence of the dynam is susceptibility. At large ~! $k_B T$, scaling implies (0; i! n) $1=j!_n j^2$ $1=j!_n j$. Hence we have

where A and B are universal numbers.

We will rst test the universality of the function for Ising spins and then present the phase diagram and critical exponents for the XY-chain. In the Monte Carlo simulations, we use a variant 14 of the Swendsen-Wang algorithm 15 which builds the clusters in a time 0 (N \log N) despite long ranged interactions.

Since n 1 is not accessible in imaginary time, we consider the case 1 n N and compute the amplitude A for weak, in termediate and strong dissipation, setting K = $\frac{1}{2}\ln \left[\tanh \left(1\right)\right]$ = 0:136 as in our recent study of the Ising chain. For this value of K , the phase transition for a single dissipative Ising spin oc-




Fig. 1. (n) for = 0 and = 0.3. The di erent curves correspond to di erent N in the range 1 N N $_{\rm x}$ (= 0) and 1 N N $_{\rm x}^2$ (= 0.3) respectively. The data are plotted in the range 1 n N=2.




Fig. 2. (n) for = 0:3 and $\frac{1}{1000}\frac{N}{2}$ n $\frac{1}{100}\frac{N}{2}$. The data sets corresponding to di erent N are plotted in di erent colors for better clarity. The dotted line shows the best t to A=n.

curs at $_{\rm c}$ = 0:625. The universal function , however, should not depend on the choice of K .

For = 0 (non-dissipative 2D Ising model), the am-plitude A can be calculated exactly. One nds for large $n^{16)}$

which we used to test the numerical simulations. (Note that the large n behavior $n^{7=4}$ applies only for = 0; any non-zero is expected to crossover into the behavior in Eq. (6).) In this case the dynam ical critical exponent is z = 1, so we plot in Fig. 1 the function (n), computed at the critical inter-site coupling K $_{\rm x}^{\rm c}$, for di erent lat- N_x . The behavior predicted from Ν the Onsager solution is nicely reproduced in the scaling N . A lso shown in Fig. 1 are the data for n = 0:3. Since z2 for > 0, we chose lattices with N_{x}^{2} . A power-law decay proportional to 1=n is clearly visible, although the curves bend away slightly for n outsite the scaling region 1 n N . For the pur-




Fig. 3. Data collapse of Binder cum ulants at the critical point for = 0:3 and z = 1:97.

pose of extracting the am plitude A, we de ne the scaling region as $\frac{1}{1000} \frac{N}{2}$ n $\frac{1}{100} \frac{N}{2}$. Fig. 2 shows the data for = 0:3 restricted to these values of n.A t to the predicted power-law (6) yields A = 0:0729. Repeating the sam e analysis for = 0.1, we get A = 0.0726. For very strong dissipation (= 0:5) we see stronger corrections $\frac{1}{100}\frac{N}{100}$ lies clearly outside the scaling to scaling and n region. Larger lattices would be needed to extract an accurate value of A . N evertheless, even our data at are roughly consistent with the asymptotic form

Having con med the predictions for , we use quantum M onte C arlo simulations to determ ine the phase diagram and critical exponents of the dissipative XY-spin chain following the analogous investigation of the Isingspin case in Ref. 5. Assuming a second order phase transition, we use a scaling procedure which was proposed for the study of spin glasses. 17) For a given value of (K = 0:1 is kept xed in this study) we determ in the critical spatial coupling K $_{\rm x}^{\rm c}$ and the dynam ical critical exponent z self-consistently from the data collapse of the B inder cum u lant ratio B = 1 $\text{Im}^4 i = (3 \text{Im}^2 i^2)$, w here m is the magnetization. Near the critical point, B scales as

At the critical point, the correlation length and the B inder cum ulants collapse onto a universal function of N = $(N_x)^z$. The excellent data collapse shown in Fig. 3 validates the scaling Ansatz in Eq. (9) and conm s the second order transition which was predicted in Pankov et al. $^{13)}$ The data collapse yields K $_{x}^{c}$ = 0.92132(2) and z = 1.97(3).




Fig. 4. Phase diagram of the dissipative XY-spin chain in the space of nearest neighbor coupling K $_{\rm X}$ and dissipation strength (K = 0:1).

Repeating this analysis for several values of , we map out the phase diagram shown in Fig. 4. In contrast to the Ising case³⁽⁵⁾ there exists no ordered state at $K_x = 0$. As mentioned in the introduction, the single site case corresponds to the imaginary time e ective action of a single-electron box, 6) which was recently studied using extensive M onte C arlo sim ulations.7)

order parameter correlation function C (x;) in an in nite system and at the critical coupling K x scales as




Fig. 5. Equal-time correlation h $_{a}$ (0;) $_{a}$ (N $_{x}$ =2;)i at the criticalpoint for = 0:3. The time direction of the lattice is scaled as N = $10N_x^2$. The curve shows a power-law to the data.

The equal-time correlation function at the critical point should therefore decay asymptotically as C(x;0) $x^{(z+1)}$. The corrections to scaling are larger than in the Ising case⁵⁾ and we cannot directly ta periodic version of this power-law to the correlation function. Instead we consider the correlations between the most distant sites for di erent system sizes. In Fig. 5 we plot $h_a(0;)_a(N_x=2;)$ i as a function of N_x . A power-law t to these data yields z + = 1.985(20).

In order to determ ine the critical exponent , we set $N = 5(N_x)^z$ to reduce the two-param eter scaling to a one-param eter one. This allows us to employ the procedure outlined in Refs. 18 and 5. Using the de nition

Next, we compute the critical exponents and . The where m denotes the magnetization and $_{




Fig. 6. Plot of $2 \ln [n^2]$ $\ln [n^4]$ ([m n] is de ned in (11)) as a function of $\ln N_x$ at the critical point (= 0.3, K $_x$ = 0.1). We scaled the imaginary time dimension as N = $5 (N_x)^z$ with z= 2 and z= 1.97 (not shown). The slope of the tred line gives 1= .

The left hand side of Eq. (12) is plotted in Fig. 6 for =0:3 and K=0:1. From the slope of a linear t to these data one obtains . The major source of error is the uncertainty on z=1:97(3). Hence, we determined

the slopes for z = 1.97 and z = 2 and z = 0.689 (6).

Having obtained the critical exponents for = 0.3, we would like to compare our result with the predicitions from the dissipative n-component 4 eld theory (2). One dimensional chains correspond to = 1. In Table I we list the numerically determined exponents for Ising (n = 1) and XY-chains (n = 2) and the values from the two-loopexpansion (3). The agreement is remarkably good. In the Ising case we found that the exponents do not depend on the dissipation strength and we expect the same for the XY-chain as well.
