## H ierarchical C hain M odel of Spider C apture Silk E lasticity

Spider capture silk is a biom aterial with both high strength and high elasticity, but the structural design principle underlying these rem arkable properties is still unknown. It was revealed recently by atom ic force m icroscopy that an exponential force-extension relationship holds both for capture silk m esostructures and for intact capture silk bers  $\mathbb{N}$ . Becker et al., N at. M ater. 2, 278 (2003)]. In this Letter a simple hierarchical chain m odel was proposed to understand and reproduce this striking observation. In the hierarchical chain m odel, a polym er is composed of m any structural m otifs which organize into structural m odules and supram odules in a hierarchical m anner. Each m odule in this hierarchy has its own characteristic force. The repetitive patterns in the am ino acid sequence of the m a jor agelliform protein of spider capture silk is in support of this m odel.

The capture silk is a naturalm aterial produced by orbweb weaving spiders. Spiders rely on it to entrap ying preys [1]. Like the spider dragline silk and many other naturally occurring silks, the capture silk has a tensile strength that is comparable to steel; but, unlike steel, it is also extrem ely elastic, with the ability to be stretched to alm ost 10 tim es its relaxed contour length without breaking [2, 3]. This perfect combination of strength and extensibility conveys a high degree of toughness to the capture silk: its breakage energy per unit weight is more than 20 times that of a high-tensile steel [2]. With the aim to produce synthetic silks with similar mechanical properties, m aterials scientists have devoted m any experin ental and computational e orts to the understanding of spider silk's structural organization [4]. Despite these painstaking e orts, the mechanism behind spider silk's remarkable strength and elasticity is still largely missing, partly because of the di culty to obtain high-quality crystallized structures of silk proteins.

Single-m olecule manipulation methods have been recently applied on spider silks to obtain very detailed information on their force-extension response [3, 5]. In a recent experiment, Hansma and co-workers [3] attached capture silk mesostructures (probably composed of a single protein molecule) or intact capture silk bers to an atom ic force microscopy tip and recorded the response of the sam ples to external stretching force. They found a remarkable exponential relationship between the extension x and the external force f,

where ', the length constant referred to in [3], is a tting parameter whose physical meaning needs to be decided (see below). '= 110 30 nm for a capture silk molecule and '= 11 3 mm for an intact capture silk ber [3]. The length constant of a silk ber is about  $10^{\circ}$  times that of a silk molecule; its relaxed contour length is also about  $10^5$  times that of a molecule [3]. It appears that 'holds an approximately linear relationship with the contour length.

The exponential force-extension curve is signi cantly di erent from the data observed during stretching single double-stranded (ds) DNA molecules [6] or single titin proteins [7, 8]. The behavior of dsDNA can be understood by the worm like chain model of entropic elasticity [9, 10], and that of titin by a two-level system coupled with entropic elasticity [11]. Sim ilar exponential forceextension data were also observed by Dessinges et al. when they stretched a single-stranded (ss) DNA molecule at low salt conditions [12]. The data was explained as a result of the interplay of electrostatic repulsion and entropic elasticity [12, 13]. However, the success of this model depends on the speci c ionic concentration (i.e., low salt and high electrostatic interaction); and it could not naturally reproduce the exponential stretching data at extrem ely high force (i.e., when the extension is larger than 1:1 tim es the ssDNA backbone length) if higher order deform ation energy term s are not included [12]. In the spider capture silk experiment, the exponential behavior was observed at both uid and air within a force range from about  $10^0$  piconew ton (pN) to about  $10^6$  pN [3].

Equation (1) indicates the following: (i) Because the capture silk is highly extensible, a great am ount of extra length must have been stored in its relaxed form . (ii) Since extension increases with force logarithm ically, som e fraction of the stored length must be easy to be pulled out, som e fraction be harder to be pulled out, and till som e other fraction be even harder to be pulled out. To m odel this kind of heuristic cascading responses, here we propose a hierarchical chain m odel for spider capture silk. In the hierarchical chain m odel, the polym er is com posed ofm any basic structuralm otifs; these m otifs are then organized into a hierarchy, form ing structuralm odules on

m ore and m ore longer length scales. At the deepest hierarchy level  $h_m$ , the structural m otifs could be -sheets, -spirals, helices [4] or m icrocrystal structures [14]. The interactions am ong some of these m otifs are m uch m ore stronger than their interactions with other m otifs, therefore they form a structural module at the hierarchy level ( $h_m$  1). These level-( $h_m$  1) m odules are then m erged into level-( $h_m$  2) m odules through their m utual interactions. This m erging process is continued; and nally at the global scale, the whole spider silk string is regarded as a single m odule of the hierarchy level h = 0.

In nature, the structures of m any biom aterials are indeed hierarchically organized. As a composite material, chrom osom e is a m ixture of DNA, histone, and other nonhistone structural proteins [15]. The DNA molecule rst w raps onto histone proteins to form nucleosom e particles, the basic units of chrom osom e. W ith the help of H1 histone, this linear sequence of nucleosom es are then coiled and folded to form the 30-nm chromatin ber. With the help of other sca old proteins, the chrom atin ber is then further coiled and folded at several levels to form the com pact chrom osom e structure. A sanother example, the am ino acid sequence of a protein st form s basic structural modules of -helix and -sheet, called secondary structures. By di erent ways of connections of these secondary modules, the protein constructs various tertiary topologies that are critical for its speci c biological functions. In a higher level, these tertiary dom ains then form quaternary structures of protein com plexes consisting of multiple chains [16]. Recent experimental and theoretical studies have shown that the force { induced unfolding of protein m olecules is indeed processed in a hierarchical way, i.e. the tertiary structure precedes the secondary structures to be pulled over at increasing external forces [7, 17]. Our hierarchical chain model may also serve as a fram ework to understand the mechanical property of these biom aterial system s.




FIG.1: The hierarchical chain model. At each hierarchy

C onsider a polym er of contour length  $L_0$ . It is regarded as the m odule of hierarchy level h = 0 (the m odule M<sub>0</sub>). M<sub>0</sub> is composed of a tandem sequence of m<sub>0</sub> subunits M<sub>1</sub> of contour length  $L_1 = L_0 = m_0$  (Fig. 1). Under the action of an external force eld f, the extension of M<sub>0</sub> is denoted as  $x_0$  (f). It was observed that water-induced protein m obility is a signi cant contribution to capture silk elasticity [18]. Therefore, we decom pose  $x_0$  into two parts: (i) the extension  $x_0$  caused by the displacement and position-rearrangement of these m<sub>0</sub> subunits and, (ii) the total extension  $m_0 x_1$  caused by the inherent deform ations of these m<sub>0</sub> subunits:

Similarly, at the hierarchy level h = 1, each unit is itself composed of  $m_1$  level-2 subunits  $M_2$  of length  $L_2 = L_0 = (m_0 m_1)$ . Therefore,  $x_1$  (f) can be written as  $x_1$  (f) =  $x_1$  (f) +  $m_1 x_2$  (f), where  $x_1$  (f) is the contribution to the extension of a level-1 m odule due to the

quence of  $m_h$  submodules  $M_{h+1}$  of hierarchy level h+1. Under


displacement and position-rearrangement of its  $m_1$  subunits; and  $x_2$  (f) denotes the extension because of the inherent deformation of a level-2 subunit M<sub>2</sub>. As this structural hierarchy is continued, we arrive at the following expression concerning the total extension x (f):

$$x(f) = x_0(f) + m_0 m_1 ::: m_h x_{h+1}(f): (3)$$

It is reasonable that the average extension  $x_h$  (f) of a M  $_h$  contributed by the reorientation or rearrangement of its level-(h + 1) subunits is proportional to the relaxed contour length  $L_h$  of this module. To facilitate the follow ing analytical calculation, let us assume  $x_h$  (f) has the follow ing non-linear form (we will show that the nal force-extension relationship is not sensitive to the speci c assumption m ade here):

where is a dimensionless proportional constant;  $f_h$  is the characteristic force needed to displace and rearrange the positions of the m<sub>h</sub> submodules contained in a M<sub>h</sub> (during this process some sacri cial bonds are broken). Equation (4) is in agreement with the experimental observation [3] that, between adjacent rapture events, a capture silk responds to external stretching in a linear way. Denote  $E_h$  as the energy cost of breaking all the sacri cial bonds between a level-h module's m<sub>h</sub> subunits. From Eq. (4) we know that  $f_{h+1}=f_h=m_h E_{h+1}=E_h$ . Consider a level-(h+2) module  $M_{h+2}^a$ , it is in  $M_{h+1}^a$  which in turn is in  $M_h^a$ .  $M_{h+2}^a$  fiels an internal energy due to



its interaction with other subunits in M  $_{h+1}^{a}$ , and it feels an external energy <sup>0</sup> due to its interaction with other subunits in M  $_{h}^{a}$  but not in M  $_{h+1}^{a}$ . Based on Fig. 1, we know that  $E_{h+1} = m_{h+1} = 2$  and  $E_{h} = m_{h}m_{h+1}^{0} = 2$ . The hierarchical organization of the polymer requires that > <sup>0</sup>, so as to ensure that structural modules of shorter length scales will be form ed earlier. Based on these considerations, we arrive at the following self-sim ilar scaling form:

The parameter characterizes the degree of coherence in the modular organization of the polymer: a large valuem eans that a submodule has much stronger internal interactions compared with its external interactions.

From Eqs. (3) and (4) we not that when  $f_{h-1} < f_{h-1}$

Equation (6) therefore recovers the experimental exponential force-extension relationship of Eq. (1) with

The length constant ' is proportional to the relaxed contour length  $L_0$  of the whole polymer, in consistence with R ef. [3].




FIG.2: Exponential force-extension relationship for the hierarchical chain m odel. Equation (4) is used in the num erical calculation. The parameters are  $f_0 = 10^{-4}$  N, = 0.3, and = 2 (the upper curve) or = 1.75 (the lower curve). Extension is in units of  $L_0$ . Sym bols are experimental data from

Figure 2 demonstrates the numerically calculated force-extension curve based on Eqs. (3), (4), and (5). As a comparison, the experimental data [3] on intact spider capture silk is also shown. As ' 2 and the exprimental exponential force range is roughly from 6 10  $^{5}N$

to 10  $\,^3\mathrm{N}$  , it appears that 4{5 levels of hierarchy were probed.




FIG.3: The force-extension relationship of a hierarchical chain is insensitive to the assumption made to the response  $x_h$  (f) of Eq. (4), but is sensitive to the hierarchical scaling form of the characteristic force  $f_h$ . The solid lines are obtained by assuming  $x_h$  (f) has the form of Eq. (8), while other parameters are the same as those in Fig.2. The dotted line shows the change in the force-extension curve when additionally a power-law form of  $f_h = f_0 h$  with = 3.0 is assumed for  $f_h$ . The dashed lines are obtained by assum - ing Eq. (8) and Eq. (5), with uctuating uniform ly within [1:25;2:25] (the lower curve) and within [1:5;2:5] (the upper curve).

The exponential relationship shown in the gure is insensitive to our particular assumption Eq. (4), as long as the elastic response at each hierarchy level is nonlinear and bounded. As an example, the solid curves in Fig. 3 show the resulting force-extension relationship when Eq. (4) is replaced by

$$x_h(f) = L_h 1 \exp(f = f_h)$$

The same exponential behavior as in Fig.2 is obtained. However, the hierarchical scaling form Eq. (5) is needed for the exponential force-extension correlations. For example, when Eq. (5) is replaced by a power-law,  $f_{\rm h}$  /  $f_{\rm 0}h$ , the response is not exponential (the dotted line in Fig.3). We also noticed that, when in Eq. (5) the parameter is not a constant but uctuates over some nite range of > 1, the resulting force-extension curve is still exponential (Fig.3, dashed lines).

In sum m ary, we have developed a hierarchical chain m odel to understand the strength and elasticity of spider silks. Rem arkably, this simple m odel was able to reproduce the peculiar exponential force extension response of spider capture silk reported by Becker et al. [3]. The m odel can also be used as a fram ework to understand the elasticity of other spider silks and other biopolym ers with hierarchically organized structures.

Becker et al. [3] have proposed an alternate and interesting idea to m odel the spider silk as a branched network of interconnected springs. In their m odel, the system responds to external stretching by rst unfolding the single spring at the root level, then the m springs at the

rst branching level, then the  $m^2$  springs at the second branching level, and so on. The hierarchical chain m odel developed here is di erent from Becker et al.'s model. First, the molecule in the hierarchical chain model consists of a tandem sequence of structuralm odules of di erent length scales. Therefore, no assumption of branching structure is made in our model. Second, the response of the chain to external perturbations is in a hierarchicalmanner. If the external force is small, only those structural units of length scale com parable to the whole polym er length will be displaced and rearranged; structural units at short and moderate length scales will remain intact. As the external perturbation is elevated, additional structural units at more shorter length scales are also deformed. Through such a hierarchical organization, a single polymer chain can respond to a great variety of external conditions; at the same time, it is able to keep its degree of structural integrity as high as possible. This hierarchical modular structure also indicates a broad spectrum of relaxation times. The modules at the shorter length scales will have much shorter relaxation times and will be refolded st when the external force decreases. This gap in relaxation tim es ensures that, after extension, the spider capture silk will return to its relaxed state gradually and slowly. This is a desirable feature for spider capture silk, because a too rapid contract following the insect's impact would propel the victim away from the web.

The simple hierarchical chain model, while appealing, needs further experim ental validation. This model seems to be supported by recent genetic sequencing e orts. By analyzing the CDNA sequence of the major protein of spider capture silk, the agelliform protein, it was revealed that the amino-acid sequence of agelliform has a hierarchy of modularity [19, 20, 21]. At the basic level, the

agelliform sequence is consisted of three repetitive m odules (m otifs): (i) the GPGGX m otif (G ly-P ro-G ly-G ly-X, X 2 fA la,Ser,T yr,Valg); (ii) the GGX (G ly-G ly-X, X 2 fA la,Ser,T heg); (iii) the highly conserved spacerm otif of length 28 am ino-acids. At the next level, an ensem – ble m otif is form ed, which is a tandem array of 43 63 GPGGX followed by 6 12 GGX, the spacer and another GGX [19]. At the even higher level, the ensem ble m otif then repeats itself about 14 times to form the agelliform m onom er. The variable residues X are not random ly distributed along the protein sequence [19], which m ay encode in portant structural inform ation. The structures of spider capture silks (and other spider silks) therefore have the potential to be hierarchically organized.

For spider capture silk, one in portant experiment will be to check the validity of Eq. (5) by single-molecule

force spectroscopy. The characteristic forces  $f_h$  m ay correspond to the forces at the saw -tooth rapture events observed by H ansm a and co-workers [3]. A lthough the experim ental curves of R ef. [3] is in agreem ent with Eq. (5), m ore system atic investigations are necessary to draw a solid conclusion.
