Fano resonances and decoherence in transport through quantum dots

A bstract

A tunable m icrow ave scattering device is presented which allows the controlled variation of Fano line shape param eters in transm ission through quantum billiards. We observe a non-monotonic evolution of resonance param eters that is explained in terms of interacting resonances. The dissipation of radiation in the cavity walls leads to decoherence and thus to a modi cation of the Fano pro le. We show that the imaginary part of the com plex Fano q-param eter allows to determ ine the absorption constant of the cavity. Our theoretical results demonstrate further that the two decohering mechanisms, dephasing and dissipation, are equivalent in terms of their e ect on the evolution of Fano resonance lineshapes.

1. Introduction

A sym m etric Fano line shapes are an ubiquitous feature of resonance scattering when (at least) two different pathways connecting the entrance with the exit channel exist. Fano resonances have been discussed in m any di erent elds of physics starting with photoabsorption in atom s [1{3], electron and neutron scattering [4,5], R am an scattering [6], photoabsorption in quantum well structures [7], scanning tunnelm icroscopy [8], and ballistic transport through quantum dots (\articial atom s") [9{13] and molecules [14,15]. Interest in charactering and analyzing Fano pro-les is driven by their

observing and analyzing Fanopro les is driven by their high sensitivity to the details of the scattering process. For example, since Fanoparam eters reveal the presence and the nature of di erent (non) resonant pathways, they can be used to determ ine the degree of coherence in the scattering device. This is due to the fact that decoherence m ay convert Fano resonances into the m ore fam iliar lim iting case of a B reit-W igner resonance. Furtherm ore, Fano pro les provide detailed inform ation on the interaction between nearby resonances leading to \avoided crossings" in the com plex plane [16,17], and to stabilization of discrete states in the continuum (\resonance trapping" [18,19]). Possible technological applications of Fano resonances have recently been suggested in R ef. [20], exploiting the transm ission resonances in transport through open quantum dot system s as a m eans to generate spin polarization of transm itted carriers.

U sing the equivalence between the scalar Helm holtz equation for electrom agnetic radiation in cavities with conducting walls and the Schrodinger equation sub-




Fig.1. (a) Schem atic sketch of the rectangular cavity with leads attached sym metrically on opposite sides. Exchangeable diaphragm s at the lead junctions allow to control the coupling between the cavity and the leads. The open even transverse states are indicated. (b) Photograph of the experimental setup.

ject to hard-wallboundary conditions [21], we have designed a scattering device (Fig. 1) that allows the controlled tuning of Fano resonances for transport through quantum billiards. The evolution of the Fano param eters as a function of the tuning parameter, in the present case the degree of opening of the leads, can be traced in unprecedented detail, since decoherence due to dissipation can be controlled. By comparison with calculations em ploying the m odular recursive G reen's function m ethod (M RGM) [11,22], the param etric variation of Fano resonances and the degree of decoherence can be quantitatively accounted for. Furtherm ore, the relevant pathways can be unam biquously identied in term s of wave functions representing the contributing scattering channels. Due to the equivalence between m icrow ave transport and single-electron m otion in two dim ensions, our device can be understood as a sim ulation for ballistic electron scattering through a quantum dot. In contrast to recent investigations of m esoscopic dots and single-electron transistors [9,12,23], where the comparison between theory and experiment has remained on a mostly qualitative level, our model system allows for a detailed quantitative analysis of all features of tunable resonances.

2. Them odel

O urm icrow ave scattering device consists of two com m ercially available waveguides with height h= 7.8 mm, width d= 15.8 mm, and length l= 200 mm which were attached both to the entrance and the exit side of a rectangular resonator with height H = 7.8 mm, width D = 39 mm, and length L = 176 mm, resulting in a circum ference C = 430 mm and area A = 39 mm 176 mm (both in the plane). At the junctions to the cavity m etallic diaphragm sofdi erent openings were inserted (F ig.1). Them icrow aves with frequencies between 12.3 and 18.0 GHz, where two even transversem odes are excited in the cavity and one transverse m ode in each of the leads, are coupled into the waveguide via an adaptor to ensure strong coupling.




Fig. 2. Decomposition of the scattering device into three separate substructures: (1) a junction from a narrow to a wide constriction (with diaphragm), (2) a wide constriction of length L, and (3) a junction from a wide to a narrow constriction (with diaphragm).

The experimental results are compared with the predictions of the MRGM.We solve the S matrix for the single particle Schrodinger equation for this "quantum dot" by assuming a constant potential set equal to zero inside and in nitely high outside of a hard-wall boundary. At asymptotic distances, scattering boundary conditions are imposed in the leads. The coupling of the leads to the cavity of length L can be varied by the two diaphragms which are placed symmetrically at the two lead openings. The lead width d and the width of the rectangular cavity D determine how many

ux-carrying modes are open at a certain energy " in each of the three scattering regions (lead-cavity-lead). W e consider in the following the range of wavenum bers where one ux-carrying mode is open in each of the leads. Inside the cavity the rst and second even transverse modes are open, thus providing two alternative pathways of transport through the structure. In order to characterize the interfering paths, we decom pose the transport across the cavity into a multiple scattering series involving three pieces [24], each of which is characterized by a mode-to-mode transm ission (re ection) am plitude or a propagator (see Fig. 2): (1) the transmission of the incoming ux from the left into the cavity, t^(L), or re ection back into the lead, $r^{(L)}$, (2) the propagation inside the cavity from the left to the right, G^(LR), or from the right to the left, G^(RL), and (3) the transm ission from the interior of the cavity to the right, t^(R), or internal re ection at each of the two vertical cavity walls with amplitude r^(R). For the G reen's functions (i.e. propagators) $G^{(LR)}(x_R; x_L)$

The shape of Fano reso $plane, k_n =$ nances can be used to accurately determ ine the degree of dissipation present.

The multiple scattering expansion of the transmission amplitude T is then given by

The identi cation of the resonant and non-resonant pathways with help of Eq. (1) is straightforward: due to the absence of inter-channelm ixing in the rectangular (i.e. non-chaotic) cavity, the non-resonant contribution corresponds to the n = 0 term of the sum describing direct transm ission while the resonant contribution ism ade up by all multiple-bounce contributions (n 1). The various am plitudes entering Eq. (1) can be param etrized in term s of four phases and two m oduli [25]: the modulus, s, of the re ection am plitude of the wave incom ing in mode 1 and re ected into mode 1 at the left diaphragm ,

and the m odulus, p, of the partial in jection am plitude of the incom ing wave into the low est m ode of the cavity, corrected for the partially re ected ux Eq.2],

Because of the sym m etry of the scattering device, the injection (ejection) amplitude at the left (right) side are equal. A coordingly, the injection amplitude into the second even m ode of the cavity is given by

A nalogous expressions can be deduced [25] for the other partial am plitudes entering Eq. (1). We om it a detailed analysis of the phases in Eqs. (2-4) since they do not explicitly enter our analysis in the following. The key observation in the present context is that the square module s^2 is monotonically decreasing between the limiting values $s^2 = 1$ for zero diaphragm opening (w = 0) and s^2 0 for fully open diaphragm s (w = d). Inserting Eqs. (2-4) into Eq. (1), a closed yet com – plicated expression for the transmission probability jT (";s) f as a function of the energy " and the opening parameter s can be derived [25]. C lose to a given resonance " $_i^R$ this expression can be approximated by the Fano form [3,25],

where $"_i^R$ (s) is the position of the i-th resonance, i (s) its width, and q_i (s) the complex Fano asymmetry parameter, all of which depend on s.W indow resonances appear in the limit q! 0 while the B reit-W igner limit is reached for jqj 1. Since Fano resonances can be identified as resulting from the interference between resonances related to the eigenmodes in the cavity, the parameter q depends very sensitively on the specie c position of the involved resonance poles [26,27].

3. C om parison between experim ent and theory

In Fig.3 we present both the experim entaland theoretical dependence of the transm ission probability $J\Gamma f$ on k (or "). In the m easurem ent, the diaphragm s were successively closed in steps of 1 mm. The data sets of Fig.3 (a,b,c) represent the transm ission probability for three di erent values of the opening of the diaphragm s w = 5:8; 8:8; and 15.8 mm, respectively. Note the rem arkable degree of agreem ent between the m easured and the calculated data with only the absorption constant as an adjustable param eter. In Fig. 3a where






Fig. 4. Fano resonance near the second even excited transverse mode at kd= 1:5095. Experim ental and theoretical result for four di erent cavity openings (w =d) are shown. Curves with equal w =d-ratio are displayed in the same line style (solid, dashed, dotted, dash-dotted). For all calculated curves a dam ping factor $= 10^{-4}$ mm $^{-1}$ was used, except for the additional gray dashed curve shown for which $= 10^{-3}$ mm $^{-1}$ and w =d = 0:68.

Fig. 3. Total transm ission probability, $f(\begin{array}{c} 2^{m}d= \;;w=d) \; \hat{f}$, for transport through the rectangular cavity with three different openings of the diaphragm s: (a) $w=d=\;37\%$, (b) $w=d=\;56\%$ and (c) $w=d=\;100\%$. For better comparison, the experimental and the calculated results are show n as m irror in ages. The positions of all eigenstates in the closed cavity are indicated by the gray tick marks. For all the calculated curves shown, a damping constant of $=\;10 \; {}^4$ m m 1 was used.

w=d 0:37, transport is suppressed and mediated only by resonance scattering with narrow B reit-W igner shapes centered at the eigenenergies of the closed billiard as indicated by the tick m arks.W ith increasing diaphragm opening (Fig. 3b) transport acquires a significant non-resonant contribution, leading to the widening and the overlap of resonances. F inally, for fully open leads (Fig. 3c), w = d = 1 (or s 0) resonances appear as narrow window resonances in a non-resonant continuum . The trajectory of the resonance parameter as a function of s can be both experim entally and theoretically mapped out in considerable detail. D i erent types of resonances can be identied by their characteristically di erent resonance param eters. The evolution of the Fano parameter as a function of w = d (or s) for one resonance is highlighted in Fig. 4. The transition from a narrow Breit-W igner resonance via a som ew hat wider asymmetric Fano pro le to a window resonance is clearly observable.

The choice = 10^{4} mm¹ provides us a good t

and an upper bound of the dam ping present. N ote that even a slightly larger value of $= 10^{-3} \text{ mm}^{-1}$ would drastically deteriorate the agreem ent between experim ent and theory (see Fig. 4). In line with the value 10^{-4} mm^{-1} , we obtain an imaginary part of the com plex Fano parameter for system swithout tim e-reversal symmetry [23] out of our thing procedure as Im q. 0:1. We note that by using superconducting cavities could still be further reduced [29], how ever with little in uence on the result, since we have already nearly reached the fully coherent limit.

4. Evolution of Fano param eters




Fig. 5. (a) Resonance width and (b) realpart of the asym metry parameter Re(q) j as a function of the diaphragm opening w = d. The data are obtained by ts to experim ental results. Solid circles (em pty triangles 4) correspond to resonances originating from the rst (second) even cavity eigenstate. Typical wavefunctions j $(x\,;y)\,\hat{j}$ for these two classes of resonances are shown in (c). In (a) the width of the -resonances is m onotonically grow ing until resonances disappear in the background of the measured spectra (see gray horizontal bar). For 4 -resonances reaches a local maximum and slightly decreases for w=d ! 1. In (b) the -resonances always have a $\Re e(q) \ge 10$, above which the Fano resonances are very close to the Breit-W igner lineshape [Re(q) = 1]. For the 4 -resonances q shows a strong w =d-dependence: resonances undergo a com plete evolution from Breit-W igner to window type as w=d varies between 0 and 1.

Follow ing the param etric evolution of a large num ber of resonances yields a characteristic pattern of Fano resonance param eters (Fig. 5a,b). O byiously, two distinct subsets of resonances appear in the rectangular billiards: one set is characterized by a strictly m onotonic increase of with increasing opening of the cavity and a large and only weakly dependent asym m etry param eter q. A second set of resonances features

a strongly varying q (on the log-scale!) from large values near the Breit-W igner lim it to values close to q 0 for wide opening, yielding a window resonance. At the same time, the width rst increases with w=d increasing from close to 0, then reaches a local maximum and nally decreases slightly when w=d ! 1.A similar non-monotonic behavior of was recently observed in a single-electron transistor experiment [9]. Such features can be understood in terms of avoided crossings in the complex plane [16,17] between interacting resonances. W hile the von Neumann-W igner theorem [30] for bound states predicts avoided crossings between states of the sam e sym metry and thus a non-m onotonic variation of the eigenenergy, interacting resonances can also display avoided crossings on the imaginary axis [16,17], i.e. exchange of the width of resonances and thus leading to a non-m onotonic behavior of one of the involved. The two resonance poles approach each other in the com plex energy plane and undergo an avoided crossing as a function of the

coupling param eter s. As a result, for increasing s the width of the resonance with large gets even larger and will form a background, on top of which the second narrow ed resonance is situated. This som ew hat counterintuitive stabilization and narrowing of the width of one resonance despite an increased opening, i.e. an increased coupling to the environment, is som etim es referred to as \resonance trapping" [18,19] and in the lim it of 0 as the \form ation of bound states in the continuum ".Thism echnism could possibly provide an alternative explanation for the results of R ef. [9], where such a non-m onotonic behavior was observed and has been previously attributed to increased in purity scattering [23].

A very interesting feature of interacting resonances is the fact that they can be directly related to scattering wavefunctions (see Fig. 5c). Resonances that undergo a com plete evolution from Breit-W igner resonances to a window resonance are all associated with the second even excited state in the cavity, while resonances that display a strictly monotonic increase of the width with increasing cavity opening are connected to transport through the transverse ground state of the cavity. This m apping is controlled by the amplitude p for transm ission through the rst transverse mode [see Eqs. (3,4)]. In the case that $p^2 > 1=2$ all resonances associated with the sst mode are broader than the resonances associated with the excited state and vice versa for $p^2 < 1=2$. For geom etric reasons the scattering device studied here (Fig. 1) always favors transport through the rst cavity mode and therefore $p^2 > 1=2.W$ e thus arrive at the remarkably simple result that all resonances associated with a rst mode feature a strictly monotonic and a large, but weakly varying q, while all resonances associated with the second m ode feature a sm aller and non-m onotonic with q undergoing the complete evolution from the Breit-W igner to the window lim it. This one-to-one mapping is also indicated in Fig. 3, where only second-mode resonances (indicated by the dotted tick m arks) \survive" the transition of w=d ! 1 while all rst-mode resonances (short tick marks) vanish in the background of the transmission spectrum. This know ledge could be very useful for the investigation of electron dynam ics in m esoscopic scattering system swhere the parametric evolution of Fano resonances could yield inform ation about the interaction of internal states and their coupling to the environm ent.

5. Resonance poles in the com plex plane




Fig. 6. The calculated k_F -dependence of transm ission through the rectangular cavity (w ithout dissipation). The diaphragm s are successively closed: (a) s=0, (b) s=0.29, (c) s=0.68, and (d) s=0.97. The upper half of each gure shows the transm ission probability $J^{\rm T}$ (k_F) J^2 on the real k_F -axis. The lower half depicts contour plots of the transm ission probability $J^{\rm T}$ (k_F) J^2 in the com plex k_F -plane. Poles and zeros in transm ission move in the k_F -plane as a function of the opening of the diaphragm s. Two of the zeros and four of the poles in (a) are marked by arrow s.

As discussed above, the transmission amplitudes for scattering through the rectangular cavity can be param etrized in terms of six independent param eters [25] (provided that no dissipation is present). By evaluating the resulting expression for the transm ission probability $\int (k_F)^2$ at complex values of the Ferm i wavenum ber k_F we can explicitly investigate the resonance poles in the complex plane and their dynamics as a function of the diaphragm opening. Inspired by the work in [31,32] we calculated contour plots of the transm ission probability $\int (k_F)^2$ in the com plex k_F -plane, displayed in Fig. 6. In general we can associate with every resonance in the transmission probability $T(k_F)^{2}$ a pair of poles for $T(k_F)^{2}$ in the complex $k_{\rm F}$ -plane and a point on the real $k_{\rm F}$ -axis where $T(k_F)$ goes to zero. For full opening of the

diaphragm s (s 0) the com plex poles and the points where the transm ission probability goes to zero occur at the same Re(k), thus giving rise to alm ost symmetric resonances (see Fig. 6a). When gradually closing the diaphragm s, the poles are situated at a Re(k) which is di erent from the position of the \zero" on the real axis. Such a conguration gives rise to asymmetric Fano resonances (see Fig. 6b,c). If the diaphragm s are alm ost shut (s 1), we are left with poles situated very close to the real k-axis (see Fig. 6d). In line with this observation, the resulting resonances are very narrow and isolated from each other.

6. D ecoherence: D ephasing versus dissipation

Decoherence in an open quantum system can be caused by di erent mechanisms: dephasing and dissipation.Both of them are contained in the relaxation operator in a quantum Liouville equation. Decoherence in the microwave scattering device is caused by dissipation, i.e. the absorption of m icrow ave energy by the walls. As discussed above, the absorption constant can be extracted from the shape of the Fano pro le in term s of a com plex q param eter. The good agreem ent with theory allows to accurately determ ine the degree ofdam ping and thus of decoherence present in the experim ent. As the Fano pro le, in particular near its m in in um, is very sensitive to any non-interfering incoherent background, we can determ ine an upper bound for the damping by comparison between experiment and theory to be 10^{4} mm¹. The consistency of this approach can be checked by an independent calculation of the absorption via the skindepth . The cavity in the experim ent is made out of oxygen-free copper 8.9kg/dm^{-3} and (D IN 1787 SF-Cu) with a density $100 \text{ hm}^{-1} \text{ mm}^{-1} \text{ at room}$ a conductivity 4:9 tem perature. The skin depth is given by [28]

with being the microwave frequency and the susceptibility of the metal, $_0 = 4 \ 10^{-7} \text{ V s} (\text{Am})^{-1}$. The quality Q of a resonator is de ned as the ratio of the eigenfrequency to its width . The Q can be calculated as [28],

where the height H , the circum ference C , and the area A of the cavity enter explicitly. The constant is a geom etrical factor close to unity. For the frequency range used in the experiment we nd a frequency width =Q 2.5 M H z.N ote that this width originates = purely in the absorption of m icrowaves in the cavity walls, as opposed to the resonance broadening caused by the openness of the diaphragm s. In line with this result we nd that the above frequency width of 2.5 M H z corresponds very well to the resonance width in the case of sm all diaphragm opening (i.e. w =d . 30%), where resonances take on the Breit-W igner lineshape. The Fourier transform of this resonance form is an exponentially decaying function in coordinate space, the decay constant of which is given by . We can therefore directly determ ine = =c, where c is the speed of light. This nally yields the esti-2:7 10^5 mm⁻¹. The value obtained from m ate the t of the Fano resonances is som ew hat larger 10^4 mm⁻¹), which is probably due to ad-(1 ditional absorption in leads. It has been shown in Ref. [23] that Fano resonances acquire an imaginary q-parameter under the in uence of dephasing. Our results presented here clearly indicate that dissipation has the same interference-reducing (i.e. decohering) e ect on a Fano resonance as dephasing does. In order to illustrate the equivalence of the decohering e ect of dephasing and dissipation on Fano resonances we simulate dephasing in cavity explicitly and compare with results on dissipative transport.W hereas absorption of m icrow aves is included in our m odel by adding to the real wavenum ber in longitudinal direction an in aginary part, $k_n = \frac{k^2}{k^2} (k_n^c)^2 + i$, the e ect of dephasing is taken into account in the following way: For each of the traversals of the cavity in the multiple scattering expansion of Eq. (1) a Gaussian distributed random phase $ran p^2 R$ is added to the longitudinal $\frac{p}{k^2} \frac{k^2}{(k_n^c)^2} + ran appearing in$ wavenum er, $k_n =$ the constant energy propagators G $^{(L\,R\,)}$ and G $^{(R\,L\,)}$. The degree of dephasing is controlled by the width of the Gaussian distribution. The num erical data for transm ission are then averaged over a large ensemble of di erent realizations of the random phase.

Note that dephasing, as well as dissipation, causes the unitarity of the scattering process to be violated. D issipative absorption of m icrowaves in the cavity walls leads to a net loss of m icrowave radiation in the system with U (k) = f(k)f + f(k)f < 1, dephasing




Fig. 7. Renormalized transmission probability, $JT (\frac{2}{2}d=; w=d)=U (\frac{2}{2}d=; w=d)^2$, for transport through the rectangular cavity under the in uence of dissipative and dephasing mechanism s, respectively. Opening ratio of the diaphragm s w=d=56%. Above the horizontal axis curves with di erent dissipation constants are shown: = 0;5;11;17;28 10 ⁴ mm ¹. The data below the axis contain a random phase factor for each longitudinal crossing of the cavity. The depicted curves feature each a di erent variance k of the G aussian random phase distribution: $k = 0;11;20;28;45 = 10^{-4} mm ^{-4}$. Note that both decohering mechanism s have a very similar e ect on the Fano resonances.

causes U (k) to uctutate around the unit value. For a meaningful comparison we enforce unitarity sim ply by renorm alizing the transm ission and re ection probabilities explicitly, $f(k)f^2 = J(k)f^2 = U(k)$ and $\Re(k)f!$ $\Re(k)f=U(k)$. We note that rigorous methods for restoring unitarity in open decohering quantum system s are available for both tim e-independent [23] and tim e-dependent system s [33]. Fig. 7 illustrates that dephasing and dissipation indeed have a very sim ilar e ect on the evolution of Fano resonances and therefore yield com plex values of the q-param eter. O ne conclusion we draw from this nding is that how ever useful Fano resonances are as a m eans to analyze the decoherence present in a scattering process, they do not allow to distinguish between di erent mechanism s leading to decoherence.

7. Sum m ary

In summary, the rectangular microwave cavity attached to two leads allows to study the interplay between resonant and non-resonant transport in unprecedent detail. By a controlled change of the opening, tuning a Fano resonance from the Breit-W igner lim it to the window resonance lim it has become possible. Fano resonances can be used to accurately determ ine the degree of decoherence present in a scattering device.W e show that dephasing and dissipative m echanisms have very similar e ects on the evolution of Fano resonances. The non-monotonic behavior of resonance param eters can be related to avoided crossings between interacting resonances, which can be unam biguously associated with di erent resonant modes of the cavity. The latter feature is a consequence of the separability of the wave function in the closed cavity. Future investigations along these lines for nonseparable chaotic cavities promise new insights into the resonance dynam ics of open chaotic system s.
