An E cient M N - A lgorithm for Joint Source-Channel Coding

A bstract

Belief Propagation (BP) decoding of LDPC codes is extended to the case of Joint Source-Channel coding. The uncompressed source is treated as a M arkov process, characterized by a transition m atrix, T, which is utilized as side information for the Joint scheme. The m ethod is based on the ability to calculate a D ynam icalBlock Prior (DBP), for each decoded symbol separately, and re-estim ate this prior after every iteration of the BP decoder. We dem onstrate the implementation of this method using MacKay and Neel's LDPC algorithm over GF (q), and present simulation results indicating that the proposed scheme is comparable with Separation scheme, even when advanced compression algorithms (such as AC, PPM) are used. The extension to 2D (and higher) arrays of symbols is straightforward. The possibility of using the proposed scheme without side information is brie y sketched.

1. IN TRODUCTION

The Shannon separation theorem [1, 2], states that source coding and channel coding can be performed separately and sequentially, while maintaining optimality. However, this is true only in the case of asymptotically long blocks of data. Thus, considerable interest has developed in various schemes of joint sourcechannel coding, where the inherent redundancy of the source is utilized for error correction, possibly with the aid of some side information (see, for instance, [3]). C om bining the two processes may be motivated by reducing the total com plexity of the procedure, and by some gain in the overall performance. Moreover, some e uncom pressed les (e.g. bitmap, text) are expected to be resilient to single bit errors, which may corrupt entire blocks in the case of the Separation scheme.

Shannon's lower bound for the channel capacity of a binary symmetric channel (BSC) with ip probability f, bit error rate p_b and source entropy H (src) per bit

is given by [1]:

where $H_2(x) = x \log_2(x)$ (1 x) $\log_2(1 x)$, is the entropy of x, and the capacity, C, is the maximal ratio between the source length k and the transmitted length m.

where P (i) is the stationary solution of the M arkov process. The entropy per bit, $H = \log_2 q$, $(\log_2 q)$ being the number of bits in the binary representation of a symbol) can be utilized as H (src) in Eq. (1).

N eighboring sym bols in a M arkov sequence are correlated. Hence, inform ation about sym bols s_{n-1} and s_{n+1} , immediately implies some knowledge about s_n , too. The main contribution of this work, is a method of incorporating this additional knowledge into the Belief P ropagation decoding scheme.

2. M N A LG O R IT H M

Our joint source-channelschem e is based on M ackay and N œl's algorithm (a thorough introduction m ay be found in [5]), a variant of the earlier G allager code [4]. A lthough originally proposed for the binary eld, extending the M N algorithm to higher nite elds is straight-forward as demonstrated in [6]. The original




Figure 1: The Dynam ic Block Prior visualized as a third layer attached to the bipartite graph of the LDPC code.

m otivation form oving to higher elds was reducing the num ber of edges (and short loops) in the code's graph. For our purpose, this enables us to treat M arkov sequences with a richer alphabet, consisting of $q = 2^i$ symbols (i being an integer). The algorithm consists of two sparse m atrices known both to the sender and the receiver: A (m k), and B (m m), where k is the source block length, m is the transm itted block length, and the code rate being R = k=m. All non-zero elements in A and B are from f1;2:::m 1g, and B must be invertible. Encoding of a source vector s into a codew ord t is perform ed (all operations are done over GF (g)) by:

t is converted to binary representation and transm itted over the channel. During transm ission, noise n is added to t, therefore the received vector is r = t + n. Upon receipt, the decoder reconverts r back to the original

eld, and com putes the syndrom e vector z = B r. The receiver then faces the follow ing decoding problem :

where square brackets denote appending of matrices, and x is a concatenation of s and n. The decoding problem can be visualized as a bipartite graph (Fig 1), the elements of x (circles) and z (squares) are termed "variable" and "check" nodes, respectivly. The edges of the graph correspond to the nonzero elements in [AB]. For the M N algorithm, one should further distinguish between "source variables" - the s elements in x (lled circles), and "noise variables" - the n elements in x (empty circles). The decoding problem m ay be solved using the Belief Propagation (BP) (or sum - product) algorithm [5, 6]. BP is an iterative




Figure 2: K anter-Saad [10] construction of the m atrices A, B, B 1 for rate 1=3, black regions denote nonzero elements.

algorithm with two alternating steps, horizontal pass (check! variable messages) and vertical pass (variable ! check messages). During the vertical pass, some prior know ledge is assigned to each decoded symbol, according to the assumed statistics (for the i.i.d. case this would simply be: Pr(s = j) = 1=q for all the source symbols). The key point here is that one can re-estimate and re-assign these priors after every iteration individually for each decoded symbol [7]. The outcome of each iteration is an a-posteriori probability $Q_i^a = Pr(x_i = a)$, for each symbol (both source and noise). The M N decoder is linear in the size of the source block, k, with complexity O (kqu) (per iteration), where u is the average number of checks per symbol [8, 9].

A proper construction of the matrices A and B is crucial in order to ensure nearly capacity-achieving perform ance. In this work we follow the K anter and Saad (K S) constructions [10, 11], which are very sparse, sim – ple to construct, and preform very close to the bound. The B matrix has a system atic construction: diagonal and sub diagonal, which sim pli es computation tasks [8, 11, 12]. The KS construction for R = 1=3, GF (2), is schematically displayed in Fig. 2, black regions denote nonzero elements. Extending the construction to higher GF (q) is done by random ly replacing the nonzero elements with elements of the corresponding

eld. A lthough constructed originally for i.i.d. sources, we successfully used KS matrices for uncompressed sources, how ever, we mention the possibility of im proving the perform ance by devising better codes.

The M N algorithm is also applicable for the case of an Additive W hite G aussian Noise (AW G N) channel [11]. The binary transmitted vector (assumed for simplicity to be 1) is corrupted by noise with zero mean and variance ², hence, the received vector, r^{R} , is real valued. The binary received vector, r, is determined by hard-decision, namely, $r_{i} = +1$ if $r_{i}^{R} > 0$. The probability of the transmitted bit $t_{i} = -1$ is given

by:

and the probability of an error in the ith hard-decision bit is given by:

Eq. (6) is used for calculating a prior for each noise variable. Apart of these modi cations, the M N algorithm for an AW G N channel is identical to the BSC case.

The channel capacity for AW GN is given by [2]:

Forbinary sourcem essages, (rather then real source m essages), how ever, there exist a tighter bound, [11]:

where x is the transmitted bit, $x_0 = 1$ and y is the received (corrupted) bit, with

3. DERIVING THE DYNAM ICAL BLOCK PRIORS

In every iteration of the M N algorithm, a better estimate of each variable node is attained (on average). In this section we shall describe ourm ethod of incorporating the statistical know ledge about the source, and these local estimates. Consider three successive symbols s_{n-1} ; s_n ; s_{n+1} in a sequence generated by a M arkov process with transition matrix T and alphabet GF (q). The probability of a triplet a; b; c is given by [13]:

where use has been m ade of the Bayes Rule: P(x;y) = P(x) P(y;x), and the fact that the process is mem - oryless. Now, given the a-posteriori probabilities for

the rst and last symbols in the triplet: $Q_{n-1}^{a} = Pr(s_{n-1} = a)$ and $Q_{n+1}^{c} = Pr(s_{n+1} = c)$, one can calculate a prior for the probability that $s_{n} = b$:

where Z is a normalization constant such that: $p_{b=1}^{q} Pr(s_n = b) = 1$. We term Eq. (11) the Dynamical Block Prior (DBP).

The extension of the MN algorithm to the joint source-channel case consists of the following steps:

- 1. A binary sequence of k log(q) bits is converted to k G F (q) symbols.
- 2. The encoder m easures T and P (a) for all the q sym bols over the source, and transm its reliably this side inform ation to the decoder.
- 3. The source is encoded according to (3), then reconverted to binary representation and transm itted over the BSC.
- 4. The decoder maps the received signal back to GF(q), and performs the regular decoding (4), but after every iteration of the BP, the prior for each source symbol is recalculated according to (11).

The complexity of calculating the q priors for a single symbol according to the posteriors of its neighbors is reduced from q^3 in the naive calculation, to q^2 by Eq. (11). The decoder's complexity remains linear, with total complexity of 0 (kqu + kq²) per iteration. The above-mentioned procedure may be thought of as adding a layer to the bipartite random graph represented by the matrix [AB]: The DBP's, Eq. (11), are messages passed only among source variable nodes, which are spatially related. In Fig. 1, the diamonds represent this new (directional) layer, which connects neighboring source nodes. We note that the possibility of extending this scheme to G allager codes is an open question, since the source is not explicitly represented in the graph.

4. SIM ULATION RESULTS

W e report here results for a BSC with rate R = 1=3, and for an AW GN with rate 1=4, using the corresponding KS constructions for A and B devised in [10, 11]. O ther rates, constructions and block length were also

checked. R andom vectors of length $L = 10^4$ bits (9;999 for q = 8) were generated by the M arkov process, then m apped to a vector in G F (q) with length $k = L = \log_2 [q]$, and were encoded and decoded as described in the previous section. For each reported result, at least 1000 sam ple vectors were generated and transm itted.

4.1. Estimating The Code's Threshold

The threshold for in nite source length, k ! 1, is estimated from the scaling argument of the convergence time, which was previously observed for q = 2 [10, 11]. The convergence time, measured in iterations of the M N algorithm, is assumed to diverge as the level of noise approaches the threshold from below. More precisely, we found that the scaling for the divergence of t_{med} is independent of q and is consistent with:

; $t_{m ed}() / \frac{1}{1}$ (12)

for a BSC, and an AW GN channel, respectivly.




Figure 3: Bit error rate p_b vs noise level f, triangles for q = 8, squares for q = 4, lled sym bols: use of all elements of T as side information, empty sym bols: use of only q dom inant elements of T. Inset: scaling behavior formedian convergence time t_{med} . $f_1 = 0.242$, is found by linear t.

This extrapolation is independent of k [14] (for k >> 1), so by monitoring $t_{m ed}$, for moderate k, the threshold can be found by a linear t. (see the inset of Fig. 3) Note that the estimation of $t_{m ed}$ is a sim – ple computational task in comparison with the estimation of low bit error probabilities for large k, especially close to the threshold. We also note that the analysis is based on $t_{m ed}$ instead of the average number of iterations, since we wish to prevent the dramatic e ect of a small fraction of sam ples with slow convergence or no convergence.

4.2. BSC Simulations

Some selected results are presented in Table 1. The columns correspond to: the eld size q; the source length in symbols, k; the entropy (perbit) of the source H [15]; and the corresponding maximal noise $f_{\rm Sh}$ (Eq. (1)); the critical noise, $f_{\rm c}$, up to which the bit error rate $p_{\rm b}$ 10 ⁵; and the threshold, $f_{\rm 1}$, Eq. (12).

In order to compare the joint and the Separation schemes, the generated samples were concatenated to strings of size $L = 10^5 \quad 10^6$ bits, and compressed using

two advanced compression algorithms: Prediction by PartialM atch (PPM) [16], and Arithm etic Coder (AC) [17]. In Table 2, we preset the compression ratio of the source vectors using each method (% AC; % PPM); the ratio between the compressed sequences and the transmitted blocks, m, (for the comparison, we use the same transmitted size as for the Joint scheme, m = 3k); and the maxim al noise level for this new rate for i.i.d. source, f_{AC} ; f_{PPM} . Since we assume an optimal decoder, these noise levels should be compared to f_1 for the joint scheme. In all cases, the threshold of the proposed Joint scheme for k! 1 is comparable with the Separation scheme. One should recall that these results may be improved by advanced codes. In Fig. 3, p_b is plotted against the noise level of the channel, f, for the examples of Table 1. Filled triangles represent q = 8; lled squares represent q = 16; the empty symbols in this qure refer to an approximation that will be described in the following section. The dashed (full) arrow $m \operatorname{arks} f_{Sh}$ for q = 8 (16). The inset of Fig. 3 dem onstrates the extrapolation of f_1 from the convergence time Eq. (12): for q = 8, f ($t_{m ed}$) is plotted against $1=t_{m ed}$, f_1 is then recovered by a linear t.

4.3. AW GN Simulations

B inary sequences of length $k = 10^4$ were generated using the following transition matrix:

$$T = \begin{array}{c} 0.89 & 0.11 \\ 0.11 & 0.89 \end{array}; \quad (13)$$

having M arkov Entropy H (src) = 0.5. For rate R = 1=4, this entropy corresponds to m axim al noise, Eq. (8), _{Sh} = 2.298, (4.2 Db). The sequences were




Figure 4: Scaling behavior for AW GN channel: is plotted vs. $1=t_{m ed}$ for various eld sizes, q.

transm itted over an AW GN channel, using three different elds: GF (2); GF (4); GF (8). Fig. 4 presents the scaling behavior, Eq.(12), for these elds (triangles, squares, and circles, respectively). The symbols mark working points with $p_b = 10^{-5}$, and were used for estimating the corresponding thresholds: $_1$ (q = 2) = 2.08; $_1$ (q = 4) = 2.14; $_1$ (q = 8) = 2.17. It is evident that as q increases, both $_c$ (q) and $_1$ (q) in prove.

5. REDUCING THE AMOUNT OF SIDE IN -FORMATION

The results of the previous sections indicate that the perform ance of the presented joint coding is not too far from Shannon's lower bound and, most probably, using an optimized code, the channel capacity can be nearly saturated. However, for a nite block length, the main drawback of our algorithm is the overhead of the header (i.e. the transmitted side information) which must be encoded and transmitted reliably. One has to remember that the size of the header, (T), scales with q^2 where the precision of each element is of the

order O (log k). This overhead is especially intolerable in the lim it where: $q^2 \log (k) = k$ O (1). Note that this is indeed the situation even for very large messages, $k = 10^6$, and a symbolsize of 8 bits (a "char", q = 256).

This point m ay be tackled by observing that for a process with low entropy, characterized by enhanced repetitions and correlations, T is dom inated by a sm all num ber of elem ents, while the rest of the elem ents are negligible. We therefore repeated our simulations, using only the q largest elem ents in T as side inform ation. The decoder would then set all other elem ents in each gow of T equally, to obey the norm alization condition

 $_{j}T_{ij} = 1$. In Fig. 3 the empty squares/triangles represent working points for the algorithm with q = 8=16. In both cases, the critical noise level f_{c} is only slightly decreased, but the size of the side information becomes considerably smaller.

6. JO IN T SOURCE-CHANNEL COD ING W ITH THE LACK OF SIDE INFORMATION

In this section we describe how the Markovian decoder can be im plem ented without any transm ission of side inform ation. The key points are the special properties of the KS construction (Fig. 2): the rst k rows of A are characterized by one non-zero elem ent per row and colum n, where the rst k rows of B are characterized by 2 non-zero elements. Furthermore, due to the system atic form of B, each row cannot be written as a linear combination of the other rows. Hence, the rst k bits of the syndrom e vector z, are equal (up to a sim ple permutation) to the source, with an e ective ip rate, f_{ρ} . For G F (2) for instance, $z_j = s_i + n_j + n_{j+1}$ (i marks the position of the nonzero element in the jth row of A), and $f_e = 2f(1 f)$. The rst k symbols of z are therefore a result of a hidden M arkov M odel (HMM). The underlaying transition matrix, T, generating the source sequence, can be estim ated by m eans of the EM algorithm [18], which is a standard tool for solving such P aram etric E stim ation problem s, with linear com plexity. Having T (approxim ately) revealed, the DBP's can be calculated as described in Eq. (11).

For the general construction of the M N algorithm one adds/subtracts rows of the concatenated matrix [AB] and the corresponding symbols in z, such that a situation is nally reached as follows: The rst k rows of A are the identity matrix, regardless of the construction of the rst k rows of B. From the knowledge of the noise level f and the structure of ith row of B one can now calculate the elective noise, $f_{i,e}$, of the ith received source symbol. Since all $f_{i,e}$ g are functions of a unique noise level f, one can estimate the parameters of the Markovian process using some variants of

the EM algorithm. Note, that in the general case the rst k rows of B contain loops, hence $ff_{i,e}$ g, are correlated. However, these correlations are assumed to be sm all as the typical loop size is of O (log (k)) [19].

7. CONCLUDING REMARKS

The only remaining major drawback of the presented decoder is that the complexity (per iteration), scales as O (kq^2), this may considerably slow down the decoder even for moderate alphabet size. Note how – ever, that for large q, such that q^2 k, and low entropy sequences, the transition matrix, T, is expected to be very sparse, and dom inated by elements of O (1). Taking advantage of the sparseness of T, the complexity of the decoder can be further reduced.

The one-dimensional M arkovian decoder can be easily extended to coding of a two-dimensional array of symbols or even to an array of symbols in higher dimensions [13]. The naive complexity of the DBP calculation scales as $k^d q^{2d+1}$, where k^d is the number of blocks in the array, and d denotes the dimension. U sing M arkovian and B ayesian assumptions, the complexity can be reduced to 0 ($k^d q^2$).
