# Fixed-C onnectivity $M$ em branes

#### Abstract

The statistical $m$ echanics of exible surfaces $w$ ith intemal elasticity and shape uctuations is sum $m$ arized. Phantom and self-avoiding isotropic and an isotropic $m$ em branes are discussed, w ith em phasis on the univensal negative P oisson ratio com $m$ on to the low-tem perature phase of phantom $m$ em branes and all strictly self-avoiding $m$ em branes in the absence of attractive interactions. The study of crystalline order on the frozen surface of sphericalm em branes is also treated.


## I. INTRODUCTION

The statistical $m$ echanics of polym ers, e one-dim ensional chains or loops to a rst approxim ation, has proven to be a rich and fascinating ek The success of physical m ethods applied to polym ers relies on universality \{ m any of the m acroscopic length scale properties of polym ers independent of $m$ icroscopic details such as the chem ical identity of the $m$ onom ers and their interaction potentia
$M$ em branes are tw o-dim ensional (2D ) generalizations of polym ers. The generalization of polym er statisticalm echanics to $m$ em branes, surfaces uctuating in three dim ensions, has proven to be very rich because of the richer spectrum of shape and elastic deform ations available. In contrast to polym ers, there are distinct universality classes ofm em branes distingu ished by the nature of their short-range order. There are crystalline, uid and hexaticm em brane analorne corresponding phases of strictly two-dim ensional system s ( m onolayers) where shape uctuations are frozer

The intrinsic crystalline order of xed-connectivity mem branes $w$ ith, say, typical coordination num ber 6 , leads to the altemative term inology crystalline $m$ em branes. T hey are also referred to as polym erized or tethered $m$ em branes. In general the $H$ am iltonian for a $x e d$-connectivity $m$ em brane will include both intrinsic elastic contributions ssion and shear) and shape (bending) contributions, since the m em brane undergoes both types of deform ation
$F$ lexible $m$ em branes are an im portant $m$ em ber oI tne enorm ous class of soft condensed $m$ atter system s
Soft $m$ atter responds easily to extemal forces and has physical properties that are often dom inated by the entropy of them al or other statistical uctuations.

This chapter will describe the properties of $x e d$-connectivity $m$ embranes $w$ ith focus on the universal negative Poisson ratio that illustrates the novel elastic behavior of the extended (at) phase of physical membranes, the tubular phase of anisotropic $m$ em branes and ordering on frozen curved $m$ em brane topographies.

## II. PHYSICALEXAMPLESOFMEMBRANES

O ne can polym erize suitable chiral oligom eric precursors to form $m$ olecular sheet: This approach is based directly on the idea of creating an intrinsically two-dim ensional polym er. A ltematively one can perm anently crosslink uid-like Langm uir-Ble in s or am phiphilic layers by adding certain functional groups to the hydrocarbon tails and/or the polar heads as shown schem atically in F i

that are essential to the function and stability of the cell as a wholk thoroughly studied exam ple is the cytoskeleton of $m \mathrm{~mm}$ alian erythrocytes (rea مlooa cells). The hum an body has roughly $510^{13}$ red blood cells. The red blood cell cytoskeleton is a protein netw ork whose links are spectrin tetram ers (of length approxim ately 200 nr ...... junction com pood of short actin lam ents (of length 37 nm and typically 13 actin monom ers long (see Fi and Fi . There are roughly 70,000 triangular faces in the entire $m$ esh which is bound as a wole oy ankyrin and other proteins to the cytoplasm ic side of the other key com ponent of the cellm em brane, the uid phospholipid bilayer. W thout the cytoskeleton the lipid bilayer would disintegrate into a thousand little vesicles and certainly the red blood cell would not be capable of the shape deform ations required to squeeze through narrow capillaries.
$T$ here are also inorganic realizations of $x e d$-connectivity $m$ em branes. $G$ raph itic oxide ( $\mathrm{G} O$ ) m em branes are m icron size sheets of solid carbon, w th thicknesses on the order of 10A, form ed by exfoliatinn ith a strong oxidizing agent. Their structure in an aqueous suspension hasbeen exam $\quad M$ etaldichaloogenides such as $\mathrm{M} \mathrm{OS}_{2}$ have alse heen observed to form rag-like sheet: Finally sim ilar structures occur in the large sheet $m$ olecules, show $n$ in Fi and believed to be an ingredient in glassy $\mathrm{B}_{2} \mathrm{O}_{3}$.

## III. PHASE DIAGRAMS

Let us consider the general class of D-dim ensional elastic and exible manifolds uctuating in d-dim ensionalEuclidean space. Such $m$ anifolds are described by a d-dim ensional vector $x(x)$, where $x$ labels the $D$-dim ensionalintemal

P hantom $m$ em branes are by far the easiest to treat analytically and num erically. They $m$ ay even be physically realizable by synthesizing $m$ em branes from strands that cut and repair them selves on a su ciently short tim e scale that they access self-intersecting con gurations. O ne can also view the analysis of the phantom $m$ em brane as the rst step in understanding the $m$ ore physical self-avoiding $m$ em brane. $C$ om bined analytical and num erical studies have yielded a thorough understanding of the phase diagram of phantom xed-connectivity mem branes.

O f course anything is possible in $m$ ean eld theory but a variety flytic and num erical calculations indicates the true phase diagram of phantom mem branes is qualitatively like Fi The crum pled phase is described by a line of equivalent G aussian xed points (GFPs). There is a crum pling transition line in the tplane containing an infrared stable xed point (CTFP) which describes the long wavelength properties of the crum pling transition. Finally, for large enough values of and negative values of $t$, the system is in a $\backslash$ at" phase whose properties are dictated by an infrared stable at phase xed point (FLFP).

T he phase diagram revealed by the "-expansion is thus a little more com plex than that sketched in F i T he three additional xed points are infra-red unstable, how ever, and can only be reached for very speci c values of the Lam e coe cients.

## 4. The properties of the at phase

Fi b) show s a typical equilibrium con guration for a $m$ em brane that has developed a preferred orientation in the oulk - the surface norm als clearly have long-range order. In this phase the $m$ embrane is a rough extended tw o-dim ensional structure. T he rotational sym $m$ etry of the full free enorry is spontaneously broken from $O$ ( $d$ ) to $O$ ( $\mathrm{d} \quad \mathrm{D}$ ) $\mathrm{O}(\mathrm{D})$. The long wavelength properties of the at phase are described by the FLFP (see F , Since the FLFP occurs at non-zero renorm alized values of the Lam e coe cients, the associated critical exponents are clearly non-G aussian. $T$ hese key critical exponents have also been determ ined by independent $m$ ethods. Large scale sim ulation of $m$ em branes in the at phase $m$ odelwere perform ed in $R \in \quad T$ he results obtained for the critical exponents are very accurate:

T he num erical sim ulations are in qualitative agreem ent with both the SC SA and large-d analytical estim ates. On the experim ental side we are fortunate to have twomeasurem ents of the key critical exponents for the at phase of xed-connectivity $m$ em branes. The static structure factor of the red blood cell cyt leton has been m easured by sm all-angle x-ray and light scattering, yielding a roughness exponent of $=0: 65$ (10 $\quad$ Freeze-fracture electron m icroscopy and static light scattering of the conform ations of graph itic oxide sheets reveal at sheets w ith a fractal dim ension $d_{H}=2: 15(6)$. B oth these $m$ easured values are in good agreem ent $w$ th the best analytic and num erical predictions, but the errors are still too large to discrim inate betw een di erent analytic calculations and to accurately substantiate the erical sim ulations.

A nalcritical regim e of at $m$ em brane is achieved by sub jecting them em brane to extemaltensio This gives rise to a low tem perature phase in which the $m$ em brane has a dom ain structure, $w$ ith distinct dom ains corresponding to at phases with di erent bulk orientations. This describes, physically, a buckled $m$ em brane whose equilibrium shape is no longer planar.

## B. Self-avoiding M em branes

Physically realistic xed-connectivity mem branes $w i l l$ have large energy barriers to self-intersection. T hat is they $w$ ill generally be self-avoiding. Self-avoidance is fam iliar in the physics of polkm er chains and $m$ ay be treated by including the Edw ards-type de retion repulsion of the H am iltonian in Eq . A detailed sum m ary of our current understanding is given in Refs $\quad T$ he essential nding is that self-avoidance elim inates all but the at phase.

## 1. N um erical sim ulations

N um erical sim ulations are currently essential in understanding the statisticalm echanics of self-avoiding m em branes because the treatm ent of nonlinear elasticity together with non-local self-avoidance is currently beyond the realm of analytic techniques.

Two discretizations of $m$ em branes have been adopted to inconporate self-avoidance. The balls and springs class of m odels begins $w$ ith a netw ork of N particles in a intrinsically triangular array and interacting via a nearest-neighbor elastic potential

Som e in the lack or a crum pled phase for self-avoiding xed-connectivin branes is ored by the study of folding. Folding corresponds to the lim it of in nite elastic constant $w$ ith the further approxim ation that the space of bending angles is discretized. O ne quickly discovers that the re ection sym $m$ etries of the allow ed folding vertioes forbid local folding (crum pling) of surfaces. There is therefore essentially no entropy for crum pling. $T$ here is, how ever, local unfolding and the resulting statisticalm echanicalm odels are non-trivial. The lack of local folding is the discrete equivalent of the long-range curvature-curvature interactions that stabilize the at phase. T he duale ect of the integrity of the surface (tim e-independent connectivity) and self-avoidance is so powerfiul that crum pling seem $s$ to be im possible in low em bedding dim ensions.

## VI. ORDER ON CURVED SURFACES

The spatial curvature encountered in curved geom etries adds a fundam entally new ingredient to crystallography not found in the study of order in spatially at system s. A s the num ber of particles on the sphere grow s , isolated charge 1 defects (5s) will induce too m uch str- train can be relieved by introducing additionaldislocations, consisting of pairs of tightly bound 5-7 defect which don't spoil the topological constraints because their net disclination charge is zero. D islocations, whicn are them selves point-like topological defects in dim ensions, disnupt the translational order of the crystalline phase but are less dismuptive of orientational order
$R$ ecent w ork on an experim ental realization of the generalized $T$ hom son problem has allow ed us to explore the low est energy con guration of the dense ing of repulsive particles on a spherical surface and to confront a previously developed theory w ith experim ent We create tw o-dim ensional packings of colloidal particles on the surface of spherical w ater droplets and view the structures with opticalm icroscopy. A bove a critical system size, the therm ally equilibrated colloidal crystals display distinctive high-angle grain boundaries, which we call \scars". These grain boundaries are found to end entirely w th in the crystal, which is never observed on at surfaces because the energy penally is too high.

The experim ental system is based on the self-assem bly of one $m$ icron diam eter cross-linked polystyrene beads adsorbe ${ }^{-1}$... the surface of spherical water droplets (of radius $R$ ), them selves suspended in a density-m atched oil $m$ ixture The polystyrene beads are alm ost equally happy to be in oil or water (the bead/oil surface tension is close to the bead/w ater surface tension) and therefore di use freely until they nd the oil-w ater interfac.-..-1 stick there. P article assem bly on the inter ftwo distinct liquids dates to the pioneering work of P ickerin and was beautifully exploited by $P$ ieransk som e tim e ago. The particles are im aged w th phase contrast using an
inverted $m$ icroscope. A fter detem ' the center of $m$ ass of each bead, the lattice geom etry is analyzed by original D elaunay triangulation algorithm appropriate to spherical surfaces.

W e analyze the lattice con gurations of a collection of 40 droplets A typical sm all spherical droplet with system size, $R=a=4.2$ where $a$ is the $m$ ean particle spacing, is show $n$ in $F$ ic $\quad$ The associated $D$ elaunay triangulation is show n in F ig . The only defect is one isolated charge +1 disclination. Extrapolation to the entire surface of the sphere is statustrcally consistent w ith the required 12 totaldisclinations.
$Q$ ualitatively di erent results are observed for larger droplet sizes as defect con gurations w ith excess dislocations appear. A though som e of these exœess dislocations aro ionlated, m ost occur in the form ofdistinctive (5 $\begin{array}{llll}5 & 7 & 7\end{array}$
5) chains, each of net charge +1 , as show $n$ in
.T hese chains form high-angle ( 30 ) grain boundaries, or scars, which term inate freely within the crystal. Such a leature is energetically prohibitive in equilibrium crystals in at space. Thus, although grain boundaries are a com $m$ on feature of 2 D and 3D crystalline $m$ aterials, arising from a $m$ ism atch of crystallographic orientations across a boundary, they usually term inate at the boundary of the sam ple in
at space because of the excessive strain energy associated $w$ ith isolated term inal disclinations. Tem ination $w$ ithin the crystal is a feature unique to curved space.
$O f$ key interest is the num ber of excess dislocations per chain as a function of the dim ensionless system size $R=a$. $T$ his is plotted in $F$ io $\quad$ Scars only appear for droplets $w$ ith $R=a \quad 5$. These results provide a criticalcon m ation of a theoretical prediction that $R=a \operatorname{m}$ ust exceed a threshold value $(R=a)$ 「 corresponding to $M \quad 360$ particles, for exœess defects to proliferate in the ground state of a spherical crysta. The precise value of $(R=a)_{c}$ depends on details of the $m$ icroscopic potential, but its origin is easily understood oy considering just one of the 12 charge +1 disclinations required by the topology of the sphere tr at space such a topological defect has an associated energy that grow s quadratically w ith since it is created by excising a $2=6$ wedge ofm aterial and gluing the boundaries togethe $\quad T$ he elastic stran energy associated with this defect grow s as the area. In the case of the sphere the radius plays the role of the system size. A s the radius increases, isolated disclinations becom e $m$ uch $m$ ore energetically costly. This elastic strain energy $m$ ay be reduced by the form ation of linear dislocation arrays, i.e. grain boundaries. The energy needed to create thes dislocation core energy $E_{c}$ and scales linearly w the system size Such screening is inevitable in at space (the plane) if one forces an extra disclination into ${ }^{10}$ free grouna state. Unlike the situation in at space, grain boundaries on the sphere can freely term inate consistent with the scars seen on colloidal droplets.

A powerfiul been developec $T$ he originalparticle problem is $m$ apped to a system of interacting disclination defects in a continuum elastic curvea background. The defect-defect interaction is universal $w$ th the particle $m$ icroscopic

$T$ he potential is attractive for opposite charged defects and repulsive for like-charged defects. $M$ any predictions of this $m$ odelare univensalin the sense that they are insensitive to the $m$ icroscopic potential. This enables us to $m$ ake de nite predictions even though the colloidalpotential is not precisely known. It also m eans that ourm odel system serves as a prototype for any analogous system w ith repulsive interactions and sphericalgeom etry. To further test the validity of th is approach wo show a typical ground state for large $M$ in $F$ id $T$ he system size here is $R=a=12$, sim ilar to the droplet in F is only di erence 15 a result of therm al uctuations, which break the tw o defect scars in the experim ent. O ne nds that $N$ grows for large $(R=a)$ as $\overline{3}$. $\overline{11} \quad 5 \cos ^{1}(5=6) \quad \frac{R}{a} \quad 0: 41 \frac{R}{a}$, independently of the m icroscopic potential. This prediction is universal, and is in rem arkable agreem ent with the experim ent, as show $n$ by the solid line in $F$ ic

W e expect these scars to be w idespread in nature. They should occur, and hence $m$ ay be exploited, in su ciently large sti viral protein capsids, giant spherical fullerenes, spherical bacterial surface layens (s-layers), provided that the spherical geom etry is not too distorted. Tem inating strings of hennons and pentagons $m$ ight serve as sites for chem ical reactions or even initiation points for bacterial cell divisio: and will surely in uence the mechanical properties of spherical crystalline shells.

The polyhedra? pus cytoskeleton of the unioellular non $-m$ otile ocean organism A ulosphaera (a m em ber of the specioc P haeodari is show in Fi A triangulation revealing three scars, tw o of which are branched, is show $n$ in $\mathrm{Fi} \quad$ The skenton itself is such a perfect triangular lattice that it coincin ith the D elaunay triangulation determ Ined by its vertioes. The case of viral capsids has been analyzed in Re where it is shown that, rather than scarring, icosahedral packings becom e unstable to facetir ciently large virus size, in analogy with the buckling instability of disclinations in two-dim ensional crystals

Scarred sphericalcrystalsm ay provide the building blocks (atom s) ofm icron-scalem olecule and materials. W hile topology dictates the overall num ber of scars (12), the details of the geom etry and derect energetics determ ine the length and structure of the scars them selves. It is possible that scarred on ${ }^{110}$ som es willultim ately y ield com plex self-assem bled $m$ aterials $w$ th novelm echanical or optoelectronic properties
$N$ ew structures arise if one changes the structure colloid of the topology of the surface they coat. N elson has analyzed the case ofnem atic colloids coating a sphere In this case the preferred num ber ofelem entary disclination defects is 4, allow ing for the possibility of colloidal atom $s w$ ith tetrahedral functionality and sp ${ }^{3}$ ty ${ }^{-1}$. case of toroidal tem plates w ith 6-fold bond-orientational (hexatic) order has been analyzed recenth It is found that defects are energetically favored in the ground state for fat torii or moderate vesicle size.
