M odulation of dephasing due to a spin-boson environment?

A bstract

We study the reduced dynam ics of a spin (qubit) coupled to a spin-boson environment in the case of pure dephasing. We derive form alexact expressions which can be cast in terms of exact integro-di erential master equations. We present results for a SB environment with ohm ic dissipation at nite temperatures. For the special value of the ohm ic damping strength K=1=2 the reduced dynamics is found in analytic form. For K=1 we discuss the possibility of modulating the elect of the SB environment on the qubit. In particular we study the elect of the crossover to a slow environment dynamics, which may be triggered by changing both the temperature and the system-environment coupling.

1 Introduction

The possibility of controlling the dynamics of a complex quantum system would open a wide scenario for both fundamental and applied physics. New physical properties emerging at the nanoscale may yield new paradigms for nanoelectronics, an example being quantum information processing [1]. The basic operations of a quantum logic device can be described in its computational space de ned by a set of degrees of freedom which can be prepared

(write) and measured (read) and of course evolve coherently. However the Hilbert space of the device is much larger than the computational space, and e ects of the additional degrees of freedom may be relevant for the reduced dynamics we aim to control [2,3]. These environmental degrees of freedom may be \internal" to the device, which is a many-body object, or \external", belonging to the read/write circuitry or to auxiliary devices (buses or other idle or working qubits). They determine loss of coherence, which is ultimately due to the entanglement between system and environment [2].

Much of the e ort in the analysis of decoherence in quantum logic devices has been focused on model environments made of many weakly coupled harmonic oscillators [2,4]. The key feature of these linear models is that the except on the reduced dynamics of the system can be described in terms of simple statistical information on the environment, spectral densities or power spectra, even if a detailed knowledge of its microscopic structure is not known [5{7]. However a slightly more detailed knowledge of the environment dynamics is needed in certain situations, for instance if the environment has memory on the time scale of the system dynamics [8,9].

B istable in purities located close to a solid state device which produce 1=f noise [10] are a physical realization of an environment with memory. They have been recognized as the major source of decoherence in recent experiments [11] demonstrating quantum coherent dynamics in superconducting devices. Such an environment has been modeled in Ref. [9], with a set of Fano in purities [12] which randomly polarize the device. A peculiar elect of this environment, related to its non linear nature, is that the reduced qubit dynamics shows various qualitatively dierent regimes depending on the switching rate of the impurities. In particular dephasing due to slow in purities is not described by a single rate and memory elects of the environment enter the qubit dynamics.

The main goal of this work is to discuss a situation where the reduced dynam ics of the system is able to probe di erent regimes of the environment dynamics. To this end we introduce a model which exhibits tunable crossover elects. We take as the environment an impurity described by a spin-boson (SB) model [5,6]. The Hamiltonian is introduced in section 2, where we also discuss applications to physical problems. In section 3 the formal solution for the o-diagonal element $_{01}$ (t) of the RDM is found, in the limit of pure dephasing and ohmic damping in the scaling regime. In section 4 a generalized master equation for $_{01}$ (t) is derived and the analytic structure of the kernels is exploited in section 5 to study the character of the behavior of $_{01}$ (t). Finally in section 6 we sketch a phase diagram for this problem.

We study the following Hamiltonian ($\sim = 1$)

It describes two spins (~ and ~) coupled to each other by the interaction v. The spin ~ is also coupled to a collective coordinate X of a set of otherwise noninteracting harm onic oscillators (operators \mathbf{a}^{y} and \mathbf{a}). The Ham iltonian H_{SB} represents a spin-boson model [5,6], which describes a two state system with tunneling amplitude and bias SB coupled to a set of harm onic oscillators. This set of bosons is characterized by the spectral density of the operator X, given by $G(!) = {}^{2}(!)$!). The Ham iltonian Eq.(1) is very rich and m ay modelmany dierent physical problems. In this work we will regard \sim as describing a qubit coupled with an environment consisting of a bistable im purity (\sim) described by the SB m odel, H $_{\mathrm{SB}}$. W e are primarily interested in the reduced dynamics of the qubit, resulting from tracing out all the environm ental degrees of freedom, i.e. the harm onic m odes and the spin \sim . Physically ~ m ay represent a Josephson quantum logic device where external voltage gates and magnetic elds are used to tune the elective charging energy and Josephson coupling E_J [4,13]. The environment may be a charge close to the device undergoing phonon-assisted tunneling between two positions. We will consider an ohm ic spectral density G (!) [5], i.e. we choose a set of free bosons such that the power spectrum of the collective coordinate X is given by

where $!_{\text{c}}$ represents the high frequency cut-o of the harm onic modes. The case of ohm ic spectral density is interesting because the SB model has a rich phase diagram resulting in an environment where memory elects may be tuned by the temperature T. We will present results for K 1 focusing on nonzero temperatures, $T > {}_{r} = (=!_{c})^{K=(1-K)}$, where ${}_{r}$ is the renormalized tunneling amplitude in H_{SB} [5]. Physically this regime describes a SB impurity active in producing decoherence for the qubit \sim . From a technical point of view this regime requires some care. For instance the dephasing rate for h_{z} i using the standard secular master equation [8,5] in the couplings

(for $"_{SB} = v = 0$) reads S_X ($_r$)=4 [5]. For $T > _r$ it reduces to

this result being valid only if (T) $_{\rm r}$ [8,5]. Thus for large enough tem peratures an analysis which goes beyond the standard secular master equation is needed [16,5].

We mention nally other physical problems where the model we study may be relevant. First of all the Ham iltonian Eq.(1) may describe a system of two-qubits (~ and ~) subject to gaussian noise, the ohmic case describing the elect of a resistive circuitry. The low temperature regime, which may describe a working two-qubit gate, has been investigated using the standard secular master equation [14]. Instead for temperatures T > r our model may describe a working qubit (~) coupled with a idle qubit (~) not perfectly switched o .Finally the spin may represent a measuring device [15] for the mesoscopic system described by H_{SB} . This picture is an alternative framework for our work, namely the reduced dynamics of ~ provides the result of the measurement on a SB system. If the coupling v is weak and the dynamics of the SB is fast enough only the power spectrum of the coupling operator r

enters the dynam ics of \sim , whereas if the SB has a slow dynam ics the spin \sim is able to detect also details of the dynam ics of which go beyond S (!).

3 Form alsolution for the reduced density matrix

We consider the pure dephasing regime $E_J=0$ where $[H;_z]=0$, so no relaxation process takes place and dephasing is due to uctuations of the energy dierence of system, i.e. $_z$, eigenstates. Hence the diagonal elements of the reduced density matrix of the qubit in the $_z$ basis (populations) are constant, whereas o -diagonal elements (coherences) decay. All the information on the reduced dynamics is included in the coherences. In this section we derive an exact formal expression for the coherence $_{01}$ (t) h0j (t) j1i.

We choose a factorized initial density matrix W (0) = (0) w_{SB} (0), with the spin-boson environment in the general state w_{SB} (0). Product initial states are relevant in quantum computing, one of the main requirements being the possibility to prepare the qubit in well de ned initial states. The coherence

The Feynm an propagators K are associated to the two Hamiltonians H can be expressed as a real-time path integral

describing respectively propagation along the diagonal of the density matrix and o -diagonal excursions. For a spin these paths are piecew ise constant, the time intervals in which the spin is in a diagonal state = 1 are called so journs, while the time intervals spent in an o-diagonal state = 1 are referred to as blips. Depending on the initial condition for the spin, the initial state can be either a so journ or a blip. We now choose for the spin a diagonal initial state in the \coordinate", i.e. $_z$, basis w $(0) = \frac{1}{2} \hat{\mathbf{I}} + \frac{1}{2} \mathbf{p}(0) _z$, where $\mathbf{p}(0)$ denotes the initial population dierence between the $_z$ eigenstates. G eneralized M aster Equation

For quantum dissipative systems it is generally useful to formulate the dynam ics of the open system by means of appropriate master equations for the reduced density matrix. For the spin-boson problem generalized master equations relating the averages of the spin components have been obtained in Refs. [5,16]. In this section we show that the series expressions for A (; 0 ;t) and B (; 0;t) given in Eqs.(21,22) can also be cast into the form of exact integro-di erential equations.

To this end we have to $\$ nd the kernels, i.e. the irreducible components in the form alexpressions (21,22). Irreducibility of a kernel means that it cannot be cut into uncorrelated pieces at an intermediate so journ without removing correlations due to the harm onic bath, across this so journ. Following the lines of Refs.[5,16] we de ne irreducible in uence functions subtracting from the inter- and intra-blip interaction factors G_m all the reducible components

where K_1 (), K_2 () are the Laplace transforms of the kernels (23,24) and p(0) comes from the initial condition chosen for the spin ~.

5 Reduced dynam ics at nite tem peratures

Solving the pole equation (30) represents a form idable task, so in the following we shall focus on special damping and temperature regimes which are particularly relevant for quantum computing. We shall analyze dephasing at nite temperatures at two special coupling conditions: weak damping K 1 and K = 1=2. In the second case the spin-boson model can be mapped onto a Fano Anderson model [12] which is suitable to study dephasing due to bistable uctuators producing 1=f noise [9].

We shall adopt an approximate treatment widely used in the spin-boson literature [5,6], the noninteracting-blip approximation (N $\mathbb{B}A$). In the N $\mathbb{B}A$, the blip-blip interactions $_{j;k}$ are neglected, and also the so journ-blip interactions $X_{j;k}$ are disregarded except those of neighbors, k=j 1, and they are approximated by $X_{j;j-1}=Q^{(0)}(_j)$. Thus the in uence functions (13) factorize into the individual blip in uence factors, and the irreducible in uence functions (23) vanish for n>1. For 0 hm ic damping in the scaling regime, each blip interacts with the subsequent so journ only (see Eq.(15)), thus the only approximation involved in the N $\mathbb{B}A$ is the neglect of the blip-blip interactions. This approximation is justified in the regimes of our interest, see ref. \mathbb{B}].

W ithin the N IBA the series expression for the irreducible kernels (23,24) reduce to the lowest order contributions (25,26). Evaluation of Eqs. (27,28), with these kernels give the reduced dynamics of the qubit in the N IBA. To make things $\sin p$ ler we shall consider the unbiased case $_{SB} = 0$.

5.1 The case K = 1=2

The behavior of C_+ (t) has been analyzed in Ref. [9] where two qualitatively dierent regimes for the problem were identied.

Fast environment { If 2v = F 1 only one of the exponentials appearing in Eq. (31) dominates the long-time behavior and C $_+$ (t) shows a single rate, given by $\frac{1}{2}$ (1) $_F$ $v^2 = _F$, the standard G olden Rule result. The decay of C $_+$ (t) at all times, described by (t) = $_-$ lnfC $_+$ (t)g, is well approximated by simulating the SB model with suitable set of harmonic oscillators reproducing the power spectrum S (!). Here the power spectrum Eq.(4) is a Lorentzian S (!) = $2v^2_F = (\frac{2}{F} + \frac{1}{F}^2)$, due to the pure relaxation behavior of h_z i for v = 0 [5]. Thus in this regime the spin ~ sees the SB environment as an elective set of harmonic oscillators, and no detailed information or memory elects of the environment enters C $_+$ (t).




Fig. 1. (a) The real part (solid lines) and the imaginary part (dots) of the rates entering Eq. (31) are plotted for nite temperature $k_B T$ $_{SB} > 0$. (b) The full expression for (t) for various $2v = _F$: deviations from the weak coupling result $_{OSC}$ (t) (dashed line) are apparent for $_F < 2v$. Here $p = tgh \left[_{SB} = (2k_B T) \right] = 0.08$.

We mention that for K=1=2 the same structure Eq. (31) is also found in more general situations, $_{SB}$; E_{J} \in 0 [9,17]. Formulas for A and are more complicated, for instance Re and Im are both non vanishing in the entire $2v=_{F}$ range and a third regime $2v=_{F}$ 1 appears (see Fig.5.1). However the analysis using the expressions (32) remains still valid, and in the following we will identify the dierent regimes for K 1 from a similar analysis of the poles of C^{b} + ().

In the absence of bias, $_{SB}=0$ only the kernel K_1 () is non vanishing, and in the M arkov lim it it reads K_1 () = $_T^2 = [+2]$ (T), where (T) is given by Eq. (3) and we have introduced the temperature dependent tunneling term $_T = _T (2 k_B T = _T)^K$. The correlator $_T^{(b)}$ + () is readily found as

In this case there is an interm ediate temperature regime, $k_{\rm B}\,T_0 = k_{\rm B}\,T < k_{\rm B}\,T_+ = \frac{2}{T} = (4~{\rm K~v})$, where we may have three real roots. In this regime, which occurs only if v= $_{\rm T}$ < 1, the dominant contribution to C $_+$ (t) comes again from a single pole, $_1$ $= 2\,(v=_{\rm T}\,)^2$ (T). Instead for temperatures T > T_+ the two complex conjugate $_{1=2}$ are the dominant poles. The decay rate displays the K ondo behavior $_{\rm T}^2 = [4~({\rm T}\,)] \,/\,\, T^{2{\rm K}-1}$ and does not depend on v. The coupling v enters the frequency shifts, which approach v if the temperature is further increased. Thus in the region T $_{\rm T}$ 0 and v < $_{\rm T}$ we nd a crossover which may be triggered by both v and T, the crossover line being given by

6 D iscussion of the results and conclusions

The analysis of the poles of $^{\circ}$ $_{+}$ (), Eq.(34) allows to extend the qualitative conclusion for K = 1=2 to the regime K 1. In this latter case we not that the dynam ics of $^{\sim}$ shows a behavior which rejects the crossover of the SB environment to a slow dynamics regime. For K 1 the SB environment can be modulated by acting on both the coupling v and the temperature. Instead for K = 1=2 and $_{\rm SB}$ = 0 the crossover is triggered by the parameter v= $_{\rm F}$ only. This is simply due to the fact that for the relatively strong coupling K = 1=2, $_{\rm Z}$ has a relaxation dynamics at any temperature. Thus at any temperature we may identify the correlation time of the SB environment $_{\rm C}$ $_{\rm F}$ 1 . The crossover to the slow environment regime occurs when $_{\rm C}$ 1 which marks the limit where the standard master equation approach in the coupling v would break down [8].

To understand the behavior for K $\,^1$ we focus on v $\,^{}_{\rm T}$ and we identify the correlation time $\,^{}_{\rm C}$ of the SB environment from the dynamics of the SB model for v = 0. In this case $\,^{}_{\rm Z}$ displays a crossover from coherent to incoherent dynamics at a temperature $k_{\rm B}$ T $\,^{}_{\rm K}$ (K) $\,^{}_{\rm r}$ = K $\,^{}_{\rm E}$ Below T coherent oscillations at frequency $\,^{}_{\rm T}$ are slowly damped with rate given by (T) $\,^{}_{\rm T}$ and we may identify $\,^{}_{\rm C}$ $\,^{}_{\rm T}$ Thus the SB environment is fast, since $2{\rm v}_{\rm C}$ $2{\rm v}$ = $\,^{}_{\rm T}$ 1 and $\,^{}_{\rm O1}$ (t) shows the single rate $\,^{}_{\rm C}$ $\,^{}_{\rm C}$ (T) $\,^{}_{\rm C}$ S (0)=2. If the temperature increases fairly above T the dynamics of $\,^{}_{\rm C}$ is incoherent and relaxation occurs, with a slow rate $\,^{}_{\rm T}$ (T) $\,^{}_{\rm T}$ =2 (T) [5] which is identified with $\,^{}_{\rm C}$ 1. Slow environment exts are then expected to appear in the reduced dynamics of $\,^{}_{\rm C}$ at $2{\rm v}$ = $\,^{}_{\rm T}$ (T) 1 which is indeed the crossover line Eq.(37).

Finally we point out possible extensions of our analysis. A SB environment with subohmic (superohmic) spectral densities [5] could be treated along the same lines, but since the uncoupled SB dynamics is always slow (fast) we do not expect tunable crossover lines to appear. Our analysis can be easily extended to an environment made of an arbitrary number of SB impurities. In this case $C_+(t) = {}^0_-i C_-^{(i)}(t)$ where $C_-^{(i)}(t)$ is the individual contribution of the i-th SB impurity. This allows to model a simple environment which produces i-finished by choosing a suitable distribution [10] of the parameters of the set SB impurities. For instance in Ref. m ost how many impurities in the set are active. Instead for a 1=f environment modeled by a set of ohmic SB impurities with K 1 our results show a non trivial behavior as a function of the temperature, which may be relevant for recent observations [18] of temperature-dependent dephasing due to 1=f noise. Finally if $E_J \in 0$, $_Z$ is not conserved and relaxation occurs. The relaxation rate increases monotonically with E_J =".We believe that the physical picture emerging from this work still applies to dephasing (see Ref. [17] for K = 1=2) at least for times smaller than the relaxation time.
