# M odulation of dephasing due to a spin-boson environm ent?

#### Abstract

W e study the reduced dynam ics of a spin (qubit) coupled to a spin-boson environ$m$ ent in the case of pure dephasing. $W$ e derive form al exact expressions which can be cast in term s of exact integro-di erential $m$ aster equations. $W$ e present results for a $S B$ environm ent w ith ohm ic dissipation at nite tem peratures. For the special value of the ohm ic dam ping strength $K=1=2$ the reduced dynam ics is found in analytic form. For $K \quad 1$ we discuss the possibility of $m$ odulating the e ect of the SB environm ent on the qubit. In particular we study the e ect of the crossover to a slow environm ent dynam ics, which $m$ ay be triggered by changing both the tem perature and the system -environm ent coupling.

## 1 Introduction

The possibility of controlling the dynam ics of a com plex quantum system would open a wide scenario for both fundam ental and applied physics. N ew physical properties em erging at the nanoscale $m$ ay yield new paradigm $s$ for nanoelectronics, an exam ple being quantum inform ation processing [1]. The basic operations of a quantum logic device can be described in its com putational space de ned by a set of degrees of freedom which can be prepared

(w rite) and $m$ easured (read) and of course evolve coherently. H ow ever the H illbert space of the device is much larger than the com putational space, and $e$ ects of the additional degrees of freedom $m$ ay be relevant for the reduced dynam ics we aim to control [2,3]. These environm ental degrees of freedom $m$ ay be \intemal" to the device, which is a $m$ any-body ob ject, or \extemal", belonging to the read/w rite circuitry or to auxiliary devices buses or other idle or w orking qubits). They determ ine loss of coherence, which is ultim ately due to the entanglem ent betw een system and environm ent [2].

M uch of the e ort in the analysis of decoherence in quantum logic devioes has been focused on $m$ odelenvironm ents $m$ ade ofm any weakly coupled harm onic oscillators $[2,4]$. T he key feature of these linearm odels is that thee ects on the reduced dynam ics of the system can be described in term sof sim ple statistical inform ation on the environm ent, spectral densities or pow er spectra, even if a detailed know ledge of its m icroscopic structure is not known [5\{7]. H ow ever a slightly $m$ ore detailed know ledge of the environm ent dynam ics is needed in certain situations, for instance if the environm ent has $m$ em ory on the time scale of the system dynam ics $[8,9]$.

B istable im purities located close to a solid state devige which produce $1=f$ noise [10] are a physical realization of an environm ent with $m$ em ory. They have been recognized as the $m$ a jor source of decoherence in recent experim ents [11] dem onstrating quantum coherent dynam ics in superconducting devices. Such an environm ent has been $m$ odeled in Ref. [9], w th a set ofFano im purities [12] which random ly polarize the device. A peculiar e ect of this environm ent, related to its non linear nature, is that the reduced qubit dynam ics show $s$ various qualitatively di erent regim es depending on the sw itching rate of the im purities. In particular dephasing due to slow im purities is not described by a single rate and $m$ em ory e ects of the environm ent enter the qubit dynam ics.

The main goal of this work is to discuss a situation where the reduced dynam ics of the system is able to probe di erent regim es of the environm ent dynam ics. To this end we introduce a m odel which exhibits tunable crossover e ects. $W$ e take as the environm ent an im purity described by a spin-boson (SB) m odel [5,6]. The H am iltonian is introduced in section 2, where we also discuss applications to physical problem s. In section 3 the form al solution for the o -diagonal elem ent $01(\mathrm{t})$ of the RDM is found, in the lim it of pure dephasing and ohm ic dam ping in the scaling regim e. In section 4 a generalized $m$ aster equation for $01(t)$ is derived and the analytic structure of the kemels is exploited in section 5 to study the character of the behavior of $01(t)$. Finally in section 6 we sketch a phase diagram for this problem.

2 M odel

W e study the follow ing H am iltonian $(\sim=1)$

It describes two spins ( $\sim$ and $\sim$ ) coupled to each other by the interaction $v$. The spin ~ is also coupled to a collective coordinate $X$ of a set of otherw ise noninteracting harm onic oscillators (operators $a^{y}$ and a ). The H am iltonian $H_{S B}$ represents a spin - ooson $m$ odel $[5,6]$, which describes a two state system w th tunneling am plitude and bias sb coupled to a set of ham onic oscillators. This set ofbosons is characterized by the spectral density of the operator $X$, given by $G(!)={ }^{P} \quad 2(!\quad!)$.The H am iltonian Eq.(1) is very rich and $m$ ay $m$ odel $m$ any di erent physical problem $s$. In this work we will regard ~ as describing a qubit coupled with an environm ent consisting of a bistable im purity $(\sim)$ described by the SB m odel, $\mathrm{H}_{\mathrm{SB}}$. W e are prim arily interested in the reduced dynam ics of the qubit, resulting from tracing out all the environ$m$ ental degrees of freedom, i.e. the harm onic m odes and the spin ~ . P hysically ~ m ay represent a Josephson quantum logic devige where extemal voltage gates and $m$ agnetic elds are used to tune the e ective charging energy and Josephson coupling $E_{J}[4,13]$. T he environm ent $m$ ay be a charge close to the device undergoing phonon-assisted tunneling betw een two positions. Wew ill consider an ohm ic spectral density G (!) [5], i.e. we choose a set of free bosons such that the pow er spectrum of the collective coordinate $X$ is given by

where ! ${ }_{c}$ represents the high frequency cut-o of the harm onic modes. T he case of ohm ic spectral density is interesting because the SB m odel has a rich phase diagram resulting in an environm ent where $m$ em ory e ects $m$ ay be tuned by the tem perature $\mathrm{T} . \mathrm{W}$ e will present results for $\mathrm{K} \quad 1$ focusing on nonzero tem peratures, $\left.T>\quad r=(=!\quad c)^{K=(1)} \mathrm{K}\right)$, where $r$ is the renorm alized tunneling am plitude in $H_{S B}$ [5]. Physically this regim e describes a SB im purity active in producing decoherence for the qubit ~. From a technical point of view this regim e requires som e care. For instance the dephasing rate for $h_{z}$ i using the standard secular $m$ aster equation $[8,5]$ in the couplings
(for $"_{S B}=v=0$ ) reads $S_{X}(r)=4[5]$. For $T>r$ it reduces to

this result being valid only if (T) r [8,5]. T hus for large enough tem peratures an analysis which goes beyond the standard secular m aster equation is needed [16,5].

W e m ention nally other physical problem $s$ where the $m$ odel we study $m$ ay be relevant. F irst of all the Ham iltonian Eq.(1) may describe a system of two-qubits ( $\sim$ and $\sim$ ) sub ject to gaussian noise, the ohm ic case describing the e ect of a resistive circuitry. The low tem perature regim $e$, which $m$ ay describe a working two-qubit gate, has been investigated using the standard secular $m$ aster equation [14]. Instead for tem peratures $T>{ }_{r}$ our model $m$ ay describe a working qubit $(\sim)$ coupled with a idle qubit ( $\sim$ ) not perfectly sw itched O.F inally the spin $m$ ay represent a $m$ easuring device [15] for the $m$ esoscopic system described by $\mathrm{H}_{\text {SB }}$. This picture is an altemative fram ew ork for our work, nam ely the reduced dynam ics of ~ provides the result of the $m$ easurem ent on a SB system. If the coupling $v$ is weak and the dynam ics of the $S B$ is fast enough only the power spectrum of the coupling operator $v_{z}$

enters the dynam ics of $\sim$, whereas if the $S B$ has a slow dynam ics the spin $\sim$ is able to detect also details of the dynam ics of which go beyond $S$ (!).

3 Form al solution for the reduced density matrix

W e consider the pure dephasing regim $\mathrm{E}_{\mathrm{J}}=0$ where $\left.\mathbb{H} ; ~ z\right]=0$, so no relaxation process takes place and dephasing is due to uctuations of the energy di erence of system, i.e. $z$, eigenstates. H ence the diagonal elem ents of the reduced density $m$ atrix of the qubit in the $z$ basis (populations) are constant, whereas o -diagonal elem ents (coherences) decay. All the inform ation on the reduced dynam ics is included in the coherences. In this section we derive an exact form al expression for the coherence $01(t) \mathrm{h} 0 \mathrm{j}(\mathrm{t}) \mathrm{j} 1 \mathrm{i}$.

W e choose a factorized intial density matrix $\mathrm{W}(0)=(0) \quad \mathrm{w}_{S B}(0)$, w ith the spin-boson environm ent in the generalstate $w_{S B}(0)$. P roduct initial states are relevant in quantum computing, one of the $m$ ain requirem ents being the possibility to prepare the qubit in well de ned initial states. The coherence

where $H=H_{S B} \quad \frac{v}{2} z \cdot W$ e evaluate the correlator $C+(t)$ using a functional integral approach. In the derivation we consider a dim ensionless continuous \coordinate" $q$, and specify later to the spin states $(\sim)$. describing respectively propagation along the diagonal of the density $m$ atrix and o -diagonal excursions. For a spin these paths are piecew ise constant, the tim e intervals in which the spin is in a diagonal state $=1$ are called so joums, while the tim e intervals spent in an $\circ$-diagonal state $=1$ are referred to as blips. Depending on the initialcondition for the spin, the initial state can be either a sojoum or a blip. W e now choose for the spin a diagonal initial state in the \coordinate", i.e. $z_{\text {, }}$, basis w $(0)=\frac{1}{2} \hat{I}+\frac{1}{2} p(0)_{z}$, where $p(0)$ denotes the initialpopulation di erence betw een the $z$ eigenstates. 4 G eneralized $M$ aster E quation

For quantum dissipative system $s$ it is generally useful to form ulate the dynam ics of the open system by $m$ eans of appropriate $m$ aster equations for the reduced density $m$ atrix. For the spin-boson problem generalized $m$ aster equations relating the averages of the spin com ponents have been obtained in Refs. 5,16$]$. In this section we show that the series expressions for A ( ; $; \mathrm{t}$ ) and $B\left(;^{0} ; \mathrm{t}\right)$ given in Eqs. $(21,22)$ can also be cast into the form of exact integro-di erential equations.

To this end we have to nd the kemels, i.e. the irreducible com ponents in the form alexpressions $(21,22)$. Irreducibility of a kemelm eans that it cannot be cut into uncorrelated pieces at an interm ediate so joum without rem oving correlations due to the harm onic bath, across this so joum. Follow ing the lines of Refs. 5,16$]$ we de ne irreducible in uence functions subtracting from the inter-and intra-blip interaction factors $G_{m}$ all the reducible com ponents

In the absence of coupling, $v=0, A(; 0 ; t)$ and $B\left(;{ }^{0}\right.$; $)$ are sim ply related to the com ponents of the average $h_{z} i_{t}$ sym $m$ etric and antisym $m$ etric under bias inversion $S B!\quad S B, h_{z} i_{t}=P_{S}(t)+P_{a}(t)$, via $A_{0}\left(;{ }^{0} ; t\right)=P_{s}(t) \quad 1$ and $\mathrm{B}_{0}\left(;{ }^{0} ; \mathrm{t}\right)=\quad \mathrm{iP}_{\mathrm{a}}(\mathrm{t})$. In this $\lim$ it Eqs. $(27,28)$, reduce to the $m$ aster equations satis ed by $\mathrm{P}_{\mathrm{s}}(\mathrm{t})$ and $\mathrm{P}_{\mathrm{a}}(\mathrm{t})[5,16]$.

Being of convolutive form $s$ the integro-di erential equations Eqs. $(27,28)$ are conveniently solved in Laplace space. P erform ing the sum s in Eqs. $(19,20)$ the Laplace transform of the correlator $C$ + $(t)$ reads

where $K_{1}(), K_{2}()$ are the Laplace transform $s$ of the kemels $(23,24)$ and $\mathrm{p}(0)$ com es from the initial condition chosen for the spin $\sim$.

5 R educed dynam ics at $n$ ite tem peratures

Solving the pole equation (30) represents a form idable task, so in the follow ing we shall focus on special dam ping and tem perature regim es which are particularly relevant for quantum com puting. W e shall analyze dephasing at nite tem peratures at two special coupling conditions: weak dam ping K 1 and $K=1=2$. In the second case the spin-boson $m$ odel can be mapped onto a Fano A nderson m odel [12] which is suitable to study dephasing due to bistable uctuators producing 1=f noise [9].

W e shall adopt an approxim ate treatm ent w idely used in the spin fooson literature $[5,6]$, the noninteracting-blip approxim ation $(\mathbb{N} \mathbb{B A})$. In the $N \mathbb{B A}$, the blip-blip interactions $j_{j k}$ are neglected, and also the so joum-blip interactions $X_{j ; k}$ are disregarded except those ofneighbors, $k=j 1$, and they are approxim ated by $X_{j ; j} 1=Q^{\infty}(j)$. Thus the in uence functions (13) factorize into the individual blip in uence factors, and the irreducible in uence functions (23) vanish for $n>1$. For $O h m$ ic dam ping in the scaling regim e, each blip interacts w ith the subsequent sojoum only (see Eq.(15)), thus the only approxim ation involved in the $N \mathbb{B A}$ is the neglect of the blip-blip interactions. This approxim ation is justi ed in the regim es of our interest, see ref. [5].

W ithin the N IBA the series expression for the irreducible kemels $(23,24)$ reduce to the low est order contributions $(25,26)$. Evaluation ofEqs. $(27,28)$, w ith these kemels give the reduced dynam ics of the qubit in the $N \mathbb{B A}$. To m ake things sim pler we shall consider the unbiased case $\mathrm{sB}=0$.

### 5.1 The case $\mathrm{K}=1=2$

For K = $1=2$ the Laplace transform of the kemel $K_{1}(t \quad l)$ takes the form

The behavior of C + (t) has been analyzed in Ref. [9] where two qualitatively di erent regim es for the problem were identi ed.

Fast environm ent \{ If $2 \mathrm{~V}={ }_{\mathrm{F}} \quad 1$ only one of the exponentials appearing in Eq. (31) dom inates the long-tim e behavior and C + ( t ) show s a single rate, given by $\frac{1}{2}(1 \quad)_{F} \quad V^{2}=F_{F}$, the standard $G$ olden $R u l e$ result. T he decay of $C+(t)$ at alltim es, described by $(t)=\operatorname{lnfC}+(t) g$, is w ellapproxim ated by sim ulating the SB m odelw th suitable set of harm onic oscillators reproducing the pow er spectrum $S$ (!). In this case the decay is described by ( $t$ ) osc ( $($ ) where $[3,5]$

H ere the pow er spectrum Eq.(4) is a Lorentzian $S(!)=2 v_{F}^{2}=\left({ }_{F}^{2}+!^{2}\right)$, due to the pure relaxation behavior of $h_{z} i$ for $v=0$ [5]. Thus in this regim e the spin ~ sees the SB environm ent as an e ective set of harm onic oscillators, and no detailed inform ation or $m$ em ory e ects of the environm ent enters $C+(t)$.

Slow environm ent \{ If $2 \mathrm{v}={ }_{\mathrm{F}} \quad 1, \mathrm{C}+(\mathrm{t})$ is determ ined by both the exponential term s in Eq. (31). D eviations from the weak coupling result osc (t) are observed, in particular the short tim es behavior t $\quad{ }_{F}{ }^{1}$ show $s m$ em ory $e$ ects whereas for long tim es the coupling $v$ does not enter the decay rates,
given by $1_{F}=2$, but detem ines the frequency shifts, which reduce to $V$ (see Fig. 5.1 a).

W e mention that for $K=1=2$ the same structure Eq. (31) is also found in m ore general situations, sв; $\mathrm{E}_{\mathrm{J}} \in 0$ [9,17]. Formulas for A and are more com plicated, for instance $R e$ and $I m$ are both non vanishing in the entire $2 \mathrm{~V}={ }_{\mathrm{F}}$ range and a third regim e $2 \mathrm{~V}=_{\mathrm{F}} \quad 1$ appears (see F ig.5.1). H ow ever the analysis using the expressions (32) rem ains still valid, and in the follow ing we w ill identify the di erent regim es for $K \quad 1$ from a sim ilar analysis of the poles of ${ }^{\text {d }}+()$.
5.2 W eak ohm ic dam ping K 1 and nite tem peratures

For weak ohm ic dam ping, $K \quad 1$ and tem peratures $k_{B} T_{b} \quad k_{B} T \quad!{ }_{c}$, where $\mathrm{k}_{\mathrm{B}} \mathrm{T}_{\mathrm{b}}=\frac{{ }_{r}^{2}+\mathrm{v}^{2}}{}$, the characteristic uctuations of the harm onic oscillators in $H_{S B}$ have no $m$ em ory and $Q(t)$ assum es the $M$ arkov form

U sing this latter expression the interblip interactions canœl out exactly, thus justifying the $N \mathbb{B A}$.

In the absence of bias, $\mathrm{SB}=0$ only the kemel $\mathrm{K}_{1}()$ is non vanishing, and in the $M$ arkov lim it it reads $K_{1}()={\underset{T}{2}}_{2}=[+2(T)]$, where ( $T$ ) is given by Eq. (3) and we have introduced the tem perature dependent tunneling term $T=r_{r}\left(2 k_{B} T={ }_{r}\right)^{K}$. The correlator $C^{\circledR}+()$ is readily found as

The qualitative behavior of $C+(t)$ is determ ined by the three poles found by solving the equation $N()=0$.

Low tem peratures \{ At tem peratures $\mathrm{T}_{\mathrm{b}} \quad \mathrm{T} \quad \mathrm{T}_{0}$ the poles, in low est order in $\mathrm{T}=\mathrm{T}_{0}$, are given by

The behavior of $\mathrm{C}+(\mathrm{t})$ depends essentially on $\mathrm{V}=\mathrm{T}$. If $\mathrm{V}=\mathrm{T}_{\mathrm{T}} \quad 1$ the reduced dynam ics show S a single rate, corresponding to the dom inant pole $0 \quad 2\left(\mathrm{v}=\mathrm{T}_{\mathrm{T}}\right)^{2} \quad(\mathrm{~T})$. Instead in the opposite regin $\mathrm{e}, \mathrm{V}=\mathrm{T}_{\mathrm{T}} \quad 1$, the two poles $\quad 1=2 \quad\left(\mathrm{~T}_{\mathrm{T}}=\mathrm{V}\right)^{2} \quad$ ( T ) iv dom inate. The frequency shifts are given by $v$ as in the slow environm ent case of section 5.1. Thus for $\mathrm{V}=\mathrm{T} \quad 1$ a crossover is expected in the behavior of C + ( t$)$.

H igh tem peratures \{ If $T \quad T_{0}$, the leading behavior is given by

In this case there is an interm ediate tem perature regin $\mathrm{e}, \mathrm{k}_{\mathrm{B}} \mathrm{T}_{0} \quad \mathrm{k}_{\mathrm{B}} \mathrm{T}<$ $k_{B} T_{+}=\quad{ }_{T}^{2}=(4 \mathrm{~K} \mathrm{v})$, where we m ay have three real roots. In this regim e, which occurs only if $v=T_{T}<1$, the dom inant contribution to $C+(t)$ com es again from a single pole, $1 \quad 2\left(\mathrm{v}={ }_{\mathrm{T}}\right)^{2} \quad(\mathrm{~T})$. Instead for tem peratures $T>T_{+}$the two com plex conjugate ${ }_{1=2}$ are the dom inant poles. The decay rate displays the $K$ ondo behavior ${\underset{T}{T}}_{2}=\left[\begin{array}{ll}4 & (T)\end{array}\right] / T^{2 K} \quad 1$ and does not depend on $v$. The coupling $v$ enters the frequency shifts, which approach $v$ if the tem perature is further increased. Thus in the region $T \quad T_{0}$ and $V<\quad \mathrm{T}$ we nd a crossover which $m$ ay be triggered by both $v$ and $T$, the crossover line being given by

Finally for larger values of $v>\quad T$ the system stays in the regin e where
the dom inant rates are the two complex conjugate $\quad 1=2 \quad{ }_{T}^{2}=\left[\begin{array}{ll}4 & (T)\end{array}\right] \quad$ iv. A gain $v$ does not enter the decay rate but determ ines the shifts $v$.

6 D iscussion of the results and conclusions

The analysis of the poles of ${ }^{\infty}+()$, Eq.(34) allow s to extend the qualitative conclusion for $K=1=2$ to the regim e $K \quad 1$. In this latter case we nd that the dynam ics of ~ shows a behavior which re ects the crossover of the SB environm ent to a slow dynam ics regim e. For K 1 the SB environm ent can be m odulated by acting on both the coupling $v$ and the tem perature. Instead for $K=1=2$ and ${ }_{S B}=0$ the crossover is triggered by the param eter $v={ }_{F}$ only. $T$ his is sim ply due to the fact that for the relatively strong coupling $K=1=2$, z has a relaxation dynam ics at any tem perature. T hus at any tem perature we may identify the correlation tim e of the $S B$ environment $c \quad{ }_{F}{ }^{1}$. The crossover to the slow environm ent regim e occurs when 2 v c 1 which marks the lim it $w$ here the standard $m$ aster equation approach in the coupling $v$ w ould break down [8].

To understand the behavior for $\mathrm{K} \quad 1$ we focus on $V \quad T$ and we identify the correlation time c of the SB environm ent from the dynam ics of the $S B$ model for $v=0$. In this case $z$ displays a crossover from coherent to incoherent dynam ics at a tem perature $k_{B} T(K) \quad r=K$. Below $T$ coherent oscillations at frequency $\quad$ т are slow ly dam ped $w$ ith rate given by ( T ) $\quad \mathrm{T}$ and we may identify $\mathrm{C} \quad \mathrm{T}^{1}$. Thus the SB environm ent is fast, since 2 V c $2 \mathrm{~V}={ }_{\mathrm{T}} \quad 1$ and 01 ( t ) shows the single rate $0 \quad 2\left(\mathrm{~V}={ }_{\mathrm{T}}\right)^{2}$ (T) $\mathrm{S}(0)=2$. If the tem perature increases fairly above $T$ the dynam ics of $\sim$ is incoherent and relaxation occurs, $w$ ith a slow rate ${ }_{r}$ (T) $\quad{ }_{T}^{2}=2$ (T) [5] which is identi ed w ith $c^{1}$. Slow environm ent e ects are then expected to appear in the reduced dynam ics of $\sim$ at $2 v={ }_{r}(T) \quad 1$ which is indeed the crossover line Eq. (37) .

Finally we point out possible extensions of our analysis. A SB environm ent with subohm ic (superohm ic) spectral densities [5] could be treated along the sam e lines, but since the uncoupled SB dynam ics is alw ays slow (fast) we do not expect tunable crossover lines to appear. O ur analysis can be easily extended to an environm ent $m$ ade of an arbitrary num ber of $S B$ im purities. In this case $C_{+}(t)={ }_{i} C^{(i)}{ }_{+}(t)$ where $C^{(i)}{ }_{+}(t)$ is the individual contribution of the $i$ th $S B$ impurity. $T$ his allow $s$ to m odel a simple environm ent which produces $1=\mathrm{f}$ noise by choosing a suitable distribution [10] of the param eters of the set SB im purities. For instance in Ref. [9], which focuses on $K=1=2$, the standard distribution / $1={ }_{F}$ has been chosen for the relaxation rate of the $S B$. W e notige that for $K=1=2$ tem perature has no e ect in the regim ewe consider. Ifw eallow for im purities $w$ th " $_{S B} \in 0$ the tem perature determ ines at
$m$ ost how $m$ any im purities in the set are active. Instead for a $1=f$ environm ent m odeled by a set of ohm ic SB im purities w ith K 1 our results show a non trivial behavior as a function of the tem perature, which $m$ ay be relevant for recent observations [18] oftem perature-dependent dephasing due to $1=\mathrm{f}$ noise. Finally if $\mathrm{E}_{\mathrm{J}} \in 0, \mathrm{z}$ is not conserved and relaxation occurs. T he relaxation rate increases $m$ onotonically $w$ th $\mathrm{E}_{J}=" . W$ e believe that the physical picture em erging from this work still applies to dephasing (see Ref. [17] for $K=1=2$ ) at least for tim es sm aller than the relaxation tim e.
